South Bay's Jamie Serbin One of the First to Get the COVID-19 Vaccine

El Segundo resident Jamie Serbin, a labor and delivery nurse, currently working at UCLA Santa Monica Hospital, was recently one of the first essential personnel to receive the COVID-19 vaccine as the pandemic continues to rage, filling hospital intensive care unit beds to maximum capacity, and continuing to crush spirits and communities worldwide.

Serbin, a 2006 graduate from El Segundo High School, as well as a graduate from Mount St. Mary's College, has also worked

at Centinela Hospital in Inglewood and currently handles two 12-hour shifts a week as she juggles mom duties with her two young boys, Noah, 5, and Charlie, 3. She received her vaccine jab-shot, without trepidation, on Dec. 16, the first day that the UCLA facility offered the shot to their employees.

"I am proud to be part of the first step in ending this pandemic," Serbin said. As a front-line hospital worker toiling in the shadow of the deadly scourge of COVID-19, Serbin noted that since the pandemic hit the fan in mid-March, her workday has changed dramatically. Hospital personnel need to mask-up, shield-up, and undergo COVID screenings and temperature checks before the medical workers enter the facility, before donning their hospital scrubs.

As the pandemic continued to rage, Serbin said it was "a little bit difficult," because she works in labor and delivery, to have to enforce the restriction on visitors' protocols as the expectant mothers continued their journeys into motherhood. She called it "a roller-coaster up and down with the patients. Quite a different style of nursing," with the necessity to wear the PPE all the time, blunting some of the "relationships that you get with your patients. It was a hard transition for us at work."

With hospitals, especially in L.A. County, overrun with COVID-cases, many have put off visiting the hospitals to have so-called elective surgeries or needed health screenings performed. But an expectant Mom cannot put off delivering a baby, so Serbin and her co-workers continue to provide the best care possible.

Coupled with her twice-weekly 12-hour shifts at the hospital, Serbin has had to, like many parents, grasp the intricacies of attempting to master distance learning for her son Noah, a transitional kindergartner at Center Street Elementary School.

Which was not easy, initially? "At first, it was overwhelming," Serbin said. Still, she has settled into a somewhat comfortable routine implementing the distance-learning protocols while juggling other Mom duties around the Serbin's El Segundo home.

A lifelong resident of El Segundo, Serbin has been front-and-center in witnessing the town's changes over the years, especially the upsurge in establishments and car and foot traffic on Main Street. "I think it is great. It is a cute little town," she said, noting that "it is so wonderful, so heartwarming to see" the efforts that the City of El Segundo administrators have made to accommodate

Promising Young Woman Tells a Twisty, Gritty Tale of Female Revenge

It was the haunting orchestral arrangement of the Britney Spears song "Toxic" that did it for me; I knew at that moment that Promising Young Woman was something special. Both a cautionary tale about a dark side of bro culture and how repressed trauma can turn into boiling vengeance, Promising Young Woman tackles a sensitive conversation with sprinkles of irreproachable charm to create an intoxicatingly

Not all superheroes wear capes. In this case, it's just pink lipstick. When Cassandra (Carey Mulligan)-a once aspiring medical student- isn't working behind the bar at the local coffee shop, she's living a double life as a single, helpless frequenter of dive bars and nightclubs. Much to the surprise of the pervy men who try to take advantage of her in her drunken state, Cassandra's disheveled appearance and slurred speech aren't the results of too much liquor. This is all an act; sober as a judge, Cassandra gets men to their most vulnerable before unveiling herself as a fully functioning feminist who highjacks the night by teaching these men a valuable (and sometimes violent) lesson about their ignorance of rape culture.

But why go through all of this trouble? It's clear that she gets some satisfaction from teaching these creeps how to treat a woman with decency and respect, but Cassandra doesn't bear this cross for herself; her justification is something she keeps close to the vest. As she continues to go through the motions of her "questionable" daily routine, Cassandra hesitantly entertains a real relationship with her old medical school classmate Ryan (Bo Burnham), a sweet guy who seems like the perfect complement to her introverted self. However, his re-emergence in her life brings up a traumatizing event from her med school days which reignites Cassandra's deep-rooted desire for revenge, making her double-down on her savage antics in an attempt at retroactive retribution.

Under Promising Young Woman's poppy bubblegum surface is a story so dark and twisted, it makes Nurse Ratched look tame. Director Emerald Fennell's genre-blending world finds the right balance between entertaining romantic comedy and horrifying revenge thriller, which is even more impressive considering it's her feature film debut. Also doubling as the screenwriter, Fennell's confidence in creating a story so sensitive yet relevant in today's dating culture and #MeToo movement is an unforgettable cinematic experience. Carey Mulligan's Cassandra is an untraditional heroine. She's quiet, cold, and suffers from mental anxiety, yet her determination to rid the world of misogynists is admirable. She is a flawed individual with pure intentions, the underdog of her own story, but not for long.

Bursting with wall to wall vibrance and violence, Fennell & Co have created a gritty tale of revenge in the modern age. Phenomenal performances aside, also worth noting is the film's soundtrack which is exclusively made up of female artists, including Paris Hilton's infamous debut single "Stars Are Blind." If there's a succinct message to take away from Promising Young Woman it would be this: don>t underestimate the strength of a woman, quiet doesn>t equal weak, and you can always count on an ex-nursing student to give offenders a taste of their own medicine.

As a practical matter, the duties of the Treasurer are largely ceremonial. The work of (i) maintaining the City's accounting and reporting on the City's finances, (ii) selecting and managing the City's investments, (iii) receiving and depositing City funds, and (iv) preparing warrants for payment is largely done by the City's Finance Department Staff. The Finance Department staff is supervised by the Finance Director and the size of that staff (and its compensation) is determined by the City Council. The Finance Director is supervised by the City Manager. Applications for the office of City Treasurer will be available on December 17, 2020 and must be submitted in person (by appointment only) or via email by January 8, 2021 at 12:00 PM. Late submissions will not be accepted. The City Council will review applications and

conduct interviews of the candidates during the special meeting on January 19, 2021 at 6:00 PM. Follow-up interviews may occur during the regular meeting of the City Council on January 26, 2021 at 6:00 PM. An appointment is anticipated to be made on January 26, 2021. small businesses and restaurants in the current cataclysmic environment. "Our leaders care about the businesses," she said, "the community, and our safety."

Serbin, an avid reader, typically, prior to COVID-related shutdowns, enjoyed visiting local amusement parks with her family and taking advantage of our proximity to the charms of the Pacific Ocean.

Stepfather Michael Walsh recommended Serbin for this profile, emailing that "after the past ten months of stressful living for all of us, and worries about what the next day or week will bring, concern for all first responders and 'essential' workers who have tirelessly put themselves on the line, we thought that Jamie, and others like her, might deserve some recognition."

As for volunteering to be one of the first to take the vaccine, Serbin said that she was always interested in taking the vaccine when it was approved and because the hospital unit that she works in is considered a "high exposure" unit, she filled out a survey before the time that the vaccine was available, and, was selected, on a "randomized" basis, to be at the front of the line to receive the jab.

The process was relatively painless, she said. It involved taking a UCLA survey and then receiving a notification on her phone app, which allowed her to select a date and time to get vaccinated. After the shot, she and the other early-vaccine recipients were asked to hang-tight in the auditorium for 15 minutes,

then sent home. Her second vaccine shot is scheduled for Jan. 6. Serbin said the only side-effects were that here jabbed arm was "a little sore."

She said that she became intrigued with a career in nursing at a young age when she would tag-along at work with her mother, who was an oncology nurse for more than three decades. "I would hang-out with the nurses and fell in love with everything that they would do," Serbin said, mentioning she had always liked "science and math" when she was growing up. It certainly appears Serbin

picked the correct career path. Just ask some of the folks who know her.

Lerin Jaraczewski works with Serbin at UCLA Santa Monica Hospital and "oriented" her when Serbin transitioned from her eight-year stint at Centinela Hospital to the Santa Monica campus. "Jamie is a very thorough nurse," Jaraczewski said, "very caring and sweet, which is great, but she also knows her 'stuff,' and sticks to her guns. When something is going right, she can recognize that, and when it is not," she is able to pivot to a different course of action. As an R.N. in charge, Jaraczewski said she never has to worry about Serbin's performance. "She is really on it," she said. "She is the kindest person...at a time like now, you have to be constantly on your toes; our patient population is direct admit," which means the patient does not have to visit the emergency department first; and COVID-19 protocols are strictly enforced. Because Jaraczewski has not been at work since the vaccine became available but said she would take the shot when she returns to work.

"I just love Jamie," Jaraczewsi said. "She has become one of my closest friends," Jaraczewski added, saying, "I think of her as my little sister."

Dr. Sue Murad, an anesthesiologist who has worked with Serbin for about a half dozen years, added this thought. "She is very conscientious and hard-working and takes very good care of her patients," Murad said.

Paula McAuliffe has been a friend of the

Troxel (Serbin's maiden name is Troxel) family for quite a while and has known Serbin for about a dozen years. McAuliffe said Serbin is a "very compassionate, very loving, very caring person to everyone she encounters. An extremely hard worker, highly organized. "She is one of my front-line heroines," McAuliffe said, who will take the vaccine when it is available to her. Concluded McAuliffe: "I think Jamie always wanted to be a nurse, like her mother."

Scheri DuBon, who has known Serbin for more than three decades (because Serbin happens to be her niece), said that while Jamie is a very caring person, she is "also very pro-active" regarding healthcare, noting Serbin's desire to "give back" and be a mentor to newbie nurses. "She really wants to be out there and be a role model for other nurses, and for her children," noting Serbin's belief in the efficacy of the vaccines and the necessity to safely implement masking and social distancing protocols. "She has a heart of gold," DuBon said. "There is so much misinformation out there," DuBon said regarding the pandemic, noting the need to follow the science to get the world through this deadly scourge.

The slew of folks interviewed for this profile would probably endorse the notion, "Thanks for all you do, Jamie Serbin." So, Mr. Walsh, consider your stepdaughter recognized for her selfless work and for being a role-model when it came to stepping-up to first take the vaccine. •

MUNICIPAL CODE.

WHEREAS, the City of Inglewood (the "City") currently does not have campaign contribution limits or regulations; and WHEREAS, Assembly Bill No. 571 ("AB 571")

imposes a default campaign contribution limit upon cities and counties without campaign contribution limits beginning January 1, 2021; and WHEREAS, the default contribution limit amount is set at the same amount as for State elected officials as that amount is adjusted by the Fair Political Practices Commission (the "FPPC") pursuant to Government Code Sections 85301(a) and 83124, which is currently \$4,700 per election; and

WHEREAS, Elections Code Section 10202 (automatically repealed on January 1, 2021) and Government Code Section 85702. 5 (effective on January 1, 2021) further permits the City to establish its own campaign contribution limits that are different from what is established by Government Code Sections 85301(a) and

where As, it is the purpose and intent of the City Council in enacting this Ordinance to preserve an orderly political forum in which individuals and groups may express themselves

WHEREAS, based upon the forgoing, and pursuant to Government Code Section 85702.5(a), the City Council desires to establish a campaign contribution limit that is different from what is established by Government Code Sections 85301(a) and 83124 by adding Section 2-247.1 (Campaign Contribution Limits and Regulations) to Article 8 (Council District Council Meetings

City Facilities) of Chapter 2 (Administration) of the Inglewood Municipal Code.

NOW,THEREFORE,THECITYCOUNCILOF THE CITY OF INGLEWOOD, CALIFORNIA, DOES ORDAIN AS FOLLOWS:

SECTION 1. A new Section 2-247.1 (Campaign Contribution Limits and Regulations) to Article 8 (Council District Council Meetings City Facilities) of Chapter 2 (Administration) of the Inglewood Municipal Code is hereby added to read as follows:

The purpose of this Section is to encourage public confidence in the political process and to prevent corruption and the appearance of corruption by limiting the source and amount of contributions that may be made to candidates and committees controlled by candidates for

elective offices.

Except as more specifically provided herein, the definitions set forth in the Political Reform Act of 1974 (Government Code sections 81000 et seq., as amended) shall govern interpretation of this Section and are hereby incorporated herein by this reference.

"City Election" shall mean any primary, general, or special election, including a recall election, held within the City of Inglewood for elective City offices. Each primary, general, or special election is a separate election for purposes of this Section.

"Elective Office" shall mean members of the Inglewood City Council, the Inglewood City Clerk, and/or the Inglewood City Treasurer. "Person" shall have the same definition as "person" in California Government Code Section 82047, as it may be amended from time to time, and which currently provides as follows: "an individual, proprietorship, firm, partnership, joint venture, syndicate, business trust, company, corporation, limited liability company, association committee, and any other organization or group of persons acting in concert."

C. Campaign Contribution Limits.

 A Person shall not make to a candidate for Elective Office, or a committee controlled by that candidate, and a candidate for Elective Office, or a committee controlled by that candidate, shall not accept from a Person, a contribution totaling more than one hundred thousand dollars (\$100,000) for a single election.

2. The City Council may adjust the contribution limit set forth in Subsection "C" of this Section in January of every odd-numbered year, commencing in 2023, to reflect any increase or decrease in the Consumer Price Index, All Urban Consumers. Those adjustments shall be rounded to the nearest one hundred

D. Contribution Limits to Other Candidates A candidate for Elective Office or a committee controlled by that candidate shall not make any contribution to any other Elective Office candidate in excess of the limits set forth in Subsection "C

E. Limits on Transfers of Contributions.

A candidate for Elective Office may transfer campaign funds from one controlled committee to a controlled committee for Elective Office of the same candidate. Contributions transferred shall be attributed to specific contributors using a "last in, first out" or "first in, first out" accounting method, and these attributed contributions when aggregated with all other contributions from the same contributor shall not exceed the

limits set forth in Subsection "C."

F. Limitations on Campaign Loans. 1. The provisions of this Subsection "F" regarding loans apply to extensions of credit, but do not apply to loans made to a candidate for Elective Office by a commercial lending institution in the lender's regular course of business on terms available to members of the general public

for which the candidate is personally liable.

2. Notwithstanding paragraph 1 of Subsection
"F", a candidate for Elective Office shall not personally loan to the candidate's campaign, including the proceeds of a loan obtained by the candidate from a commercial lending institution, an amount, the outstanding balance of which exceeds one hundred thousand dollars (\$100,000). A candidate for Elective Office shall not charge interest on any loan the candidate

made to the candidate's campaign.

G. Contributions After Election. A contribution for an election may be accepted by a candidate for Elective Office after the date of the election only to the extent that the contribution does not exceed net debts outstanding from the election, and the contribution does not otherwise exceed the applicable

contribution limit for that election in accordance with Subsection "C."

H. Limits on Carry-Over of Contributions. Notwithstanding Subsection "E," a candidate for Elective Office may carry over contributions raised in connection with one election for Elective Office to pay campaign expenditures incurred in connection with a subsequent election for the same Elective Office.

I. Contributions Before an Election.

A candidate for Elective Office may raise contributions for a general election before the primary election, and for a special general election before a special primary election, for the same Elective Office if the candidate sets aside these contributions and uses these contributions for the general election or special general election. If the candidate for Elective Office is defeated in the primary election or special general election, or otherwise withdraws from the general election or special general election, the general election or special general election funds shall be refunded to the contributors on a pro rata basis less any expenses associated with the raising and administration of general election or special general election contributions.

Candidates for Elective Office may establish separate campaign contribution accounts for the primary and general elections or special primary and special general elections

Any provision of the City of Inglewood Municipal Code or appendices thereto, inconsistent with the provisions of this Ordinance, to the extent of such inconsistencies and no further, are hereby repealed or modified to that extent necessary to effect the provisions of this Ordinance.

SECTION 3.

If any section, subsection, sentence, clause, or phrase of this Ordinance is for any reason held to be invalid or unconstitutional by a decision of any court of any competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance. The City Council hereby declares that it would have passed this Ordinance, and each and every Section, subsection, sentence, clause, or phrase not declared invalid or unconstitutional without regard to whether any portion of the Ordinance would be subsequently declared invalid or unconstitutional.

The City Clerk shall certify to the introduc-tion, approval, passage, and adoption of this Ordinance by the City Council and shall cause the same to be published in accordance with the City Charter, and thirty days from the final passage and adoption, this Ordinance shall

be in full force and effect.

WHEREAS, after taking public testimony and considering the issues, the City Council determined that certain changes specified herein, should be made to the text of Articles 1, 8, 11.1, 19 and 25 of Chapter 12 of the

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF INGLEWOOD, CALIFORNIA, DOES ORDAIN AS FOLLOWS:

1. That the proposed amendment to modify self-storage facility regulations supports the intent of the Inglewood General Plan in that it a. Provides for the orderly development and redevelopment of the city while preserving a measure of diversity among its parts.

b. Helps promote economic development and employment opportunities for the City's residents by responding to changing economic conditions. c. Facilitates the efficient use of land for conservation, development, and redevelopment. d. Promotes Inglewood's image and identity as an independent community within the Los Angeles metropolitan area.

e. Improves the visual appearance and economic condition of the existing arterial commercial development along Inglewood's

2. The changes to the text of Chapter 12 to modify self-storage facility regulations do not constitute an establishment of unique standards, offering special privilege to a particular individual

or group of individuals.

3. That the proposed amendment to modify self-storage facility regulations citywide is exempt from further environmental review under the California Environmental Quality Act (CEQA), therefore Notice of Exemption (EA-CE-2020-096) has been prepared.

Section 12-1.102.05 (Self-storage facility) is hereby added to the text of Chapter 12, rticle 1 (DEFINITIONS) of the Inglewood Municipal Code to read as follows:

"Self-storage facility" shall mean a fully-enclosed building designed and used for the purpose to customers for the purpose of storing and removing property on a self-service basis. No self-storage space shall be used as living quarters. Top with about 1 teaspoon pudding and place 1 small star pastry on top, turning it so the points do not line up. Repeat with the remaining star pastries, making 8 trees. Drizzle the trees with honey. Sprinkle with green sugar and top each with a raspberry.

 Helper: A set of star-shaped cookie cutters can be ordered from Cooking.com or cut 3 star patterns (2-inch, 2 1/2-inch and 3-inch) from cardboard. Place on the pastry sheet and cut with a knife.


