# **Pipeline Project Construction** to Continue Through November

City Points to Benefits From Increased Recycled Water Use

Though perhaps an inconvenience to drivers, bicyclists and pedestrians navigating through the area because of traffic and noise, the construction work at the west end of Grand Avenue and along Vista del Mar over the past month has gotten a big thumbs-up from the City of El Segundo for its more positive long-range impacts. West Basin Municipal Water District hired the crews to build a pipeline that will provide recycled water to NRG Energy for industrial use at the latter's seaside power plant. "We think the recycled water pipeline project is wonderful, as we fully support any and every use of recycled water whenever possible," said City of El Segundo Public Works Director Stephanie Katsouleas. "El Segundo is committed to water conservation and the use of recycled water helps us achieve that overall goal."

According to the project fact sheet, the 10-inch diameter pipeline scheduled for completion in November 2012 "will convey an average of 470,000 gallons per day of single pass reverse osmosis recycled water" to NRG's campus. "A reliable supply of water is necessary for the vitality of all communities. By utilizing recycled water for industrial, commercial and landscape irrigation uses, potable [drinking] water is saved for residential use," explained Construction Awareness Manager Trisha Murakawa. "This project in particular will save 470,000 gallons of drinking water each day."

Grand and Vista del Mar won't be the only streets affected by construction. Over the next few months, crews will lay pipe in commercial and residential portions of west El Segundo, with possible impacts to businesses and to people living in those areas. The pipeline will start at Eucalyptus Street and El Segundo Boulevard and end at Vista

del Mar at the northerly edge of NRG's facility. From El Segundo Boulevard, it will run north one block on Eucalyptus and then turn west on Franklin Avenue for another seven blocks to Loma Vista Street. It will continue one block north on Loma Vista to Grand, from where it will then head west to Vista del Mar before moving south to connect to NRG.

According to Murakawa, construction

workdays and hours will vary by residential and commercial sections along the alignment. "Generally, construction along residential streets will occur from 9 a.m. to 3 p.m., and along business and commercial streets from 8 a.m. to 4:30 p.m.," she said. "As construction work progresses along the alignment, notices will be provided to residents and businesses in the area informing them of potential impacts

# Helping America's Vets One Family at a Time

When Vice President of Space Strategy for Raytheon Space and Airborne System Brian A. Arnold was asked to be part of the Operation Homefront national board, there was a wave of emotions that filled him as he undoubtedly knew it was an offer he could not refuse.

"I was just honored when they asked me to be on the board," Arnold said. "It's kind of a nice way to give back, having been in the service for so long and seeing the sacrifices that our young soldiers, Marines, sailors and airmen make, and for the families and the things that they put up with. To be connected as a volunteer to help them out is just wonderful. I feel humbled and honored to be asked to be on the board."

Operation Homefront is a national non-profit organization that operates through 10 field offices that take care of roughly 24 states. There are also 14 chapters that take care of 17 states. Those states not covered by the chapters or the field offices are taken care of by the national headquarters located in San Antonio, Texas. The core goal of Operation Homefront is to provide assistance for the families of servicemen and women who are deployed or who were wounded. Services include rent and mortgage assistance, Wounded Warrior family transition housing, military youth programs, critical baby items, emergency home repair, caregiver retreats, local moving assistance, essential home items and urgent vehicle repair.

"There is no better feeling at all than when you come back from a deployment to have your family waiting for you," Arnold, a retired U.S. Air Force Lieutenant General, said. "The whole wait during the deployment, you have the families supporting their servicemen by keeping those home fires burning. If you look at the economic impact of late, it's had somewhat of a hard blow on the military families as well. They really focus on the needs of that family and they also help families who lose a spouse in combat. It is a way to take care of them while they get back on their feet and begin to move onto something else."

The organization operates through the efforts of more than 4,500 volunteers and

through the donations collected from both individual and corporation contributions. Last year more than \$24 million were collected in donations, of which only six percent was used for administrative costs. The remaining 94 percent went directly to benefit the families that the organization is set up to help. Operation Homefront estimates that 99 percent of the families served are junior and mid-grade enlisted personnel, also known as E1 through E6 men and women, who are deployed. The assistance is provided in the form of grants--not loans.

"We really care about the well-being of families and soldiers, sailors, Marines and airmen that are fighting the war--for them it's kind of comforting to know that there is someone back here taking care of the family while they are out fulfilling their duties," Arnold said. "All the way from the very top of our corporation with our CEO William Swanson, to the President of Space and Airborne Systems Richard Yuse, we very strongly support all of the men and

and of the construction workdays and hours." Signs will also be placed alerting drivers if traffic detours are necessary.

According to the estimated construction schedule, much of the work on Loma Vista and Franklin will take place in August and September, with Eucalyptus the final component in October. Figuring in the possibility that rain could postpone some construction days, the overall project is expected to be completed by November 20 and possibly a few days earlier. For additional information on construction and for other project-related questions, residents, visitors and business owners can check the West Basin website at www.westbasin.org or call the construction community information hotline at (310) 318-8104. The hotline is available 24/7. Murakawa anticipated construction to still be in progress along Vista del Mar by the time this week's Herald hits the streets.

El Segundo is home to the Edward C. Little Recycling Facility, described on the fact sheet as "the largest and only treatment facility in the world to provide five types of designer water to meet the custom needs of West Basin's commercial, industrial and public clients for landscape irrigation, cooling towers, street sweeping and other non-potable use services." West Basin provides more than 30 million gallons of recycled water throughout the South Bay daily and has more than 300 recycled water customers. El Segundo

is among its best stewards, as about half of all water used in the community is reused. Choosing recycled instead of potable water is a mechanism the City supports to manage its total consumption. "In drought years, the Metropolitan Water District has and can again impose potable water consumption allocations/limitations," said Katsouleas. "As new users come online or existing users change their potable consumption rates, they have the ability to adversely affect El Segundo's total potable allocation and thus potentially expose the City to over-consumption financial penalties."

In 2009/10 MWD imposed allocation restrictions on all its user groups, but lifted those after a very rainy 2010/11. MWD could very well impose those restrictions once again if California continues to experience dry years like the most recent one. "For these reasons, there is a huge benefit to El Segundo by this recycled water line being installed," Katsouleas noted. "There are no direct cost savings associated with the installation, but there is always the potential depending on how much rain California gets each year."

Murakawa added that reusing water is a sustainable measure that protects communities from increased water costs during times of drought. "Every gallon of water recycled and used locally is a gallon that does not have to be imported," she said. •

In 1962, the brilliant Ray Bradbury penned the gothic novel and poem Something Wicked This Way Comes, the story of a strange circus headed by the sinister Mr. Dark arriving in a small town. It is he who tattoos onto his body the picture of every victim he has conned into joining his circus, preying upon their hopes and bringing change from which they never recover.

A presence dark invades the fair And gives the horses ample scare Chaos rains and panic fills the air When something wicked this way comes

NEWS FLASH: The Hill Pulse Opinion Research poll found that 68 percent of Americans believe Barack Obama has substantially changed the country--56 percent negatively and only 35 percent positively. Something Wicked This Way Comes.

In 1996, under President Clinton,
Congress passed the Temporary Relief
for Needy Families Act (TANF). The act
modified the welfare program by requiring
applicants work 20 to 30 hours per week
or make material efforts towards work.
Clinton said this act "ends welfare as we
know it" and TANF did in fact reduce the
number of welfare applicants by millions.
While the law prohibited its alteration
by executive order, on July 12 President
Obama eliminated the work component of
the law by executive order, thus violating
the law itself.

And boiling currents pound like drums When something wicked this way comes.

On July 12, the New York Times reported that from 2008 to 2012, food stamp recipients rose by over 50 percent from 30 million to 46 million. Some of that increase was due to the recession, but according to The Times, much was due to policy changes. First, there are categorical eligibility rules declaring anyone receiving benefits from any other entitlement program automatically became eligible for food stamps. Even if a person received a flier describing the program, he became eligible. Second, any work requirement was suspended. Third, there is no maximum asset limit requirement. Fourth, the federal government offered states \$50 million in bonuses to sign up applicants. So the program exploded.

When the House proposed a two percent reduction in the program, equal to \$16.5 billion over 10 years, the Democratic Senate rejected that proposal.

By a 5:1 margin, the Senate had passed the Defense of Marriage Act (DOMA) defining marriage as between a man and a woman, and the House overwhelmingly passed the law by a vote of 342-67. Democrat Clinton signed it into law. In 2009, the Obama Department of Justice declared the law constitutional, but 18 months later Obama issued an executive order saying the DOJ would cease defending the law. In essence, Obama superimposed his view over that of both houses of Congress in clear violation of the Constitution.

Said Jonathan Turley, a liberal constitutional law scholar at George Washington University "The

Washington University, "The President is using executive power to do things Congress has refused to do. That fits a disturbing pattern of expansion of executive power. To close budgetary deficits exceeding \$1 trillion every year, Obama proposes to raise taxes on 950,000 small businesses, but the Democratic Senate refuses to bring the President's proposal to a vote. The Heritage Foundation calculated that if these businesses earned an average of \$250,000, their federal tax increase would be \$24,888.

On July 13, Americans for Tax Reform disclosed that income taxes have reached 54 percent of the nation's GDP and the average worker must work until July 15 to pay for this year's tax burden. Something wicked this way comes.

On July 12, the Doctor Patient Medical Association polled 699 doctors, who revealed that 83 percent had considered quitting medicine because of the burdens of Obamacare. By the year 2020, the nation will face a shortage of 90,000 doctors, and of those continuing to practice 49 percent will cease accepting Medicaid patients because of excessive regulations, low-ball payments and excessive hoops required to obtain payment.

To date, Health and Human Services (HHS) had spent \$1 billion to implement Obamacare and has drawn 13,000 pages of regulations. Yet the law allows HHS to spend another three years to finish drawing its regulations and procedures. One can only guess at the end result.

The happiness shown in the commercials hardly depict real life as the continued use and abuse of liquor result in fights, car crashes and broken families. Although they advise customers to drink responsibly, the message is sometimes difficult to find and speedily delivered to conceal it as

much as possible. By hiding their advisory as much as legally possible, the companies continue to make more money because they know that blatantly telling customers to drink responsibly would reduce their sales and income.

Tobacco and narcotics follow the same principles to persuade potential customers, but are more potent and dangerous. In the mid-20th Century, it was not uncommon to see someone break out a cigarette to relieve themselves of their problems for a brief moment. Today, people have moved from simple cigarettes to marijuana and other drugs to provide a stronger and longer escape from reality. This predicament is a very close prediction made 80 years ago in Aldous Huxley's book Brave New World, where citizens are sedated and are always in a euphoric state due to the extremely strong narcotics they religiously consume. At the rapid pace in which new and stronger forms of illegal substances are made, the illegal manufacturers may one day produce a product so potent that those who take it will remain in their own personal utopia and never wake up.

A major but unlisted consequence to an individual's constant flights in and out of this world is the loss of the individual's own humanity. Not a day goes by when someone is not on the news for a despicable act due to alcohol, smoking or drugs. As their ability to reason diminishes, so do the things that make them human. skills contest will be held at Stevenson Field for a little fun before the teams get down to business on Saturday.

Four of these teams have faced each other in the past when they competed at the 2011 Babe Ruth League 14-year-old Pacific Southwest Tournament held in Vernal, Utah. Vernal, West Reno, Tucson and El Segundo all participated. Tucson and El Segundo played each other three times, including the final in which Tucson won the championship in extra innings.

The host team El Segundo is no stranger to Babe Ruth League all-star competition. It hosted the Pacific Southwest Tournament six times including 1967, 1996, 2001, 2004, 2008 and this year and has advanced to the regional tournament a number of other times.

The regional is the final tournament before the winner advances to the World Series. El Segundo has won four Babe Ruth World Series titles including 1964, 1969, 1974 and 2002. In 1996, it finished third and was runner-up in 2004--an impressive resume for such a small league.

El Segundo has had plenty of success over the years when the all-star team travels to a regional or to the World Series. It is greeted with a measure of ultimate respect. This year;s manager Charlie Haaker has had a lot to do with the success of the league's allstar teams for the past 15 years. Haaker, a former standout pitcher for El Segundo High School, takes his coaching to another level in preparing his teams for all-star play. "When people speak about the great El Segundo Babe Ruth League coaches who have led their teams to world titles, they'll talk about Ed Helvy, Joe Soto, Jack Wayt and Charlie Haaker," said Motta, "I'd say Charlie is in pretty exclusive company."

El Segundo played in the Southern California State Tournament as a prelude to the regional and defeated Torrance 9-4, Westchester 11-3 and South Torrance 9-5 to reach the final against Torrance. In the first elimination game, El Segundo suffered through a tough seven-run second inning and fell 10-4. In the second game El Segundo used some great pitching from the team's top hurlers, Willem Mostert and Tanner Stevens, to win the championship 6-2. El Segundo has been led offensively by Lars Nootbaar, Noah Bergren, Conner Underwood, Nick Karsseboom, Joey Garza, Hunter Lewis and Dean Abramson.

Torrance is no stranger to advancing to the Pacific Southwest Regional either. It has been to regional tournaments at three different levels and won the 13-15-year-old world title in 2006 and 2008. In 2010, the 13-year-old all-star team won a world title at Levelland, Texas.

Torrance will have players from four different high schools competing, including varsity standouts David Aros and Manny Olloque (Torrance HS), Tyler Suzuki (West Torrance HS), Justin and Jason Yanez (Banning HS) and stars from North Torrance HS.

Riverton, Utah comes into the Pacific Southwest Tournament with confidence. Manager Derrick Bolton knows to win the tournament he'll need his team to play at its best. Riverton fell to Vernal in 10 innings in the Utah State Finals, so he believes his team has what it takes to play against top competition. "We aren't a travel team--all of our players are from a seven-team league," Bolton said. "They've played together or against each other for years, so they really know each other well."

Vernal, Utah, arrives as the Utah state champions after defeating Riverton in 10 innings. Vernal has become a baseball juggernaut, winning youth baseball state titles at various age levels recently. They were

fortunate to host last year's Pacific Southwest 14-year-old tournament. With nearly all of last year's roster intact, Vernal has the experience to make some opposing teams take notice.

Tucson, Arizona returns to El Segundo to play in the Pacific Southwest Regional, having competed here in 2008. Tucson (Oro Valley) is led on the mound by Gabriel Benavides, who pitched his team to the state championship. Benavides went the distance against Show Baseball, giving up two runs (one earned) and scattering five hits.

Tucson manager Mike Hanson says his team is at full strength now that shortstop Nick Ames is healthy. He says that to advance to the World Series, Tucson will need to play at the top of its game. Offensively speaking, Tucson will look to Adam Hoyos, Erick Migueles, Nick Ames, Max Smith and Benavides. It advanced to the 14-year-old World Series last year when it defeated El Segundo in extra innings in the championship game. These two teams could meet in the second round if they both get by their first round matchups.

Reno West, Nevada comes into the tournament as one of the highest scoring teams. The Nevada champions rolled through its state tournament by outscoring its opponents 56-8. In fact, the only game it didn't mercy the opponent was in the final against Sparks.

Reno West is led by pitcher Denny Peters, who threw six innings, scattered three hits and struck out four in the state final. Fireball pitcher Justin McKenzie gives Reno West some bullpen star power. Offensively the squad has plenty of bats throughout the lineup, including John Muntean, Chris Haines, Carter Knedgen, Nate Agliolo and McKenzie.

Orcutt won the Central California State Tournament and the Santa Maria-area team has plenty of experience going for it. Two years ago Orcutt played in the13-year-old Pacific Southwest Regional, so this experience will be nothing new. The team that arrives in El Segundo will be made up of mostly players from that 13-year-old team.

Orcutt manager Gary Sewell also guided the 13-year-old team two years ago. He is optimistic about his team's chances, especially when he has Walker Armstrong and Conley Runions on the mound. Runions is a two-year starter for Valley Christian Academy and could be one of the top players in the tournament. Runions, Kyle Sewell and Dylan Renteria are three of Orcutt's top offensive players.

The Cinderella team of the tournament comes from Northern California. Sonoma comes to El Segundo as the surprise Northern California representative. It isn't just glad to be invited to this dance, but also has destiny and good karma going for it. The team placed second in the district tournament, but qualified as an alternate when one of the qualifying teams dropped out of the state tournament.


After advancing to the championship game out of the winner's bracket, Sonoma faced a juggernaut opponent looking for revenge. Trailing 4-1 in the seventh inning in the championship game, Sonoma came up with a five-run rally and held on to win 6-5 over heavily favored Tri-Valley. Tri-Valley had defeated Sonoma in the first championship elimination game to force a second game.

Sonoma and Tri-Valley split their first two games and it came down to a winner-take-all game. Seth August tied the game at 4-4 with a towering three-run homer. Later in the inning, Christopher Vitale hit a two-run double in the gap to give Sonoma a 6-4 lead. Tri-Valley scored one run and had the tying run on base when its rally was cut short. It marks just the second time that a Sonoma Valley team has reached the Pacific Southwest

### Sesame-Ginger Pork Patty with Grilled Pineapple



Ditch the bun and serve this Asianinspired pork burger with sweet grilled pineapple on top of a zesty watercressand-carrot salad. We like the taste and texture of fresh pineapple for this recipe, but canned pineapple rings work well too. Serve with short-grain brown rice.

Servings: 4 servings Total Time: 35 minutes

Ease of Preparation: Easy

Health: Low Calorie, Low Carb, Low Sat Fat, High Potassium, Heart Healthy, Healthy Weight, Diabetes Appropriate

Ingredients:

- 3 tablespoons reduced-sodium soy sauce
- 2 scallions, chopped
- 2 cloves garlic, minced
- 1 tablespoon minced fresh ginger
- 2 teaspoons sesame oil, divided
- 1 pound ground pork
- 1 tablespoon rice vinegar
- 4 pineapple rings, 1/4 inch thick
- 4 cups watercress (about 1 large bunch), tough stems removed
- 1 cup shredded carrot

Steps:

1: Preheat grill to medium-high (or see Stovetop Variation).

2: Combine soy sauce, scallions, garlic, ginger and 1 teaspoon sesame oil in a small bowl. Place pork in a medium bowl. Add half of the sauce mixture to the pork and gently combine without overmixing. Form into 4 patties, about 3/4 inch thick. Add the remaining 1 teaspoon sesame oil and vinegar to the remaining sauce mixture and set aside.

3: Oil the grill rack (see Tip). Grill the burgers, turning once, until an instant-read thermometer inserted in the center registers 155°F, 4 to 5 minutes per side. During the last 3 minutes of cooking, add the pineapple rings to the grill and cook, turning once, until dark grill marks appear.

4: Combine watercress and carrot in a large bowl. Toss with 2 tablespoons of the reserved sauce. Divide the salad among 4 plates. Top each portion with a pineapple ring and a burger. Drizzle any remaining sauce on top.

Tip: To oil a grill rack, oil a folded paper towel, hold it with tongs and rub it over the rack. (Do not use cooking spray on a hot grill.)

Stovetop Variation: Coat a nonstick pan, preferably cast-iron (or a grill pan), with cooking spray and heat over medium-high heat for 1 to 2 minutes. Add burgers, reduce heat to medium and cook, turning once, until an instant-read thermometer registers 155°F (for pork and bison) or 165° (for beef or chicken), 4 to 5 minutes per side. •



women that do the noble deed of guarding this country and protecting our freedom."


For the organization's Wounded Warrior transition housing, there are three transition homes--one in San Antonio, Texas, one near Camp Pendleton and the other in Washington, D.C. These are referred to as Operation Homefront villages and are apartment-like complexes that assist in the transition of the wounded warrior going through therapy. Some families have also been provided permanent housing, which is a more recent element of the organization's benefits to vets. Through partnerships with national lenders, vets are given the opportunity of homeownership. In 2012, Operation Homefront and Chase donated 29 homes to military families with the stipulation that they live in the house for two years at which point the deed is turned over to them.

"It was such a wonderful thing because a lot of these homes were foreclosed--the home is clean and they can move right in," Arnold said. "It is one of the neatest things that I can think of. Another neat thing that they do, for example, is they take a family to a National Hockey League game and they will give the family the keys during halftime. I heard there is not a dry eye in the place. That's an amazing thing and it is just another way to reach out."

For Arnold, being part of Raytheon and Operation Homefront provides an opportunity to help the servicemen and women abroad and at home. "When we provide a capability here, whether it be a fighter radar or induced space system--that contribution allows that soldier, sailor or Marine or airman to go do their job efficiently, complete their mission and come home safely," Arnold said. "In the meantime we were concerned about the whole family element as well, so when I was asked to be on the national board of directors for Operation Homefront, Rick Hughes, our president, absolutely supported the idea. We as a corporation very strongly support the military in every way that we can."

Arnold continued, "It is remarkable how sustainable these families are. The morale that the families use to bond when a member deploys is amazing. They [military families] are one big family and they take care of each other. It is comforting to know that the members of society around them are there to support them as well. There is no greater feeling than to be part of that now that my career is over as far as being active duty in the military. It is very self-fulfilling to volunteer to help fulfill those needs. There is no better feeling." •

This project is classified as a "Major Wireless Communication Facility" ("WCF") pursuant to ESMC § 15-19-7(A) and requires approval of a Conditional Use Permit pursuant to ESMC § 15-23-6. The project site is located within the Marine Terminal Land Use District within the Coastal Zone Specific Plan Map of the City of El Segundo's Local Coastal Plan, and in the Heavy Industrial (M-2) Zone. The

project is within the portion of the Coastal Zone where the City has permitting authority. However, the City's decision is appealable to the California Coastal Commission and the project requires a Coastal Development Permit. The project site is bounded by Grand Avenue to the north, 45<sup>th</sup> Street to the south (City of Manhattan Beach), Vista del Mar to the east, and the El Segundo Beach, and Pacific Ocean to the west.

The proposed project involves the removal of an existing 30-foot tall (Class 7) utility wood pole that is located in the public right-of-way (Vista Del Mar) that will be replaced with a new 39-foot tall (Class 3) utility wood pole. The location is along the frontage of the Chevron Marine Terminal approximately 1,844 feet south of the centerline of Grand Avenue. Two (2) antennas mounted on two (2) Iwo (2) antennas mounted on two (2) 6'-0" wide extension arms, one 12.15" by 50.2" by 10.13" cabinet, and one breaker/disconnect box will be mounted on the wood utility pole. The proposed project is categorically exempt from the requirements of the California Environmental Quality Act (CEQA) pursuant to 14 California Code of Regulations § 15303 as a Class 3 categorical exemption (New Construction or Conversion of Small Structures). The proposed project involves the construction of a new 39-foot tall utility wood pole for a WCF with an approximately six-foot tall surface-mounted electrical meter within the City-owned public right-of-way on Vista Del Mar. The proposed facility is surrounded by industrial uses, including a power plant, Edison electrical transmission lines and related utility structures. 
