New Welcome to El Segundo Sign Unveiled

The City of El Segundo was incorporated as a city in 1917 and has a quite a history. For decades visitors were welcome to the city with a sign that read, Welcome to El Segundo, surrounded by smaller signs of different clubs and organizations supporting the city. In December a new welcome sign was unveiled for the first time. Cheryl Ebert, the City Engineer with the City of El Segundo and the Project Manager for the Monument Sign project, guided us through the background.

In November 2018 the City Council established an Ad-Hoc Gateway Committee, comprised of individuals to determine the vision, goals and scope of potentially changing the Main Street / Imperial Highway welcome entry monument.

Based on the Committee's vision, elements to be considered in the design must be uniquely reflective of El Segundo, including character, nature, history and potential future. The monument sign must be iconic, unique and a place for photo opportunities.

In June 2019 the committee received responses from over 40 submittals. A design team, consisting of two artists was selected. Several design iterations were prepared and presented to the Gateway Committee in December 2020. Ultimately, Hirsch and Associates was selected as the qualified firm for this project. They presented two monument sign options to City Council for consideration in September 2022.

The Conceptual Theme chosen for the Monument sign is derived from post cards of the past which typically featured bold, clean designs with vibrant color depictions. The unifying feature of all letters is the background photograph of El Segundo Beach at Sunset. There is a story line represented

by images of landmarks and programming within the letters which focuses on nature, community, Industry, Aviation & Aerospace as well as future technology and innovation.

For natural beauty the letters E & L feature the endangered species of the El Segundo Blue Butterfly as well as the Seacliff Buckwheat plant, where the butterfly deposits its eggs. It transitions to Community features such as El Segundo Beach in "L". the community is further represented by landmarks such as the High School and Stevenson Field in "S", Bike Path and Water Tower in "E", Transitioning to Industry in "G".

Industry featured in the letter "G" with the refinery is the namesake of the City meaning "The Second" when Standard Oil established its second refinery in 1911. Aviation and Aerospace are represented in "U", "N" & "D" with El Segundo having a rich history of these

industries and production within the city; the James Webb Telescope the latest representation of such. Lastly the letter "O" represents cutting edge technology and future development and discovery with the city.

The welcome sign is constructed of Aluminum Panels supported by structural steel columns. The graphic panels are CHPL (Custom High-Pressure Laminate) which is a product of layered paper and resin, compressed and bonded under heat to form the rigid panels. Programmable LED lights are able to change color and sequence, following the outline of each letter. Additionally, LED lights compliment the face of the letters illuminating the story behind each letter.

This monument is a collective achievement that symbolizes our shared history, unity and our unwavering commitment to a brighter future for El Segundo. •

Beverly Ann (Jabbour) Cason January 17, 1936 to October 4, 2024

Beverly Ann Cason passed away peacefully on October 4, 2024 in Torrance, CA. She was born in Albany, NY in 1936, and met future husband Carl while growing up there. They married in 1956, and in 1958 moved to Southern California, and finally to El Segundo in 1961.

Beverly was a fixture in El Segundo youth organizations for decades, including Bobby Sox

softball, Job's Daughters, and Girl Scouts. She may have been best known as The Cake Lady, adding her decorated cakes to many special occasions in El Segundo, and for her working with Carl taking the team pictures for every youth sports league in town for many years. In 1995 they moved to Bothell, Washington. Following Carl's passing, Beverly moved back to El Segundo in 2011.

Beverly loved to sing, and was in local concert choirs and musical theater revues for much of her life. She had an uncanny memory for lyrics from the 1940s through Sinatra, and could sing any song you called out, even up to her final days.

She was preceded in death by her husband of 54 years, Carl, in 2010, and by her daughter Kathy (Cason) Motta in 2019. She is survived by her son Mike Cason and his wife Martha in El Segundo, daughter Lisa (Cason) Tatman and her husband Paul in

Kila, MT, and son-in-law Bob Motta in El Segundo. Her grandchildren include Jeff Cason and Beth (Cason) Spring, Ray Motta and Rebecca (Motta) Meick, and Kendall Wiggins, and great-grandchildren Ryan and Ryder Motta.

What is proposed: The Department of Toxic Substances Control (DTSC) invites you to review and comment on the Draft RCRA-equivalent Hazardous Waste Facility Permit (Draft Permit) for Rho-Chem, LLC located in Inglewood, California (Facility). Rho-Chem operates several hazardous waste management units at the Facility under a Resource Conservation and Recovery Act (RCRA)-equivalent Hazardous Waste Facility Permit that DTSC last renewed in 2008 for treatment and storage of hazardous waste received from off-site facilities and generated by Rho-Chem. If approved, the renewed Permit would allow Rho-Chem to continue current storage and treatment operations, as well as additional proposed activities, as specified in the Permit for an additional ten years.

California Environmental Quality Act (CEQA): DTSC must evaluate whether the Permit may have any significant impacts on human health and/or the environment. As part of this evaluation, DTSC prepared an addendum to the negative declaration in accordance with the requirements of CEQA, Public Resources Code section 21000 et seq. and the Guidelines for Implementation of the California Environmental Quality Act, California Code of Regulations, title 14, section 15164. Upon making a permit decision, DTSC will file a Notice of Determination with the Office of Planning and Research State Clearinghouse. 
Check It Out


<u>Film Review</u>

Nosferatu Tells A Tale of Gory, Gothic Heartache

Writer-director Robert Eggers has never been one to shy away from provocatively visceral moments in his films. His feature debut, *The Witch*, dips into the dark abyss of Puritan folklore and witchcraft. My favorite of Eggers' repertoire, *The Lighthouse*, shows Robert Pattinson and Willem Dafoe increasingly spiraling into isolation insanity. His fourth and most recent feature, *Nosferatu*, further solidifies his trademark gothic style and wholly unholy flare.

Eggers' vision is not just a remake but a reimagining of the classic 1922 silent German film *Nosferatu: A Symphony of Horror.* Directed by F. W. Murnau, the original film set a precedent as being one of the most influential within the horror genre. Its stark vampire lore has continued to excite filmmakers over the last century, and Eggers is not the first to try his hand at showcasing this material through

a new lens. In 1979, Werner Herzog released *Nosferatu the Vampyre*. In the early 90s, Francis Ford Coppola released his adaptation, which was more so inspired by the original Dracula source material, called *Bram Stoker's Dracula*. Like its predecessors before it, Eggers' *Nosferatu* offers a familiar story with the benefit of upgraded technological advancements.

Lily-Rose Depp plays Ellen Hutter, a young woman haunted by a mysterious and supernatural vampire. The vampire's obsession with Ellen began in childhood and its grip on both her free will and well-being continues to tighten the older she gets. When we meet Ellen, she is happily married to the love of her life, a real estate agent named Thomas (Nicholas Hoult). A work opportunity forces the couple to spend a few weeks apart as Thomas travels to visit a prospective property owner hundreds of miles away. As soon as Thomas arrives at Count Orlok's (Bill Skarsgård) eerily foreboding castle nestled within the barren mountains, he knows something is wrong. Upon meeting the evasive and frightening Count, Thomas looks for a way out but soon realizes that he has what

Boys Soccer Impressive Start


The season started with uncertainty because so many seniors were graduating. So, the soccer program switched gears and decided to host tryouts earlier in hopes of having a quicker start than in seasons past. Head coach Andrew Kelley also reverted back to a new/old system/formation, which is the same as their two CIF championship seasons. "We weren't sure how it was going to work out. So far, defensive solidity has been our cornerstone," says Coach Kelley.

Scoring against the Eagles has been an arduous chore. They have found that the starting central midfield trio of Bryant Waites, Ethan Walker, and Tristan (Tiki) Hummel has formed a really solid partnership. Brad Huag is the leading scorer, and the goals seem to be coming from all areas (open play, set pieces, defenders, and attackers).

To start the season, the Eagles have defeated Animo, DaVinci, Redondo, and South. They competed in the South Torrance Tournament, winning four out of five games and finishing fifth overall. This was their second-best finish in the tournament in school history; they won it in 2015.



Film Review

Count Orlok really wants: Ellen. And this time, Count Orlok-or, Nosferatu, as legend has itisn't letting anything or anyone get in his way.

Evil lurks around every corner as Count Orlok makes his way toward Ellen. Thomas, with his friends Friedrich (Aaron Taylor-Johnson) and Anna (Emma Corrin) Harding, attempts to interfere but they are only met with increasing distress and devastation. This is where Professor Albin Eberhart von Franz (Willem Dafoe), a leading expert on the occult, comes into the picture. Joining forces, they work to save Ellen from the clutches of this demon. The only problem is, it doesn't seem like Ellen wants to be saved after all.

Lily-Rose Depp throws her body into the role of Ellen, which demands a high degree of physical maneuvering and expression. Any time Nosferatu visits Ellen, she flails her body in seizure-like contortions. It's a painful yet pleasurable experience for Ellen, who cannot seem to break Nosferatu's spell despite her love for Thomas. This love triangle is the centerpiece of the film's climax. While the ending may be obvious to those who already know this story, Eggers' interpretation is full of emotional depth. Its inconclusiveness may not satisfy everyone but Eggers remains confident in his choices.

Every craft department fires on all cylinders, from the casting to the set design (which included 5,000 live rats!). However, the most stunning element is Jarin Blaschke's brilliant cinematography. The shadow play is incredible, the richness of color is deliciously satiable, and every frame looks like a Victorian painting.

As expected, Nosferatu isn't going to be light-viewing. It's macabre in nature and Robert Eggers amplifies this darkness through skilled camerawork and design. More horrifying than thrilling, Nosferatu will no doubt send a cool shiver down your spine. •






