# **Hawthorne Middle School Seeks Safe Harbor**

At its most recent meeting, the Hawthorne School Board heard a presentation by Hawthorne Middle School Principal Rudy Salas on what his staff is doing to bring his campus out of Program Improvement and raise both test scores and student achievement. Salas said that his primary goal is to get at least 89.2 percent of the students to score proficient or advanced on the State's standardized test, which would take the school out of Program Improvement. However, because of the gap between the current percentage of students achieving those scores (57.5 percent) and the goal Salas and the State have for the school, the Prinicipal is investing time in meeting the "Safe Harbor" goals. This means that certain significant sub-groups (such as English language learners, socioeconomically disadvantaged students, and disabled students) would need to make gains that would show the school is on its way to getting a large and diverse group of students to be proficient or advanced in math and English language arts. Salas acknowledges that even making the Safe Harbor targets will be a challenge, but he believes that the teachers and students are up for the challenge. "It's something difficult, but attainable," said Salas. "Yes, I know the mountain is steep, but we can do it.'

One way Hawthorne Middle School teachers are working to increase student achievement is through collaboration with each other and instructional coaches. The facility is taking part in professional development and studying subject-area coaches and each other to become more effective instructors. During first period, teachers work together to examine how their students are doing and how best to reach them. "This is where we do our data analysis and where we establish our best practices," said Salas.

One key concern for Salas is the pace teachers move through their material. He would like teachers to find a balance between dedicating too many hours to concepts student easily grasp and moving quickly over topics students might need more guidance. "Are we moving too slow--painfully slow--or are

we moving too fast and brushing over key points?" asked Salas.

The Board members supported Salas's methods and said they believe he can bring up the student body's standardized test scores. Board member Cristina Chiappe said that with the support of the teachers, parents and the Hawthorne School District, the Middle School could pull its way out of Program Improvement. "When you have all this support behind you... it's doable," said Chiappe. "You have a lot of work ahead of you."

The Board also approved sending out layoff notices for several teachers, counselors and education coaches in anticipation of budget cuts. Superintendent Helen Morgan noted that what was once a rare occasion for the District has become an unfortunate yearly exercise. "This had become routine in the last few years, which is really sad," said Morgan.

George Amaya, President of the Hawthorne Elementary Teachers Association, said that while his group doesn't blame the Board for the layoffs, instructors were hoping to be spared layoff notices because of a rosier outlook after Proposition 30 and Measure CL passed last year. "Because of Prop 30 and other things that have happened this year, we thought we saw the sunshine at the end of the tunnel," said Amaya. "But apparently—and at no fault of anyone here—it looks like that sunshine has dimmed a little, making it hard for us."

Currently, educational funding is in a state of flux because of both Governor Jerry Brown's

proposed Local Control Funding Formula, which would change how some educational programs (known as categorical programs) are funded, and the fiscal cliff, which could significantly impact education programs in California. These issues have made it nearly impossible for Morgan to assess how much staff the District can maintain next year.

"We are so uncertain about the categorical funding," said Morgan. "I am worried that this list didn't go far enough. We sat and looked very carefully to try and keep staff. I am hopeful that at the next meeting, we won't have additional names on the list... but I'm just not certain."

While maintaining teaching positions is important to the Board, Morgan noted that keeping the District from financial insolvency is also a very serious matter and that finding a balance between the two is essential. "This Board has made it very clear to me that maintaining positions is important," said Morgan. "But fiscal solvency is also important. We need to find a balance."

Board member Alexandre Monteiro urged teachers to stay positive about the notices. He mentioned that rarely does the District have to cut as deeply as the number of layoff notices would imply. "One thing to keep in mind is that history has been on our side," said Monteiro. "We call almost everybody back...last year we gave notices to 45 teachers and called 41 back. There are good signs out there. We should stay positive about this. It's not a death sentence." •



# Hawthorne Leaders Host Deferred Action Event

With the help of 30 volunteers, Hawthorne City Councilmember Alex Vargas, his brother and School Board member John Vargas, and the Southeast Leadership Network hosted a free workshop providing information to local families about deferred action. The February 22 event attracted more than 200 people seeking guidance and assistance from the lawyers present who volunteered their time to provide the free service, as opposed to

arrived early to ask about the options for her 14-year-old son Carlos Gomez, who was brought to America as a baby. "More than anything I want to ask for information to see if they can do anything for my son, who is still in school," Rodriguez said. "I would like for him to obtain his documents so that he won't have to struggle to go to college."

In promoting the workshop, Alex Vargas and his colleagues did everything they could to raise awareness, including appearances by the

the fee which ranges from \$250-\$500 per applicant.

"The workshop allowed people to ask questions and more importantly to have assistance in properly filling out their applications [deferred action]," Alex Vargas said. "People were guided step-by-step by expert immigration lawyers. These lawyers were talking people through this process while avoiding the high cost that some of these predatory law firms out there are charging and taking advantage of the community. Everything was free for the applicant. It feels wonderful being able to just connect people and seeing the joy in their eyes knowing that there are people out there willing to help and give them the information that they need."

Deferred action is a process introduced by the Department of Homeland Security in which certain young people who were brought to the United States as young children without proper documentation but who do not present a risk to national security or public safety can have their deportation deferred for a period of two years. If the individual meets key criteria, they will be considered for relief from removal from the country or from entering into removal proceedings.

"It is very important that the readership out there realize is that this is not amnesty--there are detractors out there, but the truth is that this is not amnesty," Alex Vargas said. "It is not a pathway to citizenship. All of that has to be determined by Congress. What deferred action is doing is that it is deferring dislocation and allowing for those students that were brought here to this country by their parents, through no will or fault of their own, to be able to continue studying and to work legally for at least two years."

Hawthorne resident Maria Rodriguez found out about the workshop at her church and

Councilmember on television. "The Southeast Leadership Network, which is a collaborative of leaders, instituted about 25 workshops and they were able to have a collaborative of immigration lawyers," Alex Vargas said. "So I and my brother John Vargas, through our networking abilities and with friends like Vice Mayor Pedro Infanzon from Bell Gardens, decided to put together a program like this. We spoke to him [Infanzon] and collaborated with him and we went all out promoting this event in the City of Hawthorne. This was a free workshop and the first time something free like this comes to Hawthorne and people were very appreciative."

For Alex Vargas the immigration issue is one that is yet to be determined by the leadership in Washington, but he believes that at the local level more can be done with the resources being made available by the federal government. "I think it is very important and we have to really see the makeup of our community and that there is a need for these things," Alex Vargas said. "Immigration reform is something that has been brought up nationally, statewide and locally. While Congress, Republicans and Democrats in the Senate and in the House of Representatives are battling it out, they are still using immigration reform as a form of political football. We have something that could benefit the community--so while they duke it out politically in Washington, we need to do what we can to benefit our community. It is about actions and not just words and this is simply delivering what has already been mandated. Congress has to take care of this [immigration], but it would be a travesty if somehow those students and youngsters that have been in this country their whole lives were to be uprooted. This simply provides a two-year incremental relief for them." •

# Turning Their Season Around Joe's Sports

No matter what the people are saying, however, it is evident that the Los Angeles Lakers are turning their season around. Perhaps the team has been inspired by the unfortunate passing of Dr. Jerry Buss and the emotional tribute that was paid to the man who built the team before they went out and dismantled the Boston Celtics. Perhaps the increase in intensity is due to a more active and healthier Dwight Howard who has finally looked like Lakers fans have expected him to look all year long. No matter what the real reason is, it is clear that a motivated Howard, Kobe Bryant and Lakers team as a whole is a team to be reckoned with going forward. Once the team was finally healthy, however, they went on to beat Peyton Manning and Tom Brady, amongst others, to eventually win the Super Bowl. The Lakers look as if they may have a chance to follow that same script. Steve Nash is finally healthy and looks as if he will be a key contributor for the Lakers during this stretch run. Clearly, it has been helping the entire team. In the first five games after the All-Star break, the Lakers put up an impressive 4-1 record while scoring just over 110 points per game. Currently, the eightman rotation that D'Antoni has settled on is paying dividends for the club. "It really helps out, especially on the bench, knowing when you're coming in, knowing what your role is," Jamison said. "You're not worried about shots or minutes or, 'If I make a mistake, I'm coming out." That comfort within the system is perhaps the entire reason why the Lakers are now comfortable with each other and in turn succeeding.

What lies in store for the Lakers, especially considering their tendency to be consistently inconsistent this year, remains a mystery. The only thing that is known now is that the year is slowly getting better for the purple and gold. Still without a playoff spot intact, there is a lot of work to be done, to say the least, with many tough teams remaining on the schedule. But the Lakers themselves are turning into a tough team to beat and should only continue to get better as they get more and more comfortable with each other. Kobe Bryant predicted that these Lakers would indeed make it into the playoffs. When they get there, as Kobe said himself, they will "have no fear of anyone--Oklahoma City, San Antonio, Denver ...whoever." Maybe those teams should start thinking about fearing the Lakers. •

The Sentinels are seeded seventh and the top seed is their Ocean League foe and champion Santa Monica, which captured the Southern Section Division IA title with a 66-56 victory over El Toro last Saturday at the Anaheim Convention Center Arena.

The Cougars resume the tournament through this week before hosting cross-town rival Leuzinger in non-league action next Tuesday at 3:15 p.m. The Olympians are 1-3 after getting blasted by Simi Valley Grace Brethren 13-1 Friday at Leuzinger. Angel Villa went two for three for Leuzinger. •

# **SoCal Regional Occupational Center: Impacting Lives for More Than 45 Years**

### By Cristian Vasquez

Providing career technical education has been the mission of the Southern California Regional Occupation Center since its inception in 1967. However, the status of services and resources provided by this unique educational resource is in an uncertain situation.

Based on Governor Jerry Brown's recent budget proposal, regional occupational centers across the state would receive zero dollars in funding, putting at risk the continued existence of places like SoCal ROC.

"The unfortunate part where we are right now is that programs like ours, regional occupational centers, and other career technical education programs have no budget," SoCal ROC Superintendent Christine A. Hoffman said. "For the past 30-plus years, the State has always funded ROC/Ps in the state of California. You can imagine that is very disconcerting to us because this place has been here for 46 years and it is really an icon in the South Bay in terms of providing career technical education to more than 9,000 students and adults."

The courses provided by SoCal ROC

the courses offered at SoCal ROC also meet the University of California's A-G entrance requirement courses, which appeal to many of the high school students.

"I really enjoyed it here. I took the fundamentals of nursing class two semesters ago and I found out the differences between medical assisting in nursing, which doesn't seem like much but there is a major distinction," El Segundo High School senior Kyra Noel Wopschall said "The people you meet here are great. It takes about a week or two to get comfortable with the class, but once you do you make a lot of good friends. I have also had some really excellent teachers that I have connected with and one of them actually wrote me a letter of recommendation. Also, I really wanted to be in the medical field. I don't have straight As and I'm not a 4.0 student, so I found a way of getting ahead in my medical field career. This really helps."

Wopschall, who will be attending Mt. St. Mary's College in the fall to complete her BSN Nursing Program, has known she wanted to be in the medical field since she



to be in," Wopschall said. "It is very broad and there's so much out there. I knew that I didn't want to be a doctor. At first I thought I would be interested in doing the lab work, but I don't want to do that either. So I decided to do nursing because that within itself also has a lot of different options."

Through pathway courses, SoCal ROC links students with experiences as close as a work environment setting in the field in which they are interested. For instance, students interested in sports medicine can have first-hand exposure to physical therapy aid

clay models that are used in the videogame designs," Hoffman said. "For those students that are part of that JPA, they are coming here after the regular school day. If there is room in our classes after we address the needs of our students in the JPA, any high school student can come here from wherever. They have to get here on their own and we do have students coming from places like Long Beach, Orange County and we even have somebody coming from the San Bernardino area. Why? Because they can't give these programs at the high school campuses."

reach high school students in six of the surrounding school districts (Torrance, Palos Verdes Peninsula, Redondo Beach, Manhattan Beach, El Segundo and Inglewood), which agreed to participate as a consortium under a joint powers authority. As a result, all high school students in these districts have priority registration for the courses offered at the SoCal ROC location.

"Guidance specialists are assigned to work with the high schools within those districts and they will go out and talk with the students about what their future career interests are," Hoffman said. "Whether they want to be engineers, doctors, welders, work in construction or fashion design, the guidance specialists are there to speak with students and to help them."

These guidance counselors emphasize to students that they can study classes pertaining to any career interest they might have while in high school so that the student can obtain a better understanding of what the career entails and what type of schooling will be involved. In addition, more than 20 percent of

or personal training and decide which route they want to take when in college. Every academic program has pathway courses where the student can decide to continue pursuing additional courses within a given field.

"Some of the programs are an extension, a pathway, that maybe they started at the high school. They can come here and they can take anything from videogame design, animationthere is of course in that pathway a course called creature sculpting where they do the SoCal ROC also has courses for adults, at a nominal fee, looking to enter a new field, or for those who simply want to move ahead in their current career. Through the help of more than 250 partners, many of them local, SoCal ROC tries to continue having a strong impact on the lives of the students that walk through its doors.

"Not to have money budgeted is a real shock because the State budget begins July 1, so we are very, very much involved right now with our local and State elected officials from around the area," Hoffman said "They are the ones that for the next two months will debate and discuss all of the parts of the State budget and what we wanted to remember is that SoCal ROC as of now has zero dollars budget and it needs to be fixed. We think, as well as they [elected officials] at this point, that this is an oversight. There is a lot of details to the State budget, so we believe that is an oversight and we just want to make sure that there's enough time in order to get the information to them--to get information out to the whole South Bay to let them know where things are right now, but that there is enough time to fix it before a final State budget is adopted."


My favorite is Asian. This is a blend of the flavors of the far east without the over powering heavy sauce.

1/4 cup chopped pickled ginger (the kind you eat at a sushi bar)

1/2 cup brown sugar

2 tablespoons chopped garlic
