Term Limits, Mayoral Election Spark Lengthy Council Discussion

With only a few items to consider on the consent calendar at Tuesday's regularly scheduled City Council meeting in Hawthorne, it was a good bet that the evening would progress smoothly without much controversy on the dais. However, both of the resolutions placed on the agenda were tabled for lack of information that left two members of the Council unable to vote. So, opposition to any LAX expansion efforts may come back at another time.

A request by a neighborhood to give designated preferential parking on 126th Street between Birch and Cedar Avenues was questioned by Councilmember Alex Vargas as to the validity of some signatures on the required petition that allows the applicable ordinance to take effect. Chief of Public Works Arnie Shadbehr explained that his department examined the petition and any incorrect streets were corrected in the final paperwork. However, Vargas received a 4-0 vote to his motion to table the request.

In other business, the annual assessments for landscaping and street lighting improvements were approved and weed and waste abatement, also an annual assessment, was approved.

Two members of the Hawthorne Chamber of Commerce were appointed to the Board of Directors of the South Bay Workforce Investment Board (SBWIB) for a four-year term. Jay Fowler, General Manager of Republic Services; and Patricia Donaldson, CEO and owner of Active Security, will be presented to the City of Inglewood (which administrates SBWIB) for ratification.

Hawthorne Police Chief Robert Fager made a presentation to Officer Kevin Pedersen, who recently received the Distinguished Service Medal of Valor for saving the life of a resident with quick response and administering of CPR measures. Pederson was also singled out for his kindness to the spouse of the victim, escorting her to the hospital and staying with her until friends and family arrived. Pedersen has been a Hawthorne police officer for four years.

The Hawthorne Women's Club, the oldest service club in the community with a charter that began on March 17, 1917 (five years before the City's incorporation) received a proclamation for the services demonstrated to various local charities. Darlene Love, current First Vice President, accepted on behalf of the club.

In a discussion item presented by Vargas, term limits and campaign reform sparked a lengthy discourse by several members of the Council, including Nilo Michelin and Mayor Pro Tem Angie Reyes-English. Vargas' initial presentation a few months ago involved a motion to eliminate the separate election for Mayor, with elected Council members serving in the role for a one- or two-year term based on a rotation by seniority. It was discovered that a separate ballot measure would incur a \$10,000-\$20,000 cost per measure approved by the County Registrar.

Further discussions noted that other municipalities that attempted to change how a mayor is elected have all had the measure fail by wide margins. Vargas therefore decided that he would take his initial motion off the table. His second offering suggested that an individual elected to the Council be allowed to only serve a total of 12 years--either three consecutive terms as a Council member or four consecutive two-year terms as elected Mayor, for a term limit of a combined 12 years lifetime. The motion failed after a split vote, with Mayor Danny Juarez and Vargas approving and Reyes-English and Michelin dissenting.

Michelin then put forth a motion for an alternative of only two consecutive terms as a Council member or four two-year terms as Mayor, which could be a total of 16 years on the dais. The motion failed 1-3, with Michelin casting the only yes vote.

Reyes-English is opposed to making any changes and stifling anyone who wants to serve by running for office. She argued that one should be allowed to give back to the community, effect change and perform a service

for as long as the people want to reelect an individual. She also opposed spending dollars from City reserves for a ballot measure she deems unnecessary.

City Attorney Russell Miyahira pointed out a firm County Registrar deadline of June 30 for any ballot measures to be presented. A decision to add a ballot measure to the November ballot will need more than three business days after the next Council meeting in order for the wording to be prepared and the measure(s) to be submitted on time. However, Reyes-English then suggested that the next Council meeting include a discussion/action item to change the separate mayoral election to a four-year term.

A disclosure statement to be signed by City staff who may talk with a former elected official or a former City department head was given the go-ahead to be discussed by the City Manager with Staff Executive Board. The City Manager will report the reaction of the Executive Board and whether they believe it is a matter of infringing on the staff's rights to speak to anyone who approaches them.

A workshop for presentation of the 2013-2014 fiscal year budget to commence on July 1, 2013 will be held Friday, June 14 at 6 p.m. in the Council Chambers.

Saturday, July 20 at Civic Center Plaza, the annual Good Neighbors Day will be held with the theme "An Old-Fashioned Picnic." There will be entertainment, service organization vendors who will raise funds by selling food and drinks, and a car show. The Hawthorne Historical Museum will also be open to the public. Festivities will begin at 10 a.m. and continue until 4 p.m. Various picnic games will be held for prizes to the winners and service groups are encouraged to put a team together to participate. There will also be an art contest for those who want to enter a rendering of a mural that will be painted on the building walls of the museum, with the theme "Hawthorne Past."

The next Hawthorne City Council meeting will be held on Tuesday, June 25 at 6 p.m. •

Goal 2.0 of the Land Use Element of the 1989
General Plan, as amended, stating that the City
Hotel make ourse offer the control of the the city shall make every effort to ensure that both existing and future development will be and will remain compatible with surrounding uses. The properties are located between the 105 Freeway and the Hawthome Municipal Airport and therefore the Change of Zone and General Plan amendment would permit more flexibility in the development of the properties in the future.

Looking Up

Music of the Spheres: Star Songs

Plato, the Greek philosopher and mathematician, described music and astronomy as "sister sciences" that both encompass harmonious motions, whether of instrument strings or celestial objects. This philosophy of a "Music of the Spheres" was symbolic. However, modern technology is creating a true music of the spheres by transforming astronomical data into unique musical compositions.

Gerhard Sonnert, a research associate at the Harvard-Smithsonian Center for Astrophysics, has published a new website that allows listeners to literally hear the music of the stars. He worked with Wanda Diaz-Merced, a postdoctoral student at the University of Glasgow, whose blindness led her into the field of sonification (turning astrophysical data into sound), and also with composer Volkmar Studtrucker, who turned the sound into music. "I saw the musical notes on Wanda's desk and I got inspired," Sonnert says.

Diaz-Merced lost her sight in her early 20s while studying physics. When she visited an astronomy lab and heard the hiss of a signal from a radio telescope, she realized that she might be able to continue doing the science she loved. She now works with a program called xSonify, which allows users to present numerical data as sound and use pitch, volume or rhythm to distinguish between different data values.

During a visit to the Center for Astrophysics in 2011, Diaz-Merced worked with data from NASA's Chandra X-ray Observatory. The data was from EX Hydrae—a binary system in the constellation of Hydra, consisting of a normal star and a white dwarf. Known as a "cataclysmic variable," the white dwarf fluctuates in X-ray brightness as it consumes gas from its companion star.

Diaz-Merced plugged the Chandra X-ray data into the xSonify program and converted the raw data into musical notes. The results

sounded random, but Sonnert sensed that they could become something more pleasing to the ear. He contacted Studtrucker, who chose short passages from the sonified notes--perhaps 70 bars in total--and added harmonies in different musical styles. Sound files that began as atonal compositions transformed into blues jams and jazz ballads, to name just two examples of the nine songs produced.

The project shows that something as far away and otherworldly as an X-ray-emitting cataclysmic variable binary star system can be significant to humans for two distinct reasons—one scientific and one artistic.

Sonnert explains that in creating music from stellar information, "We're still extracting meaning from data, but in a very different way."

A Little Night Music

The thought of "Music of the Spheres" goes back well over 2,000 years to the time of Pythagoras. He proposed that the Sun, Moon and planets all emit their own unique "hum" (orbital resonance) based on their orbital revolution-periods, and that the quality of life on Earth reflects the tenor of celestial sounds which are physically imperceptible to the human ear. Subsequently, Plato described astronomy and music as "twinned" studies of sensual recognition: astronomy for the eyes, music for the ears, both requiring knowledge of numerical proportions to be appreciated.



On April 25, of this year Rep. Karen Bass' H.R. 1732: Strengthening the Child Welfare Response to Human Trafficking act of 2013 was assigned to a congressional committee. The resolution, which seeks to "develop and publish guidelines" to help "State, Indian tribe, and tribal organization child welfare agencies" to better serve children who are victims of trafficking as well as any youth who are at-risk of becoming victims, is in the very early stages of becoming a law. In reality, many resolutions sent to committee rarely get passed that first phase. Furthermore, www.govtrack.us gives the resolution a 0 percent chance of getting past committee, let alone being enacted.

Whether Rep. Bass' resolution becomes a law or not it addresses the issue of child trafficking and what to do with these victims. Rep. Bass, from California's 37th District, is bringing to the forefront the issue of children being taken across international borders. The resolution seeks to include various federal agencies to address this problem, which in California has been an ongoing issue throughout the state's history. From the Department of Justice, the Federal Bureau of Investigation, the Department of Homeland Security, and the Trafficking in Persons Office of the Department of State, Rep. Bass seeks to approach the issue in a more comprehensive manner. Traditionally our laws have dealt individuals crossing our borders through our criminal courts. For the most part, anyone entering the country illegally should be held accountable in criminal court, but when it comes to children we need to take a different approach and Rep. Bass' resolution is a step in that right direction.

When an adult decides to enter the United

States illegally, however compelling their reasons might be, it is a crime and they should be prosecuted as such. Yet, when a child is taken across international borders into America we need to do what is best for the child, rather than simply processing and deporting them. When children reach American soil it is more often than not the result of an adult's efforts to bring them here. Usually it is a parent bringing a child but in many instances children are brought here by human trafficking rings to work in sweat shops or as sex slaves. These are two extreme examples of children being brought to American through no fault of their own but they are directly linked to what Rep. Bass's resolution seeks to accomplish.

While these minors are on American soil illegally, they were also brought here to be exploited and as victims of exploitation, they should be treated differently by the authorities. I am not suggesting that any child that enters America through a human trafficking ring should receive immediate permission to stay in the country. Nor do I agree with the resolution's intent to "establish safe residential placements for foster youth who have been trafficked (as so defined)" if the intent is to make this permanent. Yet, we should do more to ensure that the victim can go home and not fall into the hands of similar human trafficking rings.

The main focus should be on prevention. Our policy makers must find a way to curb human trafficking, especially when it comes to children. Adults make conscience choices to cross a border illegally and take on low-paying jobs. Minors have no say in that decision, for the most part. They are only criminals by definition but victims through the actions of others. As victims, our laws should do more than process and deport them.•

 Are you being passed up for promotions,
- raises or other kudos at work?Does your family complain about the volume
- level of your TV?Have you stopped participating in the sports
- and hobbies you used to enjoy?

 If so, it may be time to get your hearing checked. If you already know you aren't hearing as well as you used to, then it is probably time to buy a pair of hearing aids.

Next steps

The first step is to contact a hearing care

- Virtually invisible hearing aids so that no one but you and those closest to you will know why your hearing has vastly improved.
- Robust waterproof, dustproof, shock-resistant hearing aids (like Siemens Aquaris (R)) that let you fully participate in sports and other events with family and friends.
- Remote controls and streamers for hearing aids that let you control the volume and listen to TV and audio devices without disturbing other listeners.

Once you can hear everyone, family, friends and business associates will no doubt welcome you back as an active and engaged participant in their lives. •

Your Financial Life After Graduation

To the millions of college and high school seniors who recently graduated (and to their parents, who weathered the ups and downs of reaching that summit): congratulations on a job well done. After the celebration dies down, you'll no doubt be eager to embark on life's next chapter, whether it's finding a job, preparing for college

or enrolling in military or community service.

Before you jump in feet first, however, let me share a few financial lessons I learned the hard way when I was just starting out. They might save you a lot of money in the long run and help you get closer to your life goals, whether it's buying a house, starting a family or even retiring early – as far off as that may sound.

First, pretend you're still a starving student. After landing your first full-time job, the urge to go on a spending spree for new clothes, a better apartment and a car from this decade will be irresistible after surviving on ramen noodles for four years. But unless you had generous scholarships or a rich aunt, you're probably already saddled with thousands of dollars in student loan debt.

(Note to entering freshmen: Tread carefully around student loan debt. The Consumer Financial Protection Bureau (CFPB) has a great guide for making informed decisions about paying for college at www.consumerfinance.gov/students.)

After you've factored in rent, car payments, renter's and car insurance, credit card charges, student loan balances and other monthly bills (not to mention payroll taxes such as Social Security tax, which went up 2 percent this year), your new salary probably won't go as far as you'd like, especially if you're trying to save for one of those life events.

That's where a budget can help. Numerous free budgeting tools, including interactive calculators,

are available at such sites as the government-sponsored MyMoney. gov (www.mymoney.gov), the National Foundation for Credit Counseling (www.nfcc.org), Mint. com (https://www.mint.com) and Practical Money Skills for Life (www.practicalmoneyskills.com), a free personal financial management program run by Visa Inc.

Next, know the score, credit-wise. Many people don't realize until it's too late that a poor credit score can trash your financial future. After you've missed a few loan payments, bounced some checks or exceeded your credit limits, you'll probably be charged higher loan and credit card interest rates and offered lower credit limits (if not denied credit altogether), unless and until you can raise your credit score. You may even have to pay higher insurance rates and harm your ability to rent an apartment or get a cell phone.

To know where you stand, review your credit reports from each of the three major credit bureaus (Equifax, Experian and TransUnion) to find out whether any negative actions have been reported and to look for errors or possible fraudulent activity on your accounts. You can order one free report per year from each bureau if you order them through www. AnnualCreditReport.com; otherwise you'll pay a small fee.

To learn more about credit reports and scores, visit the CFPB's "Ask CFPB." Another good resource is What's My Score (www.whatsmyscore.org), a financial literacy program for young adults run by Visa, which features a free, downloadable workbook called, "Money 101: A Crash Course in Better Money Management," and other free tools.

You worked hard to graduate. Just make sure you don't sabotage your efforts by starting out on the wrong financial footing. •
