

City Council Denies Legal Claim Filed by Dog Owner

With the room nearly fully occupied, the City Attorney's Consent Calendar contained one item at the Hawthorne City Council meeting on Tuesday, August 13 with a recommendation to deny a claim filed by the owners of the Rottweiler that was shot and subsequently died after an incident involving the dog owner and the Hawthorne Police Department. The claim alleged emotional distress on the minors in the family at the loss of the family pet. The Council voted 5-0 to deny the claim filed by the Rosbys on behalf of their children.

In a public hearing, which included a presentation by a representative of McDonald's Corporation who defended the way the new store and drive-through would be an asset to the community as part of a complex being built at the southeast corner of Rosecrans Avenue and Yukon Avenue, several members of the public voiced their opinions against the drive-through in particular--stating that the quality of life would be compromised for those who live directly adjacent to the property in an eight-unit townhome on Yukon Avenue. Another comment was in favor of the building of a McDonald's, after many citizens had been queried on their opinions of the fast food chain adding to its presence in Hawthorne.

The Council voted 5-0 in favor of the construction of the McDonald's with a drive-through at the corner of Rosecrans and Yukon under a Conditional Use Permit, thus overturning the denial by the Planning Commission of the same petitioned construction.

Other business included the approval of a four-way stop sign installation at the intersection of Ramona Avenue and 141st Street. The Hawthorne Police Department will make a point of patrolling that specific area to remind drivers of the placement of the new signs.

A resolution was approved to establish a Veterans' Affairs Commission to give a "voice" to veterans who live in the city.

Members of the new commission must be residents of Hawthorne. The resolution to establish a Senior Citizens Commission for those residents with an interest in senior citizen matters was inadvertently omitted from this evening's agenda and will be part of the agenda for the August 27 Council meeting. This commission would come under the guidance of the Recreation and Parks Department.

City Risk Manager Dennis Hernandez presented a proposal for a \$201,871 premium for earthquake insurance in the amount of \$7 million with a five percent deductible of appraised real estate property value for City Hall, the Memorial Center, Sports Center, Senior Center, and the three Fire Stations--all buildings owned by the City of Hawthorne. The five percent deducible would be the starting point for any FEMA dollars that could be granted in the case of any damage caused by an earthquake that would adversely affect the construction integrity of any of the buildings covered by the insurance. The seven-mile proximity to the Inglewood Fault Line is a major reason to purchase this earthquake insurance. The buildings have a combined appraisal value of \$62.7 billion. The Council will take the earthquake insurance recommendation under advisement and put a resolution on a forthcoming agenda.

The five vendors for the city-wide tree trimming project were presented and Director of Public Works Arnold Shadbehr was asked to choose the bidder who meets all the requirements, including the lowest bid amount in accordance with the State of California precedence set for bidding projects. Shadbehr suggested that it is not always the lowest bidding vendor who is chosen if one or more of other requirements are not met, with every effort made to choose the best vendor to service the city.

The Congestion Management Program (CMP) was deemed to conform to the California Government Code under which the CMP is developed. With no citizen input at the public hearing, the CMP Local Development

Report will be submitted to the Los Angeles County Congestion Management Program.

A new unmarked Police Department vehicle purchase was approved in the amount of \$30,353.23 and services of TTG was approved for Fire Safety Engineering at the Air Traffic Control Tower at Hawthorne Municipal Airport.

The Council also approved destruction of Police Department internal records for the calendar year 2007. However the resolution to destroy miscellaneous Finance Department records was pulled from the agenda to validate that no records relating to HUD actions are part of the destruction action, despite the electronic copies of all records that are part of the archives. The Holly Park Homeowners' Association petition for replacement of equipment at Holly Park, to include picnic tables, barbecues and benches, will be made part of the 2014 budget process at the cost of \$19,800.

The City Manager was approved as the chief labor negotiator for the City employee contracts for the Hawthorne Executive Group and the Hawthorne Municipal Employees Association as the contracts come up for renewal of terms.

Mayor Danny Juarez directed Planning Director Gregg McClain to investigate the individual homeowner property encroachment issue at a property at Imperial Highway and Grevillea Avenue and advise the property owners of how to deal with the encroachment.

The filing period for candidates who are seeking public office in the November 5 election was closed on Friday, August 9. City Clerk Norb Huber publicly thanked his staff for their excellent work in coordinating all the paperwork that needed to be filed with the Los Angeles County Registrar. All information for each candidate had to be validated prior to filing. There are candidates for City Clerk, City Treasurer, two City Council seats, and the Mayor's position. Those interested in the names of those who filed papers to appear on the ballot can research the Registrar's website.

The next City Council meeting will be held on Tuesday, August 27 at 6 p.m. •

Indoor Soccer Leagues Off to Good Start

In its first year of operation, the Hawthorne Recreation Futsol (Indoor soccer) leagues are off to a very good start. The adult leagues have already played several games and the youth leagues currently finished off their third matches Saturday at the Betty Ainsworth Gymnasium.

There are a total of 25 adult and youth teams in three separate leagues--the adult, youth under 15 years old, and under 10. There are youth squads for boys and girls.

The adult league consists of eight teams, predominantly named after various well-known squads throughout the world. It includes league leader Anthrax, which after the July 27 contests displays an outstanding record

of 11 wins, one loss and one tie for 34 points. Futsaleros (9-3-1) is in second place with 28 points, while San Julian (8-2-2, 26) is in third. Rounding out the rest of the league are Javentud (8-7, 21),

LCFC (6-7-2, 20), Barcelona (4-8-1, 13), CD Jaguares (4-8-1, 13) and Arriva Peru (3-9-1, 10).

There are also seven teams for youth under 15 years and six for those under 10 years old. Currently leading is Juventus with a 2-0 record for six points. Other teams for under 15 include LCFC A, LCFC B, Xolos, La U, Real Madrid and L.A. Thunder. In the under division are leader Real Madrid (1-0, 3), Real Espana, Thunder, Inglewood, LCFC and KIS.

"We were off to a slow start," Futsol official Leo Yanes said. "We started out with a lot of scrimmages. Little-by-little, the teams are starting show improvement.

For indoor soccer in the Ainsworth Gym, the court is an estimated at 20 by 50 meters. With it, some of the games get rather physical with the ball bouncing rather dynamically on the floor and the walls. "We're hoping to get more teams and more kids involved," official Chris Race said. "This gives kids something to do. We're looking to get good community support."

Yanes and Race both hope to start outdoor soccer, as they are seeking a place to play either at a local park, high school or both.

For the adults, this Saturday is the final league matches before they begin the playoffs on August 16. Youth playoffs are expected to start in a few weeks. Games are played at the Ainsworth Gym from 4-10 p.m. on Saturdays.

Lakers' Season Outlook

The Los Angeles Lakers have been one of the most successful franchises in the National Basketball Association since the league's inception. With that great success there naturally comes a more and more demanding fan base. The people of Los Angeles who cheer on Atlanta Hawks and--soon after--a matchup with Dwight Howard in his newly tailored Houston Rockets' uniform. All in all, the Lakers could be looking at an 0-6 or 1-5 start to the regular season.

the Lakers expect success on a year-in and year-out basis. When they don't get it, there always has to be a scapegoat. Take for instance last year's great expectations measured together with the poor final product. Mike D'Antoni was at the head of the line to take blame for the team's poor play. Fans everywhere wanted him out of town and clamored for Phil Jackson's return. If it wasn't D'Antoni taking the heat, it was Dwight Howard. Well, if the fans of Los Angeles thought the last two seasons were bad, their patience will really be tested this season. The release of the 2013-2014 schedule demonstrates exactly why the Lakers and their fans should be ready for, and maybe even embrace, one of the most futile seasons that the organization has had in the last 15 years.

Think back to the summer of 2012. Oh, how great it was. Dwight Howard decided to sign with the Lakers and on July 4, our country's very own Independence Day, Steve Nash seceded from the Phoenix Suns and joined forces to create a "super team" in Los Angeles. Not so super. A coaching change, disagreements with blueprints and schemes and tons of injuries later, the Lakers lost the war for their freedom and became just another casualty in the first round of the playoffs. Now, the Lakers have been left in a less than desirable position stemming from those circumstances. Howard is gone. The llost war brought a swift end to Metta World Peace (who now finds himself in New York with the Knicks), and the Lakers are hanging on to several one-year contracts with the intent to be entertaining, if not competitive, amidst a league of youth, speed and talent. Though the Lakers will be able to start fresh in 2014, the moves that they have made are not enough to help them be competitive in this upcoming season.

If you take a quick glance at the Lakers' upcoming schedule, it quickly becomes apparent that there will more than likely be more chants for the firing of D'Antoni within the first week or two of the season. The city's own purple and gold open up the 2013-2014 campaign against inner-building rivals the Los Angeles Clippers. That's the newly restocked and reloaded Clippers headed by Doc Rivers, who will most certainly look to make a statement on opening night against a Lakers' lineup that will most likely be devoid of Kobe Bryant. If the Lakers wish to have any chance in the first week of play, they'd better hope that Bryant hobbles back on to the court sooner rather than later. After the Clippers, it's the Golden State Warriors, followed by the San Antonio Spurs,

to his new Achilles and in full effect for the Lake Show. If they wish to put on any type of show, however, it's going to have to be against the Clippers, Rockets, Warriors and Spurs all over again with a game against last year's Western Conference Finals competitors the Memphis Grizzlies to top it off. So what does this breakdown of the schedule tell us? Well, if the Lakers aren't going to do damage early—and they certainly shouldn't be looking to do damage late in the season--then they are going to need a pretty epic run right smack-dab in the middle to be able to make any noise in the playoffs, or even just in this year's regular season. But what about the unpopular opinion that the Lakers shouldn't even try to make noise?

That's right--the Lakers should tank the season. One of the most unpopular opinions in all of sports... But it almost looks as if the league is trying to make up for the botched Chris Paul trade that would have had the All-Star point guard playing in the purple and gold rather than the red and white. With an extremely difficult schedule at both ends, a crippled Bryant and a roster full of names that will leave most casual NBA fans scratching their heads, it seems as if the NBA is almost asking the Lakers to tank. The league is always better when the Lakers are competitive, and surely executives of the NBA know that. Tanking the season this year will be the best thing that the Lakers can do in order to become extremely competitive next year. First of all, it will allow Kobe to sit on the sidelines and heal for a longer amount of time, it will finally get D'Antoni out of the head coaching chair and it will get the Lakers into the draft lottery.

It has recently been reported that the Lakers have the worst talent in the league for players under the age of 25. An old and slow Lakers' team is something that fans here in Los Angeles have had to put up with for years now and it is showing no signs of getting better. A horrific season this year will help to outweigh that in next year's draft--a draft that is touted to be the best since the 2003 season when LeBron James, Dwyane Wade and Carmelo Anthony all burst onto the scene. All three of those players will be free agents as well, ripe for the Lakers picking (if you're an optimist). A New Attitude Towards Mental Health

The introduction of Senate Bill 330 by State Senator Alex Padilla is a reminder of the urgency with which we as a society need to look at the issue of mental health through a more academic lens. Currently there is no active process for reviewing any types of frameworks toward adopting instructional materials on mental health. These efforts have been suspended since July 28, 2009. Furthermore, the State Board of Education (SBE) is specifically prohibited from reviewing any frameworks and adopting any instructional materials until the 2015-16 school year. This bill requires that the next revision of the health curriculum should include a distinct category on mental health instruction.


As a society, we continue to struggle with understanding mental health issues for a wide range of reasons--the most significant being the stigma that exists for people suffering from mental issues and disorders. It is tragic that because we don't fully understand the effects of mental conditions on people and the many conditions that do exist, that we, as a society, have the tendency to lump all patients with mental disorders into the "crazy" category. These people are not crazy--they are ill and need care in a variety of forms. Unfortunately for many years, these patients have being stigmatized mainly because most people are not educated about the issue.

Not having a curriculum available to explain to students in the K-12 system what some of these mental disorders are, how they affect people and what the patient must go through will only delay the process of making the general public more aware and accepting of afflicted individuals.

Teaching kids and teenagers that suffering from a mental disorder does not make the patient a bad person is the first step in helping the person afflicted by the condition. Patients with mental illnesses or disorders are reluctant to reveal details of about their struggles because they don't want to be mocked or shunned. When this occurs, the conditions for the person afflicted become worse because they are being marginalized, thus limiting their ability to socialize and try to lead a normal life.

In 2010, when the Lakers beat the Celtics in game seven of the NBA Finals, then Lakers' small/power forward Ron Artest gave one of the most interesting postgame interviews I have ever seen. After saying hello to his old neighborhood, wife and kids, Artest thanked his psychiatrist. The NBA star, from the biggest stage he had ever set foot on, told the world that he was afflicted by a mental disorder. Artest admitted that his doctor was crucial in helping him "relax a lot"--and based on his performance that night, he wasn't lying. The admission from an NBA star, known for one of the ugliest fights in NBA history, that he had a mental disorder brought the issue national attention. Unfortunately in our social media world, these issues are trendy for a while and then quickly forgotten.

Hopefully Senate Bill 330 and Senator Padilla's efforts bring the issue back via an academic approach so that more people with mental disorders can seek the help to relax them, without any of the stigma. If Ron Artest could overcome his issues, then so through a proper academic framework can society overcome its issues with mental disorders. •




