## City Council Approves 10-Year **Development Agreement with SpaceX**

In what Mayor Danny Juarez called a moment that made history, the Hawthorne City Council on Tuesday night approved an economic development agreement with SpaceX Corporation. The agreement will run for 10 years, with an option for an additional 10 years. SpaceX business license fees shall not exceed \$260,000 per year. Any and all other fees for planning, building plan checks, building permits, engineering and/ or development impact shall be reduced to 25 percent of the total fees on a project-by-

Councilmember Olivia Valentine challenged Interim City Attorney Kunle Aderonmu on a City Clerk Consent Calendar item, asking to explain the warrants presented for approval that apparently include invoices to various outside law firms and/or consultant attorneys in excess of approximately \$40,000. Questions were raised as to the reasons for these invoices and Aderonmu stated (details are available in the City Attorney's office for inspection by Council members at any time) that public explanation for these or any invoices is protected by client-attorney privilege. However, Aderonmu said an excessive amount of expenditure was paid for outside counsel fees during the term of the previous City Attorney. The Council took a separate vote on the warrants item and Valentine abstained. Councilmember Alex Vargas cast the lone dissenting vote, with the item approved for all payments by Mayor Juarez, Mayor Pro Tem Angie Reyes-English, and Councilmember Nilo Michelin.

A resolution approved competitive grant funds for tree planting from the Los Angeles County Regional Park and Open Space District for the Hawthorne Boulevard Project for \$150,000 to plant up to 200 trees in city parks and parkways to continue the beautification projects in Hawthorne that began several years ago in various medians on major thoroughfares.

The City Attorney's Consent Calendar also came under scrutiny by Council members who asked to separate the two items for discussion purposes. However, they did not call for two separate votes. Vargas initially questioned an item for adding a second Assistant City Attorney and asked how many members of the City Attorney's department had been terminated since Aderonmu was hired in


Only through mutual, verifiable reductions in nuclear weapons can we begin to reduce the nuclear weapons threat.

#### Sents Rout Hawthorne; Set Stage for Showdown

Inglewood High's football team upped its Ocean League record to 3-0 by rolling over host Hawthorne 45-6 last Friday. The win set the stage for a league showdown at home against Santa Monica (5-3 overall, 3-0 in league) Friday at 7 p.m. The Vikings remained unbeaten in Ocean play with a key 17-3 home win over Culver City last Friday. A week earlier, the Sentinels topped the Centaurs 12-9 at Coleman Stadium.

Hawthorne, which fell to 1-7 overall, started off well and inspired for an upset win over Inglewood, which is keyed by Cougar transfer quarterback Rickie Calderon. Quarterback Paul Fuller tossed a 10-yard touchdown pass to wide receiver Erik Scott-Davis to give Hawthorne

a 6-0 lead with 4:11 left in the first quarter.

The Cougars continued to lead until the Sentinels tied the game at six on a one-yard run by Treavon Benton. From there, it was all Inglewood as it rolled to a 20-6 halftime lead and then continued to pour it on Hawthorne

The Sentinels took the lead for good with 3:09 remaining before halftime when Calderon threw his first of four touchdown passes to Terrance Harvey from 32 yards out. Inglewood led 20-6 with 29 seconds to go before intermission on an eight-yard TD pass from Calderon to Damien Hamilton.

Calderon and company were only warming up as they finished off the Cougars with 25 more unanswered points. On the Sents' first possession of the second half, they drove 78 yards in seven plays, capped by Calderon's 18-yard scoring pass to Jenaeth Johnson. With 2:10 remaining before the end of the third quarter, Calderon found Zaire Andre for a 34-yard touchdown, giving Inglewood a 35-6 bulge. A 28-yard field goal and a 65-yard punt return by Andre finished off the scoring for the Sentinels.

"It was not easy," Calderon, who transferred to Inglewood from Hawthorne over the summer after Joseph Kanach (who recently resigned midway in the season as head football coach at Alhambra High) stepped down after last season's 5-5 slate, said. "We played our game. We're getting ready for Santa Monica." Calderon had an outstanding game against his former team that is for the third time under head mentor James Swain, completing 19 of 24 passes for 269 yards and four TDs.

Defensively, Inglewood held Hawthorne to just 102 total yards on offense, including 34 passing and 68 on the ground. "We must play hard for a win," Swain said. "We must take care of the ball. We kind of shocked ourselves for a little bit. Inglewood has very good athletes."

The Cougars will have their best shot at a league win as they visit a young and inexperienced Beverly Hills team, also 1-7 overall and 0-3 in league, Friday at 7 p.m.

## El Camino College Looks to Bond **Measure to Shore Up Aging Facilities**

El Camino College officials hope district voters will give the go-ahead on November 6 to a \$350 million bond measure to replace and renovate many of the campus' aging buildings. According to the bond information flyer, Measure E monies "will be used to make safety, technology and energy-saving improvements to classrooms, labs and other instructional facilities." The list of projects for the Torrance-based campus includes expanding science labs, upgrading outdated electrical systems and wiring, improving facilities for veterans, enhancing training facilities for nurses and firefighters, adding classrooms and improving site accessibility and safety. By conforming to California green building standards and promoting environmental responsibility, El Camino expects to save \$1 million annually in energy, water usage, maintenance and operating costs.

The proposed bond comes a decade after El Camino's successful \$395 million initiative in 2002 also called Measure E. College officials describe the new measure as a "bond extension" to complete the upgrades needed at the campus that opened in 1947. "Many of our buildings and facilities are more than 50 years old now-some are nearly 65 years old," said El Camino Superintendent/President Thomas M. Fallo. "They have been well-maintained, but like any structures of that age, they need repairs and renovations."

Projects completed from the first bond include a renovated science complex, electrical/ fire alarm upgrades, new humanities building, new central plant, new learning resources center, new parking structure, remodeled bookstore and conference center, and a renovated social science building. Projects still in progress include a new STEM center, fire academy repaving, industry and technology building modernization, new shops Building, new kinesiology and fitness complex, parking lot F retrofitting and additional third level, new computer server room, restroom accessibility renovations, parking lot lighting and security upgrade and electrical and data conversion.

The bulk of the new bond monies would go towards replacing the kinesiology and fitness complex, counseling and student activities center, administration functions building, and music theater and arts complex. Renovations of the library and Marsee auditorium are also planned. The projects are part of the college's Facilities Master Plan that provides a longrange forecast for enrollment and changing

The State requires a 55 percent majority vote for the bond to pass. The first Measure E garnered 62 percent, making Fallo hopeful for an encore. "The people of the South Bay have really supported El Camino through the years with recognition and understanding,"

That recognition factor is off the charts when you consider the results from a recent poll of 700 voters in the district. "In the survey, 99 percent of the people said they had some association with El Camino—either through taking a class themselves or having a child or relative go there, or attending a performance," said El Camino Community Relations Director Ann Garten. "The pollster had never seen anything like it." The survey also indicated an El Camino favorable approval rating of 83 percent, with 68 percent of respondents saying they would support a bond extension (60 percent with knowledge of a tax increase). If passed, the bond will cost district homeowners \$7 per \$100,000 of assessed valuation on their properties. The original bond has fluctuated between \$16 and \$19 of assessed valuation, making a potential combined total of approximately \$26 per \$100,000 from the two measures. If the new measure passes, El Camino would still only be in about the middle of the pack in bonded indebtedness compared with the other dozen community college districts in Southern California.

An independent Citizens' Oversight Committee, in place since 2002, would continue to oversee the audited disbursement of the bond monies and keep the public informed of revenues. By law, funds from any proposed bond can only be spent on buildings, classrooms and instructional equipment. The funds cannot go towards administrator pensions or salaries and notably cannot be taken away by those folks up in Sacramento.

El Camino's current enrollment of 25,000 is down a bit from past years due to reduced State funding. "We're down close to 10 percent in funding and closer to 20 percent in classes we've offered," said Fallo. Garten elaborated further. "Giving us less money is telling us to educate fewer students since you have to offer fewer courses," she explained. "But the key is that if you are graduating from a high school in the district, you will get early registration

El Camino's district includes El Segundo, Hawthorne, Hermosa Beach, Inglewood, Lawndale, Lennox, Manhattan Beach, Redondo Beach and Torrance, though the campus is open access and available to students outside of those communities. That said, the percentage of new graduates who enroll at El Camino in fall semesters is unusually high compared to other community colleges. Forty percent of

new graduates move on to El Camino from Hawthorne, Redondo Beach and Torrance high schools, for example. The other South Bay cities range from 15 to 35 percent. El Camino also reports the state's number one transfer admission rate to UCLA and third highest to USC, as well as top 10 rankings in transfers to University of California (UC) and California State (CS) schools. At the same time, the costs to attend UC and CS systems have become increasingly prohibitive, leading students to rely on El Camino more than ever as a viable and affordable academic alternative.

Opponents of Measure E contend that the bond will only fund construction projects and not classroom instruction, faculty salaries or job training. In their argument against the initiative, they note that the number of available classes at El Camino has been cut by 20 percent, academic counseling staff is also down 10 percent, and tuition there has doubled in the past three years. The opponents describe the

bond as "another blank check for wasteful spending at a time when many are struggling financially." In their rebuttal, bond supporters emphasize that other college systems are still six times the cost of El Camino and that voting yes on E "ensures that students can effectively prepare for transfer to four-year universities by updating outdated classrooms, buildings and technology."

Fallo pointed out that El Camino--like virtually every other academic institution in California--continues to suffer the consequences of the State's beleaguered finances. "The funding cuts have hurt class offerings across the board," he said. "The bond updates are critical to prepare students for university transfer or entry to a successful career."

Garten added, "We're replacing buildings that weren't funded in 2002, that are more than 50 and 60 years old and bringing them up to date with new equipment. There's always a constant need." •



With Halloween just around the corner I thought it would be cool to make a pumpkin brown rice and bacon risotto.



August 2012. In response, Aderonmu firmly stated that such questions of a personnel nature, asked by an elected official in public, were inappropriate and could not take place in this forum.

Vargas wondered why a new budget request was necessary to the approved 2012-13 budget. He also asked if this additional staff was in the original budget request for this department. Aderonmu explained that the department needs reorganization. He also wants to save money on outside consultation and counsel fees, as was the practice of the previous City Attorney, and addition of staff can allow for separation of City legal business to be handled by designated in-house attorneys with specific expertise.

Valentine then requested to know what percentage of the City's legal business would be brought in-house with the added staff. The response offered did not specifically answer the question other than to say the reorganized method would be more efficient--pointing out that in two months, Aderonmu had not sought any outside counsel for the City's legal issues. Reves-English then requested that the elected officials be given a directive of "dos and don'ts" to discuss in public forums and especially pointed out that elected officials should not be involved in or question personnel matters. She also asked for a sexual harassment directive to be drafted.

Vargas offered that Council members should not be dissuaded from asking questions of the City Attorney or City Manager or any department head, as elected officials must understand why they should or should not vote on matters before the Council as the governing body. The vote cast for both items of the City Attorney's Consent Calendar approved these items, however, with Juarez, Michelin and Reyes-English voting in the affirmative, Vargas voting no and Valentine abstaining.

The Hawthorne Police Department is partnering with the Inglewood Police Department and Wells Fargo Bank in a campaign to collect funds for the family of Hawthorne business owner Filimon Lamas, who was murdered in his Inglewood home by a gunman on Saturday, October 20. Lamas owned and operated Chips Restaurant. Donations can be made through the Hawthorne Police Department Facebook page or website.

The Council members individually thanked Arnie Shadbehr, the former Interim City Manager, for his dedication and hard work, as they welcomed new City Manager Michael Goodson.

Citizens voiced their opinions that the local Measure CL and Measure E should not be supported by voters on the November 6 ballot, arguing that the increases in taxes

will affect all citizens--not just homeowners or business owners--as the need to pay higher taxes will trickle down. The recent Shred Day amounted to 4,250 pounds of recycled paper, saving the equivalent of 36 trees and 14,800 gallons of water. Sam Pena from Republic Waste Services reported that a new edition of the community newsletter *Trash* includes recycling tips for all special items used during the upcoming holiday season, beginning with pumpkins right after Halloween.

A Sexual Assault Prevention and Survivor's Workshop will be held Wednesday, November 14 at 6 p.m. in the Hawthorne Police Department Community Room.

Juarez reported that the matter concerning charges assessed by the Centinela Valley Union High School District for field use by the American Softball Association Hawthorne Girls Softball League was resolved after a conversation the Mayor had with District Superintendent Jose Fernandez. Charges for practice field use have all been waived. The Council voted to approve the Hawthorne Girls Softball League to be added to the list of approved teams/organizations that can be given various levels of support by the City.

During public comments, several citizens offered their reaction to the recently reported indictment of Mayor Juarez by the Los Angeles District Attorney. Some stated their fear that the City is being disgraced by these allegations and that business owners are disappointed by the lack of no progress in the City by a seated Council that continues to conduct meetings with constant bickering and mudslinging comments. Speakers asked for an explanation of how the allegations in the indictment could be made after campaign promises of this Council included no duplication of what past administrations had allegedly done with back-room deals.

Juarez requested that the Sergeant-at-Arms escort all elected officials to their cars at the conclusion of the meeting due to the presence in the City Hall lobby of a disgruntled citizen who had harassed the Mayor as he arrived for this evening's meeting.

Prior to adjourning to a closed session, Juarez commented on the recent news story of his indictment for matters involving an alleged payment to him from a local vendor and accusation of perjury. He noted that the justice system presumes innocence until proven guilty, that the complainant(s) made accusations due to bitterness from people whom he has exposed and removed, that he believes the allegations were brought against him in an attempt to derail his bid for reelection that will begin soon after the new year, and that he is sure he will be completely vindicated of all the false accusations.

# **City Council Approves New City Manager Contract in Special Meeting**

At a special meeting, scheduled 24 hours before the call to order, the Hawthorne City Council approved a contract for a new City Manager on Wednesday, October 17. Due to the short notice and the special meeting status, the proceedings were not available for the local cable television to record or for live streaming of the meeting via the City's website.

Interim City Manager Arnie Shadbehr wore several "hats" for 16 months as he ran the Department of Public Works, chaired the Parking Authority and Housing Authority, and supervised all other departments as the City Manager. Shadbehr took over when former City Manager Jim Mitch was released of his duties in early July 2011. Mitch, who also served in 1994 as City Manager, was hired to replace former City Manager Jag Pathirana when the latter was fired in February 2010.

The process to hire a new City Manager began in May 2012 when 70 applications were reviewed by each member of the Council. The Human Resources Director, who recently left the City for another employment opportunity and has not been replaced, was involved in the process of contacting the candidates, but only after Council reviews narrowed the field to 17 possible candidates--several of whom opted out when the City was not paying for travel expenses for the interview, thus leaving 11 to perhaps be interviewed. The candidates initially received ratings of "Exceeds," "Meets" or "Not Qualified" by each Council member as the application packet was perused. Ultimately, the Council called in seven candidates for face-to-face interviews. The City Attorney was present at all closed sessions for the process of culling the applications, narrowing down the qualified candidates and then conducting the interviews.

The interviews included a series of 20 questions, four asked by each Council member, while the candidates were rated on a scale of 1 to 10 on responses. The City Attorney verified the scoring and the ranking of the seven finalists by each Council member to a pool of a top three.

Michael L. Goodson, a former City employee, was one of those top three candidates. During this special meeting, Goodson's name was presented as the candidate chosen and a copy of a contract of employment was put forth for approval.

Councilmember Olivia Valentine made a statement requesting that the City Clerk include her comment verbatim in the record when the minutes are produced for this special meeting. She stated that she could not cast a vote to approve the contract, as there was a lack of transparency in the process--the meeting was called with only 24 hours notice. Also, she noted that the chosen candidate worked for contractors in Hawthorne and won't be a neutral party if projects involve friends or acquaintances. She also stated that sources for months said Goodson would be hired and that

the interview process, which she witnessed, was flawed, political and a sham. She requested that the amount of expenses for professional development be limited and not be open-ended. Shadbehr stated that professional development is part of the 2012-13 City budget.

Councilmember Alex Vargas commented that secret meetings were held and suggested certain Brown Act violations may have occurred during the search and interview process for the position of City Manager. Vargas continued that the special meeting with 24 hours notice meant that there could be no public comment, as citizens did not have sufficient notice to be present. He asked why there was a rush to select the City Manager after 16 months of an interim one, and why the approval of the contract could not be part of the agenda for the regular meeting to be held on Tuesday, October 24. Vargas suggested "there is something to hide."

Vargas also asked why the new City Manager would need to be educated if he has the qualifications for the job, suggesting lack of experience as a manager or as a city manager and that Goodson was not the most qualified candidate despite being in the top three after the ranking by all five elected officials.

Councilmember Nilo Michelin only made comments about the question of including professional development reimbursement in the contract, stating that any city manager needs to be apprised of the new standards being set for cities by the State and its agencies and any expenses incurred for professional development should not be the responsibility of any city employee. Mayor Pro Tem Angie Reyes-English also offered that the professional development of City employees and elected officials are reimbursable under the law and City ordinances and should be part of the City Manager employment contract.

Reyes-English suggested that the Council stay out of the day-to-day operations of City departments and not dictate to department heads whether employees can or should take educational courses paid by the City. Shadbehr stated that all expenses for training come before the Council for approval through the Warrants for Payment and any special professional development expenses for the City Manager can be put on any agenda for approval.

Mayor Danny Juarez then asked Valentine and Vargas if the timeline statement of the search, interview and decision process for the employment of the City Manager was accurate. Neither Valentine nor Vargas responded. Juarez stated that no Brown Act violations were committed and called for the vote to approve the employment contract between the City of Hawthorne and Michael L. Goodson as the City Manager, with a start date of October 22, 2012, for a period of three years. When votes were cast, Juarez, Reyes-English, and Michelin voted to approve the contract and Vargas and Valentine voted to not approve the contract as presented. •

to ensure that the quality of life in their local communities does not deteriorate. In addition, she reminded the audience that the enthusiasm to vote should be carried through to midterm elections.

"In the 2010 midterm election, people were not as excited-- people felt that since we had elected President Barack Obama that they didn't have to get to the polls--and the Tea Party rolled in. They took control of the House of Representatives and they took control of the Republican Party," Congresswoman Waters said. "Speaker of the House Boehner has been held hostage by the right-wing, very, very conservative members of Congress. Everything that the President has tried to do, they have blocked it off. They didn't say that their number one priority was to bring our soldiers home, they didn't say that the number one priority was the security of this country. They didn't say that their number one priority was the veterans who served and sacrificed for this country. They didn't say that they cared about senior citizens and whether or not they had a decent quality of life, and they didn't say that they really cared about education and our children. They basically said that they wanted to stop President Obama and they have tried in every way to do it."

Furthermore, the Congresswoman indicated that even though federal funding for community development block grants and subsidies such as Section 8 for people who can't afford decent housing are coming from Washington, the decisions on how to apply and manage these funds is determined at the local level the city councils and mayors.

"I know homeowners associations are focused on these local issues--so what is going on in the city council or what kind of development is taking place in the community, along with what type of recreation services are being provided or whether or not the streets are being paved, is decided at the local level," Congresswoman Waters said. "I know that politics are local and sometimes we don't connect with what is going on at the federal level."

Healthcare reform was also brought up and the Congresswoman vowed to defend it, stating that the reform will provide the opportunity for those in need of medical coverage to purchase a plan that best fits their needs without the fear of being denied coverage. "We fought so hard for healthcare reform because they [opposition] tried to define it as practically everything except for what is," Congresswoman Waters said. "I come from communities where preexisting conditions have prevented people from getting healthcare insurance ever since I have known about health insurance. I know this, whether we're talking about diabetes or cancer or HIV/

AIDS or heart problems, because of the lack of access to healthcare, these diseases have always been present in our community. So when you have a healthcare bill that says to an insurance company that you can never again deny healthcare insurance for preexisting conditions, you got me...you have got me.

"As far as I'm concerned all politics are local and I say that because people still have to get up every day and go to work. They send their kids to school and they worry about whether or not they will have proper streetlights, if the streets are paved, whether or not the water systems are working...so people are very close to what is happening in their community. That really is what determines their quality of life. In Washington, D.C., we do get to make decisions for the entire country and it does get down to the local level because we are funding much of what goes on in the cities." •
