# Hawthorne City Council Elections: A Passel of Candidates

On Nov. 5, the citizens of Hawthorne will enter voting booths to choose a Mayor, two members of the City Council, a City Clerk and a City Treasurer. This election year, there are three candidates for the position of Mayor. Seven names entered the race for the two positions on the City Council, while the incumbent City Clerk and City Treasurer each have one opponent.

For the position of Mayor, the elected official will serve a two-year term. Current Mayor Danny Juarez, Jose Gutierrez and Chris Brown are the names on the mayoral ballot.

Juarez served 12 years as the elected City Clerk prior to his service as a Council member, and, then as Mayor of Hawthorne for one term. Also a past elected member of the Wiseburn School Board, he is an active member of the Wiseburn Education Foundation. Danny was a coach, referee, commissioner and director for AYSO. A former employee of TRW/Northrop Grumman Corporation where he worked for more than 40 years, his background includes financial and project management, network/systems administration and public relations.

Gutierrez, a former president of the Holly Park Homeowners' Association, is a 10-year Hawthorne resident. He served as Civil Service commissioner and also as president of the Economic Development Council. He is a member of the Hawthorne Historical Society and a graduate of the CERT program.

Brown is a native of Los Angeles. He has a real estate firm specializing in recovery programs for those facing foreclosure. Brown said he is concerned with the economic development of Hawthorne.

The seven candidates for the two seats on the Council include the two incumbents, Angie Reyes-English and Alex Vargas, both seeking a second term. Also running are John Jefferson, Katrina Manning, Gordon Mego, Frances Stiglich and Michael Talleda. All the candidates pointed to unique skill sets they feel qualify them for the positions they seek. All but one has resided in Hawthorne for at least 20 years, with Jefferson a resident since 2000.

Jefferson is a former law officer who is also an ordained minister serving as Pastor of the Del Aire Baptist Church. He has been a member of the Civil Service Commission since 2011. He runs a foster home as a foster parent, which he has done for 14 years. His past experience includes working in the Los Angeles County Probation Department.

Manning is a realtor, wife and a mother of a 10-year-old daughter. She is the president of the Holly Park Homeowners' Association and founded Movies in the Park, Math Maze Workshop and the National Night Out in Holly Park. She has served on the Parks & Recreation/Fine Arts Commission, is chair of the Neighborhood Watch, and serves on the Economic Development Council. She also is a member of the California Democratic Party Delegation.

Mego is a lifelong Hawthorne resident. He has been vocal in his support of revitalizing the Hawthorne Mall property and the former RFK Hospital site. He noted that his involvement includes contacting the owners of both of these sites to begin a dialogue with each of them for the City and contacting various vendors that might show interest in being a tenant in the mall, if it could be reopened.

Reyes-English has served the City of Hawthorne for eight years--elected as the City Clerk for four years and then for one term on the Council. Her background is on the staff of local elected officials to the Los Angeles City Council and also to the State Legislature. She has been a delegate to the California Democratic Party. In Hawthorne,

she has organized the Service-Provider Fair, now in its fifth year.

Stiglich is a 68-year resident of Hawthorne and for 40 years has attended City Council meetings and approached the podium during public comments. She noted that though she is vocal in her support of the Council, she also makes it a point to state her valid criticisms of their actions. As a self-proclaimed citizen watchdog, she voices her opinions when elected officials and their actions don't meet with her approval.

Michael Talleda is a local business owner with a real estate investment company he founded in 1976 at the age of 24. Talleda noted that in recent years, he has been active in the community since founding the nonprofit 9/11 Help America Project--recently renamed Wounded Warriors Foundation--which assists veterans who served since the events of Sept. 11. Since 2012, he has served on the Oversight Committee to the Successor Agency of the Redevelopment Agency.

Vargas has served for four years on the City Council, two as Mayor Pro Tem. He founded the North Hawthorne Homeowners' Association and served on the Civil Service Commission for five years from 2004-2009. Vargas is a high school teacher with a background in the aerospace industry, using his degrees in physics.

The candidates all expressed concern about the revitalization of the business district of Hawthorne, the reopening of the former mall property, the need for a hospital or at least an urgent care 24/7 facility, the lack of diversity of the police department and public safety.

Candidates for City Clerk are one-term incumbent Norbert Huber and first-time candidate Shelby Anderson. Candidates for City Treasurer are two-term incumbent Thierry Lubenec and David Patterson.

#### Juno Spacecraft Slingshots Past Earth En Route to Jupiter

On Oct. 9, NASA's Jupiter-bound Juno spacecraft made a quick pass by Earth to get a gravity boost and slingshot the probe towards its destination. The time of closest approach was 12:21 p.m. PDT, when Juno passed about 350 miles over South Africa.

As the largest planet in our solar system, Jupiter grabbed most of the mass leftover after the Sun formed. Dr. Scott Bolton of Southwest Research Institute is the Juno principal investigator, leading an international science team seeking to answer some fundamental questions about the gas giant, and in turn, about the processes that led to the formation of our solar system. Jupiter is in the outer solar system, about five times as far away from the Sun as Earth.

"Juno is a large, massive spacecraft," Bolton said. The spacecraft has three large solar panels, measuring nine-by-29 feet, and a titanium vault to protect sensitive electronics from the harsh environment around Jupiter. "Even a large rocket couldn't provide enough propulsion to get us all the way to Jupiter," he added, "so we are flying by the Earth for a gravity-assist that will provide about 70 percent of the initial boost provided by the Atlas V 551 rocket. The gravity assist essentially provides as much propulsion as second rocket launch."

The Juno spacecraft was launched toward Jupiter from Kennedy Space Center on Aug. 5, 2011. The rocket provided Juno enough speed to reach the asteroid belt, at which point the Sun's gravity pulled it back toward the inner solar system. The Earth flyby gravity assist increases the spacecraft's speed relative to the Sun from 78,000 miles (126,000 kilometers) per hour to 87,000 miles (140,000 kilometers) per hour.

"While we are primarily using Earth as a means to get us to Jupiter, the flight team is also going to check and calibrate Juno's science instruments," Bolton said. "As another bonus, Juno is approaching the Earth from deep space, from the Sun-lit side. Juno will take never-before-seen images of the Earth-Moon system, giving us a chance to see what we look like from Mars or Jupiter. We plan to release a movie of this unique perspective of the Earth-Moon system shortly after the flyby."

Juno will arrive at Jupiter on July 4, 2016. Once in orbit around Jupiter, the spacecraft will circle the planet 33 times, from pole to pole, and use its collection of nine science instruments to probe beneath the gas giant's obscuring cloud cover. Juno's science team will learn about Jupiter's origins, structure, atmosphere and magnetosphere, and look for a potential planetary core.

SwRI also provided two science instruments for the mission--the Ultraviolet Spectrograph (UVS) and the Jovian Auroral Distributions Experiment (JADE). UVS will image and measure the Jovian aurora's ultraviolet emissions. JADE will measure the auroral electron and ion populations along the planet's magnetic field lines and determine which particle populations create the Jovian aurora.

Named for the mythological wife of the god Jupiter, who used her special powers to discover the secrets Jupiter was hiding behind cloud cover, the Juno spacecraft will probe the mysteries beneath Jupiter's surface to understand its structure and history. Jupiter's giant mass has preserved its original composition, perhaps providing a "Rosetta Stone" to explain more about the rest of the solar system as well. •



#### Reevaluate Your Benefits Needs During Open Enrollment

If you're among the 170 million Americans who receive health insurance through an employer-provided plan, you'll probably receive your 2014 open enrollment materials shortly. Although it's a pain to wade through all that information, simply opting for your current coverage could be a costly mistake. Here's why:

Health insurance has undergone major changes since the 2010 Affordable Care Act was passed, including the elimination of annual and lifetime coverage limits and preexisting



for eligible out-of-pocket expenses on a pre-tax basis; that is, before federal, state and Social Security taxes are deducted from your paycheck. This reduces your taxable income and therefore, your taxes.

You can use a healthcare FSA to pay for IRS-allowed medical expenses not covered by your medical, dental or vision plans.

Check IRS Publication 502 for allowable expenses. Dependent care FSAs let you use pre-tax dollars to pay for eligible expenses related to care for your child, spouse, parent or other dependent incapable of self-care.

conditions exclusions, expanded free preventive care and allowing children up to age 26 to remain on parents' plans.

In response, many employers have altered their benefit plans. Plus, if your family or income situations have changed since last year, your current plans may no longer be the best match. And, if your employer offers flexible spending accounts and you're not participating, you're leaving a valuable tax break on the table.

Here's what to look for when reviewing your benefit options:

Carefully compare all costs and features of the different plans offered and note how your existing coverage may be changing next year. Common changes include: Dropped or replaced medical plans, increased monthly premiums, deductibles and co-payment amounts, revised drug formularies, favored doctors or hospitals withdrawing from a plan's preferred provider network and changes to the number of allowed visits for specialty care (acupuncture, chiropractic, physical therapy, etc.).

If offered, healthcare and dependent care flexible spending accounts (FSAs) can significantly offset the financial impact of medical and dependent care by letting you pay Here's how FSAs work: Say you earn \$42,000 a year. If you contribute \$1,000 to a health care FSA and \$3,000 for dependent care, your taxable income would be reduced to \$38,000. Your resulting net income, after taxes, would be roughly \$1,600 more than if you had paid for those expenses on an after-tax basis.

Remember these FSA restrictions:

- Employee contributions are limited to \$2,500 a year for health care FSAs and \$5,000 for dependent care.
- Health care and dependent care contributions are not interchangeable.
- Estimate planned expenses carefully because you must forfeit unused account balances. Some employers offer a grace period of up to 2 1/2 months after the end of the plan year to incur expenses, but that's not mandatory, so check your company's policy.
- Outside of open enrollment, you can only make mid-year FSA changes after a major life or family status change (marriage, divorce, death of a spouse, birth or adoption, etc.) If one occurs mid-year, re-jigger your FSAs accordingly for maximum savings.
- You must re-enroll in FSAs each year amounts don't carry over from year to year. •

The Cardinals held a 12-10 halftime lead, but the Eagles, who were coming off a three-game losing streak, got things going by outscoring Lawndale 19-6 in the second half for a 29-18 victory. El Segundo, which improved its overall record to 3-3 with the Pioneer opening win, got two touchdowns from Jamie Stewart on a 32-yard reception from junior quarterback Lars Nootbar and a 58-yard punt return.

The Eagles took the lead for good when Dathan Bailey, a transfer from Manhattan Beach Mira Costa, scored on a four-yard run. Bailey finished the game rushing for 85 yards and one touchdown, while Nootbar completed 13 of 21 passes for 165 yards, one TD and one interception. Stewart caught eight passes for 89 yards and one score. After the slim halftime lead, the Cardinals (4-2) went cold, totaling only 97 total offensive yards in the second half.

Due to a power outage at Lawndale High, the Cardinals were forced to move the game over to nearby Leuzinger High virtually at the last minute. As a result, the team and its fans had a hard time adjusting. It was more an atmosphere of the earlier Lawndale High era (1959-81) when it played all of its home games at Leuzinger due to the school having only just a practice field, although its lower level (such as junior varsity and freshman) teams played games on it.

The Cardinals had a fine game by Austin Manigo, who rushed for 152 yards and two touchdowns on 19 carries. It was Manigo's first full game back. Manigo gave Lawndale an early lead with a 60-yard TD run in the first quarter. Sophomore quarterback Chris Murray rushed for 80 yards and one touchdown on 15 carries and completed four of seven passes for 56 yards and one interception. Back from a torn ACL he had from last season, Will Self rushed for 51 yards on eight carries.

Lawndale will attempt to even its league record to 1-1 as it visits North Torrance High Friday at 7 p.m. The Saxons, last year's CIF-Southern Section Northwest Division runner-ups, are 3-3 after opening league with a 28-7 victory at Centennial High in Compton last Friday.

#### **Cougars Fall to Culver City**

Coming off a 2-3 preseason that included a 44-8 Mayor's Cup win at cross-town rival Leuzinger on Oct. 4, Hawthorne High's football team was hoping to open Ocean League play with a win over a rebuilding Culver City High team last Friday at Hawthorne. Unfortunately for the Cougars, their wishes did not come true as the Centaurs (2-4, 1-0) pulled away for a 27-7 win.

Hawthorne started off well and scored on its first drive on a five-yard touchdown run by running back Paris McDaniel for an early 7-0 lead. From there, Culver came back and wore down the Cougars, who fell to 2-4 overall and 0-1 in league. McDaniel finished the game rushing for 105 yards.

The loss could already hurt Hawthorne's hopes of its first CIF-Southern Section Western Division playoffs since 2004 when the Cougars won the Ocean title, but head coach Donald Paysinger is still confident. "We got Morningside, Inglewood and Beverly Hills next," Paysinger said. "We're still hanging in there. We have a chance. We'll keep working on it. The playoffs are our goal."

Hawthorne visits Morningside at Coleman Stadium in Inglewood Friday at 7 p.m. The Monarchs (3-3, 0-1) are coming off a 42-6 loss last Friday to host Santa Monica High, which is the preseason league favorite after winning the Ocean the past two seasons.

#### Inglewood Rolls Over Beverly Hills

Inglewood High's football team began the Ocean League on the right foot by rolling over winless Beverly Hills 49-0 last Friday. The Sentinels, who improved to 3-3 overall, had very little trouble with the Normans, who appear to be headed to one of their worst seasons in the nearly 100-year school history.

Inglewood will visit Culver City in what should be an evenly matched contest Friday at 7 p.m. The Centaurs, who won their league opener at Hawthorne 27-7 after losing four of five non-league games, are in a rebuilding season but should continue to be contenders for the Ocean title.

Leuzinger High's football team lost its Bay League opener at Palos Verdes 55-0 last Friday. The Olympians (0-6 overall) host Peninsula Friday at 7 p.m. The Panthers are coming off a 42-35 loss at Redondo last Friday. •

#### Assemblymember Muratsuchi's AB 568 Approved by Governor Brown, 'Saving Courts Time and Money'

**Summary:** Passed on Aug. 19, 2013, this bill would define a law enforcement officer when using hearsay testimony in preliminary hearings.

Background: On June 5, 1990, California voters approved Proposition 115, the Crime Victims Justice Reform Act, which enacted several new provisions of the California Penal Code including Penal Code Section § 872(b), which authorizes the use of hearsay testimony in a preliminary hearing by a "law enforcement officer." The measure, however, did not provide a definition of a law enforcement officer for purposes of this section. Without a definition, courts have chosen to interpret "law enforcement officer" under the statute more broadly than the term "peace officer." In the case of Sims v. Superior (1993) 18 Cal.App.4th 463, the Court of Appeal held: We find that section 872, subdivision (b), is not restricted in its application to "traditional" law enforcement officers authorized to carry weapons and make arrests, but rather is intended to encompass officers and agents with knowledge of the pertinent laws underlying the charged crime who can provide meaningful testimony at

The proposed legislation would codify the definition of law enforcement officer as provided in *Sims*.

Need for the Bill: Without a codified definition of "law enforcement officer," prosecutors face defense objections in

For that reason, we conclude section 872, subdivision (b), applies to officers and agents employed by a federal, state or local government agency: 1) who meet the threshold training and experience requirements set forth in that provision; and 2) whose primary responsibility is to investigate and prepare for prosecution cases involving violations of laws. (*Id.* at p. 465.)

Disputes over the language have arisen regarding federal agents, special agents working for California state agencies, departments or bureaus, and investigators whose primary purpose is to enforce the law but who lack the authority to

the Major Narcotics Division of the Los Angeles County District Attorney's Office faced an objection involving the testimony of a federal agent in the case of People v. Hsiu-Ying (Lisa) Tseng. In several cases justice is delayed while courts determine whether a witness called by the People qualifies under the definition of a law enforcement officer for purposes of Proposition 115. In each of these cases, after time consuming and expensive litigation, the court decides that each of these witnesses qualifies as a law enforcement officer. Although the California Court of Appeal has taken up the issue three times and the Sims court went so far as to provide a definition of this term, it appears that unnecessary litigation of this issue will continue until the term "law enforcement officer" is explicitly defined in statute. •

#### **Hawthorne School Board Excited Over New Gyms**

By Dylan Little

The Hawthorne School Board heard a report from the Hawthorne School District's Bond Oversight Committee on the construction of gyms at Bud Carson and Prairie Vista middle schools during the Oct. 9 meeting. Bond Oversight Committee Chair Allen Richards was pleased with the work Del Amo Construction did, citing the latter's experience and ability to stick to the budget. "They have done many of these gyms and I felt confident they'd do a great job," Richards said about Del Amo. "They said they would not have any overruns and they did not."

Board member Cristina Chiappe thanked Richards and the rest of the Oversight Committee for taking time out of their lives to ensure that this construction project was done correctly and within the budget. "I really applaud the Oversight Committee... for volunteering its time and making this project very transparent and something everyone will be happy with," she said.

Actually, the project came in slightly under budget. While there are still some accounts that need to be settled, Richards said the project should end with a surplus. "We actually have a credit," he said. "What we estimated this job would cost, we came in under. Well, it's not very much—\$2,079. We can always use that for something else."

In addition to those savings, the District also saved a significant amount of money by starting construction during the economic downturn. Board President Eugene Krank said the cost to build these gyms today would be about \$8.3 million, which is substantially less than the \$6.3 million the District paid for them. "The discount we got because of when we did this... and to get something back, it's incredible," Krank said.

The Board also heard an update from Michael Collins, principal of Ramona

Elementary. Collins gave a report on how the school performed in the last around of standardized testing. Ramona's Academic Performance Index (API) score improved by two points over last year's 816. However, the school's Adequate Yearly Progress (AYP) scores were a mixed bag. The school met the requirements for Safe Harbor in math, but failed to do so in English language arts and neither subject met the high goals Ramona's staff and students set for themselves.

"We wanted to grow five percent schoolwide and with our significant subgroups. We wanted to show growth in both language arts and math so we could obtain Safe Harbor in those areas," Collins said. "We didn't get five percent growth in both language arts and math, but we did score a significant amount second graders are having a tough time with word analysis. To combat this deficiency, Collins is asking teachers to incorporate more academic language into their lessons throughout the curriculum. "We are going to work with our second grade teachers to focus on academic language, not only in English language arts classes, but also through other subjects like science and social studies," Collins said. "Teachers will use English language development strategies to help students with the development of their English skills."

The other half of the second grade problem was math--specifically place value, statistics, data analysis and probability. Compared with last year, second-grade math fell from 47 percent proficient or advanced to 42

performance tasks (one of the staples of the new curriculum) in math classes. The school is also successful in attracting parent involvement in education. Ramona hosts literacy nights, math nights, Hawthorne Parent Academy workshops and Two-Way Bilingual Immersion (TWBI). Parent meetings and Collins reported that they are well attended. "We've held several of these and the turnout has been impressive," he said.

While Ramona didn't meet all its goals, the Board overall was pleased with Collins' report. Chiappe remarked that she was thankful to see that the school is looking into ways to correct its shortcomings. "It's always good to not just look at what we're doing well, but to see what needs improvement as well," she said. •

Despite not reaching their growth goals, Collins said he was proud of the effort shown by Ramona's teachers and students. "We are proud of the growth that we achieved in the majority of our subgroups, but we still realize there is work to be done with our Latino subgroup and our English Learner subgroup," Collins said.

In addition to weak performance from Latino and English-learning students, the second grade at the school was also in decline. In English language arts, Ramona went from 48 percent of students being proficient or advanced to 39 percent. According to Collins,

percent. To address these problems, Collins said Ramona would expand its after-school classes. He added that even students scoring in the proficient or higher bands would be invited to these classes to reinforce tough subjects. "We're going to hold more after-school classes taught by our classroom teachers," Collins said. "Teachers are going to invite specific students who are scoring above basic to after-school class so they can reinforce the math concepts that were taught in class that day."

Not all the news from Ramona was bad, though. The school is progressing with its Common Core State Standards implementation plan and already has students attempting We are now a Registered eBay Drop






