## Scholarship Helps Future Students, Keeps Memory of Vets Alive

For the 18th consecutive year, the Vietnam Veterans of America South Bay Chapter 53 will host its scholarship essay program seeking to award a graduating senior from the South Bay a \$1,000 scholarship. The Vietnam Veterans of America \$1,000 Scholarship Essay Program is asking students from the South Bay to submit a report on a Vietnam Era veteran who was active duty and in the Republic of Vietnam between February 28, 1961 and May 7, 1975.

"We do not want Vietnam to be forgotten," Scholarship Committee Chair and member of the VVA South Bay Chapter 53 Jerry Orlemann said. "Other veterans of previous conflicts are dying off and we are now reaching that age where we are starting to die off. When we go to talk to people in schools, they are no longer the children of the veterans--they are the grandchildren of the veterans. At one school, one student said her great-grandfather was in Vietnam. The effort is kind of twofold--to not be forgotten and we want to people who are learning today to understand what happened so many years ago in Southeast Asia and how it relates to things today."

The student must submit a minimum of a 500-word essay that includes a brief biography of the veteran, branch of service, military unit and dates of active service. There are six topics that the students can write about, including what the Vietnam War meant to the veteran, what the war meant to the veteran's family or what the war means to the student, among other ideas.

"It goes back to the old saying that history repeats itself and we want them [students] to see how things relate today with what is going on in Iraq and Afghanistan to Vietnam," Orlemann said. "We want to them try and understand what are the effects or impact

today from what happened then. Hopefully by making them seek somebody out, they will get somebody to talk about Vietnam whom they have never spoken to before. In addition, this will lead them to knowing somebody in a way that they have never known before."

The student must interview a veteran who has significantly influenced them. "We used to encourage that the student interview and write about a family member, but it is getting harder to find graduating seniors who have family members that they could write about who were in Vietnam," Orlemann said. "So

a few years ago, we changed it from family member to somebody who has significantly impacted their life. Now we have students who just found out that their math teacher is a Vietnam veteran. So not only do they know something completely new about their teacher, but they are learning something else from this teacher in a historical context. It is a good experience for education overall."

More than one scholarship has been given out each year as part of the program and the VVA is trying to expand its reach to include more of the South Bay's graduating seniors. Posters and flyers have been made and are ready for distribution. The VVA is scheduled to speak to the Hawthorne City Council as well make a presentation at the Hawthorne School District and the Wiseburn School District. However, the group hopes to reach more cities in the South Bay.

"We want all the parents to know about it because then the parents will encourage the children to compete for that \$1,000 scholarship," Orlemann said. "The parents find out through the local boards of education and by watching those city cable shows that broadcast council meetings, so we want to get the word out to the parents."

The task of reading the essays is not easy for the committee, but it does help with the scholarship program's objective of keeping the memory and service of the veterans alive. "We don't ask for an essay that says the yay-yay, rah-rah, toot-toot for the U.S. Armed Forces in Vietnam or anything like that. We wish for honesty in what they [student] write," Orlemann said. "We have had stuff that goes everywhere from being really fun and happy stories two very terrible and not so funny stories. We've had some essays that are a total condemnation of all U.S. policies in Southeast Asia and we have also had some essays where they consider everything that was done to be the right thing. The reality falls somewhere in between, but for everybody is different."

The essay contest has also benefited the VVA's membership. "We have helped more than 40 college-bound students in the last 17 years," National Board of Directors for Vietnam Veterans of America and President of the VVA South Bay Chapter 53 Jerry Yamamoto said. "If you look around, many of our members here joined because it gained their children scholarships."

All essays must be submitted by the Sunday April, 7 at 11:59 p.m. to be considered. # CSD Urges Torrance to Take Advantage of Earned Tax Credits

The Internal Revenue Service and partners nationwide have launched the Earned Income Tax Credit Awareness Day outreach campaign, aimed at helping millions of Americans who earned \$50,270 or less take advantage of the Earned Income Tax Credit (EITC).

Local officials and community organizations across the country are sponsoring more than 250 news conferences and other outreach events highlighting the benefits of this key work incentive for low-and moderate-income workers and working families. The annual campaign is necessary because one-third of the eligible population changes each year as their financial, marital and parental statuses change. Although an estimated four out of five eligible workers and families get the credit, one in five still miss out on it, either because they don't claim it when filing, or don't file a tax return at all.

"A large part of the nation sees major changes every year with their tax situation," said IRS Acting Commissioner Steven T. Miller. "This year, millions of workers could qualify for EITC for the first time, and the IRS urges them not to overlook this valuable credit."

The EITC varies by income, family size and filing status. The average EITC amount last year was around \$2,200.

As many as one out of five people eligible to claim this credit miss out because they don't apply. If you work, and earned under \$50,000 last year, you could receive up to \$5,891 by claiming the credit on your 2012 Federal tax returns.

In Hawthorne, there are 12,236 tax returns claiming the earned income tax credit for a total of \$30,087,599; in Inglewood, there are 18,036 tax returns claiming the earned income tax credit for a total of \$45,330,976; and in Lawndale, there are 4,006 tax returns claiming the earned tax credit for a total of \$9,686,946.

"To receive the credit, eligible Californians must file a tax return and claim what they've earned through EITC," said CSD Acting Director Linné Stout. "The Department and our local partners are working to get the word

out, and to help eligible Californians take advantage of the credit by offering free tax preparation services."

CSD administers the Community Services Block Grant (CSBG) through partnering with local non-profits and government agencies to alleviate the causes of poverty in local communities throughout California. Several of CSD's partner agencies around the state are offering free tax preparation and EITC filing services during the 2013 tax season. Many agencies are also collaborating and leveraging with other community based organizations to offer these services, and fill service gaps around the state.

"We are working hard to reach all the members of our community who are eligible for EITC so they don't miss out on this great resource," said Betty McWilliams, executive director for Foothill Unity Center, a CSD partner agency in Los Angeles. "For a very low income family, receiving this credit can make a significant difference in their lives. And, the financial boost EITC provides working people also offers a boost to our local economy."

## DUI CHECKPOINT NETS FIVE ARRESTS

The Hawthorne Police Department Traffic Unit conducted a D.U.I./Driver License checkpoint on Jan. 18 at Prairie Avenue and Jack Northrop Avenue between the hours of 8 p.m. and 4 a.m. Checkpoints are placed in locations that have the greatest opportunity for achieving drunk and drugged-driving deterrence and provide the greatest safety for officers and the public. The results of this January 18th checkpoint are as follows:

- 1054 Vehicles Screened
- 3 DUI-Alcohol suspects arrested
- 2 DUI-Drug impaired suspects arrested
- 41 Drivers cited/arrested for operating a vehicle unlicensed or while suspended/revoked
- 52 Citations issued

These DUI/Driver License checkpoints lower DUI deaths and injuries. A major component of these checkpoints is the deterrent effect it has on those who might drive drunk or drugged-impaired, the public's added awareness and encouragement to use sober designated drivers. According to the National Highway Traffic Safety Administration (NHTSA), checkpoints have provided the most effective documented results of any of the DUI enforcement strategies, while also yielding considerable cost savings of \$6 for every \$1 spent. Hawthorne PD will be conducting another D.U.I./Driver License Checkpoint on Friday, Feb. 22. 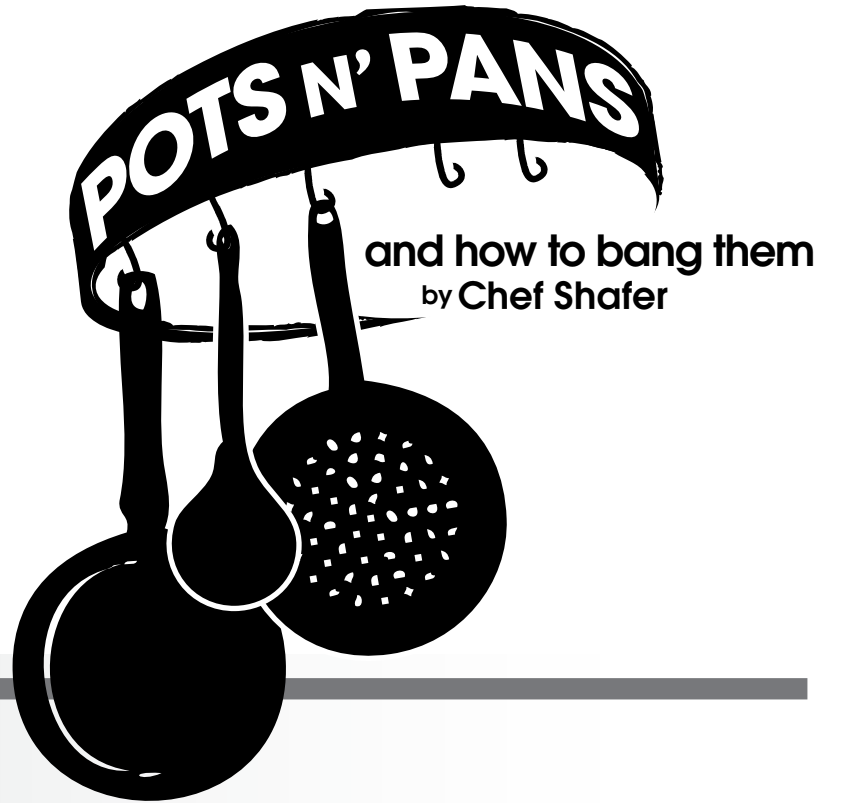

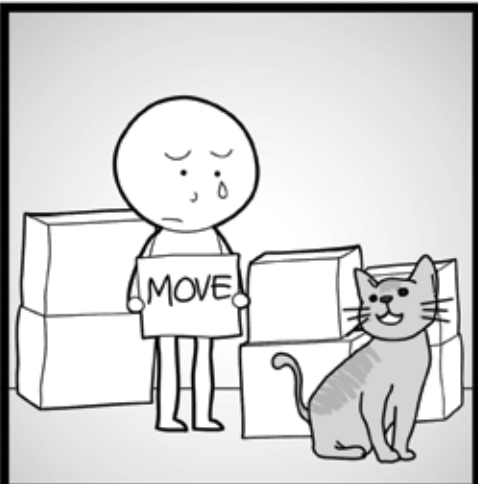

experience of going against their former successful head coach Reggie Morris, Jr., who is in his first year with the Sea Hawks. While at Leuzinger from 2002-10, Morris guided now-National Basketball Association Oklahoma City Thunder standout Russell Westbrook and the Olympians to the CIF-Southern Section Division IA championship over Santa Monica in the 2009-10 season. Leuzinger sought to spoil his return to its gym for the first time in three years and the Olympians looked like they would do so. They were leading 37-27 midway in the third quarter.
