## LAX Entry-Level Construction Program Is Building Momentum

The Los Angeles International Airport is recruiting applicants for a program that trains airport-area residents to step into careers in the local construction industry. The third HireLAX Apprenticeship Readiness Program class is preparing to start classes in August. The partnership with Los Angeles Trade Technical College, Los Angeles Southwest College, and the Los Angeles/Orange Counties Building and Construction Trades Council is a workforce development program aimed at local residents. Special emphasis is placed on finding recruits from economically disadvantaged cities within the South Bay.

HireLAX teaches skilled craft labor that is badly needed to support the multibillion-dollar capital improvement program at LAX, according to organizers. "We have seen the incredible impact that HireLAX can have on the lives of its graduates, and we are proud to know that these men and women are helping build the LAX of the future," said Samson Mengitsu, the chief operating officer with Los Angeles World Airports (LAWA). "HireLAX changes lives, and we hope that our neighbors who are interested in a construction career will take the chance and apply."

A mandatory orientation will be held on Saturday, Aug. 25, from 7 a.m. to noon at Los Angeles Southwest College. The

eight-week program begins on Monday, Sept. 10. Applicants must RSVP to attend the orientation session.

Residents of Inglewood, Mar Vista, Westchester, Hawthorne and Lennox are eligible for the 30 trainee slots. Register immediately for next month's orientation online at [hirelaxorientation2018-08-25.eventbrite.com](http://hirelaxorientation2018-08-25.eventbrite.com) and wait for an email with instructions.

Within a few days of registering you will receive an email with further information regarding applying for the program. Failure to fill out this paperwork in advance will delay your application and may result in you not being fully screened on the day of orientation.

To be accepted into this LAX-area work-readiness program, applicants must show proof of residency, be at least 17 1/2 years old, and have a strong interest in the construction industry. A California identification card and Social Security card are musts, too.

Contractors performing work on LAWA projects must meet or exceed 30 percent local participation with a workforce that reflects the diversity of Los Angeles. The HireLAX program trains local residents to earn these jobs. Under the HireLAX framework, program graduates will be connected with union apprenticeship programs and contractors so they can begin their construction careers at LAX.

Since its launch last year, two HireLAX

classes have graduated, and approximately two-thirds of the graduates are now in union apprenticeship programs and have earned local construction jobs. Of the graduates, 100 percent are working locally. Additionally, approximately one-fourth are women and two-thirds of the program participants are African Americans. Previous involvement with the criminal justice system is not a barrier to this training opportunity.

The HireLAX program was developed within the framework of LAWA's Project Labor Agreement, which is a partnership between the airport authority, its contractors and the local construction unions. The PLA requires contractors and unions to refer local workers to the project, and outreach to persons who have not previously qualified to be employed on construction projects -- especially minorities and women. The LAWA PLA and the HireLAX Apprenticeship Readiness Program are managed by Pasadena-based Parsons Corporation. The nonprofit Flintridge Center is providing recruitment and case management assistance for the program.

Those interested in participating in the HireLAX program must attend a mandatory orientation and participate in an application process. The mandatory program orientation and registration will be held on Saturday, Aug. 25 at Southwest College. 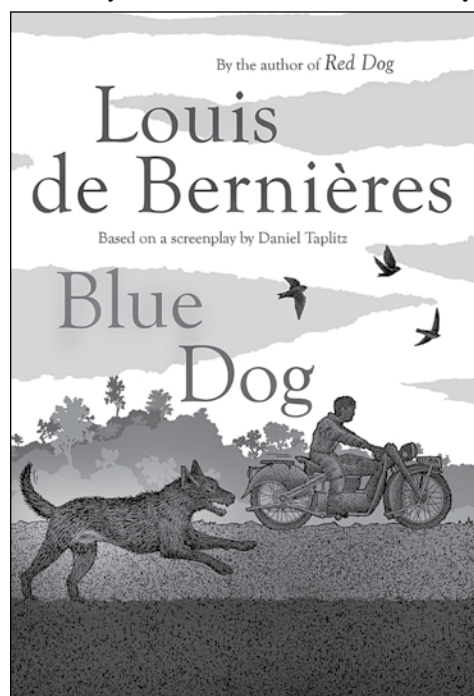


## Check It Out

### Blue Dog Aably Endears Readers to an Array of Australian Antics

Summer continues to sear and we're all still just dazed and dry-mouthed and looking for somewhere cool to wait out the sun's slow and Celsius-slopped trajectory across the sky. But the Inglewood Public Library is always serving up the literary equivalent of a frosty tall glass of lemonade. So swig deeply and full and find yourself refreshed with the bookly

offerings on our shelves.

A quaint and quenching book just in, Louis de Bernières' coming-of-age *Blue Dog* is just the story to alleviate any temperature-induced angst. Young Mick is marooned in the Australian Outback and forced to reside with his rough-living and hardened grandfather after a family tragedy. Lonely and out of his element, he has a tumultuous first few weeks adjusting to this new environment and inhospitable clime. It's a tough acclimatization for the lad. Lonely and desolate is the landscape of Pilbara but, luckily, just the right conditions for a fledgling go-getter to earn some sage life lessons and undergo a journey of self-discovery.

The descriptions of the rough-and-tumble Aussie Outback are rendered here vividly and in full color. The heat emanates from the page and all thermometers in the vicinity tick up a few degrees as the story progresses. The writer has a real gift for vivifying a far-flung locale for a reader. The perspiration and dust of rural Australia gets into your eyes and pores and roosts ruefully. The writer has a knack for

kneading rich imagery into your head. It just takes a few paragraphs to find yourself panting from heat exhaustion and scrambling for a canteen to slake your building thirst. That's just solid writing, I say.

Despite the unforgiving brutality of the Outback weather and rural hardships, Mick manages to find and befriend a young puppy, Blue, and they become fast companions and go about braving the trials and travails of adolescence together. It's a well-wrought tale of endurance and learning things the hard way. Mick is living a very unconventional childhood and must recruit a motley of eccentric and unique characters along the way if he's to survive and thrive in his new home. These are characters that provide guidance and flair to the narrative. From the reclusive hermit living on the outskirts of town (and margins of society) to the wisecracking indigenous Taylor Pete with a talent for motorcycle repair and storytelling, this is an excellent array of supporting characters that prod Mick along his road of personal growth.

The dialogue is a complete and utter delight. Pitched in regional Australianisms and distinct Antipodean patois, it's undiluted music to the ears. The vibrant phraseology and Outback witticisms will tickle you to no end. There's a catchy back-and-forth rhythm to these exchanges that ruffles your ear cilia just right. The words enter your skull and boomerang around awhile and then exit the other ear, taking with it rhyme and reason but leaving ample helpings of humor and off-kilter eloquence.

All said, a fine read and just the tome to chase away the summer enervations. A dose of *My Dog Skip*, *Free Willy* and *Rabbit-Proof Fence* all coming together to form a daring didgeridoo of delectations. So waltz on over to the library and have a readerly walkabout in our YA section.

It's fair dinkum. •

### Coming of Age in the Internet Age

Bo Burnham is an eighth grade girl. Well, it would be more accurate to say that not only is *he* an eighth grade girl – although his understanding and portrayal of this confusing time in adolescent life is astoundingly spot-on – but reveals that we *all* are eighth grade girls, or once were. Which is to say, that at one time or another, we've all felt the same

artificiality of pop consumerism is such a large part of kids' lives. The content they take in is then recreated and re-stylized in a feedback loop that results in being either so out of touch with reality or hyper in touch with a false one. This is what stirs Kayla, who is introverted and reserved at school but comes to life online making inspirational and self-help videos to an audience of none.

shared sense of awkwardness -- that of identity confusion and a general longing for love that unites us all, no matter our gender, age or generation.

*Eighth Grade*, the directorial debut of comedian Bo Burnham is, on the surface, a modest movie. Essentially, we follow a teen in the last week of her middle school year, along with all of the important and trivial life events that pop up. But that summary alone would be like saying last year's Best Picture nominee *Lady Bird* was just a movie about a high school senior. Specifically, what these movies have in common is a theme that is most noticeable: one of authenticity, identity and the general nature of who we are by how we choose to live.

Perhaps no one knows this better than Burnham himself, who dealt with crafting an identity in the age of the Internet. He cultivated a fanbase by creating pop piano hits on YouTube that eventually resulted in a successful standup comedian relationship with Netflix specials and tours. So yes, this movie is about Kayla (Elsie Fisher), an introverted and reserved eighth grader without a best friend, and whose superlative awarded by her class is "Most Quiet." But below that, it's really about identity and insecurities that we all have. Those are never more relevant than at this time, in this age of social media and online living.

*Eighth Grade* shines a light on the anxieties of growing up in the social media generation like a front-facing flash of a camera selfie. It's not news that the suffocating

Where Burnham's directorial effort, which he also wrote, truly shines most is the examination of the duality of "being yourself." Burnham's stand up specials – *what*. and *Make Happy* (available to watch on Netflix) – showcase the young millennial, all of 27 years old himself, as a meta-maddening, self-aware artist consumed by the idea of creating who you are, as well as living naturally to the rest of society's confirmations. *Eighth Grade* is successful because Bo Burnham has the eye and mind and insecurities of Kayla, and it doesn't ring false or sappy – it just feels like he *gets it!*

# Looking Up

## NASA Asks: Will We Know Life When We See It?

**Based on a Press Release from JPL/NASA, Provided by Bob Eklund**

In the last decade, we have discovered thousands of planets outside our solar system and have learned that rocky, temperate worlds are numerous in our galaxy. The next step will involve asking even bigger questions. Could some of these planets host life? And if so, will we be able to recognize life elsewhere if we see it?

A group of leading researchers in astronomy, biology and geology has come together under NASA's Nexus for Exoplanet System Science, or NExSS, to take stock of our knowledge in

the search for life on distant planets and to lay the groundwork for moving the related sciences forward.

"We're moving from theorizing about life elsewhere in our galaxy to a robust science that will eventually give us the answer we seek to that profound question: Are we alone?" said Martin Still, an exoplanet scientist at NASA Headquarters, Washington.

In a set of five review papers published last week in the scientific journal Astrobiology, NExSS scientists took an inventory of the most promising signs of life, called biosignatures. The paper authors include four scientists

from NASA's Jet Propulsion Laboratory in Pasadena, California. They considered how to interpret the presence of biosignatures, should we detect them on distant worlds.

The assessment comes as a new generation of space and ground-based telescopes are in development. NASA's James Webb Space Telescope will characterize the atmospheres of some of the first small, rocky planets. There are plans for other observatories—such as the Giant Magellan Telescope and the Extremely Large Telescope, both in Chile—to carry sophisticated instruments capable of detecting the first biosignatures on faraway worlds.

Through their work with NExSS, scientists aim to identify the instruments needed to detect potential life for future NASA flagship missions. The detection of atmospheric signatures of a few potentially habitable planets may possibly come before 2030, although determining whether the planets are truly habitable or have life will require more in-depth study.

Since we won't be able to visit distant planets and collect samples anytime soon, the light that a telescope observes will be all we have in the search for life outside our solar system. Telescopes can examine the light reflecting off a distant world to show us the kinds of gases in the atmosphere and their "seasonal" variations, as well as colors like green that could indicate life.

These kinds of biosignatures can all be seen on our fertile Earth from space, but the new worlds we examine will differ significantly. For example, many of the promising planets we have found are around cooler stars, which emit light in the infrared spectrum, unlike our Sun's high emissions of visible-light.

"What does a living planet look like?" said Mary Parenteau, an astrobiologist and microbiologist at NASA's Ames Research Center in Silicon Valley and a co-author. "We have to be open to the possibility that life may arise in many contexts in a galaxy with so many diverse worlds—perhaps with purple-colored life forms on Earth, for example."

The NExSS scientists will create a framework that can quantify how likely it is that a planet has life, based on all the available evidence. With the observation of many planets, scientists may begin to more broadly classify the "living worlds" that show common characteristics of life, versus the "non-living worlds." •
