Ballot Arguments Submitted for April Tax Measure

All five El Segundo City Council members provided input as well as their signatures on the argument in favor of the upcoming Measure A tax hike initiative that will go before voters on April 8. Submitted the day after Christmas, the document urges local residents to vote yes on the measure or else force the Council to "contract out or cut cherished El Segundo services" such as Police, Fire, Library, and Recreation and Parks, as well potentially stop school support. The argument reports that the City faces a continuing budget deficit of \$5.8 million annually starting in 2014 due to the adverse impacts of low property tax returns (six percent on the dollar), increased pension liabilities and rising expenditures--this despite shaving expenditures via a reduced workforce and implantation of a two-tier pension program for new hires. "Cutting and contracting services to Los Angeles County will be our future should Measure A not pass," the argument reads. The text also notes that the Council has the right to impose those cost-cutting measures without voter approval. The argument in favor goes on to say that the Council partnered with the El Segundo Chamber of Commerce, business community and concerned residents to craft a modest tax increase that will still keep rates lower than neighboring communities—and that the Council also passed a separate resolution indicating its intent to apply one-third of the tax revenues generated from the measure towards capital improvement/infrastructure repairs.

The City Attorney's impartial analysis of Measure A breaks down the individual components of the "consolidated tax measure" and includes a comparison between today's levels and those under the terms of the increase. For transient occupancy taxes (TOT) imposed on those who stay in local lodging facilities, the measure would raise the rate from eight percent to 10 percent. Only businesses currently pay utility

user taxes (UUT), with rates at three percent on electricity, gas and water, and two percent on communication services. The measure would increase the UUT by 2.5 percent the first three years and then by two percent subsequently—so taxes on electricity, gas and water would rise to 5.5 percent in years one through three and then drop to five percent thereafter. Taxes on communication services would increase to 4.5 percent in years one through three and then fall to four percent after that.

Residents do not currently pay any UUT. Under the measure, they would pay 2.5 percent for both EGW and CS (\$2.50 per every \$100 of utility bills) the first three years and then two percent afterwards.

The measure would also impose a new 10 percent parking tax on gross receipts from lots used predominantly for airport parking and also for some similar long-term uses. It will not apply to office visitors, employees, theater and restaurant patrons, retail shoppers, hotel guests and those with self or valet-based validated parking.

Lastly, the measure aims to reduce the sales tax credit businesses can apply to reduce the amount of business license tax (BLT) they owe. Currently, businesses can use up to 40 percent of the sales tax revenue it generates to the City to offset their BLT. As the analysis reads, "If a taxpayer generates \$10,000 of sales tax for the City, it is entitled to credit \$4,000 against its BLT. Beginning January 1, 2015, the measure would reduce the BLT credit from 40 percent to 10 percent; and on January 1, 2018, the credit would be reduced from 10 percent to five percent."

If the measure passes, the City anticipates annual revenues of \$6.6 million for the first three years and \$5.9 million annually subsequently.

In drafting the argument against Measure A, former El Segundo City Councilmember Mike Robbins maintains that utility taxes will automatically rise as rates increase and that residents will ultimately pay the business tax

increases passed on to them as customers. He reports that the measure creates a new UUT on residents and nearly doubles the business UUT. The argument also specifies that the "communication services" under the UUT encompass "voice, data, audio, or any other information or signals, using any technology including landline, eDSL, cable, wireless, broadband, VolP, and Internet." Robbins also criticizes the lack of a sunset clause (where the taxes revert back to the prior rates after a certain period) and the inability of voters to individually approve or disapprove specific taxes since the measure bundles everything together as one item. He adds that there is no guarantee any new tax money will go to infrastructure or that discretionary spending will be controlled. "Even if some of the new taxes are used for infrastructure, where will the rest be spent—on even higher salaries, benefits and pensions?" Robbins asks on the argument. In addition to stating that taxes are already too high particularly in California, he also questions the timing of the ballot measure, contending that it "greatly weakens the Council's bargaining position when it negotiates new long-term union contracts later this year." Robbins goes on to note that El Segundo voters already declined residential trash fees and a prior business utility user tax increase. "Measure A will cost residents and businesses much more than what we already rejected," he contends. Other signees on the argument against Measure A include local residents Jane Friedkin, Richard Switz, Marc Rener and Mike Van Biezen. The Council also submitted a rebuttal to

the argument against Measure A with the reasoning that while "no one LIKES to raise taxes," lowering and losing services is even worse. The rebuttal notes that the Council has cut employee compensation, reduced staffing, adopted a two-tier pension system and lowered long-term costs, but emphasized that existing

pension liability is determined by State law and is not under the Council's control. It also states that the "Council is committed to fair negotiations" with bargaining units "while taking into account the City's economic position." Additionally, the rebuttal points out that the new utility taxes will actually decrease after three years, that the Council can choose to lower taxes at any time and that the group also passed a resolution to dedicate one-third of the tax monies towards "repairing facilities like parks, streets, sidewalks and curbs." The rebuttal also states that "in 2012, El Segundo voters resoundingly voted 'No' to transfer El Segundo Fire to Los Angeles County Fire despite millions of dollars of City savings. Voters understood the personal financial impact because Los Angeles County Fire contracts its transport services to private ambulance companies, averaging \$1,500 or more per transport. Should Measure A fail and fire is transferred to Los Angeles County, those fees would be the residents' responsibility."

In Robbins' rebuttal to the argument in favor of Measure A, he writes that the Council raised Chevron's taxes by an average of \$8.5 million annually for 15 years and that the City can save millions per year in public safety employee special compensation. He notes that police and fire personnel make \$150,000 to \$300,000 per year in total compensation and that the Council increased pension costs through "excessive raises and special compensation." Robbins maintains that the Council can come back in November after negotiating new long-term contracts with unions. He goes on to call talk of transferring services to the County an empty threat, contending that this would actually reduce services—and points out that 90 percent of local voters rejected a measure to contract with the County for fire services. "We can do a referendum against an ordinance to outsource services," the rebuttal reads. As for the partnership with the business community on Measure A, Robbins states that the Chamber did not allow its general membership to vote and take a position on the matter. He concludes by stating that the Council resolution on how to spend the tax monies is non-binding.

Ballot pamphlets, which will also include information on City Council candidates as well as Measure A, will be mailed to residents in March. •

Parking Meter Law Gets Much Needed Change

With Assembly Bill No. 61 in effect, localities will no longer be able to continue to adopt ordinances or resolutions that would prohibit or restrict the ability of a vehicle to park at an inoperable parking meter. As the law was formerly applied, cities were allowed to cite and fine drivers who parked where

If there is a driver searching for a parking spot in a part of the city that requires one to pay for metered parking, there is a very that in some cities, being out 30 seconds after your meter expired will result in a \$75 fine. Having a parking space go to waste in a city where finding parking is like winning in Las Vegas is as absurd as citing someone for using said space.

For anyone who wants to argue that the city needs time to fix said meters, point well taken. However, a city's inability to fix something fast should not result in a loss of business for a store, restaurant or any other merchant that would benefit from a potential customer parking at the site of a broken meter. The meter being broken is already bad because the city is losing some income and that's never good. However, making it to where customers and local businesses can't connect also affects the city as much as the business owners. The lost sale means less sale tax being generated, which also hurts the city.

If any city believes that citing a driver for parking by a meter that the city has failed to fix is the right thing to do, then we should all thank Assemblyman Gatto. •

otherwise made the South Bay their home. First there was the Los Angeles Raiders followed by the LA Express. Then came the Los Angeles Lakers followed by the Los Angeles Clippers. Now the Los Angeles D-Fenders of the National Basketball Association's (NBA's) Development League (D-League) call El Segundo home.

Not only do the D-Fenders workout at the Toyota Sports Center, located at 555 North Nash Street, but they play all of their home games there too. This is also the same building that is the practice facility and headquarters of the Lakers. When you attend games here, you'll see the retired Lakers jerseys hanging on the wall as well as view the 10 NBA championship trophies on display.

The D-Fenders are not new to El Segundo, as they've been practicing and playing their home games right here in our backyard for years. For the third consecutive season, the D-Fenders will play their home games at the Toyota Sports Center.

The Los Angeles D-Fenders are the first franchise in D-League history to be owned by an NBA team (Los Angeles Lakers) and they are returning for their seventh season in 2013-14.

The D-Fenders franchise has quickly established itself as one of the top producers of NBA-ready talent. Just with the D-Fenders, there have been a total 15 NBA call-ups and development of 14 Laker assignment players since their inaugural 2006-07 season.

The Lakers have been without guards Kobe

Blake all out due to injuries. So the Lakers recently signed Kendall Marshall out of the D-League. He had been leading the Delaware 87ers in scoring with a 19.7 point-per-game average and 9.6 assists before he was activated

Marshall was a lottery pick by Phoenix in 2012. The North Carolina product made little impact with the Suns, who traded him to Washington, but he was waived before the season started. He set the ACC's single-season record with 351 assists in 2012, so he could be an impact player for the Lakers.

The D-Fenders are currently headlined by five players who have previous NBA experience including Jamario Moon, Kareem Rush, Manny Harris, Terrence Williams and James Southerland. The team was also the first in league history to win the Development Champion award (2011-12). This is an honor given to the team that best embodies the D-League's goals of developing NBA basketball talent via call-ups and assignments.

As Evan Kaplan, Public Relations Coordinator for the Los Angeles D-Fenders explains, the D-League is the official minor league for the NBA. Baseball has its minor leagues that canvas all across the nation in small communities to mega-metropolitan cities. Basketball has mirrored that concept

2013 A Work in **Progress for Dodgers**

While looking at the Los Angeles Dodgers' 2013 season in a macrocosm, thinking back it seems as if it was a very successful year. The team wound up in the National League Championship Series, found and promoted rookies that will serve to benefit the club for years to come--and took some relatively old, washed up has-beens and re-solidified their careers. If you extend the microscope a little further, however, and delve in deeper into the Dodgers' season as a whole, you'll realize that there was one strict turning point that turned the tides for everyone cheering on for the "Boys in Blue." In just three months time, the Dodgers went from the cellar of the National League West as one of the worst teams in the entire league to celebrating a league championship victory in Arizona's outfield pool. A midseason turnaround truly had everything to do with the Dodgers' success this year.

If you've followed the Dodgers closely at all since the 1990s, then you know that you never quite know what you're going to get from the team. They could have all of the power, pitching and potential in the league and yet somehow still let their fans down come the stretch run or playoff time. Last year was the epitome of "not knowing." Again, with all of the potential in the world coming into this season, the Dodgers started things off by letting their fans down. With manager Don Mattingly's job in question and a \$230 million payroll, the team began the season as one of the worst in the entire league. It didn't become that way solely by chance, however. With brand new players on the team like Zack Greinke and Yasiel Puig trying to fit in and stars like Adrian Gonzalez and Hanley Ramirez still needing time to get their feet wet, team chemistry began at a record low, to say the least. Then out of the blue, the injury bug bit.

Seventeen players made 24 trips to the disabled list in the 2014 season. If that doesn't spell disaster, then quite frankly what does? Josh Beckett, Chad Billingsley, Scott Elbert and Shawn Tolleson were all lost for the entire year. Matt Kemp might as well have been lost for just as long with injuries plaguing his former All-Star physique for the entirety of the season. Ramirez was out before the season even began with right thumb surgery before going down again with a strained right hamstring and then playing through injury in the playoffs when hit by a pitch--reducing the fulcrum of the team to what appeared to be almost nothing. And who could forget Greinke's story? In a spat with Carlos Quentin of the San Diego Padres, the newly acquired All-Star pitcher broke his collarbone and was sidelined for well over a month. Needless to say, Dodger trainer Sue Falsone had her work cut out for her. She resigned at the end of the season.

That's when things were looking bleak. In the cellar, injured and almost utterly destroyed, the Dodgers somehow, someway found life. On June 22, 9.5 games out of first place, the remarkable happened. Puig was called up from the minor leagues and almost like a shot in the arm (no steroid reference intended), the Dodgers were reinvigorated. The team went on to win 42 of its next 50 games, including 15 consecutive road games, to jolt the players awake and reignite a (at the time) lackluster fan base. The 50-game stretch was the second greatest in baseball history and the 15 consecutive road wins proved to be a Los Angeles record. The Dodgers, coming from out of the depths, wound up being the first team in all of baseball to clinch their division last year and finished the season with their biggest margin of victory over the second place team in L.A. Dodgers history with an 11-game lead over the Arizona Diamondbacks.

Aside from their remarkable ascension into baseball greatness towards the end of the season, the Dodgers were able to find many diamonds in the rough. Puig, for instance, was one. The energy that the rookie brought back into the stadium was rivaled only by Manny Ramirez's arrival and possibly Eric Gagne's remarkable saves streak, but may have been even greater than each of those individually. His potential, combined with the pitching prowess of rookie Hyun-Jin Ryu, who had 14 wins and a 3.00 ERA as the third starter, created a foundation for the team that will make the Dodgers successful for years to come. Juan Uribe woke up, Kenley Jansen solidified his role and the bullpen rounded out into better shape than it has looked in years.

With some work certainly still be done, the Dodgers have already strengthened their bullpen even more by locking up Brian Wilson for another two years, re-signing J.P. Howell, and bringing in former Cleveland Indians' closer Chris Perez--all while retaining the services of Paco Rodriguez, Chris Withrow and Brandon League. Truly, we won't know what the Opening Day roster looks like until the first pitch of the season is thrown, but the management of the Dodgers is what has brought reliability back into the franchise. Faith is restored in the Dodgers and an attendance that in 2011 sank below three million for the first time since 1995 jumped up 27 percent last year to nearly 3.75 million with 29 sellouts--the most since 1983 and seemingly overnight. Now, there is something to believe in around "Dodgertown" once again. Aggressive moves led by an aggressive ownership have reawakened the fans of Chavez Ravine and there is no doubt that in this new year of 2014, a championship is in the works. •

Erie BayHawks, Fort Wayne Mad Ants, Idaho Stampede, Iowa Energy, Los Angeles D-Fenders, Maine Red Claws, Reno Bighorns, Rio Grande Valley Vipers, Sioux Falls Skyforce, Santa Cruz Warriors, Springfield Armor, Texas Legends, Delaware 87ers and Tulsa 66ers.

Each of the NBA teams has a D-League affiliate and in some cases a D-League team is affiliated with more than one NBA team. There are three teams that boast more than one NBA affiliate including the Fort Wayne Mad Ants, Iowa Energy and Bakersfield Jam.

The teams are divided up into the Western, Central and Eastern divisions. Each division winner and the five "wild card" teams with the best records regardless of division will qualify for the playoffs.

The NBA prefers to call the players in the D-League prospects and believes they each have an opportunity to be called up. Most of the players on the D-League rosters have either been drafted and released from their team, signed as a free agent or have been with an NBA club and have been sent down for some additional seasoning.

The league itself has been operational since the 2001-02 season. Prior to this season, 286 call-ups have been activated to an NBA team. Some players have been activated a number of times and to different teams. The D-League has proven that it develops talent. Last season, almost 30 percent of all NBA players had D-League experience. Each of the 30 NBA teams featured players who had played at some point in the D-League.

More than 40 percent of players drafted into the NBA since 2005 have played in the NBA D-League. Ten former NBA players are in the NBA D-League coaching ranks this season. The prospects in the D-League dream of playing for an NBA team.

Unlike in baseball where a player is owned by their parent clubs and can be traded from team to team, it is much different in the D-League. There are two different types of players in the D-League--those who are on assignment from NBA teams, and free agents. While assigned players can only be recalled by the NBA team that owns their rights, free agents can be signed by any NBA team at any time during the season. That's what happened with Marshall.

The assignment system went into effect just prior to the 2005-06 season. It allows NBA

enterprise provides an NBA team control of the D-League team's basketball operations while local ownership maintains control of the business aspect.

There are a few ways to attend, view or follow the D-Fenders. Of course, taking in

The next one is Family Day 2014, set for Monday, January 20 at 1 p.m. The cost is \$15 (adult) and \$10 (kids) and includes game ticket (seating within the first seven rows), pre-game court time from 10:30 a.m. - 11:30 a.m., Laker Girl autographs, post-game autographs, a photo opportunity with Lakers' 3-Peat trophies and a chance to participate in on-court contests.

At a recent game, the promotional on-court activities with fans included a free throw contest, a dance-off and a dress-dibble and shoot contest. Also the team has giveaways that include free tacos to everyone in attendance if the D-Fenders make a three-pointer in the final two minutes of the second quarter. Local restaurant Britt's BBQ gave away a free pulled pork sandwich to fans at the game when the D-Fenders held the Bakersfield Jam to under 100 points. The Jam had four players with NBA experience playing.

Another way is to follow on YouTube. The league shows over 350 live games on the NBA D-League YouTube Channel and NBADLeague.com. Fans can get a glimpse of the players, coaches and officials competing to ascend to the NBA's ranks. The D-Fenders will show 23 of their games locally on Time Warner Cable Sportsnet.

The D-Fenders recently trailed 32-15 against Bakersfield in the first quarter before making an improbable comeback to win 107-94 to improve to 7-7. It was the team's fourth win in a row in front of a sellout crowd of 415 people. It is fun, exciting basketball and as D-Fenders head coach Bob MacKinnon says, "This is a players' league and anything can happen."
