Dugan Joins Incumbents in Race for Two Council Seats in April Municipal Election

Three candidates will vie for two open slots on the El Segundo City Council after Mike Dugan threw his hat into the ring at the 11th hour to challenge incumbents Bill Fisher and Suzanne Fuentes. Dugan pulled papers late last week and returned them on Monday—the deadline date to officially file candidacy for the April 8 municipal election. Mike Robbins, who wrote the ballot argument against the Measure A tax increase initiative also going before voters on April 8, pulled papers on January 13 but did not file. The filing period began on December 16.

Fisher, who joined the Council in 2006 and became Mayor in May 2013, is seeking a third term. He is a local business owner, running a computer engineering firm, and has lived in El Segundo for the last 15 years. He spent his youth moving with his family as his father built oil refineries around the world. He earned a bachelor's degree in engineering from Texas A & M University. In addition to his Council activities, he is on the board of the El Segundo Education Foundation. He is a past president of the El Segundo Kiwanis Club, former board member and treasurer for the El Segundo Chamber of Commerce, and was treasurer and a founding member of the grass roots organization to retain Los Angeles Air Force Base.

Fisher listed several Council accomplishments over his tenure, including balancing eight budgets, maintaining public services while reducing City costs, decreasing longterm pension expenses, successfully negotiating a revenue plan with Chevron and the future construction of a new public pool with Wiseburn School District, bringing new business to town through economic development, and defending and preserving El Segundo's home town charm. "I do this work because it's important," Fisher said of his desire to serve another four years. "I believe people deserve a fair shake and those that have contacted me will say I'm responsive, work diligently and resolve issues."

Fuentes, a 50-year local resident and 1975 El Segundo High School graduate who went on to earn a bachelor's degree at Loyola Marymount University, a master's at Cal State Dominguez Hills and completed a teaching credential from Chapman College, has worked the last 26 years as a satellite engineer for a local aerospace company. She joined the Council in 2010 and served as Mayor Pro Tem from April 2012 to May 2013. She is a former El Segundo Planning Commissioner and past member of the Aviation Safety & Noise Abatement Committee. Other affiliations included membership on the El Segundo Senior Citizen Housing Board, City/School Affairs Subcommittee, ROAD, Los Angeles Jobs Defense Council, South Bay Cities Councils of Governments (COG) and Santa Monica Bay Restoration Commission.

"I'm running for a second term because I love serving the residents of El Segundo," Fuentes explained. "I consider every day on the Council a privilege and never take the public's trust for granted. My value to our city increases daily as I build positive relationships with City, County, State and Federal representatives and agencies."

Among her Council accomplishments, Fuentes pointed to the Chevron tax settlement, improved budget restraint, her role in getting El Segundo involved in the sequestration process early

in conjunction with the Los Angeles County Economic Development Corporation to lobby Congressional leaders and speak to the media, and her active participation in the COG.

An El Segundo resident for over 30 years, Dugan is a management consultant with over 35 years of manufacturing and management experience, 31 of those with Chevron. A charter member of the El Segundo Education Foundation Superintendent's Roundtable and former Ed! board member, he is currently Chair of the St. Anthony School Council. Dugan is also an El Segundo Kiwanis member and a past president of the club, and served on the Capital Improvement Program Advisory Committee from 2002 to 2006. "I'm concerned about the future of El Segundo and the direction our current Council is taking," Dugan explained about his reason for running, while adding that his delay in filing was due to heavy year-end activity in his consulting business. "There is a lack of transparency in our current Council and I'm not sure that they are listening to the people and representing what the voters want. I believe we're best served when public officials listen

School Board Meets after Holiday Hiatus, Hears Cheerleader and Parent Views

The first meeting of the El Segundo School Board in 2014 started off with a packed crowd in attendance. After President Laura Gabel gaveled the meeting into order, the public comments portion featured a litany of parents and past and present youth cheerleaders approaching the podium. Sometimes speaking emotionally, they showed their displeasure at the recent personnel decisions involving two cheerleading coaches at El Segundo High School who had been relieved of their coaching duties last month.

Following the 65-minute public comments section of the meeting, Richmond Street School fourth grade teacher Kirsten Larson made a special presentation to the Board. Larson ran

a pilot after-school program in October and November with fourth grade students eligible for GATE (Gifted and Talented) testing. The students spent seven weeks connecting with "ePals" schooling in Brazil, collaborating on science projects. During their email exchanges, the students were tasked to not only exchange science knowledge, but to learn about their new ePals and their differences in culture.

Larson was escorted to the presentation podium by three of her young students who had taken part in the program, and they watched the video presentation to the Board. The students were also taught how to conduct online research and import the information onto school iPads to create an iMovie. The 10 students at Richmond

Kenneth McElvain

Retired El Segundo Fire Department Captain Kenneth (Bud) McElvain answered his last call December 31, 2013. Born November 23, 1930 in Evansville, Indiana, Bud was a country boy from meager beginnings who went on to lead an impressive and honorable life. Bud proudly joined the U.S. Navy in 1948, where he became an accomplished Navy diver and traveled the world while serving his country. He then worked at Standard Oil after leaving the Navy and remained there until he joined the El Segundo Fire Department on April 1, 1959, as one of the "April Fools Gang." Bud moved his family to El Segundo shortly thereafter, where they still reside today. He retired form the ESFD in 1985 and served in the Coast Guard Reserves as a Fire Fighter. In his later years, Bud returned to his love of diving when he joined the California Classic Equipment Divers Club, teaching young divers to use the classic diving equipment,

including the Mark V helmet he work in the Navy. According to his family, Bud was an archetypical "Real Man." In addition to his service with the Navy, Coast Guard, and ESFD, Bud was a Historical Diving Instructor, Moose Lodge Pilgrim, Coors "heavy" partaker, and most importantly, proud Dad, Grandpa, and Great Grandpa. Bud was preceded in death by his beloved wife Barbara, parents and three brothers. He is survived by his four children Naomi, Noel, Nora, and Michael, as well as eight grandchildren, three great grandchildren, and an eclectic extended family. Bud affected the lives of countless people during his many adventures, and he will live on in the hearts of everyone who loved him. Gerald Wayne Cox, Sr.

Gerald Wayne Cox, Sr., died on Jan. 9, 2014, on his own terms. At 92 years old, he was ready to rejoin his beloved wife of nearly 70 years, Madge Edna Randall Cox, who preceded him in death in February, 2010. And so, when Wayne was confronted with a difficult health issue recently, he decided against treatment and quickly passed

away. He had played his last round of golf, a game he loved, about a month before, and he had enjoyed good health through nearly every day of his long life.

He was born in Wilson County, Kansas (west of Fredonia), on Sept. 1, 1921, in a 10 by 12 foot tin roof shed. His parents, Howard Cox and Hazel Butner Cox Veach, moved the family to California's Imperial Valley in 1922, where Wayne's father worked on a grapefruit ranch. They settled in Redondo Beach, in 1923, on Torrance Blvd.

Soon after the Great Depression hit in 1929, Howard Cox lost his job, and it became difficult for the family to put food on the table. Wayne, who was still in grade school at the time, learned to fish and for several years he brought home fresh fish almost daily, for supper.

After entering the 9th grade, young Wayne decided to make a change in his life. As he once recalled, he "went to school one morning and never got there." He hitchhiked to Indio, CA, where he hopped onto a freight train and rode all the way to St. Louis, MO. He spent many months working odd jobs before returning to California and joining the Civilian Conservation Corps (CCC), in 1938, working in Placerville, CA, as a wood crew axe man.

After he left the CCC, he met Madge Randall at a beach party. She was a beautiful, tall girl, with flowing brown hair. She was there as the date of an acquaintance of Wayne's, but the boy asked Wayne to take her off his hands that evening, because she was a "lemon" who refused to kiss him. Wayne escorted her home and made sure he kissed her goodnight. The couple, who shared the same birthday, married in 1940 and had three children together.

The family lived in El Segundo, CA, for many years, while Wayne worked for Standard Oil.



He served his country in the U.S. Army during World War II, stationed in the Philippines, and he was reactivated in 1950, serving as a platoon sergeant during the Korean War.

After the children were grown, Wayne retired from Standard Oil and moved with Madge to Woodland, in 1966. He later worked intermittently as a

consultant for an oil and chemical company, training workers at start-up refineries. The job took he and his wife to eight countries across the world, including Russia, Poland, Belgium and Australia. From 1981 to 1995, Wayne worked part-time for JR Scientific in Woodland, helping to build lab rooms.

He was a devoted member of The Church of Jesus Christ of Latter-days Saints and served in several volunteer positions, working in the Scout and missionary programs and serving as a leader in his congregation. He considered himself to be a "helper," and frequently used his handyman skills to assist friends and neighbors with small jobs in their homes. He loved golf and baseball, and he kept a vegetable garden throughout most of his life, after he'd learned to grow food during the Great Depression.

He served on the board of directors of the Yolo Fliers Club and was a member of the American Legion and the Veterans of Foreign Wars.

He is survived by two of his children, Susan Lynn Childers, of Woodland, CA; and Carol Ann Pew and her husband, Gary, of Sacramento, CA; his older brother, Dean Cox, of Fairfield, CA; 11 grandchildren and 26 great-grandchildren. He was preceded in death by his wife; oldest child, Gerald "Jerry" Wayne Cox, Jr., who was killed in 1968, while serving in the U.S. Army in Vietnam; his parents; and his younger brother. Keith Cox.

Funeral services will be at 11 a.m. on Saturday, Jan. 18, at The Church of Jesus Christ of Latter-days Saints, 850 Pioneer Ave., in Woodland, CA, where nearly every member of Wayne's large extended family will gather. Following the funeral service, Wayne will be laid to rest next to his wife at Monument Hill Memorial Park, Woodland, at 12:30 p.m. Arrangements are being handled by McNary's Chapel. •

to residents. I listen and I take action that is in the best interest of the citizens. I want to help the people of El Segundo guide the City to a fiscally responsible and sustainable future that our children can enjoy without making short-term decisions that have long-lasting consequences."

After falling short in his first bid in 2004, Fisher was appointed to the Council in 2006 along with then-Mayor Kelly McDowell when they were the only candidates vying for two open seats. Running for his second term in 2010, Fisher was the top vote-getter out of three candidates, with Fuentes finishing second in that election to earn her seat on the Council. This will be Dugan's second Council run after finishing fifth out of seven candidates in 2012.

For those looking to promote particular Council candidates or positions on Measure A, lawn signs cannot exceed four square feet in area. Additionally, there cannot be more than one sign per candidate on the frontage line of a given property. Signs may only be placed on private property—they are prohibited on public property or public right-of-way. According to the City's campaign finance regulations, no person can make a contribution of more than \$750 to a given candidate in any calendar year. Those giving \$100 or more must provide their name, address, occupation and employer. Those contributing under \$100 need only list their zip code.

Street spent the last couple of weeks of the project collaborating with each other, learning the iMovie application. At the conclusion of the project, the students had created and shared their iMovie collaboration.

With no discussion items on the agenda, the Board then tackled the consent agenda. Among the items approved were agreements with the Humboldt County Office of Education; a consultant agreement with Behavior and Education to provide refresher training for the Eagles Nest preschool special education credentialed teacher; a couple of contracts with CSS Presentation Systems to provide support for Richmond Street teachers; a Center Street School assembly that will take place in early March; and an El Segundo Middle School Art, Band and Choir field trip slated for the second week in April that will take place in Las Vegas.

The Middle School students will depart for Las Vegas on April 11 and return the next day. While in Las Vegas, the students will participate in the Heritage Festival, which purports to promote "excellence among choirs, bands and orchestras by providing the best opportunity for learning through seeing, experiencing and interacting with other student performers and top music professionals." The price per student is \$499, with the necessary funds to be raised by student activities.

The Kahurangi Maori Dance Theatre of New Zealand will be performing at the March Center Street assembly. The assembly will provide a special musical enrichment opportunity to local K-5 students, with performances expected to include "dance and traditional music of Polynesian Island nations, including Tahiti and Hawaii, along with traditional New Zealand Maori traditional dance performances."

CCS Presentation Systems, Inc. will be providing support for Richmond Street teachers, including preventative maintenance emergency services for classroom SmartBoards and projectors. CSS will also consult with the Richmond Street staff on iPad integration in the classroom, as well as support the enhanced use of SmartBoards.

The contract agreement with Humboldt County Office of Education features an interactive website that will allow students with individualized education programs to "perform such tasks as creating resumes, letters, and studying for the California driver's license and Armed Services vocational assessment tests." The site also features several documents that are downloadable that can be useful for students transitioning into independent adult life.

With no information pending action items listed on the agenda, the 100--minute meeting concluded with Superintendent Geoff Yantz updating El Segundo Unified School District's informational calendar, Board reports by each member, and the Superintendent's report. •



Finally, Somebody Steps Up to Prevent Mass Spying of Citizens

Due to the repeated admission by federal administrators that there has been a widespread effort to spy on American citizens who are innocent of any wrongdoing, Senators Ted Lieu and Joel Anderson introduced a bill seeking to ban state agencies, officials and corporations that currently provide a service to the state from assisting the federal government in its efforts to spy and collect certain data on Californians.

It is troubling and disheartening that the federal government has spent so much time and resources on domestic espionage of people who have done nothing wrong. It is even more frustrating that since the tragic events from September 11, there are leaders still willing to exploit the fears and anguish of the victims of that day to justify these types of espionage tactics on private citizens. Sens. Lieu and Anderson are taking a stand, for now symbolic, against such invasive practices.

It is no surprise that the government, on any level, can spy on citizens. However, the steps that the NSA took to collect information on millions of citizens are as ridiculous as they are criminal. One report indicated that the NSA collected phone information on an estimated 317 million Americans. Of those citizens whose privacy was violated for no good reason, about 38 million are Californians. The NSA and President Obama's administration can claim that these actions were taken in the name of national security, but the truth is that such an explanation is simply

a copout. It is difficult for me to believe that 38 million Californians are involved in criminal activity. It is even harder to accept that 317 million Americans are such a threat to national security that we need the NSA to spy on their phone calls.

Conducting secret surveillance on a group of individuals involved with criminal activities is a legitimate security measure. In order to do so, there are several steps that must be followed, such as obtaining warrants and other paperwork that help maintain transparency throughout the process. The bill introduced by Sens. Lieu and Anderson attempts to preserve that process in order to maintain the privacy rights of every law-abiding Californian. Maybe I'm old-fashioned in believing in the Fourth Amendment to the United States Constitution and the right of Americans to not be subjected to "unreasonable searches and seizures."

In California, the NSA would rely on the services provided by the state and private entities to collect and conduct such surveillance. With the bill attempting to ban state agencies, officials and corporations providing any services to the state from giving support, from participating or assisting any federal agency in spying efforts, at least Californians will be more protected than your average American. The first step has been taken with the bill introduced by Sens. Lieu and Anderson. Maybe the rest of our elected officials in Sacramento can pass the bill and enforce it for the well-being of every Californian. •

Eagles Gain Respect Going into League Play

The high school basketball season will enter a new phase this week with the start of Pioneer League play. For the El Segundo boys' team, the season has started out a little rocky. But with an impressive showing against two Bay League powers, the Eagles have managed to raise some eyebrows.

The Eagles have started out the season just 2-12 entering this week, but they have played much better than their record might indicate. They have played 11 games against teams with winning records and one of their wins is against 1AA power Huntington Beach.

new releague alignment set to start in 2014-15, the Eagles would love nothing more than to make one last imprint on the league they've called home for more than a decade.

The Eagles hosted Palos Verdes and played inspired basketball against a team that defeated them earlier in the season in the El Segundo Tournament. In that game, the Sea Kings got out to a quick start and never allowed the Eagles to challenge them.

In their second matchup, El Segundo's defense really thwarted the Sea Kings and caused plenty of first half turnovers. The Eagles' shooting woes that have haunted them all season long continued. The fact the two teams were tied at the end of a low-scoring first quarter is a testament to El Segundo's defensive efforts.

At halftime, the Eagles trailed 21-18 and took their first lead of the game early in the third quarter on Jacob Stone's two free throws. The Eagles held the 28-27 lead going into the third quarter.

The Eagles' defense stymied Palos Verdes time and time again and did not allow the Sea Kings to make a three-point shot in the game. The defensive efforts of sophomores Andre Allen and Wyatt Boyce as well as seniors D'Marco Wood and Stone contributed to the close game going into the fourth quarter.

The fate of the game and the turning point came with a just less than five minutes remaining. The Sea Kings' Tyler Colon, who led all scorers with 23 points, made a steal and was on his way for an easy layup. Allen intentionally fouled him and the Sea Kings took advantage with a four-point swing and a 35-32 lead. The deficit grew to five points with three minutes remaining and nine points with a minute left before the eventual 50-36 loss.

There were plenty of positives going into the next game against Mira Costa. The Mustangs, ranked third in the latest CIF Southern Section State-bound Justin Strings' inside jumper. These two would battle all night long and Boyce held his own with two more blocked shots.

Allen gave the Eagles their first lead of the game with 5:40 left in the first half. The fact that the Eagles were even in the game to this point was surprising to some in the stands. "I think we surprised some people being able to stay so close in the first half," said head coach Rick Sabosky.

With a team that has steadily shown improvement, Sabosky was not phased about how his team was playing. "They're working hard in practice and we're not giving up easy

With another low-scoring affair, the Eagles weren't backing down from a highly touted team. The Eagles made the Mustangs work for their points. The fact that just two Mustang players scored in the first quarter was a testament to the defensive mettle against a high percentage shooting team.

Been There, Done That

A relatively close game through the first half turned into a dominant second half performance by the San Francisco defense as it rallied toward its 30th postseason win in a 23-10 victory, advancing the team to an NFC championship matchup with the Seattle Seahawks.

At the end of the first half, the 49ers went on an 80-yard drive resulting in a touchdown to take the lead going into the break. Coming out of the intermission, San Francisco's defense began to assert its power with a quick threeand-out, allowing the 49ers to go on another 70-yard drive for a touchdown to steal all of the momentum from the game and give the team a distinct advantage. "We had to get settled down," 49ers starting quarterback Colin Kaepernick explained. "We came out--they did some unorthodox things against us. We settled down, we got into our rhythm, we started making plays." Once the 49ers got settled down, it was all downhill for the Panthers from there and San Francisco's superiority over Carolina really began to show. The 13-point victory over Carolina marked the third consecutive season that the 49ers would make it to the NFC title game--three years straight under head coach Jim Harbaugh, including one Super Bowl appearance last year. San Francisco had the experience and that was evident on the football field. The 49ers have been there and done that before, and now will be looking to do what they couldn't last year: win on the last day of the season.

If the 49ers are going to do that, though, they are going to first have to get past a Seattle team that statistically has the best defense in the league, the loudest crowd in the league, and has lost only one game at home in the two years that starting quarterback Russell Wilson has been at the helm. If you thought the Niners/ Panthers game was intense, just wait until you see the display of emotion that takes place on beginning," Kaepernick said. "It's going to be a knockdown, drag-out game."

The 49ers may have all of the momentum on their side. Having won eight games in a row, they are the hottest team in the NFL right now and are coming off of two straight road victories in the playoffs. If that doesn't say tough to beat, then what does? Perhaps that bodes well for the team from the Bay, but if the 49ers are going to even make it as far as the Super Bowl, they'll have to learn quickly how to play in the stadium that literally generates earthquakes because of its noise level. San Francisco may enjoy playing on the road, judging from its first two playoff victories, but there is no venue in the NFL that is more difficult to play in than Seattle's CenturyLink Field.

The Seahawks and the 49ers have met twice this season already, splitting the regular season series at a game apiece. This time isn't like the others, though. This time, it's do-or-die, win or go home, and someone's season will end on Sunday night. For the two teams on the field, it will definitely be intense and impassioned in what has truly become a heated rivalry. For all of those watching, it will be fun to view, to say the least. For the San Francisco 49ers though, they have experience on their side. If there is one thing that can take down the Seattle Seahawks, it is experience in big time games like this one. The 49ers have been there and done that before and are now back to gain the one thing that has eluded them throughout their success in these last three seasons. A Super Bowl victory is the only accomplishment left for San Francisco and the only way to get to that is through the Seahawks this Sunday night. •






