City Council Moves Closer to Adopting South Bay Car-Sharing Program

On Tuesday night, the El Segundo City Council took the next step in approving a car-sharing program that will also serve other South Bay communities. With the endorsement of the South Bay Cities Council of Governments (SBCCOG), Car2go hopes to provide a "flexible mobility solution" for nine municipalities. In addition to El Segundo, the list of cities includes Gardena, Hawthorne, Hermosa Beach, Lawndale, Lomita, Manhattan Beach, Redondo Beach and Torrance.

Originally presented to the Council in November, the Car2go program allows drivers to pick up a vehicle at a moment's notice and use it for however long they wish before dropping it off anywhere within a designated geographical area-in this case, a 42-square mile section between the 105 and Pacific Coast Highway and from the ocean east to Vermont and Western. Applicants (who pay a \$35 membership fee good for life) can pick up compact two-seater smart cars parked at various locations throughout the community and rent them by the minute, hour or day. A main goal of the program is to remove cars (and associated costs) from the transportation system and also reduce the need for a second car. In all Car2go expects to provide at least 300 vehicles, though likely only 10 to 20 of those will be placed within El Segundo at a given time. To pave the way for Car2go's arrival, the Council on Tuesday introduced an ordinance to grant the company permits (in the form of a South Bay sticker) to allow the smart vehicles to park in town without time restrictions. A second reading of the ordinance will take place on April 2. Despite being in favor of the program, the Council held off on a resolution

vote to approve Car2go and to execute an agreement. Those items will also be on the agenda in four weeks. Mayor Carl Jacobson felt that it was "jumping the gun" for El Segundo to take the lead on the program when South Bay cities with the highest populations and the "most to lose" (Torrance, Manhattan Beach and Redondo Beach) hadn't weighed in first.

He indicated that he would like to see those cities on board before El Segundo formally commits. One of Jacobson's concerns was that cities with parking meters could lose revenues from the program. However, Car2go Business Development Manager Walter Rosenkranz explained that the company reimburses cities See City Council, page 13

neighboring communities will keep a close eye on upcoming developments with Los Angeles World Airports (LAWA) after the Los Angeles County Board of Supervisors last week directed CEO and County Counsel William Fujioka to review efforts made to create and implement a regional plan for air traffic. The original motion from Supervisor Don Knabe two weeks prior came out of his concern that LAWA and the City of Los Angeles may not have taken sufficient steps to spread air traffic among other airports in the region—a key provision of a 2006 legal settlement. On February 26, Knabe and Supervisor Mark Ridley-Thomas brought forth a revised and decidedly less contentious motion pointing to a regional strategy as "an essential element of the economic development and environmental future of Southern California" that should "identify the optimal usage for each commercial aviation facility in order to

According to LAWA Public Relations Director Nancy Castles, a semantics issue has clouded the conversation because various media outlets reported that LAWA is required to regionalize. "We don't know where that is coming from, but we have heard media and the community use the term requirement," she said. "The lawsuit settlement does not say that. LAWA can do all it can to encourage regionalization, but federal law prohibits LAWA from forcing airlines and/or passengers to choose one airport over another."

That said, Castles confirmed that LAWA will work with Fujioka to meet the 30day deadline. She went on to summarize the agency's efforts in promoting Ontario International Airport (ONT) to air carriers. See LAX, page 12

<u>Obituaries</u> Harrison Cecil Mondy

It is with great sorrow, tempered with celebration for a life well lived, that we announce the passing of Harrison Cecil Mondy on Saturday, February 16, 2013. He was 95 years, 10 months, and 27 days old when he passed. Harrison was born on March 19, 1917 on his father's farm, in his mother's bed, delivered

by a doctor who arrived on horseback. His birthplace was in the hamlet of Loraine, just north of Pocahontas, Arkansas in the Ozark foothills. He started first grade at age four and achieved his bachelor's degree from Tulane University at age 40.

In between those years he milked cows, plowed behind a mule, split rails, and to create a new station. H.C. Mondy, without a degree, sat down with large sheets of drafting papers and an electronics parts catalog and proceeded to design, order parts and build a 10,000 watt A.M. radio station, WWEZ. After his graduation from Tulane, he accepted a job with North American Aviation in El Segundo

and moved the family here in 1958. During his work at North American, and later at TRW, he and his team developed the homing antennas for the Apollo missions, worked on numerous surveillance and communication satellites. He created new inventions in space technology, and trained several generations of technicians and engineers in the specialized

picked cotton. He became a self-taught radio technician then headed up a radio technician school for the Army Air Corps. He was instrumental in shutting down a Nazi spy ring operating in the South. During WWII he was assigned to a group trying to put RADAR in aircraft. His team also developed the first aircraft mounted RADAR tracking machine guns. Towards the end of WWII, he reconnected with an old acquaintance, Margaret Jinks, whom he married after the war. Long before finishing a degree in Electronic Engineering, he worked at several radio stations as the "Chief Engineer". He subsequently became known as simply "Chief" to many, many people that he knew. The owner of the station group wanted a station in New Orleans, and sent him down

technologies of satellite development and communications.

Having never been anywhere at the age of 23, he has since been around the world twice, lived in Australia, been hijacked and held hostage by Palestinian terrorists, written a book on aboriginal languages, published a children's book, written profusely and learned constantly.

He is survived by his wife of 67 years, Margaret, a sister, Jewel, his daughter Judy Armstrong (John), son James (Geraldine), a grand-daughter, Brecken A. Kelsey, M.D. (Matt), a great grand-daughter, Gwyneth, a bunch of nieces and nephews, a host of in-laws, and even more out-laws, numerous co-workers and team members, and many, many students and protégés. •

<u>One Man's Opinion</u> What If...

The public consensus is that if only Republicans and Democrats would stop their squabbling and address the country's needs, our never-ending financial crises can be resolved and we can move on with our lives. But WHAT IF the consensus is wrong?

WHAT IF our national debt is so large that it is no longer a political question, but one of arithmetic? WHAT IF the total debt and annual deficit are so large that neither Democratic proposals for tax increases nor Republican proposals to cut spending, nor any combination of the two will make a material impact on our financial trajectory? WHAT IF...

The simple facts are these: Our GDP in 2012 was \$15.8 trillion, but our national debt is \$16.4 trillion. Therefore our debt is 1.04 percent of our productivity. Further, The Congressional Budget Office projects that we will add \$845 billion to our debt this year and add an average of \$1 trillion in new debt each year for the next 10 years. The obvious question then, is whether or not our economy is beyond salvation.

Earlier, economists Carmen Reinhart and Kenneth Rogoff had declared that public debt in excess of 90 percent of the nation's productivity "leaves a nation's economy in a dangerous place." Similarly, economists David Greenlaw, James Hamilton, Peter Hooper and Frederic Mishkin said a nation with debt greater than 80 percent of GDP could see its finances spiral out of its own control. Regardless of who is right, since our debt is already at 104 percent of our GDP and growing, we are living in an ever more "dangerous place."

As discomfort with this "dangerous place" grows, buyers of our debt will eventually require a higher interest rate premium. Interest on our debt will then consume a greater share of our national budget, thus increasing our debt further, squeezing out other valid functions of government, or both.

Why doesn't the Democratic approach work? Essentially, the private sector of the economy is the driver of economic growth. Raising taxes simply withdraws money from investors, businesses and consumers, thus stalling out economic growth. To state the obvious, this approach is counterproductive.

Why doesn't the Republican approach work? Between 1946 and 1964, Baby Boomers added 76 million to our population. Add four million of the same age group from immigration, and you have more than 25 percent of our population needing Social Security benefits, Medicare, and Medicaid benefits. The primary drivers of spending therefore cannot be reversed.

There appears to be no way to tax our way out, borrow our way out, or cut our way out of a long-term economic demolition. The daily economic battles are no longer about political ideology, but now sound more like angry cats in a bag, scratching to find the answer to a question that may no longer be answerable.

WHAT IF we've set our ship of state on a course that cannot turn to port or starboard, and dead ahead is a tipping point from which there is no return. WHAT IF... •

Another Man's Opinion Benefits of Attainable Education

Education has been a topic of discussion for Republicans and Democrats during every local, state and national election. Many steps have been taken to address the academic needs of the nation, all with mixed results. President Bush's No Child Left Behind addressed our national K-12 system while current President Obama's Race to the Top expanded on what the previous administration set into motion. However, there is one area of education that President Obama has been addressing during his administration and that is the ability for students to afford a post-secondary degree.

Furthermore, it is common knowledge that there are thousands of corporations that provide full and partial scholarships to academically gifted students. Unfortunately, the private sector alone cannot address the entire issue on its own. President Obama's increase in Pell Grant awards is encouraging for students seeking to finance their schooling without so much debt that upon graduation, they are being crushed by student loan debts.

Our colleges and universities are so prestigious that they continue to attract students from abroad. It would be a shame if our school financing system became so unaffordable that as Americans we are unable to seek a higher education because the financial burden is not worth the expense. President Obama's administration is aiming at having America produce the highest portion of college graduates in the world by 2020. Producing career-ready college graduates is a process that begins in elementary school, but is completed in college. To complete this process, the issue of affordability must be dealt with in a reasonable manner.

The increase in Pell Grant money is not the ultimate solution, nor will it solve all the financial complications facing students. Yet, it is a good incentive for students seeking financial aid for college. In addition, the Pell Grants are an investment by the government that will produce a generation of high-wageearning professionals which will in turn become taxpaying citizens. If we are willing to invest in our nation's safety via military expenditures, which are very necessary, we must also invest in our financial future by ensuring that students can achieve their academic dreams. •

Season Off to a Great Start

The El Segundo High School baseball season is off to a great start. The Eagles are hosting their own tournament and have played well so far. With a new coaching staff in place, a number of returning players and more than enough talent that has moved up from the JV and frosh/soph teams, the Eagles have looked impressive. Though they fell to nationally ranked Serra 7-1 to open the season, the Eagles bounced back against Bell with a 2-0 win to even their record to 1-1. The Eagles faced 2012 CIF Southern Section Division 7 champions Tuesday and continued pool play today against a team to be announced (weather permitting).

The Eagles opened the season by hosting Serra. The Cavaliers have put together an impressive lineup of players recruited from a number of schools including Mira Costa, St. Bernard, Victor Valley and Hamilton. Their prize possession, Dominic Smith, is a hardthrowing left-hander who hit the upper 80s and low 90s throughout the game.

The Cavaliers' plans to throw Smith against the Eagles was in the works for weeks. Serra opted to play at El Segundo instead of its own dilapidated field so it could take advantage of field and crowd conditions. It was also an opportunity to showcase two South Bay teams that should be in the thick of things when league play and the playoffs come around.

Serra struck first with two unearned runs in the first inning. It came back with four more in the third inning and one more in the fourth. Ryan Pordes, who started for the Eagles, gave up six runs--four of them earned--in just over four innings. Tanner Stevens came in to shut down the Cavaliers.

The Eagles had their difficulties against Smith who struck out 10 in five innings. Smith, who is a projected a top five round Major League prospect, limited the Eagles to just two hits and walked three. Facing a pitcher like Smith to start the year may have been a daunting task, but Eagle batters didn't look intimidated. "We were just out of sync with his fastball. I'd like to see where we'd be against him in another month or so," said Eagle head coach Steve Shevlin.

The Eagles' lone run came in the seventh inning when junior third baseman Nick Martinez clobbered his first home run of the year that cleared the towering second fence in left-centerfield. Shevlin, who became just the third El Segundo High head baseball coach in the past 53 years, was upbeat after his team's season opening day loss. "We played well in spite of the score," he said. "That's a good team, but we certainly are too. We're a little banged up with a couple of injuries right now."

The injuries Shevlin is speaking of are to All-South Bay centerfielder Eric Gronhagen and sophomore shortstop Lars Nootbaar. Both are expected to have great seasons and both are expected to return to the lineup in the next week or so.

Against Bell, the Eagles played a clean game defensively and turned three double plays to aid a great pitching performance by right-hander Willem Mostert. The sophomore struck out one, walked three and allowed just four hits. With his complete game, shutout victory, he became just the third pitcher in three years to match that feat. The others were Nigel Nootbaar (USC) and Josh Bornstein (UC Irvine).

The Eagles hit the ball hard against Bell and didn't strike out once, but unfortunately grounded out 14 times. El Segundo managed five hits and Nootbaar accounted for three of them, going three for three on the day with a stolen base. The only run production came in the fourth inning when Austin Brasher lashed a single to left-centerfield. Martinez then hammered his second home run of the year to give his team a 2-0 lead.

The Eagles continued pool play against Firebaugh in their own tournament on Tuesday and play today weather permitting. The tournament wraps up on Saturday with games and sites to be determined. Next week, the Eagles travel to face Redondo in a doubleheader on Thursday with games starting at 3:15 and 5:30 p.m.

The JV baseball team started its season with an 11-1 win over Narbonne. Davis Salzman went five innings to pick up the win. He gave up one run on four hits, struck out three and walked one in an impressive start. Kyle Atmore finished up by throwing two perfect innings.

Joey Garza had a two-run double in the first and Dylan McDonnell's bases loaded triple highlighted a four-run fourth Inning for the Eagles. McDonnell, Matt Mc Clean, Jackson Walz and Richard Bennett each had two hits to lead the Eagles.

Former Eagles are making an impact at the colligate level. Trent Miera (2012) is the starting second baseman for the El Camino Warriors. He is hitting a respectable .318 for the 6-7 Warriors. Justin McCullough (2010) is splitting time at catcher for El Camino and has an on-base percentage of .385 as a hitter.

Nigel Nootbaar (2011) is a sophomore pitcher for the USC Trojans. In his first start of the year, he went six innings in the Trojans' 5-1 loss to Fresno State. Nootbaar, however, may have made an impact by striking out 12 batters--the most by a Trojan in two years. At one point, he retired 11 consecutive batters including striking out the side in the fourth inning. With the loss, he dropped to 1-1 on the year and upped his ERA to 2.45. It was an El Segundo Eagle baseball reunion of sorts when UC Irvine and Loyola Marymount faced off against each other. UC Irvine had pitcher Josh Bornstein (2012) and Grant Palmer (2011) in one dugout, with Brice Savage (2010) in the other and Heath Jones (1988) as the third base umpire. With the 2013 Eagles' baseball team in the stands, they watched as both Savage and Palmer made significant contributions to their teams during this game. UC Irvine's power-hitting lineup came out on top 10-3 as both Palmer and Savage scored for their respective teams. •







"Since 2007, we have met nearly 170 times with airline officials to encourage new and increased service at ONT--22 of which were in 2012 alone," Castles said. "However, the decision to provide service at ONT is ultimately made by the air carriers."

Castles noted that LAWA has invested over \$500 million in capital improvements at Ontario since originally buying the facility in the 1960s, while also taking multiple steps to reduce annual operating costs by more than 20 percent over the last for years. "As a further cost-saving option, we are currently working with the airlines to form an airline consortium to take over several airport operational functions," said Castles. "We also conducted marketing partnerships with airlines during the last 10 years and we continue to offer joint marketing opportunities to prospective airlines. We also offered to transfer the airport's marketing budget to the City of Ontario so they could take over marketing ONT. Our offer remains open. And we conducted market research and analysis covering passenger booking study, the local Ontario and greater Southern California traveler, and developed a draft air-carrier incentive plan which we will take to the Board of Airport Commissioners."

Still, critics question LAWA's commitment to boost traffic at the struggling Ontario facility where passenger count has steadily dropped from a high of 7.2 million in 2005 to just 4.3 million last year. In the 2006 court settlement, the County and other parties dropped pending lawsuits over LAX expansion in exchange for commitments from LAWA to encourage passenger and cargo traffic to flow to other airport locations in the region---including Ontario as well as Van Nuys and Palmdale.

In a letter to the County Supervisors last week, the Playa del Rey-based group Alliance for a Regional Solution to Airport Congestion (ARSAC) stated that it was "gravely concerned" LAWA is trying to "shirk its obligations" by not forming a Regional Airport Working Group or completing an annual Regional Strategic

Planning Initiative. ARSAC President Denny Schneider said his organization applauds the County for examining why air traffic continues to concentrate at LAX instead of dispersing regionally. "The sky around LAX is approaching gridlock during peak hours," said Schneider. "This, along with the inadequate staffing of the control tower, is a major safety issue. We know that safety goes down by a factor of four when the air traffic doubles into an airport. Every other major metropolitan area has multiple airports and so should we. LAX is overdue to be upgraded into world-class performance, but not expanded."

The third busiest airport in the country, LAX reported over 63 million passengers last year, which was roughly a three percent increase over 2011. That figure is still well below the 79 million annual passenger cap established in the 2006 settlement between the City of El Segundo and LAWA. For signing on the dotted line (and in the process opening the door for LAWA's Southfield Air Improvement Project to move forward in 2008), El Segundo received a hefty chunk of money for residential sound insulation as well as a key concession to reduce the total number of passenger gates from 163 to 153 (starting in 2010 by eliminating two gates per year) unless annual passenger traffic was below 75 million. By putting the clamps on gates, El Segundo made certain the airport could not grow beyond its current physical maximum capacity of 78.9 million annual passengers. Meanwhile, LAWA's board recently approved plans to move the airport's north runway 260 feet north as part of a modernization project.

While stating that his city has always promoted regionalization, El Segundo Mayor Carl Jacobson said it was too early to comment on the situation at hand. "There is so much at play at the airport right now, many projects going on and a lot of parties involved," he said. El Segundo's agreement with LAWA expires at the end of 2015. "I hope to negotiate a new deal with them prior to that time," Jacobson added. •

El Segundo Students Stand out at Raytheon's Engineer Games

More than 150 high school students gathered and competed at this year's Engineer Games on February 20 hosted by Raytheon as part of National Engineers' Week.

"We are going to present them with a problem, set up a scenario for them that they will have to solve. They're going to be getting something that is a very unique and an interesting challenge that will highlight the role that engineers have in applying math and science to solve a real world problem. It is not just doing math for math's sake or doing science for science's sake. It is actually the application of those two for solving problems," 2013 Engineers Week chair for Raytheon SAS and acting director of the Electronics Engineering Center Noel Ellis said.

This year, El Segundo High School students Andrew Brackenbury, Bryan Johnson and Austin Thompson won third place at the Engineer Games.

The students were challenged to build a Stirling engine to turn a piston and a crank shaft without electricity, using the materials supplied (steel wool, a soda can, a paint can, a balloon and some wires) and a little guidance from Raytheon engineers.

"My students and I had a lot of fun. I had a great time being able to tie in some of the science concepts that we are learning in class to a cool engineering project. They basically did it completely on their own with some help from a Raytheon engineer and it turned out really well," El Segundo High engineering and physics teacher Steve Eno said.

Engineers' Week, which was celebrated February 18-22, has different activities every day and began the week with MathMovesU Day. Tuesday was the Tech Honors Recognition Lunch. Wednesday was the Engineer Games and Lab Tour, Thursday was Innovation Day and Friday wrapped up the week's events with Society of Women Engineers Shadow and Engineer Day.

"I wish I had been able to do something like this when I was in high school. At that time math was math, but you couldn't really see what kinds of problems you could solve with it," Ellis said. "This is all about getting the students to understand what engineering is and how we apply math and science to solving difficult problems or easy problems. It is the applications taken to solve a problem."

The students selected to participate in the Engineer Games had to submit an essay indicating why they were interested in attending and how would the experience enhance their understanding of engineering.

"I think this is good because it supports everything that we do in the classroom," Eno said.


"All of my classes are heavily project-based, so we do a lot of projects like the ones we did on Wednesday all of the time--but is just great to see them expand upon that concept experience with professional engineers. This makes them realize that what we are doing in class actually make sense. It also shows them what engineers can do in the real world and I think that is a great experience for my students to have. Hopefully this will motivate them to work harder."

Raytheon has a strong history of working with the local and surrounding high schools in different capacities in order to expose and engage students to math and science at levels that an average classroom setting cannot achieve.

"There are a number of schools that we have a relationship with and we reach out to those schools all the time," Ellis said. "We have developed a relationship with the schools through robotics and other activities throughout several years. As you walk around the room, you will notice that many of these high schools are repeat high schools. The students are different, but the high schools are the same."

Eno added, "They [Raytheon] did a great job bringing the kids in and allowing them to have fun while teaching them lessons that made them excited about engineering. Our three students were very excited that they were chosen and given the opportunity to experience." •

for parking fees for the time its cars are at metered spots.

SBCCOG Special Projects Manager Wally Siembab noted that the other eight cities have already indicated general support for the program, but some hadn't moved forward in the approval process for procedural or logistical reasons. For instance, a Torrance Council member who is a major proponent of Car2go has been on vacation-thus delaying that vote. However, the remaining city councils are scheduled to introduce the ordinance before the end of March. Though Rosenkranz said the program could still proceed if one of the nine cities bows out, universal adoption is the goal. Otherwise, it would mean the map would no longer be contiguous and make it more difficult for drivers to figure out exactly where they can pick up or drop off cars.

While the ordinance will allow Car2go vehicles to exceed parking timelines such as the two-hour limit in Downtown El Segundo, regulations for street sweeping, colored curb time, disabled spots and other parking prohibition restrictions would still be in place. To address concern about the vehicles taking up valuable spaces, Rosenkranz said it won't be cost-effective for the cars to sit unused and that they tend to turn over quickly in busy commercial zones. He told the Council that citizens will be able to contact a call center 24/7 to report any issues. Once a car goes on

a call list, it is usually moved within a few hours, Rosenkranz said.

Also on Tuesday during presentations, the Council proclaimed March 23 as Earth Hour Day in El Segundo, encouraging all City employees to turn off non-essential lighting in government buildings, public schools and public landmarks between 8:30 p.m. and 9:30 p.m. on that date. Organized by the World Wildlife Fund, Earth Hour is a symbolic international and local event to raise awareness about climate change issues and to encourage businesses, individuals and government to take action to reduce their carbon emissions.

The Council also recognized March 9 as California Arbor Day and invited citizens to participate with Tree Musketeers as part of the latter's 26th anniversary. The youthled organization has overseen annual Arbor Day celebrations since its inception, in the process helping El Segundo earn a Tree City USA designation every year since 2003. For this Saturday's event, Tree Musketeers and presenting partner Chevron will join with the City, business leaders, service club members and residents to care for Millennium Trees (and plant 10 replacement trees) along Grand Avenue just west of Loma Vista starting at 9:30 a.m., though people can arrive as early as 7. Tree Musketeers expects 300 volunteers to take part in the event. Chevron will provide lunch and match donations. •



First Rule of Grilling is to get the grill hot. Those grill rods need to be both clean

My favorite is Asian. This is a blend of the flavors of the far east without the over powering heavy sauce.

DOTS N' PA

1 cup oyster sauce

1/4 cup chopped pickled ginger (the kind you eat at a sushi bar)

1/2 cup brown sugar

2 tablespoons chopped garlic


1 to 4 tablespoons hot chili sauce depending on how spicy you want it (like sambal oelek or siracha sauce/ both can be found at your local super market)

Mix together all ingredients.

If using as a marinade, add a cup of chicken broth to thin it out

Get your grill hot then start by brushing your meat, fish or vegetables with a little vegetables oil. Place it on the grill and proceed to mark off or get some color on the product. Then as it cooks, baste the stuff with the sauce until you have cooked to the degree you wish. The sauce has sugar in it so you have to be careful that it doesn't burn so flip it repeatedly. Have fun and don't forget BBQ is for finger licking!
