## City Council Finalizes Chevron Payment Agreement

Four months after first announcing a deal with Chevron, the El Segundo City Council officially approved a slightly revised tax resolution agreement (TRA) with the refinery during a special meeting Tuesday night. The finalized document also now amends the terms of Chevron's annual gas tax payments. In all, the agreement will net an estimated \$128 million in new revenue over the next 15 years (an average of \$8.5 million annually), providing, according to a staff report summary, "significant, long-term stability to the City's General and Water Funds." The TRA runs retroactively from January 2013 through January 2027, with opt-out clauses for Chevron in the event of unusual circumstances such as the refinery ceasing operations or if the Council places a measure on the ballot to materially increase taxes.

The net new revenue amount comes out to be slightly lower than the \$134 million estimate from December 2012. "We actually saw a larger total tax payment from Chevron last year than we had previously anticipated—which was the good news to the City from a revenue perspective," explained City Manager Greg Carpenter prior to Tuesday's meeting. "All of our previous projections for the 15-year value of the deal were based on the lower base starting point. Once we reset the starting point higher, we reset the projections for the 15-year period resulting in a lower 'net new' total."

For the first year, Chevron will pay the City \$11.1 million in combined 2012 taxes plus "additional funds"—as yet undetermined but estimated to be more than \$5 million—to reflect higher than anticipated 2011/12 revenues. To reconcile the annual amount due, the City will provide Chevron with total tax receipts received the prior fiscal year to match those numbers against the refinery's payment records. By the end of March each year, Chevron will remit the balance of any additional funds due.

That payment will also be subject to Consumer Price Index (CPI) increases.

Chevron will continue to pay its gas utility user tax payments according to the terms of a 1994 agreement with the City with an amendment that will now reflect definitions of taxable gas (versus exempt gas) incorporated in the municipal code. Additionally, the gas tax will be calculated on actual consumption rather than the current base amount that gets adjusted annually by the CPI.

The deal also extends the recycled water

surcharge imposed on Chevron that would have otherwise expired in two years. The payment, which came out to about \$1.8 million in 2012, benefits the City's Water Fund while ensuring that local water customers (residential and commercial) won't have to absorb future fee increases to offset the potential loss of those revenues. Of the \$128 million in net new revenue, \$24 million will go to the Water Fund. Taking all taxes, additional funds and the extended water surcharge into account,

## School Board Enters the Second Semester Home Stretch

The only School Board meeting to take place in April featured a special presentation by two local students about the numerous benefits to the El Segundo Unified School District garnered from the possibly financially imperiled SoCalROC program, discussion items regarding getting the District involved in the California School Finance Reform Coalition (CSFR), and the approval of correspondence to the City detailing the fact that possible future funding options to the District may be limited because of what is termed a "clear local funding disparity for El Segundo when compared to the neighboring districts."

Chloe Sanchez and Kyra Wopschall, both El Segundo High School students, talked to the Board about their SoCalROC experience and were effusive in their praise of their courses and their instructors in the program as they prepared for collegiate matriculation and their pursuit of desired workforce options.

Susan Aceves, Chief Business Official, discussed the possibilities and advantages of

the District joining the CSFR. According to District-provided notes, the CSFR program, led by the Torrance Unified and Clovis Unified districts, hopes to present a united voice to the financial powers that be in Sacramento that will advocate improvements to the local control formula that disseminates State funding to school districts.

The consent agenda portion of the meeting included the ratification of the GATE family night activities, which took place on April 18, and involved students at both of the K-6 schools. The first similar night activities were held in November 2012 and proved very popular with students and parents, helping make the presentation of math, science, geometry and architecture intriguing and fresh to the young learners.

Also approved was a sojourn to Las Vegas by the varsity High School basketball team, which will take place in late December. The players will be taking part in the 15<sup>th</sup> annual Las Vegas Holiday Classic, which will culminate on December 30. All expenses

Chevron will pay an estimated \$224.5 million over the 15-year period, pending fluctuations in the CPI.

Questions about Chevron's tax liability surfaced at the end of 2011 when a City staff report concluded that the company pays far less in acreage (business license) tax than other refineries elsewhere. The Council considered placing a business license tax measure for refineries on the April ballot, but backed off after strong public outcry against

the move and a Chevron request to put off the action and negotiate instead. A subcommittee consisting of Mayor Pro Team Suzanne Fuentes and Councilmember Bill Fisher along with Carpenter, Finance Director Deborah Cullen and City Attorney Mark Hensley began confidential talks with Chevron officials last April with hopes to resolve the matter by June. But the complicated nature of the discussions pushed the process to the end of 2012. The parties

## One Man's Opinion

"Curse you, John Roberts" has to be on Barack Obama's mind. If Chief Justice Roberts had voted predictably with his conservative colleagues, Obamacare would have been ruled unconstitutional and Obama could have moved on to other issues. Instead, by voting to uphold Obamacare, Roberts has cursed the President with the burden of implementing his signature law.

The fact is Nancy Pelosi was wrong. We passed the law, but no one knows what's in it. Containing 2,700 pages and now incorporating 13,000 pages of regulations, its architect, Jay Rockefeller (D-WV) says the law now "is just beyond comprehension." Echoing his concern, Health and Human Services Secretary Kathleen Sebelius told *Politico.com* "no one fully anticipated all the complexities of the federal government's deep penetration into an industry that represents one-fifth of the U.S. economy." Sebelius further explained that rather than costing \$2 billion to create healthcare exchanges, the cost will more than double to \$4.4 billion.

As reported in *Breitbart.com*, the nonpartisan Society of Actuaries says that when fully implemented, medical claims costs will increase by an average of 32 percent. Coincidentally in California, healthcare premiums are projected to increase by 32 percent. And the beat goes on...

Today, as businesses are taking steps to protect themselves against unpredictable increases in health insurance costs, the government is ill-prepared to shoulder the burden it has taken on itself. In Senate Finance Committee hearings on April 10, Americans without health insurance are

finding that they must apply with Health Care Exchanges which then provides data to the IRS. The IRS then determines the applicant's premium and the amount of the federal government's tax credit. One problem is that the net cost to the applicant is 30 percent higher than his prior employer plan. The skimpy nine percent government subsidy is insufficient to make health insurance affordable to most.

Most embarrassingly, the system doesn't work mechanically because the IRS computers are obsolete and will not mate with the Health Care Exchange computers! Senator Max Baucus, another architect of Obamacare exclaimed, "How could this happen? I'm hearing from my constituents that they and their families have been left out in the cold and are without healthcare because the Exchanges are not accepting them"

Senator Bill Nelson (D-FL) said, "My constituents are not going to be happy to hear this administration failed to implement the necessary changes to accommodate healthcare applicants." Senator Ron Wyden (D-OR) exclaimed, "Someone has to pay for this!"

*The Wall Street Journal* reported that in addition to the 30 million Americans not covered under Obamacare, tens of millions more will be left in the "no healthcare Twilight Zone."

"Curse you, John Roberts." If you had voted this law unconstitutional, we would not be here trying to figure out what the law contains, how to fix its flaws and what the cost and quality impacts on American healthcare will be. As usual, the middle class and the working poor will bear the burdens of ill-conceived government intervention. •

finally came to an agreement on December 18, but it took four more months to hash out the remaining details, make some tweaks and finalize the document.

The City plans to utilize the additional funds to balance its budget in the short term and ideally to subsidize capital projects and/or expanded services over the long haul. "This will address what would have been a forecasted deficit over the next two years," said Carpenter.

During public communications, Chevron El Segundo Refinery General Manager Frank Semancik called the agreement "reasonable and balanced" and expressed his support for it. "This commitment is based on mutual recognition that working together to find a productive solution is in the best interest of everyone involved and reflects a 100-plus-year history

of trust and collaboration that contributes to the unique character and quality of life here in El Segundo," he said.

Describing the lengthy talks as "contentious," Fisher said the goal was to make sure the City was protected. "What we came up with, although some would say it's not enough, I think it was a fair negotiation," said Fisher. Both he and Fuentes also thanked staff and all the parties involved in the process. "I do believe it's going to make El Segundo a stronger city," said Fuentes.

Mayor Carl Jacobson noted that the two sides came to the table with good intentions. "This should serve the City for at least another decade and a half and there is language in there to extend with both approvals," he said. "I think we have a very good way to go forward..." •

Then the Board approved the always popular Pioneer Days Assembly that has perennially visited the Richmond Street School campus. The assembly will take place on April 29 and will recreate hands-on experiences that will simulate "the excitement and hardships suffered by early California settlers during the California Gold Rush."

The Board also approved an Animal Magic Show, which took place last week at Richmond Street, and a Cheer Summer Camp, slated to take place in late July in Pomona. The four-day, three-night camp will focus on team-building and cheer techniques.

The action item portion of the 100-minute meeting included the acceptance of gifts, highlighted by \$250,000 from Chevron and more than \$10,000 bestowed upon the kids at Center Street School by PTA members.

Superintendent Geoff Yantz framed the approval of the Correspondence to the City, which is an initial step in addressing the fact that the State of California lags far behind the rest of the nation in funding public school districts, and that El Segundo Unified would like to request that the City Council, as part of its strategic planning process, consider a dedicated local shared revenue source that will support educational programs and services in the District. Yantz noted that if the funding disparity continues, the District will face numerous challenges in providing a continuing exceptional level of education to the students, as well as attract top-level educators and support

personnel to the District.

Also approved was the summer reading list for the High School. One title, the *Gatekeepers*, was deleted from the reading list, and the studying reins were loosened a little on the vacationing students during the summer school hiatus. In the past, College Prep English students were required to read and complete a written assignment over the summer break. Apparently, some of the students never got around to fulfilling this requirement, as they were out enjoying their summer break. The requirement has been dropped. Now this option, if fulfilled, will be granted extra credit. According to District-provided notes, this "will start off the school year on a more positive note, rather than having the majority of students start the year at a deficit from not having completed the required reading."

Also approved was a resolution noting the fact that there will be a biennial School Board election on Tuesday, November 5. The seats held by current members President Ann Coles, Vice President Robin Funk and member Bill Watkins will be up for grabs this fall.

Later in the meeting, the Board passed a couple of resolutions to honor both credentialed and certificated District employees. Certificated Employee Appreciation Week will take place beginning on May 6. Classified employees will be honored the week of May 19.

With less than eight weeks remaining in the 2012-13 school year, the next regularly scheduled School Board meeting is slated to take place on Tuesday, May 14. •

# High School, Rec & Parks Expand Hometown Fair

After being held for decades within the confines of Library Park, El Segundo's Hometown Fair is about to get a little bigger in scope and in name. For the first time, the popular annual event that takes place on the first Saturday in May will expand to include the front lawn of El Segundo High School and Main Street in between. According to Recreation and Parks Superintendent Meredith Petit, the move symbolizes the joint effort and long-time connection between the school and her department. "The fair is a fundraising event in which various El Segundo High School groups coordinate booths for food sales or carnival games to raise money for their club, class or sports team," she said. "This year, Recreation and Parks is also adding a new carnival component to the event in which wristbands will be sold for \$6 for unlimited rides on a kiddie Ferris wheel, a swing ride, an inflatable rock wall, jousting game and other fun attractions." About 30 arts and crafts vendors will also be on-hand, with additional interactive and informational booths from various community organizations and businesses, plus a car or two on display from the El Segundo Automobile Museum. Other events and attractions include bike decorating and a bike parade at 11 a.m., the annual Bake Off competition, live entertainment from local bands, stage demonstrations from local dance and exercise groups, The Friends of the Library book sale, and police and fire vehicles on display. As part of the reconfigured boundaries, Main Street will be closed between Mariposa and Palm. Game and food booths that used to set up in front of Richmond Street Elementary School will now be on the sidewalk and walkway to El Segundo High, with some also positioned on the grass. And finally, the

event has undergone a name change, with the new moniker the Hometown Fair & Carnival.

The Hometown Fair's roots go back more than 35 years when El Segundo High Government class member Theresa Mack (Class of 1978) spearheaded the campaign to hold a small local event to raise money for the senior prom school-wide. "After two years, the class asked Recreation and Parks to join them in putting it on—they needed some help with set-up and organization," remembers Pete Whalon, who joined the City over 40 years ago, was the long-time Sports Supervisor before retiring, and now currently helps out part-time at the Campus El Segundo athletic fields. Whalon noted that a family connection spurred the collaboration between the High School and City. "The President of the Government class was the daughter of the Recreation and Parks Director, Jack Ruis, so we got involved."

The relationship between the two entities grew from there. "After that, the Recreation Department and members of the Government class would meet to decide on activities and programs to be conducted," said Whalon. "We worked with school maintenance staff to set up and break down the event. We collected all the money for the booth spaces and then sent the High School a check for the fees."

The Hometown Fair set up shop at Library Park from the very beginning and the program remained fairly consistent over the years. "Back then, the High School Band would perform and we'd have adult tap dancers," said Whalon. "The drama production from the Recreation Department would do a scene from their upcoming play. At first, it was all local school and Recreation productions and the school groups did all the food. The only change was

### Pordes and Mostert Dominate Torrance

The road to a Pioneer League baseball championship has historically gone through either El Segundo or Torrance—at least that has been the history for the past 10 years or so and this year it may be the same too. The two teams met for their home-and-home series and the Eagles stamped their claim to a third consecutive league crown by sweeping the Tartars for the first time in three years by scores of 3-0 and 6-1.

Both teams have struggled at times during the season, but when league play is on the line their rivalry and brilliant play are evident. These two teams know each other and the players have become friends off the field if not opponents between the lines. A number of players from both teams competed against one another in last summer's Babe Ruth League's Pacific Southwest Regional. El Segundo defeated Torrance to advance to the Babe Ruth World Series where it placed third.

In the first game played at El Segundo's Stevenson Field, the Eagles parlayed a dazzling pitching performance by senior right-hander Ryan Pordes into a 3-0 emotional win. Pordes used an effective fastball and a baffling off-speed pitch to quell a Torrance squad that's loaded with its usual run-producing lineup. "I felt I was hitting my spots and Chris [Gutierrez] did a great job calling the game," Pordes said.

The Eagles have at times during the year struggled to score runs, but have kept themselves in games with their keen defensive efforts. With the Eagles and Tartars locked into a pitchers' duel, both teams' defenses played at the top of their games.

Third baseman Nick Martinez made two great plays to take potential base hits away. Centerfielder Eric Gronhagen ran down a potential double in the gap. Seth McKenna made a diving catch in right field and backed up on a play that could have gone badly for the Eagles. And then there was catcher Chris Gutierrez, who threw out another potential base runner attempting to steal second.

The Eagles played an error-free, clean ballgame and none of it went unnoticed to their pitcher. "This was a total team effort and the defense picked me up and we got it done against a pretty good pitcher with our bats," Pordes added.

The Eagles scored twice in the third inning when Martinez doubled, went to third on a wild pitch and scored on a sharp ground ball by McKenna. Lars Nootbaar followed with a double and scored on Gronhagen's double in the right-center gap. In the sixth inning, Kevin Schreiber singled, stole second base and scored on Mike Pagan's RBI single to make it 3-0.

Those were all the runs that Pordes would need in getting his first shutout of the season and third complete game. Pordes scattered three hits, struck out five and improved to 4-3 on the year while lowering his ERA to 2.82. Gronhagen and Schreiber led the Eagles with two hits each while Nootbaar, Martinez and Pagan had one hit apiece.

In the second game, played at dimly lit Zamperini Field, the Eagles backed sophomore pitcher Willem Mostert with another impressive defensive performance. They also came up with timely hits and executed situational hitting in a 6-1 victory.

Not to be outdone by Pordes' pitching performance Mostert was masterful in stymieing Tartar hitters. The tall right-hander went four and two-thirds innings before giving up a single David Aros in the fifth.

Mostert benefited from some defensive gems like Pagan's catch in left field as well as the infield play of Martinez at third base and Schreiber at second base. Mostert himself caught a line drive on a hit and run to double the base runner off first base to end the threat in the fifth inning.

Offensively, the Eagles combined speed and a well-timed double to score the game's first run in the third inning. Schreiber stole second base and scored on Gronhagen's double to give the Eagles a 1-0 lead.

The score stayed that way until the sixth inning. Gronhagen reached base on an error, stole second and scored on Connor Underwood's double to the gap. Underwood then scored on Pagan's single off the left field fence. Later in the inning, Pagan scored on a passed ball to make it 4-0. Ryan Porter, running for Chris Gutierrez who had singled, easily scored on a sacrifice fly by Hunter Lewis to make it 5-0.

In the seventh inning, the Eagles once again got the timely hit to score another run. Schreiber was on base on a fielder's choice. He stole second base and Underwood once again hammered a double to the gap, scoring Schreiber and giving the Eagles a 6-1 lead. Mostert, who improved to 3-0 on the year, was replaced in the sixth inning by Tanner Stevens, who stopped the potential Tartars' rally.

The Eagles played in the consolation round of the Redondo Tournament and fell to Cathedral 8-4. Nootbaar and Pordes led the Eagles' offense with two hits apiece. Dean Abramson started for the Eagles, but Jake Gafford suffered the loss as the Phantoms scored four runs in the fifth and four more in the sixth inning to defeat El Segundo.

This week, the Eagles played at Lawndale

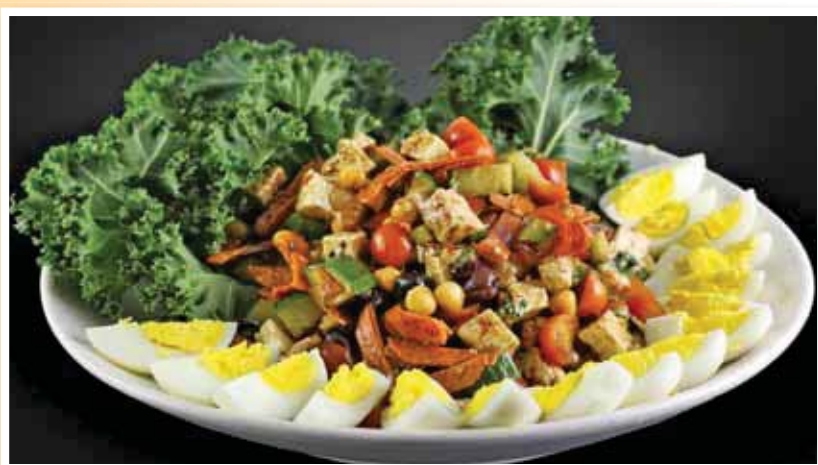
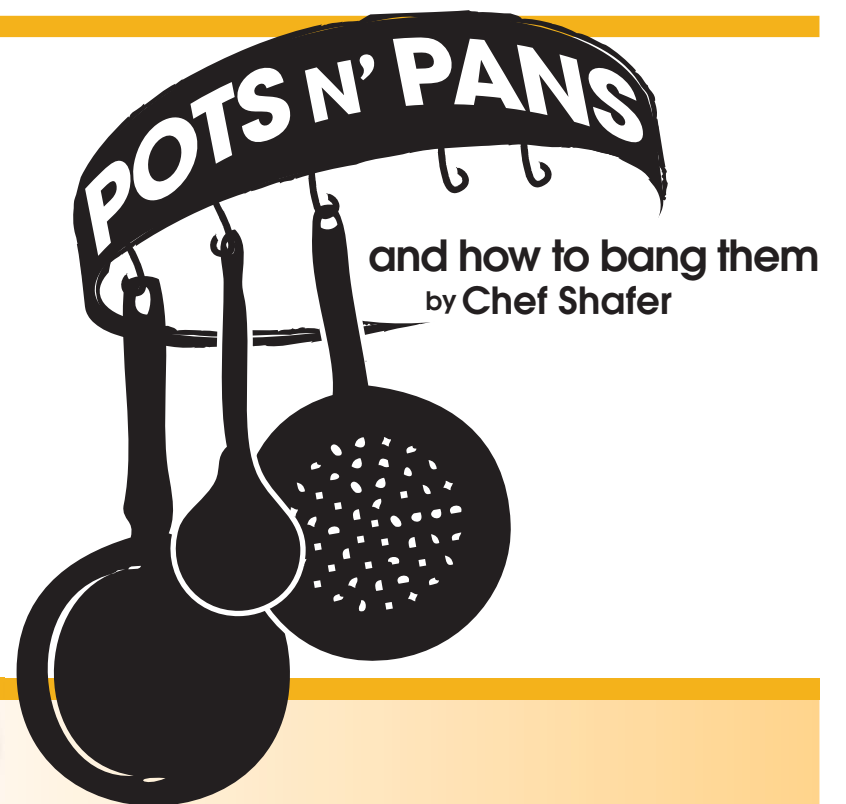

- 1 cup diced tomatoes, or cherry tomatoes, cut in half
- 1 cup diced cucumber
- 1/4 cup diced red onion, very fine
- 1 can garbanzo beans
- 1 cup diced Parmesan cheese, or you can use mozzarella or feta if you like
- 1 pound chopped hard salami, or other sausages or prosciutto cut into julienne strips
- 1/2 cup chopped kalamata olives
- 1/8 cup olive oil
- 1/8 cup balsamic vinegar
- 6 to 8 basil leaves, ripped

Garnish  
3 hardboiled eggs peeled and cut into wedges

Mix all the ingredients together in a bowl then chill. Place on a platter with the hardboiled egg wedges as a garnish. •

the Teen Center starting selling pizza there. And we've always had the craft booths." The fundraising element soon extended beyond the senior prom and the Government class would decide where to allocate the monies. According to El Segundo High Activities Director Robin Espinoza, 17 clubs or classes now participate in the Hometown Fair on an annual basis. "I get the applications from [Recreation Coordinator] Shawn Green at the City and distribute them to interested students at a lunch meeting and through the Activities Office," said Espinoza. "There is a \$25 fee that the City allows the ASB [Associated Student Body] to keep. We put the money into the day of the event and all coloring pages will be displayed at the Hometown Fair."

Lastly, Electric Bikes L.A. is sponsoring an electric bike giveaway to help Recreation and Parks raise funds to support the continuing enhancements and improvements to all of the City's special events including the Hometown Fair & Carnival, Easter Egg Hunt, Fourth of July Celebration, Concerts in the Park, Halloween Frolic, and Holiday Tree Lighting. The 36-volt orange beach cruiser, unveiled at the Easter Egg Hunt event at Recreation Park, was on display at The Lakes Golf Course and recently moved to Thursday Farmers' Market for a weekly showcase up to the Fair date. Entries into

ASB general fund so that it will be spent on the student body at large." Depending on attendance (which organizers hope will exceed 1,000 this year), a class or club can make anywhere from \$100 to \$1,000 at the event, with the food booths a particularly strong cash-generator. "Each club designates how they will spend what they raise," added Espinoza. "It's a great lesson in planning for an event—buying supplies, advertising, getting people to work at the event, etc." Petit singled out partnerships with four local businesses as sponsors this year. The Reach Out Against Drugs (ROAD) Committee is the major event sponsor for the second year in a row. Study Hut Tutoring has also come on board with a booth where parents and kids can meet the tutoring staff and learn more about programs offered. "Additionally, Boiling Point Creative has graciously supplied graphic design to the flyers, posters and Main Street banner," said Petit. "Joe Natoli at Boiling Point has also designed a coloring contest page for elementary school kids to draw their perfect carnival. Winners from each grade will be selected to win two free wristbands to the carnival on the drawing are \$5 each and available at the Clubhouse and Checkout Building at Recreation Park and at the Farmers' Market. Tickets will also be on sale at the Hometown Fair before the drawing takes place at 2 p.m. The winner must be present.

"The pairing of the High School and the Recreation and Parks Department coupled with the massive involvement from the community is truly what 'hometown' means to us here in El Segundo," said Petit. "This event is bound to be the beginning of a new long-standing tradition based on the partnerships of the people and groups in this town coming together to socialize, entertain, and support each other." Espinoza echoed those sentiments, "El Segundo High School has a beautiful relationship with the El Segundo Recreation and Parks Department," she said. "Not only does the City hire many of our students, but they seem to always have our goals and interests in mind when planning large events such as the Hometown Fair."

The Hometown Fair & Carnival takes place on Saturday, May 4 from 10 a.m. to 3 p.m. For more information, call 310-524-2700. •

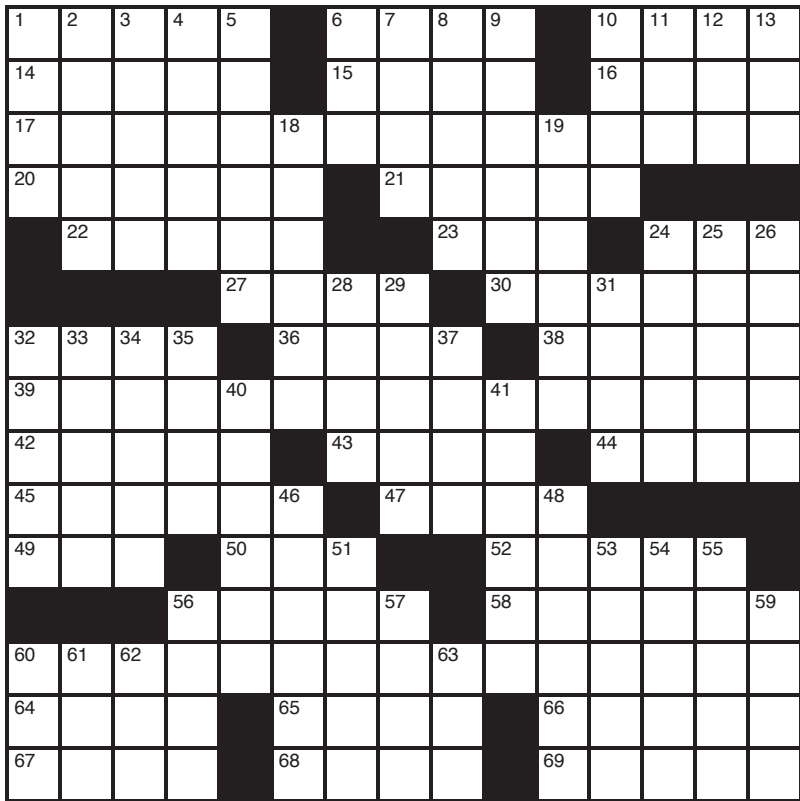

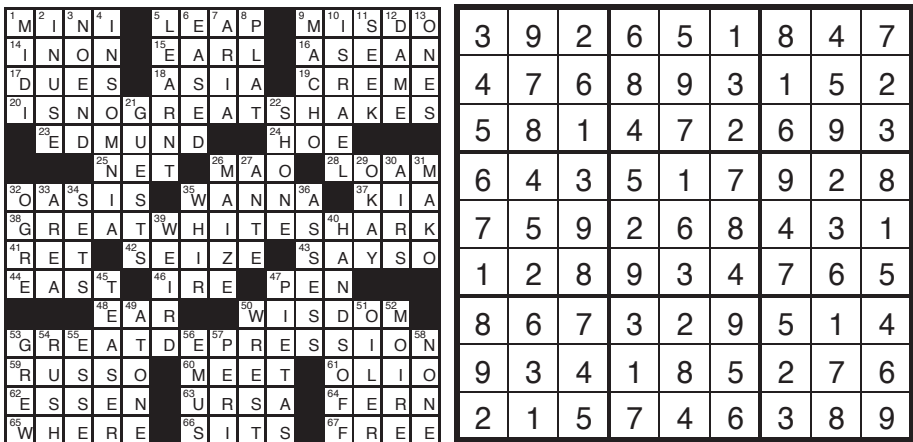

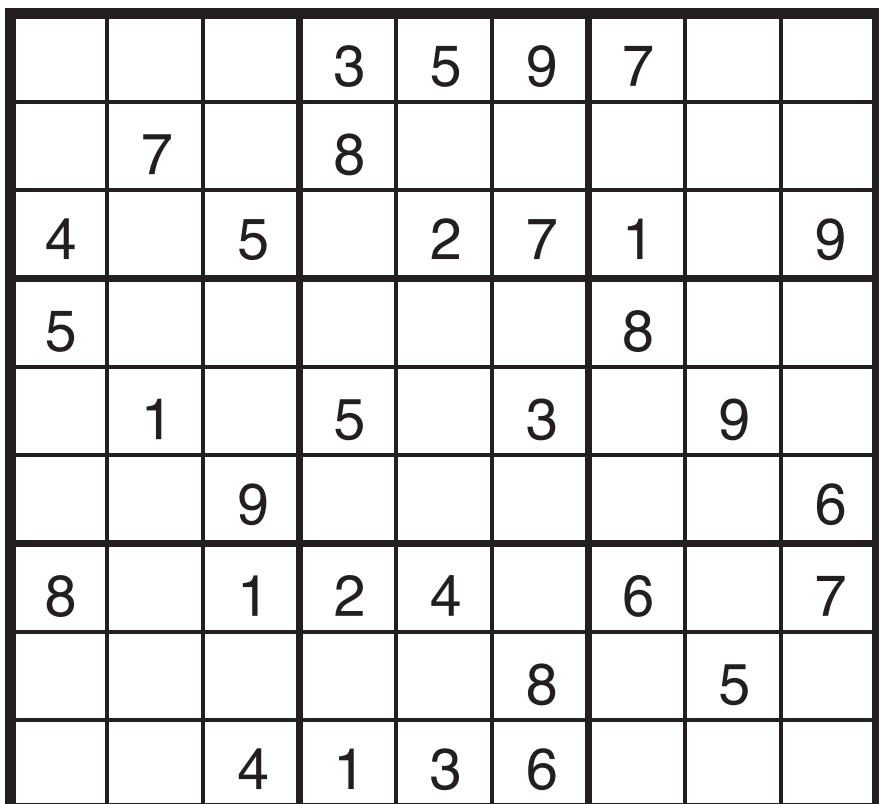
