## New Pool Agreement in Place, Plunge Awaits Repairs

Last month, the El Segundo City Council unanimously approved a settlement agreement with Wiseburn School District to bring a new aquatics center to town by as soon as late 2015. Under the renewable 25-year arrangement, Wiseburn will cover design, planning, development and construction costs of up to \$6 million for a complex that will include a 50-meter competition pool with a moveable bulkhead for short course swimming, restrooms and lockers, changing areas for men and women, plus a dedicated parking lot and entry separate from the rest of the site. If budget allows, Wiseburn may also add a smaller (20-foot by 40-foot) therapy pool, a spring board diving board, and a snack or small kitchen area. The two-acre facility will be located at the future Wiseburn High School site at 201 N. Douglas Street. Wiseburn's geographical boundaries include all of El Segundo east of Sepulveda. Though local residents belong to the El Segundo Unified School District, eastside employee children can and do attend Wiseburn schools.

The deal will also include a joint-use agreement to be finalized over the coming months, with timelines to accommodate Wiseburn, El Segundo Unified School District and the general public. "The school use of the pool will only be six hours a day--the rest of the 18-hour day [i.e. 6 a.m. to midnight] will be for public programming use," said El Segundo Mayor Bill Fisher, who was part of a Council subcommittee with colleague Dave Atkinson engaging in talks with Wiseburn officials. "In essence, this is a rather substantial gift to the City of El Segundo." Fisher added that the first meeting to discuss design took place last week and the stakeholders plan to visit other

pools in the region for ideas.

The settlement avoided what could have been a lengthy and contentious court battle between Wiseburn and the City over the chosen high school site. "I spoke publicly in opposition to Wiseburn moving into the commercial building on Douglas vacated by Northrup Grumman because of the loss of revenue to

the City which came in at around \$250,000 and probably more," said Fisher. "The entire Council was opposed to this as well. We tried for over a year to have them move to multiple locations that would be less detrimental to our revenue stream. When it came down to we could file a lawsuit in hopes of delaying them

## City Council Recap: More Golf Companies Interested in The Lakes

When it comes time to decide on the future fate of The Lakes at El Segundo, there will be many more options to consider besides the existing TopGolf proposal. So it came to light during Tuesday night's El Segundo City Council meeting after a presentation by two members of the short-term Golf Course Advisory Group confirmed there is potential interest from seven major management groups to operate the facility.

Formed at the suggestion of Councilmember Marie Fellhauer a month ago and chaired by her colleague Dave Atkinson, the Advisory Group embarked on a fact-finding mission to determine if The Lakes is sufficiently financially viable to entice credible groups to commit to a long-term (20-year) lease or management agreement, a minimum rental guarantee (\$300,000), and capital improvements (up to \$500,000). The seven outfits that responded favorably included JC Resorts, O & J Golf Management, Billy Casper Golf, American

Golf, Lane Donovan Golf Partners, Tom Frost Golf, and Touchstone Golf. Billy Casper Golf and American Golf are the top two largest golf course operators in the country, while the other five are also major players in the market.

Advisory Group member Craig Kessler (Director of Governmental Affairs for the Southern California Golf Association who made the presentation along with Los Angeles County's Golf Director Jorge Badel) said it was encouraging that The Lakes could garner interest from some of the biggest golf management companies in the United States. This despite the fact that as a rule, facilities with a nine-hole course, driving range, small restaurant and pro shop usually don't have much value in the marketplace. "This one's an exception," said Kessler. "You should take great pride that there's so much support for this golf course."

Though indicating they may need more flexibility to adjust rates on the fly (without Council control) and that it may

## High School, Middle School Students Receive Head Start via Project Lead the Way

Through the national program Project Lead the Way, El Segundo Middle School and High School students are receiving innovative education in Science, Technology, Engineering and Mathematics (STEM) curricular programs that are being used in middle and high schools across the nation. "The high school has their Project Lead the Way program and they actually have a full engineering sequence of courses that they can take similar to college courses if you were to major in engineering," El Segundo Middle School Principal Dr. Jack Plotkin said. "Starting two years ago, we began to offer those courses to our seventh and eighth graders as zero period class--and it's an engineering focused, problem-based learning program. Students will look at some

type of problem, like a train having to go through a mountainside, and they will have to engineer a tunnel using software to show their understanding."

Currently, El Segundo Middle School has 30 students registered for zero period at 6:40 a.m. at which time they go to El Segundo High to meet with math and science teacher Steve Eno. Eno, who was at Raytheon's Engineering Games earlier this year with a few of his students, is excited about the program and the positive impact it can have on the students. "It is great in terms of getting kids prepared for the high school program. With the kids that start in the middle school that come to the high school freshman class, you notice the difference in their ability to handle the class," Eno said. "I thought it would be

## El Segundo Women's Club Invaluable Asset to ESUSD Students' Academic Futures

QUIETLY LABORING BEHIND THE SCENES, THESE EL SEGUNDO LADIES HELP FUND FUTURES

A landmark building facing El Segundo High School on the Mariposa Side of campus, the El Segundo Women's Club actually predates the

high school itself. Organized on May 23, 1922, a group of 18 civic minded women banded together to become a formal entity with the central goal of enriching the community of which they were members. By 1931, the El Segundo Women's Club was federated with the District, State and General Woman's Club, continuing its good works and growing its membership.

With a goal of maintaining a viable and vital presence in the community, the ESWC members worked to feed and clothe needy families as well as begin their long tradition of providing scholarships to deserving students. By 1936, the members borrowed the kingly sum of \$2,000 to pay for moving the original one-room El Segundo schoolhouse to its present location

plays and staged raffles, ultimately succeeding in 1943 when they paid off the mortgage, owning their headquarters free and clear.

Which left them with plenty of time to do what they do so well – enrich the community. And for nine decades, they have done just that.

On June 5th at noon, 10 outstanding ESUSD students joined the El Segundo Woman's Club members for a luncheon, along with their parents, school administrators and staff, to celebrate over \$7,500 of scholarships awarded to graduating seniors.

Mrs. Kathie Stabile, Chairperson of the El Segundo Woman's Club Scholarship committee, announced 223 applications vied for the awards,

plunging the committee knee deep in reading before deciding on 10 students to honor. A most difficult assignment for committee members Maxine Walsleben, Diane Margrave, Carol Cervantes and Barbara Frazee. With families gathered in the hardwood floor dining room of the Women's Club, feasting on home cooked entrees contributed by the Woman's Club members, the scholarship recipients were invited to come up to the microphone and share a little bit about themselves and their academic careers.

Three students from El Segundo High School each won \$1,000 scholarships. Ethan Liang, one of 10 children, mentioned the scholarship held special importance to him because "My mom, who is sitting with me today, won this same scholarship 34 years ago!" Samantha Vinzon's scholarship was highly treasured, and she thanked the Woman's Club members saying "as a permit student coming here in the 6<sup>th</sup> grade, this especially means a lot to me." Abigail Landers, a senior off to UC Berkeley to study Science was especially proud of her environmental work with the students at Center Street School where she started the "Grades of Green" project which she also continued at ESHS.

Kevin Qualls, who at the previous ESUSD School Board Meeting had been honored as a recipient of the Gates Millennial Scholarship, was especially grateful to the club for the \$1,000 Barbara Kessener Scholarship. After thanking the Women's Club, he singled out

custodian William Ochoa at the high school, who was never too busy to pause in his duties to encourage and support Kevin in his dreams of attending USC to study Mechanical Engineering.

Ridley Middough, with dreams of a fulfilling career as a firefighter, was awarded the \$500 Alec Shedloy Scholarship. He thanked the Women's Club saying he felt his three years as a Los Angeles County Explorer had really paid off. Linnea Palmer, winning the Virginia Shedloy \$500 scholarship, was thankful for help in pursuing her dream of attaining a PhD in Physical Therapy.

The \$500 Lavon Frazee Memorial Scholarship went to Brent Wood, on his way to El Camino College to study Criminal Justice before ultimately heading off the Coast Guard. or negotiate a settlement that would benefit El Segundo, Councilmember Atkinson and myself sat with Wiseburn representatives and forged out a deal where they build a \$6 million pool and the City would operate it."

The exact cost to operate the facility won't be fully known until the design is completed, Fisher explained, but initial estimates are in the \$600,000 to \$700,000 annual range. Meanwhile, the City hopes to recoup at least half of that amount, if not more, through rental revenues.

The two districts will likely evenly split the six total hours of pool time devoted to school use, but it's unlikely both will utilize the facility simultaneously. Also of note, Wiseburn does not have a high school aquatics program in place as yet. "The El Segundo community has a long and proud tradition with their aquatics program and there is also a high degree of interest for aquatics in Wiseburn," said Wiseburn Superintendent Dr. Tom Johnstone. "Rather than spending negative time, energy and taxpayers' money trying to fight each other, the El Segundo City Council and the Wiseburn Board of Trustees have chosen a pathway to work together and develop a world-class aquatics facility that both communities will be able to enjoy for decades." Johnstone added that many of the families in his district who swim in community pools currently go to El Segundo.

El Segundo Unified School District

Superintendent Dr. Geoff Yantz was also pleased about the deal. "To be able to have a modern aquatics facility for our water polo and swim programs and one built for that specific purpose provides an environment for our student athletes to excel even further than they already have and to reach their potential," he said, adding that the location of the pool on Wiseburn property would not be an issue. "Our school districts are collaborative and we perceive this as a separate shared facility with its own entrance. It's the City of El Segundo's pool."

Using voter-approved bond monies, Wiseburn acquired the 13.7-acre Douglas property last fall in order to build a new high school as part of the District's long-anticipated unification set to go to vote next year. Plans include demolition of a portion of the existing 335,000-square foot, four-story building vacated by Northrop Grumman. The facility will include 54 classrooms to accommodate a maximum (capped at that total in the settlement) of 1,200 students relocating from Wiseburn's two Da Vinci charter campuses. The site will also feature a media center library, student/multipurpose cafeteria, gymnasium, 400-seat theater, student services/administration, 12,000 square feet of District office space, six basketball courts, six tennis courts and synthetic athletic fields for soccer and baseball. According to the agreement, Wiseburn and the City will commit to joint use of their athletic fields (including the Campus El Segundo facility) and the District will make the project available as an emergency shelter for the American Red Cross.

Other provisions of the agreement call for the City to operate the aquatics center for a minimum of one year after completion and to maintain and repair the pool for five years after opening. The two parties will cover their own insurance and utility costs, but Wiseburn will allocate its share of revenues to the City to offset the latter's operation and maintenance costs. The City must also contribute \$26,000 annually for the duration of the 25-year agreement towards an equipment replacement reserve fund. Wiseburn will kick in \$14,000 annually after the fifth year towards this fund. Both parties will allocate \$20,000 per year to reserves if the agreement renews for a second 25-year period.

Meanwhile as of press time, the more than 70-year-old Urho Saari Swim Stadium (The Plunge) had been closed for more than a month due to water loss from plumbing leaks resulting from severely corroded pipes. Repair plans must first be submitted to the Los Angeles County Health Department for approval. "Staff will pursue the repairs as quickly as possible and the County has indicated that they will cooperate in moving the approval along," said City Manager Greg Carpenter. Staff believes it has identified the piping problem and plans to fill up the pool as soon as next week to monitor water levels from there. Carpenter will provide an update to the Council in a month.

While The Plunge is out of commission,

### Eagles Fall Year in Review

With the 2012-13 school year completed and summer beginning, it's time for us to look back at a wonderful several months of sports at El Segundo High School. The memories of how these young athletes did will linger. We'll remember how we cheered them on during victory and held them in defeat. We displayed our support at each game and showed our spirit during Homecoming.

Teams, whether boys or girls, displayed their talents and competitiveness to vie for league titles and long playoff runs. Though a section title eluded the school this year, each team that entered the postseason was nevertheless a factor.

#### Girls' Volleyball

The Lady Eagles had a challenging season, but still managed to make the postseason thanks in part to the play of Maggie Kelly and Amanda Press. The Pioneer League was moved to the CIF Southern Section Division 2 because of its past success. That move meant playing tougher competition for the Eagles. In the Redondo Power Classic, they defeated highly touted Oxnard. The Yellow Jackets had gone undefeated in the Pacific View League, but El Segundo played an inspired match and won in three games 20-25, 25-13 and 15-12.

#### Football

The Eagles had a number of offensive starters returning as well as the cornerstone of their defense. The defending Pioneer League champs were still picked to finish behind North Torrance's high-octane offense in the Pioneer League.

A defense that includes the A-Train of

Austin Brasher and Austin Kurke would prove once again that the Eagles would stay in close games. Throw in others including three-year starter Seth McKenna and two-year starters Jamie Stewart and Bryce Harvey and it was easy to understand why this defense would be as good as promoted.

The Eagles' offense has been a machine with its passing. For each of the past nine years, El Segundo had produced over 2,000 yards in the air. With junior quarterback Daniel Zeman back under center, the streak was likely to continue.

In the first game of the year against Lynwood, Zeman completed 22 of 32 passes for 350 yards and four touchdown passes--including three to Jamie Stewart. The Eagles dominated on both offense and defense in the 41-17 win over the Knights.

The Eagles were salivating at the opportunity to face Cantwell in the second game of the year. The Cardinal had defeated the Eagles 35-28 in the closing minutes of the CIF Northwest playoffs the year before.

This time, the defense came up with a turnover in the final minute as the Eagles defeated Cantwell 25-19. For the most part the Eagles looked like the dominant team, but they had issues running the ball against a smaller yet very athletic Cantwell defense. On the other hand, Zeman looked solid in completing 10 of 18 passes for 110 yards and a touchdown.

The Eagles faced West Torrance, one of the South Bay's top teams, in the third game. The Warriors, who played for a CIF title, soundly defeated the Eagles 54-24.

In the fourth game of the year against Oak

Park, the Eagles came into the game ranked sixth while Oak Park (2-2) was eighth in the latest CIF Northwest Division poll. This would be a game that would test each others' offense. It turned out to be a defensive struggle and would come down to a last-minute potential tying touchdown by the Eagles. Zeman took a hit and was forced from the game. Lars Nootbaar came in and led the team to a touchdown

The Eagles traveled to La Puente for a first round CIF Southern Section Northwest Division match up against the Warriors. On a cool fall night, the Eagles took control early on and went on to a 31-7 win. Nootbaar tossed two touchdown passes and Austin Brasher ran for two more to lead the Eagles into the quarterfinals against Centennial.

The 2012 football season then came to an end

on a one-yard run with less than 30 seconds remaining in the game. The Eagles failed on their PAT attempt and fell 14-13.

In the Pioneer League opener, Eagle head coach Steve Shevlin had a quarterback dilemma. Two-year starter Zeman was injured. So he turned to Nootbaar and all the sophomore did was throw for 301 yards and four touchdowns in leading his team to a 28-6 Homecoming game victory.

The Eagles needed some comeback heroics to defeat Pioneer League rival Torrance 24-22 in a key league game. In the final minute of play with the Eagles leading, Stewart stepped in front of an intended receiver to make the interception and preserve the win for the Eagles.

In the next game, the Eagles could not stay with North Torrance and the Saxons came away with a relatively easy 35-7 victory. El Segundo needed a win against Centennial to stay in the hunt for a possible share of the league title. The Eagles lost the game 27-14, but the Apaches ended up forfeiting the win back when it was determined they had used an illegal player in the game.

In the regular season finale, El Segundo did what they had to do with an inspiring 24-7 victory over South Torrance. It also marked head coach Steve Shevlin's 100th career victory. The Eagles finished second behind North Torrance when the Saxons shut out Torrance 54-0.

for the El Segundo Eagles. It wasn't so much the losing, but how they lost a heartbreaking 14-10 CIF Southern Section Northwest Division quarterfinal game to Centennial. Injuries to Nootbaar and Seth McKenna helped doom the Eagles when both were forced from the game.

#### Cross Country

On the boys' front, Joel Foster competed at the Mt. SAC Cross Country Invitational and ran the best race of his high school career. The meet is one of the largest invitational events on the West Coast and includes runners from all across the state. Foster's effort broke a 34-year-old El Segundo High record time on the Mt. SAC course that was established by Alfredo Rosas in 1978.

The girls' cross country team has continued to excel under head coach Marcos Bolanos. The squad placed sixth at the CIF Southern Section prelims. Anna Farello's fourth place finish (18:44) paced the Eagles, who advanced to the CIF-SS finals.

#### Girls' Tennis

The Lady Eagles reached the CIF-SS Division IV quarterfinals, but fell to top-seeded Cerritos--the eventual CIF champions. To get there, El Segundo shut out Hesperia in the wild card round, trounced Del Rio League champion Santa Fe in the first round and overwhelmed

I'm going home to buffalo to visit my 92 year-old Mom and I can't wait to see her. But more importantly, I can't wait to have all of my favorite foods from my youth. Buffalo has such great local specialties that I have not been able to find anywhere else in the world. Yes, we all know about Buffalo wings, but even the famous wing has been bastardized by the fast food industry. We in Buffalo don't call wings, subs or hotdogs fast food. We call them "specialty" foods. Fast food is a manufactured, processed product. Specialty foods are still made with real ingredients and in a style of the past. One of my cravings will be for the riccotta cheese and brown sugar rice pudding from a small Greek coffee shop on the west side of Buffalo. It's light, but supper rich. Here is my rendition of this Buffalo classic.

- 3 cups heavy cream
- 4 whole eggs
- 1/2 cup brown sugar
- 1 teaspoon cinnamon

- 1 cup chilled & cooked white rice (I like to use sushi rice or a short grain sticky rice)
- 1 cup riccotta cheese
- Pinch salt

Mix together all ingredients and place in a buttered casserole dish. Bake at 325 degrees for 30 to 45 minutes or until firm to the touch and golden brown on the top.

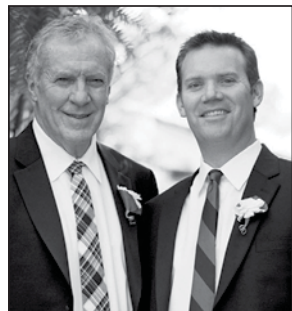

too early for some of the middle school students, but surprisingly they are always there excited and ready to go. They love it and they have a blast.”

Through its hands-on, project-based engineering courses, the program attempts to engage students on multiple levels by exposing them to areas of study that a middle school or high school student would not typically pursue by being enrolled in a traditional math or science class. Through exposure to such courses, the program seeks to provide students with a strong foundation if they decide to take the path to college in search of an engineering-based career. The curriculum, delivered through PLTW’s

every day that they are working on projects. They are using math and using science to accomplish a task and solve problems. They do this daily and they can see how they can use an engineering career the rest of their lives. The early exposure allows students to know if engineering is a path that they want to follow or if they want to go another route.”

With such a strong focus on STEM education across the country, students are becoming better prepared for the high-tech and high-skilled global economy. However, the benefits of these courses extend beyond math and science. Students learn to create, design, build, discover,

be difficult to contribute the full amount in capital improvements considering additional start-up costs, the groups surveyed felt The Lakes could generate healthy revenues. Some ideas to bolster those revenues included golf cart rentals, enhanced banquet operations, a full liquor license, and automation of the driving range.

While still too early to make a final determination on TopGolf or any of the other candidates, Atkinson said his eventual decision “will be in the best interest of the City, the surrounding areas and the citizens who live here.” Fellhauer added, “This gives us a lot more information to make an informed decision.” Prior to the Advisory Group presentation, a number of citizens from El Segundo and neighboring communities spoke of the importance of maintaining The Lakes’ family atmosphere, with some of them expressing concerns about TopGolf’s proposed entertainment-oriented complex.

Also on Tuesday, the Council authorized staff to conduct a feasibility study for possible diagonal parking on one side of Richmond and Standard streets. Research will include an estimate of how many spaces could be added, conceptual drawings for the streets and parking lot, and construction cost estimates for the streets and parking lot. City Manager Greg Carpenter noted that the sidewalks and curbs on Richmond need to be replaced (due to root damage from ficus trees that also must be removed). Diagonal parking would entail narrowing (i.e. losing portions of) the sidewalk—an issue of concern to Mayor Pro Tem Carl Jacobson. The City will also look at offering its own lot at the corner of Main and Grand currently used by the Fire Department for public parking during business hours. “Businesses need spaces for their patrons to park,” said Mayor Bill Fisher.

Councilmember Suzanne Fuentes received unanimous support on an item to oppose Metro’s recent recommendation to re-route Measure R monies earmarked for South Bay projects in order to accelerate completion of the 8.5-mile Crenshaw/LAX Transit Corridor. County Supervisor Don Knabe hopes to provide

an alternative motion and funding options. In the meantime, the Council made its official objection to the move. Metro’s recommended action would reduce the amount available for local highway projects without a plan to replace those funds.

In other action, the City’s Economic Development Advisory Council (EDAC) is now set with the appointment of three new members—Sandy Jacobs, Al Keahi and Drew Boyles. Fisher and Atkinson will be the City Council representatives for that group.

In a brief report, City Treasurer Crista Binder announced that after bidding out bank services and receiving responses from five notable candidates, the City has chosen to go with Chase Bank. She noted that Chase offers innovative solutions, incredible pricing and incentives and is a big community supporter. In the past, the City used multiple banks, making it impossible to link and streamline its accounts.

During presentations, the Council recognized July as Relay for Life Month to encourage citizens to participate in the local anti-cancer campaign that will include painting the town purple with ribbons from July 1-12. The 53.4-mile relay kicks off on July 13 at 9 a.m. at Campus El Segundo and concludes 24 hours later.

Also, Tree Musketeers’ President Julian Poyourow presented instructor Catherine Magruder with Tree Musketeer of the Year honors. Magruder used her to time at the podium to promote the organization’s summer LEAD (Leadership, Education and Action Development) courses that offer an opportunity for South Bay youths ages 10 to 16 to become environmental leaders. The Youth Manager Certification series next month includes three-day courses in personal skills, people skills and organizational management. Meanwhile, kids who complete an eight-week public speaking course from August 5-16 will earn a Toastmasters certificate and can participate in a speech contest during the August 19 graduation.

While the Council canceled its July 2 meeting, it will hold a strategic planning session on Thursday, June 27 at the El Segundo Public Library starting at 7:30 a.m. •

Virtual Academy, is provided free of charge to schools that register with PLTW. However, the classroom equipment and teacher training, which are both a requirement, are not free and are usually the main costs associated with the program. At El Segundo High School, Chevron donated the money to get the program started and the Middle School joined a year later.

“We would love to run it here, but we don’t have the space for the equipment,” Plotkin said. “So they [students] sign a permission slip and get going. That gives them a head start if they decide on an engineering pathway. It is motivating and a lot of the kids love it because it is so hands-on. That is great for the kids who don’t do so well in the traditional classroom where I would just be talking to you. It provides an opportunity for the kids to engage in deep thinking and problem solving that mirrors what students would have to do on the job.”

The application of math and science concepts to everyday activities is one of the elements of the program that Eno and Plotkin appreciate and consider to be of much benefit to their students. “This really gives the students a chance to take what they are learning in their math and science classes and really apply it,” no said. “Most classes give students a project here or there. With the Project Lead the Way courses, students are seeing what they learn

collaborate and solve problems by applying what they learn in math and science.

“All the job opportunities in engineering are based on computer skills and engineering skills that you have. That is what this program does—it prepares them,” Eno said. “They [students] are learning to use these science concepts and skills to solve major problems. By going into the Project Lead the Way, students are obtaining a huge advantage in terms of college and professional careers because they are learning the skills that will be needed.”

In addition, exposing students to STEM fields allows them to come in direct contact with professionals from local industries who serve as a strong example of real-world aspects of the curriculum through mentorships and their own workplace experiences. “Regardless of whether you are into engineering or not, sometimes you have a problem and you have to work together in a team to solve it,” Plotkin said. “That really mirrors the real world for kids. Just the exposure through design thinking to engineering gives the kids the mental framework they need for problem solving as a whole. If we can create good problem solvers and students who can work well with others and communicate and are reflective and thoughtful, that is what companies need. They don’t need students who are receptive, passive learners who need direction.” •
