El Segundo Makes Case for Silicon Beach Status

City officials hope that the geographical borders currently recognized for the so-called Silicon Beach area will soon extend a few miles south to include El Segundo. Generally viewed as a coastal stretch running from Santa Monica to Venice that also includes Marina del Rey, Playa del Rey and Culver City, Silicon Beach is rich in start-up entertainment and technology companies—with the likes of Google, Time Warner and YouTube among the household names on the list, along with hundreds of lesser known but nonetheless growing firms.

El Segundo too has also become a hub for such businesses, as attested by NSB Associates Chairman Larry Field, who said, “Once known for aerospace, El Segundo has emerged in recent years as a highly desirable location for creative, technology and new media companies.” At the same time, according to the City’s Planning and Building Safety Director Sam Lee, realtors consider LAX as a barrier for Silicon Beach to further expand to the south—thereby often excluding El Segundo despite its growth in the creative sector. “We would love to see El Segundo included more in the Silicon Beach conversation,” said Lee, who last month attended the second annual Silicon Beach Fest in Santa Monica. The festivities took place over four days with various panels, events, meet-and-greets and other activities to showcase the burgeoning tech scene. “El Segundo wasn’t really mentioned, but we are hoping to see this change in the near future. A lot of the people who work in those areas live in the South Bay beach cities to be near the water. El Segundo is in the heart of these highly desirable coastal communities. Our building owners talk about it and see how El Segundo is a wonderful opportunity.”

To truly put El Segundo on the map, the

City will pin much of its hopes on building a buzz around Smoky Hollow—the community’s industrial district sandwiched between Downtown and the eastside business corridor. Smoky Hollow garnered regional attention last year after a panel of experts from the Urban Land Institute toured the area and pegged it as a “diamond in the rough” with the potential to be the next Santa Monica or Culver City.

The panelists singled out Smoky Hollow’s coastal and freeway adjacent location, comparatively low cost, small town charm, great building stock, fine grain with accessibility to both small and large players, rich variety of uses, and proximity to Downtown El Segundo. On top of all this, El Segundo offers lease rates two to three times lower than Santa Monica.

Memorial Honors Tragic Loss of 19 Firefighters in Arizona

Two big, red firefighter helmets stand about two feet away from each other as 19 small American flags stand beneath them in the shape of a heart on the lawn of Georgina and Fred Curcio—one flag for every victim. The colorful display pays tribute to the 19 firefighters who lost their lives battling wildfires in Arizona earlier this month. For Captain Curcio, who has been a firefighter for 32 years, the loss of 19 fellow firefighters was hard news for him to watch.

“I actually started off one summer as part of a brush crew with Los Angeles County, so these kids are all starting off and these are the guys that probably work on fires the hardest,” Curcio said. “They are right down on the fire line—they do not have any water or hoses. All they just have are shovels and chainsaws and their job is to remove the fuel away from the fire, so they try to cut a line around the whole fire. These are young kids trying to become full-time firefighters so they can get on a fire engine

and work in the city on fire structures and everything else.”

Curcio is approaching the end of his career and the fact that 19 young firefighters perished in their attempt to become full-time public servants gives him a small reminder of the dedication and commitment that these individuals have toward their careers. “There are a lot of different emotions and it is tragic when these accidents happen because nobody wants to lose their life for a piece of property, a building or vacant land—which makes situations like this a lot more tragic,” Curcio said. “It is all about character and it is about dedication. I think that sometimes the general public does not realize, with issues like the economy and the hits that we have been taking recently, the amount of energy that goes into these jobs. You have thousands of people applying for one position in the department. These kids were probably taking college classes and were probably working as volunteers and on numerous hours that they log so that when they go

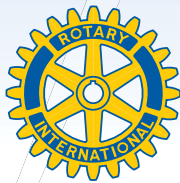

into the interviews, they can show what they are doing to obtain the job. It comes at great expense and time for what they put in."

In a career in which personal and family time are constantly sacrificed, Curcio is reminded of the bond that he has established with his crew at Station 160 in Hawthorne. "It is a calling and you really have to want to do this job. Sometimes we get accused of being a fraternity, but I think it is just an extreme dedication," Curcio said. "These guys are going above and beyond what the normal workfolk do to get jobs. Once they are in there, they are dedicated to doing this their entire career and hopefully they make it to where they can enjoy general health for retirement."

Curcio began his career when he was 22 years old and while working fulltime at Hughes Aircraft in El Segundo. After work at 5 p.m., he would drive to Palos Verdes Estates and volunteer from 6 p.m. to 4 a.m. only to go back to Howard Hughes in the morning. This included 24-hour shifts on the weekends for about two years. It also meant giving up special occasions with friends and family.

"When I started that, you almost lose track of days of the week. I was single at the time, but I told my folks that holidays do not exist. If your shift is up, then you are working that day," Curcio said. "What happens with the younger guys is that they are so happy and excited to get into the fire department that the older guys who have kids and wives will get the holidays

off, but the young guys volunteer even if they are off. For 32 years you miss birthdays, you miss baseball games, you miss graduations and holidays. There is nothing sacred anymore and you have a balance between your home family and your work family."

It is that work family that keeps these public servants so close together. Curcio planned to keep the memorial up for 19 days to honor each victim individually. "For years, I have thought situations and things that have happened during an incident that we walk away from and we wonder, 'How did I walk away from that?' Then you see incidents where people don't make it and there are great circumstances and consequences," Curcio said. "People have read the articles and understand that these were young kids trying to make a permanent career, so their hearts just go out to the families. Any time you lose a family member it is horrible--and when you lose a child, it is horrible."

Some of the victims of the fire came from a family of firefighters. "Any parent I am sure would be proud to have a son or daughter join in ranks of firefighters across the country. There are different levels in different parts of the country that we all work and have things that we deal with," Curcio said. "It is one big family. Emergency service in general-- police, fire and teachers--all just want to serve the public. Unfortunately, they paid the ultimate price and the biggest thing that we can as a public is not forget what these guys do." •

In examining what creative start-up companies look for, Lee deemed Smoky Hollow a perfect match. "They [start-up company owners] like to convert old industrial buildings and El Segundo has lot of those," he said. "They also like to be next to each other for business and social reasons to share ideas and grow together. They enjoy being close to the beach so they can surf before work and want to be near great restaurants and shops. We have all of this available to them at a much lower cost than the Westside."

Several firms have gotten the ball rolling in Smoky Hollow, including Apollo Interactive--an Internet advertising and marketing agency that moved from Culver City to a space on Illinois Street. Additionally, health information management company Caban Resources is in the midst of a physical expansion and Smoky

Hollow revitalization project on Sierra Street, while renowned retail developer CenterCal Properties recently acquired a building at 1600 E. Franklin. "If anyone would recognize the value and opportunity in Smoky Hollow, it would be CenterCal," said Lee.

At the same time, the area presents some challenges, with lack of available parking on top of the list. Ideas to remedy the situation include restriping street parking, closing certain streets, creating one-way pairs with diagonal spots, removing night parking restrictions and utilizing alleys. An actual parking district with shared and/or tandem parking and valet assistance may be necessary down the line.

City staff will soon unveil the details of an in-lieu parking program to help subsidize future

Baby Boomers and Age-Related Eye Disease

(BPT) - As the population continues to age at an unprecedented rate, the concern about age-related eye disease comes more into focus.

According to the US Census Bureau, the population of adults over age 65 is expected to double by 2025, and the American Optometric Association (AOA) reports that the incidence of Age-Related Macular Degeneration (AMD) is expected to triple during the same time period.

In 2010, more than 10 million people were affected by AMD, and looking even further into the future, that number is expected to jump 150 percent by 2050, based on the National Eye Institute's (NEI) Projections for AMD.

The leading cause of severe vision loss in people over age 50, AMD damages the macula (center of the retina) and as the disease progresses, it blurs one's central vision. AMD presents in two forms, wet and dry. Dry AMD is more common, and occurs when the visual cells in the macula slowly break down. Dry AMD that goes untreated can progress to wet AMD-caused by the abnormal growth of blood vessels under the macula. Wet AMD is considered advanced AMD and can lead to rapid loss of central vision, which is typically more severe than the dry form.

The NEI recently released the results of

AREDS 2 (Age-Related Eye Disease Study 2), a five-year, 4,203 patient study of people between 50 and 85 years of age with intermediate AMD in both eyes, or advanced AMD in one eye.

The objective of the AREDS 2 Study was to determine if the addition of Zeaxanthin, Lutein, and Omega 3's to the original AREDS formula would further reduce the progression to advanced AMD. Numerous clinical studies suggest these nutrients protect vision.

The original AREDS study results were released in 2001, and revealed that high-dose antioxidant vitamins and minerals including Vitamins C and E, Beta-Carotene, Zinc, and Copper reduced the risk of progression to advanced AMD by 25 percent, and the risk of moderate vision loss by 19 percent.

By adding Zeaxanthin (zee-uh-zan-thin) and Lutein to the original AREDS nutrients, study results demonstrated that the progression to advanced AMD was reduced by 9 percent when compared with no lutein and zeaxanthin, and an 18 percent reduction in progression to advanced AMD in subjects who received the AREDS supplement with lutein and zeaxanthin versus the original AREDS supplement with beta carotene.

Sprint has been receiving eight million government requests for snooping each year and has therefore upgraded its equipment to assist the government's invasion

into our lives. Imagine that! Our government and communications companies have entered profit-driven agreements to expedite privacy invasions.

So here's my suggestion: Why don't the conspirators up the ante? Raise the wire taps and conversation invasions to the limit of the government's capacity--one billion calls per day--and charge accordingly. Bill Seeks to Ensure Funding for Domestic Violence Shelters

When convicted of a crime, it is common that the guilty party pay a fine in which the total sum is split into different parts and used for a variety of reasons. Assemblyman Chris Holden's AB 139, which passed the Senate vote, seeks to ensure that money paid by the guilty party will go to a worthy cause--to fund domestic violence shelters. The bill would require that the penalties paid by abusers be strengthened to ensure that more funding is made available for such shelters. Having people who are guilty of violence against their domestic partners (i.e., wife or husband, girlfriend or boyfriend) pay a sum of money that will fund a local domestic violence shelter is an idea that is long overdue.

Unlike many fines that go to different departments and end up being split into several different portions for a variety of reasons, AB 139 allows more funds to go directly to local domestic violence shelters. The bill would require that anyone convicted of domestic violence must pay a \$500 fee after being granted probation. The \$500 is a fee--not a fine--and ensures that the money is used to directly help the victims of the crime. Unfortunately, the victims of domestic violence have a tendency to return to their abusers. Whether out of fear or due to a lack of resources, these victims are many times left with limited options and preyed upon by their abusers. By having a law to ensure that money is directly routed to these

shelters by such criminals, there would now be a more readily available network for these victims.

The bill was born after a 2012 State audit revealed that the distribution of payments used to support domestic violence shelters in various counties leave a significant portion of said payments uncollected. The bill will ensure this is no longer the case, hence ensuring that the funds get to their destination. It is already a challenge to convince victims of domestic violence to seek the support and resources available to get away from their abuser. The challenge is significantly magnified when the funds that are supposed to fund these resources fail to make it to their destination because of the wording of old laws.

While AB 139 still has to go back to the Assembly floor in August for language changes, having the Assembly and the Senate moving in the same direction on this topic is encouraging and long overdue. The victims of domestic violence, in their majority women and children, should not be made to wait or go without resources. Not all victims have family close to them to seek refuge from an abusive partner. Furthermore when children are involved, it becomes more difficult to find shelter. Ensuring that these shelters are funded and available to victims will help the latter take control of their lives and transition out of that violent relationship in a faster and more effective manner. •

The Babe Ruth team is off to the Pacific Southwest Regional hosted by Vernal, Utah after defeating Westchester 13-4 for the Southern California title. The 11-12-year-old All-Star team's run at a Section 4 championship came to an end in epic fashion against Eastview Little League.

The 13-year-old All-Stars handed Westchester a 13-4 pasting in the Southern California State

to make it 5-0.

In the second inning, Westchester could only answer with a scoring fly to make it 5-1. El Segundo hammered out 14 hits and was led by Emery who was three for three with a home run, sacrifice fly, walk and three RBIs. Celestial was two for four. Acosta went the distance, giving up four runs (three earned), scattering seven hits and striking out three.

Defensively, Celestial made the play of the tournament. He dove to stop a ground ball up the middle and from his knees threw in time for the out. It helped quell a potential rally.

Head coach Bob Motta said afterwards how proud he was of his team and emphasized the word *team*. "This was a complete team victory as we move on," he said. "It takes all 14 players to make a team a winner and that's what you saw from this team."

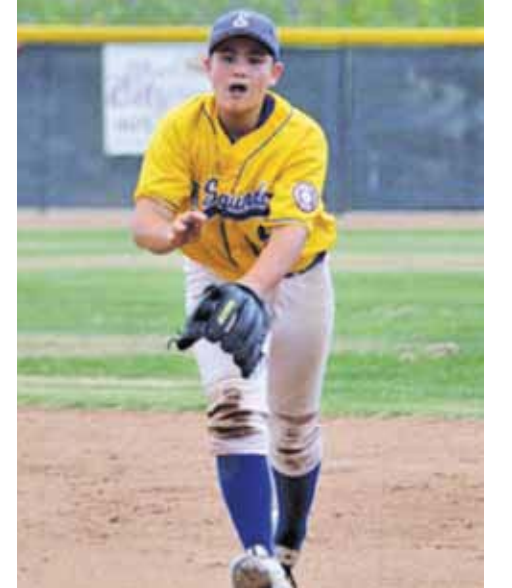

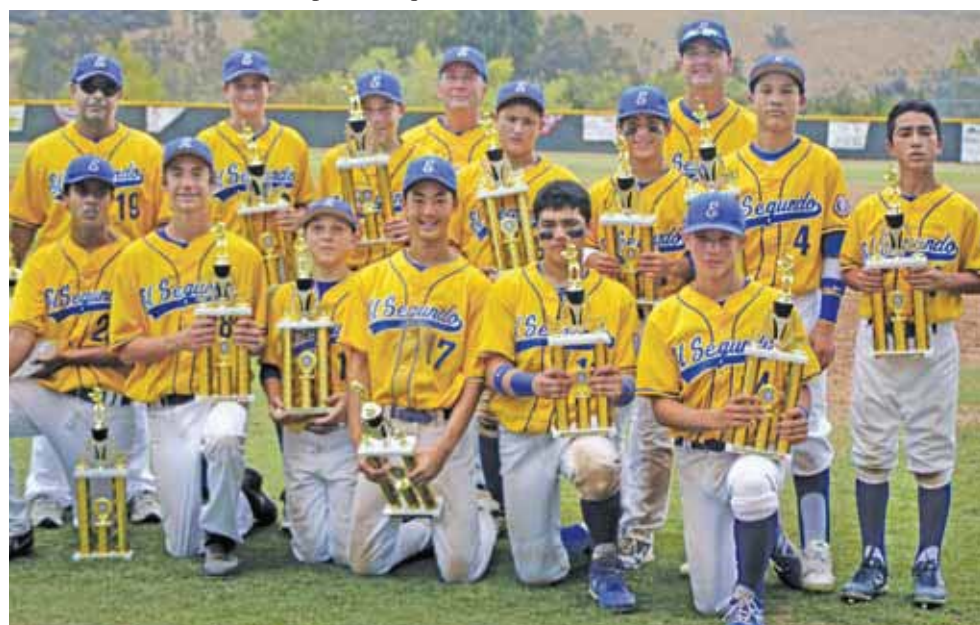


Michael Graner executes a perfect squeeze bunt to give El Segundo a 5-0 lead.

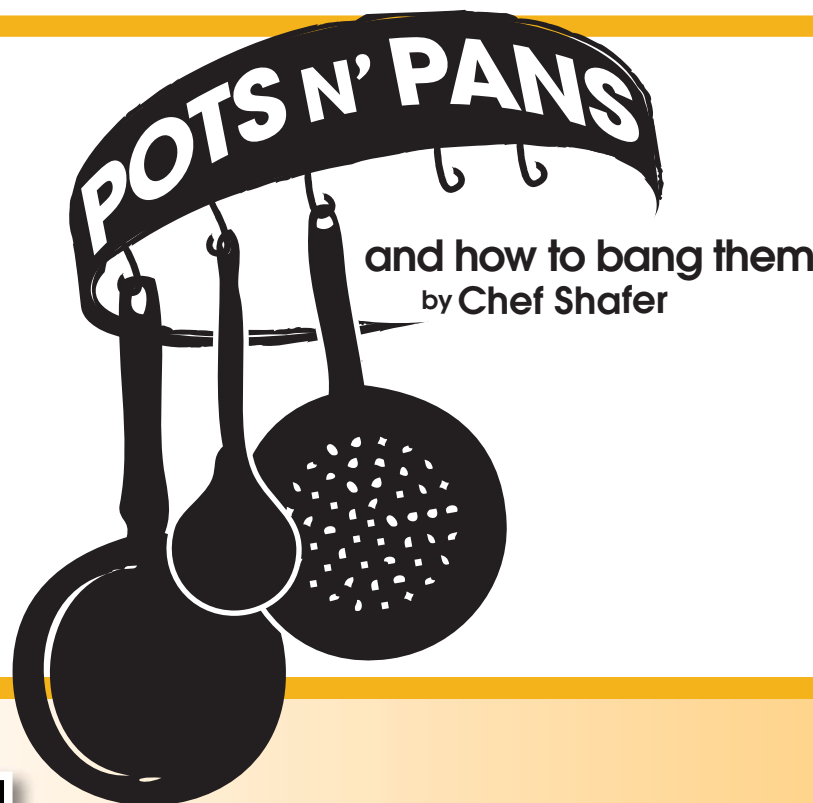

McCormick & Schmick's Gets the Seasoning Right With Summer Seafood Menu

Despite a recent spell of atypically dreary weather for late July, summer in the South Bay still has plenty going for it. Perhaps no one realizes this more than the local McCormick & Schmick's, which recently unveiled its "Summer

vegetables atop very good mashed potatoes. Cara Cara oranges are a hybrid of two navel varieties noted for their slight sweetness and low acid content. They make a perfect base for a citrus relish to accompany the salmon.

A favorite dish of Herald CEO Heidi Maerker,

the "Chocolate & Decadent" category, this dessert is not overly sweet. Circles of strawberry sauce surround the mouse cake and provide a wonderful dipping complement for the chocolate.

The kitchen has taken presentation to the next level with all of these dishes. Executive chef Joe Gonzalez, sous-chef Stephen Rodriguez and the rest of the staff deserve kudos for their plating expertise and top-notch knife work. They make it look a lot simpler than it actually is, as it's no piece of cake to julienne vegetables using a mandoline.

McCormick & Schmick's has also unveiled a new lunch menu, with debuting items including Shrimp and Bay Scallop Fettucini, Crispy Fried Cod Sandwich and Chicken Portobello Sandwich. Those looking for a refreshing beverage can also order one of many excellent Summer Refreshers. The non-alcoholic options (each \$5.00) include Strawberry Lemonade (with homemade simple syrup), Sunset Punch (with strawberry, pineapple, apple, orange and grapefruit juices), and Blackberry Splash (with simple syrup and lemonade). Drinks with alcohol include the Mango Mojito, Perfect Patron Margarita and Prosecco Sangria.

not one, but two such events. Starting August 5, happy hours will run from 4 to 6:30 p.m. and then again from 9-10 p.m. on weekdays in the bar and lounge area. Menu choices run from \$2.99 to \$5.99 with a minimum beverage purchase of \$3.25 per person. Meanwhile,

An ideal remedy for the heat and humidity, the Heirloom Tomato Gazpacho (\$6.99) is a particularly refreshing starter. A cold soup of Spanish origin, gazpacho in questionable hands can sometimes taste too much like a nondescript mild salsa. The McCormick and Schmick's version is tangy and vibrant. Topped with lemon crème fraiche and also featuring chopped onion and cucumber along with several shrimp croutons (similar in texture if not in sweetness to hushpuppies), this is one of the

the Alaska Halibut With Clams & Succotash (\$34.99) features a lovely piece of the prized white fish along with fresh clams. The kitchen's creamy rendition of succotash replaces the usual lima beans with Edamame (the Japanese name for soy beans) and also includes corn, onions and bell pepper. The flaky and moist halibut is perfectly pan-seared.

Both the salmon and halibut join forces on the Wild Alaska Duo (\$32.99), with the two grilled and plated side by side with yellow summer squash, watermelon relish and heirloom tomato salad and drizzled with balsamic vinaigrette. It's a great option for those who can't decide between one or the other.

The Seared Steelhead With Artichoke Ravioli (\$27.99) is another well-executed pairing. Though almost identical to salmon in color, taste and texture (since both fish eat the same krill-based diet and behave identically in the wild), steelhead is a kind of rainbow trout and not quite as rich as its counterpart. The fish is pan-seared and comes with sautéed squash ribbons and ravioli tossed in a lemon-thyme cream sauce.

parking in Smoky Hollow. Under the system, the City would collect funds from property owners who expand or build additional stories to their buildings but are unable to provide required onsite parking for future tenants. The tenants can instead pay a fee "in lieu" of onsite parking so the City can apply the funds towards public parking. The in-lieu fee does not mean property owners purchase or lease an actual parking space. Through this arrangement, landowners receive the benefit of developing more of the property than is otherwise allowed since they have to make room for parking. The fees then accumulate, allowing the City to later build public lots that all can share. "If someone is short a few spaces, they could pay

into the program to allow the conversion of their building," explained Lee.

Staff is also at work addressing two other perceived drawbacks of Smoky Hollow—lack of fiber optic infrastructure and a long out-of-date specific plan that is too prescriptive. The City is currently on track to complete the fiber optic infrastructure by spring 2014 and will next draft a specific plan for Smoky Hollow to incorporate new design elements in order to transform the area into a mixed-use office/ industrial hub with particular emphasis on hi-tech, creative and Internet firms. "If we can get more companies to come here, there can be a domino effect," said. Lee. "El Segundo is in the midst of all this activity." •

Another important take-away from the AREDS 2 Study, which applies to most Americans, was a 26 percent reduction in progression to advanced AMD for subjects with the lowest dietary intake of lutein and zeaxanthin.
