El Segundo Power Plant Modernization Completed

After a 13-year wait and many obstacles along the way, the modernization of El Segundo's coastal power plant is finally complete. Facility owners NRG Energy, Inc. began commercial operations at its El Segundo Energy Center earlier this month. "On August 1, we officially entered into the Power Purchase Agreement with [Southern California] Edison, which effectively serves as the start of commercial availability to the utility," said NRG Director of Communications Jeff Holland, who added that a grand opening ceremony is also set for September 12.

The project entailed construction of two new gas-fueled generating units that will produce 550 megawatts of electricity for the California grid—sufficient to power close to 450,000 homes. The units can be online within 10 minutes and at full capacity in an hour, providing critical backup support for solar power and other renewable energy sources. Environmental benefits include significantly lower natural gas omissions and the use of air-cooled condensers in the units in contrast to the prior 1960s era steam boiler technology that relied on ocean water for cooling. "The new Energy Center relies on reclaimed water for its state-of-the-art, air-cooled, combined cycle operation, reducing the use of potable water at the site by nearly 90 percent," it states in a press release about the facility opening. With these measures in place, the facility meets or exceeds California air quality regulations and falls in line with a State objective to achieve 1990 greenhouse gas levels by the year 2020.

The proposal to replace two outmoded, 1950s generators at the plant with new units goes back to 2000, but obstacles ranging from environmental outcry about impacted marine life (addressed with the air cooling system) to

lack of a power purchase agreement (inked with Edison in 2008) to a court-ordered moratorium on issuing emission credits (resolved in 2010) delayed it from moving forward until now.

NRG mothballed two of its 1950s-era units (1 and 2) in early 2003. Units 3 and 4 still remained with a combined 670 megawatt capacity and operated on an as-needed basis over the next several years. But NRG then had to retire Unit 3

as a condition for obtaining the necessary air credits to move forward with the plant modernization, reducing the facility's overall generating capacity but removing the final roadblock in the process. Crews demolished Units 1 and 2 in late 2010 to make room for the new units that are now up and running. The project also featured aesthetic improvements, including removal of two large

Valerie Voboril: Local Mom, Teacher and World Class Athlete

She's a five-foot-two, 35-year-old mother of a two-year-old girl, teaches fourth grade at Richmond Street Elementary School and, by the way, is the third fittest woman in the world. While successfully balancing her career and motherhood, local resident Valerie Voboril also competes in the annual Reebok CrossFit Games--a grueling competition that showcases the globe's most elite athletes. From a pool that started out with thousands of hopefuls, Voboril recently managed to finish third in the women's side of the event for the second time in the last three years while competing in a mixture of weightlifting, swimming, rowing and running events.

Voboril qualified for her first competition in the spring of 2009, which she found out conflicted with an April 19 wedding date set with her fiancé Steve. "We changed our wedding date, I competed, qualified for the CrossFit Games and got married the next weekend," said Voboril. Heatstroke got the best of her that first year, but Voboril finished

third in the Games in 2010 before taking 2011 off to have a baby. She placed fifth last year and third again in 2013.

"My training regimen for this year was a serious juggling act--my family and my career are very important to me as well as my training," said Voboril. "I trained an hour a day for five days a week so that I could dedicate quality time to my family and my students. This is a considerably different training plan compared to the female athletes I compete against who train twice a day for one to two hours, six days a week." Voboril's workout routine includes four 15-minute blocks with rowing, stretching, shoulder activation and stabilization, squatting, Olympic lifting, and anaerobic conditioning.

While proud of her lofty achievements, Voboril said her ability to be an inspirational role model for others continues to be her greatest reward. "I am incredibly lucky because I receive tons of support from my friends, family, gym, and from my students

City and Former City Manager Settle

The City of El Segundo and the former City Manager, Doug Willmore reached a \$300,000.00 settlement. A statement from the City of El Segundo provided: The City of El Segundo and the former City Manager, Doug Willmore reached a settlement of Mr. Willmore's lawsuit against the City relating to the termination of his employment. While the City admits to no wrongdoing, it did not want to expend further time and resources on the litigation. Therefore, the City believed it was in its best interests to put the matter behind it.

City manager Greg Carpenter provided the following statement: The City Council agreed to the settlement based upon a couple of considerations. Local Businesswoman Expands her Business by Empowering People

At the age of 19, Eileen Freiburger, CFP ESF Financial Planning Group, began her career in the field of financial planning. Her early years checks--and not everybody loves the feedback," Freiburger said. "If you are not saving enough and if you are in debt, you need someone

working at Schwab laid the foundation as a financial planner and led her to establish her own successful business.

"As the letterhead says, 'Taking you beyond the numbers' because financial planning is a process--not a product," Freiburger said. "Our business model is very unique because we are going to teach people to do it [financial planning] themselves and objectively answer whatever their financial questions are."

ESF Financial Planning Group opened its doors back in 2002 from an office in El Segundo. In 2004, Jana E. Davis joined Freiburger and together they have grown the business out. By 2008, the business moved to its current location in Manhattan Beach where the work continues to flow in.

"As a business we are as busy as we can possibly be, but I think that we both sleep better at night knowing that we are not turning away clients," Freiburger said. "We are not having someone call and asking, 'How much do you have because if you don't reach our minimum we can't work with you.' That is an awful way to treat people. When a client calls us, anyone that needs feedback, we are trying to make ourselves available. So we stay very, very busy."

Unlike many financial planners who work based on a commission and therefore require a minimum amount of money to work with someone, Freiburger and ESF Financial Planning Group will sit with any individual seeking guidance or advice.

"When we first started, we only did hourly work because we believe that you should learn to do it yourself to empower yourself--you will do so much better," Freiburger said. "Unfortunately, widows, divorcees and people who really weren't exposed to the market really were not comfortable on their own. Self or help is a trademark of the company--self or help financial planning services, whichever way makes the most sense to you. For us, that means that we are busy because not that many people offer this type of a business model without a minimum amount or without an agenda. It really lends itself to address what is that real-world financial question and we will do planning based on what your reality is."

Freiburger is proud that her company does not sell a product to the consumer. Instead they educate customers, allowing the latter to make the decision that they are most comfortable with given the available options.

"We always say that we are objective but

to objectively look over your shoulder and better answer questions. If you can't afford the mortgage that you have gotten into--if you were willing to sell and downsize--we can show you how you can do better with some savings."

With each customer, there are a different set of needs. Yet, common concerns include college money for the kids, savings for retirement and investment options.

"On the other end, we try to stay affordable and available so that if someone really needed us, we are here," Freiburger said. "We will bring someone working on their first 401K while trying to pay off student loans. We might do a working session and spend a long hour together. In the end, we will do an invoice and get the person on the right path because they do not need much more than that. This is not that difficult if you are comfortable enough with letting somebody guide you in the right direction. So much of it is autopilot. Are you saving enough? Can you add more to your 401K? Can you redirect cash to savings? A lot of it is just teaching people to be more comfortable and make those types of services available."

While Freiburger is committed to helping people understand what their different available options are so they can make the decision they feel is best, she wants her customers to walk away feeling that they have accomplished more than just a meeting with someone good at financial investments. "I want them to walk away with the sense that if they are working with a true, independent, fiduciary planner that they can feel more control of their financial life," Freiburger said. "I truly want them to feel that they had a rewarding experience. I may not have all the answers and say when exactly a person should quit their job, but I do want the client to leave with a sense of not necessarily knowing the black and white answers because it is never black and white--but that they understand the options so that they have the control and the empowerment to do what is right for them."

Freiburger added, "That is so unique because many people leave a financial planner's office shaking their heads and not knowing what to do. We do a lot of second opinions and you have no idea how many times we end up explaining other people's products. We are also explaining how to unravel it. In our world, all financial paths lead to low-cost, low-expense, non-commission products. It is a very, very different view. •

Retiring Soon? Don't Forget Tax Implications

If your retirement is not far off, you've probably already started to estimate what your living expenses will be after the regular paychecks stop. Most would-be retirees remember to include routine expenses like housing (rent or mortgage), medical bills and prescriptions, insurance premiums, transportation

- even food and entertainment.

But don't forget to factor in taxes, which can have a substantial impact on your cost of living, depending on where you live and what your sources of retirement income will be.

Here are a few tax-related issues to consider when budgeting for retirement:

Social Security. Most people can begin collecting Social Security benefits as early as age 62, albeit at significantly reduced amounts than waiting until their full retirement age (65 for those born before 1938 and gradually increasing to 67 for those born in 1960 or later).

Although many states don't tax Social Security benefits, the federal government does. Depending on your "combined income" (adjusted gross income plus nontaxable interest earned plus half of your Social Security benefits), you could end up owing federal income tax on a portion of your benefit. It's complicated,

Single people whose combined income is less than \$25,000 aren't taxed on their Social Security benefit. For combined income between \$25,000 and \$34,000, up to 50 percent of your benefit may be taxed. Over \$34,000, up to 85 percent may be taxable.

For married couples filing jointly: benefits aren't taxable for combined income below \$32,000; benefits for income between \$32,000 and \$44,000 are up to 50 percent taxable; over \$44,000 – up to 85 percent taxable.

To learn more about taxation of Social Security benefits, read IRS Publication 915 at www.irs.gov.

Some people discover after beginning to collect a reduced Social Security benefit that they can't make ends meet and must go back to work, which can backfire: If your annual wages exceed \$15,120, you will lose \$1 of Social Security benefits for every \$2 you earn over that amount (investment income doesn't count.)

Rest assured, however: These benefit reductions are not completely lost: Your Social Security benefit will be increased upon reaching full retirement age to account for benefits

oil storage tanks and incorporation of native landscaping, benches and a new sea well to enhance views of the coastline.

"It took over 13 years for the plan to modernize the El Segundo power plant to finally come to fruition, but it was well worth the effort--kudos to our wonderful business partners NRG Energy for meeting all the challenges it faced over the years to make this happen," said El Segundo Mayor Bill Fisher. "We now have an efficient, gas-fueled generating station here in El Segundo that is not only environmentally friendly, but will also supply much-needed power to the grid to help our region... as well as providing a critical revenue stream for the City."

What that revenue stream will translate to in exact dollars is unknown, as it will depend on frequency of operations along with variables in natural gas prices that directly impact utility user tax revenues. "We have load capacity to meet the currently contracted needs of the service area," said Holland. "As the new units create greater efficiency and faster starting capability, we would expect them to run more often than

the previous units when generation is needed."

In past years, the City of El Segundo could typically expect about \$3 million in annual tax revenues from the power plant when Units 1 and 2 ran virtually year-round. Sporadic operations in more recent years coupled with lower natural gas prices markedly reduced those numbers. According to a 2009 fiscal analysis provided by NRG to the California Energy Commission, plant operations were supposed to generate up to \$40 million in various tax revenues over a five-year period—and City officials originally estimated first year tax revenues in excess of \$10 million. Now that final number will well below that target. In its budget projections for 2013/14, the City staff figured in \$200,000 in additional utility user taxes compared to the 2012/13 year-end estimate. Facility operations were higher than expected over the past year due primarily to the closure of the San Onofre power plant. NRG estimates about \$3 million in additional annual tax dollars from the new Energy Center, but that includes Los Angeles County's portion of those revenues. •

and their families," she said. "The supportive e-mails from my students and their parents bring tears of joy to my eyes." One letter from the mother of a former student praised Voboril for teaching children the value of a strong work ethic-- that nothing comes easy in life and the harder you work to realize a goal, the more likely you can achieve success.

Richmond Street School creates a challenge entitled "Who Can Beat Mrs. Voboril?" at the annual PTA Run For Education. "I hear from parents how their kids can't wait to run, how they train to beat me, and how I make fitness fun," said Voboril, who incidentally finished 13th out of 819 females and third in her age range for the 5K portion of the Run.

Despite her athletic prowess, Voboril's first love is education. A native of Fresno, she graduated from Cal State Northridge with a BA and a teaching credential. She is now just three classes away from completing her Masters degree in education. "Working with children since I was in middle school by babysitting, coaching gymnastics and running kids' art and music programs made teaching a clear and easy career choice for me," Voboril said. "I couldn't imagine a life where I wasn't working with children in some capacity."

Voboril's first teaching job was with Los Angeles Unified School District as a fifth grade instructor. However she soon became dejected, feeling she wasn't making a difference in those students' lives. Through the encouragement of her friend Stacy Fienbloom, then a fourth grade teacher at Richmond Street, she applied at El Segundo Unified in 2002. "I love teaching fourth grade and watching the bright young shining faces experience those 'aha!' moments," said Voboril. "I also hope to earn my single subject credential in math and to teach at El Segundo High School at some point in the distant future."

And while it's a challenge to balance the three major elements of her life, Voboril reports that she has become very efficient with her time by working through her lunches, grading papers after her daughter goes to bed and limiting her training to an hour a day so she can devote more one-on-one time to her little one. That little one will eventually attend local schools since the Voboril family moved to town last December. "The decision was easy to make because El Segundo offers fantastic schools and I couldn't imagine my daughter going anywhere else," Voboril said. "I loved this community as a teacher and have come to love it even more as a resident. The community is supportive, involved, caring and family and education-centered. What isn't there to love about El Segundo?" •

A New Attitude Towards Mental Health

The introduction of Senate Bill 330 by State Senator Alex Padilla is a reminder of the urgency with which we as a society need to look at the issue of mental health through a more academic lens. Currently there is no active process for reviewing any types of frameworks toward adopting instructional materials on mental health. These efforts have been suspended since July 28, 2009. Furthermore, the State Board of Education (SBE) is specifically prohibited from reviewing any frameworks and adopting any instructional materials until the 2015-16 school year. This bill requires that the next revision of the health curriculum should include a distinct category on mental health instruction.


As a society, we continue to struggle with understanding mental health issues for a wide range of reasons--the most significant being the stigma that exists for people suffering from mental issues and disorders. It is tragic that because we don't fully understand the effects of mental conditions on people and the many conditions that do exist, that we, as a society, have the tendency to lump all patients with mental disorders into the "crazy" category. These people are not crazy--they are ill and need care in a variety of forms. Unfortunately for many years, these patients have being stigmatized mainly because most people are not educated about the issue.

Not having a curriculum available to explain to students in the K-12 system what some of these mental disorders are, how they affect people and what the patient must go through will only delay the process of making the general public more aware and accepting of afflicted individuals.

Teaching kids and teenagers that suffering from a mental disorder does not make the patient a bad person is the first step in helping the person afflicted by the condition. Patients with mental illnesses or disorders are reluctant to reveal details of about their struggles because they don't want to be mocked or shunned. When this occurs, the conditions for the person afflicted become worse because they are being marginalized, thus limiting their ability to socialize and try to lead a normal life.

In 2010, when the Lakers beat the Celtics in game seven of the NBA Finals, then Lakers' small/power forward Ron Artest gave one of the most interesting postgame interviews I have ever seen. After saying hello to his old neighborhood, wife and kids, Artest thanked his psychiatrist. The NBA star, from the biggest stage he had ever set foot on, told the world that he was afflicted by a mental disorder. Artest admitted that his doctor was crucial in helping him "relax a lot"--and based on his performance that night, he wasn't lying. The admission from an NBA star, known for one of the ugliest fights in NBA history, that he had a mental disorder brought the issue national attention. Unfortunately in our social media world, these issues are trendy for a while and then quickly forgotten.

Hopefully Senate Bill 330 and Senator Padilla's efforts bring the issue back via an academic approach so that more people with mental disorders can seek the help to relax them, without any of the stigma. If Ron Artest could overcome his issues, then so through a proper academic framework can society overcome its issues with mental disorders. •

After age 59 ½, you can start withdrawing balances from your IRA without paying the 10 percent early withdrawal penalty – although exceptions are made in cases including disability, qualified first-time homebuyer distributions and certain medical expenses. However, you will pay federal (and state, if applicable) income tax on IRA withdrawals – except for Roth IRAs held at least five years, whose contributions have already been taxed.

With 401(k) plans, you can withdraw funds after age 55 without the 10 percent penalty if you are no longer employed by the company sponsoring the plan.

Other taxes. Some people move to another

state after retirement thinking they'll lower their tax burden. For example, seven states do not tax personal income; however, another two tax only dividend and interest income. And five states charge no sales tax. But because other taxes and cost-of-living expenses vary significantly by community, you should only consider such moves after doing thorough research.

The Retirement Living Information Center (www.retirementliving.com) features breakdowns of the various kinds of taxes seniors are likely to pay, state by state, including those on income, sales, fuel, property and inheritances.







The Junior Guard competition kicked off the three-day USLA National Lifeguard Championships in eight different events. There were four age groups for both boys and girls for each event. Athletes competed in Beach Run, Surf Race, Run-Swim-Run, Rescue Board Race, Iron Guard, Rescue Race, Swim Relay and Beach Flags.

El Segundo's Kira Makuta dominated the first day, which featured young participants from USLA-affiliated lifeguard programs from across the country. Makuta won four first-place gold medals on the day in the Girls' 16- and 17-year-old age division. She also won a gold medal in the relay race. She won titles in Iron Guard, Run-Swim-Run, Surf Race (distance swim) and Rescue Board Race.

"It was fun and exciting," said Makuta after exiting the water following her first win in the Iron Guard event. Junior Guards swim the designated course, run to the transition area, paddle the designated course and then finish with a final run leg.







Excellent Prospects for August's Perseid Meteors

The Perseid meteor shower, an annual celestial event beloved by millions of skywatchers around the world, returns to the night sky this week, peaking late night on August 11-12 and continuing for several days through mid-August. And because the Moon will be in its crescent phase and setting in early evening, The weaker Delta Aquarid and Kappa Cygnid showers are also active during Perseid season, and there are always a few random, "sporadic" meteors. All of these track back to other parts of the sky.

Any light pollution will cut down the numbers visible. So will the radiant's lower altitude if you're viewing early in the night. But the brightest

no moonlight will hinder the viewing in the later evening hours.

Although an occasional Perseid meteor might catch your attention shortly after evening twilight ends, the prime viewing hours are from about 11 p.m. or midnight (local time) until the first light of dawn. This is when the shower's "radiant" (its perspective point of origin) is high up in your sky. The higher the radiant, the more meteors appear all over the sky.

To enjoy the Perseids, you need no equipment but your eyes. Find a dark spot with a wide-open view overhead. Bring a reclining lawn chair or a ground cloth so you can lie back and watch the sky in comfort. Patience will be needed—in a dark sky, with little or no light pollution, you could see an average of about one meteor per minute.

Perseids can appear anywhere and everywhere in the sky. Faint Perseids appear as tiny, quick streaks. Occasional brighter ones might sail across the heavens for several seconds and leave a brief train of glowing smoke.

When you see a meteor, track its path backward. If you eventually come to the constellation Perseus—which climbs the northeastern sky as the night progresses—then a Perseid is what you've just witnessed.

Occasionally you might spot an interloper.

Seniors

few meteors shine right through light pollution, and the few that happen when the radiant is low are especially long—skimming the upper atmosphere and flying far across the heavens.


Meteors are caused by tiny, sand- to peasize bits of dusty debris streaking into the top of Earth's atmosphere about 80 miles up. Each Perseid particle zips in at 37 miles per second, creating a quick, white-hot streak of superheated air. The nuggets in Grape Nuts cereal are a close match to the estimated size, color and texture of typical meteor-shower particles.

These particular bits were shed long ago by Comet Swift-Tuttle and are distributed all along the comet's orbit around the Sun. Earth passes through this tenuous "river of rubble" every year in mid-August.
