

City Council Hopes For Public Support on Business Tax Increases

Thanks to two payments from Chevron as part of a recent settlement agreement, the City of El Segundo will have a balanced budget in 2013/14. But for the following three years, staff estimates shortfalls of \$5.6 million, \$4.8 million and \$4.4 million respectively. The numbers include a \$2 million annual expenditure just to maintain a desired level of operations for equipment, facilities and infrastructure. The deficits are the product of slow revenue growth and almost nonexistent investment returns failing to keep up with rising expenditures fueled by continuing increases in pension and health benefit liabilities. The permanent loss last year of \$2 million in annual tax dollars from one major company because of a reporting change further compounded the City's problem. Even so, things could have been much worse. By deferring costs, minimizing salary growth and reducing benefits, the City has managed to chop over \$8 million in annual expenditures since 2008. And yet, that plus nearly \$6 million per year in new monies from Chevron won't be nearly enough to fix the budget.

During a strategic planning session last Thursday (the third such meeting in 2013), City Manager Greg Carpenter explained that two available options to cover the shortfalls are to make staffing cuts in all departments that will reduce service levels below acceptable parameters (including losing one of the community's two ambulances and taking police officers off the streets), or to outsource fire, police and library services to other agencies. To slightly lessen the staffing cuts, the City can also stop its annual \$1.1 million subsidy to local schools.

Realizing the severity of these options and the potentially adverse impacts on residents, the El Segundo City Council reluctantly

directed staff to take the next steps in putting transient occupancy tax (TOT) and utility user tax (UUT) increases on the ballot next April. These taxes apply to businesses only, but residents will ultimately make the final decision at the polls. The Council members plan to kick off an extensive public outreach campaign to explain to voters why they feel the tax hikes are necessary and what the community stands to lose otherwise.

At eight percent, El Segundo's current TOT rate is by far the lowest in a 12-agency comparison that includes the cities of Los Angeles, Long Beach, Santa Monica and Manhattan Beach, as well as LA County. An increase to 10 percent would generate \$1.2 million in additional annual revenues. Going to 12 percent (the average rate in the comparison) study would yield \$2.4 million. School Board Meeting Kicks Off the New School Year

Day one of the resumption of classes in the El Segundo Unified School District Tuesday featured the first School Board meeting since early July. Classes had officially begun earlier that day, with significant changes in the District leadership taking place.

Jim Garza is no longer the Principal at El Segundo High School, having been replaced by Ali Rabiei. And both of the District elementary schools have new leaders, with Liz Ramirez taking over at Richmond Street Elementary, and Martha Monahan now occupying the Principal chair at Center Street Elementary.

Superintendent Geoff Yantz made a special presentation early in the 60-minute meeting, which highlighted the progress made in the past year and noted challenges facing the District in the upcoming school year. "Summer is a always time for reflection" Yantz said. "And we often take a look at our goals and initiatives,

By Duane Plank and what we have accomplished this past year." Yantz's PowerPoint presentation highlighted some of the strides made in the past school year. His initial comments addressed the progress District-wide to help develop collaborative, critical thinking citizens who will take initiative and are self-directed.

> Yantz mentioned the growth of afterschool programs at the elementary school level; the immersion of students in all elementary grade levels in Spanish classes; the continuing process to move El Segundo Middle School towards full International Baccalaureate status; and the continuing emphasis at the High School to increase the internship opportunities available, as well as increasing enrollment in the Careers course.

Yantz spoke of the progress made in increasing achievement opportunities for all District students, including strides in enhancing the communication avenues for

Ask the Pharmacist: Caregivers, Take Care

(BPT) - Approximately 42 million Americans provide unpaid care to an ill or disabled adult and new research shows the stress associated with this responsibility can have a negative effect on a person's

research paired an analysis of prescription claims with a telephone survey of more than 12,000 commercially-insured Americans ages 18 to 65, and discovered use of medications to treat stress-related conditions, including high blood pressure, depression, anxiety and ulcers, is higher among caregivers. In fact, the use of anti-anxiety medications is 29 percent greater with caregivers compared to non-caregivers.

"As a member of the 'sandwich generation' I know first-hand how hard it can be to care for everyone who needs you, including yourself," says Paul Reyes, Express Scripts' pharmacist and host of the Ask the Pharmacist radio series. "But if your role as a caregiver negatively impacts your own health, no one benefits."

Caregivers are the unsung heroes of our healthcare system, helping many people live with dignity within their community. With the demand for caregivers expected to increase as baby boomers reach age 65 (the 65+ age group is expected to top 70 million in 2030), it's important that caregivers know how to prevent their important role from deteriorating their own health.

Reyes offers these tips for caregivers to keep their health on track:

• Practice healthy habits: Daily exercise and a good night's sleep can reduce stress and improve health. Those with a busy lifestyle can

start small by building in five to 10 minutes of physical activity into their day and going to bed a few minutes earlier each night.

• Make personal time a priority: Set aside time every day - even a few minutes - to socialize with family and friends,

read or meditate. If your loved one receives Medicare or Medicaid services, speak with a caseworker about respite resources for extended time off.

• Don't ignore depression: Understand what signals signs of depression: continuous low mood, low self-esteem, lack of motivation, neglecting hobbies and unexplained aches and pains. If you think you may be depressed, talk to your doctor immediately and consider caregiving support groups or professional counseling.

• Use online resources: At Express Scripts, their website and mobile app can make managing prescriptions for you and your patient easier, and reduce the administrative burden associated with care-giving. Home delivery can be a convenient way to receive medications and ensure you don't miss a dose, and specialist pharmacists, who understand your unique needs, can provide additional support and counsel for you and your loved one.

•Don't do it alone: Talk with your family members, friends, neighbors, your religious community or local civic organizations like the Boy and Girl Scouts of America - about available support services. The Department of Health and Human Services has an online resource to help connect caregivers with locally available support services. •

However, prior discussions about raising the TOT prompted outcry from hotel operators worried about losing their competitive advantage.

At three percent (two percent for phone, which will not be affected), El Segundo's UUT rate is also the lowest of the comparison cities and well below the seven percent average. Raising it to four percent equates to \$1 million in new annual revenues. Going to five percent adds \$2 million. In 2010, El Segundo voters rejected a measure to raise the UUT by one percent despite business community support of the initiative.

Pointing out that any tax increase is a hard sell in El Segundo, Councilmember Dave Atkinson suggested tacking on an additional percent to each of the above (going to 13 percent on TOT and six percent on UUT) and earmarking that extra percent to El Segundo Unified School District. The resulting \$1.6 million would provide schools with \$500,000 more than they now receive through the annual City contribution. That in turn can also free up the \$1.1 million that the City normally spends on schools for much-needed and long-delayed infrastructure projects.

However, City Attorney Mark Hensley explained that specifying a portion to go to schools makes the measure a "special tax" requiring two-thirds voter approval as compared to a general tax that only needs a simple majority. To remedy the situation and avoid a difficult two-thirds requirement, the measures will likely be written as "advisory" taxes in which voters suggest setting aside one percent for schools (though it's non-binding and cannot be guaranteed).

The Council will additionally look to get voter approval for a parking tax on airport lots (at 10 percent of gross receipts based on 2012 numbers, this would yield \$295,000 annually). It will also likely eliminate the sales tax credit (STC) through which companies can offset a portion or all of their business license tax (saving another \$900,000). Downtown businesses will be allowed to continue taking advantage of the credit, however. The three tax hikes together with the STC savings add up to the \$5.6 million needed to structurally balance the budget in 2014/15 and beyond.

During last Thursday's meeting, the Council saw charts showing the total cost of doing business in El Segundo--including real estate--for different categories ranging from small restaurants to large manufacturers. Figuring in the proposed UUT increase and loss of STC, the ratio of City taxes compared to rents was still nominal, running as low as 4/10ths of a percent with the worst case 7.4 percent for a large manufacturing company. 'When you look at the full absorption of costs, we're still lower or average," said Mayor Bill Fisher. "If we're ever gonna do this [ask for tax increases], that's the info we've got to get to the public."

Emphasizing that he is not in favor of raising taxes and expects to receive some backlash from developers and hotels, Fisher deemed the alternatives much worse. "We don't want to lose our fire department and cut funding to our schools," he said. "If that info gets out to the public, I think we'll have the school district behind it [the tax measures] and our senior citizens."

By covering the next few years of deficits and also providing for schools and infrastructure repairs in the process, Atkinson hopes the City will be able to stay ahead of the curve for the long term. "I'm the last guy in the world who likes taxes," he said. "But reality is reality... This is our chance to fix it. It's up to us to do it."

Staff will return to the Council either September 17 or October 1 with potential sample ballot language and to confirm other specifics about the measures before a final decision is made. Coping with Expensive Kids' Extracurricular Activities

When budgeting for back-toschool expenses, parents generally include routine fare like clothes, school supplies and maybe a new backpack. But if your kids participate in extracurricular activities, whether it's sports, music lessons or art classes, you could be on the hook for hundreds – or even

thousands – of dollars in additional expenses throughout the year if you're not careful.

As parents, we hesitate to stifle our children's athletic and creative urges, especially when it can be so difficult to drag them away from their iPods and Xboxes. But sometimes you've just got to step back, weigh the different options available and decide what you can afford without upsetting your other financial goals and responsibilities.

You'll face tough questions like, "Is it better for my child's future to spend \$500 on a soccer day camp he'll really enjoy or to invest the money in a 529 College Savings Plan?"

My wife and I commonly wrestle with these types of questions. For example, last fall our son had outgrown his baseball equipment and was begging us for a new bat that cost \$125. A year later, it sits on the sidelines because he prefers to use a friend's bat. (We're not complete pushovers, however: When he recently obsessed over a \$200 pair of hightech gym shoes, we said no.)

Among the best advice I've received from other parents is, when your kids are exploring new activities, don't overcommit your time or money until you know whether they'll stick with it or quickly move on to the next thing.

For example, before you sink a small fortune into private swimming lessons, start



small with a summer class at your local Y or recreation center. If your kid shows a genuine aptitude and doesn't balk at long hours of practice, then you can explore more costly alternatives. Just remember who'll be driving to practice and out-of-town swim meets; in other words, make sure you can honor the time commitment before signing on.

Here are a few tips for prioritizing extracurricular events and keeping your costs down:

Focus on one sport or activity per kid, per season, especially if they involve multiple practice sessions or games per week.

Form carpools with other parents. You'll save gas money and time, especially if your kids are practicing at different locations.

Learn how much equipment and instruction the sport requires. Some, like soccer and basketball can be relatively inexpensive; while others, like horseback riding, golf and ice skating involve expensive equipment or facility rental time.

Rent or buy used sporting equipment (or musical instruments) until you're sure they'll stick with the activity. Visit Play It Again Sports stores, online ad sites like Craigslist and yard sales.

Seek out or form a sports equipment exchange in your community where families can donate outgrown or cast-off equipment and uniforms for others to use.

It's probably better to invest in new safety gear, like helmets and masks, than to buy it used - and potentially damaged. The same goes for items like shoes or baseball gloves that become molded to a child's body – unless they were hardly used. •

Bill Seeks to Acknowledge Everyone's Role in History

Assemblyman Rob Bonta wrote Assembly Bill 123 he wasn't attempting to rewrite or distort history. The bill intends to do something that should have been done a very long time ago--require our public school system to educate our students about the role, contributions and influence of Filipino Americans to the farm labor movement. When we think about the farm labor movement of the 1960s, people like Cesar Chavez and Dolores Huerta come to mind. Their struggles and contributions to the movement were priceless, but the influence of the Filipino American community was just as crucial to the movement as was the leadership of Huerta and Dolores.

People like Larry Itliong, Pete Velasco and Philip Vera Cruz were all key figures in the farm labor movement in California, yet our state's curriculum does not dedicate attention to their contributions. Their leadership came at a critical turning point in the farm labor movement and it is unfair that children in our public schools are not learning about these leaders. Our state has always attracted people from all over the country and the world in search of a better life. Every now and then certain individuals endure great hardships to ensure that others have the opportunity to attain a better life. Requiring the State Board of Education (SBE) to ensure that curriculum includes information on the role of all immigrants, including Filipino Americans, in the history of the farm labor movement will help us to honor and respect our state's history.

If we continue to ignore the influence of people like Itliong, Velasco and Cruz, we are failing our public education system. I remember going through high school learning about many aspects of American history such as the Civil War. In high school we learned about leaders from the North such as Abraham Lincoln and Southern leaders such as Jefferson Davis, but it wasn't until college that I discovered who Santos Benavides was and what he accomplished. Benavides was the highest ranking Mexican American to serve in the Confederacy (http://www.tshaonline.org/handbook/online/articles/fbe47).

It is wrong that in our school curriculum, the role of such people gets lost and we can go through the entire K-12 system without ever having heard about a Benavides, Itliong, Velasco or Cruz. Bonta's bill is not asking that our state's board of education distort our history. The bill simply wants to acknowledge the efforts made by all the different groups of people who have contributed to our state's and nation's history. Particularly in California with how big the farm labor movement was, it makes little sense to dedicate part of our curriculum to that labor movement and not acknowledge the work and sacrifice made by the Filipino American community. When we ignore history and those who shape the events of our past, we are committing a great disservice to ourselves. By acknowledging everyone's role in our history, we become better informed--and there is nothing wrong with knowing more about ourselves. •

The From the Source question of the week was: Governor Brown recently signed into law AB1266, giving transgender children in K-12 the right to select the gender of their sports teams and selection of their locker rooms. How did you vote and why?

Assemblyman Steve Bradford's office responded that the Assemblyman has been out of town and was not available for comment, but did vote in favor of the bill.

Senator Ted Lieu responded: "I received an excused absence on July 3 and was not present during the floor session. If I was on the floor, I would have voted 'yes' on AB1266. I believe children should not be discriminated against based on who they are."

Assemblyman Al Muratsuchi did not respond to our question.

Senator Roderick Wright responded: "I did not cast a vote on AB 1266 because I had too many questions about its potential impacts that the author and proponents were unable to answer. As a former high school athlete and longtime supporter of the CIF Track and Field Championships, I wanted to know how this would impact record-keeping in high school athletics and how it would affect students as they tried to secure scholarships to pursue higher education.

"If a biological male competed as a girl, would that create a playing field in which females could not compete? If that young man broke a female record, would that be recognized only within California? Would our students be kept from reaching national levels of competition and therefore go unseen by national college scouts because of our vote? How would issues such as steroids be addressed? How would Title IX scholarship programs be impacted?

"Efforts to pursue equality and stamp out discrimination are always a positive endeavor. But I was not asked to vote my feelings on a concept. The bill put before me and the legislature did not address my many questions and concerns.

"Many young people from lower-income neighborhoods in the communities I represent have worked very hard--on and off the sports field-- to set themselves apart in the quest for scholarship opportunities to pursue higher education and better their lives. Now that this bill was passed and been signed into law, I can only hope that regulators will keep those children in mind and implement the measure in a way that is responsible to them and their efforts." •



/ his past weekend, I was catering a party and the client wanted some sort of pizza bites for the kids. That day, I was driving and heard a comedian on the radio saying he was shopping and saw French bread pizzas and four-cheese French bread pizzas for sale. They were the same price! He said sometimes he just felt that one cheese was not enough, but four was just overkill.

I thought of the irony of that and made the bites like French bread pizza.

My twist is that I make a garlic butter to toast the bread first. Then I top it with sauce, cheese and what ever else you want!

Pizza Bread



Garlic Butter

1 pound unsalted butter

2 cups olive oil

1/4 cup granulated garlic

2 tablespoons each: Kosher salt, black pepper, dried basil leaves, chili powder

Warm the butter and oil in a saucepot till the butter is all melted.

Then add all the dry ingredients.

The Bread

Cut a large loaf of French bread in half. Set it on a sheet pan. Coat the bread with the garlic butter and toast in a 350-degree oven for 4 - 6 minutes or till golden brown.

Remove from oven and top the bread with sauce, cheese and toppings of your choice. Place back in the hot oven and bake till cheese is bubbling and golden brown.

This garlic butter can also be used as a topping for broiled fish, on steak or chicken, or to sauté veggies or flavor rice or pasta. •



Babe Ruth All-Stars Win World Series

The El Segundo Babe Ruth League has sent seven teams to the 13-15 Babe Ruth League World Series--winning it in 1964, 1969, 1974 and 2002. This year's 13-year-old All-Star squad marks the eighth team to reach the World Series and the league's first at that age group.

El Segundo faced teams from Rhode Island, Texas, North Dakota, Oregon, New York and Tennessee. It outscored opponents 52-18, including the win over Lawrenceburg, Tennessee 11-1 in the championship game to win the 2013 Babe Ruth World Series.

The All-Stars won their opening pool play game against Coventry, Rhode Island 9-4. Joey Acosta started for El Segundo and went four-plus innings, giving up four runs on eight hits while striking out four. Michael Graner sparkled in relief, allowing just one base runner the rest of the way.

With the score tied 2-2 in the fourth inning, El Segundo took the lead. Acosta, Sean Emery and Chris Penna each singled to load the bases. Spencer Song's two-run single gave the Pacific Southwest Regional champs a 4-2 lead. In the fifth inning El Segundo broke the game open, scoring four runs on five hits. Jacob McBride singled and Spencer Long doubled before Acosta's two-run single made it 6-2. Emery had an RBI single and Song's RBI double made it 8-2. Coventry, the New England Region champion, scored two runs in the bottom half of the fifth to close the gap, but that's as close as it would come.

El Segundo moved to 2-0 in pool play with a 12-6 win over Weimer, Texas. Trailing 3-2 in the second inning, El Segundo sent 12 batters to the plate to score eight runs. The All-Stars took advantage of three hit batters, two walks and three hits to take a 10-3 lead. Brendan Casillas, McBride and Long were each hit by a pitch with Graner reaching base on an error. Acosta, Emery and Graner had RBI singles in the inning.

Weimer, the Southwest Regional champions, had two-out rallies to score in the first three innings and came up with two runs in the fifth inning to trail 10-6. In the sixth inning, Weimer loaded the bases with one out. Graner, who replaced Long on the mound, got a strikeout and an easy ground ball to snuff out the rally.


In the sixth inning, Graner and McBride each walked. Acosta's sacrifice fly ball scored Graner and Raymond Bautista's RBI single scored McBride to give El Segundo a comfortable 12-6 lead.

El Segundo battled back from a 5-2 deficit to defeat Tualatin, Oregon 9-5 in the third game of pool play. The locals scored six unearned runs on five hits in the top of the seventh inning to take the lead.

Justin Ostler had a shaky start in the first inning and the Pacific Northwest Regional champions took advantage. Ostler walked four, had two wild pitches and gave up three runs on one hit and an error. In the second inning, El Segundo loaded the bases with one out. They

RBI singles by Penna and Nico Celestial gave El Segundo the 9-5 lead.

Graner threw the seventh and benefited from starting the game-ending double play to earn the save, while Bautista got the win in relief of Ostler.

failed to score when McBride and Long hit consecutive infield pop-ups to end the inning.

In the third inning, Acosta doubled, Emery walked and Penna had a run-scoring single to make it 3-1. Casillas' RBI single scored Emery, closing the deficit to 3-2. Tualatin responded by scoring two runs on one hit to increase its lead to 5-2.

In the fifth, El Segundo looked to have a big inning when Penna scored on Song's double. With two outs, Bautista and McBride each walked to load the bases, but El Segundo failed to score when Long's deep fly ball was caught to end the inning.

In the seventh inning trailing 5-3 with two outs, Josh Sheck had a pinch hit single. McBride hit a ball to the shortstop for an error and Long walked to load the bases. Acosta then blistered his fifth hit of the day up the middle for a two-run single to tie the game. Emery followed with a two-run single to make it 7-5.

Manager Bob Motta said afterwards that the unsung heroes really came through in the clutch. "Raymond [Bautista] kept us in the game, Josh [Sheck] kept the game going and Michael [Graner] was once again solid on the mound," he noted. "And what more can you say about Joey Acosta?"

The 8-1 win over Fargo, North Dakota propelled the All-Stars into Friday night's semifinal game against Niskayuna, New York. El Segundo ran its record to 4-0 in American League pool play of the World Series, outscoring its opponents 38-16 and racked up 53 hits in four games.

Against Fargo, the All-Stars came up with two runs in the first inning when Long and Acosta both singled and later scored. In the second inning, the lead increased to 4-0. Bautista walked and scored on Long's RBI single. Acosta then singled up the middle,

Leading 4-1 in the fifth inning, Song singled and scored on Sheck's double to increase El Segundo's lead. In the sixth inning, Ostler had a pinch hit double and scored on Long's second RBI single of the game. Penna, hitting for Song, tripled in Long and Celestial's RBI double gave El Segundo the 8-1 lead.

Acosta, hitting a robust .705 (12 for 17) during the World Series, went two for four. Long led El Segundo's offense, collecting three of his team's 11 hits.

Song started and went three innings, while Sheck finished up and looked reliable in relief. El Segundo's pitching staff was well rested for Friday's semifinal game. Motta said he wasn't sure who would start Friday. He had Acosta, Long and Ostler to choose from and all three showed throughout the summer they could be tough to beat. "It's a nice problem to have, but we're here for one thing and whoever we think gives us the best chance to win will start," said Motta.

For a chance to play for a World Series championship, El Segundo defeated Niskayuna, New York 3-2 in the semifinal to advance to the championship game against the Southeast Regional champions, Lawrenceburg, Tennessee.

El Segundo jumped out to a 2-0 lead in the first inning when Long tripled and Acosta nailed a fastball up the middle for an RBI single. Acosta came around to score on Penna's RBI single to give the Pacific Southwest Regional champs the lead. In the fourth inning, Acosta doubled and later scored on a wild pitch to give El Segundo a comfortable 3-0 lead.


Acosta, who started for El Segundo, was on in the early going, but Niskayuna put together a rally before knocking Acosta out of the game. Liam Davison was hit by a pitch before backto-back singles by Ben Funyak and Connor Graham to load the bases. Davison scored on an error to close the gap to 3-1.

Graner came in to get a force out at the plate and then induced Mathew Toy to hit into an inning-ending double play. In the seventh inning Graham walked, stole second and scored on Funyak's single. Graner got Daniel Sheely to hit an easy ground ball to Long to end the game.

Motta said that Niskayuna's pitching staff was tough to figure out. It showed with El Segundo getting just five hits, but the All-Stars made the most of them. "We got the key hits early in the game and we played solid on defense," said Motta.

Before the series started, Motta was asked by a reporter what he expected from his team and his response was to be playing on Saturday (in the championship game). In front of over 800 people in person and over 6,500

both parents and students. One example given was the creation of a single Power school login for each family, which should greatly aid parents who have multiple students in the District and allow them to more easily monitor each student's progress.

Next, Yantz discussed the ongoing progress to maintain and improve District facilities. He noted that the residents have made a very significant financial investment in these, and that he is keenly aware of the need to maintain and upgrade the facilities as needed in a cost-effective manner. He mentioned a renegotiated contract with a new maintenance company to assess the current landscape maintenance needs and planned improvements; the management of long-term

investment in programs, employees and the District's overall financial security.

Prior to Yantz's presentation, the Board members witnessed the swearing in of the new student representative to the Board, Malcolm Au. After taking his oath of office from Board President Ann Coles, Au gave his first report to the Board, highlighting the ramp-up to the first day of school on District campuses, as well as the positive activities that took place on the first official day of school.

With no discussion items on the agenda for the first meeting of the 2013-14 school year, the five Board members, led by Coles, tackled the consent agenda, which featured the approval of several consultant agreements.

deferred maintenance at all District-owned facilities; the installation of a new, high-tech Voice-Over-IP phone system in all District facilities; and the continuing investment being made leading to the development of a networking infrastructure to support what is termed the "next generation" classroom for teaching and learning.

Yantz also spoke of the progress being made towards keeping the District coffers healthy and physically solvent. The number one bullet point item in that area centered on securing a long-term lease for the Imperial Avenue School property to help maximize assets and return to the District. Yantz said the property evaluation process has been ongoing for the past six or so years, and that progress is being made to arrive at a disposition that will be financially favorable to the District bottom line and student opportunities.

In conclusion, Yantz repoted that some of the "next steps" on the District agenda are to negotiate the Imperial property lease; provide continuing support for the new administrators, faculty and staff; and maintain a balanced The Board also accepted gifts during the action item portion of the meeting, including multiple donations from the Middle School PTA to help fund iPads for teachers, the Spanish program--including software--and the purchase of physical education equipment. The accepted gifts totaled nearly \$14,000.

Also approved during the action item portion of the agenda were agreements with Ricoh Business Solutions, which, according to District-provided documentation, will save \$770 per month when the company replaces current copiers with a similar multi-functional copier.

With six weeks between official Board meetings, the members spent a few extra minutes to give their summer reports. The overall theme of the member's reports was to welcome back students to campus learning and point out the overall positive attitude they had observed in the past couple of weeks as the teachers, students, parents and administrators prepared for the 2013-14 school year.
