Council Honors Babe Ruth Winners, Views Budget & Plaza Project

On a night when the meeting began with the singing of Take Me Out to the Ballgame in honor of the recently crowned 13-year-old Babe Ruth All Stars World Series champions, the El Segundo City Council heard from nearly 20 speakers about the TopGolf proposal, received the 2013/14 budget presentation, and took the first step to finalize approval of the next phase at Plaza El Segundo.

All five Council members wore t-shirts commemorating the first local Babe Ruth team of that age group to win a title (and fifth overall in community history), as the 14 players and four managers each received proclamations for their accomplishments. The team went 17-2 in its historic run, outscoring opponents 200-71 in the process over several tournaments that culminated in a World Series victory in Williston, North Dakota where El Segundo had gone undefeated. Manager Bob Motta called the achievement "a team effort with every player contributing."

Though not on the agenda, TopGolf's proposal for The Lakes at El Segundo again dominated public communications, with only two individuals indicating support of the project. Among the stated concerns, speakers (the majority from neighboring communities) worried the facility would turn into an adult entertainment complex with excessive alcohol consumption and thus lose its family-friendly environment, would drive away serious golfers and lose its base clientele, would be too expensive, and would fall below revenue projections. "If you guys change The Lakes, we won't be there anymore," said one member of the Mira Costa High School girls' golf team. On the flip side, local resident and project proponent Ron Swanson noted that the golf

course will still be controlled by the City, youth and instructional programs will stay put and the concept won't be a passing fad. Due to Brown Act provisions, the Council was not allowed to comment on the topic. However, Councilmember Dave Atkinson emphasized that The Lakes' decision "is not a done deal" and will take more time

Thanks to a large payment from the Chevron tax resolution, the City will enjoy a small budget surplus in 2013/14. On Tuesday, Finance Director Deborah Cullen went over the latest numbers two weeks before the Council adopts the final document. The Chevron payment wiped out what would have been a \$2.9 million deficit—instead resulting

South Bay Bids Farewell to **John Parsons** (1953-2013)

Mourners from across the South Bay and beyond--including a veritable who's who of area elected officials and community leaders--were in attendance last Friday to say goodbye to John Parsons, the Redondo Beach City Planning Commissioner and former City Councilman who passed away on August 22 at the age of 60. Parsons was hospitalized at Little Company of Mary Medical Center in Torrance after suffering a stroke towards the end of the August 20 Redondo Beach Council meeting where he had just spoken. Services took place at the American Martyrs Church in Manhattan Beach with a reception immediately after at the Redondo Beach Performing Arts Center. In keeping with the family's request, many of the funeral-goers arrived in Hawaiian-style attire.

In addition to his activities in Redondo Beach where he was also a Chamber of Commerce board member, Rotary Club President and Harbor Commission

By Brian Simon Chair, Parsons also served for the past year as Business Services and Economic Development Manager for the South Bay Workforce Investment Board (SBWIB) that represents the cities of Carson, El Segundo, Gardena, Hawthorne, Hermosa Beach, Inglewood, Lawndale, Manhattan Beach and Redondo Beach. On the board of directors for that agency for nearly two decades, Parsons also worked for SBWIB in 2009 to connect high school STEM (science, technology, engineering and math) students and businesses. Under his latest title, he provided information to businesses about the various programs available to them and in recent months presented indepth reports about SBWIB's offerings at a number of area city council meetings. "He helped in many more areas outside of his job description," said SBWIB Executive Director Jan Vogel. "He was somebody you could talk to who would listen, come up with good ideas and do whatever needed

to be done to move the organization forward. He was a unique individual and a good man."

Vogel went on to say that few people he has ever worked with matched Parsons' honesty, integrity and commitment to the community. "Also, John knew everyone--particularly in the beach cities," Vogel said. "You can't replicate that. It takes years and years of being connected. He did it and really wanted to make those cities better."

Parsons' connections proved instrumental in the successful campaign to keep Los Angeles Air Force Base in El Segundo that culminated in 2005. He chaired the Los Angeles Air Force Base Regional Alliance, raised funds for the cause and traveled to Washington on a number of occasions to lobby military and Congressional leaders. "His efforts saved thousands of jobs and businesses, and maintained a higher quality of life in Southern California," said El Segundo City Councilmember Suzanne Fuentes, who described Parsons as a "wonderful friend and mentor" with a "kind and generous heart." Over the past year, Parsons communicated frequently with Fuentes to build awareness about the impacts of the across-the-board federal spending cuts known as sequestration. "John Parsons was a public servant in the truest sense--even when he wasn't holding an elected office, he worked and advocated tirelessly on behalf of our region and its aerospace industry," added Fuentes. "John continued to strategize with local leaders and Congressional representatives to avoid the negative impacts of sequestration, continue resolutions and save LA Air Force Base from the next BRAC [Base Realignment and Closure] round. I will continue his work on behalf of our region."

Former Hawthorne Mayor Larry Guidi noted that Parsons always did what was right for the community and never worried about the next election. "I had the privilege to work with John for over 15 years and the first thing I found out was it took a lot to make him angry," Guidi said. "If John believed in a cause, it was like the song from Johnny Cash... 'I hear the train a-coming.' John showed his political power when he, [the late El Segundo] Mayor [Mike] Gordon and I took on the government when they wanted to close the LA Air Force Base and we won. The second biggest fight we had was over a year ago when we took on Sacramento to stop cutting One-Stop funding and divert funding. I never saw John so angry at Sacramento lawmakers. His personality as being cool helped when he got mad--they knew it was a cause worth fighting for. John was not another opportunist that used his position for his personal gain."

Though especially known for his contributions in regards to LA Air Force Base, Parsons also played vital roles in the fight to retain the 310 area code, the establishment of the South Bay Environmental Services Center, and coordination of city efforts with various key transportation projects, among other achievements. "He was passionate and able to build consensus among his South Bay city colleagues," said South Bay Cities Council of Governments Executive Director Jacki Bacharach, who noted that Parsons also served on that agency's board in 2004. "We have all lost an outstanding South Bay leader."

Parsons was also often the "go-to guy" for prominent emcee duties, recently serving in that capacity for Senator Ted Lieu's State of the State Address in El Segundo—and he was a trusted moderator at a number of area candidate forums held prior to municipal elections. In recognition of his public service, Parsons not only personally received numerous awards over the years, but even had one named after him—the South Bay Association of Chambers of Commerce's John J. Parsons SBACC Business Citizenship of the Year Award.

Raised in nearby Westchester, Parsons graduated from St. Bernard High School in Playa del Rey and went on to attend El Camino College and USC. He spent his early career in the aerospace industry, working for Hughes Aircraft in El Segundo where he eventually headed an engineering department. He shifted gears in the late '80s, moving into real estate and eventually enjoying a 20-year run with Horrell Realtors before taking the job with SBWIB. Parsons and his wife Mary Ann also moved to Redondo Beach in the '80s, where the couple raised two daughters. In his honor, the family has established the Redondo Beach Rotary Club John Parsons Scholarship Fund to help local students. Those inclined may make donations at P.O. Box 411 Redondo Beach CA 90277.

"He was a great guy--very engaging, friendly, always wanting to help and always there at important meetings South Bay-wide," said El Segundo Mayor Bill Fisher. "His public service record was incredible and his work specifically in the retention of LA Air Force Base was a huge benefit to the entire region. He was a wonderful friend to El Segundo and the entire South Bay and we will miss him deeply."•

Add Eye Exams to **Back-to-School Preparation**

As summer winds down and children are getting ready to go back to school, on the list of things for parents to check off should be an annual eye examination. While we're looking for deals on notebooks and pencils, the the way they see is the way everyone sees. Signs that may indicate a vision problem include frequent eye rubbing or blinking, short attention span, avoiding reading or other close activities, frequent headaches, covering or closing one eye, tilting head to one side, holding reading materials close to

assurance that our children's eyes are healthy and that they have good vision is priceless.

Current optometric guidelines for standard eye examinations are at six months-old, three years-old, five years-old, or more frequently, if at risk. An easy way to remember these time points would be prior to your child's first birthday, prior to entering preschool and prior to entering kindergarten. Having eye examinations at these major milestones will help give children the best opportunity for growth and development, as good vision guides their learning experiences.

Many experts state that 80 percent of what children learn in school is visually presented. Vision is more than just the ability to see clearly, or having 20/20 eyesight. Vision skills required for effective reading and learning include: seeing clearly at all distances, ability to change focus quickly at different distances, eye tracking, coordinating and using eyes together, eye-hand coordination, and organizing images into ideas. At a comprehensive vision examination, the optometrist should check all these visual skills, as well as assess eye health, which may include a dilation of the eyes. It is important to note that a vision screening is not the same as a comprehensive examination by an optometrist.

A child may not tell you that he or she has a vision problem because they may think that face and losing place while reading.

Farsightedness makes it difficult to see near objects, such as books or computer screens. It is common in young children and an excess amount can lead to a condition called strabismus, which is a crossing or deviation of one or both eyes. Untreated, strabismus can lead to amblyopia, or lazy eye. Nearsightedness makes it difficult to see distant objects, such as the blackboard or soccer ball. Astigmatism results in blurred vision of both near and far objects. Most of these conditions can be treated with glasses or contact lenses. In the case of weak focusing muscles, a program of eye exercises called vision therapy may be considered. Early detection of these disorders is essential, when they are commonly more treatable.

Children's eyes are exposed to three times the amount of UV radiation than the average adult. Because UV damage is cumulative over a lifetime, it is important to begin using quality sunglasses at a young age.

While back to school is an excellent time to assure that your children's eyes are ready for the demands of the coming school year, scheduling an annual eye examination is a good idea at any time of the year. Parents will come away with the peace of mind that their children are best utilizing the basic visual skills required to enjoy and thrive in the many activities of their daily lives. •

Park Vista Still Going Strong at 26, Looking for Community Input

The Senior Citizens Housing Facility better known as Park Vista celebrated its 26th anniversary on August 24 by throwing its annual bash for the residents, with City officials and other community members also in attendance. The festivities featured a live band, pot luck, raffle and special recognition of the four remaining "Pioneers" who moved into Park Vista when it first opened in 1987 and have lived there ever since. One of the Pioneers, Donna McCarthy, was a prime organizer of this year's event, along with Irene Sierra and other Park Vista tenants who are members of the aptly named "Seniors on the Go" club.

Located at 615 E. Holly Avenue, Park Vista consists of a five-story and a four-story wing with a total of 97 single and one-bedroom units, balconies overlooking Recreation Park and three different floor plans available. The complex also features an exercise area, media room, recreation room and outdoor patio.

Funded with surplus monies in the early 1980s when the City of El Segundo enjoyed happier financial times, Park Vista was the result of local voter approval for a low-income independent living housing facility for seniors. The idea turned out to be a good one, as the complex continues to be full—with 115 mostly single tenants in place and a waiting list of several dozen people. To qualify for residency, the combination of five percent of an applicant's total assets plus annual income cannot exceed \$45,000 (or \$50,000 for a couple). They must also show a period of prior El Segundo residency and be at least 62 years old--though a spouse or significant other as young as 55 can live with the applicant.

A year before the 1987 grand opening, the City established the seven-member Senior Citizen Housing Corporation Board to "actively oversee the management, operation, maintenance and finances of Park Vista." The Board enlists a management company to operate the facility, with the El Segundo-based Cadman Group now in that capacity for the past eight years. Resident manager Jim Maynard, also on-hand since 2005, oversees day-to-day issues and coordinates routine maintenance for the facility.

Despite a small increase a few years ago, the residents still enjoy rents about half the amount of single or one-bedroom apartments elsewhere in El Segundo. Those rents are sufficient to keep Park Vista operating in the black with enough funds in the reserves to cover major items such as new elevators last year and a \$350,000 roof replacement project this fall, as well as recently purchased upgraded furniture for the common area. Meanwhile, the close-knit tenants regularly get together for afternoon coffee, Thursday night bingo, Friday happy hours, Saturday night movies, and monthly potlucks, among other activities that keep them engaged.

Yet even with widespread resident praise for the facility and its operations, the Senior Housing Board refuses to rest on its laurels. The group has begun to reach out to the community seeking input and opinions about the future of senior housing in El Segundo. "The Board will be conducting a community survey that is now available at the Joslyn Center, Park Vista and the El Segundo Public Library," said City of El Segundo Recreation Superintendent Meredith Petit.

Petit also asked residents of the facility to fill out forms that included questions about when they moved in, why they love living at Park Vista, and their fondest memories while living there. McCarthy, now 88, was one of the first to respond. "What a place to spend my 'retirement' years!" she wrote. "Who else has our beautiful Rec Park for a front lawn? My rent is reasonable, my maintenance problems are taken care of and the laundry room is just downstairs. As a bonus, I get to indulge in my favorite--decorating the lobby and great room for all holidays."

As for the future of senior housing in El Segundo, questions still remain about the long-discussed plans to build an assisted living community at the vacant site at 540 E. Imperial Avenue owned by El Segundo Unified School District. Park Vista is strictly an independent living facility, though tenants may have a caretaker visit to help with health issues.

In March 2012, the El Segundo City Council approved two alternatives for potential development on Imperial Avenue-with the preferred option a complex with a maximum of 150 assisted living/independent living units and 150 senior apartments/condominiums (age 55 and older) and four apartments/condominiums. The other concept is a residential development with a mix of 24 single-family and 34 multifamily dwelling units. "There has been some discussion about a third project option, but we don't have the details of that proposal," said Petit. If the assisted living development moves forward as many hope, it can allow some lifelong El Segundo residents to remain in town when the day comes that they can no longer take care of themselves. •


As Commander-in-Chief, there is an expectation that in times of crisis the President make decisions within an instant's notice. However, this crisis in Syria did not happen in an instant's notice. We have seen these issues unfold and the crisis worsen, so why shouldn't President Obama consult Congress before acting? Fortunately there are members of the Democratic Party asking the President to not act without consulting Congress. Rep. Jim McDermott from Washington and Rep. Barbara Lee from California are part of 12 liberal Democrats who have signed a letter asking the President to seek an "affirmative decision" from Congress before engaging militarily in Syria.

in a \$2.7 surplus. In order to conform with a policy requirement to maintain reserves at 17 percent of expenditures, staff then applied the bulk of the surplus to shore up that account—leaving a final estimated surplus of \$367,000 (which will be applied to the economic uncertainty fund).

Despite the short-term good news, Cullen warned that general fund revenues will only grow at two percent as compared to an 11.5 percent expenditure hike next year. Culprits for the cost rise include increases in salaries, pension liability, and retiree health. Meanwhile, many tax revenues will remain flat. Cullen added that the City relies on business taxes for the lion's share of its general fund revenues—including one-third from the top 10 companies alone.

The public got its first detailed look at Phase 1B of Plaza El Segundo, known as The Point, as Planning and Building Safety Director Sam Lee and property owner Federal Realty's Senior Director of Development and Acquisitions Jeff Chambers provided PowerPoint overviews of the coming project up for final Council approval in two weeks. A larger project than one approved in 2008 by the Council for that

in a pedestrian/promenade experience. For tenant comparison purposes, he pointed to San Jose's upscale Santana Row complex, which Federal Realty also owns. Restaurant/ retail will make up 92,000 square feet of The Point, with the remaining 28,000 devoted to second floor office uses. Chambers displayed various color renderings of the proposed project, describing the design as "contemporary beach casual style" with distinctive and customized storefronts, a large landscaped public plaza, raised stage for community events, multiple kiosks, large patio, fountain, grass expanse, pond, and kids play/climbing areas.

Consultant analysis of the updated project revealed no increase in environmental impacts and that vehicle trips will fall within accepted parameters. Once the Council approves the amended project uses and development agreement (the members agreed to the environmental impact report addendum on Tuesday), the applicant will commence grading and retaining wall construction by the end of this month and overall site construction in October. Building construction will begin in early 2014, with tenant construction by the fourth quarter of that year and a grand

location, The Point will feature four buildings (three single-story adjacent to Sepulveda and Rosecrans, plus a two-story by the railroad tracks) totaling 120,000 square feet on 13 acres, with 645 parking spaces and an open promenade area geared for public gatherings. The prior project called for 70,000 square feet on 8.1 acres. An agreement between Federal Realty and Chevron paved the way for signalized access at Rosecrans and Village Drive, seen as a vital step in the process. An arrangement with the Regional Water Board will allow a former chemical plant site to be converted into a parking lot and thus circumvent potentially tricky environmental issues.

While he couldn't divulge the names of future tenants, Chambers said the center will feature chef-driven restaurant concepts that are not typical chains, high-end retail merchants not currently in the trade area, and firms interested

opening slated for the second quarter of 2015.

Chambers estimated The Point will generate \$50 million in annual sales (and \$500,000 in sales tax revenues), create 700 jobs when up and running, and provide \$1 million in fees for the City as well as an increase in the property tax base. Federal Realty acquired Plaza El Segundo at the end of 2011. Noting the firm is a \$9 billion, 50-year-old company that owns 90 retail centers, Chambers said there is nothing holding Federal back on the financial end and that it has no plans to ever sell the property. "Boy, it's been a long time coming," said Mayor Bill Fisher of the project.

Fisher adjourned Tuesday's meeting in honor of the late John Parsons, the former Redondo Beach City Councilman and civic leader who was a key figure in the retention of Los Angeles Air Force Base. Parsons died on August 24 after suffering a stroke. •

 \leq ummer vacation is over, the kids are back in school, and all is well. Or is it?


Now, we have the rush of morning, the confusion of homework, the after-school activities,

the angst of peer pressure, and of course, what's for dinner. Try to make it a one-pot meal. This is my favorite way to cook.

My mom tells the story of me pulling a chair up to the stove so I could reach the pot in which I was cooking lunch for all of my friends in the 'hood. I would go into my friends' houses and raid their mom's pantry to create what we called "Michael's Goulash." It would consist of Campbell vegetable soup cans from another kid's house, then maybe some leftover meat or cold cuts from another house. I would heat it all up, make some toast and top the whole thing with cheese. With this and some cold drinks, we were rockin' it.

Now, I make for my kids my sort-of-grown-up goulash. Here it is:

The Chef



Dad's Goulash (or the "one pot that's good for 3-4 days")



2 pounds course ground beef, turkey, chicken, pork or a mixture of all

- 2 large onions, diced
- 1/4 cup vegetable oil
- 2 medium zucchinis sliced in rounds
- 1 pound of sliced mushrooms
 2 each 15 oz cans of diead towart
- 2 each 15 oz. cans of diced tomatoes
- 3 cups chicken broth Salt and pepper

Seasoning

This is where it gets tricky. Depending on your crowd or your mood, you can go Italian with some dried basil and garlic salt; Mexican with some coriander and chili powder; or BBQ with some BBQ sauce and a little brown sugar – or any other way you wish.

Goulash

First, take the ground meat and place on a pan in the oven at 350 degrees for 15-20 minutes, stirring occasionally. This is to precook the meat so that you can strain the excess fat.

In a large soup pot, heat the vegetable oil, then sauté the onions till golden brown. Add the mushrooms and zucchini and cook slightly.

Add the tomatoes and seasoning of your choice, then the meat and broth. Simmer for 30 minutes and serve with bread, tortillas, rice and pasta. Please, don't forget the cheese.

Fall From Grace

It's funny how time can change beliefs, rearrange things and distance people from thoughts that were at one time honored as truths. Not only does that happen in real life, but in football too. At one time, Tim Tebow was a hero. Honored throughout Florida as the greatest college football player to perhaps ever play the game, Tebow accumulated multiple awards throughout his college career. With two BCS National Championships, two SEC Championships and a Heisman Trophy, just to name a few, the three-time All-American quarterback seemed to be destined for a career of riches (monetary and otherwise). Now, as he finds himself at the doorstep of attaining his ultimate goal, Tebow can't quite seem to knock loudly enough for a team to let him in and give him a chance at becoming a starting NFL quarterback. From a one-time NFL playoff contender to a team that heavily misused his abilities to now being given his outright release, Tim Tebow's NFL career has spiraled so out of control that now the one-time college workhorse finds himself desperately searching for a career.

From a 25-year-old Heisman Trophy winner with all of the promise in the world to a man searching for work in the NFL, there was always hope for Tim Tebow even when he found himself at the bottom of teams' depth charts. Oftentimes, that hope bloomed into opportunities and flourished into a body of work that was eerily reminiscent of his glory days wearing the orange and blue for the Florida Gators. Case in point, when Tebow found himself at the bottom of the Denver Broncos roster two years ago, he didn't panic.

He went about his business as he did on an everyday basis, attempting to become the best quarterback that he could be. Though there were many back then who doubted his abilities and talents as quarterback, as there are today, Tebow got his opportunity to shine and certainly made the most of it. Kyle Orton, the starting quarterback for Denver at the time, was benched in favor of Tebow and watched from the sidelines week after week as all Tebow continued to do was win. A team that was once 1-4 before Tebow took over later finished the season at 8-8 and made the playoffs as the young quarterback lived up to the moniker that all he does is win games.

Tebow accomplished a feat in Denver that the majority of NFL players can't put down on their own individual résumés. He won a playoff game and did it in impressive fashion by going 10 of 21 passing against the Steelers' number one-rated defense. Threehundred-and-sixteen yards (31.6 yards per completion) and two touchdowns later, the Broncos, behind Tim Tebow, were on their way to the second round of the playoffs where they would eventually be pushed out of competition by the ever-striking Tom Brady. One would think that a performance like that, in the playoffs nonetheless, would cement at least another opportunity for the player in a league where on the field, he showed he was successful. In came Peyton Manning, however, and out went Tebow--shipped to the New York Jets, which was, in essence, the beginning of the end.

The Safety Net That Helps Americans With Disabilities Stay Afloat

(BPT) - John Miller never much thought about the possibility that he might one day become disabled; he was too busy building and renovating homes throughout suburban Washington, D.C. For 40 years, Miller (a pseudonym to protect his privacy) worked long days with his brother - until an unexpected illness and injury struck.

Like thousands of American workers who find themselves sidelined by illness or injury, Miller could no longer work. As in many jobs, if you don't work, you don't earn. Miller soon found himself in dire straits, both financially and in terms of his health. He had never accepted any kind of public assistance, but now he desperately needed help just to pay basic living expenses.

Miller knew nothing about Social Security Disability Insurance (SSDI), the federal program that provides financial support to millions of Americans unable to work because of injury or chronic illness. Learning about the program and securing benefits took months, but now Miller knows his monthly SSDI benefits will at least help him put food on the table.

"My benefits check is something I can count on every month," he says. "I know that I'll be able to eat and that I'll be able to stay in my house for another 30 days."

Established in 1956, SSDI is an important part of our nation's Social Security system for disabled workers, retirees, dependents and survivors. Funded through payroll taxes, SSDI provides vital financial support for Americans with severe disabilities and chronic health conditions. Workers earn coverage for SSDI and other Social Security benefits through payroll tax contributions, and may only become eligible for benefits if they have earned coverage and their health prevents them from working.

Currently about 8 million Americans receive SSDI benefits. While the number of people receiving SSDI benefits has risen recently, the increase was expected, and experts say that influx will level off soon. Baby boomers reaching the disability-prone years of their 50s and 60s account for much of the increase. The growing number of women in the workforce also accounts for much of the rise, as they are now eligible for benefits in greater numbers than ever before. The rise in retirement age has also contributed to the increase.

Benefits are modest. On average, SSDI pays individuals just \$1,132 a month and families just \$1,919 a month. The requirements to qualify for benefits are very strict. Applicants must present extensive medical proof of significant disability. In fact, qualifying disabilities are so severe that about one in five men and one in six women receiving SSDI will die within five years of receiving benefits, and those eligible for benefits are three times more likely to die than other people their age, according to Kathy Ruffing of the Center



on Budget and Policy Priorities.

Applying for SSDI benefits is a complex process, especially for people who are unfamiliar with how the system works or who are already dealing with significant illness or injury and the emotional and financial strain that accompanies poor health. Many people find that getting help from a disability advocate or lawyer can help ease the process and relieve some of the stress.

Securing approval for SSDI benefits took Miller 35 months. His experience is far from unique. Miller's disability meant that after

spending his entire career taking care of the homes of others, he wasn't even able to perform needed maintenance on his own home. After nearly three years of waiting, he is finally able to use the benefits he earned while working on other peoples' homes, to hire someone to repair his own home. "I'd love to go out there today and work," he says. "Now I have to get someone else to do the work on my house that I had done for years."

Sports "We've offered to play schools that are bigger and have a football heritage. They decline because I don't think they see the benefit of potentially losing to a smaller school," said Parker.

The Eagles have a dilemma at quarterback, but according to Shevlin it's a nice predicament to have. Lars Nootbaar, a junior, took over at quarterback last year when Daniel Zeman suffered a knee injury midseason. Nootbaar led the Eagles to the CIF Northwest Division quarterfinals. Both players have earned all-league honors as a quarterback for El Segundo--Zeman in 2011 as a sophomore and Nootbaar in 2012 also as a sophomore. Nootbaar, who is expected to get the bulk of the snaps, boasts a big arm and has the speed to run the ball. Zeman should still see plenty of action and he also has a strong arm, but is especially skilled at the short passing game. "They're both leaders in the huddle and together they have the ability to throw for over 2,000 yards," said Shevlin.

The crop of receivers is deep, but look for Jamie Stewart's numbers to increase over last year's team-leading 50 receptions for 749 yards and 12 TDs. Stewart's numbers haven't gone unnoticed either. The All-South Bay/All-Pioneer League senior is being considered by a number of Ivy League schools--a testament to his 2,200 SAT score.

Others who figure prominently in the passing game are Miguel Wagner and Nick Karsseboom, tight end Connor Underwood and running back Henry Doby. Don't let Wagner's size fool you. He is a speedster with great hands and has a knack of catching the uncatchable passes. Karsseboom has so much upside that teams will have to defend him and his breakaway speed. Underwood is returning from a season-ending injury as a junior. He recovered in time to play baseball and help lead the team into the CIF quarterfinals. There is no question about his athletic ability and he should prove to be a viable threat. Doby returns to get the bulk of the rushing load, but will see plenty of passes coming out of the backfield too.

While Doby looks to have a solid year running

Ryan attained Tebow with the intent of using him in specialized packages while giving him a backup opportunity behind incumbent starter Mark Sanchez. Not only did Sanchez play horribly all season long, but he was also a victim of the "butt-fumble," to add insult to injury. And yet, Tebow still never received an opportunity. The Jets failed to improve under Sanchez, eventually missed the playoffs and Tebow remained there on the bench as even third string quarterback Greg McElroy got a show at stardom in New York. McElroy eventually failed too. Tebow began, for the first time in his football career, looking like nothing more than a distraction and he quickly found his professional reputation plummeting quickly.

Tebow would receive another opportunity with the New England Patriots, for whom he played briefly in this year's preseason. If you follow sports at all, or even entertainment news given Tebow's polarizing effect on the media, you of course have heard by now that the Patriots' feelings were not as mutually exclusive. As Patriots' head coach Bill Belichick explained, "It's not just one game [that matters], although every game is important. But the body of work, the camp,

the rate of improvement, the ability to do the things that players are going to be asked to do at their respective positions [also matters]." Tebow apparently showed no improvement even under the great Belichick and his football skills were deemed unsatisfactory, leading to the quarterback's eventual release that finds him in his current state looking for work.

Perhaps Tim Tebow will never be the great practice player that will get him an immediate starting job again. Perhaps he doesn't have the intangibles of a Tom Brady or the arm of an Aaron Rogers that will make the way that he plays quarterback look easy. But the hard work and dedication that Tebow puts into his craft not only makes him as an individual polarizing, but it leads people toward an appreciation of him as a player as a result of his undying determination. Despite horrendous footwork, an inability to make the most natural of reads on the field and what many experts call an altogether horrible throwing motion, Tim Tebow has the off-the-charts intangibles that make him a winner. He did it in Florida, he did it in Denver and was never given a chance again. Should Tebow find another opportunity in the NFL, he will certainly win again. •



the ball, there are a couple others who look to spell him. Ryan Kelly and Dathan Bailey are two different types of runners and will challenge opposing defenses. Kelly has speed to run north and south, while Bailey is more of a slashing type of runner.

The offensive line has experience and it begins with returning starters Dante Johnson, Gabriel Rocha and Michael Rincon. When you include newcomers Ernesto Rivera, Brian Hayes and Nick Palomo, you get the idea that moving the ball shouldn't be a problem.

The defense lost a wealth of talent to graduation, but returns the core unit that was solid. This junior-dominated squad is coming into its own and it starts at linebacker. The entire linebacker group returns, including juniors Jackson Walz, Joey Garza, Ryan Kelly and Jake Barone. Together as first-year sophomores last season, this talented group helped make the Eagles' defense one of the best in the Pioneer League.

The defensive line may be a bit on the small size, but they are all athletic and eager to impress Heck. Seniors Nick Palomo and Josh Pacheco as well as juniors Dante Johnson, Dwayne Polk, Zeke Rodriquez, Noah Bergren, Mike Villa and Tyler Stephens lend to a quality defense.

As the team readies for the season opener, it is dealing with some injuries. Shevlin is optimistic they'll all be ready to go. "It's a chronic problem each year during the first part of the season and something that most teams go through," he said.

It all starts Friday night when the Eagles travel to play Lynwood at 7 p.m. The Eagles play their home opener next Friday against Cantwell Sacred Heart. Kickoff is 7 p.m. •


