TopGolf Talk Continues to Consume Council Meetings

The TopGolf proposal again dominated discussion at the latest El Segundo City Council meeting—with about 30 people speaking on the topic on Tuesday during an emotionally charged public communications period that extended well over an hour. Out of that group, all but three (two of them representing TopGolf) voiced their disapproval of the project and hoped to keep The Lakes at El Segundo as it is. Most of Tuesday's comments came from El Segundo residents.

TopGolf Real Estate Director Zach Shor confirmed the company had sent representatives into the community to discuss project issues directly and had reached almost 500 people so far. Of those, he reported 200 signed their names in support of TopGolf's proposal for The Lakes at El Segundo. Alex Comisar from TopGolf's public relations firm Cerrell Associates said the goal of the campaign is to establish an "open and honest dialogue" and that allegations that representatives identified themselves as City employees were unfounded. "None of these individuals would have engaged in such an act of dishonesty," he said, adding that from this point forward those knocking on doors will wear TopGolf t-shirts.

Local resident Liz Gamholz reported that one of the representatives came to her door and told her that the Council supports the project. "How did TopGolf know the Council is for it?" she asked. "When was this Brown Act vote taken?" Later, a second speaker confirmed a representative told her the same thing. In response, Mayor Bill Fisher said, "No one's decided anything... If we get an agreement we feel is reasonable, we'll bring it forward." Mayor Pro Tem Carl Jacobson emphasized that any upcoming decision "would only be to bring it to the public." Councilmember Dave Atkinson added that "it's a decision we

can't make until we have all the information."

Noting that she had received verbal and written threats from residents warning her not to vote in favor of TopGolf or else face future repercussions at the polls, Councilmember Marie Fellhauer said her mind isn't made up yet and that her vote will come down to what she believes is best for the City. "I will never make a deal for the City of El Segundo based on being reelected again or not," she

said. "Stop with the threats. It makes no impact on me."

Among the items brought up by public speakers, Golf Course Subcommittee member and former Mayor Bill Bue said that in contrast to previous reports, The Lakes is actually profitable and figures to do even better in 2013/2014 as recent fee increases have helped matters. Mike Dugan later reported that in 2012

City Hires New Human Resources Director

Among the casualties a few years ago when the City of El Segundo had to cut costs by not filling vacant positions and working leaner was the entire Human Resources (HR) Department, which technically went away after the retirement of long-time director Robert Hyland. The duties of that department became absorbed under the Finance Manager, tacking on additional responsibilities to an already daunting schedule. While the budget is still shaky today, City Manager Greg Carpenter and staff see a critical need to build a quality workforce and provide services at the highest level possible. With that in mind, he recently restored Human Resources to departmental status and appointed Martha Dijkstra as HR Director. "I believe it was essential to invest in an HR director because our workforce is our most important asset," Carpenter said. "HR recruits and helps develop our employees while also being

responsible for developing a long-term strategy to insure that we have a motivated and qualified workforce. HR has taken on additional roles and responsibilities and has become increasingly more challenging and complex. It was a difficult responsibility for another department head to juggle along with their other responsibilities. Martha is very experienced, dedicated to the organization and its workforce and she provides thoughtful and clear advice."

A Los Angeles native who earned a Bachelor's degree from Cal State Los Angeles in Business Administration and a Master's in Human Resources from Chapman University, Dijkstra has been a South Bay resident for over 16 years. She began her career in HR in 1983 as a student worker with the Los Angeles County Office of the Assessor, Personnel Division. Over the next 18-plus years, she rose up the career ladder and worked in a number of different County departments.

New \$1.9 Billion Tom Bradley LAX Terminal

Los Angeles Mayor Eric Garcetti, City and LAX airport officials, and subject-matter experts will commemorate the grand opening of the \$1.9-billion New Tom Bradley International Terminal and completion of Phase I of the project.

Phase I includes nine of 18 new aircraft boarding gates, which can accommodate larger, new-generation aircraft such as the Airbus 380 and Boeing 747-8. Passengers will experience a first-class level of comfort and convenience with premier dining, retail shopping, airline lounges, a children's play area, spa, and other passenger amenities in the 150,000-square-foot Antonio Villaraigosa Pavilion. The New TBIT Project is creating nearly 4,000 construction-related jobs during the project's five-year schedule, and nearly 2,000 permanent new concession jobs.

The Lakes generated over \$300,000 in excess cash for the City. He noted that the driving range is the moneymaker, while the clubhouse, restaurant and golf course itself are in the red.

Dugan and others asked the Council to put out a request for proposal (RFP) to seek bids from other golf course operators. Fisher reiterated that the Council is not required to issue an RFP, but did create an ad hoc subcommittee comprised of golf industry professionals who reached out to outside companies to gauge interest in operating The Lakes—based on the criteria of committing to a 20-year land lease, a \$15-\$20 million capital investment and bringing in 80-plus employees. While three companies showed interest, none have been able to match TopGolf's proposal, according to Fisher and City Manager Greg Carpenter. "If there's someone that is open to competing with this [TopGolf's proposal], I would love to do an RFP," said Fisher.

Addressing concerns that TopGolf will be a bar, Manhattan Beach resident and El Segundo business owner Tom Courtney contested Chief Development Officer Randy Starr's recent statement that alcohol sales only make up 10 percent of the company's total revenues. After researching data provided by the Texas Alcohol and Beverage Commission, Courtney said he discovered that TopGolf was number one in the entire city of Austin, Texas in alcohol sales. Another Manhattan Beach resident accused TopGolf of changing its PowerPoint presentation to appear to be more family-oriented when its actual premise, in her estimation, is to promote entertainment and alcohol. "Every pod [driving range bay] is a bar if you choose to order a spirit," she said.

Responding to the alcohol worries, local resident and TopGolf supporter Ron Swanson said the El Segundo Police Department contacted law enforcement agencies in other municipalities where the company has facilities and found "no major concerns." Additionally, he

noted, TopGolf drew praise for its community involvement. Pointing out that TopGolf is a private enterprise willing to invest \$20 million-plus into a City-owned facility and provide a \$2 million facelift to the golf course that the City will continue to own and operate, Swanson reasoned that "even if it goes away, we'll still have a three-story driving range." He added that the new facility would be a "gathering place for the community" that "will meet the needs of everybody," but also warned the Council to make a decision quickly. "Put it to bed soon... it's tearing the community apart."

Also on Tuesday, the Council adopted the 2013/14 budget presented in detail two weeks ago, including a few revisions from the preliminary document. It is a balanced budget, thanks to a double payment applied from the Chevron tax resolution. The Council also approved the new City of El Segundo Strategic Plan, outlining projects through all departments that are in progress and pending.

During presentations, the Mayor and Council proclaimed the observance of the 37th annual Richmond Street Fair on Saturday, September 28 from 9 a.m. to 5 p.m. Sponsored by the El Segundo Kiwanis Club as a fundraiser for local youth scholarships and projects, the festivities will include arts and crafts, food, live music and a beer garden. Councilmember Suzanne Fuentes pulled a consent agenda item regarding the beer garden, stating she was against alcohol consumption in public. Jacobson agreed and voted against it, but the remaining three Council members opted to maintain the garden—arguing it was in a controlled area and responsibly managed.

The Council, along with Chief Kevin Smith, also proclaimed October 6-12 as Fire Prevention Week, inviting the community to practice general fire prevention and fire safety year-round while focusing on this year's theme to "prevent kitchen fires." Smith reported that

Next were stints in municipal government, working for the cities of Manhattan Beach and Redondo Beach for a combined seven years. She became HR Manager for the City of El Segundo in 2008—a move she saw as a promotional opportunity. Now overseeing a department comprised of four HR professionals and two office specialists assigned to reception, Dijkstra noted that a key challenge to tackle from day one is the economic downturn that continues to impact the City of El Segundo. "The staffing reductions have required the workforce to do

more with less while maintaining a high level of service," she explained. "Our objective is to come up with strategies to ensure the workforce continues to be engaged and committed to providing excellent public service. The City is fortunate to have outstanding, productive and dedicated employees, so a priority for us is to keep them motivated and to continually acknowledge and recognize their excellent work and dedication. We also need to look at succession planning and knowledge transfer. We

Law to Reduce Hit-and-Runs Seeks to Make U.S. Safer, More Accountable

This week, the State Assembly voted 68-0 to approve a bill authored by Assemblyman Mike Gatto that seeks to reduce the amount of hit-and-run offenses in California. The State Senate also voted 37-0 in favor of this proposed legislation. Assembly Bill 184 will provide additional tools to law enforcement officers investigating hit-and-run offenses by extending the current three-year statute of limitations for such offenses to six years from the date of the offense. This simple piece of legislation is long overdue and even though the statute of limitations only extends to six years (should be longer), it is a good extension for law enforcement officials to find these offenders.

Each year, thousands of hit-and-run incidents occur throughout the state. These accidents cause pain and suffering to thousands of victims and in some cases the injuries lead to death. Only in instances where the hit-and-run ended in death would there be no statute of limitation, but that was because of the death and not the hit-and-run itself. Giving law enforcement agencies more time to investigate these crimes will hopefully result in not just the apprehension of these cowards, but a reduction of hit-and-run incidents.

One reason criminals break the law is because they think that they can get away with their actions. When accidents happen, it is normal to go through a moment of shock and fear. Unfortunately, people allow these few seconds of panic to overtake all common sense and they run with complete disregard for the well-being

of the person with whom they just collided. The Legislature's decision occurred a few just days after a deadly series of hit-and-runs in the state. A press release from Gatto's office stated that in the past three weeks, separate hit-and-run incidents took the lives of seven people in the City of Los Angeles while five others dies in Los Angeles and Orange counties. Among the victims were a three-year-old, several college students and two older men.

Criminal investigations take time--especially in a place like California where there are several big cities with populations of more than two million. Tracking down every criminal within a limited time structure only complicates the process. With gang violence, drug issues and other dangerous crimes happening, it is hard to believe that law enforcement agencies can or will prioritize solving hit-and-runs within a three-year span. It might even be a stretch to think that with a six year span, such crimes will be moved to the top of the list of issues to solve. However, giving investigators six years will at the very least provide the victims of hit-and-runs and their families an opportunity for closure.

Getting into an accident is already a stressful incident for everyone involved. Even when the incident doesn't end in tragedy or injury, there has to be accountability--and to have people run from their mistakes, leaving others to deal with the consequences on their own, is simply wrong. Hopefully with three more years to investigate these crimes, more offenders will be caught and less people will be inclined to hit-and-run. •

"HR recruits and helps develop our employees while also being responsible for developing a long-term strategy to insure that we have a motivated and qualified workforce."



Protect Yourself Against Credit Discrimination

Have you ever been turned down for a credit card and wondered why? Or gotten approved for a car loan or mortgage but suddenly the interest rate and fees are much higher than in the initial quote?

There are many legitimate reasons why people are denied credit – insufficient income or a poor track record on past loan repayments, for example. But sometimes people are denied credit because of discriminatory lending practices – which are not always easy to spot.

Fortunately numerous federal and state laws

You are refused credit even though you qualify for it.

You are offered credit with a higher rate than what you applied for, even though you qualify for the lower rate.

You are denied credit, but not given a reason why or told how to find out why.

prohibit lenders from discriminating in any part of a credit transaction on the basis of many personal characteristics. What’s more, the Consumer Financial Protection Bureau (CFPB) and other governmental agencies provide avenues for filing complaints if you feel you’ve been discriminated against. And, offending lenders face lawsuits and stiff penalties if found to be discriminatory.

Under the Equal Credit Opportunity Act (ECOA) it’s illegal for creditors to discriminate against credit applicants based on their race, color, religion, national origin, sex, marital status or age, because they receive income from a public assistance program, or because they have in good faith exercised any right under the Consumer Credit Protection Act.

Based on those criteria, lenders cannot:

Refuse you credit if you qualify for it;

Discourage you from applying for credit;

Offer you credit on terms that are less favorable than those offered to someone with similar qualifications; or

Close your account.

Another federal law, the Fair Housing Act (FHA), prohibits discrimination by direct providers of housing, such as landlords, real estate companies, municipalities, banks or other lending institutions and homeowner’s insurance companies.

Warning signs. Red flags that may indicate credit discrimination include:

Your deal sounds too good to be true.

You feel pushed or pressured to sign.

If you believe a lender has discriminated against you for any reason, you can submit a complaint to the CFPB (www.consumerfinance.gov/complaint), which will review and route your complaint to the lender and work on your behalf to get a response. Once your complaint is logged, you will receive email updates and can log in to monitor the status of your complaint.

To better protect yourself against credit discrimination – or from pursuing credit products that aren’t right for you:

Learn about the various features and downsides of the credit product you want. Research current interest rates and compare products from several lenders.

Creditors make decisions based on your credit history, so make sure there are no mistakes or missing items in your credit reports.

Be sure you understand the rates and fees you’ll pay over the long run and ask whether they could change in the future. If a creditor doesn’t want to answer your questions, this could be a bad sign.

Don’t let lenders make you feel rushed or unnecessarily delay action on your application.

Bottom line: Before you sign on the dotted line, make sure the credit product is right for your needs – both today and down the road. •

Empowering Patients to Become Self-Health Advocates through Use of Technology

Advances in technology have shaped the way we communicate and have enabled the modern-day patient to easily connect with medical experts, patient advocates and

Through computers, handheld devices like tablets and smart phones, and social media, patients are also able to instantly access credible information – something that could not have been imagined until recently. Digital tools and online resources have become especially beneficial for people living with rare health conditions, such as sarcomas or malignant tumors that are often difficult to diagnose.

Sarcoma Awareness Month was recently commemorated in the United States and is an opportune time to raise awareness among those people unfamiliar with sarcomas, while also empowering patients living with the disease to be their own best advocates. One way patients can self-advocate is by using available digital resources to obtain information about their condition.

For example, for patients with gastrointestinal stromal tumors (GIST), a rare, life-threatening sarcoma that is primarily found in the gastrointestinal (GI) track and most often found in the stomach or small intestine, the journey to a correct diagnosis may take years as symptoms are not present in earlier stages of the disease. Once diagnosed, the journey has just begun, and patients should understand how to best manage their disease. Patients with GIST can use online resources to take charge of their health by following these steps:

Form a healthcare team: Form a multidisciplinary team of healthcare professionals (e.g., gastroenterologist, medical oncologist, surgeon, pathologist) to ensure that

hesitate to ask questions or reach out to healthcare professionals between regular visits.

Connect with others: Join online or live support groups to connect with other patients and exchange personal experiences. A recent study from Japan showed that in today’s era, social media, including Twitter, are valuable resources for the sharing of psychological support among the cancer community.

To further assist patients with GIST with managing their condition, Novartis recently launched two new digital resources:

The GIST Network YouTube Channel: Featuring videos to support GIST patients and their caregivers with patient stories and tips from medical experts.

“Assess the Risk” Mobile App: Geared to educate healthcare professionals on how to assess the risk of recurrence of GIST and facilitate the discussion between healthcare professionals and patients.

“With the availability of new digital tools, such as the ‘Assess the Risk’ mobile app, new lines of communication are being formed between patients and doctors, which is truly remarkable,” says Dr. Robert Andtbacka of the Huntsman Cancer Institute. “Working with a team of physicians and connecting with other patients are both integral parts of the patient journey.”

As technology continues to evolve, it is important that patients living with a rare condition such as GIST continue to be their own health advocates and work with their healthcare professionals to determine a disease management plan that is best for them. •

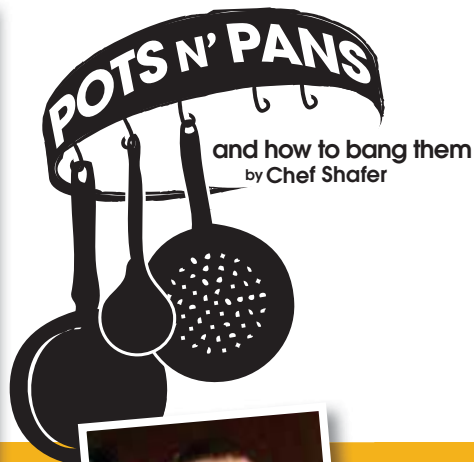

My mom would drive us to the farming area outside of Buffalo, an area called Dunkirk, and we would buy a bushel full of apples, some squash and fresh corn on the cob. This was, and still remains, the sweetest corn I've ever tasted. This week, I thought I would give you a mix of the two. This week's dish is a savory relish that you can serve with a roasted bird, pork or beef, along with a grilled salmon or seared Ahi.



The Chef

Sweet Corn and Apple Relish



- 1 cup diced onions
- 1/4 cup vegetable oil
- 2 ears of corn (cut from the cob)
- 3 cups of diced apples {peeled and seeded}
- 1/8 cup brown sugar
- 1/8 cup white vinegar
- 1/2 cup chopped dates or raisin fig (or other dried fruit)
- Pinch of salt and black pepper

In a hot pan, sauté the onions in the oil till lightly browned.
 Add the corn and cook for 1 minute.
 Add the apples, sugar, vinegar, dates & salt and pepper.
 Simmer for 2 minutes, then chill and serve with your choice of foods. It also goes well with cheese. •

Bruins Taking Control

Motivation normally goes a long way in the sports world. If any team in the NCAA had the motivation to win last week, it was the UCLA Bruins. Not just because they're in a constant battle with USC for control of the Los Angeles college football scene. Not just because of the high expectations placed upon them this year. But two weeks ago, UCLA wide receiver Nick Pasquale was killed when he was struck by an automobile while he was doing nothing more than simply

before they channeled their true selves, rallied and eventually won the game.

When UCLA played Nebraska last year at the Rose Bowl, it was a coming-out party of sorts for Mora and his Bruins. Starting quarterback Brett Hundley tore up the Nebraska defense for 653 total yards en route to a 36-30 win that thrust UCLA into the national rankings and gave them the push they needed to finish off the year at the head of the Pac-12 class. This year, Hundley showed up once again, this time throwing for three

walking down the street in his hometown. Going on the road to take on number 23-ranked Nebraska, the Bruins knew that they had a challenge in front of themselves. This game, though, was for Pasquale. When UCLA fell down by 18 points early on in the game last Saturday afternoon, they used the motivation fueled by Pasquale to score 38 unanswered points, secure the victory and remain one of the powerhouse teams in the Pac-12 conference.

While with the UCLA Bruins, Pasquale wore a number 36 jersey. Last Saturday during the game, all of the UCLA players wore number 36 patches on their own jerseys in memory of him. Even the Cornhuskers wore number 36 decals on their helmets, showing a great sign of sportsmanship to their foes of the day. Though the Bruins must have been undoubtedly motivated to win the game for Pasquale, UCLA head coach Jim Mora had a different point of view on the whole thing. "You can't believe how tough it was on them," Mora said. "You never want to say you won one for somebody. We didn't win one for Nick. What we tried to do today is go out and play with the type of energy, enthusiasm and passion for the game that would reflect what he meant to us." The Bruins certainly lacked that energy and enthusiasm early on, but it wasn't long

touchdowns and 294 yards through the air. "The first half there was so much emotion, I'm not going to lie," Hundley said. "I just had so much emotion going into the game. There were a lot of things that added up to it. After the first half, everything slowed down and we got back to playing football and came out with the win." The game really was a tale of two halves, as Hundley explained. The Bruins wound up scoring 35 points in just 16 minutes, including a 10-yard touchdown run by Paul Perkins to end the first half, giving UCLA the momentum that it desperately needed heading into the locker room for the break.

A break from all of the emotion is certainly what the Bruins needed. "We came in at halftime and there weren't a lot of adjustments that needed to be made," Mora said. "It was more of an adjustment in our mindset." Once they got their break over with at halftime, Hundley and the team got their minds right and never looked back. After Jordan James ran the ball in from three yards out for a touchdown, Hundley tossed a 28-yard touchdown pass to Shaquille Evans, a 12-yard touchdown pass to Phillip Ruhl and another three-yard TD to Nate Iese. Nebraska allowed 236 yards on defense in the third quarter alone, all while going scoreless in the second half.

Eagles Keep Rolling Behind Doby and Nootbaar

For the third consecutive year, El Segundo and Cantwell have faced each other on the football field. Two years ago, Cantwell defeated the Eagles in the last minute of play in the first round of the CIF Northwest Division playoffs. Last year, the Eagles returned the favor in non-league action. This year, the Eagles used an effective offense and a stout defense to come away with the win.

Running back Henry Doby bolted 38 yards for a score on El Segundo's first play, and the Eagles took a lead and went on to win a 46-19 non-league victory over visiting Cantwell. Doby finished with 146 yards

had one just before halftime near midfield.

On the fourth and long near midfield, Joey Garza and Shane Van Pelt stopped Jean Lue Dauphiney for a five-yard loss with less than 10 seconds left in the half. With just four seconds left in the first half, Nootbaar found a streaking Jamie Stewart for a 42-yard touchdown pass to give the Eagles a 25-5 lead at halftime.

El Segundo's wide-open offense had thoroughly blended a mix of power running from Henry Doby and the pass catching of Stewart, Connor Underwood and Nick Karsseboom. It was all Cantwell could do to stop one phase of the Eagle's offense.

and two touchdowns on 18 carries for the Eagles (2-0).

Lars Nootbaar completed 17 of 28 passes for 302 yards and three touchdowns with one interception. His favorite target was wide receiver Jamie Stewart, who had nine catches for 177 yards and two scores.

What started out as a blowout ended the same way and seemed to delight the large home crowd. It was the Eagle's home opener for the 2013 season and gave its strong supporters a glimpse of what could be a very exciting season.

On El Segundo's second possession, Nootbaar found Stewart wide open for a 42-yard catch and run touchdown to give the Eagles a 15-0 lead.

On Cantwell's ensuing possession had gained momentum and were marching towards the Eagle end zone. On second and five at the Eagle 23-yard line, Cantwell quarterback Mathew Valencia's pass was intercepted by Elijah Hale near the goal line. He returned it to his own 6-yard line. On the first play, Nootbaar was called for 'grounding' the pass in the end zone for a safety to make it 15-2.

Cantwell couldn't take advantage of good field position and Nootbaar took his team on a seven-play drive that resulted in Gabriel Rocha's 31-yard field goal to make it 18-2. Cantwell responded with a hurry up offense that kept the Eagles off-balanced. The Cardinals embarked on a 17-play series but could only manage a 30-yard field goal by Raphael Munoz to cut El Segundo's lead to 18-5.

"That was a big stop for us holding them to just a field goal," said defensive coordinator Dan Heck.

When the Eagle's offense went sour in its next two possessions. The defense continued to play well particularly Stewart and defensive lineman Mike Villa. Stewart's interception stopped the next Cantwell drive. Villa, who sacked Valencia three times in the game,

"We did some great things and there were other things we need to work on for the second half," said head coach Steve Shevlin before heading to the locker-room.

El Segundo came out ready to continue its momentum from the end of the first half. The Eagles drove to the Cardinal's 5-yard, but a fumble and penalty backed them up to third and goal from Cantwell's 20-yard line. A pass intended for Underwood in the end zone was picked off by Brye Busse and returned to his own six-yard line.

On El Segundo's next possession, Underwood picked up eight yards on a pass, Karsseboom picked up another 15 yards and Hale picked up six yards for a first down. It set up another TD pass to Stewart from 24 yards out to extend the lead to 32-5.

Cantwell's woes continued as El Segundo's defense came up with another turnover. Joey Garza came up with a loose ball and the Eagles were in business again this time at the Cardinal's 22-yard line. Five plays later, Nootbaar got a great block from Gabriel Rocha and Ernesto Rivera and dove into the end zone for a 39-5 advantage.

The Cardinal's Max Mora nearly returned the ensuing kickoff back for a touchdown before Henry Doby caught him at the Eagle's seven-yard line. One play later Dauphiney snuck into the end zone to make it 39-13.

With 8:42 left in the game, Cantwell closed the gap to 39-19 with a 4-yard TD run by full back Anthony Hadd.

Any designs of a comeback by Cantwell were quieted by Henry Doby. The senior tailback, who rushed for a game high 147 yards, broke through the defensive line and outran the Cardinals secondary for a 52 yard touchdown run to cap the scoring.

The fifth-ranked Eagles amassed 443 yards of offense led by Nootbaar who completed 17-28 passes and one interception for 293 yards and three TDs. Jamie Stewart caught

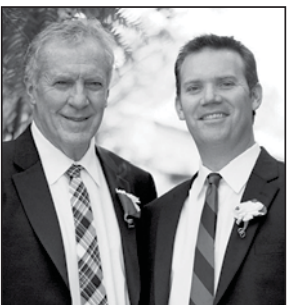

“The second half was a lot like last year,” Nebraska head coach Bo Pelini explained. “We made the tackles in the first half. I don’t know how many tackles we missed in that second half, but it is a lot. We missed tackle after tackle after tackle.” Maybe you can say that Pasquale was with the Bruins in the second half, or maybe you can’t. Either way, the team gained strength enough to put away its ranked foes and climb up the top 25 ladder more than it has done in the past 10-plus years.

The Bruins are 2-0 on the year now, but go up against New Mexico State in

Pasadena to try to keep their perfect record intact this week. If that wasn’t challenge enough, UCLA takes on Utah, Cal, Stanford and Oregon in consecutive weeks following New Mexico State. If the Bruins are going to take over Los Angeles, this is their perfect opportunity to do it, but they will have to go up against and beat multiple strong teams in order to gain that designation. Only time will tell what happens at this point, so keep following the Bruins all year long to see if they have what it takes to become the class of this year’s Pac-12 conference once again. •

Noting that said systems are underused, Levy has created several tools to inform the community about how to sign up (by going to the City’s website at www.elsegundo.org, clicking on “Virtual City Hall” at the top of the page,

and then clicking on “Alert El Segundo”) to receive messages via the options of land line, cell, text and email. The campaign includes a slide play shown on El Segundo TV, door hangers to be placed at community homes this Saturday, and posters for Main Street businesses to display.

The Council also agreed to amend the municipal code so that local police officers can enforce animal control violations such as dogs at-large or not licensed as infractions instead of misdemeanors, so those offenses will no longer need to go before the Los Angeles County District Attorney’s Office (which is now declining to prosecute such cases). Under the new system, first-time animal regulation offenders will receive a fine of up to \$100. The penalty can rise to as much as \$200 for a second violation within one year and up to \$500 for each additional violation within a one-year period. •

Looking Up

Near-Earth Asteroid “Don Quixote” Is Really a Comet

Things are not always what they seem—especially in space. For 30 years, a large near-Earth object called “Don Quixote” was believed to be an asteroid. Now, an international team of astronomers and planetary scientists has discovered it is actually a comet.

Called 3552 Don Quixote, the body is the third-largest near-Earth object (an asteroid or similar body orbiting the Sun in the vicinity of Earth). About five percent of near-Earth objects are thought to be “dead” comets that have shed all the water and carbon dioxide in the form of ice that give them their coma—a cloud surrounding the comet nucleus—and tail.

The team found that Don Quixote is neither. It is, in fact, an active comet, thus likely containing water ice and not just rocks. The finding, presented at the European Planetary Science Congress 2013 [<http://www.epsc2013.eu>] in London on September 10, could hold implications for the origin of water on Earth.

“Don Quixote has always been recognized as an oddball,” said team member Joshua Emery, assistant professor of Earth and planetary sciences at the University of Tennessee, Knoxville. “Its orbit brings it close to Earth, but also takes it way out past Jupiter. Such a vast orbit is similar to a comet’s—not an asteroid’s, which tend to be more circular—so people thought it was one that had shed all its ice deposits.”

Using the Spitzer Space Telescope, the team reexamined images of Don Quixote from 2009 when it was in the part of its orbit closest to the Sun and found it actually did

have a coma and a faint tail. “The power of the Spitzer telescope allowed us to spot the coma and tail, which was not possible using optical telescopes on the ground,” said Emery. “We now think this body contains a lot of ice—including carbon dioxide and/or carbon monoxide ice—rather than just being rocky.”

This discovery implies that carbon dioxide and water ice might be present within other near-Earth asteroids as well. It also may have implications for the origins of water on Earth as comets may be the source of at least some of it, and the amount on Don Quixote represents about 100 billion tons of water—roughly the same amount that’s in Lake Tahoe.

Fire and ice are the two opposites that meet when an icy comet approaches the Sun. The result can be a spectacular tail, as when Comet Halley approached us in 1910, or just an unheard sizzle, when all of a comet’s ice melts away on a too-close approach to the Sun. Comets are always unpredictable objects. Comet discoverer David Levy likened them to cats “because they have tails and they do what they want.”

Fire and Ice is also the title of my all-time favorite book on comets. Published in 1985 and still available from Amazon (authored by Roberta J.M. Olson and subtitled “A History of Comets in Art”), it holds a treasury of paintings, drawings and descriptions of all the great comets that have stirred the imagination of mankind. Looking ahead to the holidays, the book would make a great gift to accompany the approach of Christmas comet ISON, which we hope will still brighten and become spectacular at that time. •

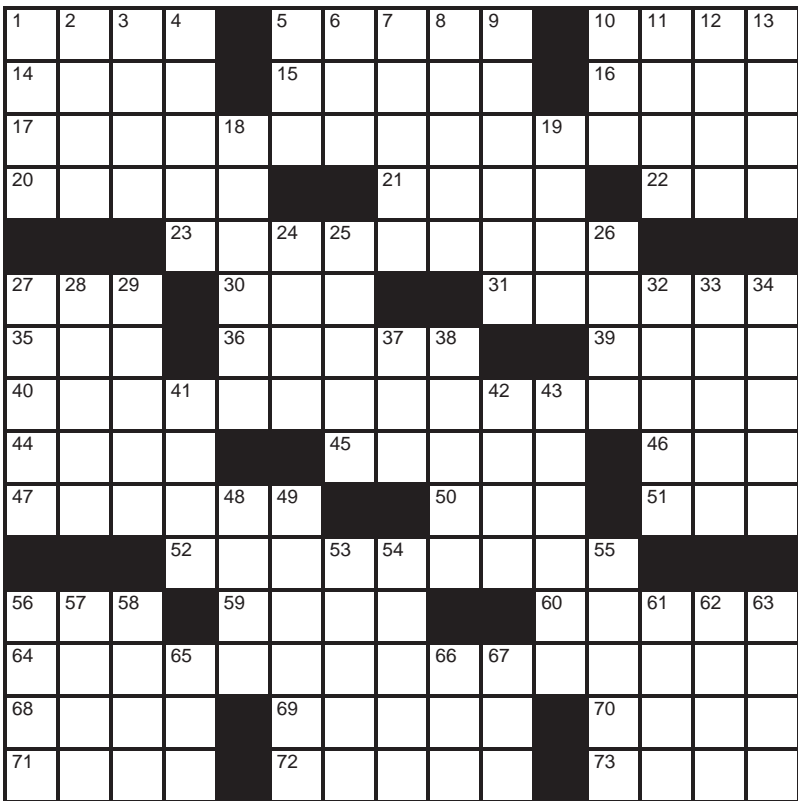

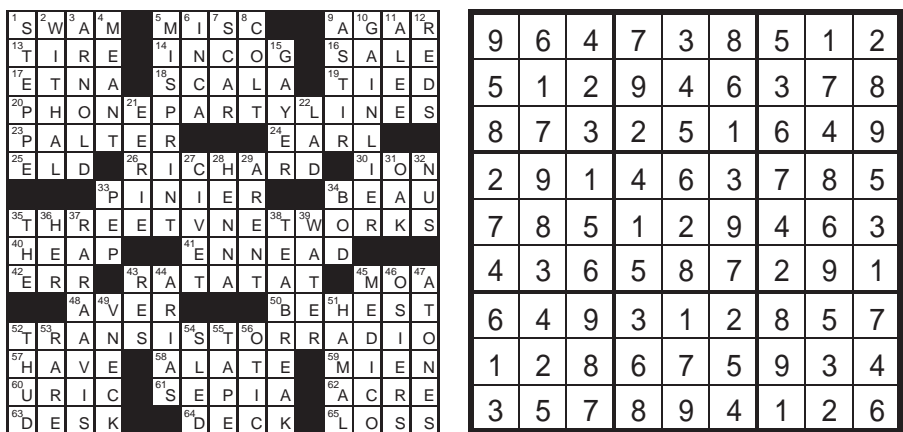

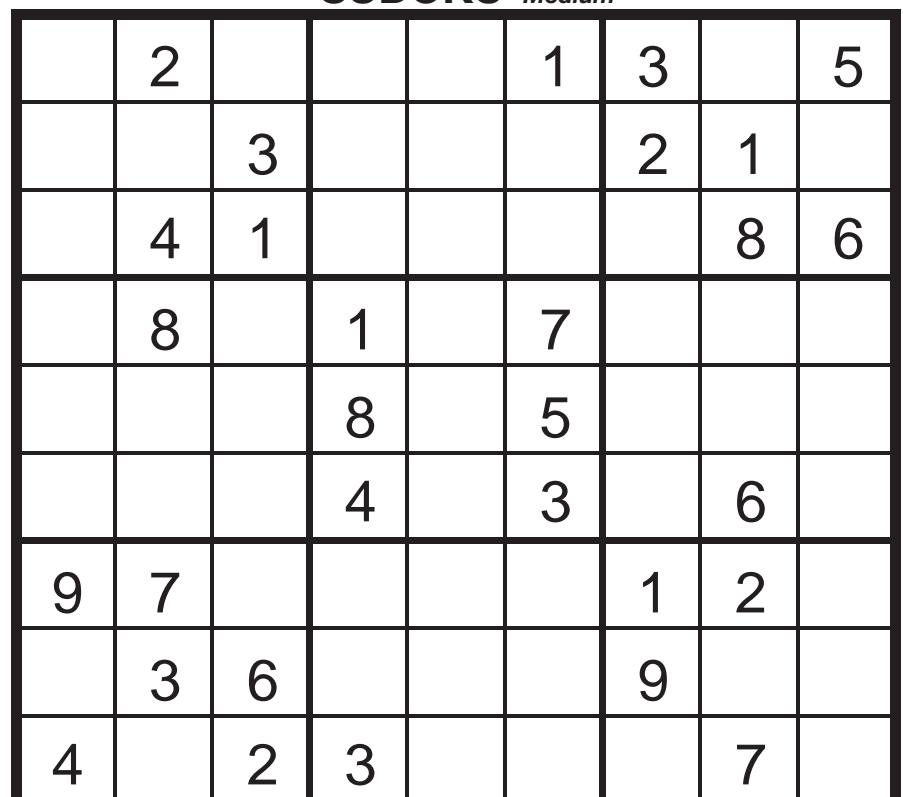
