## El Camino College Looks to Bond Measure to Shore Up Aging Facilities

El Camino College officials hope district voters will give the go-ahead on November 6 to a \$350 million bond measure to replace and renovate many of the campus' aging buildings. According to the bond information flyer, Measure E monies "will be used to make safety, technology and energy-saving improvements to classrooms, labs and other instructional facilities." The list of projects for the Torrance-based campus includes expanding science labs, upgrading outdated electrical systems and wiring, improving facilities for veterans, enhancing training facilities for nurses and firefighters, adding classrooms and improving site accessibility and safety. By conforming to California green building standards and promoting environmental responsibility, El Camino expects to save \$1 million annually in energy, water usage, maintenance and operating costs.

The proposed bond comes a decade after El Camino's successful \$395 million initiative in 2002 also called Measure E. College officials describe the new measure as a "bond extension" to complete the upgrades needed at the campus that opened in 1947. "Many of our buildings and facilities are more than 50 years old now--some are nearly 65 years old," said El Camino Superintendent/President Thomas M. Fallo. "They have been well-maintained, but like any structures of that age, they need repairs and renovations."

Projects completed from the first bond include a renovated science complex, electrical/fire alarm upgrades, new humanities building, new central plant, new learning resources center, new parking structure, remodeled bookstore and conference center, and a renovated social science building. Projects still in progress include a new STEM center, fire academy repaving, industry and technology

building modernization, new shops Building, new kinesiology and fitness complex, parking lot F retrofitting and additional third level, new computer server room, restroom accessibility renovations, parking lot lighting and security upgrade and electrical and data conversion.

The bulk of the new bond monies would go towards replacing the kinesiology and fitness complex, counseling and student activities center, administration functions building, and

music theater and arts complex. Renovations of the library and Marsee auditorium are also planned. The projects are part of the college's Facilities Master Plan that provides a long-range forecast for enrollment and changing student needs.

The State requires a 55 percent majority vote for the bond to pass. The first Measure E garnered 62 percent, making Fallo hopeful

## High School Choir Serenades School Board Members

The second El Segundo School Board meeting in October started a little differently, with the El Segundo High School Choir serenading those assembled with a stirring rendition of the "Star Spangled Banner." The choir then belted out a couple of more tunes before Board President Bill Watkins and the other members took their seats to conduct their twice-monthly business.

Two months into the 2012-13 school year and with less than two weeks before the very important general election that will not only elect a President but also closer to home impact available funding for the El Segundo Unified School District, the Board heard a state of the schools address from the District's elementary school principals.

Marisa Janicek spoke for Center Street Elementary, while her counterpart Dickie Van Breene represented Richmond Street. The two spoke of the gains that have been made in all areas of the curriculum, including science, writing, English language arts and math.

The principals also addressed the "school climate," including after-school programs, participation in community activities, the implementation of grade level community service projects, and the development of student groups that are meeting to further the educational opportunities at the K-5 schools.

Janicek and Van Breene also spoke to the parental support in the community and the volunteer opportunities that are available at the schools, and the support received from the PTA as well as the El Segundo Education Foundation. Speaking of the District's successes, Van Breene said, "We couldn't do this without our parents."

Also on the agenda was a financial boost for the District in these economically challenging times. Chevron representatives, led by Frank Semancik, Rod Speckman and Lily Craig, stood before the Board members and presented the District reps with a well-received grant of \$250,000.

Following the Chevron presentation, a representative from Piper Jaffray stepped to

## Bob Hughes

Earl "Bob" Hughes, age 81, passed away on October 11, 2012, in Arroyo Grande, CA. A true "Gentle Giant", Bob was an international champion who never sought recognition. He was a remarkably humble man whose footprint in life touched so many. A former Los Angeles County Beach Lifeguard, Olympic swimmer, water polo player, water polo coach, beloved high school teacher and artist/sculptor, Bob was a quiet, engaging man who had a way of touching the lives of others with his honest and friendly nature.



Breaststroke and on the U.S. Men's Water polo team, where his team finished fifth. He is the only man in U.S. history to qualify at the Olympic Trials and compete in two water sports at the same summer Olympics. He has been inducted into the USA Water Polo Hall of Fame, the El Camino College Hall of Fame, the California Community College Coaches Hall of Fame, and the USC Hall of Fame. Although he appreciated the historic consequences of his role in Olympic history, he was a modest man who avoided the spotlight, choosing to lead a quiet, private life with his family and dear friends.

We mourn the loss of a good man and also celebrate his remarkable life. His acceptance and peace in passing was to be admired, and we will sorely miss his utter joy in the adventure of life. He is survived by Suzanne, his wife and best friend of 54 years; children Dina McCrum, George, Gary Hughes, Sandra Cirilo and Mark Hughes; grandchildren Mimi Stange, Carlie Hughes and David Hughes; his older brother Donald Hughes, cousin Greg Bott, and nieces and nephews. He was born Dec 15 1930 in Los Angeles and graduated from El Segundo High School in 1948. He attended El Camino Junior College in 1948/50 and then enlisted in the U.S. Coast Guard during the Korean conflict. After mustering out of the Coast Guard, Bob was recruited with a full athletic scholarship by USC where he swam and played water polo for the Trojans from 1954 - 1956. He represented the U.S. in water polo at the 1952 Olympics in Helsinki, Finland where his team finished 4th. At the 1956 Olympics in Melbourne, as a dual water sport athlete, he was the U.S. Men's single entry in the 200m

## Students Receive New Opportunities through Project Lead the Way

El Segundo High School students have been provided a unique opportunity to engage in science through investigating, examining and solving medical challenges through a new Biomedical Pathways Program. Project Lead the Way: Biomedical Sciences Program offers courses that attempt to better prepare students to be at the head of innovation in science, technology and medicine. Thanks to the partnership between The Murad Family Foundation—a charitable organization dedicated to promoting inclusive health in education and action to help young people to lead healthier and more connected lives—and the El Segundo Education Foundation, El Segundo High School students will have the opportunity to engage in the four-year program.

"We are trying to create an interest and provide structures and education in a meaningful way that will allow the kids to pursue potentially a career in the biomedical sciences," El Segundo High School Principal Jim Garza said. "What we are trying to do is create a real-life, real-world application for our kids at a pretty early age. The beauty of the program is that you are not tied into it necessarily because the students can explore other options. We currently have kids that are taking bold pathway programs [engineering], so they're taking introduction to engineering and this new one. It gives the kids a good experience to see if this is something they want to major in or pursue as a career option."

The Biomedical Science Program is structured in four different components that follow each other in sequence. The first element of the program is the principles of biomed, followed by the human body systems. The third portion of the program deals with medical interventions and the program concludes with a capstone piece on biomed innovation. Students can take one class of the sequence or they can take all four classes.

Though the courses are considered electives, they correlate with the academic core requirements asked of from each student.

"The superintendent and the principal of the high school recognize that they needed to offer the kids that are really smart in math an outlet," CEO of the El Segundo Education Foundation Carol Pirsztuk said. "With the biomed program, they could get their feet wet in the biomedical sciences to determine if it is an area they would like pursue. It is really the choice of the child and if they want to get into it, this gives them an opportunity to learn about science in a fun way. The program is kind of run like a CSI program—it is more investigative and doesn't just rely on book learning and memorization. It is more practical learning."

It was necessary for the high school to hire a teacher, Erica Zug, with an extensive science background to lead the program. So far the students have responded well to the new program, which requires more of a hands-on approach to learning. "What they are doing is that they are able to explore. We just did a heart dissection and we began with them drawing the heart and learning the flow of blood through the heart," Zug said. "Then we looked at an app on the iPad about blood flow through the heart. When they actually got to dissect the heart, they were finally able

to make the connections and see what the artery looked like that the blood was flowing through, and what the different chambers of the heart looked and felt like. That was a really neat opportunity for them."

While applying the learning techniques in the biomed courses to other classes has benefited some students in the program, the course has also created enthusiasm among the students. There are currently 110 students in the program and it is expected that more will join in the next year.

"It's a lot of fun. I was interested in being a dentist and this just gives you an overview of all the different careers options," ninth grader Jamie Mullins said. "It is a fairly difficult program. However, you learn a lot because it's so hands-on and that makes it easier to understand. In biology class you read books, but in this program there are no textbooks. It is all hands-on activities, worksheets and you get to use iPads. You just get to use so many different resources. It definitely helps me, especially in biology. If I was just taking biology, I probably would not have been doing as well as I am right now."

Helping students succeed is at the core of the Murad Family Foundation, which will donate up to \$180,000 to the El Segundo Education Foundation earmarked to support the Biomedical Sciences Pathway program. "Project Lead the Way program in Biomedical Sciences is a perfect fit for the Foundation," Hilarie Murad, President of Murad Family Foundation, said. "As an organization founded by a physician, research and development and medical sciences have always been at the forefront of our business. Having the opportunity to provide important educational tools to encourage students to become engaged and passionate about something we are at a young age is a win for everyone. Hopefully one day, local El Segundo kids that participated in this program will be working with Murad on developing the latest innovations in healthcare."

For the Education Foundation, establishing the partnership with the Murad Foundation has been a win-win situation for everyone, but most importantly for the students. "There were a couple of meetings where we presented the program and they were engaged quickly and they understood the need for offering elective programs to kids in the sciences arena that engage kids at an early age to determine if they want to go in the medical field," Pirsztuk said. "It's been very positive and within the first week we had about 10 students that wanted to transfer into the class. It's kind of nice that we created excitement around science."

Students that complete all four elements of the program will be recognized for their achievement during graduation, where they will receive a special certificate indicating that they completed the biomedical pathway program. Earning a certificate is considered something that colleges would appreciate in an enrollment application.

"None of this would have been possible without the support of the Education Foundation and our corporate donors as well," Garza said. "We provide the students with real-world problems and then they get to apply their knowledge. Hopefully this class provides them with a real-world opportunity to apply what they are learning in this class."

#### What is Measure J?

The additional funds will be used to secure bonds, which will allow Metro to accelerate construction of traffic relieving projects and the related job creation. #### New El Monte Station Opens

The new \$45 million El Monte Station public bus terminal at Santa Anita Avenue and Ramona Boulevard opened October 14. It has been expanded to double its original size and capacity, and includes a two-level bus station with 30 bus bays, bike lockers, customer service center and potential future retail outlets.

#### Feds Approve \$546 Million For Crenshaw Line

The Crenshaw/LAX Transit Corridor Project received a \$546 million federal loan to accelerate construction of a light rail line in the Crenshaw District. #### Sunset Bridge Opened

### Eagles Let Opportunities Slip Away

The El Segundo Eagles played host to North Torrance in an all-important Pioneer League football contest. What was on the line for the winner was the inside track for a league championship and a ticket to the postseason known as the CIF Northwest Division playoffs. Each team came into the game with a 2-0 league record, but North Torrance prevailed in a 35-7 triumph.

With games against Centennial and South Torrance left on the schedule, the Eagles aren't out of the title hunt just yet. North Torrance still has South Torrance and Torrance left to

play and both of those schools are looking to crack the playoff picture themselves.

In this game with so much at stake, the Saxons attempted to intimidate El Segundo players before kickoff. Saxon players taunted Eagle players while the hosts were jogging down to their end zone and stretching. The bush league Saxons were then ordered to their bench by the officiating crew.

The Saxons, who average 43 points per game, went on a 15-play drive spanning 91 yards to open the game. Jorge Hernandez, who has thrown for over 3,200 yards thus far on the year, completed seven passes including a two-yard TD pass to Devante Jenkins.

The Eagles backed the Saxons up to their own nine yard line on the second possession. The result was a defensive stand by the Eagles that forced North Torrance to punt from its own end zone.

The Eagles' only scoring drive of the night started at the Saxon 44 yard line near the end of the first quarter. Sophomore quarterback Lars Nootbaar found Matt Keener open for 12 yards and Jamie Stewart open for another five yards. On fourth and 10, Nootbaar found Keener open for a 13-yard gain to the Saxon 19 yard line. Henry Doby blasted through the middle for five more yards. On the first play of the second quarter, Nootbaar threaded the Saxons' defense with a pass to Stewart, who made an incredible one-handed grab in the end zone to tie the game at 7-7.

North Torrance would go on to score the go-ahead touchdown in the second quarter on a pass from Hernandez to Michael Jurado. Jenkins would catch two touchdown passes in the second half and Hernandez would run the other one in himself to close the scoring.

The Eagles certainly had chances, but dropped passes and penalties marred their drives. They had one eight-play drive and another one that spanned nine plays only to come up empty.

Nootbaar, who led the Eagles to two consecutive comeback wins, could not do it this time. He played with the cool and calm of a seasoned quarterback and was on target throughout the game. His receivers at times made great catches and there were times that passes fell incomplete.

Even still, Nootbaar's numbers were surprisingly as good as Hernandez's. While the South Bay's most proficient passer was 21 of 30 for 227 yards, Nootbaar completed 20 of 40 passes for 198 yards.

Eagle head coach Steve Shevlin was upbeat

about the game's outcome and said the season isn't over because of one league loss. "Look, that's a good football team over there and the better team won tonight. It doesn't mean I think they're a better team than us. They just had our number tonight."

The game may have been different had El Segundo played with a full deck. Three key players were missing due to injuries, including two defensive backs/receivers--Seth McKenna and Kaylin Franklin. Another defensive standout, Connor Underwood, is out for the year with a shoulder injury. "There's no telling how the game's outcome would have been had we been at full strength, but I'll take the effort we gave any day," said Shevlin.

The Eagles' playoff hopes rest totally in their own hands. They travel to face Centennial Friday at 6 p.m. A win against the Apaches would give the Eagles an edge for a playoff berth. It would most likely set up the most important game of the year on November 2 at South Torrance.

The football feeder program continues to shine. The freshman team is vying for its third consecutive Pioneer League crown on the leadership of Shawn Green. The Eagles are 6-2, 3-0 on the year with their latest 32-28 victory over North Torrance.

Alex Rios returned two punts for touchdowns and was on the receiving end of another one. Will Davis led the ground game by rushing for two touchdowns and he was in on 12 tackles on defense.

Coach Green believes his team's success has been linked to the steady play of the offensive line that includes Ben Saucedo, Ben Barsky and Sam O'Conner. He also says that quarterback Jason Kiel has played brilliantly in directing the offense.

With a bye this week, the Eagles will host

#### Cross Country Milestone

### TREAT YOUR TREES

While trees growing in the wild get along quite well on their own, human assistance is required for those planted in the urban forest. The general needs of trees are pretty simple and begin with putting the right tree in the right place.

- Space – know the mature size of a tree and its root system before you plant.
- Sun – know the sun or shade requirements before you plant.

- Soil – amend poor soil while planting.

After planting, water is the most critical issue and lawn sprinklers are not enough. Give new trees five gallons twice a week for three months and then 10 gallons once a week for the remainder of the first year and 20 gallons monthly until age 3. Mature trees are happy with an hour or two of a slow drip from a garden hose monthly during the dry season. Protect your tree's most vital organ, the root crown, by not allowing grass, ivy or other plants to touch the tree trunk. Nip disease or infestation in the bud by calling a Certified Arborist if a tree begins to look less healthy. Trees ask very little in exchange for the multitude of things they do for us. Treat your trees!

for an encore. "The people of the South Bay have really supported El Camino through the years with recognition and understanding," he said.

That recognition factor is off the charts when you consider the results from a recent poll of 700 voters in the district. "In the survey, 99 percent of the people said they had some association with El Camino—either through taking a class themselves or having a child or relative go there, or attending a performance," said El Camino Community Relations Director Ann Garten. "The pollster had never seen anything like it." The survey also indicated an El Camino favorable approval rating of 83 percent, with 68 percent of respondents saying they would support a bond extension (60 percent with knowledge of a tax increase). If passed, the bond will cost district homeowners \$7 per \$100,000 of assessed valuation on their properties. The original bond has fluctuated between \$16 and \$19 of assessed valuation, making a potential combined total of approximately \$26 per \$100,000 from the two measures. If the new measure passes, El Camino would still only be in about the middle of the pack in bonded indebtedness compared with the other dozen community college districts in Southern California.

An independent Citizens' Oversight Committee, in place since 2002, would continue to oversee the audited disbursement of the bond monies and keep the public informed of revenues. By law, funds from any proposed bond can only be spent on buildings, classrooms and instructional equipment. The funds cannot go towards administrator pensions or salaries and notably cannot be taken away by those folks up in Sacramento.

El Camino's current enrollment of 25,000 is down a bit from past years due to reduced State funding. "We're down close to 10 percent in funding and closer to 20 percent in classes we've offered," said Fallo. Garten elaborated further. "Giving us less money is telling us to educate fewer students since you have to offer fewer courses," she explained. "But the key is that if you are graduating from a high school in the district, you will get early registration priority."

El Camino's district includes El Segundo, Hawthorne, Hermosa Beach, Inglewood,

Lawndale, Lennox, Manhattan Beach, Redondo Beach and Torrance, though the campus is open access and available to students outside of those communities. That said, the percentage of new graduates who enroll at El Camino in fall semesters is unusually high compared to other community colleges. Forty percent of new graduates move on to El Camino from Hawthorne, Redondo Beach and Torrance high schools, for example. The other South Bay cities range from 15 to 35 percent. El Camino also reports the state's number one transfer admission rate to UCLA and third highest to USC, as well as top 10 rankings in transfers to University of California (UC) and California State (CS) schools. At the same time, the costs to attend UC and CS systems have become increasingly prohibitive, leading students to rely on El Camino more than ever as a viable and affordable academic alternative.

Opponents of Measure E contend that the bond will only fund construction projects and not classroom instruction, faculty salaries or job training. In their argument against the initiative, they note that the number of available classes at El Camino has been cut by 20 percent, academic counseling staff is also down 10 percent, and tuition there has doubled in the past three years. The opponents describe the bond as "another blank check for wasteful spending at a time when many are struggling financially." In their rebuttal, bond supporters emphasize that other college systems are still six times the cost of El Camino and that voting yes on E "ensures that students can effectively prepare for transfer to four-year universities by updating outdated classrooms, buildings and technology."

Fallo pointed out that El Camino--like virtually every other academic institution in California--continues to suffer the consequences of the State's beleaguered finances. "The funding cuts have hurt class offerings across the board," he said. "The bond updates are critical to prepare students for university transfer or entry to a successful career."

Garten added, "We're replacing buildings that weren't funded in 2002, that are more than 50 and 60 years old and bringing them up to date with new equipment. There's always a constant need." •

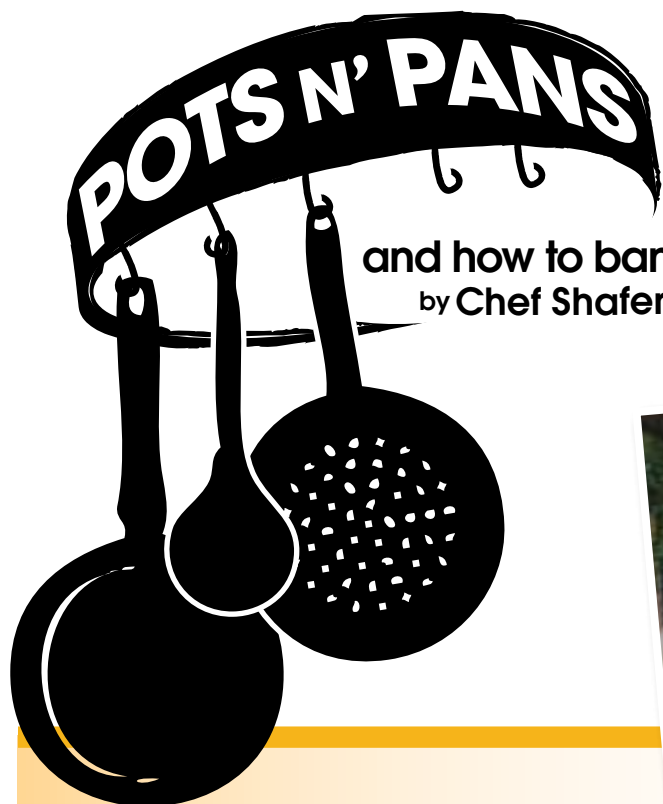

With Halloween just around the corner I thought it would be cool to make a pumpkin brown rice and bacon risotto.

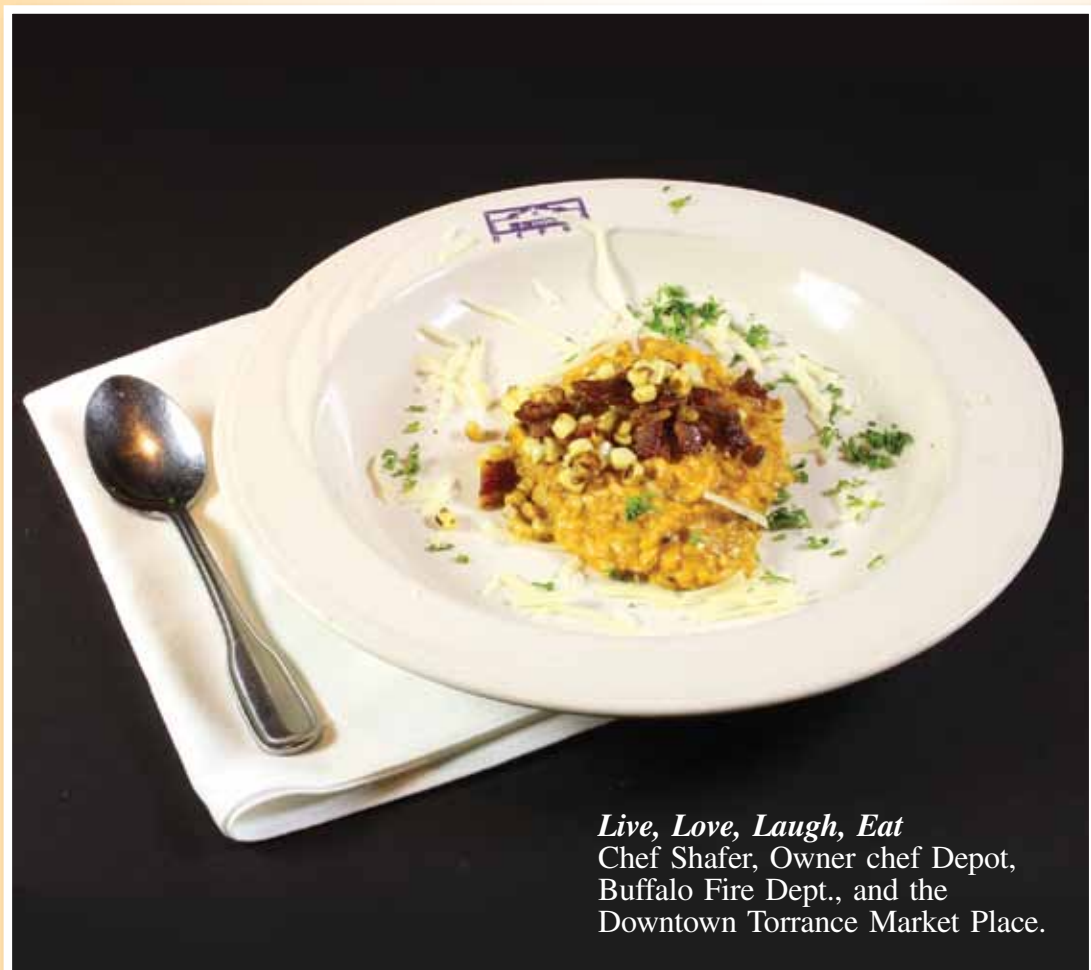
Now classically risottos are made with Italian rice called Arborio. It is a round almost pearl shaped rice. In Italy risotto is served as a primi or first course. It's the method of cooking the rice by adding broth till it reaches a creamy consistency that makes it such special dish. It then can be flavored any way you wish with different cheeses or different flavored broths or herbs.

But in today's kitchen risotto has become a cooking method more than an actual dish. Now you'll see on menus corn risottos, potato risottos, and grain risottos.

Here is my pumpkin risotto.

- 3 tablespoons olive oil
- 3 cups raw brown rice
- 10 cups chicken broth  
or any broth you would like
- Salt and pepper to taste
- 1 can Libby pumpkin meat
- 1 cup parmesan cheese
- 3 tablespoons unsalted butter
- garnish
- 1 cup fresh cut corn
- 6 pieces of bacon diced and sautéed
- ½ cup parmesan

In a saucepan sauté the onions in the olive oil. Add the rice and let it mix with the onions for 1 minute. Add 3 cups of the broth and stir till it is absorbed then continue adding broth will stirring till the rice is tender about 30 minutes. Fold in the pumpkin butter and cheese heat slightly and serve. Garnish with fresh cut corn and sautéed diced bacon, and parmesan. •

the podium to speak of the general obligation finance opportunity available to the District. The general obligation refunding should save the average taxpayer resident about 11 bucks per year, or \$102.50 over the next nine years.

The consent agenda portion of the 60-minute gathering featured the approval to enter into the continuing agreement with Northrop Grumman to have El Segundo High 12<sup>th</sup> grade students take advantage of internship opportunities with the local aerospace icon.

The long-running High School Involvement Partnership Program (HIP) provides students with the opportunity to retrieve training in more than 40 possible career paths, including engineering, manufacturing, office administration, environmental management, health and safety, model building and firefighting. The training will begin in February and conclude with a recognition ceremony in late May.

El Segundo High instructor Linal Miller, who is closely involved with the internship programs, noted in an email prior to the meeting, "For over 40 years, the HIP program has allowed students to learn career-based skills in a large,

professional workplace setting. Students earn high school credits while working in departments such as engineering, medical, graphic design, human resources, corporate citizenship, factory/tool building and security. This provides the students with the experience and networking that are vital for employment in today's economy. Northrop Grumman encourages students to stay connected and perhaps come back as employees in the future. In addition, all students who participate are eligible for scholarships upon entrance to college. We are fortunate to have Northrop Grumman so close in proximity to the High School and thankful for their investment in our students."

Also approved was a college scouting field trip for High School students to travel to Northern California and check out the matriculation opportunities at UC Santa Barbara, Cal Poly San Luis Obispo, UC Santa Cruz, Cal State San Jose, Cal State San Francisco and UC Davis. The trip will begin on February 28 and the students are slated to return on March 2. The cost is approximately \$300 per student and includes transportation and housing. •

The City of El Segundo (City) is the Lead Agency under the California Environmental Quality Act (CEQA) for the preparation of an Environmental Impact Report (EIR) for the El Segundo South Campus Specific Plan Project (Project). Consistent with the requirements of CEQA, the City has released this Notice of Preparation (NOP). The City seeks comments regarding any specific concerns related to the potential environmental effects of the Project. Information gathered during the NOP comment period will be used to shape and focus future analysis of environmental impacts. The proposed El Segundo South Campus Specific Plan Project is located in the County of Los Angeles, in the southeast quadrant of the City of El Segundo, approximately 19 miles southwest of downtown Los Angeles. The Project site is more specifically located at 2000-2100 East El Segundo Boulevard, south of East El Segundo Boulevard, in the block between South Sepulveda Boulevard and South Douglas Street.

The Project proposes to establish a maximum allowable development within the Specific Plan area boundaries of 3,718,889 net square feet, or an additional 1,916,376 net square feet over existing conditions, and including office, warehouse, light industrial, and retail/restaurant uses. In addition to the Specific Plan, the proposed Project entitlements include a General Plan Amendment, a General Plan Map Amendment, Zone Change, Zone Map Amendment, Zone Text Amendment, a Vesting Tentative Map, and a Development Agreement.

Should the El Segundo South Campus Specific Plan be approved, all future development proposals within the Project area must comply with the Specific Plan. It is anticipated the actual amount of development would be refined during subsequent entitlement processes. However, future development could not exceed the development limits established by the El Segundo South Campus Specific Plan.
