## School Board Views Presentation by High School Representatives

The final El Segundo School Board meeting prior to the Nov. 5 election featured a presentation made by El Segundo High School representatives detailing the "State of the School" on the campus and the strides made to prepare students for success not only now, but as they matriculate to universities and seek to become successful members of the 21<sup>st</sup> Century workforce. El Segundo High Interim Principal Ali Rabiei was first to the podium and introduced an overview of the High School PowerPoint presentation entitled "The Best is Yet to Come." Rabiei framed the presentation, promising how the future has changed, and how El Segundo Unified School District students were being well-prepared for the 21<sup>st</sup> Century challenges that face them during their school years and post-graduation.

Leadership Chair and El Segundo High teacher Mark Doering spoke to the Board about the State's Common Core standards that are now being implemented district-wide. The Common Core standards represent a change in the way students are taught and evaluated in the classroom. The Common Core standards, currently in place for English language arts and mathematics, strive to better prepare students for immersion in the post-high school world, with narrower,

more in-depth education and less reliance on teaching to standardized testing based on rote memorization.

Doering called the implementation of the Common Core standards "an amazing transition" with endless possibilities. "The

time is now," he said, adding that it was "the toughest time I have had teaching as far as getting things together, but the most rewarding and the most fun."

Next up was teacher Jason Ito, who

# School Board Elections

## El Segundo School Board Candidate Bill Watkins

A teacher and administrator in the El Segundo Unified School District for 38 years before his retirement in 2001 as Superintendent, Bill Watkins hopes to serve a third term on the El Segundo School Board on which he has sat since 2005. He believes he offers the distinctive advantage of having worked in every facet of local education through various economic times. "Continuing to improve our academic programs for all of our students with the current funding from the State will continue to be a major challenge for the Board," Watkins said. "To accomplish this, I am prepared, through my educational and employment background, to continue to bring a unique perspective to the Board."

A Los Angeles native who moved to the Del Aire area at the age of 10, Watkins attended Dana Middle School in the Wiseburn School District and graduated from Hawthorne High School, El Camino College and then George Pepperdine College with a teaching credential. He earned a Masters degree from California State University Dominguez Hills and a Doctor of Education in Institutional Management from Pepperdine University Graduate School of Education and Psychology. A local resident since 1972, Watkins is married with two children who graduated from El Segundo High School. Two of his five grandchildren grew up here and graduated from or currently attend El Segundo High.

Beginning his academic career 50 years ago, Watkins taught English at El Segundo High from 1963 to 1979 and coached the tennis team from 1968 to 1979 when he became Athletic/Activities Director. He moved to the Assistant Principal position from 1980-1984, overseeing athletics and activities. He served as El Segundo High Principal for the next 10 years before becoming Director of Curriculum and Instruction and then Assistant Superintendent for the District. Watkins was briefly Interim Superintendent and then Superintendent of Schools from 1997 until his retirement in 2001.

Watkins noted that during his tenure as Interim Superintendent, El Segundo voters passed the first of three bond measures, and as Superintendent he oversaw the modernization and reopening of El Segundo Middle School



and Richmond Street School. Upon retiring, he worked to pass Measure E and served on the financial oversight committee for that bond. During that period, the District also completed the restoration and modernization of Center Street School and El Segundo High. Among Watkins' other affiliations were stints on the El Segundo Education Foundation Board (with additional roles as Chair of the Community Giving Committee and membership on the Superintendent's Roundtable). He is currently a representative on the Southern California Regional Occupational Center Board of Education.

In addition to overseeing past academic successes during his time working for the District, Watkins pointed to his track record over the past eight years on the School Board as a compelling reason to elect him to another term. "An area that all Board members can be proud of is that we maintained a fiscally sound district with the help of the parents and PTA, the Education Foundation, the City, and the business community at a time when our country and state went into a deep recession," he said. "El Segundo students continued to receive an outstanding education, which is exemplified by the state Academic Performance Index [API] scores. In addition to maintaining a strong academic focus at all grade levels, I am most proud of El Segundo Middle School's transition to an International Baccalaureate [IB] school. I have been interested in the IB program for many years because it allows our students an

## One Man's Opinion

*Through many dangers, toils and snares  
I have already come;*

*'Tis Grace that brought me safe thus far,

In the ultimate irony, before the Republican capitulation on all issues that had brought the government to a partial standstill, Congressman Steve Southerland (R-FL), a funeral-home director, led the House in a rendition of the traditional burial hymn *Amazing Grace*. For some, this song was simply a replacement for the House's morning prayer. For others, it marked the death of the last Republican proposal to end the shutdown. But for still others, it signaled the death of the Republican Party.

The Republican predecessor, the Whigs, bickered and remained on its death bed for five years before disbanding. So should Republicans. For five years, they have been unable to make a single, simple point: Specifically, Obamacare is the foundation for our economic malaise.

It creates or raises taxes, slows job growth and replaces full-time jobs with part-time jobs. Its goal is to enroll seven million new insureds, but government and private organizations project 11-35 million will lose employer-provided insurance. It diminishes family income. Its projected cost has exploded from \$960 billion to \$2.6 trillion--a 270-percent growth in three years. Medical care will be rationed. Administratively, the Obamacare website cost \$634 million and is nonfunctional. By its most crucial measurement, at full implementation, 30 million will still remain uninsured. Any moron should have been able to forcefully

tell this story, but not Republicans.

Steve Forbes, editor of *Forbes Magazine*, offered a seven-step modification to Obamacare, but Republicans ignored it. Specifically: Allow interstate shopping for medical insurance. Eliminate coverage mandates and allow companies to offer an array of plans, allowing consumers to shop for the plan that best suits their needs. Provide tax deductions for individuals for buying insurance. Initiate medical malpractice tort reform. Eliminate government employee exemption from Obamacare. Create high risk pools to mitigate the impact of premium jumps on healthy consumers. Prevent Medicare money from funding Obamacare. Again, a simple story to tell, but Republicans failed.

What has the end to the government impasse shown us? It shows Obama will not compromise and will give no quarter to the party that is busy committing suicide. In two steps, he will drive the Republican Party from existence. First, the outlines of a budget accord must be reached by mid-December with final agreement by Jan. 15, 2014. Expect sequester spending cuts to be erased, while new spending initiatives and taxes will be increased. Then in its second step, he will force the raising of the national debt from its current \$16.95 trillion (\$125,000 for each working American) to over \$18 trillion!

The hapless Republicans are defenseless. They have played the shutdown hand poorly and can only quietly acquiesce, folding their tent. Any political party that over five years cannot make two simple arguments does not represent its constituency and does not even coherently represent a point of view. It therefore deserves its fate.

### Another Inefficient Solution to a Serious Problem

A few weeks ago, Governor Jerry Brown signed Assembly Bill 60, authored by Assemblymember Luis Alejo, which grants the opportunity for undocumented immigrants to apply for a driver's license. There are many theories and arguments in favor and against such a move. Whether or not you are in favor of giving a driver's license to someone who is in the country without permission, this new law is a fresh example of how badly the issues with our immigration system need to be fixed. In addition, AB 60 highlights the inefficiency of our federal government's ability to solve an important task.

First of all, if the federal government is responsible for determining immigration policy and states have resorted to enacting laws within their borders to help deal with the issue of undocumented immigrants, then that proves how badly the federal government is failing at its task. This failure can be attributed to more than a handful of factors. The easiest thing to address is border security. Between arguing about building a wall at the United States-Mexico border or increasing border patrol personnel, little has been done in regard to either one. As a result, the border remains unprotected and vulnerable to human trafficking rings that will exploit every opportunity to make money. Furthermore, there is the issue of companies hiring undocumented workers. For years, the approach has been to punish and deport the source of cheap labor (undocumented workers) while the ones creating the demand (businesses) got off with a slap on the wrist

at best. So while one group of undocumented workers left the country, businesses recruited a new batch of similar workers. The recent E-Verify Program is supposed to help and there has been a decrease in the amount of undocumented workers hired by large companies.

The reality is that if the borders were better secured and if businesses that hired undocumented workers suffered more severe and serious consequences, there would be less of a need for states like California to enact laws granting driving privileges to these workers. Opponents will say AB 60 does not make our roads safer and that it rewards a group of people violating the law. That's true. Supporters argue that these people are working and acting as productive entities in society, so the driving privileges are being extended to a group of people contributing to the economy. That is also true. What is additionally true is that if the federal government took the issue of border security and immigration trends and policy more seriously, we would not be in this position.

If imposing fines and penalties removed the incentive for businesses to hire undocumented workers, then there would be a smaller pool of undocumented laborers waiting to jump into the workforce. Not to mention, these businesses would have to follow the rules like the majority of business owners. If the border was better protected, there would be an even smaller pool of undocumented workers. Hence, we would not have to resort to controversial laws such as AB 60. •

### Governor Signs Senator Wright's Gun-Storage Bill into Law

SACRAMENTO – As the deadline for bills passed this year to be signed or vetoed approached, a measure by Senator Roderick D. Wright (D-South Los Angeles) to help keep

guns out of the hands of those individuals the law prohibits from possessing them was signed into law Friday by Governor Jerry Brown.

Under current law, gun owners only have a responsibility to keep their guns secured and out of the reach of children. Problems can

arise, however, when a licensed gun owner resides in the same home as someone who is legally prohibited from owning a firearm, usually due to previous crimes.

Senate Bill 363 creates a safe storage requirement for a person who legally owns

right to own a gun for their own protection, but they also carry a responsibility to do what they can to keep that gun from falling into the wrong hands and becoming a threat to the community," said Wright.

Wright is a vocal proponent of the right

a firearm and resides with a person he or she knows, or has reason to know, is prohibited from owning a firearm. Under the bill, a gun owner would face misdemeanor charges if they store a gun unsafely and it is used by the prohibited person residing in their home to cause bodily injury.

"Law-abiding citizens have a Constitutional

to responsible gun ownership. Last year, he passed a bill to streamline the process for applying for a Concealed Carry Permit in California, and in the last days of the 2013 Legislative Session, he spoke out against several of the overreaching gun control bills, which were vetoed by Governor Brown this month. •

### Karsseboom and Stewart Lead Homecoming Win

The 2013 Homecoming Game between El Segundo and Torrance will most likely be remembered for years to come. In what became an emotional game between two teams vying for a Pioneer League championship, the Eagles came from two touchdowns down in the first quarter to defeat the Tartars 31-24.

This game resembled two prize fighters going at it toe to toe all game long. It was also a poignant game between these two teams not knowing if they'll be playing each other

soon after this season. The Pioneer League is reorganizing and as it is now, the Eagles will be moving into the Ocean League as soon as next fall.

With Homecoming Game festivities, you get all the hype of the game as well. This pitted two teams annually near the top of the standings. This was an important game for both teams with the winner all but assured of a postseason berth in the CIF Southern Section Northwest playoffs. Each team entered

the game with first game wins in league play.

Torrance came out swinging first and went on a 10-play, 78-yard drive to take the early 7-0 lead. Quarterback Gabe Gonsalves scored on a keeper from eight yards out. The Tartars extended the lead later after a 76-yard punt return by Bobby Wilson put the ball on the Eagle one yard line. Eagle punter Jamie Stewart had chased down the speedy Wilson near the goal line. Sean Luna scored on the next play to make it 14-0.

The turning point of the game came on the second play of the second quarter. The Eagles were forced to punt and JP Rubalcava's high end-over-end punt was touched by Torrance's Wilson. El Segundo's Ryan Kelly quickly fell on the ball and the Eagles took advantage.

Eagle quarterback Lars Nootbaar found Nick Karsseboom open on a fly route near the Tartar 11 yard line. Then Karsseboom made an acrobatic catch and went into the end zone on the 50-yard pass play.

Eagle head coach Steve Shevlin thought the recovery of the muffed punt was a key part of the game and his team capitalized on the big mistake. "Torrance would have had great field position and possibly a three-score lead if Ryan [Kelly] doesn't recover the ball," said Shevlin. "That play was a game-changer and then Lars [Nootbaar] and Nick [Karsseboom] put us on the scoreboard. That was huge."

Whenever Jamie Stewart is on the field, you have to be aware of his electrifying speed and his knack of befuddling the opposition.

In this case after El Segundo's defense shut down Torrance for a third consecutive time, Stewart fielded a punt near his 11 yard line and made two defenders initially miss him. Stewart astonished the crowd of 3,000 by making four more defenders miss and speed down the sidelines. The return was good for 89 yards and a touchdown to tie the score at 14-14 with 2:19 left in the first half.

The Tartars responded with a big-time play of their own. Gonsalves found Tommy Nash open on a 46-yard catch and run for a go-

ahead touchdown with 1:32 left.

That was no problem for the Eagles since the Tartars left too much time on the clock for Nootbaar. The Eagles were backed up on their own 20 yard line. Dathan Bailey picked up nine yards, Elijah Hale caught a pass for another 11 yards and Kelly had a reception near the sidelines for another 10 yards. Karsseboom's catch for another 16 yards gave Shevlin's team hope with 52 seconds remaining. Nootbaar scrambled for seven yards and got out of

bounds to stop the clock. Two plays later, Nootbaar found Stewart open on a 22-yard touchdown pass with 11 seconds left in the half to tie the score at 21-21.

The Eagles had faced their dilemma and the adversity of being down by as many as two touchdowns. After falling behind again, they came back to tie the game. "We made some mistakes and missed some reads, but the offense was clicking," said defensive coordinator Dan Heck.

Torrance took its first possession of the second half just over 50 yards, but the defense came up with a big stop to force a 46-yard field goal attempt. Nash's kick fell short and the Eagles took over on their own 20 yard line.

Nootbaar hooked up with Karsseboom on a 43-yard pass play. Then he found Stewart open for a 34-yard pass completion. On the next play, Bailey received great blocking up front from Gabriel Rocha and Dante Johnson to get into the end zone from four yards out. The Eagles had finally forged ahead for the first time and taken a 28-21 lead.

The defense came up with another turnover as Torrance was driving. The Tartars were in the midst of an eight-play drive when Hale stepped in front of the Tartars' Luna for an interception that was returned 53 yards to the Torrance six yard line. The Eagles couldn't punch it in and on fourth and goal at the three yard line and came up short in lieu of kicking a field goal.

### 'Tis Not The Season

The Los Angeles Dodgers have not won a World Series title since 1988 and after much hope, optimism and anticipation from the team's fan base for this year, that trend remains intact. After an impeccable regular season, many free agent moves that served to improve the team and some of the best talent that the Dodger uniforms have ever seen, it all came crashing down on L.A. in just one game. After finishing off the regular season strong and devouring the Atlanta Braves in the first round of the playoffs, the Dodgers knew that the last team that they wanted to see was the St. Louis Cardinals. This was why. As good as Los Angeles' pitching has been all season long, St. Louis' proved to be better. Clayton Kershaw is now 0-4 against the Cardinals this year. If the best pitcher in all of baseball can't beat them, then the Dodgers stood no chance.

Looking back to June 22, the Dodgers were in last place in the NL West and fans everywhere seemed to be giving up on a team that opened its pocketbooks in the offseason to manufacture a playoff contender. All of a sudden, as if over night, something in the clubhouse changed. The Dodgers began enjoying coming to the ballpark and

believed that they could beat any team that they played against. That showed too as the team went on to win 42 of its next 50 games and not only wind up on top of the NL West, but also as one of the best teams in the league. In that light, the season was a success for the Boys in Blue. Losing in six games in the National League Championship Series sure has a way of overshadowing all of the good from a season that is now over, though. "What does it really matter, making the playoffs or coming in last place?" a clearly dejected Clayton Kershaw said. "If you don't win the World Series, it doesn't really matter." Just like that, Kershaw's Cy Young caliber season, Yasiel Puig's remarkable rookie season and Zack Grienke's outstanding first year in Dodger blue all went out the window. Ninety-two wins means nothing to the Dodgers without a ring.

There is reason to be optimistic for next season. The Dodgers entered the postseason with an injured Matt Kemp and as many people forget, without one of their best pitchers who has been out all year in Chad Billingsley. Hanley Ramirez also had no right to be out there on the field after a wild pitch hit him in the side and fractured his rib. Andre Ethier was battling injuries

all postseason long, too. The team will also have a full year out of Puig and will most likely know now what it takes to upgrade some of the weaknesses that haunted the club early on in the season. This Dodgers' team, despite the large salary, defied the odds this year and gave its fan base hope--the first real hope that it has had since the 2009 season or possibly even well before then. Even still, the players don't see it that way yet. "It's great, but we didn't meet our goal," Dodgers' catcher A.J. Ellis explained. "I'm not really in the mood to pull out positives or moral victories right now. This hurts and it's going to hurt for a long, long time. Probably until we get to spring training and we get back together again, we're going to think about this and what could have been."

What could have been is a lot different than what was. An 11-pitch at-bat to Cardinals' lead-off batter Matt Carpenter sparked a run that wound up booting the Dodgers right out of competition. But between the lines, the Dodgers have somewhat of a bigger problem to handle this offseason. When Carpenter laced a double to right-center on that 11th offering, Beltran should have been walked with first base open. Ricky Nolasco maybe should never have taken the mound

in Game 4 of the series. In a pivotal Game 1 that went back and forth and eventually ended in the 13th inning, Adrian Gonzalez should have never been taken out in the eighth inning for a pinch runner, leaving a gigantic hole in the lineup. The Dodgers could have maybe been a little bit more prepared for Game 6, rather than playing games after the National Anthem. Instead of cheering on Scott Van Slyke to hold his position outside of the Dodger dugout in a stand-off of sorts with Joe Kelly, they may have been better served to keep their heads on the task at hand, figuring out how to get a hit off of Cardinal pitcher Michael Wacha.

Sources say that Mattingly will be back in Dodger blue to coach the boys into another playoff run. Maybe this year was pivotal. It gained Mattingly and his club the experience that is necessary to come up big in the World Series. There is no question that the talent exists on the Los Angeles Dodgers. How that talent is used, however, is the difference between putting a nice shiny ring on your finger at the end of October, or watching a team that you've lost to have that same opportunity. There will always be next year for the Los Angeles Dodgers, but that next year could have been this year. •

## Protecting Yourself from the "Invisible" Crime of Identity Theft

(BPT) - Identity theft: It's the subject of articles everywhere you turn. That's because the problem has exploded in recent years, as new methods for collecting, storing, sharing - and stealing - your personal information have developed.

"Identity theft is an increasingly pervasive problem, particularly in today's digital economy," says Trey Loughran, president of the Personal Solutions unit at Equifax.

Identity theft topped the list of national consumer complaints received by the Federal Trade Commission in 2012, for the 13th consecutive year. It accounts for 18 percent of all complaints, up from 15 percent in 2011.

Identity theft can involve taking over your credit account, stealing your tax refund, taking out loans in your name, accessing personal bank accounts or even running up medical bills using your name. You might not notice these crimes until they're done, which can mean you'll have months of inconvenience and time spent correcting the problem, in addition to the financial cost.

You may be more vulnerable than you realize. Common opportunities for identity theft include:

Collecting personal information you've shared over unsecured websites.

Completing change-of-address forms to redirect your mail.

Going through your mail or trash to find credit offers, bank and credit card statements, or medical records.

Stealing personal information you're carrying if your wallet or purse is lost or stolen

Stealing your mobile device

You could turn around and discover bad checks, loans or credit card bills that are suddenly your responsibility. Your savings account could be wiped out and your credit ruined.

Even children are vulnerable because of their clean credit histories.

Equifax recently launched a website, IdentityProtection.com, that provides consumers with information on identity theft and how to help protect themselves. "Consumers who are armed with useful knowledge and tools can be a powerful deterrent to the rapid growth of this 'invisible' crime," Loughran says.

The identity theft experts at Equifax offer some advice:

When you sign up for a catalog or add your name to a mailing list, consider if the benefit is worth sharing your personal information with someone who could potentially sell it.

If you sign up for email coupons or loyalty programs, don't share your full address or any financial information.

Ensure your passwords used for online banking and shopping sites are strong and unique; use a different password for each site. Mark your calendar to change your passwords every 90 days.

Request that your medical and insurance providers assign you a unique personal identification number. Don't reveal medical or insurance information by phone or email unless you made the first contact. File paper and electronic copies of your records in a secure location, and shred any outdated medical documents, including old prescription labels.

If your passport has been lost or stolen, prevent someone from ordering a new one in your name by contacting the U.S. State Department's Passport Services Department.

Remember - the IRS doesn't contact taxpayers through email, text message or social media. If you get a message from a sender that is identified as the IRS, don't respond or click on any links. Forward the email to phishing@irs.gov.

Don't wait until you or your family become victims of identity theft. The more you know about this problem and how to help protect yourself, the safer you'll be. •

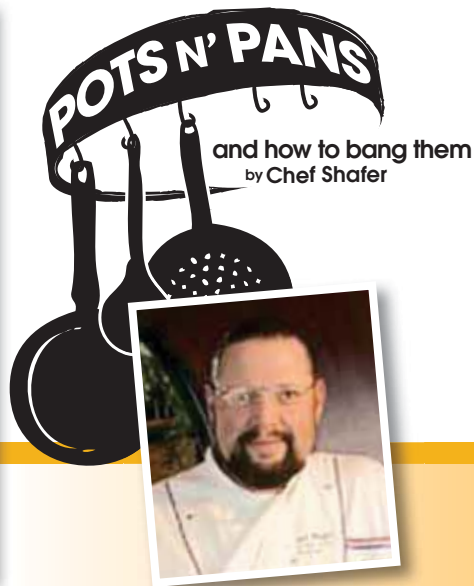

Torrance took over and moved the ball out to its own 25 yard line. The Eagles' defense made another stand to stop the Tartars after seven plays. On third and seven, Noah Bergren came up with a sack of the quarterback and the defense held to force a punt with four minutes left in the game.

Before punting, the Tartars called a timeout. After the timeout Torrance lined up in punt formation, but Hale keyed on punter Spencer Kovacs. Kovacs started to run for a first down,

but Hale put a punishing tackle on him for a loss and the Eagles took over on the Torrance 20 yard line. The Eagles then ran off valuable time and Rocha's 31-yard field goal with 2:37 left gave his team a 31-21 lead.

Torrance drove to the El Segundo 14 yard line where Nash connected on a 32-yard field goal with 0:12.8 showing on the clock. Kelly recovered the onside kick and the Eagles prevailed with the 31-24 win.

Offensively speaking, Nootbaar threw for

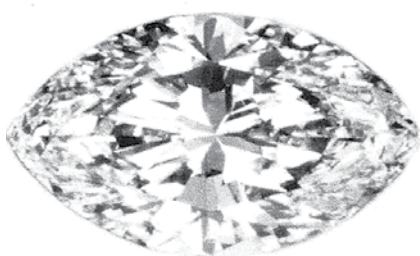

opportunity to compete on an international level. The results have been a marked increase in the Middle School API score.”

If elected again, Watkins promised that he will continue to focus on improving the District’s excellent academic program. “This can be accomplished by continuing to give our teachers the opportunity to work with our neighboring universities to hear about and integrate the latest teaching strategies and methods into their classrooms and to meet with their fellow teachers across grade levels,” he said.

Watkins also emphasized the need to make parents an integral part of the learning process. “We must offer our parents the

opportunity to learn about the curriculum being used with their children and to be an active participant in their children’s education,” he said. “We can do this by presenting to the parents the language arts, math, and science curriculum for each grade level at the beginning of the school year.”

As always, Watkins sees finances as the key challenge for the current and future Board. “We must continue to find alternative sources of funding for our educational programs,” he said. “I will continue to work with our parents and the PTA, the Education Foundation, our business community and the City to help fund our programs while maintaining a balanced budget. •

offered information about El Segundo High’s iPad program. He talked about how the objective wasn’t just utilizing technology for technology sake, but hoping to get the most “bang for the buck” with the iPad, and becoming a pioneer in the usage of the new age technology in the South Bay. Ito also talked about implementing iBooks into the curriculum, while teacher Jennifer Cho spoke of what she termed the campus’ implementation of iTunesU.

High School teacher Jason Simon spoke next, enthusiastically promoting the implementation of iBooks in his classroom. He talked of making textbooks more interactive for his students, calling it “a time of discovery.”

Teacher Steve Eno was the next presenter and he informed the Board members about the strides currently being made on the

Day slated for late February of 2014. Last year’s Career Day included the involvement of more than 80 career professionals.

Miller’s presentation also highlighted the fact that the courses feature a job board that is updated every two weeks; internships with 13 partnership companies, including 50-60 students; work experience for 14-20 students per semester; and field trips to possible work destinations like The Grammy Museum, SpaceX, the Los Angeles Crime Lab and Centinela Hospital.

Athletic Director Steve Shevlin, Teacher on Special Assignment and Campus Supervisor Tomas Romo discussed the on-campus Intervention Programs. Romo noted that the importance of the program wasn’t necessarily in dishing out the discipline for a student who made a misstep, but helping

Engineering Pathway. Eno’s presentation was framed “Engineering and the 21<sup>st</sup> Century Learner.” He gave a quick overview of the new aspects of the engineering program, and how it aligns with the Common Core standards. He mentioned the cutting edge Math integration that is happening in the Engineering department, and that the High School is doing its best to prepare the students for success in the 21<sup>st</sup> Century workplace, which he noted, is incredibly fluid and evolving at a breakneck pace as technology continues to evolve.

Eno spoke of the intertwining of math and engineering, and that the campus Engineering courses highlight the ability of students to define a problem, design, build and test the possible solution to the program--and then present and defend the solution to a panel of engineers.


Next up was Career Educational Advisor Linal Miller, who talked of the Career Explorations courses and opportunities that are being offered on campus. The career readiness resources include a planned Career

them after the initial disposition of the incident. “My job is about supporting the kids,” said Romo.

With no discussion items on the agenda, the Board approved eight consent items, including a consultant agreement with Behavior and Education for the provision of training and certification of seven elementary site Special Education Instruction Assistants in the area of discrete trial training at a cost of \$2,000. The behavior-based instructional technique has been research-proven to be effective helping students with autism.

Also approved was an ongoing internship with the El Segundo Police Department. In its third year, the program offers interested students the opportunity to view the behind-the-scenes workings of the local police department, allowing the interns to gain an up-close view of the skills necessary and expectations involved in considering a career in law enforcement.

The next regularly scheduled El Segundo School Board meeting is set for Tuesday, Nov. 12. •

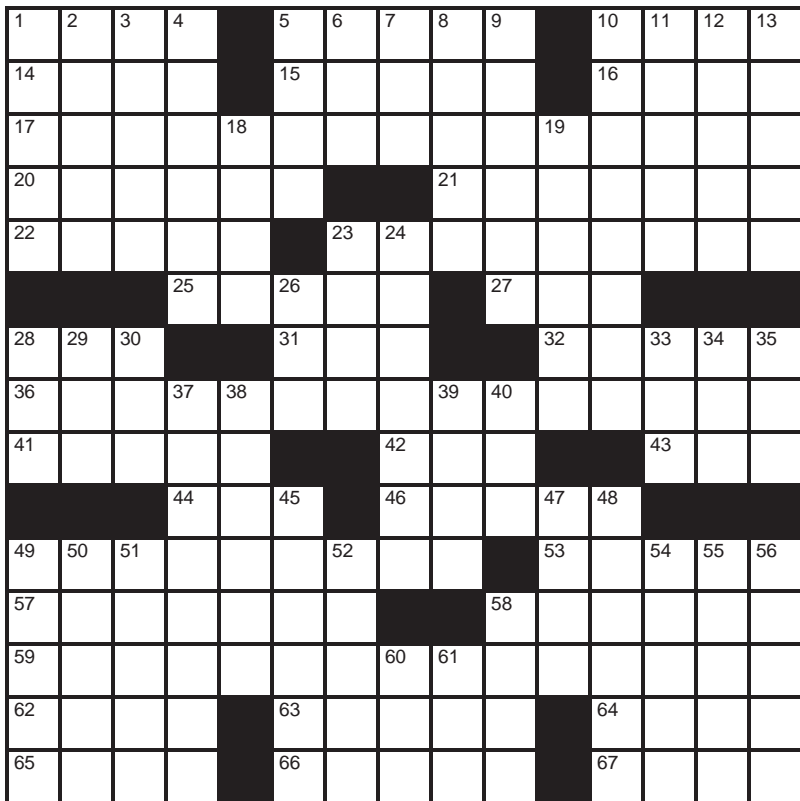

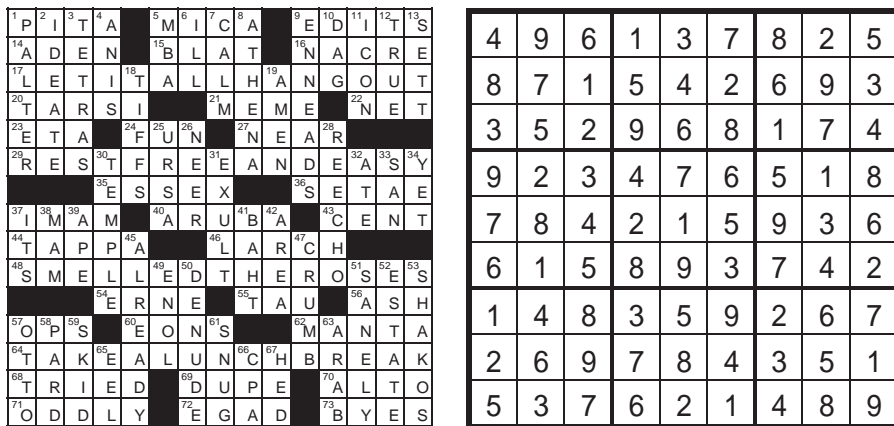

The addendum has been prepared under the authority of 14 California Code of Regulations § 15164(a) (CEQA Guidelines) which allows a lead agency to prepare an addendum to a previously certified EIR if some changes or additions to the previously certified EIR are necessary but none of the conditions described in CEQA Guidelines § 15162 of the CEQA Guidelines requiring preparation of a subsequent EIR occurred. The purpose of the addendum is to provide substantial evidence in the record to support the determination of the decision making body of the lead agency that none of these conditions has occurred as a result of the proposed changes in the Revised Corporate Campus Development. An addendum need not be circulated for public review but can be included or attached to the final EIR.

The proposed project includes certain modifications to an existing Specific Plan, Development Agreement, internal street circulation, and the approval of a Vesting Tentative Tract Map. The Revised Project proposes the same permitted uses under the existing Corporate Campus Specific Plan and Development Agreement and seeks minor amendments for a down-scaled development project.

The Revised Corporate Campus Development proposes to consider modification of certain development standards of the Specific Plan and Development Agreement that would: 1) Allow for the creation of green-belt lots with 30' foot minimum lot frontage; 2) Allow 80' minimum frontage for lots abutting to a green-belt lot; 3) Eliminate Campus Square East and convert it to a green-belt lot and maintain the current easement for utility purposes; 4) Modify the existing easement along Campus Square East to allow for the installation of

landscaping; 5) Approve Vesting Tentative Tract Map No. 72287; 6) Increase the maximum number of lots from 26 lots to 46 lots; 7) Allow parking on private streets on Campus Drive, Campus Square West, and that portion of Parkview Drive South located north of Fire Station No. 2; 8) Convert Campus Square West into a private driveway that will be improved with parking along the east side of the driveway; 9) Allow shared use of loading spaces with parking spaces during business hours; 10) Modify the existing recorded Parking Covenant to relocate the required parking for soccer field use within the project site during Phases 2 and/or 3; 11) Allow at-grade patios with 6-foot high walls, fences and hedges to encroach into front yard setbacks; and 12) Extend the Development Agreement by 2 additional years through June 11, 2020.

Other modifications to the Development Agreement may be made to reconcile changes in the property involved, the property ownership, the project description, and the other requested discretionary actions.

The original Corporate Campus Development project was approved in 2002 under EA-548. The approval also included a General Plan Amendment, Zone Change, Specific Plan, Development Agreement, and Subdivision. The original Corporate Campus included the development of 2,175,000 square feet of commercial, office, and retail on a 46.5 acre site. The project was approved with a .99 Floor Area Ratio (FAR).

In 2007, a portion of the site, approximately 13.7 acres of the 46.5 acres site was approved under EA-737. The project included the development of the northern portion of the site bounded by Maple Avenue, Nash Street, Atwood Way, and Douglas Street (the "Edge at Campus Project"). The Edge at Campus Project consisted of 216,000 square feet of commercial office and retail. The existing improvements within the original project site of 46.5 acres consist of: 1) the 216,465 square foot Edge at Campus Project; 2) a five-story, approximately 83,855 square foot, 143 room hotel/conference center (Hyatt Place); 3) two soccer fields; 4) City of El Segundo Fire Station No. 2; 5) a parking lot for the soccer fields just north of Fire Station No. 2; and 6) the internal roadway system that was part of the original site plan. In total the existing improvements constitute 304,820 square feet of the approved 2,175,000 square feet of development on the project site.

The proposed revised Corporate Campus under this application (EA-1021) proposes to develop the remaining 23.87 acres under three (3) phases. The 23.87 acres also includes 2.1 acres of private streets. Collectively the Revised Project will be 625,205 square feet of developed space and will consist of 611,545 square feet of office and 13,660 square feet of retail and restaurant uses. The project will have 2,114 parking spaces and will be developed with an overall Floor Area Ratio (FAR) of 0.60. The project will also include transfers of floor area (TFAR) from any parcel within the project. The project was originally approved with a FAR of 0.99.

Phase 1 will consist of 217,637 square feet on 12.3 acres. Phase 1 will be developed with 15 two-story office buildings totaling 203,977 square feet and 13,660 square feet of retail and restaurant uses under 2 buildings on 12.3 acres of land. Phase 1 will be developed with 732 parking spaces. Phase 1 proposes to be developed with a FAR of 0.40.

Phase 2 will consist of 193,228 square feet of commercial office with 634 parking spaces. The total site area under Phase 2 will be 4.4 acres. Phase 3 will consist of 214,340 square feet of office space with 748 parking spaces on 4.97 acres of land. Both Phase 2 and 3 will be developed with a FAR of 0.99.

The proposed Revised Project of 625,205 square feet combined with the existing improvements of 304,820 square feet total 930,025 square feet of the 2,175,000 square feet approved under the Original Corporate Campus project. The 930,025 square feet is 1,244,975 square feet less than the allowable development of 2,175,000 that was approved and analyzed in the Certified EIR. Additionally, the Certified EIR allowed for a daily maximum allowable trip count of 21,366 and the total existing development plus the proposed Revised Project will generate a total of 10,532 daily trips, which are 10,834

trips less than the maximum or less than half the trip generation used to evaluate the traffic impacts of the Original Project in the Certified EIR.

The proposed uses, buildings, and parking are consistent with the requirements of the Corporate Campus Specific Plan and with the Final EIR certified on January 2, 2002, for the Corporate Campus Project.

The proposed project remains subject to all conditions of approval that were required in EA-548, and any additional conditions which may be required for Environmental Assessment No. EA-1021, Specific Plan Amendment No. SP 13-02, Subdivision No. SUB 13-05, and Development Agreement Amendment No. DA 13-01.

ANTICIPATED SIGNIFICANT ENVIRONMENTAL EFFECTS Based on the analyses in the Addendum to the Certified EIR, following incorporation of mitigation measures, the project would have no additional significant and unavoidable impacts not previously identified. The project, as analyzed in the Certified EIR, has a significant and unavoidable impact relative to transportation/traffic, air quality, and construction noise. The proposed project will also contribute to a significant cumulative impact relative to traffic/transportation, regional population growth and housing, and solid waste but will less than the Original Project as the Revised Project is smaller in scale.

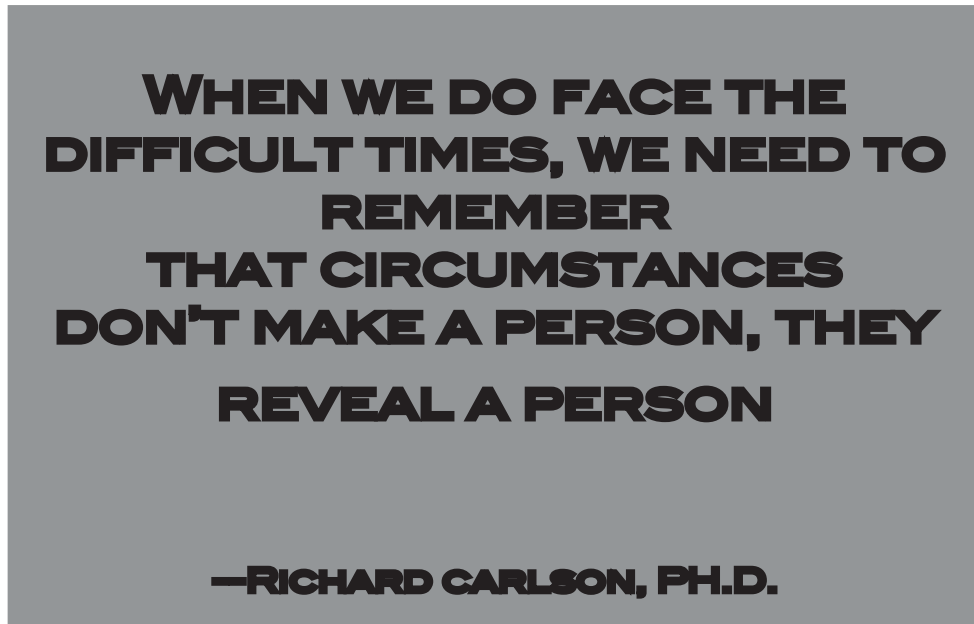

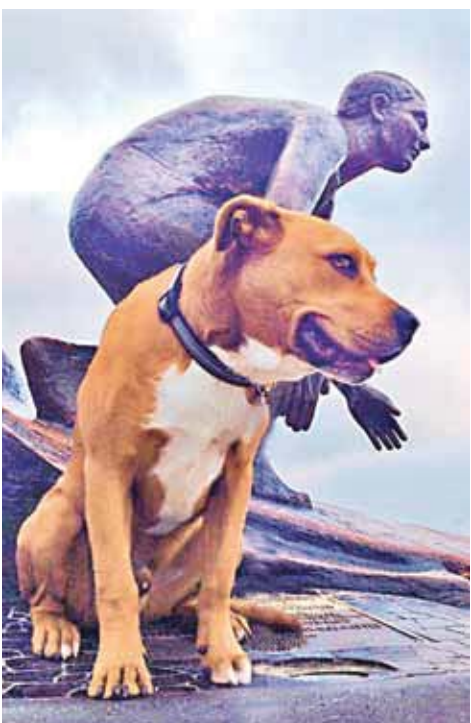

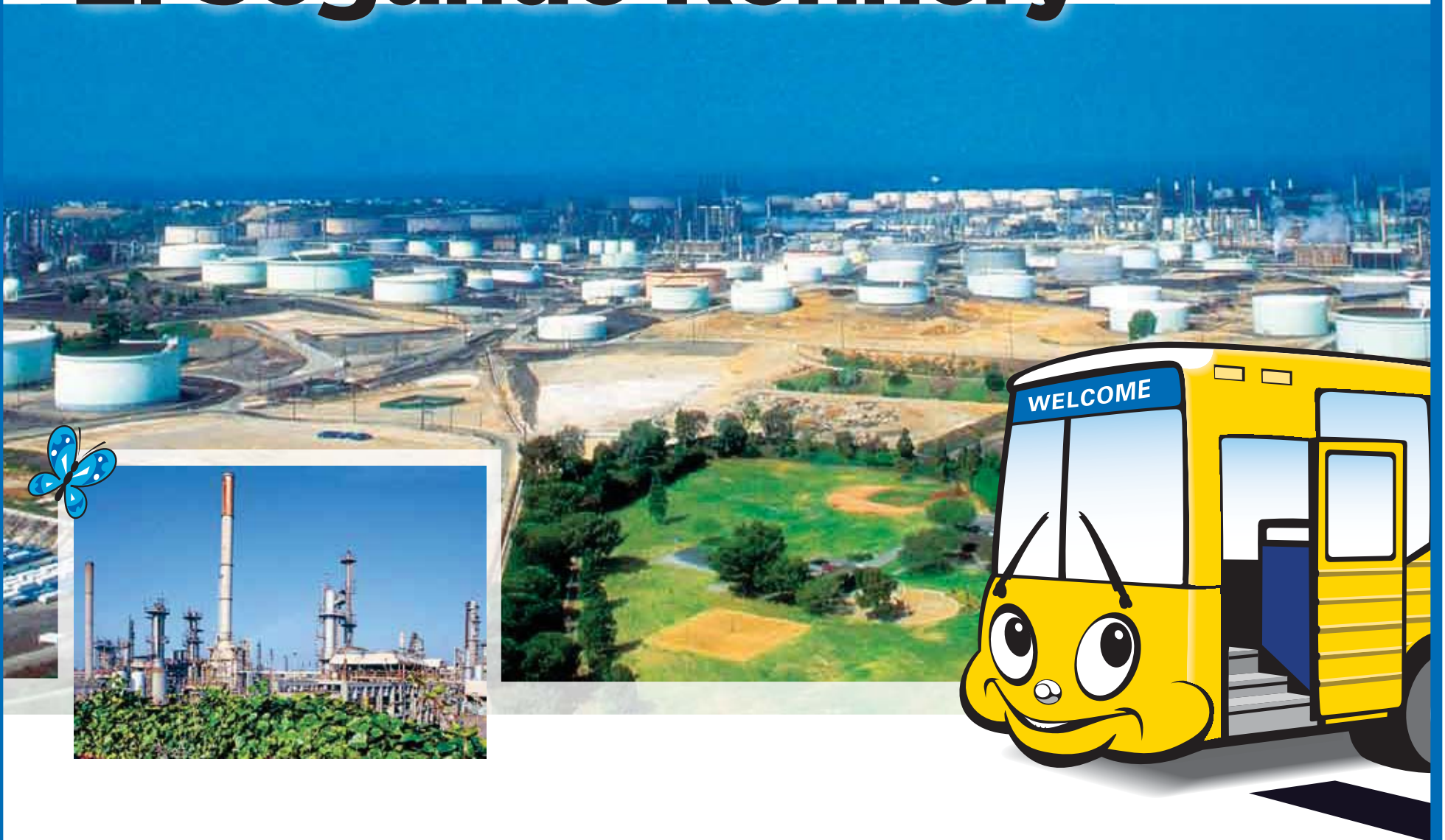
