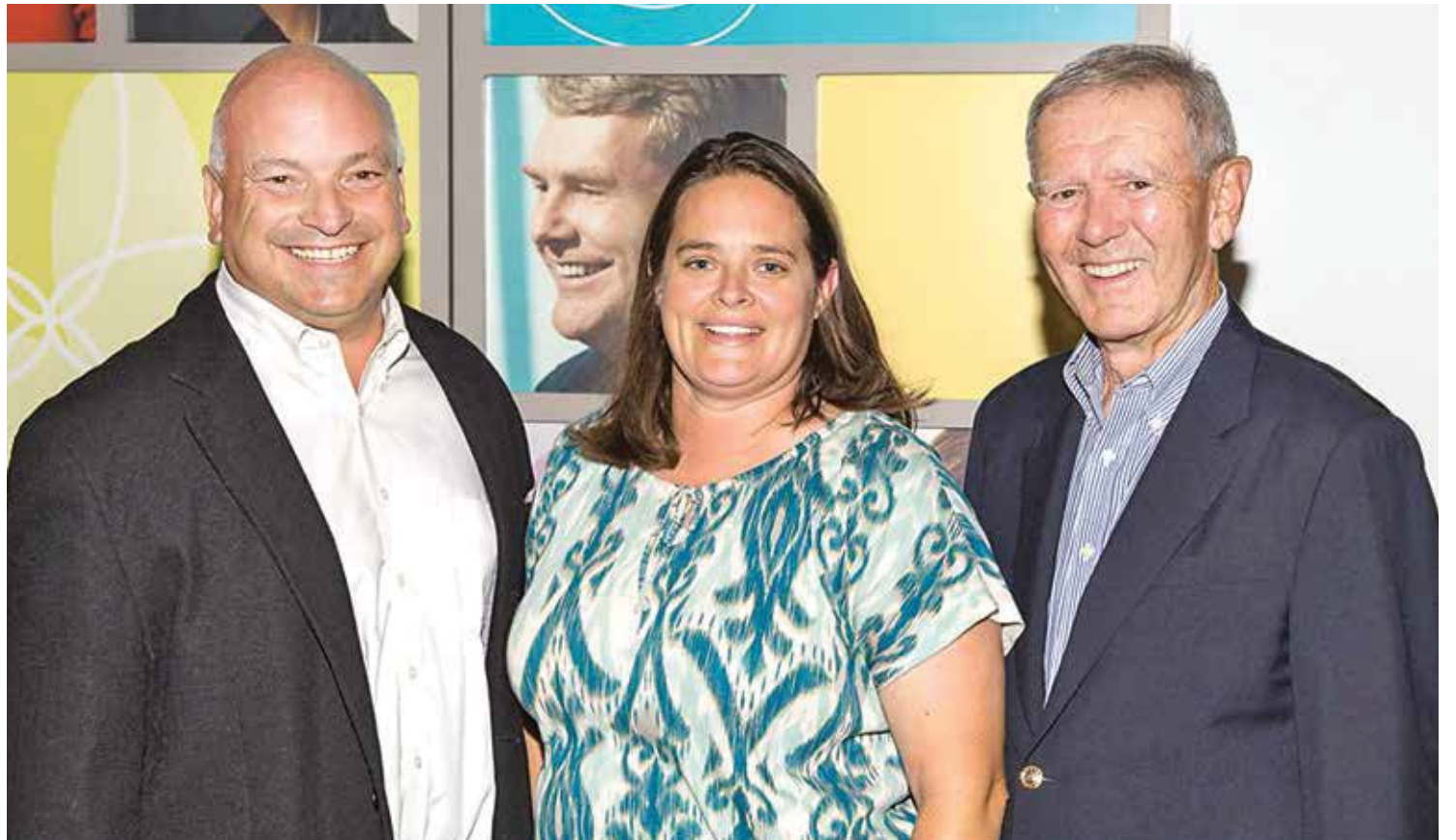

## El Segundo City Manager Presents Financial Stats to School Board

El Segundo City Manager Greg Carpenter and El Segundo Unified School District Director of Educational Services Marisa Janicek both made presentations to the El Segundo School Board during the Tuesday night meeting--the only regularly scheduled Board meeting slated for November. It was the final full Board meeting for outgoing members Ann Coles and Robin Funk, who have both served the District for eight years.

Student representative Malcolm Au made the initial special presentation, noting the fact that Funk was serving at her last meeting and presented her with a special pass that will admit Funk free of charge to all future El Segundo High School sporting events. An emotional Funk took to the podium and thanked many of the people she had collaborated with during her eight years of service, noting that the Board and support staff had been a "very cohesive unit" during her two terms.

Later on, the Board again tackled the ongoing process of the possible leasing of the District surplus school property at 540 E. Imperial Avenue, which was closed in 2009. The 5.65-acre property has been considered for the development of a senior housing community.

Carpenter's PowerPoint presentation, entitled "City Financial Situation and Options for the Future," detailed, among other bullet points, how City funds are spent, how City services are funded and what steps have been taken to reduce expenditures in recent years to deal with the projected future budget deficit. He then noted the City services that are provided, including police, fire, library and recreation and parks.

Carpenter then spoke of how City dollars will be spent in 2014, including the allocation for salaries and benefits to employees and noted the funding for those expenditures, including monies from taxes, the Chevron Tax resolution agreement, fees for services and cash garnered from licenses and permits. He showed a slide that listed an expected budget deficit in 2014-15 of between \$3.6 and \$5.6 million.

Towards the end of the presentation, Carpenter discussed possible recommendations to address the City's financial stability, including implementing ongoing cost containment, increasing economic

development and three tax measures, including a utility users tax, a transient occupancy (hotel) tax and a business license tax.

Janicek made a brief presentation about a recent teacher in-service day, which took place on Nov. 1, and how the teachers utilized the "pupil-free" day. "While the students had hopefully a wonderful day off, our teachers had a wonderful day together," she said.

After approving the consent agenda items, the Board received more information about the long-banded-about disposition of the Imperial Avenue property. Located across from LAX, the facility was constructed

## School Board Welcomes Two New Members, Says Goodbye to Two More

On Tuesday, a reconfigured El Segundo School Board convened for the first time after last week's vote as newcomers Jim Garza and Emilee Layne joined re-elected incumbent Bill Watkins and mid-term members Jeanie Nishime and Laura Gabel in the group. Ann Coles, the outgoing president, opted not to run again after serving two terms. Eight-year School Board veteran Robin Funk, who had been in line to succeed Coles as president in the rotation, fell short in her bid for a third term. With four candidates vying for three open spots, Garza was the top vote-getter with 1,345 (29.01%), followed by Watkins (1,322 and 28.52%), Layne (1,066 and 22.99%) and Funk (903 and 19.48%). Voter turnout was less than 15 percent, with poll locations

often empty for lengthy stretches.

Garza, the long-time principal at El Segundo High until a few months ago when he accepted an upper administrative position in Inglewood, was the only candidate who garnered an endorsement from the local teachers union. "The reason I believe the campaign was successful is that we were able to clearly articulate a clear vision for the students and the [El Segundo Unified School] District," he said. "In addition, I have an 18-year history of working in partnership with the community."

Garza said he is excited to work with his four colleagues and believes each of them offers a unique skill set to view issues through different lenses. "Together, we can develop policy and provide leadership that

### The Pants-on-Fire Chronicles, Edition One

*"That means no matter how we reform healthcare, we will keep this promise to the American people. If you like your doctor, you will be able to keep your doctor, PERIOD. If you like your healthcare plan, you'll be able to keep your healthcare plan, PERIOD. No one will take it away, no matter what."* – Pants on Fire, June 15, 2009 and 23 additional times

*"If you already have health insurance you won't have to do anything."* – Pants on Fire, Oct. 30, 2013

Since so much has been written about Obamacare, this chronicle is essentially a scorecard for masochists:

In 2009, the projected cost of Obamacare was \$960 billion, but by 2013, it had exploded to

\$1 billion in Obamacare taxes and fees.

The New York Medical Society says 44 percent of doctors are not participating in Obamacare. Only 23 percent of 409 doctors queried will accept non-group policies.

Watchdog.org surveyed 18 top hospitals, many of which are opting out of Obamacare because of reduced reimbursements.

The June, 2010 Federal Register reported 51 percent of employer-provided plans and 50-75 percent of individual plans will be cancelled under Obamacare, resulting in 93 million losing existing health plans!

AP reports that after surveying only half the states, 3.5 million Americans have already received cancellation notices.

The Los Angeles Times reported that in

\$1.8-\$2.6 trillion – and we've only just begun.

The Obamacare website was budgeted at \$93.7 million, but the GAO now projects money spent by Oct. 1 is \$630 million. After corrections, its cost will exceed \$1 billion. CGI, an Obama fundraising bundler and the company that created the debacle, has been given a new no-bid contract to fix its own errors.

The HHS Secretary estimates that as of now, there are still "several hundred" errors in the website that need to be corrected.

The New York Times says Obamacare will leave out two-thirds of poor blacks and single mothers.

CBS news says premiums for young men will rise 99 percent and then 55-62 percent for young women.

Aetna's CEO says all individual plan participants will pay a minimum of 20 percent more to meet Obamacare "essential benefit" levels. Aetna will pass through to subscribers

California, the average healthcare premium will increase 30 percent. More than one million individual subscribers in California will lose their coverage.

Obama says individually purchased policies are being cancelled because they are inadequate. But under Obamacare, "bronze" plans are equally inadequate but will be paid for by taxpayer subsidies.

Staff Director of the House Ways and Means Subcommittee on health said, "Eight of 10 small employers are going to have to change the health packages available."

CBS reports that "many in the 15 state-based exchanges are enrolling in free Medicaid rather than Obamacare. If that trend continues, there won't be enough healthy people buying health insurance for the system to work."

### Local Elections Done

Many localities recently hosted elections to determine new cycles of leadership, as well as new measures. While the fate of incumbents and challengers was determined by voters and new measures were approved or shot down, I am reminded of something that a political science professor at Cal State Long Beach once told the class: local elections are the most important elections because those are the people whose decisions will affect your life the

most. After the Nov. 5 election, it is hard for me to disagree with these words.

While it is of very important who we, as voters, send to Washington, D.C. and to Sacramento, the people we elect to our local city councils and our local school boards will determine the quality of life available within our city's borders. It is through electing the right mayor, city council, city treasurer and city clerk that we, as voters, can ensure that our city doesn't fall to pieces.

It wasn't long ago that the fiasco in the City of Bell made headlines and highlighted how having the wrong leaders can lead to rampant corruption. In any city where citizens are not paying attention and coming out to vote, the possibilities of mismanagement are endless. Unfortunately, as a society, we still register low in the voter turnout area, but there remains a committed core of citizens loyal to the democratic process where it most affects them. For those who still aren't convinced, we can look

no farther than the City of Inglewood, which in 2010 had its then-Mayor Roosevelt Dorn plead guilty to corruption charges. Since the removal of Dorn, Inglewood has elected Danny Tabor to the same position before ousting him for current mayor James T. Butts. Since then, the city's finances have been slowly recovering.

While Inglewood is far from being in an ideal financial position, the fact that a corrupt mayor was removed after years of unaccountability highlights the need for people to pay attention

and get involved in their municipal elections. In Inglewood, much like in Bell, the corruption lasted as long as it did because of the apathy of people. Local elections should have a higher turnout rate than they currently register in order to ensure that leaders are in line with their obligations. Having the right people in office is a benefit to our respective cities as well as to our surrounding cities. When you have two neighbors that are fully functional and responsible, the trickle effect will impact the rest of our county, eventually our state and maybe even the country.

It would be great if people keep participating in national elections but having a more active role at the local level is ideal. Call your Congressperson in D.C. and your local city council official and compare the response times. Granted, the people in D.C. have a lot more constituents to whom they respond, but it proves that regarding a direct impact to your quality of life, local elections matter a great deal. •

will take the District to the next level," he said. Garza added that his first priority is to get to know his colleagues a little better en route to developing a unified vision for all students and the community. "I think by establishing a sense of relational trust among us, we will be better prepared to honestly communicate with one another and problem-solve at a much higher level. Also, as I mentioned during the campaign, one of my priorities is to ensure that the teachers are included in the design and rollout of the Common Core [State Standards]. The teachers must be included in all aspects of the transition."

Beginning his third term on the School Board, Watkins began his academic career in El Segundo 50 years ago and worked as a

teacher, administrator and superintendent before retiring in 2001. "I thank the community for allowing me to serve another term on our Board of Education, and I look forward to serving with Jim Garza and Emilee Layne," he said. "I know we will work together with Jeanie Nishime and Laura Gabel to provide the best education for our students. Any change that will occur will be seamless as we strive to continue to improve our educational program." Watkins said his top priorities are to continue preparation for Common Core, determine the best use of the Imperial Avenue School site for the District and the community and continue to seek funding for beyond the basic amount provided by the Governor's Local Control Funding Formula.

Layne credited her successful election outcome to years of volunteering, being active in the community and people having confidence in her. "The campaign process was very new to me and very demanding," she said. "I attribute my final results to the many volunteers that helped me through that process." •

indicating that she looks forward to working with her new colleagues, Layne believes each brings a different and key perspective to the School Board. "My goal is to serve El Segundo with all my ability," she said, adding that her first priority will be to help ensure a smooth transition to Common Core.

Funk admitted that she was surprised by the election results given the fact she was an incumbent, local schools are thriving and she received nothing but positive feedback from the community when she walked precincts over the past few months. Asked why she thought her re-election bid fell short, Funk said she wasn't really sure. "We had low turnout and I think our schools have been doing so well that maybe people just take it for granted that they will continue to do well," she said. "I don't think this was about a particular desire to make a change." While disappointed she won't be able to continue her work on the School Board, Funk said she will remain heavily involved with local education as vice president of programs at El Segundo High. She also plans to continue her volunteer work on the El Segundo Museum of Art Board and will spend more time with her daughter who will graduate from El Segundo High in two years. "I wish them [the new School Board] the best and I know that our school district is in a better place than it was when I started," said Funk, citing top-percentile academic scores, facility improvements and the new High School auditorium, track and fields among the achievements over the past eight years. "We had some tough times, but I am very proud of my service and what we accomplished. I know they are in capable hands with a great superintendent and cabinet in place." •

### Stewart Leaves Mark on Senior Night

On a cool, damp, fall night, the El Segundo Eagles steamed up Hazeltine Field with a blistering offense and a defense that returned two interceptions for touchdowns. The result was a 59-34 win over South Torrance and the final piece to an undefeated Pioneer League season. It marked the first time in 25 years the Eagles have had a perfect league season.

The night was that more special as the El Segundo football program paid homage to the nine seniors on the squad on Senior Night. Senior wide receiver Jamie Stewart was a highlight reel by himself. He caught

66-yard catch and run touchdown with 3:48 left in the first quarter. Then after the Eagles got great field position after a poor Spartans punt, Nootbaar found his favorite target open near the end zone. Stewart made an ESPN highlight reel-type diving catch in the end zone for a 21-7 lead.

With their fourth possession of the first half, the Eagles made it 28-14. Nootbaar found Stewart in the end zone for another highlight film catch that made the first one look pedestrian. "Jamie's so talented and he made some sick catches tonight," said Nootbaar.

## Reel Review *Carrie: All Gore and No Guts*

Warning: Spoiler alert.

Internationally renowned author Stephen King's first-ever published novel, *Carrie*, has seen a number of variations over the past almost-40 years, from paperback to film to Broadway (a musical released in 1988 – I wonder if there was a “splash zone” warning during the famous prom scene).

This year, King's long-lived novel came to life again with a feature-film remake starring Chloe Grace Moretz (*Carrie* White) and Julianne Moore as mother Margaret, whose infatuation with her daughter's “damned” soul was *almost* as creepy Piper Laurie in '76 (Brian de Palma's version). Let's face it – nobody can outdo Laurie. I know now that Sissy Spacek is also irreplaceable, though I applaud Moretz for taking on the role and obviously giving it her all. It must've been intimidating for her, stepping up and redoing a role that isn't (and probably never will be) easily replaced.

Although neither *Carrie* film is a spot-on depiction of King's novel, I will remain a fan of the original *Carrie* simply because of its underlying message and artistic vision. Even so, I'll give credit where credit is due. I appreciated that the new version's updates and modernization didn't drastically alter the eeriness of the clearly out-of-place mother-daughter duo. I am sad to admit, however, that the 2013 version was more of a blatant gore fest for the sake of entertainment rather than a preservation of King's original intentions.

I went into the movie expecting its original creepiness and subtle (but effective) fear, and I came out feeling angry with *Carrie* instead of sympathizing with her, which I believe was originally intended. Near the film's end, when the audience should pity *Carrie* the most, they turn against her as she enters a blind rage, destroying everybody in her path. This isn't the old *Carrie* we knew and pitied – new *Carrie* is a relentless war machine. Instead of simply flipping her classmate's car near the film's end, *Carrie* completely mutilates both passengers, leaving nothing to our imaginations. The abundance

of CGI effects left no room for guessing. In another scene, Margaret uses a seam ripper to cut into her own leg, revealing her masochist personality. Again – could've gone without seeing that. My brain is perfectly capable of creating its own grotesque scenes, thank you.

Imagined by *Boys Don't Cry*'s Kimberly Peirce and *Glee*'s Roberto Aguirre-Sacasa, new-age *Carrie* focuses less on what makes this poor and otherwise innocent high-school girl go mad, concentrating on haunting the audience (not that 70s *Carrie* didn't sufficiently do so). I loved and feared the original film in which *Carrie*'s mother was detestable, so much that *she* was the evil of the two. This time around, her mother is almost pathetic and weak, and *Carrie* – once meek and mild – is the film's villain, as if her infamous “freak-out” was bound to happen with or without the relentless bullying at school and at home.

Sadly, the addition of violence and gore led to the depletion of the more important details. For example – I believe the original locker-room scene, though a tad risqué for movie-going youngsters (I'm 25 – is that old enough to use the word “youngsters?”), was brutally revealing for a reason. Shockingly, the 2013 *Carrie* shower scene was modest and less vicious, almost suggesting that those girls were unknowingly torturing *Carrie*. This hindered the film's authenticity, leading me to ask, “Are we purposely ignoring the bully issue at hand?”

Another shocker (a positive one) – all actors remained clothed or toweled. How odd for 21<sup>st</sup>-century films in which clothes seem to disappear into thin air. So, clothed characters – just fine. But the downplay of the bullying done by *Carrie*'s peers was a poor move, considering bullying and its side effects seem more relevant today than ever. They *did* manage to slip in a cruel, modern-day YouTube joke, which pandered to the now, but, as I recall, original *Carrie*'s bullies were relentless and proud of it.

So, if anyone asks, I stand behind the original *Carrie*. •

in 1956 and was utilized as an elementary school, employee training facility, and a special needs school until its closure four years ago. The Board discussed a resolution that will continue the process that will provide the District with the greatest flexibility in leveraging the best possible usage for the property and meet the goals of maximizing annual revenue on an annual basis, while being balanced with the ongoing needs of the community.

The aforementioned consent agenda featured the amendment of an agreement with Four Square Church for usage of El Segundo High School facilities including the auditorium, classified lounge and cafeteria Sunday mornings, Good Friday and Christmas Eve; an internship program that will allow high school students to gain after-school work experience with Infinite Learning; and an internship agreement with Legacy Dance for high school students to intern with the dance company and experience how the academy operates, work with a variety of instructors, schedule and accommodate classes for clients and help grow the business.

The Board also approved art enrichment classes that will take place for Eagles Nest students on Jan. 29 and 30, and a consultation agreement with Lisa Nicholson to serve as a consultant to El Segundo Middle School's International Baccalaureate (IB) program as the campus makes its way through the second year of the IB application process. Nicholson, a Cornerstone Educational consultant specializing in IB, will also work with the Middle School administration in ensuring that all students receive the required number of minutes in each semester to

satisfy the demands of the IB schedule in all necessary content areas.

The consent agenda continued with the approval for the implementation of Junior Achievement programs at El Segundo High. The entrepreneurial program introduces students to the essential components of a practical business plan and challenges them to start an entrepreneurial venture while still in high school.

The action items featured the approval of the District's Common Core implementation grant plan. The enacted State budget for 2013-14 provides school districts with one-time funds to support the activities required to implement the federal Common Core State Standards that California has adopted. The new funding is provided specifically to support technology, professional development and needed materials. The funds--\$683,000--must be spent by July 1, 2015. The District's planned expenditures include upgrading the infrastructure to provide superior Internet access; purchasing additional devices and software for technology-based instruction; providing support needed to help educators and schools in teaching to the new standards, including utilizing consultations and scheduling collaboration time; purchasing instructional materials aligned to academic content standards and providing common comprehensive assessment systems to measure student performance as the new system implementation gets off the ground.

The meeting concluded with members Bill Watkins, Laura Gabel and Jeanie Nishime, as well as Supervisor Geoff Yantz, lauding the outgoing Coles and Funk for their eight years of service to the Board. •

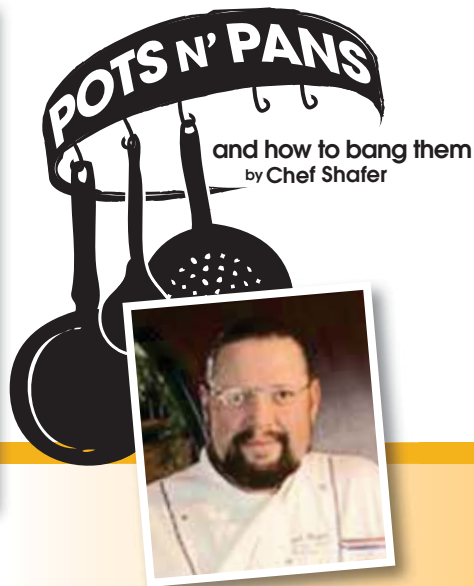

For a team with such low expectations coming into this year, Christmas has certainly come early this year for the Lakers indeed. •

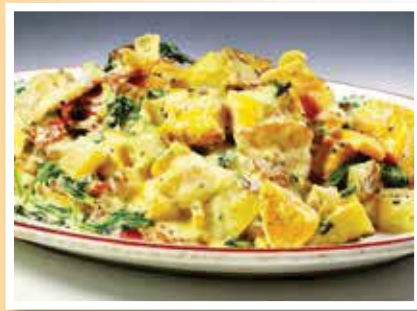

The Eagles' final score was set up by Kelly, who sacked Zuniga and recovered his fumble. Elijah Hale picked up a couple of yards and Josh Pacheco rushed for eight more. Underwood caught a pass over the middle for 20 more yards. On second and 10 from the Spartan 15-yard line, Stewart put the finishing touches on another spectacular game. Out of the Wildcat formation, he went right up the middle and slithered his way into the end zone.

The win gives the Eagles their first history-making undefeated league season since 1988. The Eagles fell to Santa Monica in the last match of the Ocean League and entered the CIF Division 4 playoffs 22-6 on the year. The second place Eagles face Troy the Freeway League champions today on the road. A win sets up a match with the winner of the Cerritos versus San Louis Obispo or Yucaipa wild card game on Saturday, most likely at home. •
