El Segundo Considers Car-Sharing Program

El Segundo is one of a number of South Bay cities considering a car-sharing program in which drivers can pick up a vehicle at a moment's notice and use it for however long they may need it—even if just for a few minutes. A representative from the automaker Daimler recently pitched the El Segundo City Council about the Car2go concept that conveniently places "smart cars" throughout the community and allows program members to rent by the minute, hour or day.

Launched by Daimler in Europe in 2008 and brought to the United States the following year, Car2go is now in eight North American cities, including Miami, Washington, D.C., Portland and San Diego. Under the program, applicants can register online by paying a one-time membership fee of \$35 that's good for life. Assuming a DMV check passes with flying colors, signees receive their membership card within three to five days. A special phone app provides a map of where the nearest car is. In the proposed South Bay system, Daimler would provide 300 to 350 cars in a geographical area bounded by the ocean to the west, Western Boulevard to the east, 105 Freeway to the north, and PCH to the south. Through even distribution, no one should have to venture more than four or five blocks to find a vehicle--so ideally, a car is always within walking distance. To secure the rental in advance, members can put a hold on the car for 15 minutes.

The compact, two-seater smart cars come equipped with computer systems and a centerdash touch screen. Doors remain unlocked with the key in the dash, but the car can't start until the member punches in a four-digit code to legitimize the rental. Drivers then pay only for the time they have the car, based on 38 cents a minute, \$13.99 per hour and \$72

a day. However, the fee includes all fuel (the program includes a fleet gas card members can use to fill up the tank), insurance, maintenance and even parking—cities with meters get reimbursed. Though members may take the car anywhere, they must return it someplace within the program's prescribed geographical area. "You can pick up the car in El Segundo,

drive to Redondo and Torrance, end the rental and walk away without bringing it back where you got it from," said Car2go Business Development Manager Walter Rosenkranz. "It gives you the ability to rent a car on a very short-term basis...It's another mobility option for those without cars."

Challenge Day Helps Students, **Grown-Ups Connect**

For a third consecutive year, Challenge Day leaders visited El Segundo Middle School (ESMS) with their workshops and programs aimed at helping students and grown-ups connect through the celebration of diversity, truth and full expression. The three-day, energy-filled event was hosted at ESMS November 27-29. Challenge Day leaders and adult volunteers from the community dedicated one day to students from each grade level separately in order to carry out the workshops' activities.

"This is the third year of Challenge Day at El Segundo Middle School and I do think that Challenge Day continues to benefit children and our school climate," El Segundo Middle School Counselor Lori Klein said. "As we continue Challenge Day year to year, I believe it has even a greater impact. So far, this was the best year ever and I anticipate it only growing."

Challenge Day has been reaching out to schools across the country and around the globe since 1987. The program is designed to create empathy for children to better connect with each other so

that they can feel safe. This nonprofit has a unique approach that goes beyond traditional anti-bullying efforts.

"Calling it anti-bullying is the easiest way to describe it, but it is so much more than that. It is about workshops for people to come together, which is a really humanizing experience for an adult and for students to go through," Challenge Day leader Michelle Arias said. "It helps break down those barriers that exist among students so that they realize that we are all actually together on this planet and that a lot of us are going through the same things, a lot of the same pressures and a lot of the same issues. It is a really wonderful experience for them to be able to see that someone that they maybe thought they had nothing in common with, are actually going through the exact same things. I think that that is the point of Challenge Day--to create a more loving, create a more accepting environment at school and among students so that they can feel empowered."

Since coming to ESMS, Challenge

STROKE, OSTEOPOROSIS SCREENINGS COMING TO EL SEGUNDO

Residents living in and around El Segundo can be screened to reduce their risk of having a stroke or bone structure. South Bay Masonic Lodge #421 will host Life Line Screening on January 25. The site is located at 520 Main Street in El Segundo. Screenings identify potential cardiovascular conditions such as clocked arteries and irregular heart rhythm, abdominal aortic aneurysms, and hardening of the arteries in the legs, which is strong predictor of heart disease. A bone density screening to assess osteoporosis risk is also offered and is appropriate for both men and women. Packages start at \$149. All five screenings take 60-90 minutes to complete. TREAT YOUR TREES: KNOW YOUR CHRISTMAS TREE

This is the season when trees come indoors to make our holidays festive. There are environmental arguments for and against any tree you may choose. If you opt for an artificial

tree, be certain you will use it for years to come since nonrenewable resources were used to produce it. There are two ways to minimize the environmental impact of cut trees. Try to get a locally grown tree to reduce pollution associated with transporting it, and be sure it gets recycled after the holidays. The other choice is a living tree that, instead of becoming trash, can be planted after the holidays. There are precautions to be taken to ensure this noble outcome. Check the species before you buy. Will it live in a Southern California coastal area? Is its eventual size practical for your yard or other spaces should you donate it to a nonprofit such as Tree Musketeers? Many living trees are Italian Stone Pines that reach 80 feet in height and crown width at maturity. Ignore labels boasting that living trees can be in the house longer. That is true only if tree survival is unimportant. Ten to fourteen days is about all of the warm indoors time a tree can tolerate. Keep a saucer under the pot before, during and after its time inside. These trees are root bound meaning there is little soil in the pot, and water runs straight through. The saucer will collect that water allowing the roots to drink at their leisure. Learn to identify trees by species at Tree Musketeers' Treat Your Trees workshops on Saturday Dec. 15 10 a.m. to 1 p.m. People who participate in each of five free Treat Your Trees workshops can earn a Tree Caregiver Certificate. Day has earned a strong reputation and has become an event that students look forward to with workshops at full capacity every year. "The first year, students and families were a bit apprehensive--but as we have continued, there has been an ongoing popularity for the program," Klein said. "We are getting more students signing up earlier and more parents requesting that their students participate."

While the goal of Challenge Day is to get children to open up their lines of communication between themselves and with adults, the day's activities are tailored to keep the children fully engaged while promoting the message of love, respect and tolerance. "The important thing is to have fun at the beginning of the day. We are acting goofy together and we're having fun together to kind of create that safe environment with each other," Arias said. "That way when we share parts of our lives and our stories, it begins the humanizing factor. It initiates the realness and the dynamics of a human being. It shows that we have such a range, beyond what we are showing every single day. There is no such thing as just a happy person all time. I think that is what kind of sets the mood for the students to feel safe in a way to discuss what is real for them and to discuss what is actually going on with them."

The program also has a strong impact on the adults who take part since they too participate just like the students and share their thoughts and past experiences. "A lot of times, the students see the adults as strong pillars where life is perfect and everything is fine, as if they were all born at age 25," Arias said. "They [kids] don't realize that we were 12 and 13 as well at some point, that we have our own experiences and that we have been through some things as well. I think it kind of helps the students and shows them that there is light at the end of the tunnel and that you can get through things even if it is feeling very hard at the moment."

Arias walked away from a career in advertising and merchandising in San Francisco after volunteering for a Challenge Day event. It has since become her passion. "I remember how I was feeling when I was 14--you understand everything that is happening around you, you are really in your emotions and you are really in your feelings," Arias said. "I remember feeling that appreciation when an adult was real with me and when they spoke with me at the same level, instead of talking down at me. I truly think that is the beauty of Challenge Day. None of the adults are talking down to you."

Arias concluded, "Students understand that we are human and we share our experience. We let them know that we can help them in any way and if it helps them, I'm going to pass it along. It has really been the best thing that I have done with my life. I feel really blessed..." •

Rosenkranz noted that according to data, each car-share vehicle takes 15-20 personal vehicles off the road and reduces the need for consumers to own additional cars. Pointing out other benefits of the program, he said the car is fuel-efficient, doesn't take up much space and is easy to park. Additionally, the city itself benefits by recouping a portion of the sales tax.

Car2go approached El Segundo at the behest of the South Bay Cities Council of Governments (SBCCOG)—a joint powers authority of 16 cities that address issues of common interest such as energy and water conservation, advocacy, land use and transportation. Realizing the South Bay is a relatively dense area without an extensive transit system and limited travel options, the SBCCOG looked at strategies to handle growth and improve mobility. "We studied transportation behavior in the South Bay for the last five years and found that other than the commute trip, most trips are under five miles," said SBCCOG Executive Director Jacki Bacharach. "We also learned that there are 266,000 secondary vehicles in households in the South Bay-second, third and fourth vehicles in a household. We piloted a slowspeed neighborhood electric vehicle project--our LUV project for local use vehicle--for the last two years and it was very successful with the households that participated. It highlighted that almost all of the trips other than the commute trip were local."

With that data in mind, the SBCCOG contacted several car-sharing companies to determine interest in offering service within the South Bay. Car2go studied the area and agreed to come into a nine-city block. "They were the only company that has expressed an interest in serving the South Bay since most other companies prefer to start in a campus atmosphere," said Bacharach.

While Car2go prompted initial positive feedback from a couple of Council members (Mayor Pro Tem Suzanne Fuentes described the program as "very exciting," noting that it gives people access to a car to "just zip around town and do their errands"), City staff will first study its viability in the community and the matter will return for final consideration at a future date. Some of the logistics may be a bit complicated, such as a request to waive existing two-hour parking limitations—although Rosenkranz indicated that the program is designed so cars won't remain stationed in one spot for that long. Even so, ultimate implementation hinges on approval from all nine South Bay cities targeted. In addition to El Segundo, the list also includes Gardena, Hawthorne, Hermosa Beach, Lawndale, Lomita, Manhattan Beach, Redondo Beach and Torrance. •





School Board Elects New Officers

In its only meeting scheduled for the month of December, the El Segundo Unified School District School Board recognized outgoing President Bill Watkins and elected new officers who will serve students in the upcoming year. Ann Coles was selected as the new President, with Robin Funk taking over Vice President duties and Jeanie Nishimie appointed to serve as Clerk.

Watkins has been a Board member since 2005 and has been active in overseeing the passage of and implementation of

a 10-day period to upgrade the electric grid and components at the District's campuses and the Sheldon Street District Office. Lubs noted that the Edison labor and materials were valued at \$200,000, with no cost to the District. The NRG grant, valued at \$225,000, featured energy-saving projects at El Segundo Middle School involving Bulldog Hall as well as the North and South gyms at El Segundo High School.

The consent agenda portion of the meeting included approval for three assemblies at Center Street School, as well as approval

significant bond measures used to finance the modernization of some of the aging campus facilities. He had just concluded his third tour of duty as President.

Coles has also served on the Board since 2005, just finishing up her term as Vice President. Funk has likewise been a Board member since 2005 and recently served the District in the past year as Clerk. Nishimie joined the Board after her election in November 2011.

After the members tackled the reorganization issues, Funk then read from prepared notes, detailing some of the various duties and responsibilities of the elected Board and noting that the members were selected to represent the students of the District and could only be replaced due to death, resignation or by being voted out of office.

Next up was a State of the Schools address for the Eagles Nest Preschool, and an Edison/NRG grant report. The Preschool address highlighted the evolving curriculum as the District diligently works to prepare its youngest students for matriculation into kindergarten and beyond. The PowerPoint presentation noted that numerous support services are currently available for the students and that the Preschool continues to receive "robust" support from parent groups.

The Edison/NRG grant presentation, made by administrator Dave Lubs, highlighted recent energy- related work that has been completed and will continue to take place in the District that will lead to a significant cost reduction in energy bills. At zero cost to the District, Edison provided up to 17 technicians over of what was termed an "adjustment" for the tuition payments at the aforementioned Eagles Nest Preschool. According to District-provided agenda notes, the Preschool tuition for the 2013-14 school year will increase, by a monthly maximum of \$15 "due to rising personnel and supplies costs." The notes mention "extensive research into fees at neighboring South Bay preschools," and that the "Eagles Nest Preschool remains an impressive value to El Segundo community members compared to comparable preschool tuition in Manhattan Beach, Redondo Beach and Palos Verdes."

During the action item portion of the gathering, it was recommended that a positive certification be filed with the Los Angeles County Office of Education, stating that even with the tenuous funding emanating from Sacramento, the District "believes that it will be able to meet all of its financial obligations for the remainder of the fiscal year and the next two years."

Chief Business Officer Susan Aceves pointed out that while the passing of Prop 30 was a shot in the arm to California school districts, the proposition does not provide any new funds for the District, but rather mitigates pending budgetary shortfalls and cuts.

Action was also taken on a request by Yantz to advertise for bids for a construction company to provide services to complete the installation of a turf practice field at El Segundo High.

The next regularly scheduled meeting will take place on January 8. •



Girls' Soccer Preview

The high school soccer season is upon us and the El Segundo girls' soccer team is off to a great start. The Lady Eagles are in a rebuilding year and will have a new look and new coach this year. Juan Mosquera, who guided the Eagles for the past 14 years, stepped down a year earlier than he was expecting for personal reasons. With a head coaching void, assistant coach Tony Hobbs volunteered to take over the program. "I've been the JV coach for four years and I helped Juan [Mosquera] with the varsity, so I feel I know the system and the players," said Hobbs.

Coach Hobbs takes over an established program that has gained respect not only in the Pioneer League, but throughout the South Bay. Hobbs will lend his experience as a player and his method of teaching and coaching to continue the Eagles' respect in the South Bay.
