Stop Signs, Homelessness Outreach, Hyperion, and a Plunge Construction Update

The power of attending an El Segundo City Council meeting to address the five elected members during Public Comment may produce a stop sign at the corner of Loma Vista Street and West Acacia Avenue. During its regularly scheduled meeting on Tuesday night, the City Council heard from Loma Vista resident Eric Bahor, who asked for the council's "consideration of approving a stop sign" at the intersection after city staff had determined the stop sign was not "warranted." In response, City Manager Darrell George said he would meet with the city's public works director "before anything comes back to council" for consideration. Bahor told the council that visibility was poor at the intersection due to the width of the street and parked cars and that installing a stop sign was a "common sense decision to make." In other news, George provided an update on activity at the Hyperion Water Reclamation Plant run by the City of Los Angeles' sanitation department, noting that the South Coast Air Quality Management District had recently received 19 odor complaints and issued one Notice of Violation halted to odors at the plant on February 14. City residents and officials have been grappling with the ongoing aftermath of an emergency at the plant in July 2021. On its agenda Tuesday night, council received a quarterly update on the city's new "Proactive Approach to Combatting Homelessness in El Segundo Program" called PATCHES and a mid-year and second quarter

of the fiscal year financial report; approved an additional \$87,479 for a contract with MIG to update the development of the city's General Plan Land Use Element; heard the first reading of an updated/new ordinance for a franchise-based model for commercial solid waste management in the city; heard about new ways the city could set up its Building Permit Fee and Development Impact Fee Deferral Program, and received an update with photos on the renovation of the Urho Saari Swim Stadium, aka The Plunge. New El Segundo Unified School District Superintendent Jason Johnson was praised for his willingness to bring an already-agreedupon \$1 million payment (the agreement was made in 2019) from ESUSD to its school board for consideration in November to "expedite" the payment, which initially wasn't due until "completion of construction". In its Plunge presentation, city staff noted several challenges that had been discovered once renovation construction began, including several that were not shown in the "as-built drawings" for the facility. Construction on The Plunge renovation project started on August 12, 2024, and staff presented photos of the demolition phase that included lead and asbestos remediation, the lobby where a wall was removed, the locker rooms, the old filter room and the new ancillary space, the new structural foundation, pool improvements, mechanical room improvements, the terrace area, and other activities that in included termite damage repair, structural seismic upgrades, conduit installation, and

spalling repair. City Council approved an additional \$104,000 to cover the additional engineering and architectural design that went into remedying the unforeseen issues and a \$50,000 contingency.

El Segundo Police Department Lt. Luke Muir and Sgt. Anthony Sanchez delivered an update on the city's new PATCHES Program, which is currently in its seventh month and is a cross-departmental collaboration in the city meeting monthly to identify solutions for homelessness-related issues. The duo covered the number of calls for service related to homelessness from October through January. However, Lt. Muir noted the numbers may not be an accurate reflection because how the numbers are determined involves either an officer responding to the call or the dispatcher documenting it. He noted that the PATCHES engagement team arrested a subject with an active warrant of a "violent felony crime" on November 6, 2024, due to new laws that allow police to detain and talk with individuals who are camping or sleeping in public. On January 30, the team also arrested a subject for possession of drugs for sale, which is a felony. Both subjects were in violation of the new El Segundo Municipal Code 7-8-2. PATCHES also works with Harbor Interfaith and reported that the team was able to help 18 individuals get "off the street, with 13 of those people going into a shelter or housing program, three of which were reunited with family members. Two military veterans were moved into "the VA". See City Council, page 6

Eagles Softball Team Has High Expectations

El Segundo High School's softball program has enjoyed plenty of success over the years. The Eagles have won 19 league titles, the last one in 2019. CIF titles have evaded them since 1976, but the league and CIF title drought could end this season. With high expectations and a loaded team, this could be the Eagles' year.

First-year head coach TD Mayer, a former standout baseball and football player for the Eagles, is fortunate to have many of his players playing travel ball, so the talent is already in place. He also reflects on former coaches like Rob Croxall, who left the program in great shape in his two years following Megan McCann's successful leadership.

There are nearly 40 girls in the program, and a lot of prep has been getting everyone acclimated to the changes. The JV team has new coaches led by head coach Jeremy Adler. You can find them preparing the Richmond Street field and getting it ready before each practice. On the varsity side, former alumni standout Jami Escalante has joined the staff, committing her time and experience to assist with the coaching duties. Also, adding a decade of experience in the softball environment is Eric Stevenson, who will invest his time in Varsity practices.

The Eagles lost two key players to graduation, pitchers Maiya Anderson and Hailey Wantz; both are playing collegiately this season. With so many starting returnees, the team's success will lean on the pitching staff, which starts with Jacy Lindsay. According to Coach Mayer, Jacy was one of the most successful pitchers when this senior class started out a decade ago.

The lineup is loaded, and it starts with a four-year starting shortstop, and the captain is Sienna Mayer, who is coming off a junior year where she was selected All-State, All-CIF, and All-Area. The other four-year starter is Allie Stevenson, and the other captain is coming off an All-Area junior year. Second baseman Jazzy Ramos made first-team All-Pioneer League honors and led the team in hits and OBP (.511) a year ago. Center fielder Charli Pages is a three-year starter and is another D1 colligate signee.

Several other players have the potential to make big contributions. Taryn Walker is a D1 college commit, and Kacy Ekstrom is another collegiate signee who had some big hits last season. Other returning contributors who could have their moments are seniors Maggie Green, Jameson Gertsch, Ace Anderson, and junior Ava King. The Eagles are lucky to have two of the top sophomore catchers in the area. They could see time in the outfield this year as well. Marilyn McCaverty and Sullivan McLaughlin can both hit and will see a lot of playing time behind the plate or somewhere else on the field.

This season's team has four new faces, including three sophomores each who will add depth. Pitching phenom Molly McAndrews looks to make some significant contributions this season as the number two pitcher. Cat Reed is another daughter of an Eagle former baseball standout David Reed. She has a lot of high-level skills, is versatile in the field with some speed, and will get some opportunities this season as she tries to crack the lineup. Elissa Campos hit over .500 the past two years on JV and will have some moments this season coming off the bench. The final addition is sophomore power hitter Carter Cswaykus. She is another high-character kid who just smashes the ball.

Coach Mayer is preparing his team like each game is a playoff game. "I like to play the best competition. I realized we need to temper that a bit to ensure we aren't limping into what is consistently one of the deepest leagues in SoCal." The Eagles did schedule some games against many top-ranked teams in the state this season. "We play 15 of the first 17 games on the road against traditional powers like Los Alamitos, La Mirada, Huntington Beach, Mater Dei, etc., and even scheduled a few games against recent CIF champions.

To win the program's first league title in six years, the Eagles will be challenged by the four Torrance schools. Only three get an automatic bid into the CIF playoffs, so it will be a battle every single game. "While I am confident in us being the team to beat - the reality is you must beat West Torrance and their talented ace if you want to win the league. Either we will be battle-tested come playoff time or worn out," said Coach Mayer

What are the expectations of Coach Mayer in his first season? He asked the girls to write down their season and team goals before the start of the season. On the list is to win a CIF championship. "We have not accomplished that since the mid-1970s, so why not now - we are due."

Coach Mayer says this team has so much talent. "We have kids who will play at the next level but won't be full-time starters this season. We have a dozen girls on varsity who could play colligate ball and more than a handful at the D1 level. We have a JV team that has a wealth of talent and many who would start at the varsity level at many other schools in the area right now."

Coach Mayer expects his team to be tough despite the demanding schedule. He expects

his team to get into the final four of the Torrance tournaments for the fourth consecutive season. "Win a league title, make a deep run into the CIF playoffs, and have fun this year!"

Coach Mayer says he is fortunate to have been put in this situation. The support from the school, and in particular, Athletic Director Fotis Davlantis, has been invaluable. He says it was a perfect storm, from having a team of nine talented seniors returning to having Jami Escalante return as an assistant coach. He says the last time he ran a program; he saw several kids on this roster hoist a trophy, making it to the final four in nationals for ESGS. I want to see them finish it off now."

The Eagles have begun their season but will not play their home opener until Tuesday, February 25, at 6:30 p.m., when they host Agoura.

Several teams have played or are playing in the CIF post-season playoffs. The girls' water polo team, the boys' soccer team, and the girls' basketball team each won their respective playoff games, while the girls' soccer team lost a heartbreaker.

The Eagles traveled to Corona to take on the second-seeded Santiago Sharks and came away with a tense 7-5 CIF Division 2 quarterfinal win. Ava Albertson paced the Eagles with three goals, while freshman sensation Camila Martinez scored two goals and had a key assist. Kendall Donahue had another outstanding game with five blocks, an assist, and two steals. The Eagles advanced to the semi-finals this past Tuesday, with the winner advancing to the Division 2 CIF finals on




Pony Confidential: One Small Pony, One Big Mystery by Christina Lynch

You'll laugh, you'll cry --- you'll gasp, then sigh! Read all about the crime-solving pony! In Pony Confidential, author Christina Lynch succeeds in persuading the reader that animals can indeed communicate --- with other animals, certainly, but also with some "sensitive" humans. Though he has had many names throughout his years and from different owners, he is "Pony" in this, the story of his complicated relationships with fellow animals and especially, with people. In an interview for a website called Crimereads, author Lynch describes her protagonist as "a cranky pony that had been passed around too many times and was fed up with humans."

Told from two different viewpoints, Pony Confidential makes us believe that animals might be higher on the scale of empathy, when compared with people. But we also get confirmation that some people are worthy of an animal's devotion. But there's a sinister side too: those evil folks who hurt animals, what happens to them?

Pony still remembers his former owner Penny, 25 years after they were separated, and he seeks to find closure by traveling across the country to find her. Pony alternately feels anger, shock, bewilderment, sympathy and

shame during his eventful journey, while Penny tells her side from a jail cell. She has been arrested on a murder charge and taken from her home in California back to her childhood home in Ithaca, New York to stand trial. She is innocent, but no one believes her story. Her estranged husband is ineffective in her defense and her court-appointed legal duo are stumped as well. Things are looking bleak for Penny.

Pony decides to leave his current home (a sad backyard consisting of a dilapidated house inhabited by an equally sad semi-invalid, a tired dog named Caya and a sarcastic goat, Circe) and track down Penny. Through many adventures, including stints in horse shows, being "pony-napped," winding up in a desolate petting zoo, "rescued" by animal activists, etc., etc., Pony learns that Penny is in trouble. He must save her!

Penny, given time to ponder her choices in life in her solitary cell, seems to always return to her nostalgic memories of her Pony and the love she had for him. This love is key to the story and is told with as much humor as there is in sentimentality. There is a deeper subtext to Pony and Penny's individual recountings, "... where the plight of animals was mirrored by those wrongly imprisoned in our problematic justice system," as the author points out in Crimereads.

Will Pony ever find Penny? Can he gather evidence to set her free? Will Penny ever see her husband and teenage daughter again? These questions and more will be answered if you take a chance on Pony Confidential. •

I Love You Forever Review: Heartbreak at the Hands of a Narcissist

Prince Charming quickly turns into Prince Creepy in the indie romantic drama I Love You Forever. Co-written and co-directed by Cazzie David and Elisa Kalani, I Love You Forever shows how one millennial meet-cute went from giddy heart-eye emoji to toxic heartbreak. This film is not the first to shed light on the modern dating experience, however, its portrayal of an increasingly frightening dynamic between a young woman and her overly obsessive boyfriend offers a fresh and authentic perspective on

Mackenzie (Sofia Black-D'Elia) is in a dating rut. Her hook-up buddy continues to be ambivalent about their relationship, and her patience is running low. A stressed-out law student, Mackenzie doesn't have time to waste on boys who won't commit. But her pessimistic outlook on love changes the night of her best friend's (Cazzie David) birthday party. This is where she meets Finn (Ray Nicholson), a devastatingly handsome man who seems immediately smitten with her. Their chemistry is undeniable from the beginning. The script's zingy one-liners add much-needed lightheartedness, as does Cazzie David's dry comedic relief. Ray Nicholson puts on a stunning performance as the endearing-turned-creepy Finn. His ability to switch between sweet and psychotic is impressive. For her role as the tortured girlfriend, Sofia Black-D'Elia gives a heartfelt performance that many women may, unfortunately, relate to.

Emotionally abusive relationships are no laughing matter, and I Love You Forever handles this delicate subject matter with the right amount of empathy and dark humor. Produced in part by Diablo Cody, the film made its World Premiere at the 2024 SXSW Film Festival. •


