Meet Tim Chrisman: Old School El Segundo High School Grad

Tim Chrisman still casts a large El Segundo shadow. He has a business in town, Hydra-Wedge, kids, and grandkids working and schooling in town, and was a graduate, in 1962, of El Segundo High School.

The legendary news anchor and writer, the great Tom Brokaw, penned a book about who he called “The Greatest Generation,” regaling readers with stories of the folks who emerged from the Great Depression in the late 1920s and surged forward and helped shape America. But those folks are not the only “Great Generation” that this country has nurtured.

Look at El Segundo High in the sixties. Graduates included Ken Brett, a baseball star who went on to play for more than a decade in the big leagues. Attendees at ESHS in the ‘60s also included his brother, Hall-of-Famer George Brett. And I am sure that there is a roster of esteemed 60’s ESHS graduates that I have not mentioned.

Chrisman attended Richmond Street School, ending up at ESHS. He played basketball and baseball, joining a “loaded” varsity baseball squad in his senior year, a team that had recently included the great Keith Erickson and Bobby Floyd, athletes who ascended to draw paychecks at the highest sports levels. Erickson matriculated to UCLA to be coached by the legendary John Wooden and then spent time playing with the Los Angeles Lakers and became a proud member of the 1971-72 NBA champions.

Erickson later served as the color commentator for the Lakers, trying to get a word or two in each broadcast when the great Chick Hearn captained the team’s simulcasts, putting the latest Los Angeles win “in the refrigerator.” Said Erickson, who was a multi-sport dynamo when he attended ESHS (Chrisman said that the lanky shortstop had a “cannon of an arm”) of his friend Chrisman: “Tim is the nicest, kindest, happiest guy that any of us would be fortunate enough to know. It is a joy to talk to him; I

always feel better after speaking with him.”

Floyd, who Chrisman said was “all everything” as a prep baseball player, notched a six-year major league baseball career. His claim to fame: he was the shortstop for the Baltimore Orioles in 1969 who fielded the final ground ball of a no-hitter tossed by the great right-hander, Jim Palmer. After his playing career ended, he began a longtime coaching career with the Seattle Mariners and

Cherchez la Truffe!

This story starts out on a bitterly cold November evening in the ancient Marais quarter of Paris, at our favorite northern Italian restaurant on the planet, Enoteca. Actually, it probably starts out a few hours earlier, around the corner at our favorite absinthe bistro on the planet, Chez Janou. The latter is renowned for its tiny horseshoe bar and the expert Provençal bartenders who can identify and recommend every one of their 53 styles of absinthe—so we might not be entirely sure about the bitter cold that evening, but we vividly recall the rest of it.

We’ve never come close to a bad meal at Enoteca—a highly unusual circumstance in the mom-and-pop style of restaurants

we typically patronize in Paris, where nearly everyone suffers an occasional off-night, and you just have to roll with the punches. But that evening, the chef decided to celebrate truffle season with fresh truffles in every dish on the menu—from the carpaccio to the tagliatelle, to the veal chop, and even the fresh ice cream.

At that point in our lifelong culinary journey, we knew truffles mainly by reputation. What we didn’t know was that 95% of the truffle dishes we’d tasted were a certified rip-off. If you don’t spot the thin black or white slices on your plate—if the dish is flavored with “truffle oil”—then you’re nearly always consuming cheap olive oil flavored with the synthetic chemical 2,4-dithiapentane.

City Council's adherence to the Citywide Strategic Plan provided the organization with long-term public policy direction and stability. 

"To serve the public is an honor. To serve as City Manager is a privilege. It was an honor and privilege to serve as El Segundo City Manager for the past two years and seven months.

It was a pleasure to work for so many amazing residents, businesses, and stakeholders. Being an advocate for over 350 dedicated and talented municipal employees was the highlight of each day. In looking back, this was the most challenging and demanding public CEO position of my career. It was also the most productive, successful, and rewarding experience of my three decades of public service.

El Segundo is a unique and great community. This town has a 'sense of place' unlike anywhere. No matter if one is a recent arrival or lived here all their life, everybody has incredible pride in being an El Segundo resident. And, they should!

Our residents are also not bashful about communicating directly with their city government. Nearly every day, including weekends, I received multiple questions/requests covering the full spectrum of municipal services. I enjoyed every resident interaction...even when the caller was upset and their voice started to escalate. Resolving issues (no matter how big or small) was the most rewarding

aspect of the job.

I am also grateful for the opportunity to have managed the City organization through the initial stages of the exciting transformation that is taking place. I am proud of the high caliber professionals that were hired or promoted on my watch, including the recent promotions of Jaime Bernudez to Police Chief and Deena Lee to serve as the South Bay's first female Fire Chief. Seasoned and experienced directors were also brought in to lead the Public Works, Human Resources, and Development Services departments. City employees were empowered to do more and were provided with improved working conditions, promotional opportunities, and administrative support that produced positive outcomes.

Faithful implementation of City Council's direction, including its Citywide Strategic Plan, resulted in the completion of dozens of exciting public and private sector projects. This success was impressive in terms of the numbers and benefits to the community, along with how the hard-working public employees delivered all this during the throes of a major pandemic, budget challenges, and the lingering LA Hyperion sewage spill odor incident.

While grateful for the experience, I will miss all of you reading this letter and those that I was blessed to interact with. Working for this compassionate community will be hard to replicate. I will miss what became my favorite local government job ever.

Film Review

In Twist-Filled Drama 'Sundown,' Tim Roth Reveals His Shadow Self

Where to watch: 'Sundown' is now playing in select theaters and available to rent on Digital Platforms.

When it first begins, *Sundown* slows you down to its wonderfully relaxing, worry-free vacation time. The sight of Tim Roth endlessly lounging in a luxurious resort overlooking a beautiful Mexican coastline had me enjoying every gorgeously serene and sun-drenched moment (and made me remember his other vacation film, 2021's *Bergman Island*). Then, *Sundown*'s darker story begins to unfold, and the shadows begin to loom large. Soon enough, I also remembered the other side of the fantasy that vacations offer: escaping from your current circumstances, and yourself.

Unless anybody spoils the story for you (don't worry, I'll spare you any overly-revelatory details here), you'll have absolutely no idea what to expect in this twist-filled, thrilling drama. Heading into *Sundown* as blind as possible really will make for the best viewing

experience. Although even I knew a tad more than I would've liked to have known before going in, I was still entirely unprepared for what *Sundown* had in store.

Written and directed by Michel Franco (2020's *New Order*), *Sundown* is a slow-burn film that follows Neil (Tim Roth) on vacation in Mexico with his family, Alice (Charlotte Gainsbourg), Alexa (Albertine Kotting McMillan), and Colin (Samuel Bottomley). When an unexpected emergency summons them all back home to London, the family must cut their trip short and hurry to the airport. It's a tense moment, made even more heart-dropping when Neil realizes that he's forgotten his passport back at the hotel. Unable to join them on the flight and now separated from his family, he hops into a taxi. When the driver asks where he's headed—and it's here where the film gets interesting—Neil simply requests to be taken to a hotel—any hotel.

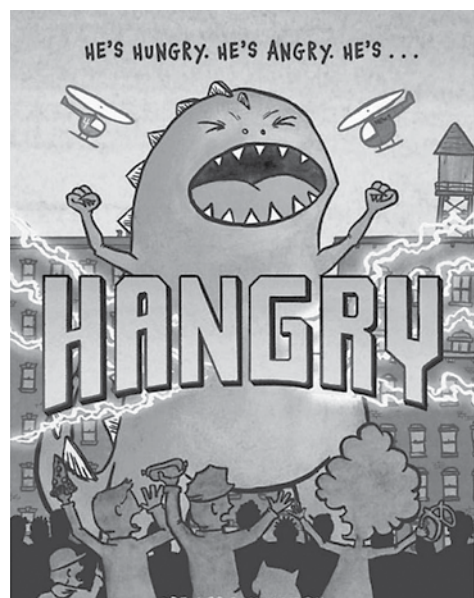
Check It Out

Wants Community Garden Expanded

The last two years have been hard on everyone, and I have noticed an uptick in online bullying, profiling, and overall bickering amongst neighbors. We need to get everyone off social media and back into the community by focusing on rebuilding Mayberry by the Sea. I am recommending that the city expand our community garden as we grow our housing community by 492 units through the Housing Element requirement. This growth will include yard-less townhouses, condos, and apartments. The current garden is gated and only accessible through a once-per-year lottery. I am proposing a community garden that isn't gated and accessible to all (like Queen's garden in Inglewood). This would meet the required housing elements open

space requirements: *A land-use element must provide for the general location and distribution of land uses for "open space, including agriculture, natural resources, recreation, and enjoyment of scenic beauty" (Gov. Code § 65302(a)).* A detailed proposal that entails planning, funding, maintenance, and collaboration was assembled and shared amongst the EN committee, DEI community, and the Arts and Culture Committee back in 2021. On July 14th, 2021, the DEI Committee unanimously voted to support an Environmental Committee push for a community park. A community garden provides healthy food, provides a community space for gatherings, and endless educational opportunities for our youth. If you support this idea, please write to your council members.

what's going on in Neil's head by studying his calm demeanor and blank, expressionless stares (the film definitely hints that something's on his mind, with shots of him staring vacantly into the ocean and pools). Neil proceeds to aimlessly walkabout in his flip-flops, having beers on the beach, and even meeting a local, Berenice (Iazua Larios). While Alice continues to try to contact him, Neil continues to deceive and avoid her calls. We're now fully only along for this mysterious ride, and the *Sundown* only dials up the heat from there.

Writer-director Michel Franco patiently divulges every piece of new information, which ratchets up the suspense in every scene. Neil's avoidance really gets under your skin—a cinematic sunburn—when you consider how easy it would be for any one of us to do exactly that. We've all had fantasies where we imagine leaving our old lives behind, impulsively staying on that never-ending vacation. Sometimes it's in the pursuit of enjoying the pleasures that the world has to offer, other times it's for deeper, more twisted, and complex reasons. Like avoiding sinister truths that we can only attempt to outrun for so long.

Franco teases out the rest of Neil's larger story so well, especially in regards to how he shoots the film. Yves Cape's (2012's *Holy Motors*) beautiful cinematography consists of widely framed shots, immersing and hiding Neil in his surroundings. The enduring images in *Sundown* are of Neil slumped over in various lounge chairs, staring vacantly into large bodies of water (the ocean, a hotel pool, it makes no difference). Also, from behind, in three-quarter, and side-profile shots (there is always a side of him we're not seeing). Franco uses the idea of the sun and the shadow to further symbolize Neil's internally conflicted state. Neil stays mostly in the shadows of his hotel room or on the beach, except for a sprinkling of moments where he's head-on in the scorching sunlight.

Tim Roth is truly exceptional here. As Neil, Roth gives a mostly quiet, internal, and understated

performance. The longer Neil remains unwaveringly relaxed under these distressing times, the tension grows to wildly unexpected new heights. We eventually learn about Neil's history and his family's global significance as an affluent business, which reveals Neil's strange behavior. With *Sundown*, Roth continues to re-emerge onto the film scene as an unsettling, pathological figure (look for him as an unnerving villain in *Resurrection*, which premiered at Sundance this year). Just by sipping a beer, or even while doing nothing, Roth radiates an unnerving quality who seems to be possessed by the question: what is peace? Is it the sustained feeling of happiness, or can peace just be what's left when you've outrun the darkness?

If you're intrigued, and in search of a smartly-written film that starts as a slow-burn drama before ending up as a head-spinning, jaw-dropping hallucinatory fever dream of a film, then look no further than *Sundown*. Led by an incredible performance by Tim Roth, *Sundown* is one of the most unexpected, gripping, and utterly arresting dramas I've had the joy of seeing recently.

One tactic is to rotate which company you request a report from, requesting one every few months.

• An address where you've never lived. This could be a sign someone's tried to use your identity to open an account.

If you see items like these on your report, contact the credit agency right away. A change to the Fair Credit Reporting Act (FCRA) in 2018 allows consumers to put a freeze on

their credit reports for free, so credit reporting companies will restrict access to your reports, not allowing lenders with whom you do not have an existing relationship to pull them. This can help prevent fraudulent credit applications from being opened. Then you can choose when to "unfreeze" the credit

reports and put them back into circulation.

You may receive an email saying one of your credit accounts has been blocked or suspended. It may look like an email from a legit company. Never click links within the email, as they may take you to a fake website (that looks real). Instead, access your

account from the website you always use to see if there's a problem. Contact the company directly, not through the email. Most likely it's a phishing attempt to get your personal login or financial information.

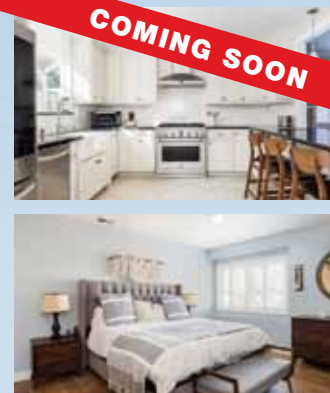

included a multi-decade stint with the New York Mets. Fun fact about Floyd: when he was attending ESHS, he authored some sports stories for the *Herald*.

Of living in El Segundo back in the day, Floyd said that "I can't imagine a better place to grow up. We had a small town, and all the parents and families knew each other. You grew up with the same guys all the way through high school," noting that he is "still pretty close" with many of the early 1960's ESHS graduates.

Back to Chrisman. He did not have an infield position that he was adept at when he attended ESHS. "I was afraid of the ball," Chrisman said, "and I couldn't hit," so legendary Eagle coach John Stevenson and staff pointed Chrisman to the pitching mound. Chrisman also played American Legion ball for three years, developing his pitching talents.

Once Chrisman graduated, he attended El Camino College, but that experience tanked. He became academically ineligible to play ball at El Camino, but pitched for a KC Athletics

rookie team and caught the eye of the legendary Tommy Lasorda, who was scraping around the lower levels of pro baseball.

With Lasorda in attendance at one of his games, Chrisman was tossing a no-hitter, and Lasorda posited, "how would you like to become a Dodger? I would like to come over and speak to you and your parents." After the Lasorda visit, Chrisman signed a contract on the dotted line, and ended-up pitching, for about a year, as a Dodger farmhand, toeing the slab in the low-minors in Santa Barbara.

The slim Chrisman said he gained a bunch of weight when he signed with the Dodgers. Not sure if the always well-fed Lasorda participated in the weight gain. "Lasorda was a wonderful guy, worked with me very hard on my curveball," Chrisman said. "He was almost like a father figure. We were very close. He would send me Christmas cards after I was out of the organization."

At this point in our phone conversation, Chrisman and I chuckled over a couple of classic Lasorda rants that were immortalized

on the must-listen-to Jim Healy sports radio show that ruled the late afternoon drive-time AM airwaves back in the day. Lasorda's classic diatribes involving "Kingman's performance" and the banjo hitting Padre Kurt Bevacqua falling out of a boat were legendary rants that cannot be repeated in this family-friendly newspaper.

After his year with the Dodgers, Chrisman was selected by the Houston Astros in the Rule 5 draft. He went to North Carolina to pitch, but things did not go well. More ominously, Chrisman, who was nursing a sore arm, soon received his draft notice, allowing him to participate in the Vietnam War.

Chrisman became a soldier on Valentine's Day of 1966. When he was pulling his tour of duty with the armed forces of the United States, he took every opportunity to participate in whatever sporting options were available, including quarterbacking in flag football, bumping a volleyball, playing centerfield on the diamond, and participating in softball activities.

Chrisman was stationed at the massive

armed forces facility at Fort Hood, Texas, which encompasses more than 350 square miles. "Quite an experience," he said. "We had 66,000, mostly men, training at that post. People were coming there like crazy," but fortunately, Chrisman was never deployed to Viet Nam.

Chrisman friend Lee Sherrill still lives in El Segundo. He said that when he peruses the *Herald*, he "looks at the (obituaries) to make sure that my name is not in there." He played youth sports with Chrisman and still cherishes their friendship.

Tom Callanan was the ESHS student body president in 1961. He recently retired from El Segundo Middle School, where he taught physical education. Callanan was a varsity basketballer when Chrisman made free throws for the junior varsity. "Knowing Tim at the time," Callanan said, "I always thought to myself, what a friendly, outgoing, intelligent individual, who was always smiling and positive."

At one point, Chrisman satiated his baseball needs by pitching batting practice to a new generation of players at ESHS. "Coaching with Stevenson," he said, was "one of the highlights of my life." Chrisman would leave work before 2 p.m., go toss batting practice, and return to his business to ice his throbbing elbow and shoulder. "I did it for me as much as I did it for them," Chrisman said. "There is something about being outside, in the sun, on the green, freshly mowed grass. I loved throwing BP," Chrisman said.

Chrisman moved to El Segundo when he was seven years old. He originally lived in Hawthorne, then his family moved to Oregon and finally relocated to the El Segundo area. He currently lives a stone's throw from the El Segundo border, but is a Mayberryite, through and through.

So, how does Chrisman sum up his decades-long love affair with El Segundo?

"A bitthen little town," he said. •

If that isn't appetizing enough, consider that 2,4-dithiapentane is also known as the dimethyl dithioacetal of formaldehyde. And if you still haven't lost your appetite, 2,4-dithiapentane is the odor that overwhelms your nostrils in halitosis, smelly feet, and some forms of flatulence.

Yum!

So that evening, our entirely authentic (and wildly expensive) dinner at Enoteca, even with hours of Chez Janou's absinthe in our bloodstreams, came as a revelation—one of those meals in your gastronomic life that divides the BE from the AE (Before and After Enoteca). As of that night, we still had a few weeks of vacation left and nothing planned, so our mission became clear—to thoroughly research the subject of truffles and to chase the weird and elusive tubers all the way to their origins.

There's a scene in the movie Goodfellas, where the Paul Sorvino godfather takes forever to slice a garlic clove with a razor blade into tiny, translucent sheets (since he's in prison, he naturally has the time). No one would blame you for slicing your truffles that way (in or out of prison), because the genuine article

white truffles, and Périgord (just outside Bordeaux) and upper Provence for the black, French version. In the 19th century, these regions exported truffles of both colors, but then World War I killed too many farmers, World War II destroyed too many forests, and suddenly, truffle-harvesting became a rare and disappearing art.

It might come as a surprise, considering how they usually live, but female pigs have one of the most acute senses of smell in the animal kingdom. Add in the fact that the scent of raw truffles is indistinguishable from the sex pheromone of boar saliva, and for centuries, these females have proved remarkably enthusiastic at sniffing out the underground fungi. The only issue is that these same very smart pigs excel at wolfing down the buried treasure before the farmer can pry it away from them. So much so that, in 1985, Italy banned pigs altogether in favor of dogs—who don't particularly care for the taste, but can be trained from puppyhood to follow its scent.

On that allegedly cold November evening at Enoteca, we'd already thought about following in Thomas Jefferson's steps when he took a rickety three-day carriage ride to

wouldn't open for another couple of weeks. The bad news: We'd miss the boisterous open-air markets where the farmers convene to sell their harvests. We'd also miss the latest and greatest truffle specials in the local restaurants. The good news: No one would mind us wandering around the plantations themselves, sniffing and photographing the pregnant, photogenic oaks.

And so we spent a week wine-shopping and puttering around Richerenches, Carpentras, and Grignon, the three scenic villages at the heart of the French truffle industry. With the lavender and fruit tree harvests just in, the air was pungent with a constantly evolving aroma. The truffle forests were unfenced, so the only limit on our meanderings was the size of our tires and the ruts on the dirt roads. Farmers—who would probably shoo us out of the way in another month—glanced up from the repairs they were working on, but otherwise ignored the invasion.

In that sleepy calm before the harvesting storm, the biggest challenge was to find an open restaurant for an edible lunch. So we were walking around Grignan, getting used to the idea of kebabs at the local Turkish

the chef had developed for brides who were planning their receptions. Naturally, that was

comes in at more than \$300 per pound. So one way to guess that you're buying the real thing comes when your French grocer uses three keys and a secret password to unlock the caviar-pâté-truffle cabinet.

Why so expensive? Because human beings have never quite found a way to standardize the harvesting of the tuber, a distant relative of the common mushroom. Truffles grow in random clumps a few centimeters underground, in the roots of oak and hazelnut trees, both wild and cultivated. Theoretically, they can be found anywhere on earth, but the three dominant regions are Italian Piedmont for

Tain-l'Hermitage, south of Lyon, to augment his wine collection. Tain and Châteauneuf-du-Pape bookend a hilly wine region in southeast France that boasts some of the country's best "undiscovered" wines—up-and-coming AOCs like Gigondas and Vacqueyras. So we decided to stock up on obscure wines, chase down the black truffles of the Vaucluse, and then head to Marseille for Bouillabaisse.

As we mentioned, sometimes in traveling, you just have to roll with the punches. And it turned out that Enoteca had been celebrating the start of the Italian truffle season—the French season, where we were headed,

grill, when we passed a rusty cast iron gate into a disaster of wildly overgrown weeds. Through the mess, we thought we spotted a glass greenhouse with uniformed young women walking back and forth. A push of the gate, and we crawled through to find the back door to a thoroughly elegant atrium restaurant with exactly one two-top available.

At the next table, a bride-to-be and her mother and aunts (we guessed) were being served an endless variety of Nouvelle Cuisine tidbits. When we discreetly inquired of the maître d', he explained that we were looking at an eight-course tasting menu that

we'd ever eaten.

But here, in the heart of truffle country, out of season and in the typically purist French manner, not one iota of truffle appeared on our plates. So we just had to roll with that punch straight out of the restaurant and into a very long and happy afternoon nap.
