California's "Right to Repair" Act Is Just the Fix

California's Senate Bill 244 (SB 244) "Right to Repair" legislation was passed and signed into law by Governor Gavin Newsome on October 24 of last year, and it will go into effect July 1, 2024. Electronics have become completely integrated with everyday life; this bill protects consumers' right to have the freedom to choose where their sensitive and private electronics are repaired. It regulates manufacturers' and corporations' ability to limit and completely restrict access to vital tools and instruction in the repair process. The intention is to create a competitive marketplace for repairs and reduce overall e-waste by allowing components to be repaired and not just replaced.

California has joined with three other US states that have passed similar legislation, but the Right to Repair Movement has been a global effort dating back to the early 2000s. Manufacturers began using proprietary parts and accessories as consumer electronics such as laptops and cell phones became more common. Before cell phone charging ports were standardized, thanks to laws recently passed by the European Union, the 2000s were plagued with dozens of different chargers for all major phone manufacturers. While most cell phone brands began to use Micro-USB ports during the 2010s uniformly, Apple remained a notable hold-out, continuing to use its own design.

Electronics is not the first industry to have this type of legislative oversight; the Right to Repair Movement gained momentum back in 2012 when Massachusetts passed a law requiring car manufacturers to provide independent mechanics access to diagnostics and parts, previously only any available directly through the car manufacturer.

Companies have been making subtle changes to their products in an effort to restrict access to parts or components. By design, any simple or complex upgrades or services could only be performed by the company itself, without competition or alternatives. Batteries are a great example of how users previously had the ability to replace components themselves. Cell phone and laptop batteries were originally external, allowing for third-party vendors to develop and sell compatible products offering longer battery life and a variety of other improvements. With our devices continuing to get smaller and more complex, the ability to repair the items we own has become unrealistic for the typical consumer.

This is precisely what California's SB 244 hopes to correct. The law provides a foundation to protect consumers and allow third-party businesses to have access to the repair marketplace. Specifically, it requires parts, guides, and tools to be made available and set strict pricing guidelines. The products covered include cell phones, laptops, tablets, and home appliances sold or used in California on or after July 1, 2021. Products specifically excluded include equipment related to agriculture, forestry, or construction, video game consoles, and alarm systems.

SB 244 also hopes to build on the Electronic Waste Recycling Act of 2003 in reducing

ESUSD Superintendent Dr. Melissa Moore Announces Retirement

Dr. Melissa Moore, superintendent of the El Segundo Unified School District, has announced her retirement, effective June 30, 2024. Dr. Moore assumed the role of superintendent in July, 2014, dedicating a decade to serving the district. In a letter to ESUSD families and the community, Dr. Moore expressed gratitude to all who have supported her throughout her more than three-decade-long career in education.

"This decision, made with joy, anticipation, apprehension and acceptance, marks the end of a noteworthy chapter in my life," said Moore. "It has been my distinct honor and privilege to lead this school district for a decade, alongside an extremely talented team of dedicated faculty, staff, teachers, ad-

ministrators, Cabinet, and Board Members."

During Dr. Moore's tenure, ESUSD achieved significant milestones, including the establishment of an ongoing revenue stream through the investment of \$16 million from the sale of the Imperial Street School, the development of a comprehensive Graduate Profile, adoption of the RULER Program for social-emotional learning, and the passage of Measure ES, a \$92 million bond measure addressing critical facility needs district-wide. This year, ESUSD plans to open three new school buildings.

"While the Board and I are happy for Dr. Moore to move into her next chapter in life, we know we will all feel her absence

Eagles Fall in CIF Basketball Final

The El Segundo high school boys' basketball team had an incredible season. They won 23 games, claimed their first league title in three years, and advanced to the CIF Southern Section Division 5AA finals for the first time in over twenty years. It marked the fourth time in 61 years the program had reached a final. The first and only time the Eagles won a basketball CIF final was the year President John F. Kennedy was in the final months of leading our nation. After a see-saw battle, the Eagles fell to the Castaic Coyotes 63-52.

This season, the Eagles were the top-seeded team heading into the playoffs, and they lived up to the hype. To get to the finals, the Eagles defeated Filmore by 55 points in the opening round, Tarbut Torah 60-36 in the second round, Trinity Academy in the quarter-finals 66-52, and fourth seed Buckley 74-41 in the semi-finals.

The somewhat easy schedule through the playoffs did not prepare the Eagles for a date in the finals against Castaic, a team that finished winless in the Foothill League. Don't let the fact the Coyotes were 0-12 in Foothill League play fool you. They entered the playoffs 14-14, meaning the Coyotes were 14-2 outside their league. The Coyotes' march to the finals included wins over the second-seed Godinez and third-seeded Dunn. Played at the University of Azusa-Pacific, the Eagles were supported by a large contingent of community and student body fans.

City Council to LA Mayor **Karen Bass: Do Something**

The Mayor and City Councilmembers sent this letter to Los Angeles Mayor Bass on February 23, 2024.

RE: Failed Management of the Hyperion Wastewater Treatment Plant

Dear Mayor Bass,

We are writing to you on behalf of the City of El Segundo with grave concerns regarding the appalling state of affairs at the Hyperion Wastewater Treatment Plant under the current leadership. The recent string of failures and compliance breaches at Hyperion have made it abundantly clear that there are significant deficiencies in the management and maintenance of the facility, posing serious risks to public health and the environment.

As you already know, since the nearly catastrophic spill on July 11, 2021, El Segundo residents and businesses have continued to suffer from terrible odors and gases being released from the plant. Our community members have reported that the odor causes headaches, itchy eyes, nausea, and vomiting. It has been over 2.5 years since that unfortunate incident and there continues to be multiple compliance and equipment failures at Hyperion, resulting in South Coast Air Quality Management District (AQMD) issuing over 70 Notices of Violation (NOVs) to the plant.

At the end of 2023, it seemed that the situation with Hyperion was improving, and the plant was making progress toward complying with AQMD's orders of abatement. Further, we are very grateful to Ryan Jackson in your office, who has done great work connecting us with Hyperion leadership and taking action on a number of requests - he has been excellent to work with. After connecting with Hyperion, we thought we established improved lines of communication. However, it appears that has all fallen apart.

In the past three weeks:

- AQMD issued FIVE NOVs to Hyperion
- Air Quality Monitoring website failed.
- Electrical damage led to storage of solid waste in truck loading areas.
- Process equipment failures caused biogas flaring and implementation of tanks with faulty covers.

- Extremely delayed by 3-5 days or nonexistent, and incomplete communication to the community about odors and plant activities.
- Willful misinformation from Hyperion senior leadership to the City Manager and staff about plant activities. Stating that there were no odor causing activities or that the smell was caused by increased inflow from the rain, only to later discover:
- ° They were cleaning tanks without proper notice.
- ° The bar screens failed again, causing flooding
- ° 25% of the bypass was opened, but they did not have a heavy equipment operator to open the system fully.
- ° Flooding, combined with the sludge released to the settling tank, caused pumps to fail.
- ° They are in violation of their water purity

The repeated instances of equipment failures, lack of proactive maintenance, odor leaks, poor communication, faulty information, and flagrant violations of regulatory standards are nothing short of reprehensible. Such negligence and incompetence cannot be tolerated, especially when they jeopardize the health and safety of our community and the integrity of our natural resources.

We refuse to stand idly by while our constituents suffer the consequences of the gross mismanagement of Hyperion by the City of Los Angeles. We demand immediate and decisive action to remove Los Angeles Sanitation Director and General Manager Barbara Romero from office. The position must be replaced with an individual with extensive expertise and training in wastewater management, unquestionable integrity, and dedication to upholding the highest standards of environmental protection and regulatory compliance.

Our community deserves better. We will not rest until we see meaningful change and accountability at Hyperion. As elected officials, we are duty-bound to champion the interests of our constituents and hold those in positions of authority accountable for their actions—or lack thereof. We expect nothing short of your full commitment and immediate action in addressing this request. The health and safety of our community depend on it. •








<u>Film Review</u>

The Arc of Oblivion is a Kooky Mediation on Impermanence

Two of the documentary world's most respected filmmakers, Werner Herzog and Kirsten Johnson, give their stamp of approval to Ian Cheney's expansive and rhetorical film The Arc of Oblivion. Lending their astute insights to this cinematic meditation on mindfulness, The Arc of Oblivion playfully explores the human desire for keepsakes amidst an ever-evolving world. Confronted by a question with a myriad

of possible answers, Ian Cheney encourages audiences to ponder what from this world is worth saving or, even more profoundly, "Are we insane to imagine that anything can last?"


Film is a tangible medium that has been around since the Lumière brothers presented the Cinématographe in December 1895. Images are captured and stored on rolls of film or hard drives, accessible when needed. Through the medium of film, we can experience cultures, periods, and places beyond our wildest imagination. The thought of this portal getting erased is terrifying, both from an enjoyment perspective and a historical one. As a filmmaker himself, Ian has always had a fear of losing his life's work from one accidental deletion or natural disaster. In opposition to our need for preserving history, Planet Earth archives it by burying its dead, as seen in limestone layers, tree rings, and fossils. Is that the true order of how we should approach archiving-here one minute, and gone the next?

This train of thought sparks a chain of wild hypothetical theories about memories and the human desire to want to preserve a legacy. Ian draws comparisons, quite literally, to Noah from the Bible, asking what he would take with him on his arc if he existed in today's modern times. Wanting to experience this scenario from a very method perspective, Ian enlists help from his parents and neighbor to build a 10ft arc in his backyard, using wood he excavates from the neighboring forest. This act of building a backyard arc gets Ian thinking about the fragility of memories, how to cope with their impermanence, and the theory that nothing ever "goes away"-rather, that energy is placed elsewhere.

The Arc of Oblivion has a kookiness to it that feels fresh and unexplored. The incorporation of video art, stop-motion animation, interviews with top subjects (including Johnson and Herzog), and timelapse sequences gives this unconventional thought experiment a sharp edge that is both fun and poignant. Werner Herzog is the film's Executive Producer and he makes an appearance in the last 10 minutes, breaking the fourth wall in a way that feels exciting. He comments on the power of the word "Oblivion" in the film's title, calling it a blessing because we would be miserable if we remembered everything. The human mind needs to be able to forget, he states. He even goes so far as to let us in on a little secret: Herzog discards all of the unused footage that doesn't make it into his films. Never will you see an outtake, director's cut, or extended scene. If it's not in the film, it's deleted from existence.

Acting as a philosophical springboard into the discussion of a desire for permanence, The Arc of Oblivion begs us to question, in the nicest of ways, if we are beautifully insane in our efforts to continue to preserve memories, despite the natural order of disregarding them. It's a fascinating film that I hope remains in the public's consciousness



Prophet Song by Paul Lynch

Prophet Song, the Booker Prize Winner of 2023, is a harrowing account of the descent into authoritarian rule by the fictional National Alliance Party in Dublin, Ireland. Viewed through the lens of one family, mainly matriarch Eilish Stack, the novel is an unrelenting assault on the belief in human decency and democratic rule. Told in running prose with no paragraph breaks, Prophet Song is a frightening look at societal collapse from the ground up.

When the secret police come knocking on the Stack family door, looking for her husband Larry, the deputy general secretary of the Teachers Union of Ireland, Eilish feels the haunting dread of things to come. "This feeling now that something has come into the house, she wants to put the baby down, she wants to stand and think, seeing how it stood with the two men and came into the hallway of its own accord, something formless yet felt."

As Eilish tries to hold her family together through the inexorable slide into fascism, she refuses to see the truth. When Larry is disappeared, as so many are, Eilish continues to cling to the Ireland she knows, not the one that it has become. With four children ranging from nine months to sixteen years and a father sliding into dementia, Eilish rebuffs all





Directions

- Step 1: Heat the oven to 450°F. While the oven is heating, cook the sausage according to the package directions and finely chop (should make about 1/2 cup). Line a baking sheet with parchment paper.
- Step 2: Stir 2 1/2 cups flour, baking powder and butter in a large bowl (using your fingers, crumble the cold butter into the flour mixture until it forms pea-sized pieces). Add the sausage, soup, honey and thyme and mix just until a slightly sticky dough forms. Shape the dough into a ball.
- Step 3: Sprinkle some additional flour on the work surface. Roll the dough into a 10x7-inch rectangle (should be about 1 inch thick). Cut into 12 (about 2 1/2-inch) squares. Place the dough squares onto the baking sheet. Brush with the egg. Sprinkle with additional chopped fresh thyme, if desired.
- Step 4: Bake for 12 minutes or until the biscuits are golden brown. Serve warm.





The Eagles and Coyotes matched up well both physically and athletically, and it showed in the first-half stats. Both teams play an aggressive defense while employing an up-tempo offense, and the result was a low-scoring first quarter.

Ethan Thomas scored the game's first points for Castaic on a tip-in. The Eagles followed by scoring three consecutive baskets, including two layups by Darreson Naruse and a mid-range jumper by Eli Coles to make it 6-2 two minutes into the first quarter. The Coyotes took a 10-8 lead on a three-point play by Lucas Milan, but the Eagles closed out the first quarter with two free throws by Coles and one by Naruse to take a 12-10 lead.

In the second period, the Eagles had a challenging time shooting but, in the process, went to the foul line plenty. In fact, the Eagles only field goal they made came on Shane Biscaya's jumper with 6:46 remaining in the first half. The Eagles were constantly being harassed offensively and were thrown out of their usual successful outside shooting. They did manage to convert 11-of-13 foul shots and take a 25-23 halftime lead. The Eagles shot a dismal 27 percent from the field and were 0-5 from three-point range. On the other hand, El Segundo's 17-20 free throw shooting in the first half kept them in the game.

The officials were generous with letting both teams play. The Coyotes aggressively mauled the Eagles on offense while holding their whistles on obvious traveling sequences. The Eagles got away with some obvious holding calls that were not called. If the Eagles were to prevail, it was obvious that their field goal shooting would need to improve.

In the third quarter, the Eagles shot a little better, but so did Castaic. There were seven lead changes in the quarter. Gavin McKinnon gave the Eagles a 31-27 lead, and Jack Pinten scored from inside to make it 33-29 with five minutes remaining in the period. With 2:45 remaining, Pintens made a brilliant pass to Coles under the basket, who promptly laid it up and in. He was obviously fouled on the play, but there was a no-call, and the



Eli Coles, who scored 13 points, converted seven of eight free throws. Eagles took a 39-38 lead. Darreson Naruse found an opening and managed his way for a layup and again was fouled with a no-call but a 43-42 advantage.

Perhaps two late baskets by Castaic and the end of the third quarter were the game-changing turning points. The first, with twenty-four seconds in the quarter, the Coyotes' Lucas Milan connected on the team's first three-pointer of the game to give his team a 45-43 lead. After a steal by the Coyotes, Giovanni Valentin put up a shot at the buzzer. The shot was altered at the rim and fell from the basket. After the three officials discussed the shot attempt, it was ruled a successful try, giving the Coyotes their largest lead of the game, 47-43.

The fourth quarter saw the Eagles frantically trying to make up the deficit with poor shot selections. Turnovers by El Segundo gave Castaic the opportunity to pad their lead. The Coyotes took advantage by increasing the lead to 51-43 with six minutes remaining in the game.

El Segundo closed the gap with 4:24 remaining when Shane Biscaya connected on El Segundo's only three-pointer of the game. Darreson Naruse squeezed through the lane for a layup to close the deficit to 55-52 with just over two minutes left. The Coyotes would hold off the Eagles the rest of the way while scoring the game's final eight points and going on to defeat the Eagles 63-52.

It was a disappointing ending to the game, but they lost with dignity and kept their heads high. The Eagles advanced to the CIF State Division IV Southern Regional Tournament. They traveled to Reseda to play the Cleveland Cavaliers on Tuesday. Should the Eagles win, they would play today against the Northview/Palisades contest winner. The Southern Region Tournament Final is slated for Tuesday, March 5, with the winner advancing to the CIF State Championship game in Sacramento on Saturday, March 9.

Baseball Team Routs Bellflower and Mira Costa

The Eagles defeated Bellflower 7-1 and Mira Costa 13-2 in the El Segundo Tournament. Against Bellflower, the Eagles rout started in the first inning when they scored three runs on four hits, including three doubles. In the third inning, they scored three more runs to make it 6-1 and went on to win it 7-1.





overall e-waste in California. By encouraging components to be repaired and expanding the locations where those repairs are available, more will be repaired than replaced. The Department of Toxic Substances Control reported that every American produced an average of 46 pounds of e-waste in 2019. E-waste can contain harmful chemicals such as lead and mercury and present environmental dangers unless disposed of properly.

For the supporters of the bill, the stakes could not be higher. In a statement regarding the bill's merit, law professors specializing in intellectual property described the bill as "crucial, not only to our autonomy as individuals but to our collective obligations to the planet. This bill would provide the citizens of California with tools to regain control over the consumer devices they rely on daily and stem the environmental harms of a throwaway consumer culture."

A notable and surprising supporter of the law included Apple, based in Cupertino, California. Apple had previously been outspokenly against Right to Repair protections. In a letter, Apple's director of state and local government affairs praised the bill, saying

European Union Directive (EU) 2022/2380, passed back in 2022, requires all phones sold in Europe must employ an industry-standard USB Type-C port. In response, Apple redesigned its next generation of phones to retire its proprietary Lightning connector in favor of a USB-C port.

Included in the California Senate Floor Analysis of the bill, the coalition of opponents, which includes the California Chamber of Commerce among other local, state, and national organizations and businesses, argued that this would "stifle innovation by putting hard-earned intellectual property in the hands of hundreds, if not thousands, of new entities."

Ultimately, California's SB 244 "Right to Repair" was approved unanimously. Penalties for non-compliance include \$1,000 per day for the first violation and \$2,000 a day for the second, up to \$5,000 a day for all subsequent violations. California is clearly showing its commitment to protecting consumers' rights in the ever-changing electronic and digital space. •

His wife Leticia, who knows him so well, was quite clear: "Honey, you're afraid of dogs. Why would you ever take on the K9 program?"

Well, the rest is history. When Luciano was scheduled for the Kennel Interview to seek to become part of the K9 program, the first question he was asked was just a little unusual: "Do you have a spleen?" (Luciano said to himself, wait a second, what? Do I have a spleen?)

He would learn that to handle the K9 work, you want to have a spleen because that is a vital part of fighting off infection... after you get bit by a dog!

Even so, some things are just meant to be. Luciano overcame his fear of dogs. In fact, "I fell in love with the adrenaline. It's like playing baseball. You have to move a certain way to make a catch, and you have to put the glove out there... I learned the same thing dealing with dogs: how you position yourself. How you set it up."

Luciano's K9 schooling began in 2000 at Lackland Air Force Base in San Antonio, Texas. This included how to teach a dog to be obedient and also how to hunt, how to bite, and how the dog should use its nose to sniff out items such as drugs and bombs.

"The breeds included German Shepherds, Belgian Malinois, and Golden Retrievers. Dogs that are good at hunting, dogs that can be adept at herding. K9 training school is kind of like boot camp for dogs..."

Luciano's next location is Andrews Air Force Base in Maryland. The military K9 program teamed up with law enforcement on a number of projects. However, the process of gaining his clearance to officially become part of the Presidential K9 program was very detailed. It took seven months for Luciano to be "checked out."

Let me then go back to what I said above: This process, sometimes very gradual and which is going to grow further, was the outcome of choosing the Air Force as a way of making sure he could marry his childhood sweetheart. As Paul Harvey would say, "And now, the rest of the story..."

Luciano became an official Military Working Dog Handler. His service included the Administrations of Bill Clinton and George W. Bush. This meant he dealt with the horrific circumstances caused by the attack on our country on September 11, 2001.

With his team in tow, Luciano would get to a site well before the President to "sweep it" to seek to make sure the area was safe

and secure. This work is referred to as "the Presidential mission." Ironic that as a young person, Luciano Aguilar was afraid of dogs.

Eventually, hoping not to have to travel, or to at least travel less, and also to finally avoid risking his life since he had three kids, Luciano returned to Hawthorne. The problem is that he did not know what he wanted to do. For a little while, he helped out his father-in-law, who has a self-service cash wash business, but it did not fulfill what rightfully now can be referred to as "his calling." Luciano did some soul searching, asking himself in his private moments: "What am I here for? And I really miss working with the dogs."

He started a dog training business in 2005. In those earlier years, Luciano would go to the owner's homes. He made presentations to many groups. After all, he has a unique talent and is very experienced. But, Covid hit, and there was great apprehension the business would falter, if not fail. How could he support his family?

It turns out that during COVID-19, many people were adopting dogs, staying at home, and needing help with their new four-legged family members.

"We went from training seven dogs at home to 15 to 20. We couldn't do it all at the house. It definitely was not an easy decision, but we found ourselves a great location, a great building, and now we run Presidential K9, located at 12233 Prairie Avenue in Hawthorne. We handle dog training, daycare, boarding, and grooming, and we assist some rescues through adoption. We work six days a week. One of our sons, who is now 22,

started helping. He had other interests, to be sure, but chipped in. Well, guess what? He liked it a lot, is very dedicated, really good at what he does, and now is full-time. With our oldest, our daughter, she is on her way to Veterinarian School. After she has the Veterinary degree, we will become a full-on clinic. Leticia, my wonderful wife, runs the show. She runs the operation. Our youngest is 19, and the door is open for him as well. He has been responsible for the grooming side of the house for the last two years. Thankfully, business is good."

Luciano Aguilar is just 47 years of age. This gentleman has done and is continuing to do, outstanding work. Now, please remember, he just wanted to be able to marry Leticia, and as time passed, he wanted to make sure to spend time with his family.

Thank goodness Luciano Aguilar took the path on which he finds himself. I guess he did not know it meant "going to the dogs". •








to sitting next to him on the bus.

After joining Dark on his journey, Orion meets the rest of the creatures that positively and negatively affect people's sleep each night. There's Insomnia (Nat Faxon), Unexplained Noises (Golda Rosheuvel), Sleep, (Natasia Demetriou) Quiet (Aparna Nancherla), and Sweet Dreams (Angela Bassett). Orion also meets Dark's nemesis, Light (Ike Barinholtz), who everyone naturally loves, except for jealous, hurt Dark.



While the movie follows a pretty simple story, there are also a few unexpected layers to it. As his adventure is about to begin, we see an older Orion (Colin Hanks) telling the story of his adventure with Dark to his daughter, to help her fall asleep. It's a clever way that screenwriter Charlie Kaufman (Eternal Sunshine of the Spotless Mind) links people together.

There are several other smart and sophisticated parts to the film that make it more than just a simple kid's movie. Orion's message is one of authenticity. He says parents love simple stories, "but real life is complicated. The only stories that really help are the true ones." By relaying mature, real messages to the audience, we can relate to it more.

There are also big lessons here – some that adults can benefit from too: after wondering why Dark would be needed at all, if everyone loves Light so much, he soon finds that reason: Dark is needed because there is beauty in the contrast of life. What is "light," except for the opposite of "dark"? Dark is what makes light possible. There is a balance and relationship between all things in life, showing that everything in life is necessary. It's a very wise observation that young viewers would benefit from.

In the end, Orion and the Dark is a familyfriendly movie that shows how taking risks is the only way to overcome your fears. If you're afraid of the dark, or anything at all, just know you're not alone, and someday, you may look back and share the story of how you overcame your biggest fears.
