## Plunge Project Gains Approval

In a 4-1 vote Tuesday night at its regularly scheduled meeting, with Council member Lance Giroux the lone "No" vote, the El Segundo City Council officially breathed life into its ailing community indoor pool facility, the Urho Saari Swim Stadium, also known as the Plunge. It was built in 1940 under a federal program known as the Work Projects Administration (WPA) created by President Franklin Delano Roosevelt and Congress. The aging Plunge, now nearly 84 years old, has been nonfunctional and closed since 2021 after suffering through years of equipment and facility issues that kept its use unpredictable.

In a brief presentation before council Tuesday night, Recreation, Parks, and Library Director Aly Mancini chronicled the history of the Plunge's potential renovation, noting that in 2005, the city's Aquatics Master Plan recommended the facility be renovated and repaired. She also stated that in 2006, the city council had approved the concept of a two-pool swim stadium complex at El Segundo High School, located a few blocks from the Plunge. The bond measure that supported that endeavor, Measure Q, was rejected by voters in 2006.

In 2008, a study conducted by Rowley International determined that the Plunge needed \$676,000 in filtration and circulation repairs. A 2010 "pool alternative study" by Rossetti and Counsilman-Hunsaker consisted of community input meetings and stakeholder

strategic plan meetings to gather feedback on aquatics programming and facilities for the city.

Tuesday night, with a mix of public comments that included several individuals asking the council to pause to take a look at building an outdoor pool with a depth sufficient enough for water polo players on the property instead of renovating the Plunge, many in the community rallied for the renovation, urging the council to make good on its pledge to renovate the Plunge. They mentioned that the Plunge, a 25-yard lap pool with a second shallower children's pool, is suitable for children's swim lessons, seniors, and exercise. One pointed out that the city had accomplished its goal to have a world-class aquatics facility and it was time to bring the community pool, the Plunge, back. Notably, the Plunge sits just off the small town's Main Street, near the public library and a park and school, on the residential side of the city, west of Pacific Coast Highway.


In terms of the large aquatics facility desired by the city, in 2015, the Wiseburn Aquatic Center Program was undertaken, delivering the El Segundo Wiseburn Aquatics Center to the community and public at large east of PCH next to Wiseburn High School and amongst the city's commercial buildings. That swimming complex features an Olympics-caliber 10-lane competitive lap pool that can change size and shape thanks to adjustable bulkheads, creating the potential to swim in one area and play water polo in another, along with a four-lane teaching pool. The complex also

includes stadium seating for 500, a public-address system for competitive events, and other high-level amenities/capabilities. The aquatics center held its grand opening in January of 2019, and the complex cost \$13.8 million, paid for with a bond measure from the Wiseburn community at \$6 million, the City of El Segundo pitching in \$1.8 million after an agreement was reached in November 2016. A fundraising effort led by Richard C. Lundquist, president of Continental Development Corporation, funded at least another \$4 million of a \$6 million goal.

The Plunge renovation will cost an estimated \$13 million, with the city funding \$9.2 million and loaning itself another \$4.7 million. Council approved a \$1.3 million contingency fun Tuesday night, as well. Lundquist again is set to raise funds for the Plunge renovation via South Bay Sports Health and Recreation. As the president of Continental Development, he has an outstanding record of fulfilling and reaching goals and commitments in the community. It was noted that the city has to "loan itself" via a funds transfer and designate all the funds needed for the project to start, unlike what occurs with federal government projects.

In dissent, Giroux said that all he wanted to know was what the cost would be for an outdoor pool instead of renovating the Plunge. He said his "concern is fiduciary," noting that the two pool facilities will require






## Check It Out

Sydney doesn't have any family. Her mother died and her father was abusive, so Sydney





## Ennio is a Singing Tribute to a Legendary Film Composer

It's been said that, at the sound of the first note, you will be able to identify an Ennio Morricone score. The duality of the music's boldness and beauty is unmistakable. We also know what will follow is a rich orchestral melody that weaves in and out of emotional landscapes. The prolific composer's influence on music scores in cinema is explored in great detail through Ennio, directed by his longtime collaborator, Cinema Paradiso filmmaker, Giuseppe Tornatore. Paying tribute to one of the industry's most legendary artists, Ennio explores the maestro's career across his iconic film scores, including The Good, The Bad, and the Ugly, Days of Heaven, A Fistful of Dollars, and his Academy Award-

winning work on *The Hateful Eight*, among hundreds more.

I like to listen to music when I write, and sitting down to begin this review was no different. As I opened Spotify and searched for his name, I was shocked but not surprised to see that the Ennio Morricone profile receives an average of 3.3 million listeners a month. His most recognizable song, "The Ecstasy of Gold" from The Good, The Bad, and The Ugly shows that it has been streamed nearly 69 million times and counting. These numbers, while staggering, are only a snapshot of the storied career of the Italian maestro.

The documentary runs just over two hours and thirty minutes, and every frame is packed with words of admiration from Ennio's peers, including autobiographical anecdotes from Ennio himself. Fans of his music-making process will revel in the abundance of fascinating interviews with various musicians and directors who have either worked







directly with him or were indelibly inspired by him.

Bringing a personal component to the film, Ennio shares stories about his childhood and reminisces about wanting to be a doctor. It was his father who convinced him to study the trumpet instead. It's a scenario you don't hear too often, parents persuading their children's career path towards the arts over medicine. From there, we weave in and out of his repertoire, growing more awestruck with each passing film score.

The film itself is very traditional in its documentary format, fueled by sit-down interviews that bounce from subject to subject. The stories themselves are larger than the formulaic way in which they are told, which seems like a conscious choice by Giuseppe Tornatore to not let stylistic filmmaking choices get in the way of the heart and soul of the film. It's works for a while; some interviews have a dated, public-access look to them that seems ripe for screening in a museum.

The descriptions given about Ennio Morricone range from "very serious" and "very absorbed" to "a genius" and "a marvel." Waxing poetic about their idol, some interviewees stated that "the God of music speaks through him as if he were possessed" and "His music is... eternal." Before his passing in 2020, Ennio finally won his long overdue Oscar for Quentin Tarantino's 2015 film, The Hateful Eight. At 87 years young in 2016, Ennio Morricone set a new record: the oldest recipient of an Academy Award, proving age is nothing but a number.

Ennio is now playing in Los Angeles at Laemmle Noho with a national expansion and home entertainment release to follow. •

a hefty annual operations and maintenance cost. "All I wanted to see was an alternative," said Giroux. Council member Carol Pirstuk noted that recreation programs and facilities generally are a service to the public. It was also noted that the city's reserve is now 25 percent. Just four years ago, it was 15 percent.

In more news concerning the city's recreation and parks, the Recreation Park renovation project moved forward on a 5-0 vote. The Teen Center, Teen Plaza, basketball court, and skatepark plans are being examined, with a focus on how to configure the basketball court and skatepark.

Also, a postcard-like entry sign to the city set for Imperial Highway and Main Street the two "No" votes.

In other news, El Segundo Police Chief Jaime Bermudez introduced nine of 12 new members who have joined the police department within the past year. He thanked the City Council for approving a \$40,000-tiered lateral incentive bonus they approved in May of 2023 to help the department's recruitment efforts.


