Jason Haffley: El Segundo's "Pollinator of Positivity"

If you look in the dictionary for the definition of "eclectic," you might find a picture of El Segundo's Jason Haffley, whose career has encompassed numerous forays into the work world, including captaining a horse ranch in Montana; delving into music marketing, and hotel management, working as a business banking specialist, small business consultant, and, his current endeavor with OneNinth Media, where he and partner, Lenny Vallone offer their clients a host of services, including "Marketing & Promotional Content Strategies, and Video Production & Post-Production Services."

While you are dusting off that old dictionary (I know, I know, no one, even relics like me, uses a dictionary. Google rules the world) and look up "vagabond," you would see the definition of "a person who wanders from place to place without a home or job."

Well, that definition does not entirely fit Haffley, who has had multiple homes and jobs and was raised, at least for his first few years, in El Segundo. AAA Travel Offers Tips for First-Time and Repeat Visitors to The Aloha State

The Hawaiian Islands are welcoming visitors back just in time for the spring and summer travel seasons. Now that Omicron cases are on the decline worldwide and fears of the variant are easing up, the State of Hawaii is inviting travelers from the mainland United States, as well as international travelers, to return to the island chain's colorful sandy beaches, jagged coastline, lush forest reserves, and majestic volcanoes.

Hawaii Entry Requirements:

Hawaiian state officials recently announced that travelers are not required to have a COVID-19 booster shot to enter the state.

U.S. citizens traveling to any of the islands, who wish to bypass the state's 5-day quarantine mandate, must be fully vaccinated at least 14 days prior to arrival or have had a *Nucleic Acid Amplification Test* (NAAT) no more than 72 hours prior to arrival.

Before your departure for Hawaii, if you are an adult (age 18 years or older) you will need to create an online user account and register with the State of Hawaii Safe Travels Hawaii program. This applies only for domestic passengers from the U.S. and its territories

Once you create your Safe Travels Hawaii account, you will then need to enter your traveler information and trip details on the program's application form. It is important to get the correct test and upload the correct form or vaccination record document.

Completing the State of Hawaii's Safe Travels Hawaii program application form, uploading COVID-19 test results or vaccination record document (if applicable) and obtaining your QR code PRIOR TO departure will significantly reduce your airport screening and processing time at arrival.

The Department of Health is currently working on criteria and conditions that would allow the state to eventually end its Safe Travels Hawaii program.

Hawaii Statewide Mask Mandate:

Governor David Ige's Emergency Proclamation requires individuals across the state to wear a face covering when indoors in public places unless they are actively eating or drinking

Oahu: The Hawaiian Island of Oahu has announced that it will drop its "Safe Access Oahu" program on March 6th, ending many

The Eagles have employed two talented goalies all season long. Tanner Ijams, just a sophomore, would play the first half while Kovacs, a senior, would finish the second half. For the Regional final, Ijams was away and wasn't available, so Kovacs was in goal. Head coach Skip Jones said, "We have two very good goalies with no drop off."

"We have known for years that vitamin D plays an important role in immune health, and now there are multiple meta-analyses that appear to demonstrate the benefits of this nutrient in COVID-19."

One statistical review found that intervening with vitamin D in an active case of



Most studies focused on vitamin D blood levels and COVID-19, while two exclusively looked at vitamin D consumption in relation to the illness. Most analyses reveal that higher blood levels of vitamin D appear to be correlated with lower incidence or severity of COVID-19, whereas lower blood levels of vitamin D appear to be correlated with a more severe case of COVID-19.

"Increasing evidence suggests a link between higher vitamin D levels and lower incidence

COVID-19 reduced chance of death, though another, smaller meta-analysis did not see a statistically significant relationship. Timing and dosage of those vitamin D interventions may have led to different results. Summaries of the meta-analyses and links to the research are available on the CRN Foundation's "Vitamin D & Me!" website.

Low vitamin D status is increasingly common. The prevalence of vitamin D deficiency

alleged higher learning, including Cleveland State University, but never received a college degree, instead working in hotel management in Indiana after he left his first college, Indiana University, Purdue University, Indianapolis.

He said he felt that he should give college another attempt and enrolled at Cleveland State at that point in his life. But higher education was still not the path that he wanted to follow. "I was still not interested (in college) at all," he said, so he moved on. Unsure at that point in his life which path he wanted to follow, he said that, after residing for a couple of frigid winters in Indianapolis and Cleveland, he was ready to again embrace the warm climate of California.

Once back in California, Haffley, a huge fan of hip-hop music, was quickly offered an internship with a hip-hop record label. He "fell in love" with the artistry of hip-hop recording sessions, he said. At that point, he was living in a place on Sunset Boulevard, but was not feeling the vibe. So, he went to Montana to spend some time, was enamored with Big Sky Country, sold his Los Angeles possessions, and landed a job as a construction framer in Montana. He ended up meeting and dating a gal who was helping train horses on a 200+ acre ranch that was owned by "a renowned heart surgeon."

Haffley was offered the job to manage the ranch. Haffley said he had no real qualifications to manage the ranch, but the job was offered, and he took the post, a gig that lasted for four+ years.

Alas, Haffley and his girlfriend parted ways. He "put the Bat-signal out there," seeking his next employment opportunity, and he ended up in Virginia, working with a sports marketing firm. He also later landed in Cleveland, working for a tax service.

As Haffley recounted his differing employment travails, he agreed that "eclectic is a good word."

Haffley later returned to California when he was recruited by a "buddy starting a mortgage business in Dana Point." Looking for "what's next," Haffley quickly attained a real estate license and "dove into the mortgage business," living in Laguna for a year. Still, Haffley was not enamored with his situation at the time and was looking to "get back to L.A."

He ended up back in El Segundo in 2008.

He was dating his now-wife Sara, living in Playa Del Rey, when they moved to our Mayberry.

OneNinth Media recently celebrated its ninth anniversary in January. The genesis of the company, Haffley said, was to create a "digital content production company." He and his partners were looking to provide "high-quality digital content, with a quick turn-around, with a price-point that made sense."

The company has evolved from becoming just "content producers, to a boutique creative agency that can develop (effective) strategies."

Haffley and Vallone were looking to start a company that had the mission of embarking on "projects of substance. 
When OneNinth launched, there were naysayers in the industry who scoffed at a start-up that wanted to make a profit and inspire and influence their communities with their digital footprint.

He and Vallone blocked out the noise generated by the doubters and are thriving nine years later.

"I have a lot of love for El Segundo," he said, noting how, despite his many forays outside the friendly confines of Mayberry, he is here, again. He said that his giving back to the community is a family tradition, noting that his grandparents were always active in their community. On the recreation side, Haffley and wife Sara consider themselves "beach bums," with occasional forays into local nature areas, exercising while hiking, and exploring the nearby environs.

Summing up what drives him, Haffley said: "I like to be a pollinator of positivity, taking a little from this place, and sprinkle it over there." What does the future hold for Haffley? No one has a crystal ball, but he did say that "the best way to predict the future is to create it." •



restrictions on restaurants, bars, and gyms. This means patrons will no longer be required to show proof of full vaccination or a negative COVID-19 test before entering businesses.

Maui: As of Feb. 21, proof of vaccination or testing is no longer required for indoor service at restaurants, bars and gyms. Maui County's indoor mask requirement will remain in place until lifted by the Governor.

(VDD) was found to be 28.9%, and vitamin D insufficiency (VDI) 41% in 26,010 U.S. adults surveyed as part of the ongoing National Health and Nutrition Examination Survey from 2001-2010.

Recent studies in the British Journal of Nutrition, European Journal of Clinical Nutrition, and Aging Clinical and Experimental Research revealed that the following people are more at risk for VDD and VDI:

- People of color, especially the Black community
- Less educated populations
- Those of lower socioeconomic status
- Smokers
- Physically inactive people
- Obese individuals
- Infrequent milk drinkers
- · Individuals with chronic diseases, especially of the liver, kidney and heart
- · Anyone with a disease that leads to malabsorption, such as Crohn's disease
- Older adults, due especially to aging skin's reduced ability to synthesize vitamin D • People with pre-existing conditions, such
- as diabetics · Anyone with reduced exposure to sun-
- light, such as those hospitalized and institutionalized
- Those taking certain medications Vitamin D comes from three potential

sources: food, sunlight-dependent production in the skin and supplements. Because vitamin D is not easily obtained from food, many countries have regulations that require vitamin D fortification of commonly consumed foods, such as milk, orange juice, other dairy products and cereals.

With regular sun exposure, a healthy diet and healthy kidneys, many people can make the vitamin D they need; however, most people are not regularly exposed to the sun, and diets vary. According to the American Journal of Clinical Nutrition, few people can obtain enough vitamin D from food sources alone, making supplementation important.

"This growing body of research does not indicate that vitamin D is a substitute for vaccines, mask wearing, social distancing or other behaviors to mitigate the spread of the coronavirus," said Huber. "But the data indicate that vitamin D levels may play a role, in combination with other therapies, in strengthening the immune system to resist the virus."

The CRN Foundation, a nonprofit educational organization of the dietary supplement industry that provides information about responsible use of dietary supplements, has put together a "Vitamin D & Me!" educational initiative to explore the science: VitaminD-AndMe.org. •

Directions

- Step 1: Season the beef with salt and pepper. Shape the beef into 4 (1/2-inch-thick) burgers.
- Step 2: Heat a 10-inch skillet over medium-high heat. Add the burgers and cook until well browned on both sides (to prevent sticking- make sure the skillet is hot before adding the beef). Remove the burgers from the skillet. Pour off any fat.
- Step 3: Stir the soup in the skillet and heat to a boil. Return the burgers to the skillet. Reduce the heat to low. Cover and cook for 5 minutes or until the burgers are done. Top the burgers with the cheese and cook until the cheese is melted. Serve the burgers on the buns with the soup mixture for dipping.

Tip.

• Skip the buns: and try serving these in a bowl, on top of hot mashed potatoes!

only multiplied with time, and he cultivates this creative side through art, singing, songwriting, and most recently, a complete podcast from start to finish.


The Gundo Ghost is a podcast written, created, recorded, and edited by Marsden. With a flair for narrative design, a love for the paranormal, and experience as a voice actor, a podcast seemed the perfect medium for a campfire tale about the creepy and abnormal happenings in Mayberry-by-the-Sea.

During the pandemic, like many people, Marsden picked up an almost ritualistic daily walk. These walks allowed his imagination to run wild, and as he observed strange artifacts and unusual sights around town, he began to spin stories in his mind to explain their existence. These stories, of course, aligned with his appreciation for the eerie and uncanny.

Marsden's works are akin to modern tales like those found on Creepypasta, a horror fiction website featuring user-submitted stories, and the birthplace of legends like Slenderman and Jeff the Killer. Most of the things in the stories are real and can be seen around town, making the fictional parts almost believable.

"It's a little bit like War of the Worlds or Twilight Zone," he says. When the radio adaptation of Orson Wells's War of the Worlds was first broadcast on October 30th, 1938, the station failed to insert enough reminders that the story was in fact fiction, and the audience of listeners believed they were hearing a real news broadcast of aliens taking over the earth.

Marsden says he has had a couple stories of listeners being concerned about the reality of his words. However, he thinks his work is rather "heavy-handed" in the paranormal horror category.

The podcast premiered last October, everywhere that podcasts are played. Though the story is accessible to a wider audience, Marsden hid easter eggs throughout the episodes, specifically for El Segundo residents.

Always creating, Marsden has also had art gallery shows of masks that he made, with four-line poems or stories to accompany them. His taste in horror gravitates toward vintage Halloween, which is the inspiration for his mask art.

"Halloween outfits from the 1920s and 30s [have] so much personality, and they're so

distorted and wrong. And they do not mean to be that way," he laughs. He enjoys the charm of a child trying to create something specific and getting a unique and custom result compared to mass-produced plastic masks produced in the 1980s to today.

Marsden's wife and kids appreciate his love

for Halloween and are well versed in the world of Hallow's Eve and content revolving around the holiday. Marsden jokes that he may have oversaturated them with Halloween, so their interest may not be as strong as his.

If working for major film studios, creating a podcast from start to finish, and crafting custom masks wasn't enough, he's also written and released music. Marsden's music has been described as a cross between Tracy Chapman and the Dave Matthews Band. His singing is not about love or sorrow, but in true Marsden fashion, it tells an unusual story. Marsden mentions a wild dream he had that inspired one of his songs, and he explains that there is a numeric theme building between albums. His first album is called *One Wrong Step*, his second being *Two Red Herrings*. He says if a third album is on the way, he'd like to tie it into the first two this way.

The Gundo Ghost was created as a complete and round story, able to exist as a standalone project, which is where it stands for now. Marsden says if interest builds or residents want to interact with his local stories more, a second season is not out of the question. In the meantime, he says his project can best be enjoyed with headphones and dimmed lights.

Marsden loves living in El Segundo, and perhaps his only regret is that he didn't live there sooner. He sees the town through curious eyes, and whether he continues his project or not, he has created some local legends that will live on for years to come. •
