# **ESUSD 'Rock Star' Robin Espinoza Is All-In for Her Students**

El Segundo High School Athletics Director Steve Shevlin considers his colleague Robin Espinoza a "rock star" for the tireless work that she does with high school students. A job made more challenging as the COVID-19 pandemic has disrupted school districts for the past year, necessitating the implementation of innovative ways of reaching and connecting with students who are being forced to learn and interact virtually.

Espinoza, who was born and raised in neighboring Manhattan Beach, and graduated from Mira Costa High School in 1994, currently tackles three positions at ESHS: Director of Student Activities; Business Pathway Teacher; and Leadership Chair for the high schools Western Association of Schools and Colleges

completely alone, as the rest of the student's family had COVID and was quarantined in different parts of their home. Robin took it upon herself to send the family dinner for multiple days and check in regularly with the student to see what they needed. That right there embodies the kind of person and educator Robin is."

Espinoza is a "legacy" ESUSD teacher. Her mother, Cathy Teitelbaum, who passed away in 2015, taught third-grade students in El Segundo for 26 years. Espinoza fondly remembers the times, beginning as a preteen, that she would accompany her Mom to school and "spend hours on the swings" outside while her mother worked in her classroom. # *Jumbo*: An Untraditional French Love Story About Loving Someone (Or Something) Despite the Status Quo

When we feel a desire for someone–or something–are we brave enough to express that love, uninhibited of others' thoughts?

And what if that something isn't human at all? But rather, an inanimate object-or in the case of *Jumbo*-a towering amusement park ride?

In *Jumbo*, Jeanne (Noémie Merlant), a shy theme park worker, falls in love with a new "attraction" and explores what of a Lady on Fire). And while it may sound like a silly premise for a film, *Jumbo* (the pet-name that Jeanne gives to "The Move It" theme park ride) is actually–somewhat surprisingly–heartfelt, sincere, and emotionally felt.


Zoé Wittock directs the film with such compassion (and sensuality) that you really could substitute "Jumbo" with anything at all and the film would still hold strong as an involving, stimulating movie about forbidden love. But the fact that Jumbo is specifically about this sort of tilt-a-whirl attraction is what gives the film its visual identity, which Wittock uses to highlight its oscillating movement, and kaleidoscopic light design, which Jeanne is succumbed by.

The West Basin Municipal Water District announced a new contactless delivery program to provide qualified District residents with free rain barrels worth approximately \$100 per unit.

The 55-gallon eco-friendly rain barrels help residents collect rainwater to use for landscaping and reduce urban runoff into local storm drains. One rain barrel can save up to 620 gallons per year. This year, 1,000 free rain barrels will be available for direct delivery to eligible homes. To register for a rain barrel delivery or learn more about the program, please visit www.westbasin.org/ rainbarrels or call (310) 371-4633 for details.

"Capturing rainwater with a free rain barrel from West Basin is a great way to water your garden, prevent runoff pollution from flowing into waterways, and save money," said West Basin Board President Harold C. Williams. "West Basin encourages residents to save water and use local resources whenever possible."

West Basin's rain barrel distribution program is part of a larger District-wide water-efficiency program that launched in 1990. Since its inception, the program has helped the District to conserve more than 7 billion gallons of water through the distribution of more than 300,000 water-saving devices. Since 2014, West Basin has given away more than 8,000 free rain barrels to local residents.

Registration is required. Some conditions apply. Rain barrel deliveries will be scheduled in groups, with lead times of up to a few weeks between order and delivery dates.

# South Coast Conference Cancels Spring Sports

The presidents of the South Coast Conference Colleges made the decision to suspend athletic competition for traditional spring sports for the 2021 season, it was announced February 25.

To ensure El Camino College student athletes remain in shape and ready when competition does return, the college is returning athletes to campus for conditioning purposes, March 10. Conditioning will occur outside only and the athletic department will implement social distancing guidelines recommended by the California Department of Public Health. Equipment will not be shared.

"We realize that maintaining optimal athletic stamina is critical to the future performance of our student athletes," said El Camino College President Dena P. Maloney. "By implementing stringent and proven safety measures we can offer student athletes the opportunity to strengthen their abilities and be ready when they do compete."

"At this time we are excited to have our student athletes get back on campus for conditioning," said ECC Athletic Director Colin Preston. "It is the first step that is needed in the process to return to what our student athletes love to do; practicing and competing. We will continue to evaluate the current trends in Los Angeles County and will be prepared for the next steps."

Sports returning to campus for conditioning include badminton, baseball, women's basketball, football, men's and women's soccer, softball, men's and women's swim and dive, men's and women's track and field / cross country, and men's and women's volleyball.



# **Football Preview**

Are you ready for some football? With high school sports resuming, one of the most anticipated sports to return is football. When the Eagles play their first game of the season next Friday night, at South Torrance, it'll have been 404 days since the last time they suited up for a game. A lot has changed in that time, including a head coaching change for the first time in 26 years. When Steve Shevlin coached his final game on October 31, 2019, he had already mentored his replacement, and now Shawn Green takes over as the face of the program.

Coach Green will inherit a young team loaded with talented juniors as well as a stripped-down version of a varsity program that has shrunk this season to just 32 players. "The numbers are a reflection of some players opting to play other sports that intersect with football," Green said. He believes this is a one-time anomaly that will self-correct in the fall. He's anticipating continuing the success with a roster filled with players he coached on the freshman team and whose team went undefeated two seasons ago.

Coach Green's philosophy is the same as his mentor, to focus on the student while teaching the athlete inside the discipline, overcoming adversity, and teamwork in a camaraderie environment. His passion for the game and his demeanor with his players reminds you of a younger Steve Shevlin.

Most of the coaching staff put together by Coach Green is holdovers from Shevlin's staff. While Coach Green is expected to call the offense, Mike Wagner will direct the defense. Coach Wagner is another who learned from his predecessor, Dan Heck, who helped make the Eagles have one of the top defenses in the South Bay. Coach Green has filled out See Sports, page 8

#### Dear Neighborhood Therapist,

I have been having a lot of anxiety recently, and I am hoping to find counseling. I have looked online and all therapists seem to promise basically the same thing. I feel like I don't want to pay someone to tell me what's wrong with me. Do you have any suggestions to help navigate this process? – Frustrated With the Process,

Manhattan Beach

#### Dear Frustrated,

I'm really glad that you asked about this, and I completely agree that you do not need to pay someone to tell you what is "wrong" with you. Every single one of us can find plenty of things that are "wrong" with us according to some expert or some social expectation. While some people find genuine comfort in a diagnosis that confirms that what they are going through is "real" or even "normal," I think working towards a diagnosis does very little in terms of actually helping someone to face the problems that caused them to seek out a therapist in the first place. or jumping quickly to a diagnosis and treatment. Your therapist should recognize that no set of problems and circumstances interacts with every person in exactly the same way. If you really think about it, the idea that a person who is not you could possibly be an expert in YOUR life doesn't make much sense.

Third, give it a little bit of time but also trust your instincts. As with any working relationship, it may take a few meetings to find a rhythm or rapport. If something feels off after a few meetings, bring it up if you feel able to. A good therapist will want to hear this, and you can decide together whether or not to continue. If you get pushback, it's probably best to end the professional relationship.

Do expect to work. Psychotherapy is not

Now that I've made my little speech, here are a few things to look for in the initial phone calls and meetings:

The most important thing is to find someone who you believe is genuinely interested in helping you. The good news is that this should not be a problem. The vast majority of therapists get into this field precisely because helping people is important to us. If you do not get the sense that your therapist is genuinely interested in helping you, don't move forward.

Second, in your initial call or "consultation," listen for signs that a therapist is curious about your experience, as opposed to trying to fit you into a pre-existing box like going to the doctor, where hopefully you are "cured," sometimes by just taking a pill or lying down for surgery. Of course you will have to provide some basic information during the meetings, but you should also expect to be asked to think and to reflect in a way that gives your mind a workout.

Most importantly, though, you should feel that the therapist has created (or will create if you haven't started yet) an atmosphere where your honest reflections will be accepted with kindness and interest, and never shame. It is often this last part where the magic happens.



### Jackson Kalb

a Michelin two-star institution, thinking he would speak with the owner for a bit and maybe watch some practices. When the owner greeted him, his first remark was, "Why are you wearing shorts? You're working today." After a quick panic call to his mom to bring him more professional clothes, they threw Jackson into the current, assigning his first task to be deboning rabbit confit. "Rabbits have very teeny tiny bones. It's a very tedious process," he explains.

Kalb continued to work at Mélisse after school for the rest of middle and high school. "It wasn't a paid gig," he says, "It was an apprenticeship. I was there of my own accord because I wanted to be there."

Toward the end of his high school years, he went to work for three Michelin-star reshow they treat the dining experience and process their food. "Their restaurants are about nourishment, and part of nourishing yourself is nourishing the soul," he says. In other words, consuming food is about more than just getting enough calories to go about the rest of your day. For him, this comfort and nourishment looked like a fresh plate of pasta.

Upon his return, he got a job as the Chef de cuisine at Factory Kitchen, all the while planning out a future in which he operated his own Italian restaurant. After a very intense experience working for Factory Kitchen and an opportunity to open a restaurant for someone else fell through, Kalb resolved that he was ready to be his own boss.

"So we tried the fundraising thing, and let me tell you, it is brutal," says Kalb. He and dollars. Finally, someone he'd cooked for a few times who was blown away by the food decided to get his group together and invest \$40,000 into Jackson's idea. "Forty thousand dollars may sound like a lot of money, and I can tell you, restaurants are expensive," he says, adding that this amount might cover half the kitchen equipment in a new restaurant.

Splitting their time between Santa Monica and Long Beach, they settled on El Segundo as the halfway point and lucked into their current spot. "I believe this of anyone with any sort of success in any magnitude... teeny tiny, huge, massive... there has to be a stroke of luck," Jackson says. The landlord was not ready to lease to someone who was young and had little money or experience. But the property manager believed in him and asked them to give him a chance. So, with less than \$100k, at twenty-seven years old, Jackson Kalb opened his Italian restaurant

taurant Joël Robuchon in Las Vegas. Here he found himself at a crossroads. Nearing graduation, he found himself trying to decide between going to culinary school or trying to get into college to learn the business side of restaurants.

Very luckily, he says, he got into Cornell University's hospitality program, which he didn't know at the time was ranked number one for that field. While there, he worked for three Michelin-star rated Chicago restaurant, Alinea.

After graduating, Kalb went to what he calls "restaurant boot camp", or working for Hillstone Restaurant Group. The rigorous nature of this company enabled him to learn how a well-run restaurant business looks. After about two years of this experience, he knew he wanted to open his own restaurant. So he took what money he had and booked himself a one-way ticket to Italy.

For his four months in Italy (until he ran out of money, he jokes), he picked up jobs here and there in multiple kitchens, learning his business partner (and now fiancée), Melissa Saka, raised money for eleven months, and at the end of month ten, had exactly zero

here in El Segundo, called Jame Enoteca.

Jame comes from a combination of Jackson and Melissa, and Enoteca is a kind of wine bar and casual eatery in Italy. Kalb is not the biggest fan of the name Jame, but after a difficult lawsuit claiming the original name (Workshop Enoteca) was too close to an existing restaurant in Palm Springs, they needed something that could not be in danger of being duplicated on accident.

Jackson and Melissa put a lot of love and work into their restaurant, still working seven days a week. Since the opening of Jame, they opened a second restaurant in Venice during the pandemic, and as new homeowners here in El Segundo, Kalb says they have exciting plans for new projects in the community. Most of all, Kalb hopes to bring a sense of nourishment with his food, measured not just in calories, but in comfort. •

mother prepare classroom bulletin boards and materials for her students during the weekend. As she got older, she chipped in to help her Mom grade spelling tests. A time where, Espinoza said, she "developed a great love for the classroom and El Segundo."

Post graduating from Mira Costa, Robin matriculated to Cal Poly San Luis Obispo, where she attained her degree in Social Studies, and in the following year, secured her teacher's credential.

A return to El Segundo beckoned Espinoza: She soon landed a job teaching 8th grade U.S. History and English at the El Segundo Middle School. "A dream job," she called it. "I had never worked so hard in my life," she said, calling her tenure at the ESMS "challenging, but I loved it." She relished the school culture and interactions with the Middle Schoolers and helped lead six excursions for 8th graders to Washington, D.C., for the always-popular ESUSD civicminded whirlwind tour of the Capitol and other historical environs.

During her tenure at the ESMS, Espinoza served as an ESTA Teacher's representative, PTA Liaison, Mentor Teacher, and Campus Orientation Provider. In 2002, Espinoza was selected as teacher of the year by her fellow teachers. "I still feel proud of that" accolade, she said. Which was a fitting tribute from from the daily interaction with students. After two years, she yearned to return to the four walls of the classroom environs. Espinoza said her reading tastes tend towards fiction. "Take me away," she said. "I don't want to read about real things." She lives in town with her husband of nearly sixteen years, Chuck, and son Charlie, a 4th grader at RSS, and Grace, currently a 7th grader.

Espinoza likens the current El Segundo environment to the way things used to be in her hometown of Manhattan Beach "in the 70's and 80's," citing the close-knit community. She feels that the high school is a "special piece of the town, people rally around the high school. I am right where I am meant to be," she said. Espinoza is obviously dedicated to her career in education. And she credits that to her upbringing. She related how her mother, who retired from teaching in 2010, had a Charlotte's Web mural "created/painted in her honor by her amazing friend and former teacher Janet Read, and we installed a bench near that mural on the most beautiful grassy knoll behind the building. The inscription on the bench reads, 'Books are my friends, who never fail me.' Like mother, like daughter. "My Mom's final students graduated in 2019, and we shared many of the same students over the years," she said. "I am her legacy in the classroom, and I try to live up to her legacy every day. I really value the relationship that I have with my students, and, as they graduate, staying in touch with them, celebrating their milestones and successes." One would assume that Cathy Teitelbaum would be justifiably proud of her daughter's

accomplishments. •


