Power to the Patients Fights for Your Rights

Power to the Patients is a non-profit organization established in 2020, founded by filmmakers Kevin and Paul J. Morra alongside a titan in the stem cell field, Cynthia Fisher. Before co-founding Power to the Patients, Cynthia Fisher got her MBA from Harvard Business School before going on to become an entrepreneur. Fisher has founded and co-founded several companies in the health-tech space, including ViaCord, a stem cell banking company. Kevin and Paul J. Morro come from the film and entertainment industry, often collaborating with the multifaceted Henry Rollins.

The organization advocates for patients' rights in what has become an increasingly complex system of healthcare and insurance for the average American. Morro commented that the Power to the Patients organization was "bred from rebellious art and culture, protest music, and key influences like Public Enemy."

In this spirit, Power to the Patients spreads its message by supporting local artists nationwide to create unique murals featuring the Power to the Patients logo: a raised fist holding the winged symbol of medicine: a caduceus.

The raised fist icon traces back to the French Revolution and was used heavily during the Civil Rights movement. During the 1968 Olympics in Mexico City, after Black American runners Tommie Smith and Jon Carlos took 1st and 3rd, Smith and Carlos each raised a fist on the award podium in protest. Later, saying, "We had to be seen because we couldn't be heard."

Power to the Patients recently partnered with famous hip-hop artists, including Method Man, Busta Rhymes, and Rick Ross. Joseph Antonio Cartagena, also known as Fat Joe, was another contributor and has been friends with Kevin Morra for over 20 years. Cartagena is best known for his music including songs titled "Lean Back" or "All the Way Up". Cartagena is no stranger to harsh conditions, hailing from

the poorest urban congressional district in the country, an area in South Bronx, New York.

During a recent interview on CNN, Cartagena spoke about the condition in the neighborhoods where he grew up. "Hard-working men who walk with a limp, they're hobbling because they're scared of the prices at the hospital," he describes. He says, "A woman may be sick and not go to the hospital till the last minute. And before you know it, she has stage III or IV breast cancer."

Cartagena also touched on meeting with the co-founder of Power to the Patients, Cynthia Fisher. He explained how she had shined a light on the risks and consequences patients face daily. A key criticism of the American medical pricing system is that, formerly, prices were not publicly available. Even when patients

were admitted to a hospital, the hospital would standardly only offer estimates for their services. Patients agreed to services and procedures without knowing what those would cost, only to find out too late the estimate was far below the actual cost.

In medical emergencies, life-saving care may need to be administered before the insurance companies can approve or explain coverage. Families are left with delaying care until they can be more informed or take the risk of not being covered.

In September of 2022, NPR covered the tragic story of the Markow family. After the birth of their son in 2021, AJ and Crissa Markow were advised their son would need an emergency transfer to a hospital in California, or he may

Christopher Edward Barrett passed away in Torrance, California on February 24, 2024 after a brief battle with Leukemia, surrounded by his loving family. He is survived by Kathy, his wife of 52 years, son Bret and his wife Marcie and their children Aiden and Brady, and daughter Gina and her children Gavin and Kaya.



He then worked for Hughes Aircraft Company (later Raytheon Company) in Corporate Security for more than 26 years.

For several years, Chris was an instructor/lecturer in Field Operations (Police Officer Safety/Survival), Disaster Management and Business Continuity for such entities as the California Specialized Training Institute (CSTI), Office of the Government Emergency Services, City of Los Angeles, LAPD, LASD, Hawthorne PD, City of El Segundo and other agencies. He was also a presenter for the El Segundo PD Citizens Academy for the last 3 years.

In his "free" time, Chris coached 26 seasons of girls' softball at various levels. His proudest achievement was coaching the 1974 Girls All Star Softball team and winning the National Tournament, along with Mal and Arleen Charsha.

Chris was a remarkable man who persevered in the face of adversity. He loved people and enjoyed getting to know everyone he met. He will be missed.

Chris was born May 19, 1949 in Van Nuys, CA. He was raised in West Los Angeles and Pacific Palisades and graduated from Pacific Palisades High School in 1967.

After high school, Chris attended Santa Monica College before he was drafted into the US Army. He was honorably discharged in 1970.

Chris began his Police Department career in 1976 as a Reserve Officer. He later attended the Riverside County Sheriff's Academy and became a full-time officer in 1977. In the early morning hours of May 6, 1979, he responded to a disturbance where he was involved in a fatal shooting with the suspect in the alley behind the bar. Chris was shot and left paralyzed from the waist down and retired from the Police Department on May 5, 1980.

In 1980 Chris received a Certificate of Valor from Attorney General George Deukmejian. That same year, he was awarded the South Bay Area Police and Firefighters Medal of Valor.

Will the South Bay face a similar fate as Inglewood?

What do Hulu, Youtube, Facebook, and Amazon all have in common? Silicon Beach, CA. Hundreds of start-up tech companies followed in their footsteps and established offices nearby hoping to take advantage of potential collaboration opportunities, which resulted in densely populated communities. Rapid developments like these have huge impacts on the housing market, local businesses, and even schools. Take Inglewood for example, an area that is currently experiencing a developmental boom. The housing prices and rents shot up the first day of construction of the Sofi Stadium. As USC Masters of Social Work interns in middle schools, one of us has seen first-hand how the rapid development in Inglewood has impacted the community. Businesses are being relocated and parents

have to think of alternative childcare due to school being let out early when events occur at the stadium nearby. Inglewood is becoming a hotspot for entertainment so this will attract young tech companies to relocate to the area due to its accessibility. Due to the overcrowding in Silicon Beach, companies have their eyes set on expanding south where there is less crowding and more affordable housing for their employees. The expansion of Silicon Beach has already begun. SpaceX, the aerospace company founded by Elon Musk, was established in Hawthorne in 2007. More recently the home security system, Ring, established their offices right next to SpaceX in 2021. It is only a matter of time before more companies take root in the cities of Torrance, El Segundo, Hawthorne, and Lawndale.

Golf Team Sees a Bright Future

The El Segundo High School boys' golf team is in its second season after a long hiatus. In the first year, the Eagles competed well, and according to head coach David March, he saw what the future of the program could be. "The team played well and was not intimidated by other established schools we faced. This year, the future is now, and we are playing great."

The team is full of talent and experience. Both captains return in juniors Jack Harris (last season's ESHS boys' golfer of the year) and Ryan Sowder. Returning sophomores Collen Ungaro and Joey Schobel advanced to the CIF individual qualifying round last year along with Jack Harris. Top newcomers are sophomore Remy Romero and freshmen Lukas Da Silva and Shaan Patel.

The Eagles started preparing for this season almost immediately following their last match in 2023. Coach March said, "Our team has been committed since the end of last season to do whatever it takes to be prepared to compete this season in a tough Bay league and challenging non-league schedule."

During the summer, the Eagles held an eight-week program in which Coach March had 100 percent of the players involved. Practice and practice rounds were done at The Lakes and Westchester Golf Course. Once school started, the team played practice rounds three days a week. Coach March said, "We had a bonding overnight team trip to Ventura to play three courses used for CIF playoffs. The experience and being together as a team really helped our team chemistry."

Before starting this season's schedule, the

Eagles practiced four days a week, working at the driving range, chipping, and putting. A typical practice involved an hour of drill work and then a practice round. They had one preseason match against Santa Monica and won at Rancho Park Golf Course 201-211.


High school golf matches are played at nearby courses, with seven golfers competing. Most matches are nine holes, while there are a few 18-hole matches. Scoring is much like in cross country, where the top seven players compete, with scores of the top five lowest scores counted.

Weather permitting, the Eagles will play 22 matches, mainly against teams in higher CIF divisions. The Eagles' schedule is very challenging this year to prepare for an arduous league. Coach March said, "I can't stress the amount of hours this group has committed to golf and how their scores have come down due to their commitment."

The Eagles have started the season 5-1, with their only blemish a tie-breaker 200-200 sixth-player scoring loss to the Walnut Mustangs. The Eagles defeated CIF defending champion Chaminade 379-386 in an open 18-hole match. The Eagles then scored wins over Walnut 171-178 and Quartz Hills 177-181 in nine-hole matches.

Scoring leaders through the first four matches included Jack Harris, 2 over 38, and Lukas Da Silva 3 over 39 in the first match against Walnut. In the second match against Chaminade, Shaan Patel was one under 71, while Da Silva was even par 72. In the third match against Walnut, Da Silva shot one under 31 while two other players

Ryuichi Sakamoto | *OPUS* is a Stunning Send-Off for a Beloved Virtuoso

It was no surprise that Ryuichi Sakamoto had been sick for some time. The legendary composer and pianist had a semi-public battle with throat cancer in 2014, temporarily hitting pause on work engagements and creative output. The documentary *Ryuichi Sakamoto: Coda*, directed by Stephen Nomura Schible, elegantly captures Sakamoto's gentle return to music in 2017 after living in remission from cancer. For fans, the film offered a glimmer of hope that our maestro would live cancer-free and continue to bless us with beautiful music. But the happy ending we hoped for wasn't meant to be. The cancer came back in 2021, and Ryuichi Sakamoto died in March 2023. His final performance lives forever in *Ryuichi Sakamoto | OPUS*, a feature-length concerto directed by his son, Neo Sora.

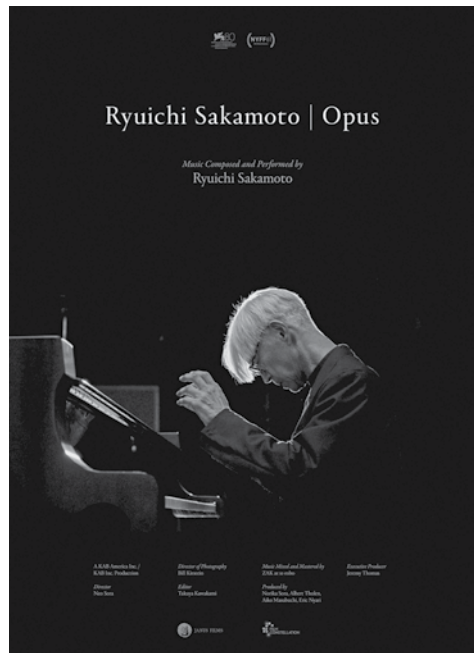
It's hard to find the words to convey just how powerful *OPUS* is. Watching Sakamoto put what energy he had left into this performance is both heartbreaking and devastatingly beautiful. Shot in black and white with practically no spoken words, Neo Sora puts the audience front and center to be immediately swept up in the protruding elegance of the Yamaha grand's ivory keys.

Sora doesn't shy away from close-ups, which is a welcomed sight. Sakamoto's signature eyeglasses are displayed in such stunning detail, as well as his soft, nimble hands and sturdily-constructed jacket.

His career-spanning final performance consists of twenty compositions, including "Lack of Love," "The Last Emperor," "The Wuthering Heights," "Aqua," and "Opus," and ends with Sakamoto's most recognizable song, "Merry Christmas, Mr. Lawrence." Tears were flowing all throughout the film but this finale gutted me. I couldn't help but feel a little selfish watching him play. Here is a 71-year-old man, pushing through visible discomfort to give us, his fans, a final gift. For Sakamoto, the reason he is making this film is clear: it's because he is dying. But instead of surrendering to the illness in self-pity, Sakamoto gracefully and selflessly offers us a lyrical elegy that will withstand time. His legacy is preserved in his music and fortunately, we can revisit this moment in time when Ryuichi Sakamoto graced the world with his stunning compositions through *OPUS*.

The film ends with Sakamoto's favorite quote, projected on the big screen as a reminder to embrace the world as he did. It simply states, "Ars longa, vita brevis," which translates to "Art is long, life is short."

Valentine's Day may be over but books about friendship and love are always nice to read.

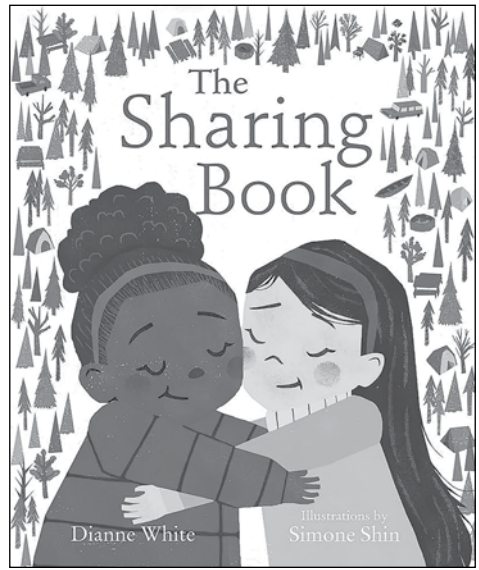
This sweet picture book features beautiful hand painted and digital illustrations by the award winning Simone Shin. The colors that are used are muted and each page has a comforting retro feel.

Understanding Type 1 Diabetes: Should You Get Screened?

(BPT) - More than 1.4 million Americans have type 1 diabetes - thought to be caused by an autoimmune reaction where the body attacks its own cells that produce insulin. Although type 1 diabetes is relatively less common when compared to type 2 diabetes, it's anticipated that cases of type 1 diabetes in the U.S. are expected to grow to five million by 2050, underscoring one of many reasons why increased awareness about type 1 diabetes is so important.

Type 1 diabetes can be elusive, meaning that while you may have the disease for months or years, outward symptoms can take time - sometimes even years - to show in a noticeable way, resulting in more advanced disease at initial diagnosis. What's more, when symptoms do finally present themselves, they frequently present with life-threatening complications, such as diabetic ketoacidosis (DKA). Family History

that truly does not discriminate.

Age

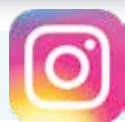

lose his ability to see. The Markows chose to attempt saving their son's sight only to find out the emergency transfer was out of network and they would be responsible for a \$71,000 bill, more than Crissa's annual salary. Ultimately, their son, Bennet, passed six months later, leaving the Markows to fight with their insurance company while also grieving their son.

Other efforts, like the 2021 federal No Surprises Act, aim to prevent this exact situation; however, Bennet was born before the bill went into effect.

Hospital prices, historically, were not publicly available and were set by each hospital's management. Prices for the exact same service could be four times as much at a hospital in the same city. The Hospital Price Transparency Rule was issued via executive order and took effect on January 1st, 2020. This required all hospitals to make their prices available online.



In theory, this would allow patients to determine the best location for their medical needs.

While the Hospital Price Transparency Rule was a tremendous victory for patients' rights, clear out-of-pocket costs were still hard for patients to determine. In response, Biden recently passed the Transparency in Coverage Final Rule (CMS-9915-F) which requires hospitals and insurance companies to create online tools that will accurately tell patients what cost they should expect.

Medical debt has become such a dire issue in this country, with research supporting over 66% of bankruptcies involved medical issues. It's estimated over one-third of Americans currently have medical debt. To combat this financial burden states like Connecticut have taken matters into their own hands. The state's recently enacted Medical Debt Relief Initiative uses surplus COVID-19 relief funds to wipe

out medical debt. The initiative will affect over 250 thousand residents and is estimated to erase over 1 billion dollars in debt.

Despite the recent rulings, enforcing the Hospital Price Transparency Rule and the Transparency in Coverage Final Rule remains the biggest shortfall. While the penalties for hospitals' non-compliance start at \$300 a day until corrected, without enforcement, hospitals have not been quick to follow the guidelines. In 2020 and 2021, only four hospitals nationwide were penalized and fined.

Power to the Patient and its allies remain committed to advocating for patients' rights and holding hospitals and insurance companies accountable for existing laws and guidelines. During Cartagena's interview on CNN, he smiled and said, "I never thought Fat Joe the rapper would be saying 'Enforce the Law,' but I am..."
