City Voices Strong Disapproval of Massive LAX Expansion

The city has put Los Angeles World Airport officials on notice that El Segundo believes the airport's planned expansion violates state law and should be scaled back. A 200-page response to the airport's environmental impact report was delivered Monday, a legal step that Mayor Drew Boyles admits won't halt the project entirely.

Holding up the three-inch-thick response to the LAX development plan, Boyles said El Segundo officials hope to minimize the jet noise, air pollution, and traffic expected from the addition of two passenger terminals and 29 arrival and departure gates at the airport. LAWA wants to build the airport's first terminal east of Sepulveda Boulevard.

According to the mayor, the east terminal and rerouting airport traffic toward El Segundo and neighboring cities greatly concern El Segundo officials. The thick document for LAWA officials to consider before any construction can begin includes statements by expert witnesses who say the airport's latest modernization draft plan violates the California Environmental Quality Act. Known as CEQA, the law protects people living near large developments and requires the airport to inform the neighboring cities of its plans.

Manhattan Beach, Hermosa, Torrance, and Rancho Palos Verdes were expected to file letters objecting to the environmental and traffic impacts, which the LAX draft EIR readily admits will result if another concourse and terminal are built at the airfield. Boyles estimates five or six local governments are on record opposing the expansion unless changes are made to minimize the noise, protect the air,

and additional car trips. LAWA must respond to public comments from surrounding cities and other stakeholders before moving forward.

"We can't stop this project from happening," the mayor admitted, explaining the city's best hope is to get airport officials to carefully consider how the changes in passenger traffic at LAX will adversely affect its neighbors.

"We can insert ourselves in the process from a political, legal, and public-relations standpoint to ensure we get the best deal possible for the El Segundo residents," Boyles said. The deadline to file public comments was Monday. LAWA officials extended the comment period at the

request of El Segundo city leaders.

The LAX construction is estimated to cost \$6 billion and take seven years to complete. Increasing the number of daily arrivals and departures has a long-term effect. However, the dust and air emissions from construction are the more immediate concern for El Segundo.

Passenger capacity at LAX could grow by 50 percent over the next two-and-a-half decades. "All of this is going to have a profound effect on us," Councilman Lance Giroux warned back in November when he briefed council members about the size and

El Segundo Realtor Bill Ruane Continues to Crush the Competition

Anyone who has lived in or traversed the confines of El Segundo has probably viewed the branding signage of RE/MAX's Estate Properties wildly successful realtor Bill Ruane on commercial properties and homes for sale, or maybe even a bus bench or two.

to property owners in the South Bay. An El Segundo resident, Ruane, who is the youngest of six siblings, was raised by parents who worked in the medical field (his mother was a physician), said his interest in becoming a realtor was piqued by palling around with a friend whose father had his own El Segundo real estate business. Asked what makes El Segundo such a perfect fit for his real estate talents, Ruane succinctly summed it up: "I grew up here, I live here, I like it, it's enjoyable."

James Sanders, a local RE/MAX CEO and co-owner, feels that Ruane is successful because he "really cares about the outcome. He is helping (his clients) achieve the American dream. Since he is so connected, he can often connect the buyer with the seller. He thinks, deep and hard, always thinking about the client."

"I am super competitive and like the challenge that real estate offers," Ruane said, noting that his level of client service does not change depending on the value of the property, whether it be a start-up home or a megabucks residential property. Ruane said that he likes the feeling of "winning for your client" and the satisfaction he receives from closing the transaction with a satisfied client. "A win-win," he said. Said Sanders about the traits of a successful agent: "It is really about just helping people," mentioning that he often receives a note from a very satisfied client, post-sale, about Ruane's top-notch customer service.

Ruane has become a featured media star, with appearances on the RE/MAX Zoom production "Good Morning RE/MAX" that is available for viewing by 130,000 agents and has also been spotlighted on segments run on the American Dream TV channel.

As for industry recognition, Ruane has garnered numerous tributes. He was feted in 2020 as a winner of the "Paramount of Excellence" award, one of "only three agents in the entire RE/MAX network of 130,000" to be so honored, Sanders emailed. Ruane also

picked-up the industry's prestigious "Pinnacle Award" in 2020. Both awards recognize high echelon, top producing agents.

On winning realty top producer accolades, Ruane chuckled and said, "staying number two or three is great, because if you are #1, the only way that you go is down, right?"

Sanders's mother, Sandra Sanders, established the RE/MAX Palos Verdes office in 1984, and, emailed James Sanders, "had the vision to establish a brokerage with an environment for the real estate agent that is positive, professional, and supportive in order to deliver the best possible service to their customers."

Ruane continues to embody the aspirations established by Sandra Sanders more than three decades ago. James Sanders said that, some 37 years later, he and his siblings have attempted to "foster the same values as their

mother, and have gained momentum, a loyal following, and a shift to a more efficient online and digital support that has taken RE/MAX Estate Properties to new levels."

Sanders said that RE/Max Estate Properties "has been the #1 real estate firm in sale volume in the South Bay since 2010," and that

his empire to include listings in, among other areas, Westchester, Marina Del Rey, and Venice. "He is just a great guy," Sanders said. "We, as a company, as you can imagine, take care of him. He has a lot of balls in the air."

RE/MAX is a worldwide realtor network, boasting 130,000 agents. Of the approximately 70,000 stateside agents, Ruane ranked #2 in the U.S. in 2020 and #3 worldwide. "That is pretty impressive," said Sanders. "He is always thinking ahead, thinking what he can do to give back to the community and how to help others." Sanders noted that the RE/MAX team racked-up more than four billion dollars in sales in 2020 and completed more than 4,000 transactions.

Discussing the state of the real estate market in March of 2021, Sanders said that RE/MAX had approximately 500 properties in escrow, pre-pandemic, but that once the realities of COVID-19 hit, 30 percent of the proposed buyers, he said, canceled. "Scary times," he said. "The world was going to end...I think a lot of people felt that way...We didn't know what was going to happen. Who knew that" he continued, as the COVID pandemic escalated, "people would actually realize the value of having a home?"

Sanders noted that, currently, the clamoring to own a home has led to a low inventory of available properties because many people now look at their home as their office, their work-out facility, and, at least at this point, their children's classroom, all the while (mostly) following social distancing guidelines, somewhat quarantining with their family members.

"Homes became (more) valuable," Sanders said. "People are really seeing the value of (homeownership), as more than just an asset, but as a place to raise a family, go to school, work-out, and cook. It has changed the whole perspective of what owning a home means. And that is why we have low supply, high demand, and prices are coming up."

Towards the end of our interview, Ruane was asked, if he had not chosen the real estate pathway, what other profession may he have pursued? He laughed and paused a bit, "that's a good question," he said, before answering that "I don't know in what other career they would have tolerated me."

Suffice to say that the buyers and sellers that Ruane has worked with and for over his career are very satisfied that he stuck to the field of real estate. Summed-up Sanders: "Bill is the consummate professional, always taking care of his clients." •

Ruane is not only a top producer in the South Bay and the United States, but in the entire world of real estate agents working under the RE/MAX umbrella. "Bill is amazing," Sanders said. Britt Deanda Brings Kundalini Yoga to El Segundo

A few years ago, Britt Deanda quit her corporate job. She moved to El Segundo for its slower and quieter atmosphere by the beach with her husband to raise her children. And it was here that she founded Elevate the Globe, where she now teaches South Bay residents and clients from all over the world how to “raise your vibration, find your bliss, and stay energized all day.”

Born in San Diego, Britt moved to Temecula while she was still in school. When

she was twelve, she met Tara Schulenberg in a ballet class. Little did they know, over a decade later, they would found a wellness business together.

After splitting up for college, Britt moved back to LA. Her stress began to build as she navigated climbing the corporate ladder in ad sales, dealing with a breakup, and helping her mother through a diagnosis of lung cancer, news she learned just two weeks after getting married. With the pressure mounting, unhealthy habits forming, and not feeling fulfilled in her day-to-day job, Britt decided to take a yoga class in West Hollywood. What she thought would be a regular yoga exercise class turned out to be Kundalini yoga.

Kundalini yoga was the first yoga practice ever created. Kundalini in Sanskrit means “coiled snake.” It follows that a person has energy coiled up at the base of their spine, and through yoga and meditation, one can begin to uncoil this energy and connect with the inner self. In its early days, around five thousand years ago, Kundalini yoga was reserved for royalty. The knowledge was passed only from teacher to student, who then became the teacher. To practice was

posture might be held anywhere from three minutes to eleven minutes or more.

Because it was so specialized, Kundalini practice was not brought to western society until the late 70s, when brought to the U.S. by a yoga master. Through this class, Deanda had a peaceful, healing experience. It was a break from everything going on in her life and set her on a path that would define the next chapter of her life.

In 2015, after leaving her corporate job, Britt’s mother passed away from her cancer. Three months later, she found out she was pregnant, moved to El Segundo, and adopted a plant-based, vegan diet. With all the chaos of grief, pregnancy, and moving, Kundalini Yoga remained a constant.

After reconnecting with her friend Tara from high school and gaining a certification to teach Kundalini yoga, they used their practice to help them find fulfillment and ditch unhealthy habits, addictions, and coping mechanisms. Britt and Tara founded their spiritual lifestyle brand with the hope of bringing Kundalini yoga to the masses and helping others find the clarity and peace that they found.

Baseball and Softball Preview

The 2020 high school baseball season was washed out because of the pandemic. The Eagles featured a team with just three senior starters but were on pace to win 20 games. Last season is in the rearview mirror and head coach Billy Traber, starting his fifth season at the helm, says this year’s team was eager to get out on the field and play. “They couldn’t have handled the adversity any better than with the class and the work ethic they’ve shown.”

With the high school baseball field under repair and not safe or ready to practice or play on, the team works out at Stevenson Field. “They could care less where they practice or play. They were chomping at the bit to get on the field,” Traber said. Now with the season on the brink of starting, you can feel the energy as the players prepare for what could be a full schedule.

The Eagles return nine players from last season, including seven starters. Julian Rodriguez is one of those rare four-year varsity players who has limitless upside. He could be one of the top catchers in the South Bay and, with his power, could hit third or fourth in the lineup. Brendan McAndrews is a three-year starter and has shown that he could be mentioned in the same breath with other former Eagle greats at shortstops such as Tom Soto (1974), Wil Parsons (1986), Mark Lewis (1990) and Kobe Estrada (2006). Rafael Smith is a speedy outfielder who started last season and was hitting over .400 before the cancellation of the rest of the schedule. Junior second baseman Evan Smith led the team in hitting and proved he is a perfect fit at second base. Lloyd Sapanza will be counted on to play first base and should

see time in the outfield. Kenny Chung and Cooper Stolnack look to see time at third base. Jake Stolnack and Brian Pham return as part of a deep pitching staff.

First-year players will be multi-talented Christian Kramer, who can play the outfield and back up Rodriguez behind the plate. Eddie Grant is a hard-throwing pitcher who can play the infield and outfield. Jack Stoker can

play anywhere in the infield, Owen Kirsten will add depth to the pitching staff and Trevor Steele, who will play in the outfield with his speed and a strong arm. Sophomore utility player Brady Engelhardt looks to make the team stronger as another infield/outfielder and pitcher.

The pitching staff is deep with plenty of experience. Kenny Chung, Brian Pham,

Film Review

Tilda Swinton Captivates in *The Human Voice*, Pedro Almodóvar's Deconstructed Short Film

 At just thirty minutes long (the length of a TV episode), Tilda Swinton commands every second of the small screen in Pedro Almodóvar's beautifully staged and winkingly meta new short film, *The Human Voice*.
 Based "freely" off of a play by Jean Cocteau, Almodóvar takes the concept of the "one-woman show" from Cocteau's play and

re-tools it to fit within the times of which he made his film, which was during the middle of the pandemic last year.
 With Tilda Swinton as the film's singular character, *The Human Voice* (which was also selected to play at last year's Venice Film Festival) is a devilishly playful bit of pop-art filmmaking that sees the director combine his source material's wonderfully satiric silliness and makes it a meta viewing experience that

comments on both film production and how we communicate as humans.
 In *The Human Voice*, Swinton plays an actress unhinged, at first silent and vacant as she sulks about her decadent and deadening modern apartment, but then fiery and alive at the sound of her iPhone ringing, her lover on the other end of the line.
 Over the course of their on-off conversation (of which we only hear Swinton's side of throughout the entirety of the film) she switches from depressed and pilling boozier, to desperately needy partner, to rage-filled and scorned woman of the world all in a moment's time.

The Human Voice does communicate a narrative story (kind of), but just as Almodóvar makes a point of regularly reminding us that the apartment is in fact a set within a soundstage, and the actor alone within it all, the film should really be watched and appreciated for what it is: an exercise in filmmaking where the audience gets the rare chance to deconstruct, study, and understand all the parts that go into the art of filmmaking, which feels so special to get during a crossroads in film production when everything was flipped on its head. Personally, I think it's something worth shouting for.

It's a high task to have to create the entirety of a world when you're acting alone, but if there's anyone in Hollywood who can do the job, it's Ms. Swinton, whose talents and stamina make the film captivating. What she does so effortlessly—communicating an entire story and relationship of a fictionalized, passionately troubled couple—is accomplished all by way of using a singular element: her voice.
 And she does this with gymnastic range, pitching up her voice to harken back to old Hollywood romantic starlets, and then down-shifting gears into a lower register to convey darker colors. Her voice work on display here is as vital and deadly as any of Almodóvar's beautifully composed hardware and tools that are so artfully composed within the background.

30 minutes. *The Human Voice* is now playing in Los Angeles at the Vineland Drive-In Theater. •

"It's just opened up a lot for me as far as my life and how I've been able to change it and what I've been able to accomplish," Britt says, "It [brings] those unspoken things that are hard to describe but just... higher levels of happiness."

Through her practice, Britt now teaches online yoga classes, offers coaching, programs, and (during non-Covid times) retreats in places like Joshua Tree, Bali, and all over the world. Her programs are comprised of things like "the conscious bump," a yogic approach to pregnancy, and "good morning intentions," a forty-day morning ritual challenge about which that she and Tara recently published a book.

In the future, Deanda hopes to open up a physical studio. She hopes to continue to expand her business all over the globe and continue to help others find the clarity in their life that she has found in hers. If you find yourself feeling stuck in your life situation, be it feeling unfulfilled in your job, or using outside mechanisms to cope with your daily struggles rather than looking inward, Britt has some advice.

"Ask yourself: what do I want?" says Deanda. If you're unhappy with something, allow your mind to explore the question of what things could look like, no matter how far-fetched. Give yourself the chance to see possibilities that seemed impossible before. Focus on yourself.

She leaves us with a short breath work exercise from her book, *Good Morning Intentions*, for readers to try at home.

Get comfortable in a cross-legged position, straight spine, chin tucked, and chest lifted. Place your hands in Gyan Mudra, with the tips of the thumbs and index fingers touching and the rest of the fingers out straight. Next, close your eyes, and begin to concentrate on your breath. Inhale through your nose in eight equal breaths, and exhale through your nose in one deep, powerful breath. Continue this pattern for three minutes.

Finally, to end, inhale deeply and hold for five to ten seconds; exhale. Inhale deeply again, hold for fifteen to twenty seconds, rolling the shoulders forward. Exhale powerfully. Repeat this last step, and relax. •

Jake Stolnack and Lloyd Sapanza lead the staff. Each brings a different look, but they all have one thing in common: they have a good command of their pitches. When you add Eddie Grant, Owen Kristen and Brady Engelhardt to the mix, you find the Eagles have enough depth to throw at the opposition.

The offense could be exciting with speed and power throughout the lineup. Look for Brendan Mc Andrews, Evan Smith and Rafael Smith to get on base with Julian Rodriguez, Cooper Stolnack and Kenny Chung to drive them in.

The Eagles once again host the Stevenson El Segundo Tournament, which begins Friday night at home at 6 p.m. They'll host Millikan on Saturday at 11 a.m. before road games next week. With the cancellation of the Redondo Tournament, the Eagles will compete in the El Camino Real Tournament, featuring some of the Southern Section's top teams. This year the Eagles rejoin the Pioneer League in what looks to be a battle between five teams. At this time, the CIF is still deciding on a CIF Championship tournament format. Should the Eagles advance to the postseason, they'll compete in Division 2, one of the most competitive divisions.

Attendance for spectators will be restricted and social distancing along with masks required will be monitored and enforced.

Softball Team Loaded with Talent

The Eagles are two seasons removed from

an appearance in the CIF finals. That team was filled with gifted players who came together to be successful. Head coach Megan McCann, who begins her fifth season, believes this year's team can be just as good because of their hunger for the game. The Eagles return 14 players from last year's team, which should give them an edge this season. Coach McCann said, "The girls are focused on how much they love the game and how much fun they've had together the past few years." She added, "The past year has taught us all not to take any practice or game for granted."

Since the shutdown of the softball season last March, many of the players have been able to play on travel teams but missed the opportunity to play together. That's all changed now, and the team is jelling together to make a run at their first Pioneer League championship in 12 years.

Coach McCann will lean on a group of seniors who will provide their leadership and their athleticism. Katie Croxall is a four-year starter and will anchor the infield at shortstop. Mya Bennett is another four-year player with infield skills. Other seniors who look to make an impact are infielders Shanai Owens who led the team in stolen bases two seasons ago, and two returning infielders Isa Gomez and EB Steinbacher. Outfielders Kelly Carignan, Laila Phillips and Leah Abitante are all three-year starters

and should provide an outstanding defense as well as form one of the best outfields in the South Bay.

Other returners are juniors Sophia Marrero, who is a three-year starter behind the plate. Pitcher Bailey Gertsch-Douglass. Azah Benshir, who plays first base and one of the corner outfield positions, and Norah Green, who can play multiple positions. Sophomores, middle infielder Bella Gridley who batted .356 last season as a freshman, and pitcher/outfielder Avery Chavez.

New to the varsity this season is junior catcher/first baseman Riley Mossman, sophomores Sammie Kleiger who has great speed and plays multiple positions and pitcher Sofia Tembalor add depth to the Eagle's pitching staff. Freshman pitcher Maiya Anderson has shown great control and location and could be vital to the team's deep pitching staff.

Bailey Gertsch-Douglass leads a deep pitching staff that is loaded with young talented arms. Avery Chavez has great command of her pitches, while Sofia Tembalor is a strong athlete who competes with passion. Maiya Anderson is just a freshman but competes at a high level with her control.

Katie Croxall heads a batting lineup that could see some lofty batting averages. Croxall hit .444, Kelly Carignan .400, Sofia Marrero .377, Leah Abitante .375, Laila Phillips .325 and Shanai Owens .275 with 13 stolen bases during their run to the CIF final appearance

in 2019. Now add Avery Chavez and Bella Gridley, who both showed a knack for hitting as freshmen, and you could see the Eagles roll out a formidable lineup capable of putting up a lot of runs.

The Eagle's future looks to benefit from a very talented junior varsity team, according to coach McCann. Sophomore utility player Miranda Sullivan has a speedy bat with power. Freshman pitcher Hailey Wantz has a good riser with good control, while Maya Holtzman looks to lock down the infield at shortstop, and Chloe Crabtree will do the same in the outfield.

The Eagles have their home opener on Tuesday, March 23, at 6 p.m. when they host Mary Star. This season they join the Pioneer League, which features South Torrance and Torrance. Both teams joined El Segundo in competing for a CIF division championship at Deanna Manning Stadium in Irvine in 2019, the last time a CIF championship was held.

The El Segundo Athletic Department is cautioning those wanting to attend football games to start the season. Each player will be allowed up to four support people to attend games, and they could be family or friends or a combination of both. Social distancing will be monitored and enforced, and a mask will be required. •

scope of the runway and terminal project. Giroux is El Segundo's representative on the Los Angeles Area Advisory Committee. It reviews airport operations issues that impact nearby communities and makes recommendations to the airport commission, Los Angeles mayor's office and city council.

Airport officials say the expansion is needed to improve efficiency at the nation's second-busiest airport. A people mover that will convey passengers along Century Boulevard from a transportation and parking hub is currently under construction.

In Other Council Actions:

TopGolf has decided to redesign the nine-hole course to make it more challenging and attractive to golfers of all skill levels. The company, which took over The Lakes driving range and course and will manage the city-owned property, asked the council to amend the original development and design agreement. TopGolf will spend another \$800,000 to create a new course layout, with all-new grass on tees, greens, roughs and fairways. The

former site of The Lakes - when it opens in May 2022 - will be an all-new course instead of a modified one. The council unanimously approved these changes:

- All tees being expanded to allow for short, medium, and long hitters. This should attract golfers of varying experience levels. The tee boxes will be laser leveled, too. New drainage and sand will be used on all bunkers instead of just some. Incorporating the lake on the course to two holes on the course instead of one. Golfers will face water hazards on holes number seven and nine.

The nine-hole course will feature a three-level driving range, restaurant, and entertainment venue on site. It's estimated the site will bring 400 jobs and generate up to \$2 million per year in new revenues for El Segundo.

• On the recommendation of the council's Pension Ad Hoc Committee, the members adopted a policy to follow in the event of future unfunded pension liabilities. Should the state-run public-employee pension system

- CalPERS - raise El Segundo's contribution level, the city would tap up to 50 percent of any new revenue to pay down what it owes. Local governments must pay higher contributions when CalPERS reports lower-than-expected earnings on its portfolio.

The issue of unfunded pension obligations to CalPERS remains a huge concern to the current City Council. El Segundo is looking at issuing \$152 million in low-interest bonds to pre-pay its future pension costs and avoid millions of dollars in interest charges to CalPERS. The pension-finance plan could save the city \$61 million through 2041.

• City Treasurer Matt Robinson reported El Segundo's investment portfolio earned \$413,000 in the fourth quarter of 2020. Despite the economic slowdown and loss of tax revenues due to COVID-19, the city ended the calendar year with a positive cash flow. The balance at the end of December was \$737,577, according to the treasurer's report.

• On a narrow 3-2 vote, the council OK'd spending \$581,000 to replace the windows,

install shades and remove hazardous materials from City Hall offices. The council accepted the bid by A.J. Fistes Corp. Councilman Scot Nicol and Councilwoman Carol Pirsztuk voted against the expenditure. The windows at City Hall haven't been replaced in several decades, and Councilman Giroux said the project was long overdue.

• The state Homeland Security Grant program awarded the city a \$541,900 grant to buy equipment and training so that local fire departments are ready to respond to acts of terror or national emergencies. El Segundo is recognized as a leader in preparedness response, having created an All-Hazards Incident Management Team before the COVID-19 pandemic began a year ago.

• The council accepted a \$43,000 grant from the California Department of Justice to reduce tobacco use among teens. The Police Department will use some of the money for outreach to minors, enforcement, and to catch retailers who break the law. The legal age to buy tobacco products in the state is 21. •
