Scout Troop 267 Still Making a Difference After 100 Years

When it all started, the U.S. President was Calvin Coolidge, the Great Depression was years away, television was found in nobody's home, and the Babe Ruth-led Yankees ruled baseball. Meanwhile, El Segundo was still a fledgling town with strawberry fields and a very small population based near the Standard Oil refinery. There was no high school or airport as yet. However, the weekly Herald newspaper was going strong 14 years after its first edition. These were just a few notable milestones in 1925 when Boy Scout Troop 267 was officially established in town. Described as "the backbone of youth development in El Segundo" that provides "leadership, outdoor adventures, and lasting friendships," the nowiconic outfit recently celebrated its centennial with a well-attended event at its long-time headquarters on Grand Avenue.

About 75 scouts, scouters, alumni, and family members came by to honor the troop for the special occasion. "The El Segundo Scout House was beautifully decorated in a fantastic tribute to the longest continuously operating troop in the South Bay," said Scoutmaster, 267 alumni, and El Segundo-born and raised Eric Kari.

To begin the ceremony, Kari asked for a moment of silence in honor of the Scoutmaster of his youth, Shelly Butler, who passed away on February 21—only three days after the El Segundo City Council issued a commendation to Troop 267 in recognition of the 100th anniversary. That evening, the scouts opened the meeting with a flag ceremony and led the Pledge of Allegiance. "We're truly thankful to the City Council for recognizing this milestone and to the volunteers, leaders, and

scouts who've kept the scouting flame during all these years," Troop 267 Committee Chair Allen Semerdjian said.

The centennial attendees additionally shared their personal experiences as part of the troop and the impact it made on their lives. Mayor Pro Tem Ryan Baldino also presented the troop with a Council proclamation at the event.

Kari noted that he was extremely proud of his time with Troop 267, both as a youngster and now as an adult leader coming full circle. "As a boy in the troop, I never realized just how well it was preparing me for my future," he said. "I just thought I was having fun. But as an adult, I see just how well the troop shaped me for leadership, civic responsibility, and active citizenship. It has been my distinct privilege to pass along the lessons I've learned to the youth under my charge. They get so much out **See Scouts, page 6**



Second Act for Library's Canary Island Pine?

The Canary Island Pine removed from Library Park this month couldn't be saved, however, one El Segundo man envisions a second act for the 60-foot-tall pine that shaded park visitors for nearly a century.

A tree-care company examined the pine and declared it dead in February. Dying bark indicated an insect infestation, and the pine needles had turned brown, prompting a recommendation that the longstanding tree be removed because it posed a hazard. Crews cut down and removed the tree from Library Park on March 3.

Bryan Shepard, a resident and local businessman, told the City Council Tuesday night that he wants to preserve the memory of the towering pine and repurpose the salvageable wood from the tree's trunk. A 45-foot section of the trunk was taken to an Ontario arborist, with hopes that money can be raised to find contemporary uses for the urban timber. Local supporters created a GoFundMe campaign to help with the expenses.

The "Milton C.I. Pine," as the tree was known, can be fashioned into seating or furniture for public or private indoor use, he explained in a letter to the council outlining preliminary plans to move the timber from its current location in Ontario to the woodworking business in Los Angeles.

Shepard pitched the idea to the council, explaining that having a bench, for example, constructed of pine wood could reconnect people to the tree, which was planted in 1950 and had a trunk width of 3.5 feet. Angel City Lumber in Los Angeles accepts old and historic trees and works with customers to turn out contemporary pieces that serve as reminders about the benefit of trees in urban landscapes.

"Trees are important and a way for us to connect with nature," he said, adding that

many El Segundo streets are named after tree species. Amazing things are being done with reclaimed wood, he told the council.

His hope is the city will engage in the campaign to repurpose the Library Park pine and demonstrate that old trees are good for something other than mulch. "They aren't trash, they can become something beautiful."

City Manager Darrell George indicated the city is open to the timber-reclamation idea and will be placed on a City Council agenda after talking with the arborist and Angel City Lumber. When that happens, Councilman Ryan Baldino invited Shepard back to talk about a second act for the old tree that stood 95 years.

The Recreation and Parks Commission was scheduled to meet midweek to discuss and possibly select a replacement tree for the Library Park.

At Tuesday night's meeting, the council continued a public hearing about residential parking requirements for multi-family dwellings. With density in R-3 areas expected to increase in the future, the council is searching for a parking-space formula that eases street parking near apartments and condominiums.

The council rejected tandem parking on multi-family properties in previous discussions despite the Planning Commission's willingness to allow some tenants to park two vehicles end-to-end in one space.

The new proposed parking requirements would allocate one parking space for a studio, two spaces for one- or two-bedroom units, and one guest parking space for every three units. The proposed changes apply to dwellings on two acres or less.

Any projects larger than two acres or that propose less on-site parking than the city requires would be ineligible and would either


Delivery Issue on Eastside

be subject to a development agreement or need the City Council's approval.

The update, if approved by the council at its April 2 meeting, would include penalties for illegal garage conversions. Penalties range from denial of new parking permits to revocation of existing permits.

Before the measure passed on a 4-0 vote, Mayor Chris Pimentel said he believed the revisions adequately address the issue of parking sprawl "at this time."

In other council action:

El Segundo Police Department hired 21 officers in 2024 and currently has 66 positions filled, according to an annual update of staffing and crime statistics. Chief Saul Rodriguez told the council that crime was down 18 percent in 2024 with no homicides, 137 assaults, 22 robberies and seven sexual assaults. The number of reported burglaries, thefts and car thefts also declined last year. There were six cases of arson in 2024.

According to the chief, property crime accounts for 90 percent of the city's incidents. Organized theft rings were responsible for 104 thefts, with three stores at the Point and Plaza being hit most often. Kia and Hyundai vehicles accounted for nearly one-third of the car thefts and attempts in the city last year. In all, 116 vehicles were targeted by thieves last year, and 51 were stolen and recovered.

The city will create an underground utility district for Lairport Street. The action is needed before Southern California Edison can bury power lines and remove power poles from the sidewalks. The cost to design and install the underground utilities, including fiber-optic cable and communication lines, would be covered by the utility company, according to Public Works Director Elias Sassoon. Any power upgrades requiring more transformers to boost the power supply would be the city's responsibility, he advised the council. According to the Public Works Department, the district will encompass Lairport Street from Maple to Mariposa Avenue and take six to nine months to design and up to one year to complete construction.

El Segundo may exit a municipal risk pool used by 13 other cities for insurance coverages, including workers' compensation, general liability, cybercrime and terrorism. This will be the second time since 2022 that El Segundo has informed the Independent Cities Risk Management Authority of the its intent to leave the risk pool and look elsewhere for insurance products.

If the city decides to remain in the group, it must notify ICRMA by December 1. El Segundo has been a member of the municipal risk pool since 1985, and wants to explore other options and possibly join other risk groups, Human Resources Director Rebecca Redvk explained. Another option is going solo and buying coverage directly, she said.

Mayor Pimentel also announced the selection of Steve Taylor and Melissa Mc-Caverty to fill vacancies on the five-member Planning Commission. •





The El Segundo high school's baseball team has started the season with an undefeated record. With an 8-0 record and the program's first El Segundo Tournament championship in decades, the Eagles are hitting on all cylinders. The unblemished record, except for a 7-7 tie with Los Alamitos, is the best start for the Eagles in over fifty years. Nobody expects the Eagles to run the table, but they are making others sit up and notice how well they're playing. The sophomore follows in a long line of outstanding Eagle shortstops over the years, including Gary King, George Brett, Tom Soto, Wil Parsons, Mark Lewis, Robi Estrada, Grant Palmer, and Lars Nootbaar. 

of scouts, and they just think they're having fun. This cycle will again repeat itself, which is what has made this troop so successful for the last 100 years. I am grateful to have a part in its history."

That history features countless highlights, with over 100 boys in El Segundo earning the prestigious Eagle Scout rank—the highest honor in scouting. Inspired two years earlier by Robert Baden-Powell, William D. Boyce founded scouting in the United States in 1910. An act of Congress officially chartered scouting in 1916 and El Segundo organized a Boy Scout troop in February 1918, as reported in the Herald at the time. "All troops nationwide were initially designated as Troop 1, and differentiation into other unit numbers only occurred after it became too confusing to multitudes of troops that were all similarly numbered," Kari explained. "So in reality, the troop is 107 because Troop 1 changed to Troop 267 in the 1925 timeframe."

Throughout its existence, Troop 267 has followed the hallowed 12 principles of scouting: "A Scout is trustworthy, loyal, helpful, friendly, courteous, kind, obedient, cheerful, thrifty, brave, clean and reverent." Those components guide the scouts as they engage in activities that build character, develop outdoor skills, and promote community involvement. With 137 merit badges available to learn In a plethora of areas, scouts can create a well-rounded early life resume that helps them navigate their future careers, as well as prepare them for parenting, service, and overall citizenship.

Troop 267's monthly activities include backpacking, camping and varied high-adventure experiences that provide physical and mental challenges. The annual week-long summer camping trip is a beloved tradition that continues

to top the list of favorite outings. "Our troop is going to Emerald Bay in Catalina this year and we have most of the boys signed up to go," Kari reported. That trip combines scenic beachfront and mountain camping with sailing, kayaking, snorkeling, and scuba diving among the options available. "We have other short-term adventures as well. We are going to Camporee [a regional gathering] in April where we camp with a bunch of other local troops, and we will go backpacking in the San Gabriel Mountains in May." The group also spent the weekend in Carrizo Plain, a national monument in San Luis Obispo County, earlier this month.

Currently, the troop has a membership of 17 scouts, though the numbers continually change as boys age out once they become adults and new members join the fray. "Boys ages 11 through 17 can be scouts," Kari said. "The younger they start, the better because they have more time to adventure and earn their way to Eagle. That said, we welcome older boys who have a sense of adventure and want to build skills and do outdoor activities."

The scout-led model encourages independence, decision-making, and teamwork. As such, the adult leaders act as advisors and do not try to dictate the proceedings. It's all part of the strategy to help the boys develop into responsible and confident adults. The game plan hasn't really changed since 1925 despite the advent of virtually endless technologies and a world that El Segundo residents 100 years ago could never have imagined. No matter the era, it will always be useful to learn how to build a fire, cook, administer first aid, and become a leader in one's community, among the many other skills that will always have a place in life. It never gets old, even after a century....


