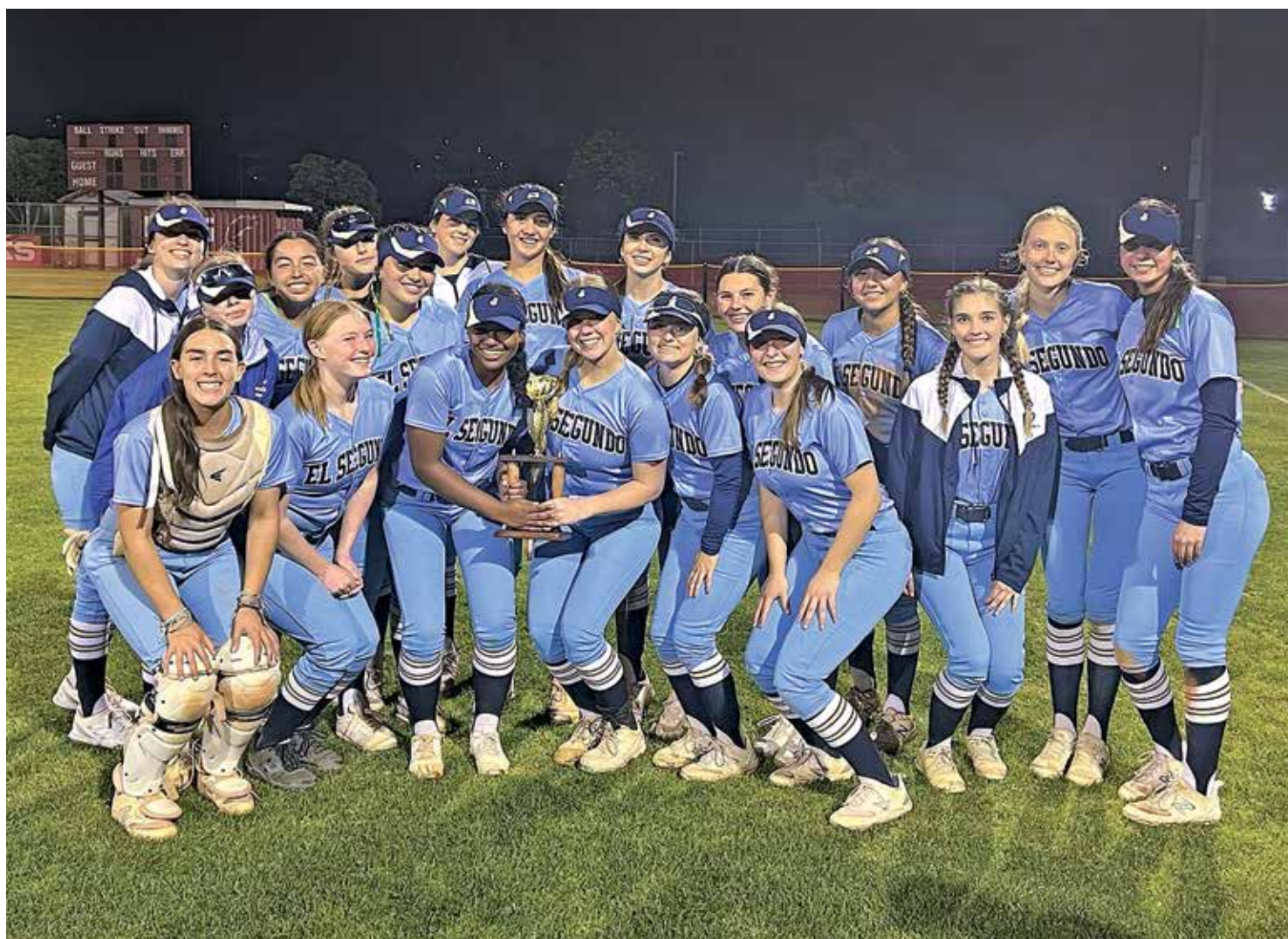

## Parking Zone's Boundaries Widen, Hyperion Problems, Fund Swap, Outdoor Dining Downtown

At its regularly scheduled City Council meeting last Tuesday evening, the El Segundo City Council added streets to its pilot parking permit program for Preferential Zone 3, made a \$1 for 75 cents swap of funds, feted retiring Police Chief Jaime Bermudez, saw a data-driven financial forecasting tool presentation, and watched a high-level overview presentation of outdoor dining in downtown El Segundo.

In other news, Certified Green businesses in the city were announced, the council watched a work plan presentation from the Environmental Committee and heard the latest news on the Hyperion Water Reclamation Plant from City Manager Darrell George, who provided an update on what's being done to combat the plant's ongoing odor issues impacting El Segundo. Ever since the plant, which is owned and operated by the City of Los Angeles and sits adjacent to El Segundo to the city's west, had an emergency in July of 2021 that greatly impacted residents, the city council and city staff have been confronting the ongoing realities of consistent issues at the plant with progress taking place slowly since the 2021 emergency incident. In a letter to LA Mayor Karen Bass in late February, city officials asked for Los Angeles Sanitation & Environment Director and General Manager Barbara Romero to be removed from overseeing the facility. Romero was hired in July of 2021. George said city staff had met with LA City staff and staff from other legislators' offices

(LA County Board of Supervisors Holly J. Mitchell, State Senator Ben Allen, and Congressman Ted Lieu, among others), including Ryan Jackson, director of public works in Bass' office, calling it an "all-hands meeting yesterday" and noting that he believes changes will be forthcoming in plant management. He told the council Mayor Bass intends to create a Division Manager position and that the gameplay moving forward calls for "organizational changes" in the "next several months." El Segundo officials said that a "significant recent uptick in odors" that "continued for several weeks" prompted the letter to Mayor Bass amid ongoing frustration since the July 2021 emergency incident sent sewage into the ocean with flooding and equipment damage inside the plant. Hyperion has yet to complete 33 recommendations made by a committee shortly after the emergency to avoid another emergency or catastrophe. George said he thinks LA City now has a "desire to seek outside experts" and that "perhaps" some El Segundo city officials may even be included on interview panels.

Council member Ryan Baldino said, "We are optimistic that with the help of..." the legislators and a reorganization of some 30 LA City/Hyperion staffers, the situation would improve. He also noted that the city would continue to advocate and verify for its residents. Council member Carol Pirsztuk noted that the city is "pushing for transparency," saying "everything they do is reactionary."

She said she wants to see Hyperion being "more proactive in their approach" and "to notify us (of an issue) before we notify them." She also wanted beach impacts to be reported promptly and for the word of beach impacts to get out to the public.

With Washington Street now added to Preferential Parking Zone 3 (which, at its first city council pass, only included Indiana and Illinois streets within designated cross streets just west of Pacific Coast Highway) after residents implored the city council to add their street to what had previously been moving forward by city council dictates, residents of Kansas Street asked for their street to be added to the new Preferential Parking Zone 3 during the Public Comment portion of the meeting. With more than 20 commenters in favor of adding Kansas Street, the council did so while also carving out a four-hour parking restriction for Kansas Park at the corner of Holly Avenue and Kansas Street. The new Preferential Parking Zone 3 is being implemented with the hope of curbing or eliminating parking by nearby business staff, airport passengers who park and use Uber to get to LAX, transients, and others who don't live in the residential neighborhood. Public Works Director Elias Sassoon told the council that at this point, the place is to provide two parking decals per unit (i.e., single-family home, apartment) with an optional third if the vehicle meets specific criteria. Each unit

## James Evans 1986-2024

James Flint Evans, age 37, has completed his battle with cancer and passed away in his childhood home surrounded by friends and family on March 4th.

He was born in Sacramento, CA in 1986 to Leslie and William Evans and moved to Westchester, then El Segundo where he attended 4th-12th grades. Those who grew up with him called him different names, from Jamie to James, to Tio Jaime, yet he was always the same caring, loving, generous, sarcastic, and thoughtful person.

In addition to being an astute student and his love of learning, James equally enjoyed the outdoors and athletics. James spent his childhood in the gymnasium perfecting his gymnastic skills, for over a decade he invested over 10 hours a week perfecting his craft at the Broadway and LA School of Gymnastics. In High School, James discovered his love of wrestling and after a knee injury, traded in one uniform for another, officially retiring from gymnastics. He went on to win the 2003 Southern CIF section wrestling title in the 113 lbs division. James was also committed to scouting and was an active participant in scouting from Tiger Scouts. He attended multiple summer camps, learning skills, and creating memories backpacking the rugged northern New Mexico wilderness at the Philmont Scout Ranch. James's journey through Scouting earned him the prestigious Eagle Scout Rank. James even contributed as a junior Scoutmaster, teaching and mentoring younger Scouts.



After graduating El Segundo High School in 2005 he moved to Las Vegas to pursue a degree in Gaming from UNLV. James loved the idea of gaming and the aspect of managing in a Vegas Casino. Unfortunately, James withdrew from college during the 2008 financial crash. He continued to live in Vegas and eventually met a fiery redhead who stole his heart, Autumn. They began dating and James rapidly became a father figure to her two children. James and Autumn were married in Laughlin in 2021 and nine months later welcomed a son together.

After his diagnosis of glioblastoma (brain cancer) in 2022, James and his family returned to El Segundo where he lived the rest of life, spending every moment doing things with friends and family. After a lifetime of ignoring both baseball and lacrosse, he rapidly became a fan watching both his children and nephew play. Even during his treatment, James rarely missed games. He was never happier than the last three years with his wife and children.

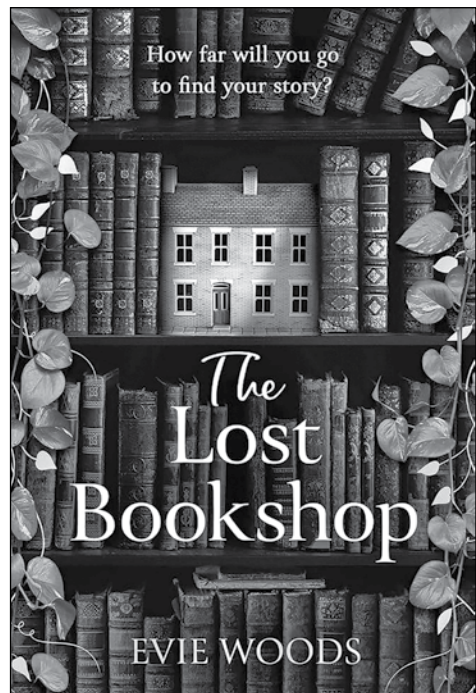
*The Lost Bookshop* by Evie Woods is a magical blend of mystery, romance, and history about three book lovers, Opaline, Martha and Henry, who find the strength to pilot their stories instead of remaining on the sidelines. Set in Europe, the story alternates between the 1920s to 1950s and

present day.

In the 1920s, Opaline flees England to avoid an arranged marriage and her oppressive brother. Armed with determination and a love of rare books, she discovers community and independence at a progressive bookshop in France. Her renaissance is cut short when she has to run again and settles in Dublin, this time in a curio-shop turned bookstore.

Back in the present day, Martha comes to Dublin to escape her abusive husband and finds work as a housekeeper for the quirky octogenarian Mrs. Bowden. Martha finds

### The School of Canine Massage: A Dogumentary On Wellness

For too long, man's best friend has been left out of the wellness conversation. The Ojai School of Canine Massage is hoping to change that. In director Emma D. Miller's short "dogumentary" *The School of Canine Massage*, which premiered at the SXSW Film Festival last week, dog owners learn firsthand how valuable and beneficial it is to indulge their pets in a little doggy TLC, for both their health and relationship.

Running 11 minutes long, *The School of Canine Massage* is a tightly bundled piece of filmmaking. Taking place in one location, Ojai Valley Women's Club, the film opens with a canine masseuse demonstrating various movements and massage techniques on a black pug who seems to turn into putty the longer the back rub goes on. Like their human counterparts, the masseuse points out that dogs also enjoy cupping, kneading, gentle back-slapping, and prodding. Not only does this attention stimulate muscles and relieve tension and tightness, but it also strengthens the bond between owner and pet.

## Eagles Have Productive Week

This is the time during the season when teams have settled in, and the routine of playing more leads to improvement from the beginning of the season. It has certainly done that for the El Segundo Eagles. During the past week, the baseball team swept their Pioneer League games, the softball team reached the semi-finals of the prestigious Torrance Tournament, and the golf team continued its wonderful start.

### Baseball Team Winning with Pitching and Defense

It's been said that good pitching and defense wins baseball games. The El Segundo Eagles have had their challenges offensively lately but the defense and pitching have been the team's strength. The result was a sweep of the Da Vinci Wolves 6-2 and 5-3 in a Pioneer League matchup. In the two games, El Segundo managed just 11 hits, but the defense and pitching were solid. The defense committed one error, and the pitching gave up four earned runs on ten hits and struck out ten.

The Eagles got the most out of their base runners and timely hitting in the first game. Louis Church drew a walk to lead off the game, and Kyle Whalen was aboard on an error. Lincoln Quaintance walked to load the bases with two outs. Ethan Aylar's two-run double made it 2-0. In the second inning, Mays Borgmeyer and Church singled. Whalen's grounder was misplayed, scoring Borgmeyer, and Church scored on a fielder's choice. Whalen would later score to make it 5-0.

Dylan Alcala started and looked in command, cruising through the first four innings. In the fifth inning, the senior gave up a single, followed by an infield error to put

two runners on. Both wound up scoring on a fielder's choice by David Ortiz and an RBI single by Victor Marcelletti to make it 5-2. The Eagles were gifted a seventh-inning run when Whalen drew a walk and later scored on a passed ball for the final 6-2 score.

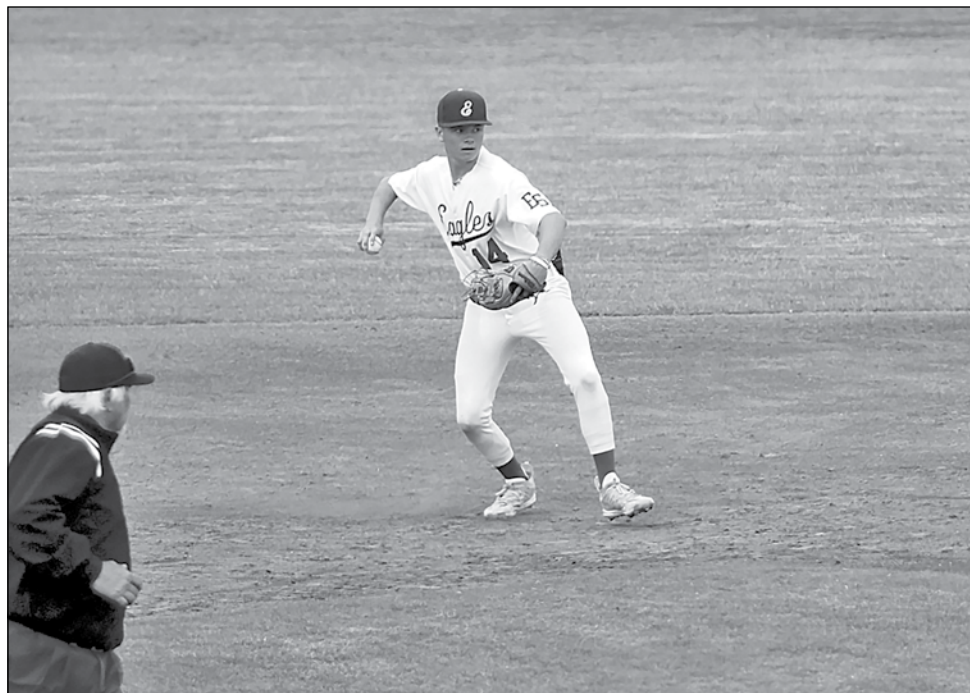
In the second game El Segundo continued its struggles at the plate but had plenty of opportunities. The Eagles left the bases loaded twice on one hit in the first two innings. Their short-lived rally consisted of one hit, four hit batters, and a walk but came up empty. In the third inning, trailing 3-0, Hudson Comer singled and scored on Chase Mattoon's fly ball.

In the fourth inning, the Eagles tied the game. Dlyan Alcala singled and scored on an RBI single by Mateo Heredia. Hudson Comer's one-out RBI double scored Louis Church, who had walked earlier in the inning. In the fifth inning, Austin Hohman singled and later scored to make it 4-3. In the sixth inning, Comer hit a bases-empty 375-foot homerun to centerfield to cap the scoring for the Eagles.

Jake Collins started for the Eagles, and the junior left-hander went 3.1 innings before giving way to hard-throwing Wil DeBlanc. Over the final three innings, DeBlanc limited the Wolves to one hit, walked one, and struck out four to earn the win. The Eagles improved to 4-0 in Pioneer League play with the win.

The Eagles traveled to face the Sierra Canyon Trailblazers in the El Camino Real Tournament and came up short in their 3-0 loss. The Trailblazers scored two runs in the first inning and another in the third inning and held on for a 3-0 win. The Eagles were limited to just four hits and never really got

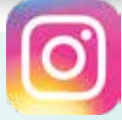

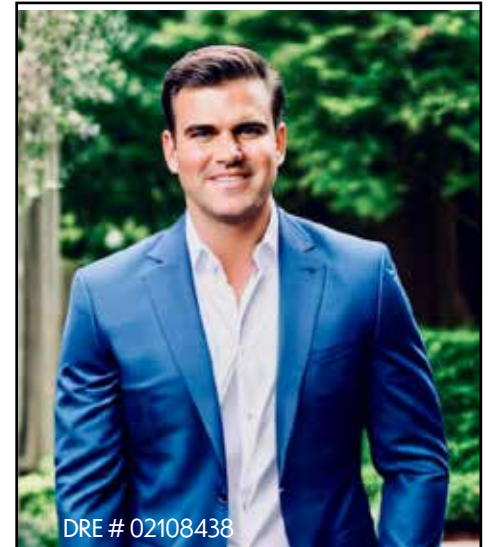

could also receive two guest parking decals for visitors (i.e., gardeners, occupational therapists, plumbers, etc.). Sassoon said it would be up to the residential neighbors to plan and share their guest parking decals when needing parking for a special occasion like a birthday party.

City Council also approved 5-0 a move to take Proposition A Local Return Funds and exchange them with the City of Commerce. El Segundo would forfeit \$740,992 in Proposition A funding by the end of the fiscal year since the money has to be used for specific purposes within a limited timeframe and has not been used. With time evaporating, the city is swapping the money for \$555,744 in general funds. Though the swap means the city is providing the City of Commerce with more money than El Segundo is receiving in the trade, relatively new Chief Financial Officer Paul Chung said typical trades of this sort go at a much lower percentage than the 25 percent El Segundo is receiving for every \$1. He said most swaps are in the 40 to 50 percent range. Chung also said the city should allocate the incoming funds to an equipment

fund that is underfunded. Council member Ryan Baldino called Chung's allocation idea a "good solution," while Mayor Drew Boyles said the city needs to "think creatively in the future" to avoid such a trade. May Pro Tem Chris Pimentel lamented the trade, saying he felt a "little lack of imagination" and that there must have been a way to use the funds.

Outdoor dining in downtown El Segundo was briefly looked at, with Community Development Director Michael Allen noting city staff was "not looking for specific recommendations" at this time. Council member Lance Giroux pointed out that he believed requiring business owners who want outdoor dining to receive 100 percent approval from neighboring businesses "problematic." He noted that if an outdoor dining space did not extend beyond its property frontage, business neighbors and property owners should be unable to nix an outdoor dining space. Pimentel suggested "a two-hour churn" for parking adjacent outdoor dining so as not to impact other businesses, retail and otherwise, who count on customers being able to park close to their business. •
