# Jose Calderon Keeps the City Running Smoothly

El Segundo is not your typical city; the quiet streets and friendly neighbors give it a small-town feeling everyone's come to love. But behind the scenes, the city is running cutting-edge technology and employing sophisticated, layered cyber protections, and one elite team oversees it all. That team is led by the Information Technology Director, Jose Calderon, who described himself as having "always been a little different for the IT world."

On a sunny Friday morning, I sat down with Jose outside of Blue Butterfly Coffee on Main Street, which is conveniently right across from City Hall, where Jose manages the information technology needs for the entire city of El Segundo. The first thing I noticed about Jose was his calming presence. As we discussed the highly complex nature of his work, Jose explained everything to me in very digestible ways.

Jose has been with the city for 18 months. Along with two other managers, his responsibilities include keeping the city's hardware and software up to date, protecting the city's sensitive information, and managing both the physical and virtual systems the city runs on every single day. The scope and stakes are massive, and Jose takes it quite seriously: "We want people to be able to do their jobs..."

Jose's mission to enable everyone to do their best work also extends to his team. Jose

tried to build a team that shares his outlook on approachability. He shared that he takes great care and intention to put people in positions where they could succeed. "My job is to run interference on behalf of my team so they can go do the technical stuff..."

Originally from Illinois, Jose received a bachelor of science degree from the Milwaukee School of Engineering and his MBA from Xavier Saint University. During his junior year of undergrad, Jose followed a passion for the music industry and interned for ABC Radio. He retold fond memories of handing out t-shirts at concerts in the Chicago area. After graduating, he worked as a System Administrator for the Chicago Bulls and Chicago Black Hawks. Jose seeks to combine the experience of these unique opportunities to shift the paradigm and change the way people see Information Technology (IT).

Moving to California was always something Jose had considered, and while working for the City of Evanston in Illinois, he began to look for opportunities in Los Angeles, where his brother already lived. Eventually, landing a position at Raytheon right here in El Segundo, Jose oversaw and staffed confidential and sensitive projects. Due to the size of a company like Raytheon, with thousands of employees working in El Segundo, Jose decided he wanted to explore opportunities with a smaller team in the civil sector. He describes it as "a call to service."



# **Infectious Generosity** is **Spreading Fast**

Think of the last viral video you saw. How many people did you send it to? How many people did you tell or talk to about it? Now, what if that video wasn't a video but an act of generosity? Would you share it as much? Infectious Generosity is a movement that hopes to do just that: make random acts of generosity go viral and Chris Anderson, the author of the book by the same title, thinks it can change the world. Chris describes the idea in the book as "anchored by two complementary themes: The Internet can turbocharge generosity, and generosity can transform the internet. Each theme feeds the other."

The internet is a powerful force; the term "viral" refers to ideas or content spreading rapidly across the web, like a virus. Unlike its namesake, Anderson hopes to harness this power to spread a positive message through acts of generosity. In conjunction with the book, Anderson and the team at Infectious Generosity have launched an AI assistant named TIGG.

As the Infectious Generosity website calls it, anyone can access this, an AI Guru. When I asked TIGG to tell me about its mission, the response was surprising. TIGG relayed

that its mission was to "sprinkle that extra bit of magic into everyone's day by nudging them towards more generous actions. Think of me as a cheerleader for the good stuff, a jovial-jump-starter for joy, if you will."

After trading around a dozen messages back and forth with the AI, answering honestly, if a little guardedly, it encouraged me to "channel your journalistic superpowers to create something that echoes through the hearts of your readers."

Similar generosity movements have made waves as recently as 2000 when a movie called Pay It Forward introduced a concept by the same name. Based on an original story by author Catherine Ryan Hyde, the novel has been translated into over 20 languages. The book describes a system in which the main character starts by doing a favor for a stranger without the expectation of reward, but there's a catch: that stranger must then do a favor for three additional strangers. While the story is fictional, the spirit of generosity at the time was quite real and inspired an International Pay It Forward Day celebrated in over 80 countries annually on April 28th.

Chris Anderson is an Oxford-educated entrepreneur who started his career in

# **ESUSD Board Meeting Report**

The following information covers the March 12, 2024 ESUSD board meeting and was taken from ESUSD website:

#### Congratulations to Our Spelling Bee Champs!

In January, Center Street and Richmond Street 4th and 5th grade classes hosted class spelling bees to determine who would compete in each school's spelling bee. Each school then hosted its own bee at the end of January, following the Scripps National Spelling Bee rules and regulations. Center Street 5th grader Ryma Ghosh and Richmond Street 4th grader Emmerson Hwang won their respective school competitions, and went on to compete against each other at a regional competition on February 28. Ghosh emerged as the ESUSD Spelling Bee Champion, who will go on to the Los Angeles County Regional Spelling Bee on March 20. The board recognized both Ryma and Emmerson for their achievements.

#### **CBO Presents 2nd Interim Financial Statement**

ESUSD Chief Business Official Kimberly Linz presented the 2023-24 Second Interim Budget Report. Highlights of the report included:

The district is putting forth a Positive Certification, meaning it will meet its obligations in the current year and the next two years.

The Cost-of-Living Adjustment (COLA) from the state is currently expected to be 2.73%. At the time of the adopted budget in June 2023, a 3.95% COLA was expected. However, the legislative analyst office predicts a 0.00% funded COLA for 2024-25.

The district was able to provide a 7.5% raise for all staff members for 2023-24.

Over the next few years, due to the decreasing COLA and current economic conditions, the district expects to be operating in a deficit. Financial staff will closely watch and balance the budget as much as possible, and the deficit will require monitoring.

The recently approved retirement incentive resulted in 16 employee retirements. The district is realizing significant savings from those retirements, as half the positions will be eliminated and the other half will be filled by new staff members who will likely be lower on the pay scale.

In addition, the district will be eliminating positions funded by one-time funds and re-examining site and department budgets for 2024-25.

The Board of Education voted to accept the Second Interim Budget Report. It was then submitted to the Los Angeles County Office of Education. Next, district staff will attend the Governor's 2024-25 May Revision Workshop. By June 30, the Local Control Accountability Plan and budget for 2024-25 need to be adopted.

#### **Additional Board Actions**

The board approved The Education Support Services Consulting Group to conduct a search for the next ESUSD superintendent. The consultants will work with the district and the community in the process of hiring the next ESUSD Superintendent.

The board voted to enter into an agreement with Kirksey & Co. Inc. to provide furniture for the music classroom, CBI classroom, and concession offices for the El Segundo High School Band and Community Based Instruction Building Project. The El Segundo High School Band Director was involved in identifying the essential furnishing needs for the new classroom space.

After analyzing the district's staffing needs for 2024-25, it was determined that eight FTE positions were no longer needed. The board approved Resolution #11-2023/24, Reduction or Discontinuance of Particular Kinds of Services and Establishment of Tiebreaking Criteria. As a result of certificated retirements effective June 7, 2024, the positions in question will be unfilled; therefore, it will not be necessary to issue layoff notices to any employees as a result of the passage of this resolution.

The board voted to accept the proposal from NIC Partners, Inc. for purchase and installation of cameras for the El Segundo High School New Band & Community Based Instruction Building Project. The total project will cost \$95,045. The board approved Contract Change Order Three with Keystone Builders Inc. for the Richmond Street Classroom Building Project.

The board approved Work Authorization #13 for positions required for upcoming construction projects. The proposed support staff is one full-time, onsite project manager and one full-time project engineer for 17 months, through August 2025. The district will only be invoiced when the positions are staffed and for the days worked. •

# El Segundo Girls U14 All Stars Win Western States Championship

The El Segundo's AYSO Region 92 girls U14 All Star team made an epic run that culminated in a Western States Championship. Much like the El Segundo Little Leaguers run to a World Series title that was three years in the making, this all-star team's path to immortality actually began during the 2019/20 season. They were edged out in the U10 Area final by Manhattan Beach. The following year this team was once again runners up in the U12 division following a tough loss to North Redondo. In 2023, their first in U14, El Segundo reached the Area final for the third consecutive time but fell to Manhattan Beach.

This season, and the final year of All-Star eligibility for most of the team, proved to be their time to shine. El Segundo finished Area play in first place with shutout victories over Westchester, North Redondo, South Redondo, and two Manhattan Beach teams. The win propelled El Segundo into the Section Tournament in Redlands.

El Segundo faced a physical South L.A. in the opening round of the Section Tournament. In this physically active contest, El Segundo received goals from Reilly Stebbins and Nora Gormley in another shutout 2-0 victory. The win came with a price when Riley Stewart, daughter of Head Coach Jordan Stewart, suffered a double leg fracture. Assistant Coaches Brendan Gormley and Lance Bustrom took over for Coach Stewart while he was with his daughter. El Segundo rounded out day one with two more shutout victories over Diamond Bar and La Verne.

Day two started with an 8-0 win over South Ontario. El Segundo scored goals from Stebbins and Gormley, along with Olivia Torres, Maddie Leitch, Hannah Bustrom, and Saya Elliott. The win set up a final against Alhambra with a trip to the Western States tournament on the line.

In the final, the scoreless game was broken up when Saya Elliott converted a penalty kick for El Segundo for a 1-0 lead. Alhambra quickly responded with the equalizer. It was the first goal scored on El Segundo in All-Star play. That goal, combined with the emotional drain of the weekend, seemed to take the wind out of El Segundo's sails. Alhambra went on to score a second goal and

# **ES Youth Cheer Ends Season** with Three National Titles

El Segundo Youth Cheer wraps up the 23-24 season with three National Titles! The program consists of five different teams comprised of athletes ages 5-14. In the fall, the cheerleaders cheer for El Segundo Youth Football. In November, the cheerleaders start their competitive season.

This year, three teams, the Gremlins (ages 6-7), the Junior Pee-Wees (ages 8-10), and the Pee-Wees (ages 11-12), won the league championships. The Jr. Midgets (ages 13-14) took second place in the league, missing first by two one-hundredths of a point!

After winning the league championships, the Gremlins and Junior Pee-Wee Teams headed to Las Vegas for The JAMZ National Championships in January. The JAMZ Nationals includes teams from across the Western United States. Both teams competed in two divisions: sideline and show cheer. ## Pajama Game for Dementia Patients

Families often ask me why their loved ones will not change their clothes. More specifically, families complain about how their loved one no longer dresses—or undresses, so to speak—for bedtime. At first glance, this is a mystery, especially when, for decades, likely looked forward to bedtime and unwinding after a long day.

There are many potential causes to "unlock" here. Before starting, let's remind ourselves of one crucial fact: you will never win an argument with your loved one with dementia. You will not succeed at reasoning with them or convincing them to do as you expect. The reality of a person with dementia is different from what those of us who reason might expect. We must remain creative when developing strategies to improve their quality of life.

The reasons behind the behavior may differ widely between people with dementia. Some lose track of time and don't readily accept that it's time to prepare for bed. Others may forget they haven't changed clothes for a day or days or believe they have changed recently. Others forget that the clothes they just removed are dirty and put them back on.

Other factors may also play into the mix. For example, some people with dementia are no longer capable of making good choices, even when the choice seems obvious. Others may find comfort or security with one or a few items of clothing and resist changing out of them. Still others cling dearly to what independence remains when they cannot make most decisions for themselves, stubbornly refusing to change


when asked.

Before we discuss approaches, we should also consider our loved one's physical and mental state. Body aches, fatigue, or feeling chilled may prevent someone from wanting to change clothing. We also must monitor for patterns or clues from behaviors or even what they say. Many people with dementia develop a like or dislike for specific clothing, possibly even the color or patterns. And if clothing doesn't fit well or is too tight, that may also contribute.

So, how do we get creative to help our loved ones into fresh clothing, especially at bedtime? One approach is to turn dressing for bed into an activity – a pajama game of sorts. Lay pajamas or favorite bedclothes out on the bed and take a presumptive approach. Have hot chocolate or herbal tea ready for your loved one to enjoy, and play music to make winding down more comfortable.

If the game fails, you may need different approaches, like waiting for them to fall asleep, removing dirty clothing from their room, and replacing them with fresh clothing. Whether dressing for the day or bed, keep it simple. Clear the closet to just a few choices. Fewer choices make easier decisions. It is always good to provide clothing in their favorite colors and to remove clothing that isn't appropriate for the season

Lastly, dump feeling embarrassed that your parent or other loved one who was once a conservative dresser is now comfortable wearing joggers and a cartoon-themed sweatshirt. Remember that we want our loved ones to be clean, comfortable, and happy. •





# Film Review

### Immaculate: This Feral Horror Film is Sinfully Sadistic

Sydney Sweeney gives a wickedly righteous performance as a scorned nun turned rogue vigilante in the psychological horror film, Immaculate. Directed by Michael Mohan, who last collaborated with Sweeney in 2021's The Voyeurs, Immaculate may fall short when it comes to convincing plot points but still, it is without a doubt an unforgettable, blood-soaked visceral experience. Immaculate is now playing in theaters.

Sweeney (Euphoria, The White Lotus) plays Cecilia, a young nun who suffers a near-death experience and subsequently decides to uproot her life in America for a fresh start in Italy. With a renewed sense of optimism and faith that she will find her purpose here, she arrives at a beautiful convent, set in the remote Italian countryside. This spiritual sanctuary, with its baroque architecture and longstanding religious legacy, is where she is prepared to call home for the foreseeable future.

The language barrier aside, Cecilia receives a mostly warm welcome from the other religious residents, including Mother Superior (Dora Romano), Father Sal Tedeschi (Álvaro Morte), and the rebellious Sister Mary (Simona Tabasco). Nuns of all ages who have devoted their lives to serving the church live on the property, and Cecilia finds the sisterhood

comforting. However, the angelic facade deteriorates as she begins witnessing bizarre behavior and grotesque atrocities at the hands of the women she called sisters. Once Cecilia finds herself at the center of an unexplainable circumstance-falling pregnant despite being celibate-all hell breaks loose.

Proving that she can confidently master the spectrum of emotional and physical exertion, Sydney Sweeney gives a mesmerizing performance as Sister Cecilia. Both in front of and behind the camera, Sweeney-who also serves as the film's producer–gives it her all in a way we haven't seen before. Immaculate isn't without its flaws, however, especially in the script. For as strong as the first half of the film is, the plot seems to derail into goofy territory that leans more towards comedy than full-bodied horror. Suspension of disbelief isn't so much suggested as it is required here, and even then some moments come across as a parody of a campy horror flick. Sweeney and company nail the performances, every supporting role is successfully unwavering in its impact, yet Immaculate unfortunately pales in comparison to similar genre films with a more solid plot.

Those looking for a fun and freaky night out will find much to enjoy in *Immaculate*, despite its less-than-serious storyline. Sydney Sweeney proves that she has the range-and the vocal strength-to carry a horror film and watching her slowly spiral throughout the film's 89 minute runtime is sinfully sadistic. Immaculate made its World Premiere at the 2024 SXSW Film Festival and was nominated for the Audience Award in the Headliners category. •





In her debut novel, The Berry Pickers, Amanda Peters tells the story of a Native American family that is torn apart through a tragic event. It is July, 1962 and a Mi'Kmaq family from Nova Scotia comes to Maine to pick blueberries for the summer season. A mere few weeks into their arrival, their youngest daughter Ruthie disappears. The last person to see Ruthie, was her brother, Joe. Ruthie was last seen sitting on her favorite rock near the berry field. Joe feels an immense amount of guilt and responsibility for Ruthie's disappearance. We later learn of Norma, a young girl living in Maine, who comes from an affluent family. Norma is an

only child and often feels suffocated by her overprotective mother. Norma regularly has vivid dreams, to her these dreams feel like memories, and she can't seem to get any clarity about these dreams from her mother or her emotionally distant father. Told from Norma and Joe's perspectives in alternating chapters that are clearly labeled, this story is very easy to follow and hard to put down. There are many characters, and the author does a wonderful job of developing all of them and showing their importance to Joe and Norma. I should also note that there are no shocking surprises in this story, it is evident what has happened from the beginning, but that does not stop it from being a page-turner. 



publishing and journalism. When he moved to the US in 1994, Anderson founded Imagine Media. At its height, Imagine Media was responsible for over 150 magazines and websites. Anderson began to search for ways to continue his work as a champion of change and self-betterment.

Anderson found that opportunity when he became the current curator of TED Talks, the international public speaking organization. Anderson took over TED in the early 2000s with the blessing of its founder, Richard Saul Wurman. Wurman, along with Harry Marks and Frank Stanton, started the conference in 1984, and in its early years, the presentations primarily focused on science and technology topics. Anderson challenges people to "go and work on that thing that keeps you up at night until it gets done. Until it's good enough - Don't stop until it's good enough to share. And then share what you've learned."

Under Anderson's tenure, the organization broadened to include a wide array of positive and helpful content. Anderson hired media

innovator June Cohen to build what would become TED.com, an online platform where anyone can access hours of TED Talks content completely free. As stated on its website, Ted Talks' mission is to be "dedicated to discovering and spreading ideas that spark conversation, deepen understanding, and drive meaningful change."

Anderson recently partnered with a team of three psychologists to test his theory on generosity, and the findings were published in the Psychological Science journal. The experiment was conducted with over 200 participants in seven different countries, each given \$10,000 and the only catch was they had to report how they used the money. The results were that the average participant spent over half the money given for the benefit of other people. The experiment built in a control to see if the altruistic spending was only due to social pressure, but the experiment found individuals publicizing their expenditure on then Twitter and little various to those who could keep their purchases private. Anderson believes "generosity is in our genes."

Jose's commitment to the work and the city is inspiring. He described picking up a phrase during his career that had become a core principle of his approach to his work: "IT is the enabler of business."

It is a simple and incredibly collaborative approach. "There are things behind the scenes that people are unaware of, they don't need to be aware of..." Jose shared. "It's very much preventative, it's being proactive..."

This is all a part of Jose's unique approach to IT; rather than just responding to your ticket, he's willing to help you in person if possible. "Knowing when to engage, knowing when to back off... That's really the tough part."

IT is present in every city building, including the library, El Segundo High School, and even Rec Park. And for those who think he's there to fix your printer, think again. Jose was smooth, as he assured me, "That's the easy stuff."


Jose was proud to discuss spearheading a program with the Department of Homeland Security (DHS) to evaluate the El Segundo

As we were wrapping up, Jose received a call that AT&T was on the way. Keeping the city safe is a full-time job that Jose described as a "juggle." After spending the morning with Jose and getting to know more about him and his amazing work for the city, I can confidently say we're in very capable hands.•



and won the National Title in the show cheer division, too! The Junior Pee-Wee team has been extremely consistent all season. Winning two National titles is amazing!




