Dr. Homan Diba Works Magic

El Segundo chiropractor Dr. Homan Diba did not see his career path pointing in the direction of...well, becoming a chiropractor.

In fact, Diba, moved to the states with his family from Iran when he was five, landing in the San Fernando Valley, and was *thisclose*, to nabbing a degree at California University Northridge, that would have launched him into the field of law, with an emphasis on business. But he had become bored with the business law classes and curriculum and decided to pursue his passion.

Here are a few previously published quotes from Diba about his career choice: "I noticed that I was not happy and did not feel like I was on the right path. The courses were boring and did not pique my interest like I expected," he said. "I was going through a crisis and needed to pursue my passion, which was health and wellness. For as long as I can remember, I've been the go-to person in my family to loosen up tight, aching muscles through my muscle work and self-taught soft tissue techniques. There had to be a profession that suited my strengths and dealing with the human body."

As Diba was teetering on the finish line of receiving his business degree, he decided to delve into the medical field of Chiropractic. In 2004, he decided to roll the career dice. He enrolled in the Chiropractic Program at Cleveland Chiropractic College, where he graduated in 2008 with a bachelor's in Human Biology and a doctorate in Chiropractic. "I found my calling, which was Chiropractic," he said while noting that he took an accelerated program of study that allowed him to get his degree quickly.

After graduating, Diba joined a multispecialty clinic in Redondo Beach where "I was immediately recognized for my hands-on soft tissue techniques and adjusting skills," he said. Diba said that when working with his clients, he always looks to find "the cause of the problem, and not just [making] an adjustment."

In 2022, Diba, decided to start his practice in El Segundo, having built his client base in Redondo Beach. Like many folks, Diba said he was barely aware of the possibilities of building a business in El Segundo, zooming down PCH to his office in Redondo Beach.



Announcement from the El Segundo Police

The El Segundo Police Department is currently investigating a string of commercial burglaries that occurred during the early morning hours of Saturday, March 25 at approximately 3 AM. Eagles Return to Action

With the wettest season in decades on record, it has canceled or delayed baseball and softball games, events, and matches. The spring sports, which started during the final weeks of winter, have left fields or venues too soggy to play on. The delays have made rescheduling games a challenge. But with better weather, the teams have returned to competing.

Baseball Team Back to Winning Ways

The Eagles had lost consecutive games for the first time this season before defeating Da Vinci in a Pioneer League double-header. Since then, they defeated Bishop Montgomery 4-1 and City Section powerhouse El Camino Real Royals 5-4 to run their season record to 8-3.

Dylan Garcia got the start against Bishop Montgomery and made it look easy. He limited the Knights to one run on just one hit while striking out eight in his complete-game victory. El Segundo's offense was limited, but they made the most of what they had. would score on an RBI single by Heredia. Luis Church, who had walked, scored on a double steal. Dylan Immel, who was 3-for-4, had an RBI single to give the Eagles a 5-2 lead. In the bottom half of the seventh inning, the Royals' offense consisted of three walks and an El Segundo error to score two runs before relief pitcher Mateo Heredia got Jonathon Bogacz to hit into a game-ending ground ball out.

Weather permitting, the Eagles return home on Friday at 6 p.m. to host the Torrance Tartars in a key Pioneer League matchup.

Softball Team Having a Rough Go

After opening the season with a 5-0 record, the Eagles have lost seven of their last nine games. El Segundo dominated Da Vince 14-0 and then fell to the Torrance Tartars 4-0 in key Pioneer League games. In tournament action, they took a 5-1 loss to Granada Hills Charter and rebounded with a 5-3 win over La Canada.

In the lopsided win over Da Vinci, Allie Stevenson collected four hits, including two

The Eagles came up with a four-run second inning highlighted by RBI walks to Dylan Alcala and Tucker Stevens and fielder's choice ground balls by Luis Church and Wil DeBlanc.


The Eagles came up with a 5-4 win over El Camino Real, but it wasn't easy. El Segundo took an early 1-0 lead in the first when Mateo Heredia singled and later scored on fielder's choice. With the score tied 1-1 in the fourth, Anthony Temesvary RBI single gave the Eagles a 2-1 lead. The Royals tied the game in the sixth inning, setting up an exciting seventh inning.

Cooper Gamble opened with a single with Tucker Stevens pinch running. Dylan Alcala sacrificed Stevens to second base, and he triples and two RBIs, while Sienna Mayer was 3-for-4 with three RBIs. Maiya Anderson, Haley Wantz, and Jacy Lindsey combined in the circle on the one-hit shutout.

The Torrance Tartars scored two first-inning runs and two more in the third inning and then held on for a 4-0 win over El Segundo. The Eagles weren't intimidated by the Tartars, who are ranked tenth in the CIF SS Division 1 poll. They hit the ball hard, but Torrance's defense came up with a flawless defense.

In the Village Christian Tournament, the top-ranked City Section Granada Hills Charter Highlanders scored three runs in the fourth inning and went on to defeat the Eagles 5-1. El Segundo's lone run came in the third



In Rodeo, A Young Motorbiker Revs Into a Life of Crime

From writer-director Lola Quivoron comes Rodeo, the story of a tough young woman whose passion for riding motorbikes leads her into a world of criminality and danger. Bringing an authentically-captured French motorbiking subculture to the big screen, Rodeo is both a gritty character study and crime movie that plays like Emily the

Criminal, The Place Beyond the Pines, and Fast & Furious.

If life is a rodeo, then Julia (Julie Ledru) is a wild bronco, unable to be tamed. The movie opens with her shooting out of her home as if a starting gun has just been fired. She's intent on doing just one thing: testing out a new motorbike. After inspecting it from an unsuspecting male seller, she asks for a test drive. Which, she subsequently races off with, her middle finger blazing behind.

This says exactly what we need to know about her. That she's unstoppable, and only lives life in one direction: forward, and fast. With her oversized shirts and unkept hair, Julia's clearly not interested in the typical girly world. We soon enough see where she feels most at home: on a motorbike speeding down an open road.

Julia takes her new possession to the local dragstrip, where young bikers fly past her, popping wheelies and tricks that amaze and wrack the nerves. Noticeably, she's the only woman in this mostly male world. However,

the insults that the aggressive crowd of bros hurls her way bounce off of her like a steel engine. When the cops come to bust it up, she scatters away with a new group, taken in by one boy Kaïs (Yannis Lafki). With-

out a place to sleep, she asks Kaïs and his

crew if she can sleep in their garage (like a

She soon learns that the crew steals and flips bikes. And it's under the direction of the ringleader, Domino (Sébastien Schroeder). Fearless and looking for refuge and the opportunity to ride, Julia offers to lend her services of stealing bikes. And so, she does what she does best: tries out bikes, then speeds off leaving unsuspecting men in the dust. The closer she gets to the crew and begins to establish trust, the more she feels like family. It all leads up to a heist, the climax of the movie, that has deadly results.

Rodeo throttles in and out of exhilarating moments, as well as narrative consistency. Particularly the riding sequences, when bikers rev engines that roar and pop wheelies, feel exhilarating. The film also downshifts, into a slower more emotional story. We see that Julia gets closer to her new makeshift criminal family, making for strong emotional moments.

Writer-director Lola Quivoron creates a world that feels real, raw, beautiful, and dangerous. Julia's world is most compelling when it juxtaposes the dualities mirroring "throttling" and "braking" of riding itself: balancing the fast with the slow; the loud with the quiet; the male with the female; and the peace and danger.

Her relationship with Kaïs has a hint of romance, but it's the bond that Julia develops





with Domino's wife, Ophélie (Antonia Buresi), and her young son, that is the more compelling, heartfelt relationship. We see how Ophélie is similarly trapped in a world of oppressive males, which Julia notices and bonds over (in a familial, but also suggestively intimate way).

There's also the storyline of Julia being haunted by a tragic death that takes place earlier on in the film, as well. Nightmares begin to plague her (though to the film's detriment, not much adds beyond that). With no exposition, Julia's backstory is a mystery (she literally asks to be called "Unknown" in her heists). It's as if she herself is a bike without any identifying plates, made of different parts she replaces along her hard-lived journey of life.

As Julia, Julie Ledru is perfect for the role. She's tough and unafraid to get physical

when needed. But she also plays the slower, quieter, emotionally affected moments that the film demands of her as well. It's here where her face betrays how haunted she is. She can more than hold her own in a world where everyone's edging her out, but it will soon take its toll.

Raphaël Vandenbussche's cinematography is beautiful and evocative. Gritty handheld cinematography, composed in ultra-wide format captures the wide frames that the motorbike sequences and film need.

While *Rodeo* falls into a familiar crime story that didn't leave me particularly thrilled or roused, the riding sequences themselves are quite exciting. Blazing fast shots take on an ethereal, transcendent feeling. At its fiery end, we understand that for some, riding fast is the only speed that people can live.




