

Eagles Dominate Inside while Struggling Outside

The El Segundo high school's boys' volleyball team has all but dominated their Pioneer League opponents, while the boy's golf team is showing signs of success. The baseball and softball teams have hit a snag and are struggling to go into Spring Break.

Volleyball Team in Control of Pioneer League

The Eagles are one of the top four teams ranked in the CIF Southern Section Division 3, and for good reason. With their sweep of league foe Da Vinci, they improved to 8-0 in the Pioneer League and 14-2 overall. Their two losses were to Mira Costa, ranked fifth nationally, and Huntington Beach, widely considered the top-ranked team in the nation.

Facing Da Vinci, the top-ranked Division 5 team, proved to be no problem for the Eagles. In their first meeting, El Segundo dropped the first game 25-23 when Da Vinci went on a run to close it out. The Eagles proceeded to take down the Wolves 25-10, 25-23 and 25-10 in the next three games to win the match.

In the team's final match before Spring Break, the Eagles swept Da Vinci 25-19, 25-19, and 25-18. It was a spirited match between two teams with power hitters and enough defense to extend rallies.

El Segundo got a 15-10 lead in the opening game before the Eagles went on a run. Nolan Kelley and Dylan Pilkvist nailed points, and Daniel Escobar's consecutive ace serves gave their team a 19-13 comfortable lead. Ryan Pilkvist's thunderous hit set up the Eagle's first game win.

The Eagles and Wolves played a tight game to start in the second game, but Da Vinci never took the lead. The Eagles went on a run outscoring the Wolves, and took a 16-12 lead. A block by Nolan Kelley and consecutive aces by Jackson Breneman gave El Segundo a 22-17 advantage. The game ended when Kelly made a block of Da Vinci's Cody Evans' hit.

The third game was another close one when Ryan Pilkvist's kill and Nolan Kelly's ace gave the Eagles a 6-2 lead. The Wolves made it close and came within 18-15 before Dylan Pilkvist's kill, and an extended rally ending with an unforced error gave the Eagles a 20-15 lead. Gio Biondo's hit set up the game-winner, and the Eagles swept Da Vinci.

The Eagles return to action Wednesday at home when they host West Torrance at 3:30 p.m.

Golf Team Showing their Potential

The El Segundo HS Boys Golf Team is off and moving this spring with a group of determined young athletes wanting to put their stamp on golf at El Segundo. With the winter weather causing some havoc on sports, golf has been forced to postpone matches and move practice rounds. This hasn't stopped the team, as they have now entered league play and are pushing for a spot in the CIF playoffs.

The Eagles started the season with a challenging non-league schedule against some very tough local schools. This included matches against St. Monica at Chester Washington GC, the Torrance Tartars at Los Verdes GC, St. Francis at Brookside GC, and Culver City at Westchester GC. The young Eagles battled and won two of their four non-league matches



A Lovely Girl: The Tragedy of Olga Duncan and the Trial of One of California's Most Notorious Killers by Deborah Holt Larkin

True crime is a popular genre for readers and Deborah Holt Larkin's book A Lovely Girl: The Tragedy of Olga Duncan and the Trial of One of California's Most Notorious Killers, is a unique addition to that category.

Ms. Larkin's father Robert Holt was a reporter and columnist for the Ventura County Star-Free Press. While he was covering the Olga Duncan case, "Debby" (the author) became extremely interested in it. At first she was terrified that she herself could go missing (or worse) or that her family could suffer from random violence noted in the local newspapers.

The format of the book alternates from her 10-year-old child's eye viewpoint and the actual facts of an investigation into a missing nurse in Santa Barbara. Olga Duncan was a well-liked woman who worked as a surgical nurse at Santa Barbara's Cottage Hospital. She was last seen by friends on a Monday night in November of 1958. She was married to a local attorney, Frank Duncan. She was also almost eight months pregnant.

Debby saw the headline "Missing Nurse Sought By Police, Friends" in the Santa Barbara News Press and quickly discovered that she could not stop thinking about it. Despite admonitions by her father to stop worrying about it, Debby soon began to obsessively follow the case.

As the author leads the reader through the police probe into Olga's disappearance, it becomes obvious that there were some farfetched circumstances that turned up. It is learned that Olga and her husband were not living together ... her husband Frank seems to routinely dismiss the odd reason for their estrangement: his mother's possessive feelings toward her son. Frank frequently mentions that his mother (Elizabeth Ann Duncan) was "terrified of being alone, and she's afraid of losing (him.)" There are tales from Olga's friends that her mother-in-law was harassing her. Then, accusations of extortion, intimidation, fraud, kidnapping ... and that's just the beginning!

Soon, evidence of violence is exposed when Olga's tragic remains are discovered. Perpetrators are sought, arrested and a trial follows when the killers finally confess. But who was behind it all? And so, a story stranger than fiction unfolds.

This tale does not follow the usual "true crime memoir" formula (if there is one), but juxtaposes Ms. Larkin's memories of her family, friends and neighborhood almost seamlessly with the very readable account of the "remarkable Duncan case." Her recollections as her younger self Debby seem in-the-moment, rather than nearly 65 years in the past. Life in the 1950s was mixed with visions of promise and hope, even though the Cold War and fear of Communism loomed. American society was becoming somewhat affluent with the steady growth of the suburbs that were populated with a larger middle class. The family unit was still important – parents wanted their children to have better lives than they had had during the World War II era. The goings-on in the Holt family's household, at times quite comical and at others, a bit poignant, reflects that time of "modern" life. Bob Holt is quite a character and it is easy to see why he made such a huge impression on Debby and her younger sister Betsy as they were growing up. There's a particular anecdote featuring their father that was completely side-splitting. I don't want to spoil it, so just know that it involved a Christmas episode of *Dragnet* on TV, an exhausted Bob Holt passed out on the couch and a surprise visit from local minister Reverend Ralston. Hilarity did ensue.


Film Review

Ryuichi Sakamoto: Coda is a Sensational Portrait of a Legendary Musical Poet

One of the hardest adjustments I had to make during the 2020 lockdown was not being able to visit my favorite bar. No, not for the drinks, but for the hi-fi audio equipment and their vast collection of classic and rare records from all over the world. This Japanese-style "listening bar" is where I first discovered Ryuichi Sakamoto, and for that, I am ever grateful.

Thankfully, MUBI cured my quarantineinduced hi-fi blues with the 2017 release of

Ryuichi Sakamoto: Coda, a documentary about the daily life and creative process of one of the industry's most innovative and revelatory artists. Sadly, the legendary composer passed away on March 28, 2023 at 71 years old.

Ryuichi Sakamoto is a man who dedicated his entire life to creating art. The documentary wonderfully sweeps through his musical career- highlighting his days as a member of the techno-pop band Yellow Magic Orchestra to his work on Alejandro Iñárritu's The Revenant. His accomplishments are many, and

those familiar with his work consider him to be one of the great artists of our time. Despite the accolades, awards, and notoriety, his humbleness remains untouched.

It's fascinating to watch how passionately Sakamoto respects sound and the concept of its use. How it's created, how it's used, and, semi-morbidly, how it will reflect on him when he's gone. Sakamoto lived with throat cancer, but he didn't let that get in the way of consistently creating. Using field recordings of running water, forest air, and other natural sounds, he creates a purity that amazingly complements the delicateness of his piano keys. The result is a sound unlike any other, hauntingly beautiful and dynamically all-encompassing.

Thanks to MUBI, this special edition release, directed by Stephen Nomura Schible, also includes the full concert documentary Ryuichi Sakamoto: async At The Park Avenue Armory. And although my Sonos is no match compared to my favorite "listening bar," Sakamoto's music transcends standard commercial speakers, making me feel like I'm back in my favorite place once again.

football Championship in 1962. After graduation he attended Long Beach State where he played wide receiver while earning his degree. After graduating from Long Beach State he played for the San Diego Chargers, chasing down passes for nearly three years before an injury cut short his NFL career. That's when Newell decided to chase his other passion--teaching.

Bob Kingston, the vice-principal who recommended Newell for hiring in 1969, said he had recommended him because of two very important traits he saw. "When Steve taught his math classes he took it very seriously and when he was coaching he was very dedicated," Kingston said.

Kingston remembers how well disciplined Newell's students were and how well respected he was in front of the class. Kingston believes that is why he was so successful in the classroom and on the football field as a coach. Kingston said, "Steve spent equal time with his students and the athletes and was just as interested in both and played no favoritism."

Kingston thought that Newell was a "great guy, good coach and someone [he] admired." Kingston went on to say that Newell and his wife, Barbara were great parents and that you could see why their children, Brett and Julie turned out so well.

Another of Newell's co-workers, Larry Cummings, who gets a broad smile when he talks about Newell, said that he will miss his long-time neighbor from across the street. "Steve was a just a great neighbor and even when he was having real hard time with his back he had real concerns for my family. (Pause) He just put others before himself."

Cummings said that Newell was as conscientious a person as you'll ever find and a very dedicated teacher in the classroom. "He was really prepared whether it was in the class room or on the football field," he said.

Craig Cousins, who coached with Newell for a number of years said, "Steve was a real communicator and the players all respected him." He added, "He was fair with his assistants and he let us coach."

Cousins remembers coaching with Newell on the frosh/soph and varsity football teams and described him as someone he enjoyed being around. Cousins said that they worked well together on the gridiron because of their chemistry with the players and the way they complimented each other's coaching philosophies and that may have had a part in Newell's success as a coach.

Steve Newell after guiding the Eagles to their best season in the school's history. That was the year the Eagles lost to Burroughs of Burbank on a rain-soaked field in the CIF semi-finals.

Steve Shevlin, the current Athletic Director and head football coach at the high school, said he owes a lot to Newell. "Steve recruited me to come to El Segundo because he thought I might be a good candidate to take over the football program one day."

Shevlin said that Newell was so meticulous and organized about his football practices that he adopted that way to run his practices. Shevlin went on to say that Newell saw to that the transition was smooth and that's because of his leadership qualities. He also said that he will miss the camaraderie and the mentoring that Newell provided not only him but to other teachers as well.

Perhaps John Stevenson summed up Steve Newell the best when he said "Steve was a go-to guy at the high school and someone you could count on," Stevenson remembers that Newell was quick to step up in the early 1990s when he had a heart condition and couldn't make the annual summer baseball trip to Montana. He asked Steve if he would help accompany the team on the trip and help coach the team and Newell quickly said yes. Even though Newell's background was football and not baseball, he knew how to coach and the players had a great respect for him and he made the trips very smooth.

What many of Newell's friends fondly remember about him was his way of finding the perfect meal. For example in Miles City, Montana, Newell was a fixture in one of the local steakhouses on Main Street because they had the biggest and best steaks he'd ever had. Cousins added, "He loved a hot, piping breakfast on the road."

Steve and Barbara Newell called El Segundo home for over 30 years and made some lifelong friends here. And though they're moving away to a new home, a thousand miles away, they will always be close to our hearts.



nial powerhouse South Torrance. Sammie


