Cherished Memories from the 2023 World Series Champions

It's been seven months since the El Segundo Little League All-Stars became household names and electrified a nation by winning the Little League World Series. Twelve players and a coaching staff of three were together for three months, which culminated in their historic run. The team has been on-field guests at Dodgers, Angels, and USC Trojans football games. They were greeted with a welcome back parade, highlighted in the El Segundo Christmas Parade, featured on magazine covers, and rode on a float in the 2024 Rose Parade. Memories of the Summer of '23 will be etched in each of their minds for stories to be told to their grandchildren.

There were indelible moments of the Little League World Series that will be remembered by all of us. The players and coaches who lived in the moment will remember the precious moments that made their experience a once-in-a-lifetime event even more special. So, besides the obvious, what these players and coaches remember seven months later is what they'll talk about for decades.

Manager Danny Boehle was a natural to manage this team. A knowledgeable baseball mentor and gifted speaker, he took charge of the team he called family. One of his fondest memories was watching the players interact with all of the other teams from different countries despite a language barrier. Somehow, kids have their own way of communicating and having fun in the moment. Coach Boehle says Japan and Panama were especially favorites when they were trading practice gear, jerseys, hats, and pins. "The smiles on the kid's faces were priceless."

Third base coach Tim Abrams, a former colligate baseball player, said he was in awe of many things during the Little League World Series. "Walking into Howard J. Lamade Stadium for the first time gave us all goosebumps. It's such an iconic stadium." Coach Abrams says the uniqueness of Williamsport, Pennsylvania (where the World Series is played) is perfect, and the community is so

nice. He says the parade, which all the teams participated in, was a highlight. "The streets were lined up three deep."

Coach Abrams hit pre-game and threw batting practice daily to the team. The memory he cherishes most is hitting pre-game before each game, especially the one before the United States World Series Title game. He says it was extra special when ESPN analyst and commentator Tim Kurkjian said, "I really enjoyed watching you hit your pre-game." But the memory that stands out the most was returning home to a hometown parade down Main Street. "Priceless."

The players were just as eager to reminisce about some of their favorite moments. Leadoff hitter and one of the top shortstops at the World Series, Brody Brooks, said, "My favorite memory from the LLWS was the game room." He said on the first day, he met almost all of the other teams either playing them in ping-pong or air hockey. "Throughout the course of the week I went there around ten times. There were always new people there to meet, which was cool." Brody says from the first day every team tried to beat Japan in games to three. "There were only two people who beat them one of them was on the Northwest team." He added he has tons of memories from the game room, "It was a place we could all just hang out without baseball."

Utility player Quinn Boehle was passionate about his memories. He said, "Spending time with all the other teams, especially Japan and the Northwest team from Seattle. I still stay in touch with some of the kids today. He added, "We will be spending spring break with some players from the Seattle team in Palm Desert." He says he will never forget his other family, "The 2023 LLWS champs! And, of course, Louis' homerun was a favorite moment."

As you might expect, some of the players were wide-eyed and excited about their presence in Williamsport. First baseman Jaxon Kalish said, "I have so many cool memories of Williamsport. It was fun meeting and hanging out with teams from other states and countries." Jaxon said they all shared the same dream and were so excited to be there. "I have good memories from the parade in Williamsport. The town seemed small and quiet, but the parade was so loud, and the streets were packed." He ended by saying, "Everyone was so happy; it was a lot of fun being with my team and seeing everybody so excited."

Some players were excited to meet and bond with players from other states and countries. They would exchange stories on how they each got to Williamsport. Ollie Parks said, "Being in the dorms with the teams from other countries and states was one of my favorite memories."

Civil War Challenges Insights Into Freedom of the Press

Civil War, directed by Alex Garland and starring Kirsten Dunst, explores societal tensions without succumbing to political bias. Garland, known for his cerebral storytelling in films like *Ex Machina* and *Annihilation*, crafts a narrative that transcends traditional partisan divides, delving into the complexities of free speech and its implications for a fractured society.

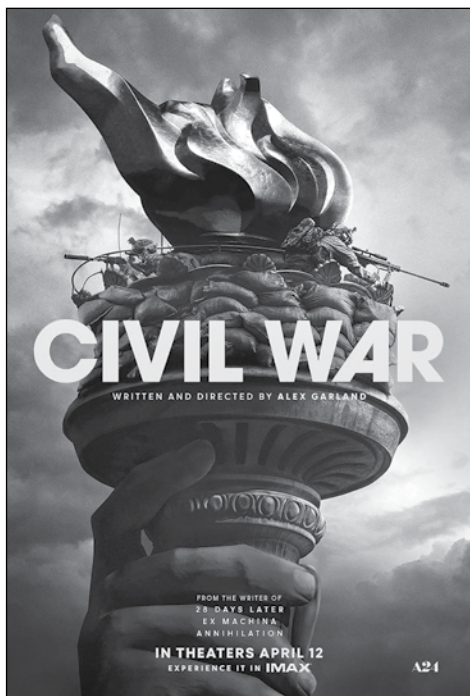
Set in a near-future world on the brink of collapse, *Civil War* follows photojournalist Ellie (Kirsten Dunst) as she navigates a society torn apart by ideological conflicts. A Short Walk Through a Wide World by Douglas Westerbeke

Venturing out of my usual literary fiction genre, I came upon this gem of a science fiction novel. Author Douglas Westerbeke is a librarian who decided to write a book of his own. I am glad he did. *A Short Walk Through a Wide World* is a fantastical story that begins with Aubry Tourvel, a young girl living in Paris with her family in 1885. They are a loving family so when a curse afflicts Aubrey with an illness that prevents her from staying in one place for long, it is a crushing blow to them all.

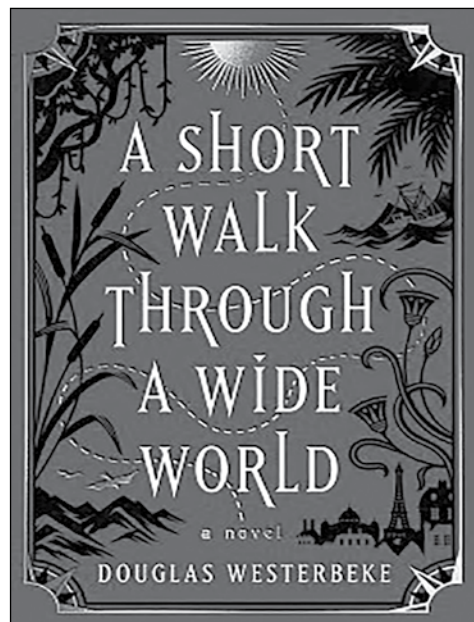
So begins Aubry's walk through a wide world, but it is certainly not short. Forced to keep moving, Aubry's mother accompanies her as she grows, but soon she is on her own. Her adventures are many and varied, as are the people she meets along the way. Across deserts and seemingly insurmountable mountains, Aubry faces challenges that force her to learn, adapt, and grow mentally, emotionally, and physically. She faces death on many

occasions and happens onto extraordinary places hidden in plain sight.

Racing down an alley to escape marauders, she darts into a dark cave like entrance that leads to an enormous underground library, visible only to miraculous few. As she struggles to survive a snowstorm in the Himalayas, she stumbles onto a door in the snow-covered mountainside. It is only through this illusory labyrinth that she makes it to the other side of the mountain range and back into the world. Not all of these secret lairs are harmless.

As she ages and navigates through the world, Aubry becomes a famous, eccentric oddity. Doctors want to cure her, researchers are certain they can find a cause, writers want to tell her story, and many are simply fascinated by her story. She finds love and friendship, but they are fleeting. There is no way to outrun her disease; she must constantly move on and leave those she loves.

Aubry's adventure may be implausible, but Westerbeke is a master of world building and character development. Aubry is an enchanting, formidable, and resilient human. Read this book and accompany her on this journey. You won't have any trouble believing it.

ESUSD Board Meeting Report

The following information covers the March 28, 2024 ESUSD board meeting and was taken from ESUSD website:

Board Recognizes Retiring Police Chief Jaime Bermudez

The ESUSD Board of Education has recognized retiring City of El Segundo Police Chief Jaime Bermudez for his outstanding service to youth, the collaborative relationship with the school district, and steadfast commitment to the safety and security of all.

Chief Bermudez started with the El Segundo Police Department in 1992, and has since held every rank during his 32-year career. As chief, he has been visible at every school site, working collaboratively with school leadership to ensure a positive police presence in the ESUSD community.

Update from SoCal ROC

Southern California Regional Occupational Center (SoCal ROC) Superintendent Dr. Julian Rodriguez presented an update to the board. The agency is a part of the California public school system that provides career and technical education opportunities for high school and adult students.

Highlights from Dr. Rodriguez's presentation include:

Forty students from El Segundo High School and Arena High School are currently enrolled in a SoCal ROC program in spring 2024.

SoCal ROC offers a total of 29 "A-G" courses. These courses fulfill the minimum admission requirements for the University of California.

Students at SoCal ROC have the opportunity to earn industry certifications in health sciences, cosmetology, HVAC, and welding

before graduating from high school. In the cosmetology program, students can receive California State Licensure.

Beginning in the summer, SoCal ROC will begin piloting programming targeted at middle school students.

SoCal ROC recently received approval to begin a barbering program and will begin offering it for students soon.

Additional Board Actions

The board approved the 2024 Summer Credit Recovery, Geometry, and Extended School Year (ESY) Programs. Due to the expiration of federal funding, this year's programming will look slightly different than it has for the past few years.

Credit Recovery: June 24–July 15, Monday–Thursday (El Segundo Middle School)
Geometry: June 24–July 26, Monday–Friday (El Segundo Middle School)
Extended School Year: June 24–July 25, Monday–Thursday

Preschool Learning Center Class (Eagle's Nest) Gr. TK-5 ESY Classes (Center Street School) Gr. 6-12 ESY Classes (El Segundo Middle School)

The board approved an Affiliation Agreement between Point Loma Nazarene University and ESUSD to provide fieldwork opportunities in school administration.

The board approved the 2023-24 ESUSD Transportation Services Plan.

The board voted to enter into an agreement with Sandy Pringle and Associates to provide DSA Project Inspector services for the 24-006 District Offices Modernization-Site Work Project. The district will only be billed for the hours worked.

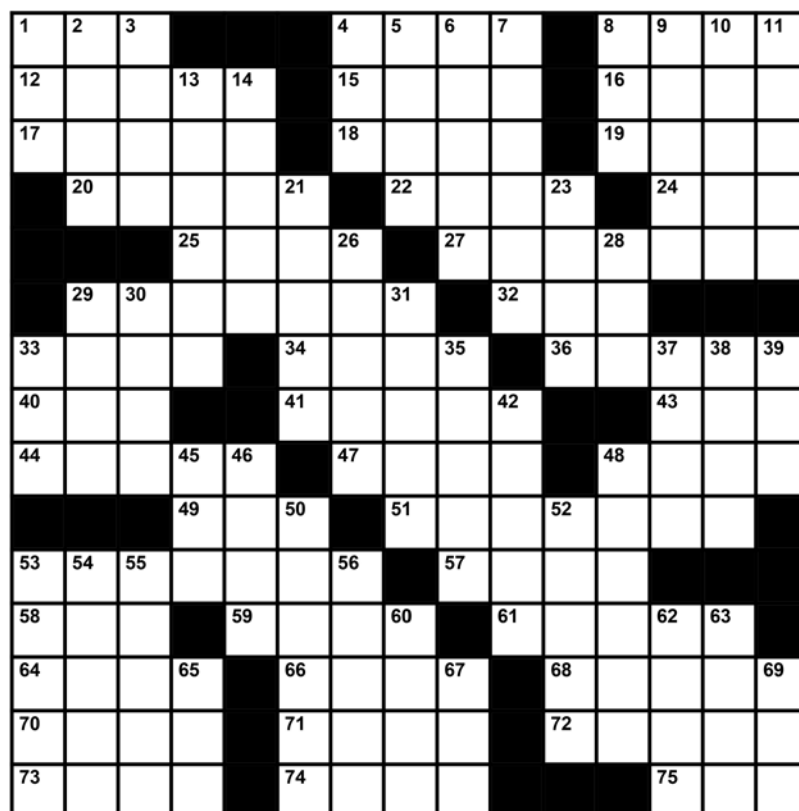

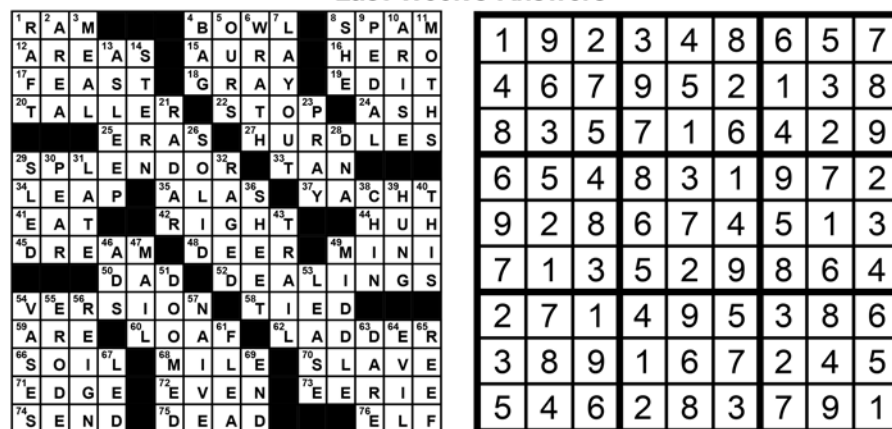

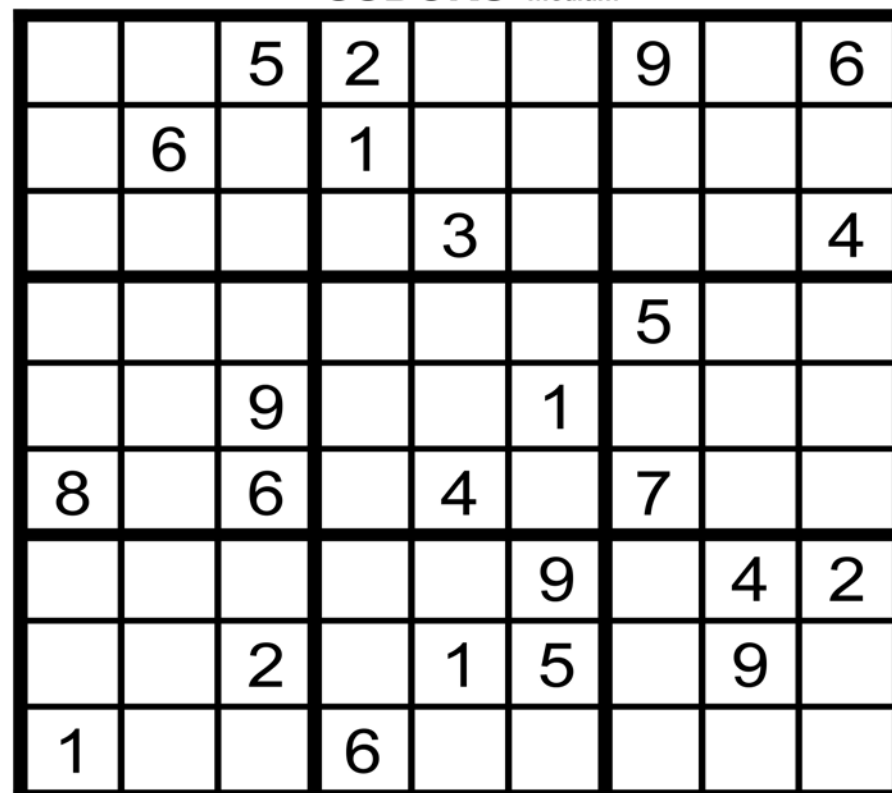

It was fun getting to know all these kids from other teams and staying together in the dorms.”

Though being a player in the World Series was certainly an once-in-a-lifetime memory other players thought the journey getting there was equally as memorable. After defeating Sherman Oaks in the Southern California Championship game El Segundo qualified for the Western Region in San Bernardino. Crew O'Connor said, “My favorite and most memorable moment was staying with my teammates at the Doubletree Hotel San Bernardino during the West Regional.” Little League International bought out floors of the hotel to house the teams competing.

Crew says he roomed with Ollie Parks, Max Baker, and Lennon Salazar. “We turned our room into a fun frat house, and the entire team took over a wing of the hotel. We had so much fun, which also helped us bond even closer as teammates.” He says there were lots of hall whiffle-ball games along with other fun activities. “We took over the entire wing of the hotel.”

Declan McRoberts echoed Crew’s thoughts about the memorable summer. “My favorite memory from last summer is our time in San Bernardino. We had some great competition

there; we were on ESPN+ for the first time, and we all stayed in a hotel.” At the hotel, there were four players per room, and the coaches had their own rooms. “So we had the rooms to ourselves, and we all had so much fun together!”

The players’ families made the trek to Williamsport to watch their sons and grandsons play on the biggest stage for a 12-year-old. It was an emotional reunion for the players when they saw familiar faces, including catcher Lucas Keldorf. “My favorite memory was when my grandparents arrived in Williamsport the day of the U.S. Championship game. It was really special to have them there as part of the whole experience. I’ll never forget our Dunkin Donuts car picnic the morning of the World Series final game.”

When you are thrust into the biggest moment of your young life, and you deliver one of the greatest home runs in Little League World Series history, the memory of the journey never escapes you. Louis Lappe says he has so many memories of the Summer of ‘23. “Our team winning State and then West Region in San Bernardino was great, and flying to Williamsport on a private jet was even better.” He says seeing teams from around the world and

making friends with the Japan team was really cool. “But my favorite moment from a summer of amazing moments is hitting the walk-off home run in the World Championship game.”

Perhaps what these twelve players learned most about being together was how they became not just friends but a family for life. Second baseman Colby Lee summed it up by saying, “My favorite memory from Williamsport and the Little League World Series was bonding together in the bunks with my teammates and our neighbors from Panama.” He says it was so cool to meet other kids from another country and experience different cultures firsthand. Colby added, “Experiencing all of it with my teammates, getting to know them better, and spending time with people who are like family to me is the cherry on top.”

First base coach Eddie Lee summarized what the team’s ride to the pinnacle of success meant. He gets emotional when he thinks about the three-year ride he and the team were on. He says his lasting memory was watching the team run out of the dugout after clinching the Little League World Series title. “Knowing we had just accomplished this goal we all envisioned three years ago (long pause) was priceless. He says the precious words from

manager Danny Boehle and assistant coach Tim Abrams telling the team afterward says it all. “Don’t let this be the best thing that happens to you, boys.....let this be the beginning.” It was the best in-the-moment speech ever, and one he says is cemented in his memory of the Summer of ‘23.

It was a special summer with plenty of memories for all of us but cherished memories for 15 World Champions. •

Two in Five Americans Define 'Making It' as Achieving Financial Independence

(BPT) - Financial independence is important to 67% of Americans, though nearly a quarter (24%) say they haven't yet achieved it, according to new research from Empower, a leader in financial planning, investing, and advice.

The definition of "making it" financially varies among spenders and savers, though many equate it with resilience and independence: 44% of Americans say it's synonymous with not needing to rely on anyone else for money, 39% say it's career advancement and one quarter say it's reaching a certain net worth.

To put a dollar value on it: \$94,000 per year is the magic number average Americans feel they need to earn to achieve financial

freedom, and 60% feel optimistic they can reach this money milestone. yourself what you want and why you want it. Establishing clear financial goals provides both direction and purpose, motivating you to work towards a more secure and satisfying financial future."

The Journey Looks Different for Everyone

Over half (57%) of Americans say they still rely on their family and friends for financial support, especially for help paying their rent (62%), internet and streaming services (56%), and their phone bill (54%). Of those who don't feel financially independent, 3 in 10 (31%) are optimistic they will be in the future, while 54% don't think they'll ever be



able to pay their bills without help.

The majority (92%) of financially independent Americans say they only started to feel that way once they reached the age of 36.

Money Talks Are Important

Among parents surveyed, many linked communicating about finances to achieving financial independence, with 57% saying they regret not having more money conversations with their children while they were growing up. In fact, 3 in 5 parents (60%) say if they could turn back the clock and do things differently, they would have made financial literacy a priority.

Although many believe their kids should be able to pay their own bills and expenses by age 23, 40% of parents with adult children aged 20 or older currently support them financially. More than half (53%) are dipping into their retirement savings to do so and 49% say they live with their children to help manage expenses.

This random double-opt-in survey of 2,000 general population Americans was commissioned by Empower and fielded by market research company OnePoll between December 11 and December 12, 2023. •

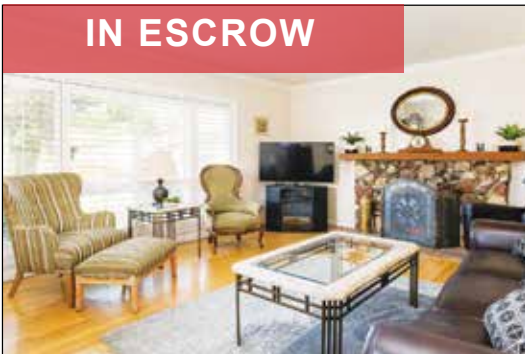

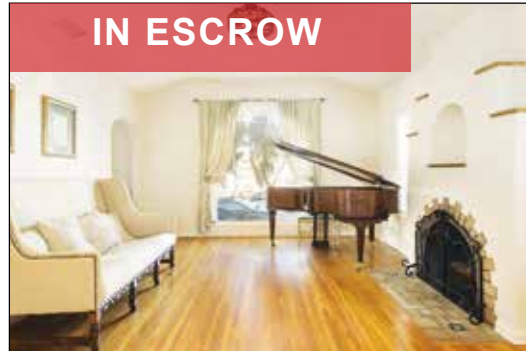
