Helping Young Women to Pursue a Fire Service Industry Career

Fired Up!: Empowering Girls to Shape Possibilities Into Realities

Fired Up! is the annual empowerment camp hosted by the Women's Fire Alliance (WFA); their goal is to provide representation for female workers and prepare young girls and women in a way that not only inspires, but excites participants to pursue careers in the fire service industry.

"There's a saying among women in the fire department," Linda Cessor, co-chair of the Women's Fire Alliance (WFA), explained. "And that is, if you can't see it, you can't be it."

Formed in 2018, the WFA is a nonprofit organization founded with the goal of providing access to information and resources for women interested in joining the fire service, as well as those already involved. The group also prioritizes mentorship, offering a support network for women in the field to talk to one another and offer helpful tips and feedback based on their experiences on the job. Serving 33 fire departments across LA County, the WFA's ultimate goal is to provide a foundation for women to feel empowered, seen, and heard in a traditionally male-dominated field.

"We're stronger together when we can support one another," said Deena Lee, Vice Chair of the WFA's Board of Directors and one of the organization's founding members. Lee is the first female fire chief of El Segundo and one of the mentors for Fired Up!, the annual two-day girl's empowerment camp that takes place on Main Street at Fire Station 2. The camp is held once a year in March in line with Women's History Month; this is their second year in El Segundo. Fired Up! is run by primarily female volunteers-an intentional decision, explained Lee and Cessor, to provide young women with an example to look up to and someone to show them the possibilities available to them.

Reflecting on the event's reception over the past few years, Lee is proud to see how the activities have opened up so many possibilities for young girls in town. "One of the most rewarding things is to see the look on that young girl's face when they realize they can cut with a chainsaw or drag the 150-pound dummy," she explained. Lee also talked about the importance of preparation during these two days, saying that teaching young girls specific skills to prepare them for the physical and emotional demands of the job is just as important as having fun and learning about what opportunities are available to them. This includes practicing exercises that focus on building specific muscles to address the job's unique physical expectations. "The reason I wanted to be a part of this organization is to provide mentorship and opportunities I didn't have as a woman in the fire service," she explained. "Now, as a fire chief, I have access to the other 29 fire chiefs in the LA region, so I can unite the women of the small and large fire departments nearby so we can support each other."

Part of this support comes from training, including activities that range from physical exercises, like pulling hoses and wielding an ax, to first aid and CPR techniques. Exposure to such variety in jobs not only shows girls they are completely capable of such tasks, but also gives them a solid foundation for what to expect on the job. The camp is primarily aimed toward young women ages twelve to nineteen. One returning attendee,

Kate Humphries, cited canine handling as the activity that showed her potential careers she hadn't previously heard of. "I learned a lot about what I want to do when I grow up, which is work for the canine search and rescue unit," she said. "The blind search and rescue was my absolute favorite." A participant in the camp in 2022, Humphries was excited to return this year.

Lee and Cessor are excited about the camp's reception since its establishment, pre-pandemic. With a return to in-person activities, they hope to see more engagement and outreach throughout departments across LA County. "Since the beginning of the WFA, we have seen a significant increase in the number of departments interested in doing girls' camps, which is amazing," Lee reflected. "The ultimate goal is to improve the numbers," Cessor added.

But as they note, the camp isn't just helpful for women and young girls. It also See Fired Up, page 5

Nancy spent her childhood in Denver and Chicago, as her father, Frank, was the Director of Scheduling and Charters for

Continental Airlines. Eventually locating to California (Westchester/Los Angeles), Nancy spent some of her elementary school years attending Loyola Elementary. In the late 60s, her family moved into a house on Center Street in El Segundo, California, where she grew up with her younger brothers Ken and Sam Kyzar. She spent summers on her grandparent's farm in Mississippi as well.

Nancy was very involved in many of the sports and clubs in El Segundo, enjoying Girl Scouts, softball, and gymnastics the most. She also played the guitar, sang in choir, and made beautiful stained-glass panels. She was also a babysitter for many families in town. With the Spring Break behind us, it gave the El Segundo Eagles an opportunity to catch their breath while they took the week off. The baseball team was the only team that played during the break. The El Segundo Little League and the El Segundo Girls Softball League were also on a week-long hiatus. Let's see how the teams are doing midway through the season that ends towards the end of April.

Baseball Team Ends Tournament on High Note

The Eagles played in the Elks Spring Break Tournament and ended the tournament with an 11-0 win over Foothill after suffering three losses. In the tournament opener, the Eagles were held to five hits and couldn't put together any timely hits, and fell the La Salle Pasadena 9-0. In the second game against Beckman (Irvine), the Patriots combined a walk, a batter hit by a pitch, two singles, and a ground ball to score three first-inning runs. The Eagle's offense was limited to four hits and was defeated 3-0.

In the game against Palo Verdes, the Eagles' offense came back to life. El Segundo pounded out 12 hits and put together two four-run innings but fell 12-9. After taking a 4-0 lead in the second inning, the Sea Kings scored ten unanswered runs to take an 11-4 lead in the sixth inning. In the bottom of the sixth, freshman catcher Lincoln Quaintance hit his first home run to make it 11-5. Trailing 12-5 in the seventh inning, the Eagles put together an impressive four-run inning. Dylan Alcala, Lucas Bonham, and Kyle Whalen each

singled to load the bases. Hudson Comer's two-run double made it 12-7. Ethan Ayler and Cooper Gamble added RBI singles to make it 12-9, but an inning-ending double play ended the rally.

In the win over Foothill, the Eagles were hitting on all cylinders. They took a 3-0 lead into the fourth inning, where they opened up

yesterday and on the road on Friday. They'll host Simi Valley in the ECR Tournament on Saturday at 10 a.m.

Softball Team Looks to Improve Their League Standings

The Eagles started the season off with a new coach and a string of victories. They are 2-4 in the competitive Pioneer League and

The Eagles play a two-game set against West Torrance this week, including at home

8-8 overall. Their record is a little misleading since they have faced some high-profile teams. Of the 15 schools they have played, 13 of them should qualify for the playoffs. They are keeping scores low with their pitching and defense because the offense has struggled with its young players.

They have already had some swimmers meet the CIF qualifying cuts, but they are looking for further success. They have gone undefeated in the Pioneer League thus far after defeating South Torrance.

Some of the highlights included a winning time by Chase Little, Patrick Wang, Avi Sharma, and Alexnader Cole in the 400-freestyle relay (3:39). 





mid-thirties, Isabelle's world is splintering. Her mother just died from a rapidly progressive illness, and her father lives in the rarified world of his own ego. Her first book wasn't accepted and she's wrestling with the expectations of herself and the publishing world as the only child of Ward Manning, the feted and fawned over best-selling author of nineteen novels.

What Isabelle doesn't know is that her father is floundering as well. Ward's agent is pushing him to deliver at least the first chapters as the deadline for his latest book looms. Ward doesn't have any chapters to give. He is so obsessed with his reputation and standing that he spends most of his time reading fan mail and scrolling

the internet for mentions. He has no time for anyone or anything that doesn't cater to his monstrous ego. That includes Isabelle. Losing his wife Claire has only made things worse. He is spiraling out of control and there is no one to stop him.

Set in New York City and Sag Harbor, this story of a fractured family coming to terms with loss and failure heats up as Claire leaves a cryptic legacy for Isabelle. Why did her mother insist that her father have no knowledge of what she finds? Why is it so carefully hidden? What she ultimately discovers may destroy them all.

While the characters can be unlikeable, we see how Isabelle's obsession with pleasing her father has shaped her life. Isabelle recognizes her single-minded ambition comes at a terrible cost; one she isn't sure she can live with. This story slowly builds, and the tension thickens as each of our protagonists strive for that publishing pot of gold. Who will win and what will they lose? This book is hard to put down.




Film Review

In *Paint*, Owen Wilson Plays a Bob Ross-like Painter

If you're going to have someone play a Bob Ross-type character in a movie, there's no one better to do it than Owen Wilson. It's this casting alone that made me want to watch *Paint*, in which Wilson stars as a not uncoincidentally-imagined fictional basic cable painter known for his serene landscape portraits.

However, Wilson's gimmick of channeling Ross's famous hippie vibes with his trademark chill is only rewarding for so long. While it's an intentionally silly sendup and a mildly funny world to live in, *Paint* isn't nearly as subversive or funny enough to become a new comedy classic.

Wilson plays "Carl Nargle," a hippie host of a live painting program for the local Burlington PBS affiliate TV station. With his good vibes and worldly bits of wisdom, Carl is beloved in his small town. The ladies especially love him, too. They rush him after every show merely for the chance to hold his paintbrushes.

Times are good for ol' Carl Nargle. Except—predictably—the times are about to change. Once the station's ratings start to go south, the station manager (Stephen Root) brings in a new painter. Ambrosia (Ciara Renée), a

hip younger gal, is to add to Carl's success with another hour of live painting.

Carl and the rest of the station are surprised at the new blood that Ambrosia brings to the show. It's quite the departure from the peaceful mountains and calm creeks painted by Carl for his mostly-senior viewers. But her fresh energy—and new female empowerment—push Carl to the sidelines. Soon enough, he's left alone as an aloof artist and out-of-time man.

If this setup sounds similar to *Anchorman*, it's because it really is. I wonder if this was a conscious or unconscious template that writer-director Brit McAdams had in mind when creating this movie. With his curly blonde perm and woodsman-styled facial hair, even Carl's comically dated '70s appearance channels that of Ron Burgundy's.

I did find an interesting story a few layers underneath *Paint*, which comes about towards the end of the film. When Carl is sidelined, he finally confronts how his "hotel art" compares to more compelling art of the time, like modernism.

I wish the film followed the blueprint that last year's Weird Al parody-biography Weird: The Al Yankovic Story did so well: weaving biography and wild absurdism together actually drew laughs. While perfectly cast, Owen Wilson is only so watchable as the film drags on. It's enough to make you wonder how much longer it'll take for the paint to finish drying.


