Take A Chance on *Mamma Mia!*

El Segundo is buzzing. This month, El Segundo High School's production of the world-famous musical *Mamma Mia!* will premiere on Thursday, April 27th. The show will run for three nights along with a "Special Dress-up Sing-a-Long" performance on Sunday afternoon, all presented in the ESHS Performing Arts Center. Tickets can be purchased on the GoFan website, and a direct link is available on the El Segundo High School's (ESHS) website. VIP tickets are available for those interested in premiere seats, including a small commemorative surprise!

Catherine Johnson wrote the jukebox musical and exclusively features songs by the beloved Swedish band ABBA, an acronym of all the band members' first initials. Hits include 'Dancing Queen,' 'Take A Chance On Me,' 'Waterloo,' and a catalog of nine studio albums over 50 years. ABBA was Sweden's first winner of the widely acclaimed Eurovision Song Contest, an annual competition with local bands representing European countries. Other notable winners include Celine Dion who won in 1988 representing Switzerland.

This ambitious production was made possible with the collaborative efforts of students, parents, and two exceptional El Segundo High School teachers: Tiffany Maisonet and Glenn Sidwell. Ms. Maisonet and Mr. Sidwell have known each other since they were kids. Both Alumni of ESHS, Tiffany and Glenn's connection began through their mutual love of performing at an El Segundo Rec Park production.

Mr. Sidwell went on to pursue acting professionally for over a decade and has both feature and commercial credits. At the same time, he was also working as a tutor before

combining these passions and becoming an educator. The timing worked out, and about a year after he began teaching, a position opened up in El Segundo.

Ms. Maisonet's journey back to El Segundo High School took a different path, studying Molecular Biology at UCLA and going on to work as a scientist at the prestigious institution for seven years. While taking time off, Ms. Maisonet decided to volunteer at the high school part-time before ultimately joining the faculty. Most of Ms. Maisonet's family are educators, and she describes teaching as being "in [her] blood."

Ms. Maisonet and Mr. Sidwell share the responsibility of directing and producing

and describe it as a "balance," but each has their specialty; one example is Mr. Sidwell happily defers to Ms. Maisonet for all matters of choreography, and she doesn't hold back. The intention is not to put on a scaled-back version of this show; Ms. Maisonet revealed that some of her choreography is HARD, but the students don't back down. The goal is to put on the highest quality show possible, challenging all the students. Ms. Maisonet joked, "The first week [the students] are usually cursing me, 'What have you done to us', 'This is so hard and advanced!'"

These students' and volunteers' time and dedication are nothing short of amazing. **See *Mamma Mia!*, page 4**

Hyperion, Crime, Copiers and Kiwanis Chilipalooza

The Hyperion Water Reclamation Plant and its odors that impact El Segundo residents and visitors were once again pushed to the forefront of an El Segundo City Council meeting after a leak in a digester generated 23 odor complaints last Tuesday. City Manager Darrell George addressed City Council during its evening meeting last Tuesday, telling them that Hyperion staff was in the "process of fixing the leak" and cleaning it up, with a projected completion expected later that night. Those 23 complaints came on the heels of 31 odor complaints over the previous two weeks. George explained

that the South Coast Air Quality District had conducted investigations and had not issued any Notice of Violations for those 31 odor complaints.

El Segundo has been grappling with issues emanating from Hyperion ever since a plant emergency in July of 2021 produced "a nearly catastrophic spill," according to a city press release dated April 5, 2023. After months of George making a specific presentation on Hyperion plant progress, repairs, odors, and gases updates to the council at every regularly scheduled council meeting, those updates became simply part of his overall updates

School Spotlight

ESHS Student Named Semifinalist in The Music Center's 36th Annual Spotlight Program

El Segundo High School student Milena Vanek has been named a semifinalist for the Music Center's 36th Annual Spotlight Program in the acting category. This year, more than 1,520 teens, representing 265 schools, 177 cities, and eight counties, auditioned for the prestigious program. Out of the 1,520 entrants, only 114 were selected as semifinalists.

The Spotlight Program provides teens with expert advice, coaching, auditions, and mastery classes taught by professional artists and arts administrators in seven categories: acting, ballet, dance, classical voice, non-classical voice, classical instrumental, and contemporary instrumental.

As a semifinalist, Vanek will have the opportunity to attend a special mastery class for acting hosted by highly regarded artists who will share their expertise on performance technique, training, and professional life. Following the mastery class, each semifinalist will audition again before a new panel of judges, who will then select the top two finalist performers in each category, for a total of 14 Grand Prize Finalists (two from each category). Judges will also name an Honorable Mention in each category.

The Grand Prize Finalists will perform in The Music Center's Spotlight Grand Finale on Tuesday, June 4, at 7:00 p.m. at The Music Center's Walt Disney Concert Hall. The program awards more than \$100,000 in cash scholarships annually. As a semifinalist, Vanek will automatically receive a \$500 scholarship. Grand Prize Finalists will each receive \$5,000 scholarships; one Honorable

Mention in each category will receive \$1,000. This year's finalists will be announced on April 18, 2024.

"We are so proud of Milena for being chosen as a semifinalist for acting," said Superintendent Dr. Melissa Moore. "Her hard work and dedication have paid off with this incredible recognition. Milena is a wonderful example and representation of ESUSD. We congratulate her on this remarkable achievement and look forward to her continued success!"

Unsung Heroes Reminisce on Their Favorite LL World Series Moments

When the El Segundo Little League All-Stars made their incredible journey to a World Series championship, they had plenty of support. The unsung heroes of the ride the All-Stars took were the support from the parents and family members of the players and our community.

The trek to a Little League World Series championship started at home. It didn't begin with the District 36 championship banner of 2023. No, it started years earlier when moms and dads signed up their sons to play Tee-Ball as 7-year-olds. They sat in the cool weather on chilly evenings, ushered them to travel ball games, and sat in the stands at All-Star games. The mothers, fathers, brothers, and sisters of these All-Stars attended faithfully and cheered them on.

The pinnacle of a Little Leaguer's All-Star run is playing for a Little League World Series title. The parents hang with every pitch of their son's All-Star experience. When their son is thrust onto the biggest stage of their young lives, playing a game they love, parents place their lives on hold to follow them. Much like their All-Star sons, they have lasting memories of their experiences.

Tiffany Brooks, the mother of Brody, said there were countless memories that "I hope will remain with me forever." Tiffany continued, "Whether it was coming back from a deficit in our final state game against Sherman Oaks to the heat and games that happened in San Bernardino." She said arriving in Williamsport and seeing Lamade Stadium for the first time gave her a special feeling. "Every part of this journey had a moment, a smell, a song that will probably bring us right back to that day, feeling like it just happened."

Sheena Parks, Ollie's mother, is filled with emotion when thinking about the Little League World Series. She says there were so many moments to choose from. "Honestly the most emotional moment for me was coming home to the enormous welcome from our town. It was something I will never forget. And even now, I get overwhelmed with emotion if I see videos from that day. The support

from our city was unbelievable."

Jackie Kalish, Jaxon's mother, said, "It was like having a front-row seat to the entire experience; it was like living a dream." She remembers being emotional as she walked into Lamade Stadium, day after day wearing her WEST/ El Segundo gear and family pass lanyard around her neck. There was a mixture of nervousness, excitement, and anticipation, as well as an overwhelming sense of pride and joy. She said, "Numerous times, my eyes would water, and I would choke up walking past the fields. The energy was electric, strangers would cheer us on, and there was an unspoken connection seeing so many people we didn't know wearing the WEST jersey."

Jackie marvels at the sight of the kids' impact on everyone: "it was beautiful." There were so many obstacles the parents had to deal with but they all had each other's back. Whether it was parents ordering and dropping off food for the boys or driving 30 minutes to pick up a group of kids so they could come to take a good shower, rest in a quiet room, eat a home-cooked meal, or get over the stomach flu, they worked as a team. When it was time for the kids to return to

the barracks at night, another parent would bring them back without hesitation. While the stomach flu worked its way through the team, they helped each other in any way they could. "Seeing the boy's strength and resolve during this difficult time moved me immensely. This experience, the laughter, and the love we all shared will connect us forever."

One common thread among the parents was their gratitude for the support from the community. Christibelle Villena, Lennon Salazar's mother, said, "The Homecoming

made it so real for all of us, especially after such a long summer away from home. Even better was seeing the boys' faces as they felt everyone's joy, pride, and gratitude - this whole experience has been unforgettable."

Nikki Boehle has had a front-row seat to the team's incredible ride. As the wife of manager Danny Boehle, she has been there for all the exciting moments. Her favorite moment during the summer was the Welcome Home parade El Segundo rolled out the day they returned from Williamsport. "It was absolutely incredible!"

Nikki was just as passionate about so many post-World Series experiences to be thankful for including the team being honored at the USC football game to riding on a float in the Rose Parade. "But what's impacted me more than anything has been meeting people of all ages from all parts of the country who have shared their experience, watching the games and the joy and excitement it brought to their lives. It brings me to tears just thinking about it."

Entire families put their lives on hold during the three-month ride for the opportunity to support their sons during their World Series run. Dan and Jen Salazar (father and stepmother of Lennon) and Lennon's sister Corinne were faithful supporters. Corinne wore a special dress to each game for luck. Dan said, "The whole experience of being at Lamade Stadium, the Little League facility, was magical." He remembers walking up

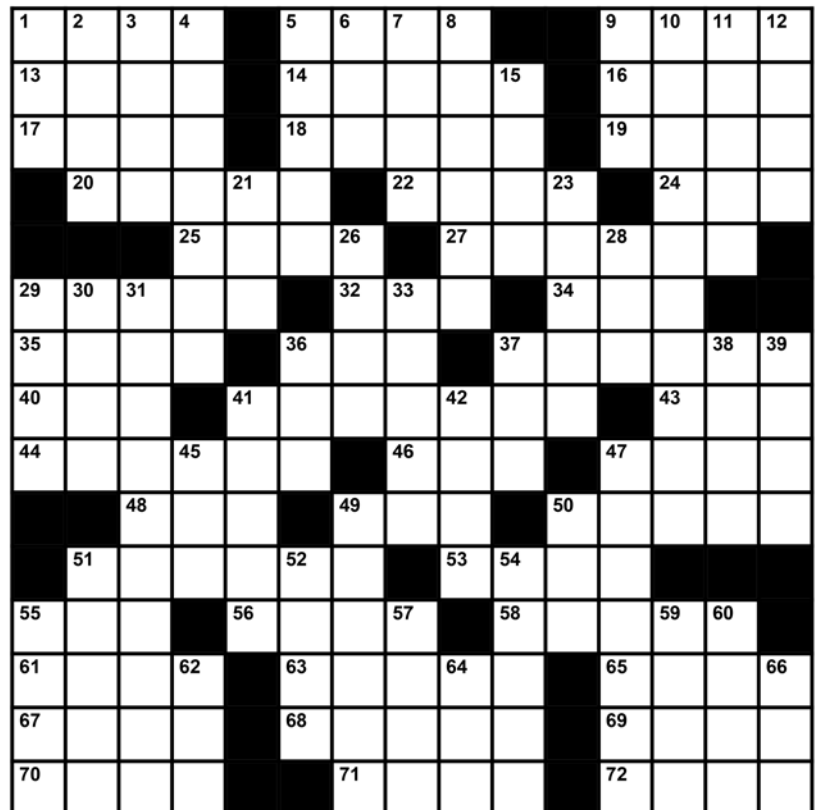

Ms.Maisonet was gracious about how none would be possible without the tremendous assistance and support of the parents and the community. Ms.Maisonet and Mr. Sidwell were specific in recognizing all the tremendous assistance provided by the parents. Another stand-out volunteer is Lauren Muraida. She has spent time performing in New York City and brought her professional experience back to the community. Ms. Muraida helps work with the kids individually, taking pages of notes during rehearsals and emailing students individually to help hone their craft.

Even students have taken up leadership roles. The show has two student Dance Captains who also work in smaller groups to practice and train. All the students were outspoken on how special and valuable this experience has been. Grace Espinoza, who's playing one of the leads, Sophie, was grateful for the connections she's found through the play. "The community of people it creates is hard to come by. I look forward to coming to rehearsals and seeing my friends."

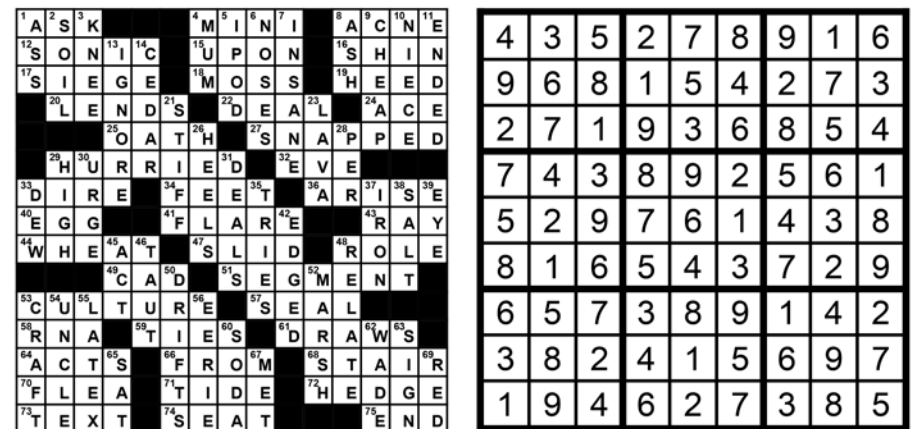
With Ms Muraida's help, Mr. Sidwell and Ms.Maisonette felt enabled to channel their

focus on the production. Focus is an interesting obstacle the show faces. While the show is associated with the Drama program, this production is entirely extracurricular. That means it competes with all the other excellent extracurricular options at El Segundo High School, including sports, band, and other activities. "None of our kids can say they only do the musical, and that's it," Ms. Maisonet described. "They all spend their time between clubs and everything else they do. Which is awesome!"

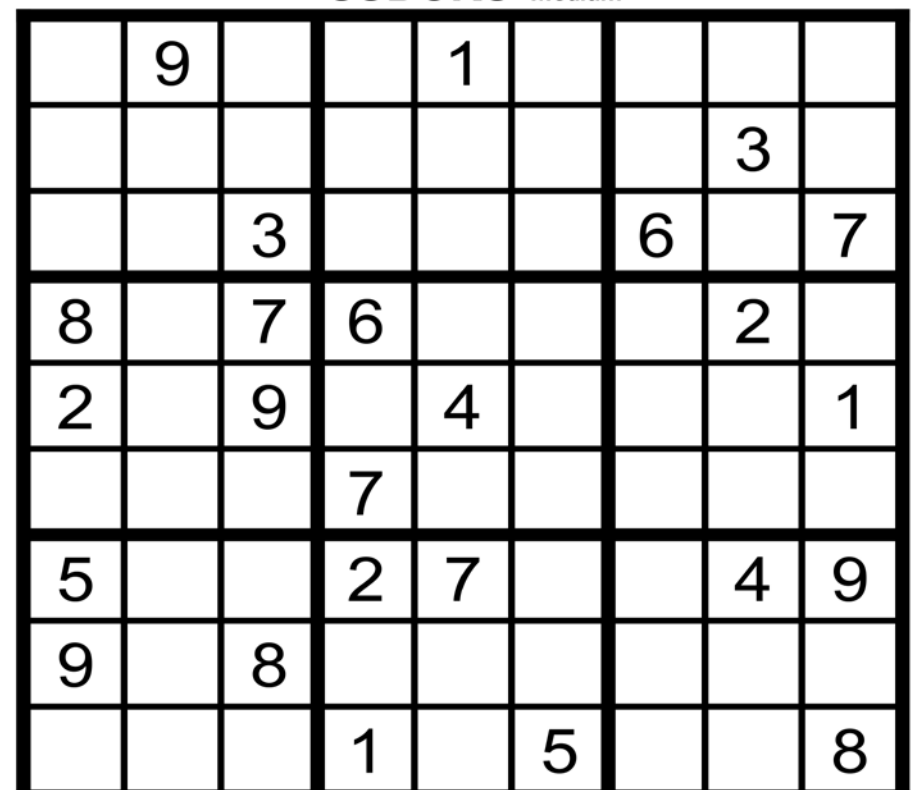

Assistant Director, Stage Manager, and Prop Master are all critical roles students hold. Mr. Sidwell mentioned that non-performing roles were popular amongst students in the drama program, even El Segundo High School's Business Pathway program is involved! Glenn was proud to talk about how many unique opportunities the production had available to students and how performing these key roles helped students feel a sense of ownership and responsibility. "I have worked tirelessly with our wonderful cast and crew to create the best show we have ever produced!" described the Stage Manager, Bear Ruedas. "Can't wait to see our hard work pay off."

Nicolas Cage's Arcadian is an End of World Thriller with Heart

The new film *Arcadian* offers exactly what I want to see in an apocalyptic thriller. Terrifying creatures loom outside a small family's remote farmhouse, waiting to consume them. Cleverly constructed traps and weapons are ready in case they need to defend themselves. Heart-pounding sequences of those creatures bursting through boarded-up doors with bone-chilling jowl snaps that cause the hairs on your neck to stand straight up. And yet, while these moments are spectacularly executed, *Arcadian* is not a traditional horror movie. Focusing on the smaller moments of life during end times, like a joyful run through the woods, a first kiss from a pretty girl, and the bond between brothers and their doting father, director Benjamin Brewer crafts an emotional, tender, grounded coming-of-age film that subverts typical genre conventions.

Set against an apocalyptic landscape, *Arcadian* opens with Paul (Nicolas Cage) desperately sprinting while cradling his twin boys, evident that he is their only protector in this hellscape. Years later, Paul and his sons have aged: himself, older, and the infants, now teenagers. They are the only people around for miles, living a life of near solitude after the apocalypse wiped out most of society. The three upkeep their home like self-sufficient sailors, cooking, cleaning, and creating reinforcements to keep the life-threatening, otherworldly creatures at bay. Paul isn't one to let his guard down, especially around his children. "Are we not men!?" he exclaims,

combination of special effects and emotional heart, both of which can be attributed to the direction of Benjamin Brewer. With previous credits such as Visual Effects on *Everything Everywhere All At Once* and the writer of Netflix's crime thriller *Reptile*, *Arcadian* is his first solo directorial debut (he also co-directed Nicolas Cage in *The Trust* with his brother Alex Brewer). Beyond its technical impress, it's a grounded coming-of-age film similar to *Stranger Things*, with young people needing to save the world. Brewer shows the small moments with gentle observation. Some are slow and sad which, at times, adds unnecessary weight that the film is forced to overcome. Some of those moments could have been better served with more moments of joy.

Speaking of twists, I was surprised about the smaller presence of Nicolas Cage in the film. It's a bit of a bait-and-switch marketing Cage front and center when really, his character bookends the film. He doesn't offer a zany Nic Cage performance, he's more subdued. The story largely rests on the shoulders of Jaeden Martell and Maxwell Jenkins, who give performances that are wise beyond their years, as does Sadie Soverall.

Overall, *Arcadian* is a visual and tonal achievement, with great cinematography, although the story does leave a bit to be desired. By being so grounded and raw, it fails to get into the mythology of the creatures, or even let itself have as much fun as it could. Could *Arcadian* have been even more enjoyable as a silly popcorn flick? Undeniably,

driving a steak knife into the dinner table. Ever the devoted sons, they reaffirm their commitment to the family unit.

While the twin brothers share the same age, they are also noticeably different. There's Joseph (Jaeden Martell), the inward intellectual who hides behind his flop of hair to engineer weapons and traps to protect his house and father. And there's Thomas (Maxwell Jenkins), the more adventurous of the two who runs through the woods each day to visit the neighboring house where his crush, Charlotte (Sadie Soverall) lives. The brothers' spats are typical, especially when Thomas misses curfew. Paul warns his young son of the dangers that lie in the woods, a warning that Thomas mostly shrugs off until he encounters the creatures that threaten his life. Paul thrusts himself into danger, an act that alters the family's safety and dynamic and forces the two brothers to grow up and heal wounds quickly to save their lives.

Arcadian captivates and impresses with its

yes. If you're looking for a monster movie with heart-pounding action sequences and tender coming-of-age moments that show the beauty in family during the end of the world, *Arcadian* is for you.

Fourth Wing by Rebecca Yarros

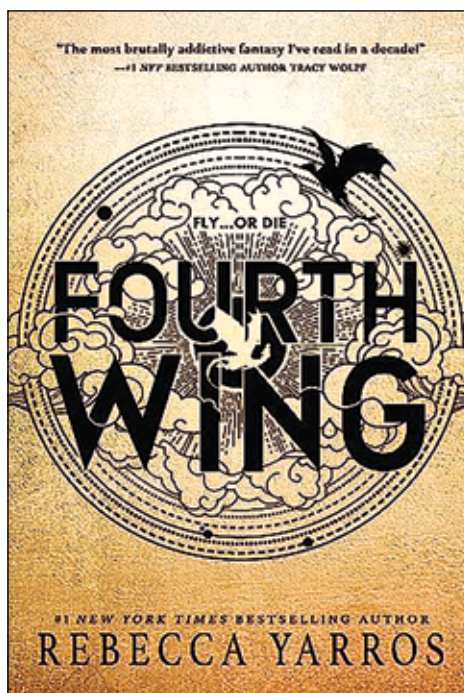

Fourth Wing by Rebecca Yarros is the first in a five-book series about Violet Sorrengail, a cadet at Basgiath War College. It is an adult fantasy book set in a warring world with dragon riders, scribes and infantry soldiers in the country of Navarre. Violet Sorrengail is twenty years old and was supposed to enter Basgiath in the Scribe Quadrant, living a quiet life among books and history. Her mother is a general and her dad was a scribe. Although Violet was trained and wanted to be a scribe,

her mother, the General, commanded that she join the hundreds of candidates striving to become a dragon rider, the elite of Navarre.

Violet has Ehlers-Danlos Syndrome, which causes her to have brittle bones and dislocate and sprain body parts easily. She lives with pain every day, but it makes her more resilient and determined to succeed. Violet's sister Mira is a lieutenant in the military and is a dragon rider. Before Violet has to go to Basgiath, Mira helps her pack her backpack and gives her advice so she can make it safely across the parapet. Each year about half of the students trying out to be dragon riders die climbing the parapet, and even more die during training. If you successfully complete all of the tasks, then you get to compete on Ascension Day and hopefully have a dragon

to the council and not a standalone segment. Tuesday night, the city council asked him to prepare once again to deliver those standalone updates. When asked what had happened, the city's Public Works Director Elias Sassoon said the problem was with a "system that sometimes doesn't work the way it's supposed to, so it was a system accident." Mayor Pro Tem Chris Pimentel said, "It was truly remarkable, the smell." Added council member Ryan Baldino, "It's the motto of Hyperion: a 'system that sometimes doesn't work the way it's supposed to.'" George noted that it was the first time a digester had been named as an odor culprit and that he and staff would "get additional information on that." He also said the digester leak caused "sludge to be exposed, which created the odor nuisance."

Other items that the council heard about and discussed included storm-water pump station #16, located near Stevenson Field in Recreation Park; the number of copiers the city and its staff need in an age of digital signatures via DocuSign; an Aquatics Subcommittee update; and Public Hearings on proposed zoning amendments, including housing overlays and identifying specific parts of the city that could be used as a backup should any of the overlays not work out to meet state Regional Housing Needs Assessment requirements; a proposed ordinance amendment to the El Segundo South Campus Specific Plan to allow for potential lot subdivision for financial purposes as outlined by real estate developer Mar Ventures, which is currently at work on Chargers Commons, where retail, dining, and medical facilities are being built; and an amendment to an ordinance to allow driveway and curb cut standards to be different in specific circumstances.

City staff also presented the results of the "2024 Resident and Business Survey Regarding Satisfaction with City Services," and both the new fire chief and police chief addressed the council: Fire Chief George Avery presented the council with seven recommended updates to the current city code regulations and Police Chief Saul Rodriguez (on the job for just ten days) was introduced by George. He told the council he's "fortunate to work for such a fabulous city. I look forward to working with everyone here and I look forward to meeting this wonderful community. The small-town feel is something that drew me here. I look forward to doing everything I can to make sure that the men and women continue to make the city proud, make you proud, and make everyone happy for the best police department you have in the entire country. That's my goal. That wherever you go, you say, 'We have the best police department in the country.' That is my passion, and I'm grateful to be here." He noted that he is technology proficient and will adopt "things that will get us ready for the future... to make our city safe."

Before Rodriguez was introduced by George early in the meeting, resident Chris Johnson spoke during Public Comment to tell the council about crime in his neighborhood. He noted that his aunt had her car window smashed while parked in front of his house, that he'd "twice caught footage" of doors being checked on cars parked in his driveway, and most notably, that after driving away for a family trip, his alarm captured individuals who broke into his home and left via the front door in a white Dodge Charger. He noted that

just 45 minutes before leaving for the family trip, he had left two of his three children home while dropping off his eldest at an area location so he could go on a trip and that he couldn't imagine what would have happened had the burglars come to his home while his youngsters were home alone. The break-in occurred on a Saturday at about 6:00 p.m., he said, during daylight. He said once word got out about his situation, other residents came forward to say their car windows had been smashed recently, and another house was broken into nearby, the same night as he was. Those burglars used side gates to access backyards and then smashed French doors, ransacked master bedrooms, and fled via front doors, all within three minutes. He told the council he is "grateful to live in El Segundo where I know it will be pursued." He also said, "My concern is that criminals are emboldened."

In other news, council member Carol Pirsztuk read a proclamation designating April 27, 2024, for the 32nd running of the Big 5 PTA Run for Education, which includes a 5k, 10k, and kid's fun run, all to raise funds for the El Segundo public school PTAs. Notably, the race course is "challenging" due to the number of hills in the city, according to Mayor Drew Boyles, who said he would enter it. Baldino called out the accomplishments of El Segundo High School junior Alexandria Taylor who ran the recent Los Angeles Marathon in 2:56:53, taking first place in her age group and the Women's Open Division. Council member Lance Giroux hailed the athleticism and dedication of El Segundo Youth Cheer, a group of 6th-8th graders who took three national titles this year. The squad and its coaches and staff were feted by the council.

At the end, council members delivered optional reports. Baldino said the Kiwanis 2nd Annual Chilipalooza was well attended even with the torrential pouring of rain; Pirsztuk suggested council look into selling the parking lot the city owns on Main Street between Fantastic Cafe and El Gringo to raise funds for developing other public parking areas, perhaps including a parking structure; she also said she'd like for her and the city to understand the role the Los Angeles County Public Health Department plays in the city, particularly when it comes to aging in place; Pimentel brought up regional developments on Measure R and the Local Travel Network, mentioning golf cart accessibility near the beach/ocean, and talked about how elsewhere unused railbeds have been turned into parks and water rehabilitation elements that can deliver five times "what we're currently doing out of Hyperion. Boyles said he'd recently met with a Forbes reporter and taken a tour of Chevron with entrepreneurs and others interested in doing business in El Segundo. He'd also met with LA County Supervisor Holly Mitchell, whose district includes the city, and talked about Hyperion and a new mental health policy that enables authorities to place a person in need of mental health care more easily. He called the policy "a game changer for us." He also said he'd read "Recoding America: Why Government Is Failing in the Digital Age and How We Can Do Better" by Jennifer Pahlka after Mitchell called the book to his attention and highly recommended others read it. •

"While the last inning of the 2023 LLWS championship game is indelibly etched into my memory," she pauses, "I am most struck by the welcome home the day after the championship game and the outpouring of heartfelt support from our neighbors and city." She says seeing the joy and excitement on that homecoming day... from the grand welcome by LAX to the cheering families, students, the first responders fire/police, and shops along the drive on Main Street are all cherished memories."

As with so many precious moments during the World Series run, Jim O'Connor, Crew's father, had the most memorable moment attending each game during the entire week. Other special moments were when Crew had an impactful two-run RBI single off the feared 76 mph fastball off Brandon Manivong to help win a West regional game. "The other unforgettable moment was watching Crew, at Angel Stadium, throw out the first pitch before the Angels game with his teammates surrounding him in support; it was priceless."

Michelle Keldorf, Lucas' mother, is someone who really enjoys her personal space. "I am honestly a little surprised to hear myself say that I loved living communally for almost a month!" She and the other parents fed each other's kids, helped take care of sick players, rode the waves of anxiety and pure joy, and lived into every moment together. She says, "It sounds a lot like El Segundo in general."

Michelle never wavers about her favorite

memory. Coming back to their shared rental in Williamsport every night and digesting all the messages sent from home. "It's hard to articulate the feeling of reading all those notes of love and support." She adds it was the most unifying experience she's ever been a part of. When she watches the video of Main Street going wild right after the final win... cars honking, people pouring onto the streets from all the restaurants in town, "It chokes me up every time, so thank you, El Segundo!"

When Samantha Lee thinks about a favorite moment of the LLWS she says watching her son Colby, who hadn't pitched all summer long in All-Star play, get the opportunity to pitch on Little League's biggest stage. Colby pitched against Rhode Island and struck out the last batter to seal the win. "Watching the sheer joy on his face when he struck out the last batter to end the game was priceless." She says the entire LLWS experience was surreal "and one our entire family will never forget."

There were several community members who had ties with the team who traveled to the World Series and weighed in. Ryan Lopez, who coached many of the El Segundo Baseball Academy players, sat in the stands at Lamamde Stadium beaming with pride as he watched many of his former players. Alberto Concepcion and his son Tucker were there too. Alberto, who has coached a few of the players at the El Segundo Baseball Academy, said his favorite moment was watching his son slide down the hill with the Jaxon Kalish after, "They became the last Little League team in the world to end their season with a win."

Two others, including John Garland and Jose Mendez, attended the State, West Region, and World Series games. John said, watching the games at the World Series, "It was youth baseball Disneyland; clean, safe, and beyond
