## City Council Considers Stricter Water Conservation Requirements

In the wake of California's continuing drought that has reached historic severity and the Governor's recent executive order to reduce water consumption, El Segundo residents will be asked to further conserve their own usage of the precious commodity. During Tuesday night's City Council meeting, Public Works Director Stephanie Katsouleas presented a series of staff recommendations to beef up El Segundo's existing water conservation ordinance from 2009 to align the City with State requirements set to be approved in early May and go into effect on June 1.

While the State Water Resource Control Board called for measures to cut water usage by 25 percent overall, the reduction goal won't be applied evenly across California. Reduction ranges will be set from 10 to 35 percent depending on a particular city's existing consumption patterns. With that in mind, El Segundo residents will be asked to cut water usage by 20 percent-based on an average consumption allocation of 55 gallons per day (equal to four units per person per billing cycle) to meet basic indoor needs. El Segundo residences averaged 95.4 gallons per day according to the most recent statistics, with landscape and irrigation usage accounting for the overage.

Staff-recommended municipal code updates include limiting outdoor watering to two days per week. El Segundo's current water

ordinance restricts the time (may be done between 5 p.m. and 9 a.m. only) and duration (15 minutes per station) of watering, but not how many days per week it can take place. Katsouleas asked the Council to consider designating specific days for all residents to water, but the group was reluctant to impose a set calendar. Mayor Suzanne Fuentes preferred to "leave it up to the people" and avoid a police enforcement scenario. "If we tell them [residents] they need to conserve, they will," she said. Councilmember Mike Dugan thought it more sensible to spread out watering dates, as people may end up oversaturating their lawns if restricted to two days.


Another suggested code change is to limit landscape watering 48 hours before or after predicted rainfall. The City ordinance currently only restricts watering during actual rainfall. This item didn't sit well with Mayor Pro Tem Carl Jacobson, who questioned how anyone can accurately predict when it's going to rain. Fuentes added that some residents don't know how to turn off their sprinklers (that may be on timer systems). She suggested encouraging residents to follow the 48-hour guideline, but not to make it a requirement.

Other proposed revisions include completely prohibiting washing down driveways and sidewalks (local residents can do so now as long as the water doesn't reach the storm drain); not allowing watering of landscape medians with ornamental turf unless using recycled water; and revising the building code to allow only drip irrigation or microspray for landscaping of newly constructed homes.

West Basin Municipal Water District Associate General Manager Fernando Paludi touched upon conservation incentives such as available rebates for removing turf (recently increased to \$3 per square foot) and for exchanging old sprinklers for new smart controllers that sense weather conditions. The agency will promote these and other options. "When armed with information, they [water consumers] tend to do the right thing," Paludi said.

Meanwhile, Dugan emphasized the idea of reducing consumption "in a creative way—not in a policing way" so that the end result isn't simply "shutting water off and killing landscaping." He also thought the City ought to look into the future viability of recycled water and grey water systems. Earlier during public communications, Tree Musketeers Executive Director Gail Church reminded the Council that El Segundo is home to the nation's largest water recycling plant (West Basin's facility on Hughes Way) and yet that water is not available for residential landscaping. "Recycled water is the long-term answer to a green El Segundo," she said. Church also maintained that "everyone needs a plan for

### Nick Kroll and Friends Grow Up in Adult Beginners

Opening at the ArcLight Hollywood this Friday is Adult Beginners, an adult-aimed comedy about struggling thirtysomethings trying to embrace and make sense of newfound grown-up living. It's light-hearted fare and an easy watch that will effortlessly entertain young audiences with its humor and heart. Just don't go into it expecting it to add anything new to the genre.

The film stars Nick Kroll as Jake, a young jerky entrepreneur seen living the good life

With no other options, Jake leaves New York to temporarily move in with his estranged and very pregnant sister Justine (Rose Byrne), brother-in-law (Bobby Cannavale) and three year old nephew. As a Big City transplant in the small-town suburbs, Jake prolongs his stay, becoming their "manny," looking after the kid with the hopes of grounding himself and figuring out next step. At this point, the movie leans into the comic hijinks of seeing Jake's self-centered sleazeball so hilariously taking care of the kid ensuing in the sort of

watering trees"-since grass can come back relatively quickly, but it can take "30 years to get new trees."

Before the Council makes a final ruling on the potential code updates, the City Attorney will first determine if the items in question must be imposed according to State mandate or can simply be local policy calls. Staff will come back in the coming weeks with a draft ordinance for consideration. While the State can issue cease and desist orders as well as impose hefty fines on cities for non-compliance, Katsouleas said she does not believe El Segundo is in danger of such action given its exemplary recycled water record (over half of all water used in town is recycled, with Chevron the primary user). She described El Segundo as the "poster child for the whole state for what water conservation should be."

Also on Tuesday, the Council approved another expansion of the permit parking zone in residential sections on the east side of town to alleviate the negative impacts of Sepulveda business employees who leave their cars in adjacent neighborhoods. Permit parking areas will now also include the 1400 and 1500 blocks of Maple Avenue, 700 block of California Street and 700 block of Washington Street. The City received signed petitions from a majority of residents on those streets favoring implementation. In voting for the item, Councilmember Dave Atkinson remarked that "residents here should have the right to park in front of their house." Realizing that the City can't force existing employers to provide parking, Councilmember Marie Fellhauer suggested to expand the current permit zone even further—since residents on other blocks will almost certainly make the request in the future anyway. Dugan felt that the latest Council move only treats the symptoms but not the root of the problem. He asked if the City can require employee parking provisions as part of future business permits issued in the area. Fellhauer said the City must strike a careful balance in setting any such regulations so as not to push a large business away from coming to town.

During Council reports, Jacobson received his colleagues' blessing to send a letter in support of Senate Bill 485 that would allow the Sanitation District of Los Angeles County to assist local jurisdictions in stormwater and dry weather runoff management projects. Fuentes asked staff to look into the process of establishing a committee to pave the way for El Segundo to have its own float during the 2017 Rose Parade—in celebration of the City's 100<sup>th</sup> anniversary. •





## **Lakers Season Ends How It Began**

Losing. That's what the Lakers did best during the 2014-2015 NBA season that ended last Wednesday night with a 122-99 loss to the Sacramento Kings at Staples Center in Los Angeles. Not only did the Lakers finish off their worst season in franchise history with 61 losses on the year, but the team also lost their rookie Julius Randle to injury

In order to get better, you have to get worse, to look at things optimistically. It's hard to believe that just five years ago, in 2010, the Lakers won their last championship. It's also hard to believe, however, that they will be back to anywhere near that same type of championship caliber anytime soon. Expect to see a completely different roster once again, though. The only players contractually guaranteed to

and lost Kobe Bryant once again: the Lakers even lost at winning this year. It was a rough year for fans of the Lakers and for the team itself, which lost its first five games of the season back in late October and early November. With another three-game losing streak to close out the season, the Lakers finished the season just the way it began, leaving everyone to wonder whether or not there is any hope for the future of this once prestigious franchise at all.

With golden championship banners hanging from the rafters and all of the glitz and glamour of Hollywood that surrounds, a Los Angeles Lakers team of nobodies and castoffs finished off the regular season dressed in purple and gold. Almost as if it was Halloween all over again, faces that were almost unrecognizable donned the purple and gold once worn by all-time greats and Hall of Famers like Magic Johnson, Kareem Abdul-Jabaar and Wilt Chamberlain. My, how these Lakers have come a long way. Magic and the Showtime Lakers could have won 21 games with their hands tied behind their backs and blindfolded, just to bring the crowd to their feet in an ovation once again. Well, this year there weren't many ovations at the Staple Center and what was left of the crowd at Staples Center was rarely brought to its feet, if ever. At least, for now, it's over. The optimism that inevitably comes with every Lakers offseason can now begin anew as fans dream of what the team may possibly look like next year.

"It obviously doesn't sit well with me," said head coach Byron Scott, who was hired on to coach a team that he knew would be bad. "I don't like the sound of that," he said referring to the 16-time NBA championship franchise's worst season ever in the history of its existence. "But it also makes for a remarkable story when we turn this around as well." There's nowhere to go but up for the Lakers now, though last year we thought it couldn't possibly get any worse when the Lakers finished at 27-55. With a 21-win season this year, not only did the Lakers get worse, but they also missed the playoffs for the second consecutive year for the first time since 1976 - the team's worst two-year stretch in all 67 seasons of existence. "It's embarrassing, but tough times build character," said Lakers forward Ryan Kelly. Tough times for the Lakers used to be missing the NBA Finals, not finishing as the fourth worst team in the league.

be back are Bryant, Nick Young, Randle and Kelly. Say goodbye to Jeremy Lin, say goodbye to Carlos Boozer and say goodbye to Jordan Hill. All three of those players will take their mediocre talent to the next most willing team to hand out money in order to fill out a roster. As the team's lone bright spot this past year, you will also certainly see Jordan Clarkson back. A team that can keep Clarkson, Bryant and Randle all on the court and healthy for at least 82 games sounds like the beginnings of a pretty decent team - at least compared to this year's standards.

In addition to Randle, Clarkson and what will hopefully be another high draft pick in this year's NBA Draft, the Lakers will have a lot of money to spend on free agents, as they did last year. Last year, they chose not to spend much. This year, the free agent crop is ripe for the picking and apparently the Lakers won't be shy about spending. Marc Gasol, Greg Monroe, Kevin Love, and Rajon Rondo, just to name a few, will be on the free agent market and could all fit in nicely with the Lakers. If you disagree, just look at what the team was working with this year. See? They'd all be upgrades. The Lakers have resisted the urge to just throw money at their problems to solve them thus far, but this year they will have to spend that money before NBA's new national TV contract with Turner and Disney hits in 2016, increasing the salary cap for every team in the league. "Two years from now, it looks like almost every team in the league is going to have cap room," Lakers GM Mitch Kupchak explained. "We do have a lot of cap room this summer. You can look at that as a strategic advantage, yeah."

It would be about time the Lakers had an advantage at anything, but it seems all signs are pointing to this offseason to get things turned around for the once prestigious franchise and that can make for an entertaining time for fans. Money will be spent, more young talent will be acquired and groomed and before you know it, the Lakers should be back to being the Lakers again as long as they avoid another Steve Nash, Dwight Howard debacle. Clearly, the Lakers have bottomed out with their worst season ever. If they stay bottomed out, it may be time for the Buss's to think about leaving office. But with the worst season ever officially done with and in the books, everyone can now start looking forward to an offseason that could and should be filled with promise for the purple and gold. •



## **Keep Your Pets Healthy During the Holidays**

Why should we be concerned in sunny California? Canine Influenza Virus, abbreviated CIV, has been found in every state. Most dogs have not been vaccinated for CIV and more dogs are enjoying day care and dog parks where respiratory infections can be easily transmitted. Southern California has experienced similar but fortunately smaller outbreaks of CIV in the past.

Canine influenza is a contagious viral disease that can spread quickly among dogs. It affects a dog's respiratory system and may cause serious illness. In the US, outbreaks of canine flu were first reported in 2004 and the virus has since spread across the country. CIV represents a very rare event in adaptive evolution; the entire genome of the H3N8 equine influenza virus was transferred to dogs, and the virus adapted to the canine species to emerge as a new canine-specific virus. Although the virus spreads readily from dog to dog, there is no evidence to support that it can be transmitted from dogs to humans.

Dogs have no natural immunity from the flu virus and dogs of any age or breed can get the disease. Canine influenza is caused by an H3N8 virus. Similar to human flu, it is contagious and is usually spread when dogs come into contact with infected dogs in places such as dog parks, at dog shows, boarding kennels, grooming facilities, veterinary hospitals, and humane shelters.

It is important to know and recognize the

signs of infection both in your dog and in other dogs that your dog may come into contact with. Some cases of canine flu may be mild and include signs such as: a persistent cough, sneezing, runny nose, fever, loss of appetite, and loss of energy. However, some dogs may develop a more severe disease, which could develop into pneumonia. If you notice any of these signs, it is important that you contact your veterinarian.

Virtually all dogs that are exposed become infected with the virus. Infection rates of 60% to 80% are not unusual and 10% to 20% of those dogs may develop severe disease. Deaths occur mainly in dogs with the severe form of the disease. The mortality rate is thought to be 1-5% or slightly higher.

Canine flu spreads through 3 main ways. First, through contact with infected dogs. Dogs that do not show signs of canine flu can still spread the virus to other dogs. Second, by airborne exposure, coughing, sneezing and runny nose. Third, by contact with contaminated items such as food and water bowls and toys.

Just as you take steps to protect yourself from the flu every year, it is also important to help protect your dog. Highly effective and affordable vaccines for canine flu are available to help protect dogs against this serious disease. Vaccinating against canine flu is beneficial by helping to prevent infection in your dog and reducing the spread of the infection. Talk to your veterinarian for more information about CIV and other preventable canine diseases.

balanced out other half, the more warm and honest reflections and admissions of young married and family life, which Jake is forced to confront with his sister, as well as with her and her husband's rocky moments.

There are whiffs of the Apatow-styled manchild hero that is forced to grow up in an age of stunted maturity epidemic that has grown to define the generation, but there is more of a connection to the 2011 feature Jeff Who Lives at Home and the HBO series Togetherness, both of which were made by the films producers, Jay and Mark Duplass (Duplass Brothers Productions). It's a watered down version of this Duplassian comedy, as half-laughs are given the same treatment as its dramatics, involving the expecting of children, infidelity, and commitment to family, that makes the film a very lukewarm experience comparatively.

Kroll and friends work as a strong, threepiece dynamic in a film that certainly needed each of its leads to be able to navigate the waters between playfully humorous and seriously relatable to earn this film's keep. Kroll as Jake dials in his slacker charms that make his character's story-about his ignoring of his sister and ailing mother while he was off making his dreams come true-that much more effective. Cameos by familiar-faced comedians Joel McHale and Jane Krakowski add a further touch of comedic do-gooding.

Applaudable strides are given to Kroll, who pushes himself here in more dramatic moments then he has in any other opportunity. For fans of the comedian's signature unconventional comedic stylings, they'll only be treated to the film's opening sequence: a fake commercial ad for his company "Minndsi," in which he's able to use the weird format to best serve his signature "Tim and Eric" chops, however briefly.

In the end, Adult Beginners isn't exactly proof of what a terrific low-budget festival-style film is, but what one inspired by those is. It's simultaneous meandering and heavy-handedness could come off more dissuading to others, such as its forced title into the story: "Adult Beginners," as it turns out, is a swimming class for the age-pushing crowd ("Get your feet wet!" is on the brochure, and an almost eye-rolling metaphor), and wouldn't you know - Jake and Justine were both never taught how to swim. Suffice it to say, the film's emotional climax centers around embracing family by reconciling differences, and jumping into the pool.

If you decide to take the plunge with Adult Beginners, just know that you won't be leaving the shallow end - but you might end up still having a little fun anyways. Adult Beginners is Rated R for language and some drug use. •


