## Photography and Passion: Tom Cocking at UNITA

Tucked away within a row of houses at 215 Arena St. is a cozy, bohemian building filled with entrepreneurs, freelancers, and artists. Tom Cocking, the Community Manager at UNITA, is also one of them.

Working as a photographer, Cocking stumbled upon UNITA by happenstance. “I was neighbors with one of the owners, Ego, and when the office in El Segundo opened up, he invited me to work there to help further my success in photography.”

Ego Alpay, an ex-professional basketball player from Turkey, started UNITA with a dream to provide artists with a collective environment to share ideas, art, and success. Tom has become an integral part of that community, and the best part is that his involvement still allows him to pursue his ultimate dream.

“At first, he didn’t really offer me a job,” Cocking explains. “Ego wanted me to hang my photos on the wall to potentially sell them to clients or others working in the office. And then he asked me if I would be interested in being there full-time - meaning that he would pay me to manage the location. I could sell my photos and then also work on my photography business. It was an unbelievable opportunity for me because being a freelance artist, especially coming out of the COVID-19 pandemic, was extremely hard.”

Originally working as a second-grade teacher at a private school, Cocking only dabbled with photography on the side. “I would make a little bit of money here and there, taking senior portraits or shooting a friend’s headshots, but I wasn’t committed to it enough to make a living.” Which proves to

be the greatest dilemma for anyone who has a passion they’re not sure how to monetize yet.

There is a struggle between time and commitment that dictates how successful one can be at something they love to do. For instance, Cocking wanted to pursue his photography full-time, but how could he do that with bills piling up? How could he take the risk to leave his old job and step into the uncertain world of booking clients and gaining popularity in something creative?

“It’s the classic ‘chicken or the egg’ question,” says Cocking. “I was ready to stop teaching, but I wasn’t ready to completely dive into being an artist. But how could I make the transition? Would I have to quit my job first and then go all in with photography? Or should I wait until I’m at a point where my photos are selling well, and then I can quit my job? Will I ever realize the point when making the jump is safe?” Thankfully, Cocking was presented with a third option - UNITA.

The opportunity to oversee the community at UNITA allowed Tom to gain a steady paycheck while focusing entirely on his passion. Yes, there are the occasional tours he has to give to new members, refilling coffee machines, or making sure the wifi is up and running, but the benefits he gains go well beyond the regret of living safely in the past.

“One of the greatest things about the space in El Segundo is the professional photo studio. It has a large cyclorama wall for fashion and product shoots, and there are tons of colorful backdrops to use for models, headshots, commercial photography – it’s been a tremendous perk that I can offer my clients.”

Cocking is a talented photographer who works primarily for brands of all sizes. He

One of his favorite events that he works every year is the well-known BeachLife Festival for the city of Redondo Beach.

“I’ve become friends with the festival runners there, and every year, it proves to be something fun that allows me to capture photos the way I want. I love music, and I love the crowds, and I’m just so fortunate to be at a place in my life where I can thrive at doing something that makes me happy.”

Cocking relates a lot of his success to his relationship with UNITA. It’s a place where creative minds come together and feed off each other in a way that a traditional office doesn’t support. “I owe a lot to the community here. It’s given me the freedom to be more like myself, and I’m honored to share that feeling with others who are looking for a way to pursue their purpose”.

## Jason Parker

Jason "Coach" Parker of El Segundo, California passed away on April 13, 2023 at Imperial Crest Healthcare Center.

Jason was born on September 5, 1966 to Rae and Richard Parker in Fort Lewis, Washington and, after his father left the army in 1975, Jason's family finally settled in Yakima, Washington. From grade school through high school, Jason played sports year-round and would eventually varsity in football, basketball, wrestling, and baseball.

After he graduated from Eisenhower High School in 1984, Jason played football at Yakima Valley Community College before moving permanently to Los Angeles where he immediately fell in love with the city, the climate, the beaches, and ultimately the



students he would coach.

Jason attended California State University, Dominguez Hills before working as an Athletic Trainer at ESPN Rise, a bartender at the Stick and Stein, and coach at El Segundo High School where, over the course of 25 years, he coached football, wrestling, baseball, softball, and track, and was also instrumental in the year-round weightlifting program for ES athletes.

Jason was predeceased by his mother and aunt. He is survived by his father, brother, sister-in-law, niece, nephew, and numerous aunts, uncles, and cousins.

Services will be held at Hazeltine Field, ESHS on Saturday May 6 at 10:00 with refreshments to follow. •

# Empowering Those with Dementia

Parents who want the best for their kids work hard to create experiences for their children to learn. As the children become more capable, parents increase the level of challenge and empower their kids to learn and grow more independently. These parents strive to raise self-sufficient adults who embark on their journey through life with confidence and a sense of self-worth.

Caring for adults with dementia effectively reverses the experience. Although dementia is complex and comes with many different facets, memory loss is the most notable aspect of the condition. As the disease progresses, our loved ones become less capable and require more assistance each year. Sometimes we forget that they also need challenging experiences to help them feel self-sufficient, especially when they are the parents who raised us to be independent ourselves.

The deterioration from dementia manifests in countless ways, including masking the symptoms from others to hide the extent of their impairment or adding memory devices like sticky notes around the house. We readily ascribe these behaviors to ways of clinging to independence, but these behaviors are also symptoms of feeling less worthy, less confident, and more vulnerable.

We can help our loved ones improve their sense of usefulness and self-worth by finding ways to empower them to do a wide variety of activities consistent with their level of impairment. As the disease progresses, we must lower our expectations rather than increase them as we would with raising children.

Empowering adults with dementia can often feel discouraging because we know their capacity will not grow alongside our efforts, but we must try. We must also control our emotions and not react in ways that increase



The El Segundo Eagles needed a good week to make a difference, with the CIF playoff pairings coming out soon. The boys' volleyball team honored their seniors before securing their seventh league title since 2010. The baseball team split their games with South Torrance to set up must wins this week against Lawndale, while the softball team got a much-needed win at South Torrance.

### Volleyball Team Wins Pioneer League Title

Before the Eagles rolled to a 25-14, 25-14, 25-16 three-game sweep of the Lawndale Cardinals, the program honored their seniors and their families in a pre-game ceremony. The six seniors honored included Lukas Lubs, Daniel Escobar, Nolan Kelly, Jett Antell, Connor Logan, and Ethan Dea.

In game one, the Eagles got out to a 6-2 lead with a hit by Ethan Dea. But the stubborn Lawndale Cardinals wouldn't back down and kept the game close until Daniel Escobar pounded a point past the defense for a 19-11 advantage. Dylan Pilkvist put the game away with his thunderous hit. In game two, Nolan Kelly passed a volley that gave the Eagles a 15-9 lead. His ace gave the Eagles a 20-10 lead, and Dea's hit ended the game. In the third game, Daniel Escobar had back-to-back aces to stretch El Segundo's lead to 15-7 on their way to an easy 25-16 win.

The Eagles, the third seed in the CIF Southern Section Division 3 playoffs, open their playoff run today at 6 p.m. against La Serna, the second-place team from the Del Rio League. Should El Segundo win, the

anxiety over progressive memory loss. People with dementia have so many emotional battles of their own to fight, and it can be calming and encouraging to see their loved ones with strong, positive attitudes.

Good memory care homes that our focused on memory care will have the resources to empower residents with daily meaningful tasks and stimulating activities. To the greatest extent possible, experiences will be crafted based on the residents' lifelong occupations, interests, and hobbies. Finding safe but meaningful activities like this is a great way to start restoring a lost sense of purpose for your loved ones as they struggle with dementia.

Here are additional useful tools to help empower a loved one with dementia: Establish daily routines which reduce anxiety, outline ex-

pectations and promote ease and independence; Encourage that they write in a daily journal; Set reminders for their appointments or daily tasks; Assign appropriate but necessary tasks toward self-care to encourage self-worth; Label cabinets to indicate the location of personal care items, dishes, or pantry items; Keep important objects (e.g., wallet, purse, and house keys) in the same place; and read a daily newspaper or find news online to stay current with events.

All these tools can help to live in the here-and-now, reduce confusion, independence, and as such, self-sufficiency and self-esteem. No matter what condition a person is battling, it is vital to their quality of life that they believe in themselves and their self-worth. If we can help our loved ones feel good about themselves, we make their whole lives better. •

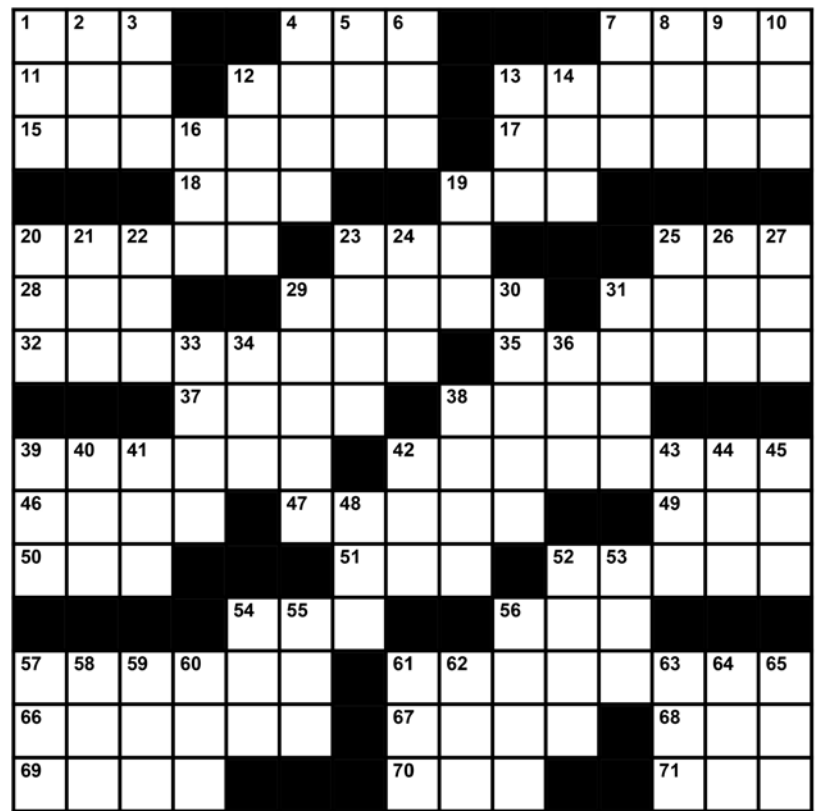

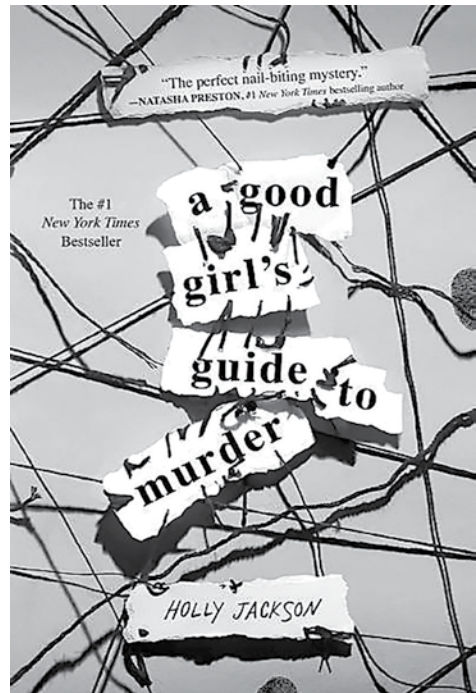

### A Good Girl's Guide to Murder by Holly Jackson

*A Good Girl's Guide to Murder* by Holly Jackson is the first of a trilogy starring Pip Fitz-Amboi. It is a YA mystery with a really great twist. Everyone in Fairview knows the



story of what happened to Andie Bell, and it is all the buzz in town, even five years later. Pip is a high school senior who needs to complete a Capstone Project to graduate. She has always liked mysteries and decides to open an investigation on the disappearance and presumed death of Andie Bell. Everyone, including the police, assumed Andie died five years earlier, but her body was never found. The entire town thought the murderer was her boyfriend, Sal Singh, who supposedly committed suicide shortly after Andie went missing. Sal supposedly left a suicide text on his Dad's phone confessing to the murder. Despite all the evidence, Pip doesn't believe that Sal did it. She starts investigating Andie's disappearance and tries to figure out who Andie really was as a person and why she disappeared. Pip is an overachiever who just wants to find out what really happened to Andie.

Pippa Fitz-Amobi's investigation into Andie Bell's murder begins as a simple proposal but quickly turns into an in-depth investigation full of unexpected twists and turns. After teaming up with Sal Singh's younger brother Ravi, the pair spiral into a web of danger and obsession, and quickly wonder if they've gotten themselves in too deep.

Pip begins her investigation by researching Andie and what type of person she was. Everyone thinks of Andie as being a pretty, popular girl with many friends and one of the rulers of the school. Pip begins to get a different picture of Andie when she starts questioning Andie's friends and reading past articles and social media about Andie. Pip begins to set up a murder board and keep a journal outlining who Andie really is and why someone would want to kill her. Ravi helps Pip investigate others through all of the twists and turns into the investigation.

Just when Pip thinks she knows who really killed Andie, she finds another suspect. I like that Pip sets up her investigation to mirror how true crime investigators set up theirs. Does Pip find out who really killed Andie? Was Sal the killer after all? Read the book to find out!

I really enjoyed the book a lot! It's a combination of a good murder mystery and a true crime podcast. The book reads as if you are investigating alongside the main characters, and the multimedia formatting wittily engages the reader from beginning to end. If you enjoy a grounded, engaging mystery that features a diverse cast, discussions surrounding racial injustice, and the tight bonds of friendship, this is the book for you!

### Norwegian Comedy Sick of Myself Abounds With Unhinged Narcissim

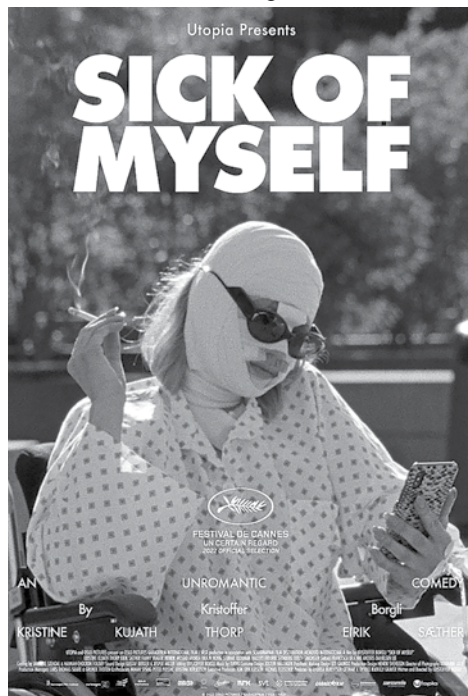

From the producers of Joachim Trier's Academy Award-nominated film, *The Worst Person in the World* comes *Sick of Myself* (*Syk Pike*). Norwegian-born filmmaker Kristoffer Borgli takes twisted relationship dynamics to extreme lengths in this dark, demented comedy about the "actual" worst person in the world and their no-holds-barred addiction to sympathy. Nominated for the Un Certain Regard Award at the

2022 Cannes Film Festival, *Sick of Myself* is a 97-minute-long insanity spiral and a nihilist's delight.

Kristine Kujath Thorp plays Signe, a woman in her early twenties who has the emotional maturity of a toddler. Signe and her boyfriend Thomas (Eirik Sæther)—another stunted adult—have a rather unconventional relationship; despite presenting a compassionate and fun-loving facade, the duo vindictively takes any opportunity to outshine and undercut their partner. When the film begins, the stakes already seem high but turns out that stealing a \$2,300 vintage bottle of wine is just the beginning.

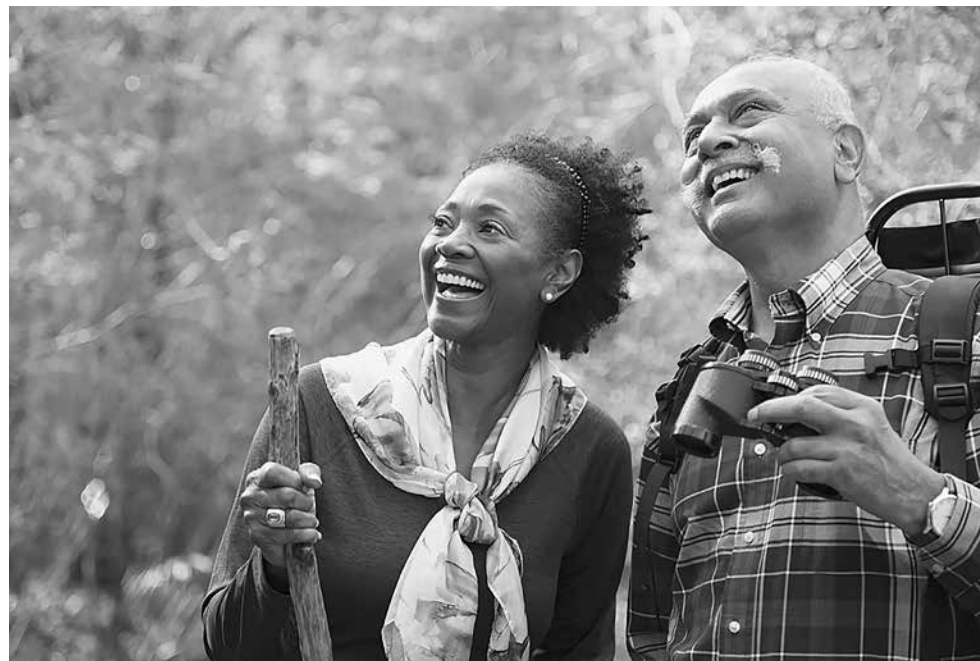

It doesn't matter from who, as long as it's her name is in the mouths of their friends, and not Thomas'. Things take a nasty turn when Signe realizes that feigning an illness may be her golden ticket to notoriety.

From beginning to end, *Sick of Myself* is an unhinged black comedy fueled by gaslighting of the highest degree. Kristine Kujath Thorp's performance is praiseworthy and her complex villain origin story is one we love to hate. The rest of the cast equally holds their own, including a short guest appearance

by Norway's finest, Anders Danielsen Lie.

With *Sick of Myself*, Kristoffer Borgli has solidified himself as a director to watch. Although, he's far from new on the scene with over 10 short film credits on his IMDb. Born in Oslo, his childhood revolved around skateboarding and making videos (not unlike our other favorite Norwegian filmmaker). It's this effortless confidence behind the lens and strong directorial point of view that makes *Sick of Myself* one of the most exciting films of the year thus far.
