Interim Fire Chief Appointment Cause Public Comment from Resident and Retired Firefighter

The El Segundo City Council tackled some heavy topics at its regularly scheduled meeting last Tuesday night, including appointing an interim fire chief that sparked commentary from a resident, a Community At Large report from the city's Diversity, Equity, and Inclusion Committee that mentioned residential outcry at having a DEI committee, and nonprofits in the city asking the city to help them financially.

While the appointment of Los Alamitos resident Robert Espinosa, a former fire chief who retired from the City of Manhattan Beach in 2018, sparked lengthy oppositional commentary from Jim Boulgarides, himself a previous El Segundo city council member from 2004-2008, the interim appointment of David Cain as the chief financial officer to fill the gap left by departing CFO Joe Lillio, who is moving on to the City of Burbank, did not elicit any public comment.

During the Public Comment portion of the meeting, Boulgarides took to the microphone to offer his input: "I want to speak to the agenda item on the hiring of the interim fire chief Robert Espinosa—just a couple of things. I'd like to start, I'd like to talk for a minute about how we got here, and why we're hiring an interim fire chief. I remember when I got the invitation, December 7, 2021, at 3 p.m. over on the apron of Fire Station 1, they had the badge ceremony for Fire Chief Deena Lee. After decades of service in the department, she achieved her dream job. And she was the fire chief. And I think that was one of the best decisions this city ever made. I mean, you had a trailblazer; she had her program to encourage young women to get into the fire service. I think she was a feather

in your cap. And then I have to ask myself, why less than two years later, achieving her dream job, is she gone? And what does that mean for the city? And then you consider that she was three years from maxing out her retirement, and it wasn't a lightly taken decision. I spent 25 years, 26ish, and retired from the fire service, so I know what that means. And I think the reason she left, and it's more than hearsay. I've spoken with her, and she wouldn't tell this you herself, but I don't think she wanted to watch the dismantlement of her beloved fire department. And there's been some real substantive cuts, and I don't think she wanted to have to sit and justify them to the public. And so she walked away from a job that I know she loved and I know she was proud to have, and I think that she was a trailblazer. And I think it's a loss. I think it's a loss to the city.

"And then I'd like to just remark for a second on what brings people to El Segundo. And there are a couple of big things, banners that we stake our city on. And one of them is our schools, and one of them is our public safety. And trust me, I don't wanna; I mean, this is the second time I've been in this chamber in three weeks, and my poor wife is going, 'Oh my god, you're not running again, right?' and I just saw Mr. Hensley (city attorney), and he goes, 'By god, you know, three times in two weeks and it's been 15 years.' And I go, 'No, not running for anything. All I want to do is drink coffee and coach Babe Ruth.' I don't want to come back here and keep bothering you guys, but this is something that I knew I'd regret if I didn't come and talk to you about it. And I don't expect to agree with you guys every time. We had this conversation before you

ran for council member Giroux. If I wanted to agree with a council member every time, I'd run again. You guys are gonna make your best judgment. I think maybe there's something you haven't considered in this particular appointment. Of course, you need an interim fire chief.

"I'm assuming that you guys all know that he walked away from Manhattan Beach after he got a vote of 'No confidence' from the Manhattan Beach firefighters. I've been in the industry for decades. I've never heard of that happening before. And this isn't a remote department, Manhattan Beach, as we all know, is next door. They run calls with these guys. They go into house fires with them. They're their brothers and sisters in arms. OK. This is, as you know because god knows we've been talking a lot about mutual aid as we make cuts here. Those are the guys that are going to be coming in; we go into their city. And for you to take a guy that their brother and sister firefighters had no confidence in, and this is a guy already drawing a pension, and you know to pay him \$18,000 a month to come here and take over your fire department, I don't think you realize, maybe you don't, that that to your firefighters, it's just going to feel like one more kick in the teeth. Yeah, you've gotta fill that spot. It doesn't have to be him. OK. It doesn't have to be him. He's drawing a pension. He's done fine. He walked away. He walked away after his firefighters had no confidence in him. If he's not good enough for the firefighters of Manhattan Beach, I don't think he's good enough for your firefighters here in El Segundo. So, throw 'em a bone, maybe. Show 'em you do still support them.

Eagles are Playoff Bound

As busy and active as the spring high school sports scene has been, the Eagles will be busy this week playing in the CIF Southern Section playoffs. The volleyball team advanced to the third round with a couple of first two-round victories. The boy's tennis team is heading to the playoffs as a team for the first time in several seasons. The baseball is expected to draw a playoff berth after their sweep of Lawndale. The softball team got into the playoffs, and the boy's lacrosse team drew a favorable first-round opponent.

Volleyball Team Advances to Third Round

The third-seeded Eagles have swept their way into the quarterfinals of the CIF-SS Division 3 playoffs. In the opening round, the Eagles were in complete control over La Serna and came away with a 25-14, 25-13, and 25-16 win. Then they went on to throttle Warren 25-17, 25-18, and 25-17 to reach the quarterfinals.

It was a relatively easy win for El Segundo over a team that had a 20-win season the year before and had plenty of returners back. The Lancers really posed no threat to the Eagles, whose net play overwhelmed their guests.

The win sent the Eagles into the second round against the Warren Bears, the Gateway League champions, who went undefeated in league play. In the pre-game warm-ups, El Segundo showed off their thunderous hits that must have been somewhat intimidating to their opponents.

Sophomore Ryan Pilkvist had a big say in the first game. His hit gave the Eagles a 14-9 advantage after the Bears were creeping back into the game. His block gave his team a 23-16 lead, and the Eagles went on to win game one.

In the second game, the two teams played a close match with four lead changes and extended rallies. Jackson Brenneman helped rally his team and take a 13-12 lead, and the Eagles never looked back. After a long extended exhausting rally, Ryan Pilkvist put away a point to give the Eagles a comfortable 17-13 lead. His game-ending hit gave the Eagles a 25-18 win.

Game three went as expected as the Eagles wore down Warren's attack. Nolan Kelly's serves were tough to handle, and the front line made it a challenge to score. Brenneman had a couple of blocks, and Kelly Escobar's ace ended the game and sent the Eagles into the quarterfinals against Vista Murrieta on Tuesday. A win would send them into the CIF semi-finals tonight, with the finals set for Saturday.

Tennis Team Advances to CIF

As a tennis team, the Eagles finished as co-league champions with South Torrance in the Pioneer League. This marks the first time in a number of years that that team has made it to the CIF Team Playoffs.

"The boys' have been putting in the time and effort, and it's paid off. The addition of Assistant Coach Paul Rayburn and our team managers from the girls' team has been the key to our success," explained head coach Bonnie Maye. In addition, freshman Shane Hines, and the team of sophomore, Caleb Tsai, and freshman Aarush Antil will be representing the Eagles in the CIF Individual Tournament that begins after the end of the CIF Team Tournament. "The team has put incredible amounts of effort and time in, and it is paying off. The commitment that they made has been the turning point," said Coach Maye.







help relate the story to historical context and provide more resources for interested readers.






Film Review

Moonage Daydream is a Stunning Portrait of David Bowie, Now Streaming on HBO Max

They say never meet your heroes. Unfortunately, I'll never have the chance to meet one of mine. The world changed on January 10, 2016, when the news of David Bowie's death stunned everyone who knew and loved him. If you listened closely, you could hear the collective gasp from fans worldwide as we sat in disbelief. How could he be gone when, just two days earlier, his 26th studio

album – Blackstar – was released? It wasn't fair. Bowie was one of those rare artists who only got better with time. And now we were to be robbed of what genius he could have contributed in his golden years. *Moonage Daydream* may be the closest thing we'll get to having another Bowie experience, and that's reason enough to consider this documentary a treasure.

Director Brett Morgen's (*The Kid Stays in the Picture, Kurt Cobain: Montage of Heck, Jane*) kaleidoscopic retrospective of one of the greatest artists of our time is an amalgamation of sight, sound, and spirit. The film premiered at this year's Cannes Film Festival and more recently, crossed the pond with screenings at TIFF, before opening in theaters last Friday. Unlike a traditional biopic, which can be hard to tonally get right, *Moonage Daydream* plays

like a video collage of rare concert footage, TV talkshow appearances, and behind the scenes moments. It truly is David Bowie like you've never seen him before. Plus, this is the only officially sanctioned film from the Bowie estate (which says a lot).

Moonage Daydream is so whimsical that, for a moment, it's easy to forget Bowie himself isn't calling the shots behind the lens. Morgen channels his protagonists' energy and playfulness by breaking the "rules" of traditional documentary storytelling. There is no beginning, middle, or end here. Rather, we jump forward and back in time, onstage and off, creating intimate controlled chaos. Visually, it's stunning. And sonically, it's outstanding. Long-time collaborator, friend, and music producer Tony Visconti and Academy Award-winning sound mixer Paul Massey (Bohemian Rhapsody) remixed and translated Bowie's original stems for theaters in 12.0, 5.0, Atmos, and 7.1/5.1. That's nerd talk for: see it in an IMAX theater if possible!


Running 2 hours and 15 minutes, *Moonage Daydream* is the furthest thing from a sleepy affair. Prepare for a full-body adrenaline rush as your mind attempts to wrap around a technicolor explosion of the senses. You don't have to be a David Bowie fan to appreciate the film either; although there is a high chance you will be converted into one by the end credits. *Moonage Daydream* is a love letter to a hero who continues to inspire us, even in the afterlife.

Need a Small Loan? Make Sure You're Not Adding to Your Financial Woes

(BPT) - April is Financial Literacy Month, and it's an opportunity for people to take a closer look at their finances and be smart about their money. However, being unable to pay back your secured loan could result in losing access to the property you put up as collateral - such as your vehicle - which creates even more challenges, especially if you need your vehicle to get to work.

Unsecured loans place a greater risk on the lender, since the borrower does not provide collateral. To account for that risk, lenders may offer unsecured personal loans in smaller amounts, charge higher annual percentage rates (APRs) and/or require the borrower to have a much higher credit score to qualify. These requirements can create barriers to accessing or building credit for anyone who is financially struggling.

To find out how much these products can really set you back, a 2022 analysis by the Financial Health Network, "The True Cost of a Loan," compares six financial products - payday loans, online-only payday loans, rent-to-own, installment loans, online-only installment loans and single-pay auto title loans - to unsecured installment loans from Oportun to estimate the total cost of these products to typical borrowers.

The study showed that even short-term, small-amount loans can end up being very expensive to borrowers in the long term, especially when compared to loans from Oportun. Overall, Oportun loans can be significantly less costly than alternative products, as they often have lower rates and more affordable terms than many other choices on the market.

The Unsung Hero Behind Mortgage Lending in America

(BPT) - If you've ever purchased a home, you've probably at least considered a 30-year fixed-rate mortgage. It's the most popular type of mortgage loan in the U.S. But this wasn't always the case. The 30-year mortgage was a product of the Great Depression - and the Federal Home Loan Bank System, which was formed more than 90 years ago to help increase homeownership in America, was a key player in bringing it to fruition.

The FHLBank System was created by the federal government in 1932 to promote mortgage lending by thrifts and insurance companies in response to the economic devastation of the Great Depression. Previously, mortgages typically could be "called due" after three to five years if the bank didn't choose to extend, resulting in the demand for a balloon payment. Obviously, this would wreak havoc during a financial crisis, and the new FHLBank System began working to support the creation of a true 30-year fixed-rate, fully amortizing mortgage loan (meaning a loan with the principal and interest paid down via equal payments over the life of the loan), that would provide more stability for everyone.

Today, the 11 regional FHLBanks continue to support homeownership and mortgage market stability by providing member financial institutions with reliable liquidity - the ability to quickly access cash when it's needed - in the form of low-cost loans, which in turn facilitate lending at the community level. FHLBank System lending benefits lenders, homeowners and local communities in three key ways.

• Providing consistent, low-cost liquidity that reduces the cost of borrowing for both businesses and consumers. Lenders need money to lend, and the less they are required to pay for the money they lend (referred to as liquidity), the greater the savings they can pass on to borrowers. Although the FHLBank System is overseen by the Federal Housing Finance Agency, the FHLBanks themselves are private cooperatives owned and supplied with capital by their members, receiving no government funding. As cooperatives, they pay no income tax, have moderate overhead, and the loans to members are low risk because they are fully collateralized. As a result, the FHLBanks are able to offer lowinterest loans that help reduce the overall cost of borrowing - saving homeowners as much as \$17 billion in interest payments each year, according to a recent University of Wisconsin study.

• Enabling community lenders to keep loans on their books. The ability of member institutions to obtain liquidity through loans from their FHLBank using mortgages and mortgage-backed securities as collateral gives community lenders the confidence to provide mortgage loans and hold mortgages long term rather than selling them on the secondary market. When local lenders keep home loans on their books and service them from start to finish, borrowers benefit as well, since their banker is better able to get to know their particular situation and work with them if their circumstances change suddenly. "We saw the clear benefit of this approach during the Great Recession," said Teresa Bryce Bazemore, president and CEO of FHLBank San Francisco. "Borrowers still need to be qualified and uphold their obligations, but if we can help people through tough times and they fully repay their loan, that's far better for them, for their bank or credit union, and for the community as a whole - than letting them default and lose their home."

· Boosting community lending. Low-cost liquidity enables community lenders to invest in mortgage-backed securities, making more money available for home loans generally,

and also levels the playing field, allowing community lenders to better compete with larger institutions and giving them more opportunity to draw on their deep knowledge of local credit needs. When local institutions have access to the liquidity they need, they can more effectively respond as the credit needs of their community evolve. Ultimately this results in more home, business, and economic development lending that grows local economies.

You may never have heard of the FHLBanks, but they play an important behind-the-scenes role in keeping money flowing within the mortgage lending and banking system, making sure that community lenders have the liquidity they need to support housing finance and community investment. While the housing and financial markets are in constant evolution, and housing affordability continues to be a critical concern across the country, the FHLBanks' efforts - from the initial work facilitating a true 30-year mortgage to helping keep local lenders in our communities today - have played a pivotal role in fueling community lending and helped millions of families achieve their dream of homeownership. •

City Council unanimously voted to approve Espinosa's appointment as interim fire chief after council member Ryan Baldino asked City Manager Darrell George if he had interviewed the proposed interim fire chief and if he'd done his due diligence, and if he believed in his judgment that Espinosa is the right choice and he answered affirmatively. Baldino also elicited the information that the only reason the interim fire chief appointment was coming before the city council was because CalPers has certain requirements when a city is hiring retired CalPers members as interim staff.
