## Flags Show Main Street Strong

From waves crashing to planes landing, El Segundo is a town constantly surrounded by movement. And with so many people coming in and out each day, it is important what makes El Segundo stand out: the community. According to El Segundo resident and prominent realtor Bill Ruane, this has never been more important. As the #2 Re/Max Agent nationwide, Ruane makes a point to show his support to the city he calls home and contributes to the town and residents in any way he can.

Fourth of July is Ruane's favorite holiday, not just for the history behind it but also for the response from the community. From celebrations at Rec Park, including fireworks and watermelon eating contests to live entertainment, these events bring the community together, Ruane explained. They demonstrate just how important the relationships between the people of El Segundo are. After all, in a small city like El Segundo, it is these relationships between anybody and everybody who comes through the city that make El Segundo special. And more importantly, it is these relationships that keep El Segundo strong.

This Fourth of July, Ruane will put American flags outside as many businesses on Main Street that would like to participate, a gesture aimed at showing the strength among El Segundo residents and businesses in light of the recent string of burglaries on Main Street last March, which left several businesses damaged and burglarized. Although Ruane noted how he observed an immedi-

ate response from the city and the ESPD, explaining how all of the damaged property was replaced by city officials within a few hours of the initial break-ins, Ruane himself has three Re/Max offices in town, the largest of which is on Main Street, which is why they hit so close to home as a resident and as a business owner. Ruane hopes business owners on Main Street are able to keep these flags up year-round, with the goal of putting up El Segundo flags also. This way, Ruane explains, it isn't so much a temporary symbol of unity, but one that always stands.

Ruane was drawn to use U.S. flags after attending a funeral for the father of an ESPD officer he knew, noting their use of red, white, and blue lights during the tribute "was really inspirational." In that, his goal to bring that same feeling to Main Street is not only meant to uplift the community, but also promote the neighborly All-American feeling. The response from the community at the time of the break-ins represented just how strong the community of El Segundo is, and the flags give the opportunity to continue that.

## City Council Hears About Housing and Business Growth

This article continues coverage of the May 2, 2023, El Segundo City Council meeting that pertained to ESEDC findings. Daniel Martin, ESEDC vice president/secretary and president of Paolucci Salling & Martin Communication Arts, provided an update from the El Segundo Economic Development Advisory Council (ESEDC).

Notably, ESEDC was formed "to guide the City's efforts to attract, retain and grow businesses in the community" and "The El Segundo Economic Development Corporation (ESEDC) works to identify, support and drive key initiatives forward that are of critical importance to the city's leading businesses and then to act as a

bridge in communicating those interests to the City Council and the community at large."

ESEDC's three priority initiatives are Lifestyle, Amenities, and Connectivity; Diversity, Equity, and Inclusion; and Expanded Housing Opportunities, he identified during the presentation to the city council.

Said Martin during the presentation, "As you know, the ESEDC has been working with the partnership of some of what I consider to be the great brands, some of the great companies of El Segundo. And we've had the distinct honor of having time with the board of governors and

No, they'll join hundreds of other El Segundo high school seniors who'll continue the next step in their yearning for higher education but with one added element. These students are athletes, too, and will be playing a sport in college. These last four years are the culmination of hard work in both the classroom and on the field of play, and it has paid off in the form of a scholarship.

To be a student-athlete in high school is one thing. To continue that drive, ambition, and passion for playing a sport at the collegiate level while concentrating on a potential degree is only reserved for some.

Brett Abitante, Owen Frank, Stephanie Rodriguez, Leo Menendez, and Alec Dominick convened in a room filled with family, friends, teachers, and coaches to sign their college Letters of Intent. Sitting in a room with these student-athletes, you have to marvel at their poise, articulate demeanor, and how they have grown into young adults. To think that a mere four years ago, they were scared freshmen. In June, they will walk up proudly for their high school degree. During their strut toward the School Superintendent, they will each display a wide grin with the knowledge that their future plans include continuing their passion for competing on the playing field while earning their degree.

**Brett Abitante, Chapman University (Football)**

Brett was a standout three-year starter for the Eagles, playing in the secondary on

defense. His unselfish style of play, work ethic, and leadership skills should help the Chapman Panthers continue their success.

In his three years as a starting defensive back, Brett was named to the All-Pioneer League first team, named the team's Most Valuable Player, and named to the Lions All-Star team. As a junior and again as a senior, he was the second-leading tackler. He says

one of his favorite memories was making an over-the-shoulder catch for a 56-yard catch and run touchdown in the Homecoming game; It evened the score at 21-21.

Brett, who has been an honor roll student all four years, will work on earning a computer science degree. He says he is grateful for his family's support and would like to thank the community for the support over the years.

**Owen Frank, Colorado Mesa University (Cross Country)**

Owen is one of those shy athletes who compete at a high level. He has been running for the Eagles all four years. His senior year may have been his breakout season when he averaged 5:25 per mile in his five races, ranking him second on the team. His 4:28 mile was a personal best and a highlight of his career.

He'll take his running skills and the knowledge he learned from his teacher/coach Marcos Bolanos to Colorado Mesa University and help the Mavericks to greater heights. His 4.0 GPA over the last two years will help him continue his drive for an Economic Engineering degree.

**Stephanie Rodriguez, Biola University (Water Polo)**

Behind that eye-catching infectious smile is one of the most competitive athletes you'll

meet. Stephanie is one of those special water polo athletes that made her teammates better. She's been a four-year starter and, in that time, has amassed a school record 92 sprint wins, two-time Most Outstanding Defensive Player of the Year awards, led the Eagles to consecutive league championships, and helped her team to a CIF title.

Her four years as an honor roll student reflect how committed she is. It will certainly help during her collegiate career at Biola playing for the Eagles. She will join a team that qualified for the 2023 National Collegiate Women's Water Polo Championships.

Stephanie says her favorite moment was celebrating the Eagle's CIF championship with her teammates as a junior. She added that her success is tied to her family, friends, coaches, and teammates who, with their support, made her better in every facet of her young life. "I want to take this opportunity to thank all of them."

**Leonel Menendez, Lawrence University (Football)**

Leo led the Eagles for three years and will look to take his quarterbacking skills to Lawrence University, located in Wisconsin, to play for the Vikings. He says his favorite high school memory is Homecoming Week, with all the energy involved that leads up to the game. Leo was injured in his sophomore year during a Covid-shortened schedule; the last two seasons, he tossed for over 3500 yards. He was named the team's Most Valuable Player this past season.

He will take his Honor Society status in academics to Lawrence University to study Political Science, hoping to lead the Vikings to winning ways on Saturdays. He says he

appreciated the community's support throughout the ups and downs and had a great time playing quarterback.

**Alec Dominick, Westminster College (Men's Lacrosse)**

Alec has been playing lacrosse for five years, and in that time, he excelled in a sport that he accidentally got involved in. At the urging of his mother, Heidi, who signed him up to play lacrosse, Alec's fondness for playing football became a memory with his newfound love for lacrosse.

Alec is a four-year starter for the Eagles and has been named the team's captain as a junior and senior. He has helped lead the Eagles to the CIF Southern Section playoffs this season. He says his favorite moment was an easy question. "Scoring my first goal on Senior Night without a doubt." When pressed on why that was his favorite moment, he said it was because he is a defenseman, and it felt so right. He is looking to add another award to his 2022 Coach's Award, which he won as a junior at the end of the season.

Alec will take his defensive skills to Westminster College and play for a competitive Titan's team that routinely vies for a conference championship while studying for his psychology degree.

So, there you have it, five very special students who are also very talented athletes. Their focus in the classroom and the discipline of a competitive athlete equals a person with plenty of success in the future.

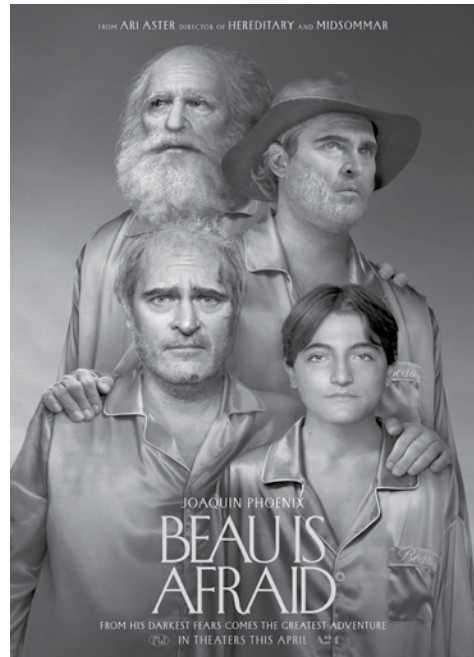

## Film Review

### Beau Is Afraid Is An Odyssey of Anxiety

Film director Michelangelo Antonioni once said, "A film that can be described in words is not really a film." Since it's nearly impossible to describe the new dark comedy *Beau Is Afraid* (now playing in theaters nationwide), I suppose that makes this a film with a capital "F."

*Beau Is Afraid* is the story of one helplessly fear-stricken man's stress-inducing, anxiety-ridden, paranoia-packed odyssey to see his late mother amidst the threats of a harrowing world. Written and directed by Ari Aster, the film is equal parts absurd and visually astounding, and by its end will leave audiences speechless and confounded as to what they just experienced.

Beau (Joaquin Phoenix) is a sensitive, inept sadsack who lives in a comically uninhabitable version of New York's inner-city, constantly evading a world of psychos who threaten his everyday life. As Beau's misfortune would have it, on the day he is to visit his doting mother (who he admits smothered him since he was a child during a therapy session in the film's opening scene), he loses his keys, leaving him helpless to break the news that he is to stay home. When he receives the news of her unexpected demise just one day later, against all of his fears, he sets forth to journey to her through a world of dangers that lie in front of him.

*Beau Is Afraid* is a big bundle of childhood anxieties and unprocessed emotions wrapped up in a 2-hour and 59-minute runtime. It's also a fascinating journey through many imaginative and distinct worlds, including a deliriously deranged low-rent apartment building where

he lives; a suburban home with suspiciously kind parents (Amy Ryan and Nathan Lane); a forest-turned-full-on animated parable; and then a nightmare-ending that is the film's most head-spinning part.

Audiences are likely familiar with writer-director Ari Aster's previous films, *Hereditary* (2018) and *Midsommar* (2019), which were both equally polarizing and shocking for their depictions of horror and traumas around the devastating losses of family. *Beau Is Afraid* is a painfully punishing movie that stuffs guilt, trauma, and physical injury upon its lead character, and Joaquin Phoenix is up to the challenge. Pushing his bloated body to the brink through physical and psychological torture, Phoenix is nothing short of amazing here. He's joined by comic performances from Nathan Lane and Amy Ryan, as well as Stephen McKinley Henderson as Beau's therapist. In its last, and most WTF section, Parkey Posey and Patti LuPone show up to push the film over its edge of sanity.

*Beau Is Afraid* is a work of incredible artistry (indie distributor A24 should get a special mention for producing a movie that is so defiantly unique, challenging, and original—much like how they did with last year's *Everything Everywhere All At Once*). It's been fun to talk about *Beau Is Afraid*, and its word-of-mouth seems to continue to grow, making for conversations around this deranged psychoanalytic dive into unprocessed childhood trauma that Freud would have a field day dissecting.

If you're looking for a dose of easily watchable popcorn entertainment, this film is not for you. Whether you end up loving or hating it, don't be afraid to check it out for yourself.

including the boys' volleyball team, the boys' tennis team, the boys' lacrosse, as well as the baseball and softball teams.

The volleyball team won a thrilling five-game set against the Vista Murrieta Braves in the quarter-finals. Their 25-15, 24-26, 23-25, 25-23, and 15-13 win was an emotionally charged event that had plenty of powerful hits and extended rallies. The win propelled them into the CIF-SS semi-finals against Fairmont Prep Huskies.

The matchup between El Segundo and Fairmont turned out to be another test for the third-seeded Eagles. They overcame a shaky first game and went on to win the match 18-25, 25-19, 25-10 and 25-18. Both Dylan and Ryan Pilkvist were dynamic at the net. Nolan Kelly's passing and sets accommodated the Pilkvists, Jackson Brenneman and Gio Biondo, who converted into points.

The win sends the third-seeded Eagles (22-3) into the CIF finals to face top-seeded St. Margarets (28-6) from San Juan Capistrano. The Eagles are back in the finals for the first time since 2015, when Steven Moye helped the Eagles defeat Quartz Hills in five games.



A memorial tribute for former football, track, softball coach and athletic trainer Jason Parker was held at Hazeltine Field and included some mementos on display, including his iconic bicycle he rode daily.

The Eagles also won a CIF title in 2010, with Hunter Hovland leading the way. The Titans are the defending CIF-SS Division 4 champions and have two other titles in 2001

and 2010, both in Division 5.

The tennis team is making a bit of school history. Not only did they win their first league title, but the Eagles advanced to the

CIF Southern Section Division 4 quarter-finals. After defeating Lancaster 17-1 in the first round, the Eagles dominated Jurupa Valley 14-4 in the second round. According to sources, it is the first time the program has advanced to the quarter-finals. They faced Mark Keppel on Monday, the semi-finals, should they advance, were played yesterday, and the finals are set for Friday.

The boy's lacrosse team made the long trip to Carpinteria to face the Cate Rams in the second round of the CIF playoffs. Coming off a 10-2 win over Millikan in the first round, the Eagles' hard-fought effort came up short against Cate and fell 10-6.

The baseball team's season ended with a thrilling 8-7 loss to Don Lugo. The Eagles had overcome a 6-4 deficit in the sixth inning to take a 7-6 lead. Don Lugo tied the game in the seventh inning and won it in the eighth inning with a walk-off RBI single.

The softball team traveled to face the top-seeded Moorpark Musketeers. It marked the second consecutive year El Segundo had drawn one of the top two-seeded teams. The Eagles were limited to four hits, and their season ended with a 6-0 loss. •

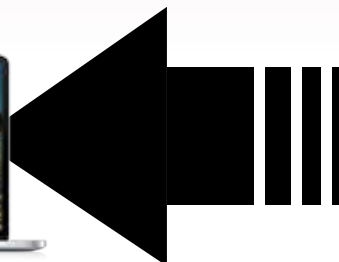

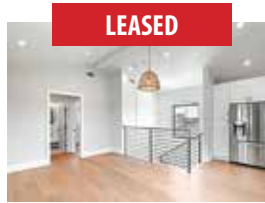

These moments also represent an opportunity, as Ruane noted, to show just how special Main Street is, not just as a community, but as a place to be. "The heart of the city is on Main Street," Ruane said. Ruane sees Main

Street as a bridge between the public and private spheres of life; it is where people of all ages can work, play, and relax, all in the same five-block radius.

Ruane views the flags as a symbol of the role Main Street plays in and for the city. It is not just a hub for restaurants and stores, but also a place to bring everyone who comes into town together and where the local city government operates. "On Main Street, you have the fire and police departments and city hall," Ruane explained. El Segundo High School and Library Park, amongst others, are places he mentioned people could meet to build new relationships or strengthen existing ones, whether they be within a family or between friends. Thus, Main Street is not only a place of work and play, but also a space where people can learn from each other and grow.

In other words, the flags serve as a reminder that one of the strengths of a small city like El Segundo is the community; it is the personal relationships between bartender and customer, mother and daughter, librarian and student that represent how the people of El Segundo are there for one another, in more ways than one.

leadership of these companies to really outline and be able to bring forth a communication package that's outlined around the ideas of what will it take for these companies to go to the next generation of success? How will these companies find their next big idea? How can they really fulfill the mission that El Segundo has placed in front of the world, which is 'the city where big ideas take off'? And it's with that in mind that we kind of come here today as a bridge for communication. The ideas and the programs that we've been working on that have been shared prior to this time. We've been making great progress through the volunteer work of Al (Keahi, ESEDC vice president/treasurer) and Eric (Chan, ESEDC president), as well as through the board of governors and board of directors.

"As you guys know, the continued prosperity of the city is at the heart of our mission. But, in order to achieve that mission, the ESEDC's board of governors really felt that the continued focus on employee recruitment and retention for the next generation of big ideas was really at the forefront. And how does this start to take shape? Well, I think it takes shape in the idea of understanding what they believe to be some of that next leadership, and it's a more diversified, tech-forward base, a generation that will provide long-term sustainability and growth, that meets

the demands of the future employees in the heart of ESEDC's three active initiatives. And those three active initiatives really take to heart kind of the changing demographics that aren't just in El Segundo. These are changing demographics that are faced across Southern California as a whole, with an aging workforce and the opportunity to really identify the next leaders and idea generators. We believe that through these three priority initiatives, we can address that mission. And we broke them apart here for you guys today with our update.

Martin then presented actions taken and meetings held by ESEDC to capture information and interact with businesses and ESEDC's "ask" of the city council, which is "Continued support of select City staff resources when proposed as well as acting as the 'applicant' for future Grant submissions when and if ESEDC staff identify funding opportunities." He also covered initiative number three, noting that ESEDC had contracted with The Concord Group to develop a "Strategic Analysis for Residential Development for East El Segundo Market." He presented the "study takeaways and key considerations," which include the fact that 98 percent of the city's general tax budget is derived from business and that attainable housing for future employees of businesses in El Segundo will be needed to attract "the

best and brightest" and that additional housing, if planned strategically, can be a "win/win for businesses, residents and the City at large," as exemplified by case studies in Irvine and Anaheim.

The ESEDC also presented its ask around housing in El Segundo. To ensure that future strategic planning sessions focus on housing east of PCH, incorporate business feedback, and consider the immediate importance around this topic for ongoing retention and recruitment and a cooperative review of any city-initiated studies on housing in partnership with the ESEDC's Concord Group study to drive the discussion forward with shared ideas around housing opportunities.

Carol Hamilton of L'Oreal, which opened its West Coast Headquarters in El Segundo last August after deciding to make El Segundo the home of its West Coast Headquarters in October of 2020, addressed the council on the need for the city and businesses to work together to move forward. Saying L'Oreal is "all about growth" and that the company plans to bring more growth to the city, she noted that Los Angeles is 49 percent Latinas and El Segundo is 18 percent. She said the company believes the city's population should mirror LA and "really believe in diversity to be a vibrant beauty company."

She said L'Oreal wants to "build a beauty capital here" and support events in the city

and its residents. She explained that L'Oreal is a "proponent and dedicated in our value system to really fight climate change and address that in everything we do." She noted that the company's "KPIs to bring us to 2030" are "so ambitious, we don't know if we can make them. They're not a slam dunk. Greenway project (on Aviation Boulevard involving LA Metro and creating transportation to meet workers in El Segundo) is something we're very excited about and want to support."

In response to the presentation, council member Ryan Baldino asked to see The Concord Group's housing study; Mayor Pro Tem Chris Pimentel said the city could be active with zoning and conditional use permits for businesses and housing on the east side of the city and mentioned that the city works with the Workforce Development Board "all the time" in terms of hiring and employees; council member Lance Giroux said the "taboo discussion on housing east of PCH" needs to begin since the pandemic has brought office building vacancies higher, hence business tax and city revenue will go down, and council member Carol Pirztuk brought up grants and wanted to know how city grant ownership could avoid any legal issues or problems given the arrangement with the nonprofit ESEDC. She noted she wants the city to go into any such arrangements with "our eyes wide open." •
