Eagle Scouts, Hyperion, and Los Angeles International Airport

The El Segundo City Council delivered several special presentations during its regularly scheduled meeting Tuesday night, including honoring Ainsley Gulden, the city's first female Eagle Scout, as well as William Wenger, a 20-year resident who has been awarded the "Distinguished" Eagle Scout, a distinction "established in 1969 by the National Eagle Scout Association to recognize Eagle Scouts who achieve extraordinary national-level recognition, fame, or eminence within their profession and service to the nation and have a strong record of voluntary service to their community," according to the Boys Scouts of America website. Council also heard updates on the Hyperion Water Reclamation Plant and Los Angeles International Airport, both neighbors to the city that have caused issues for residents and community members.

Ainsley Gulden, who will graduate from El Segundo High in the class of 2024, addressed the council, telling them she was grateful for the city's support with her Eagle project and Mayor Drew Boyles attending her ceremony. She noted that the scouting program has helped her develop her leadership and practical skills and thanked the council for supporting girls in scouting.

Wenger's list of achievements is long. Now a retired U.S. Army Colonel after serving in the Army for 42 years, from 1969 until 2012, Wenger has lived in El Segundo with his wife for more than 20 years. He has been in scouting for over 65 years and

was nominated for the Distinguished Eagle Scout Award by the Orange County Council and the Boy Scouts of America. Wenger was registered as a scout in the Long Beach Area Council from 1954 through 2019 and earned his first Eagle Scout award in 1963. In Scouts, he has been a tribe chief, cub den leader, assistant scoutmaster, explorer post advisor, camp staffer, camp commissioner, and executive council member. Professionally, he has worked as a commercial real estate executive, college professor, and professional writer in addition to his military career. He served as an infantry battalion commander during the Los Angeles Riots and as part of the Northridge earthquake response. After his initial military retirement, Wenger volunteered for four combat tours as an infantry airborne ranger colonel in Iraq and Afghanistan, countries in which he also worked to "revive, develop and support" the scouting programs in those countries. He is an outstanding alumnus of the U.S. Army War College and a distinguished graduate of the U.S. Military Academy. He has been involved with scouting locally, nationally, and internationally. "I am greatly honored by your recognition of me for the Eagle Scout award," he told the council, adding that he loves the city and the people of El Segundo. "And this means so much to me personally to be recognized by you all and the citizens of our beloved city."

City Manager Darrell George provided an update on Hyperion, where an emergency

release into the ocean and flooding in the plant in July 2021 caused significant impacts on residents in El Segundo. He told the council that Hyperion has a planned functionality test of its east one-mile outfall discharge gate on Tuesday, May 23, in which .25 million gallons of fully treated and disinfected effluent will be discharged and immediately pumped back to the plant for treatment." He noted that this procedure would not impact the El Segundo community. When council member Carol Pirsztuk asked for clarification, Public Works Director Elias Sassoon said, "They are not going to be dumping anything into the ocean." Pirsztuk also asked when the "full-out emergency test" would be done. Sassoon told her and everyone in council chambers that the once-a-year test had been done "a few months ago" and that the city had been "part of the process" and would be every year moving forward. George noted that the South Coast Air Quality Management District had received 19 odor complaints about Hyperion since May 2 and that a Notice of Violation for issues concerning "AQMD rules" and "permit conditions" had been issued by AQMD to Hyperion on May 3 and May 5. He also said that he, Mayor Boyles, and council member Ryan Baldino had recently met via Zoom with Los Angeles City Council member Traci Park, who now represents the district Hyperion. "It was a pleasure to have someone from Los Angeles at the table with us talking about issues with Hyperion," he noted. George called it a "productive intro-

BlackBerry is a Dark Comedy About the Rise and Fall of the World’s First Smartphone

From director Matt Johnson comes *BlackBerry*, a fictionalized story inspired by real people and events leading up to the uncharted success and ugly demise of the world’s first smartphone.



In the early 2000s, the BlackBerry was a symbol of status. Lindsay Lohan and Paris Hilton would carry their Swarovski-covered accessories to and from Hollywood’s most exclusive clubs, and teenage girls everywhere (*raises hand) subconsciously equated this bedazzled phone to power. A device that you could call, text, and check your email? It was a cultural revolution.


The year is 1996. Mike Lazaridis (Jay Baruchel) and Douglas Fregin (Matt Johnson) are on their way to pitch the latest invention born out of their small Canadian-run business, Research in Motion. The men are on a mission – a deal with a corporate big shot would mean financial security and technological advancements the world has never seen.

Unfortunately, their dreams seem even further out of reach after stumbling their way through the presentation for their “computer-in-a-phone” device in front of businessman Jim Balsillie (Glenn Howerton). Jim is a fast talker and brutally honest straight shooter and barely acknowledges the men, even as they speak directly to him. Jim has too much to do and too little time and he makes that known.

Eagles Have Historical CIF Playoff Runs

It has been a historical CIF Southern Section playoff run for the El Segundo High School's boy's swim team, the boys' volleyball team, and the boy's tennis team. The swim team won its sixth CIF title, the volleyball team won its third title, and the tennis team made school history by advancing to their first CIF-SS semi-final match.

Volleyball Team Wins Third CIF Title

Before the season had started, the Eagles were working out daily, either in the weight room or getting court time in the gym. The payoff would be in the form of a championship

season. All that hard work in the off-season paid dividends when the Eagles won the CIF Southern Section Division 3 championship. "Their commitment was unmatched," said assistant coach Tim Hovland. "We knew we had a special team if we came together and played to our potential," he added.

The third-seeded Eagles defeated top-seed and defending CIF-SS Division 4 champions, the St Margarets Tartans, 20-25, 25-19, 25-18 and 25-9. The Tartans had come into the finals having won 51 consecutive sets, including the first set in the finals, before the Eagles spoiled their streak by winning the next three sets.

The Eagles started slowly, but it could've

been first game jitters on the biggest stage of their season. They fell behind 14-5 before going on a run and figuring out their defense. Jackson Brenneman's point closed the gap to 21-19, and a serving error gave the Tartans a cushion and went on to win the first game.

In the second game, the teams played it close with plenty of extended rallies. Neither team could sustain much of a scoring gap. Brenneman's ace gave the Eagles a 19-15 advantage before Ryan Pilkvist's ace gave the Eagles a 22-18 lead. Dylan Pilkvist pounded a point to make it 23-19, and Nolan Kelly's block for another point helped set up the final point of the game, and El Segundo evened the

match at one game apiece.

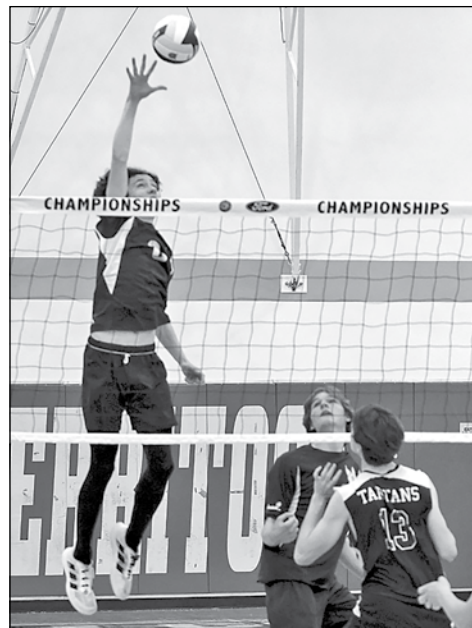
In the third game, El Segundo handled the net on defense and kept the Tartans off their game. The turning point was an extended rally that culminated in a hit by Kelly to give the Eagles an 18-15 lead. The Eagles would close out the game with seven consecutive points, including the last three, thanks to Jackson Brenneman's timely and well-placed hits.

The Eagles were in total control of the match and demoralized a Tartans team that had so much confidence coming into the CIF finals. After Reed Wainwright gave the Tritons their only fourth-game lead El Segundo took

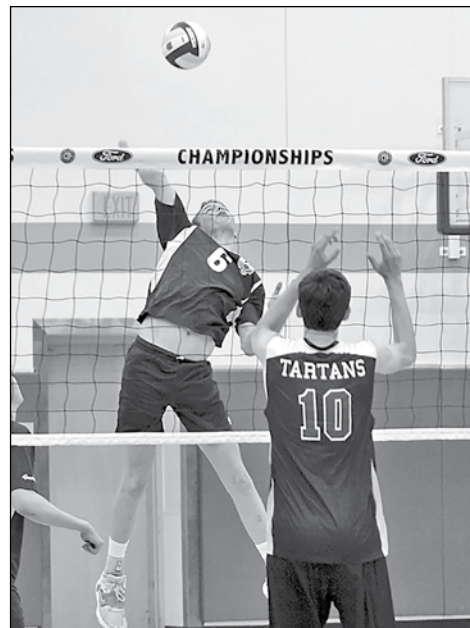

Swim Team Wins Sixth Title

The El Segundo high school's boy's swim team has been one of South Bay's most prolific programs. The Eagles have been to the CIF finals 12 times and have captured six titles, including this year's CIF Southern Section Division 2 title; it was their first team title since 2011. The girl's squad, which won a CIF team title in 2008, placed a respectable seventh out of 52 teams.

On the girl's side, highlights included a second-place finish in the 400-yard freestyle

Alexander Cole won the 500-yard freestyle in 4:29.8 and placed second in the 200-yard freestyle, while Lucas Hubbard wasn't far behind, placing fourth. Taisei Sato had a fourth-place finish in the 200-yard IM race, while Lucas Crother-Collado sprinted to a fourth-place finish in the 50-yard freestyle in 21.34. Taisei Sato was edged out of second place in the 100-yard butterfly by three one-hundredths of a second.

It was a brilliant day for both teams and with so many underclassmen returning next year, look for the Eagles to be well-represented at the CIF finals.

The Eagles had an incredible season. They won their first Pioneer League championship and advanced to the CIF Southern Section semi-finals for the first time in program history. Attending practices, holding each other accountable for showing up to practice, and focusing, has definitely paid off," said Coach Maye. "We could not be prouder of the turnaround this season, and it's all due to the hard work of the players and the support from the families and the community," added Coach Paul Rayburn.

With strong showings throughout the year from their singles players, including graduating senior Hashi Yamashita, and non-seniors such as Shane Hines, Aarush Antil, and captain Caleb Tsai the Eagles are positioned well to continue their success. The development of emerging doubles play from Andrew Clouse and Nic Rayburn, Dorde Glisovic, Luke Martinez, Connor Frasciso, Camden Chen and Chase Lai-Yates, and Thomas Cuzzocrea proved to be a strong point. Jacob Rodriguez, Dylan Evers, Kai Clifton, Bennett Fisher, and Aden Calof were ready and willing to step in at any time they were needed and played brilliantly. "It's been a complete turnaround from last year, and we are looking forward to seeing more from this team as they work hard in the offseason," said Coach Maye. •

ductory meeting” and said Park had directed him to a staff member who would be the point person on Hyperion matters. He also provided an update on California Assemblymember Al Muratsuchi’s Assembly Bill 1216, which addresses wastewater treatment plants and the monitoring of air pollutants, noting it had passed two committees and is headed to the Assembly floor to see if it (the bill) will pass and move forward to the state senate for a vote.

In the news between Los Angeles World Airports and the city, a city-hired attorney who has been involved with the city working to improve communication between LAWA

for some 25 years, Osa Wolff, presented information on current and upcoming projects such as Residential Sound Insulation (RSI), which LAWA recently has taken over from the city, and the Green Infrastructure project slated for Imperial Highway from California Street to Vista del Mar and on Pershing. The project will bring native plants, new trees, hedges, flowers, and shrubs to beautify the landscape and make the area safer, particularly for pedestrians, who will now have hedges intended to keep them from crossing roadways in non-designated crosswalks. The first project is “practically funded,” said Sassoon, noting LAWA is contributing \$4 million, the

city \$500,000, and Los Angeles County is expected to add the remaining \$7.5 million soon via approval at a board meeting. The RSI demonstration house the city has used at 910 Hillcrest Street will now be sold, as the city council approved its sale Tuesday night during the meeting. The property was purchased in 1990. The property is in the city’s name; however, LAWA and the Federal Aviation Authority hold equity ownership. The FAA funded the purchase of the property and will now return whatever equity comes from the sale to its use for RSI in El Segundo. The city is currently looking for a real estate agent to sell the property, as authorized by the

council, Tuesday night. During the council meeting, LAWA reported that the People Mover for LAX is expected to be completed by the end of 2024. At that time, LAWA can move forward to address other issues impacting El Segundo, such as overflow parking. LAWA also noted that LAX traffic is back to 85 percent pre-pandemic levels, with international travel mostly accounting for the fall off, notably Asian countries and the geopolitical climate between China and other countries. Flight traffic from Hong Kong, Australia, and New Zealand has been off, too. Domestic travel is at 90 percent pre-pandemic. •

Deeming the pitch a disaster, Mike and Doug begin to feel the prongs of desperation grip their bodies. Everything changes when, after a moment of clarity, Jim returns with a counteroffer that would take the company and the device to the next level. What ensues is a *Wolf of Wall Street*-type ebb and flow of nerdy engineers who fell into an influx of cash and don’t know what to do with the newfound success.

Mike has always been the most level-headed of the group and keeps one foot rooted in reality but not Jim. If he’s not trying to buy a professional hockey team, he’s unethically trying to poach employees from competitive companies or letting personal grievances get in the way of the health of the company. The final nail in the coffin comes during

Apple’s keynote address when Steve Jobs (using archived footage from a real event) introduces the world to the first iPhone. Game over.

Director Matt Johnson, who also co-stars in the film, creates a thoroughly engaging, high-stakes comedic adaptation from his inspiration source: the book “Losing the Signal: The Untold Story Behind the Extraordinary Rise and Spectacular Fall of BlackBerry”. *BlackBerry* is shot in a style that’s similar to *The Office*. It’s not a faux-documentary but the loose, handheld camerawork gives *BlackBerry* a breathy nature that contrasts the corporate world we’re living in. The film’s soundtrack further sets the mood and takes us down memory lane, with tracks from Joy Division, The White Stripes, and The Strokes to name a few.

Now, the reason why you should see this film: Glenn Howerton. His performance as a manic, loud-mouthed, egomaniac is entirely pitch-perfect and hilarious. His comedic fingerprints are all over this film in the best way possible; anyone acting alongside him is automatically elevated to his level. The energy that radiates from this film probably equates to a double shot of espresso.

BlackBerry was an official selection of the 2023 SXSW Film Festival and is distributed by IFC Films. If you ever wondered about the evolution of the smartphone and how it landed into the palms of people everywhere, or just looking for a smart, comedic gut punch, this is for you.

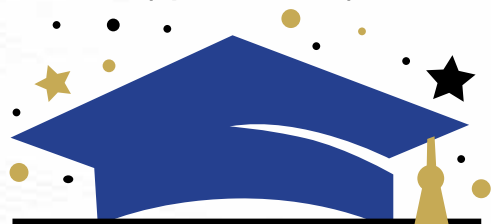
