

#### **City Discusses Funding of Senior Housing**

The El Segundo City Council approved moving forward Tuesday night with an update to the city's General Plan Land Use Element, which was last fully addressed and updated in 1992, with incremental changes and zoning amendments made in the years since then. Doing so sets the stage for the city to issue a Request for Proposal to select a vendor consultant to help it dig into reworking and updating its existing plan. City Council Member Ryan Baldino noted that updating the General Plan would set the stage for the city to maintain "local control." Said Baldino, "It's important work. It's grueling work. But it's worthwhile work." While Community Development Director Michael Allen said the focus would be on land use east of Pacific Coast Highway, he noted that the update would include the entire city. He estimated the cost to be between \$500,000 to \$800,000, adding that the city has a "dedicated funding source for this" with more than \$1 million.

In other news and action, the City Council proclaimed June as LGBTQ+ Pride Month and recognized May as Asian American Pacific Islander Heritage Month. They also honored outgoing El Segundo Unified School District Superintendent Melissa Moore, who is retiring after ten years with the school district. They lauded two El Segundo youth sports teams on their championships and recognized Public Works Week. Moore, who arrived at the podium to address the council in tears, told the council how the city's school district "serves as a shining example of excellence in public education. She thanked the community and those in ESUSD for their work, saying, "This (El Segundo) is a very special place...It doesn't happen by one individual. It happens by an entire team." After Moore spoke, council member Carol Pirsztuk announced that Moore would be joining the city's Board of Education.

During Public Communications, El Segundo resident Anya Goldstein, who is a member of the Sweat Equity Alliance, a racial justice community group in the city, noted that one of two people council would be interviewing for a seat on the city's Diversity, Equity, & Inclusion Committee, Yadranka Drascovic, ran for a seat on the ESUSD school board "on an explicitly anti-DEI platform." After reading quotes by Drascovic illustrating her stance,

Goldstein said that appointing Drascovic to a DEI Committee seat would send the message "once again that this council wants to hobble DEI efforts in the city." Subsequently, council member Lance Giroux pointed out that "anyone can apply" for a committee or commission seat as long as specific residency or work-in-the-city requirements are met.

The council's agenda for the meeting also included reviewing the El Segundo Senior Citizens Housing Corporation Board Annual Report Update and Funding Request for Reserves. The city's senior housing consists of 97 units built in 1987. Tenants who move





This novel left me flabbergasted. As soon as I finished, I threw it down and sat there stunned. I picked it up to read the last chapter

over again because I was so overwhelmed. However, it isn't just the last chapter. From the beginning this book grabs you by the throat and leaves you breathless. It may not be a real mystery where this story is headed, but the journey to the end is so taut with tension that one really can't adequately guess the ending.

This tale full of lies, deceit, and betrayal as well as love, friendship, and loyalty is set in the 1950's during the Korean War. Nestled in the rural town of Blowing Rock, North Carolina Jacob Hampton and Blackburn Gant grew up together. Jacob is the beloved only child, his parents having lost two daughters before he came along much later. His parents own the lumber mill and general store and are well respected as leaders of the community. Blackburn is disfigured from having polio as a youth and at sixteen was left by his family to work as the caretaker of the local cemetery. Loneliness was their bond, and it cemented their friendship.

As young men, the two remain friends. When Jacob is conscripted into the service, he pleads with Blackburn to help his very



## The Last Stop in Yuma County Review: A Slow Burnin' Shoot 'Em Up

The Last Stop in Yuma County may be the final rest stop before passing into the next county, but it's also the end of the line for an unlucky bunch of diner guests who get





trapped with trigger-happy bank robbers. This slow-burn neo-western crime thriller is a throwback to single-location standoffs where the fun comes from colorful characters, patiently building tension, fun jukebox needle drops, and not knowing what's going to happen next.

The movie opens on a silent desert highway, basking under the hot sun of an early morning, and awakened by the arrival of a traveling Knife Salesman (Jim Cummings) who pulls into a rest stop to fill up his car. Immediately, there is a problem, the Diner Waitress (Jocelin Donahue) points out. The rest stop is out of gas, and the gasoline truck that refuels the station is delayed. However, a larger problem presents itself when more shifty-eyed travelers arrive at the rest stop, and their car perfectly matches the description of the getaway vehicle used to hold up a bank hours earlier.

Just their luck-it's indeed the bank robbers (Richard Brake, Nichola Logan). The Knife Salesman grows increasingly uncomfortable after realizing this fact. As more travelers shuffle in and fill the diner, the slow-boiling setup reaches its climax. The bank robbers

#### **Golf Team Wins CIF Title**

The El Segundo High School's trophy case added another CIF Southern Section championship plaque to its display case. The boy's gymnasium will add two more banners, including a Bay League championship and a CIF-SS banner for the recently crowned boy's golf team.

In just its second year in existence, after a nearly forty year absence, the El Segundo Eagles have done the unthinkable by winning a league title and a CIF team championship. It is a rare feat to win a league title so early in a program's history but to win a section title in the second year is extremely rare.

So how did the Eagles become the darlings of the South Bay in just the second year? It starts with selecting the right coach who had the vision for the golf program. David March was a standout basketball player in high school and college. He became the Eagle's head basketball coach after legendary coach Rick Sabosky retired. March guided the Eagles for several seasons before stepping down.

Coach March said when he heard that the golf program was returning, he immediately let the school know his interest. His golf background is his passion for playing for the past twenty years, and he can boast a scratch handicap. Couple that with his basketball coaching experience it made Coach March a natural for the program's head coaching position.

The banner season continues for the ESHS Boys' Golf Team. On Monday, the Eagles won the CIF Team Championship with a first-place score of 365 at Meadowlark GC. For most of the afternoon, it was a back-and-forth battle with second-place finisher Notre Dame (Sherman Oaks). The Eagles jumped out to an early

lead over the 20-team competition and held first place for the majority of the first third of the match.

Then, the Eagles hit a rough patch on the course. Multiple bad breaks and some poor shot selection took their team score from plus 2 to plus 10, putting them five strokes behind Notre Dame (Sherman Oaks). Coach March was confident with his group and knew their hard work would not disappoint them. He stated, "All our work on and off the golf course for the last 12 months was to get to this day. The long summer practices, playing golf in the fall until dark, and the tough 18-hole matches and tournaments that got us battle-tested have prepared us for this moment."

As the match continued, the Eagles knew what they needed to do. The message from Coach March and team captain Jack Harris to the group was to lock in and finish strong. The season had prepared them to finish like champions. Their 18-2 record, top three finish at the loaded-up Walnut Tournament, and the Bay League Team and Individual Championships were proof. The team always got stronger as the match continued, and the CIF Championship at Meadowlark GC would be no different.

As the pressure mounted, the 20-team competition started to struggle to keep their numbers low. Scores started going high across the board as the wind picked up and each shot was critical to the success of each team finish. The Eagles held strong at ten over for the day. With the final six holes left, the Eagles, who were matched up in groups with the Sherman Oaks (Notre Dame) players, knew the tides were turning. Each player's commitment to the





in now and in the future pay 60 percent of the market rate in rent, while existing renters can receive up to a two percent increase per year without the Park Vista board having to seek council approval, explained El Segundo Senior Citizen Housing Board Corporation volunteer President Paul Lanyi. Approximately 65 percent of the housing tenants are not paying 50 percent of the market rate, and approximately four units turnover per year. He said there is a 12- to 18-month wait for a rental opening for those on the rent list. Last year, a studio rented for \$706 per month; it now rents for \$846 per month at 60 percent of the market rate. A one-bedroom unit rented for \$960 per month last year, and under the new 60 percent rate of market rate, rents for \$1,142. Lanyi also told the council that a previously perceived to be more imminent major plumbing project for the building has been able to be pushed to 2033/2034 due to recent assessments. That project, estimated at \$1.3 million, has an added five percent cost increase when it hits in 2033/2034. He said under current practices and plans, and Senior Housing Fund 504 (controlled by the city), Park Vista will remain below the requirements of the city's finance-recommended reserves. Lanyi said if the city continues to contribute \$200,000 per year to the city's Senior Housing Fund 504, the board would not dip below the city's finance-recommended reserves in 2033. Layni thanked city Finance Director Paul Chung and Director of Public Works Elias Sassoon's assistance with projections and costs. Council approved the allocation of \$200,00 per year, 5-0.

On a 3-2 vote, the City Council denied the use of city Asset Forfeiture funding to complete the purchase of an armored rescue vehicle

after receiving a United States Department of Homeland Security 2023 Urban Area Security Initiatives Grant Program Award and Subaward Agreement with the City of Los Angeles for \$348,355 and was awarded \$251,765. Tuesday night, the council was asked to approve spending \$206,614 from the El Segundo Police Department Asset Forfeiture Expenditure Account. However, council member Giroux, Mayor Pro Tem Chris Pimentel, and Mayor Drew Boyles questioned the reasoning behind the need for such an expensive vehicle in El Segundo and shot down the request. The need for such a vehicle was addressed in the agenda as "The unique feature of the vehicle is that it is an armored rescue vehicle with advanced life support and firefighting capabilities. No other South Bay agency has a rescue vehicle with these capabilities, and it is large enough to provide emergency medical treatment inside the vehicle cabin. The vehicle will allow the SWAT Team to coordinate efforts to respond to and recover from emergencies in Regional Area 'G' Mutual Aid." ESPD applied for the 2023 UASI Grant Program in October of 2022 and received notice that the law enforcement working group approved the application with the reduced amount of \$251,765. The agenda included that the "Goals for this purchase would be to: Deploy the rescue vehicle multiple times yearly during large-scale public events as part of the SWAT Security Reaction Team; Train with neighboring agencies such as Hawthorne PD SWAT, Manhattan Beach PD SWAT, and Gardena PD SWAT; Train El Segundo PD and El Segundo FD members to use the armored rescue vehicle with advanced life support and firefighting capabilities; and Provide mutual support to surrounding agencies. •



# Roast Beef Sandwiches with Melted Provolone

#### Directions
