Cleaning Up the Galaxy with Drew Keller-Goralczyk

Many people today may not remember or know, but in 1977, the great planetary scientist, Carl Sagan, sent a golden record out into the far reaches of space with hopes that some intelligent lifeform would find it and listen to the many sounds of Earth. To launch such a project, NASA used a rocket to send the object into space, where it would dislodge from the vessel, and a satellite would begin its long journey into a vast universe. The rocket left behind gets caught in the earth's gravitational pull, where it circles the globe for all eternity until it eventually breaks apart by force, or worse yet, it gets close enough to earth to reenter the atmosphere. Over time, debris from countless launches gets caught in the earth's pull, and as new exploration efforts begin, the stellar debris becomes a huge concern since it travels at such a rapid pace. For example, even the smallest item (a piece of fiberglass or a rivet) can destroy a shuttle or satellite instantaneously, if it penetrates an object with the right amount of force. Drew Keller-Goralczyk, an engineer based in El Segundo, has dedicated his career to solving the issue of interstellar debris, keeping the community—and the world—safe from catastrophe.

As the founder of the Kessler Aerospace Corporation, Keller-Goralczyk has been obsessed with the active prevention of debris-causing collisions in space since he first read a news headline on his way to a new position at ABL Space Systems—a rocket startup based in El Segundo.

"I was taxiing on the plane leaving DC and bound for my new role at ABL. As the plane finished taxiing and began rolling for take-off, I read the headline of an article dated only two weeks prior: "Experts Watch in Horror as Two Dead Satellites are on Track for a Potential Collision." I remember it so vividly. I spent the entire flight thinking deeply about the problem and realized that helping solve it is my purpose."

Oddly enough, humankind is capable of predicting collisions in orbit, but giant leaps are still needed in order for actions to be taken against those predictions. It will take nothing less than a clear orchestration of funding, technology maturity, international and domestic policy, regulatory licensing, and public opinion to prevent a polluted orbital environment for future generations. However, Keller-Goralczyk sees it as an opportunity to make a tremendous difference.

"The company is named after a celebrated pioneer of orbital debris science, Donald J. Kessler, NASA (Ret.). He founded NASA's orbital debris program and modeled a run-away chain reaction of debris impacts that will irreversibly pollute Earth's orbit. This phenomenon has been dubbed the "Kessler Syndrome," for which his name is typically recognized. From my laptop, while sitting on El Segundo beach last year on my birthday (May 2nd), I formally filed for incorporation of Kessler Aerospace Corporation. I decided to fully dedicate myself to my passion with the aim of ensuring a better future orbital environment."

And what better place to secure the safety of the globe than in the aerospace capital of

the world, El Segundo, CA? Keller-Goralczyk moved to the area in 2020 with his wife, Karis, and their frisbee-loving dog, Duncan.

"It was very difficult to leave our lives behind, and I'd love to take the opportunity to publicly praise and thank Karis for having the strength and willingness to do so, specifically for me. She continues to work for her same DC metro-based public accounting firm. She has established a California office here in El Segundo since making the move, even accomplishing CPA licensure in California. She should be nominated for sainthood. Since moving, we've made friends around town and have been dedicated to exploring and experiencing everything the area has to offer."

With his family in tow, Keller-Goralczyk is focused on "working toward a future in which experts will no longer merely 'watch in horror' if a satellite collision is probable."

‘We Believe’ as Volleyball Team Wins Regional

The El Segundo high school’s boys’ volleyball team made program history by winning its first CIF Southern California Division II Regional championship. After winning the CIF Southern Section Division 3 championship, they were awarded the top seed in the CIF SoCal Regional, and the Eagles made sure they were worthy of the high seeding. They disposed of Palisades in four sets and then took down San Diego’s Del Norte in four sets. It set up the team’s biggest win of the season when they won the championship 24-22, 14-25, 22-25, 25-19, and 15-9. From the beginning, the team’s mantra and theme of their season was, “We believe.”

It was a hectic week for the Eagles after winning the program’s third CIF title in 13 years. Two days after their crowning moment, they returned to work, working on their game to prepare to face some of the best teams in Southern California. First, they faced L.A. City Section Open runner-up Palisades. The Dolphins’ lofty 36-7 season gave them the second seed in the city playoffs. The Dolphins had wins over City powers Venice and Kennedy as well as Southern Section powerhouse programs Royal and Quartz Hills.

In the first set, the Eagles spotted Palisades a 7-2 lead before taking charge. El Segundo went on a run, and the game was tight until Ryan Pilkvist gave his team a 17-15 advantage. Jackson Brenneman kill made it 22-20, and Ryan Pilkvist’s ace gave the Eagles a 25-22 first set win. The Dolphins would even the match at one set a piece before the Eagles closed out the match in four sets.

Next up was a matchup against the Del Norte Nighthawks. The Nighthawks had a grueling schedule but made it to the San

Diego Section Open Division semi-finals, and the Eagles won convincingly 25-15, 23-25, 25-12 and 25-12. In the first set, Ryan Pilkvist and his brother Dylan led the charge by combining for seven kills. Daniel Escobar’s block gave the Eagles an 18-12

block by Jackson Brenneman. Dylan Pilkvist had one of his three third-set kills with a powerful hit 12-7. The Eagles would go on to outscore the Nighthawks 8-3, including Ryan Pilkvist’s kill to make it 20-10. Pilkvist would account for the final three points of

in the nation. They are loaded with talent, including three Division 1 colligate commits with an imposing front line. They came with a swagger of thinking they would roll through the championship match in three sets. The Falcons had not had much of a challenge in the first two rounds of the SoCal Regional tournament sweeping Hart in the first round and sweeping St. Margaret’s in the semi-final.

Not many outside of El Segundo gave the Eagles a chance at actually taking down Torrey Pines. If the 13 players on the Eagles roster looked intimidated before the match started, it wasn’t noticeable because they weren’t. “We belonged in this game because we believe. We believe in each other, and we believe in our team,” said assistant coach Tim Hovland.

In the opening set, the Eagles came strong and confident. Early on, Dylan Pilkvist had three kills, and Daniel Escobar had a block to give the Eagles a 6-3 lead. Ryan Pilkvist had a kill for an 8-3 lead. But the Falcons went on a run, and with an ace by USC commit Christian Connell, the Eagles held a 17-16 advantage. The Eagles inched away, and with some unforced errors by the Falcons, El Segundo won the first set 25-22.

In the second set, the Eagles realized how good a team they were facing. “We knew they were good, and they took us out of our rhythm of winning the first set,” said Princeton signee Nolan Kelly. The Eagles kept it close and trailed 15-12 before the Falcons took complete control by outscoring the Eagles 10-2 to close out the second set 25-14.

The Eagles regrouped, and the two teams battled a close game with plenty of blocks, digs, and spectacular saves. Nolan Kelly gave the Eagles its first lead with a drop shot and

lead. Brenneman’s ace made it 22-13, and Ryan Pilkvist finished off the first set with a powerful kill.

In the second set, the Nighthawks played a different strategy and, coupled with the Eagles’ errors, kept the set close. There were four lead changes until the Nighthawks took control of the set when Gavin Kirby’s kill gave his team a 22-19. Brandon So had an ace, and Kirby ended the set with a kill to even the match at one set apiece.

El Segundo took control of the third set from the beginning, and it started with a

block by Jackson Brenneman. Dylan Pilkvist had one of his three third-set kills with a powerful hit 12-7. The Eagles would go on to outscore the Nighthawks 8-3, including Ryan Pilkvist’s kill to make it 20-10. Pilkvist would account for the final three points of

the set for the Eagles that, included two kills and a serving ace for the 25-12 win.

Set four was another easy one for the Eagles. Giorgio Biondo’s early block gave the Eagles a 3-0 lead. Dylan Pilkvist had six kills during the set, including back-to-back giving El Segundo a 21-10 lead. The Eagles would close out the set with a 25-12 win and advance to the CIF Southern California Regional championship game against Torrey Pines.

The Torrey Pines Falcons came into the championship match as the ninth-ranked team

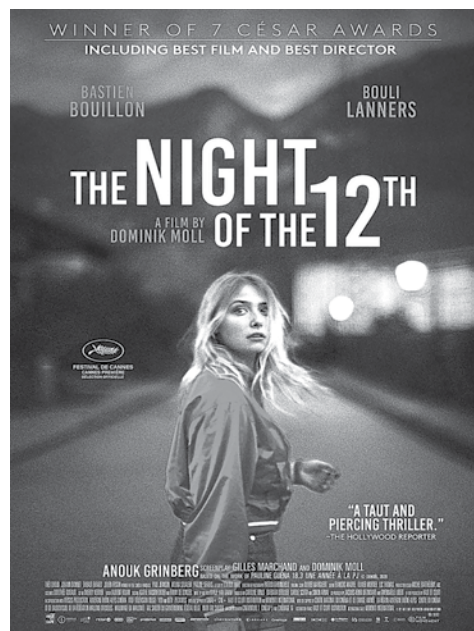

Film Review

The Night of the 12th is a Sobering Crime Drama Based on True Events

It's no secret that true crime is one of the most popular themes in the "entertainment" space. All too often in this current landscape, one person's tragedy is turned into cultural fodder that we devour weekly in the form of podcasts and TV shows, sitting through a

plethora of advertisements to get our "who-dunnit" fix. What is it about true crime that is so appealing? Is it our innate voyeuristic nature, or our fascination with death and its permanence? Audiences are left to wrestle with those complex rhetorical questions in French director Dominik Moll's layered crime drama, The Night of the 12th (La Nuit du 12).

Clara Royer (Lula Cotton-Frapier) is heading home after a night out with friends when she is confronted by a stranger on a dimly lit street. Masked and unrecognizable, he calls Clara by name – catching her off guard – before dousing her in gasoline and throwing a lighter in her face. Head and torso ablaze, she runs a short distance before collapsing onto the street and is left to die. The graphic nature of the crime is a shock to the community, especially the police department. Even though they are used to dealing with the sad reality of death every day, it never gets easier to tell the family of a loved one that they have passed.

From the very beginning, Clara's case feels strangely unique and the deeper investigators dig into her background, the more obsessed they become. Police captain Yohan Vivès (Bastien Bouillon) begins to spiral after initial leads become dead ends. After speaking with Clara's best friend and uncovering dark

truths about her past, Clara's sexual history becomes his North Star. The film toes the line between being concerned and shaming Clara's past actions. A pattern quickly emerges that every suspect on the police's radar has slept with Clara rather recently, more than one being an illicit affair.

Yohan becomes fixated on this fact, and his personal feelings toward the matter seep into his professional actions. The evidence is right in front of him, and at the same time, isn't there at all. No matter how strong his intuition is, it cannot compete with physical evidence – or lack thereof. Clara's killer roams free, and that haunts Yohan to no end.

The Night of the 12th is ominous and dark both in subject matter and visual aesthetic. Setting the film in the mountainous French commune of Saint-Jean-de-Maurienne has a baked-in sense of isolation that feels both idyllic and anxiety-inducing. Composer Olivier Margueri's score offers a beautiful mix of buoyancy sprinkled with melancholy. At times reminiscent of the French pop scene he used to frequent as a musician, Margueri uses soft vocal melodies and luxuriant arrangements to give the film a sense of cautious optimism.

Filmmaker Dominik Moll combines elements of documentary and fiction in The Night of the 12th, adapting a book from writer Pauline Guéna, who spent a year immersed in the Versailles Criminal Investigation Department. Her book, "18.3 – une année à la PJ" (18.3 – A Year With the Crime Squad) is the source of inspiration for the film. An official selection of the 2022 Cannes Film Festival, The Night of the 12th is a tough film to swallow but an equally important story to witness.

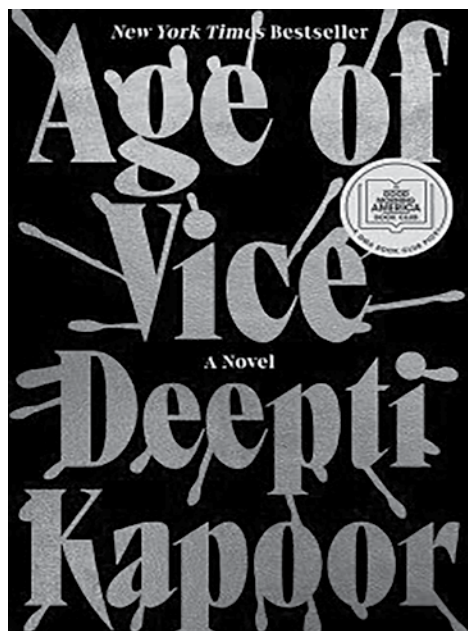

Explosive from the first page, the Age of Vice is an epic family thriller of crime and corruption. In the early hours of the morning in the impoverished outskirts of New Delhi, a Mercedes jumps a curb and kills five people, one a pregnant woman. This is how the story of Ajay, Sunny, and Neda begins on the page. Their story started long

before this stunning turn of events, which marks the beginning of the end for the trio. Deepti Kapoor grew up in northern India and knows of what she writes.

Ajay's journey begins in the poorest of provinces, his parents literally scraping feces for a living. Tragedy strikes and Ajay is sold off at the age of eight to pay off the family's debt. Working as an indentured servant, Ajay grows into a handsome, subservient loner. A chance encounter changes the trajectory of his life and he finds himself indentured yet again, this time in the lavish, treasure filled home of a gangster's son.

Sunny Wadia is a shining star of the social scene. He plays at bringing culture to the masses but can never get past his father's

flinty-eyed indifference. A pitiful playboy, he fuels himself on alcohol and cocaine, jet setting around the world, gathering acolytes and groupies. Money flows like a river from daddy's coffers, an unending stream of wealth fed by rampant corruption. Trouble comes in the form of an investigative journalist, working on exposing the Wadia family's corruption. Neda is a hapless twenty-something who halfheartedly goes through the days with little purpose. When she meets Sunny, she quickly falls under his spell.

At 548 pages, this is a hefty tome, but well worth the time. The book is split between the three protagonists – Ajay, Sunny, and Neda. Each character comes to life with their own story and intertwine as the novel moves forward and back in time. We come to know them intimately, with all their faults and ambitions. Ajay remains stalwart and loyal throughout, but Sunny and Neda cling to each other like life preservers, drowning together amid the detritus of their doomed relationship.

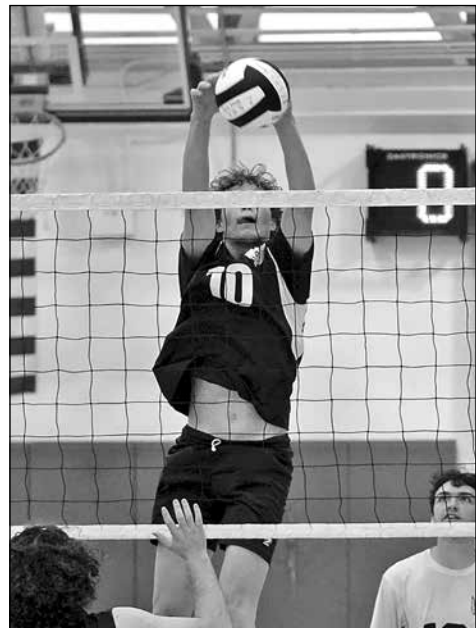

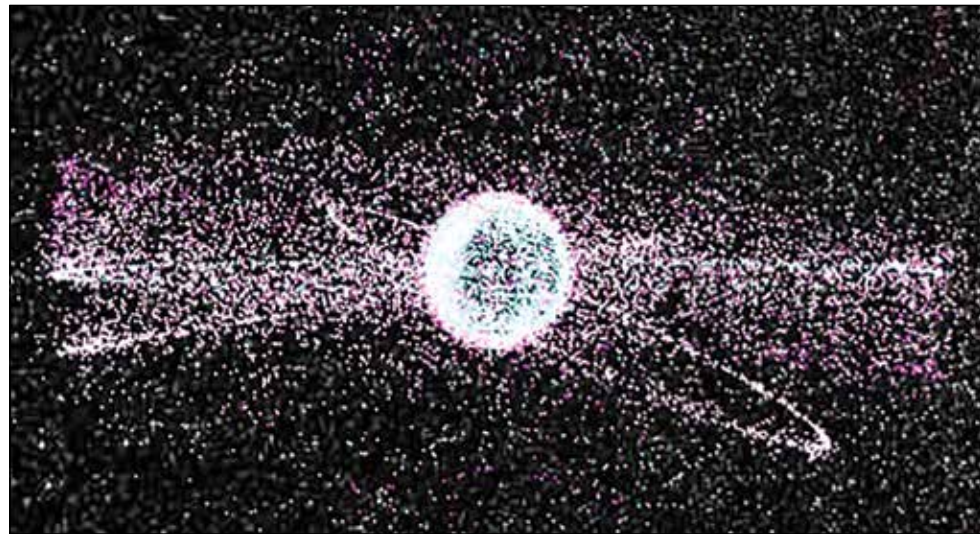

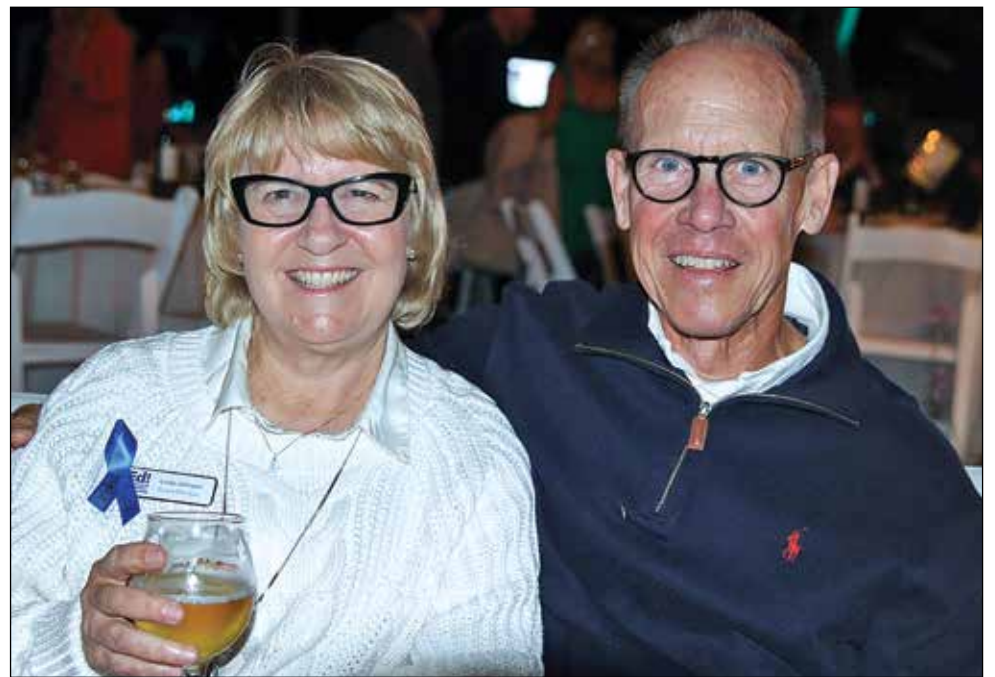

Combating Senior Social Isolation And Loneliness

(BPT) - For many Americans, life today feels typical - we're back in school, returning to the office and are enjoying our hobbies and social lives. Connecting in-person with friends and family is once again a regular part of our routine.

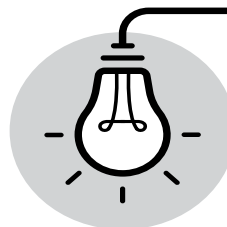

Use whichever you prefer- just follow the recipe as written above for the best result. If you're using larger chicken breasts they may require a little longer cooking time.

Directions

- **Step 1:** Heat 2 1/2 cups broth in a 2-quart saucepan over medium-high heat to a boil. Stir in the rice. Reduce the heat to low. Cover and cook for 45 minutes or until the rice is tender.
- **Step 2:** While the rice is cooking, season the chicken as desired. Spray a 12-inch skillet with vegetable cooking spray and heat over medium-high heat for 1 minute. Add the chicken and cook for 15 minutes or until well browned on both sides and cooked through. Remove the chicken from the skillet, cover and keep warm.
- **Step 3:** Add the mango, red pepper, chutney and remaining broth to the skillet. Cook over medium-high heat for 5 minutes, stirring occasionally. Stir in the green onions. Season to taste. Serve the chicken and mango mixture with the rice.
