Michael Klesic: Springing into Action

El Segundo resident Michael Klesic has twice saved someone's life using CPR. His philosophy in times of crisis is both familiar and important: doing something, no matter how small, is always better than doing nothing at all.

On February 23, 2023, Michael Klesic was home, waiting for the plumbers to finish repairs in his apartment on Virginia Street. He took the morning off of work and was about to head out when he heard screaming from the building directly next to him. While initially thinking it was a couple fighting, he quickly realized that there was only one voice, and she was screaming. "I thought I heard her yelling, don't bleed out," Klesic explained.


Klesic, who was in the Croatian military in 1993, said his response was almost instinctual. While he found himself in a position where anyone needed to be revived during his time in the army, he saw people wounded and acted on that. "You just act. You don't really think," he said. Running outside and into the neighboring building, he announced himself as he headed toward the door, toward the voice of someone screaming for help. Upon opening the door, Klesic explained how he ran into the back bedroom, where he found a man, Justin Rivera, lying on the floor. Klesic began straddling him, putting his legs around Justin's waist to position himself to check his airway. "I jumped on top of him, gave him CPR, then checked his pulse. CPR again and checked his pulse, but still nothing. CPR again, checked his pulse, and there was a

faint heartbeat," he explained, "All I started thinking was, we have to get blood to his brain, we have to get blood to his brain."

According to Klesic, fifteen seconds later, an El Segundo Fire Department EMT came running in, followed by a police officer. They spoke to both Klesic and the woman who initially screamed for help, who he later learned was Rivera's girlfriend. He had had a heart attack in his sleep when Klesic found him on the floor. Rivera, who has a rare heart condition, was in a coma for a week after the initial incident. A week later, when he was released, Klesic was able to meet Rivera's parents, who were extremely grateful for what he had done to help their son. "His mother gave me the best hug of my life," Klesic explained, "It was really sweet."

Much like his parents, Rivera was and continues to be extremely grateful for Klesic and his ability to jump into action in times of crisis. "He saved my life, and I'm extremely grateful for it," Rivera said. Looking back on the moment when Klesic met his parents for the first time, Rivera also mentioned how touching it was to see everyone who supported him in his time of need together in the same room. "It was very heartwarming to have something so crazy happen and for everyone to support me," he said, "I wouldn't be here without them."

Now, Rivera is focused on moving forward. "I'm just trying to piece it together and move on from it," he said, "But I am and will forever be so grateful for Michael and what he did for me."




Michael Klesic on the set of a previous acting project for Marvel's

Klesic, who has been a professional actor since he was eighteen years old, pointed out the irony of the situation, as Rivera is also an actor. "I'm used to saving an actor on stage, but not in the real world," he commented.

That being said, Klesic made it clear that he wasn't the only one helping Rivera at the moment. "It wasn't just me who saved his life," he explained, "It was the fact that the girl that was with him was yelling, and I wouldn't have been able to help if I hadn't heard her screaming." He also mentioned that, according to Rivera, the paramedics revived Justin once more in the ambulance. Klesic reflected, "If we didn't live so close to the fire department, you know, they got there so quickly. I don't know how successful I would have been if he coded again." 'Coded' is a term that refers to the state of




Film Review

Master Gardener is a Beautiful, **Complicated Story of Metamorphosis**

Many ecosystems benefit from controlled fires. The act of burning to rebuild is a natural phenomenon that has occurred Haverhill's attempt to keep her off the streets and away from the crowd she's currently caught up in, so he cuts her some slack. As the days become easier for both Narvel and Maya, their relationship grows into an unexpected entanglement of feelings, desires, and secrets.

Suppressed violence is at the root of Paul

Schrader's drama, making for a rich juxtaposition between the beauty of the present and the darkness of the past. Narvel's current rehabilitated image may be one of gentleness and care but his previous dealing as a white supremacist hitman is never far from the surface. The film's tension comes from the growing love story between Narvel and Maya, a black woman. He can only conceal his swastika-bearing tattoos for so long, and his growing existential crisis threatens to blow up his newly-curated life, his relationship with Maya, and his future.

For all of the film's darker themes, Master Gardener emits a vibrant frequency through the cinematography and the score. We dip







those in cardiac arrest.

And what's more, this isn't the first time Klesic has saved someone's life using CPR. About eight years ago, he was sitting at the Wolfgang Puck restaurant in terminal seven of LAX when he looked over to find an older gentleman sitting on a stool table, turning blue. "He wasn't eating, and he collapsed on the floor," Klesic explained, "I gave him CPR, and he ended up getting up and walking out [of the restaurant] before any EMTs got there." Klesic, who had been sitting on the opposite side of the restaurant, said he was surprised that nobody helped the man before him. "Did that really just happen?" he remembered asking himself.

It is moments like this, he explained that reveal the importance of being able to think independently and trust oneself, especially in stressful situations. Klesic explained how this is a lesson he teaches his two boys, Liam and Luca, who are eight and twelve, respectively. "I've tried to tell [my sons] when the crowd goes one way, sometimes it's best to go the other, but you have to make that decision really quick," he said.

when he took his first CPR class when he attended Beverly Hills High School. He explained, "Bad CPR is better than no CPR. Somebody attempting something is better than nothing." This approach to moments of crisis prioritizes jumping into action, something

This is a lesson Klesic first learned back

Klesic has always been familiar with. For him, time slows down in crisis situations, and he is able to think clearly about what he will do next. He said this is why he wants his boys to take CPR classes. "They will definitely have training; it's nice to have in the back of your head," he explained. Since the incident, Klesic has gone back to

work as an actor, mindful of others around him and how he can help, especially in moments of crisis. His last role was on NCIS: Los Angeles, and since then, he has pivoted to theater, working for The Groundlings, amongst other companies. But whether it be acting in a role or in a moment of crisis, Klesic tries to help however he can, mindful that while he's not the only one offering support, he will still do everything he can to help, making him a truly Good Samaritan. •

Set to hypnotic synth-forward melodies from Devonté Hynes, who also performs as Blood Orange, the soundtrack is also the perfect moody supplement to an already tense film.

Ultimately, Master Gardener is a story about a man's search for redemption.

Thematically, Schrader doesn't stray far from his last two films, The Card Counter and First Reformed (the latter of which made my top 10 list in 2017), so fans or critics can expect as much from his "man in the room" storyline here. It's not a lighthearted affair, but the heftiness is not without incredibly powerful performances and breathtaking views of the natural world. •
