City Council Designates Funds for Capital Improvements, Adds \$1 Million to Police Budget

The city's first-ever Juneteenth Celebration Day, the city's water tower once again lit in rainbow colors in honor of LGBTQ+ Pride Month; three upcoming tours of Blue Butterfly habitat and hopefully some blue butterflies in July; a resident who is volunteering time and money to produce fun events and host an ESHS math teacher who runs a "Math Lab" at her house asking for fee waivers were all part of city proclamation presentations and the Public Comment portion of the City Council's meeting Tuesday night. Two residents also brought up three additional subjects: super loud conditions during a senior class at the Aquatics Center and subsequent safety issues arising from the excessive noise, pedestrian safety at Oak Avenue and Main Street near the high school, and posited that bike lanes on El Segundo Boulevard could slow down traffic whose speeds have increased since the widening of the traffic lanes after the stripes for a pilot parking project on the roadway were removed, and the boulevard repaved and re-striped.

City Council also heard or addressed agenda items that included an update on the City of Los Angeles' Hyperion Water Reclamation Plant, which is still recovering from an emergency in July 2021 that has impacted El Segundo residents and their health. Approval of a new full-time position, Aquatics Manager, to help move the city forward as it gets ready to complete a major Capital Improvement Project to update and upgrade Urho Saari Swim Stadium, aka "The Plunge," while also currently operating two pools, including the Olympic-sized pool that is part of the Aquatics Center, with hopes of increasing sponsorships, notoriety, and position it for major use by sports organizations, including the 2028 Olympics, which will be held in Los Angeles.

And after reviewing and participating in budget sessions for the 2023-2024 city budget, some sessions held as recently as April and May, city council, which was a threesome by this point due to Mayor Drew Boyles' absence and council member Lance Giroux' virtual departure after the Aquatics Manager discussion and vote (he was working in New York), Mayor Pro Tem Chris Pimentel and council members Carol Pirsztuk and Ryan Baldino approved the budget, which includes \$18-\$19 million transferred into the Capital Improvement Projects fund to cover some "19 brick and mortar projects," including the updating and renovation of Recreation Park and The Plunge, among many other long-delayed projects. The city, which achieved an AA+ Bond Rating in 2021, is working to secure a Triple A rating by July 2024. At one time, the city allocated 12 percent in reserves. They now have 25 percent in reserves.

Pimentel brought up the issue of refunding/ reimbursing residents for overpayments of wastewater bills made to the city and wanted to know how the city handled the overpayments. He called the \$900,000 "improperly collected." The city was overcharged and hence overcharged its residents. "We are still holding people's money hostage. That is not our money." Public Works Director Elias Sassoon said the city had received a credit. Pimentel said the people who paid the city had not received their money back. Sassoon noted that he thought former Chief Financial Officer Joe Lillio, during the 2023-2024 budget process, which he stayed on with the city to help with before departing for a new job, "was recommending at that time" to keep the money in the reserves "for a rainy day." Said Pimentel, "That may have been Joe's plan, but I don't think that's defensible. I'm sure there's a magic computer that can figure this out."

Deputy City Treasurer II Dino Marsocci then said they think they reduced the revenues in that fund (saying he would check and confirm the next day and let the city manager know)

Communication, Humor and Dementia

We all know the frustration of not understanding someone or feeling misunderstood. Miscommunication can be one of the greatest divides of all time, and disease, aging, and cognitive decline make this even more pronounced and difficult, especially when dementia is involved.

Communication often includes references to past events, to current news, nuances, sarcasm, or sense of humor, all of which are compromised by the disease. There are sparks of clarity and brightness in the day, and there can also be darkness, quietness, and withdrawal; and as I always remind my clients and readers, this is part of the disease, and no one's fault.

How to improve communication with someone with dementia:

The routine and normal cycle of a day has times of highs and lows. When seeking to communicate with your loved one, try and use the "high time" of the day. Often, this may be mid-morning after a snack but not a lunch. And yet, gauge for a response: Be aware of uneasiness, if they are tired, distracted, or simply don't want to talk or interact as your communication will not be successful.

The space is also of relevance. Often, TV is on for "white noise," but this is also a distraction and can be over stimulating.

El Segundo Little League Season a Success

The El Segundo Little League's season ended when three championship games decided the Major, Triple-A, and Double-A level champions. What started on a rain-soaked February Saturday morning, with an abbreviated parade to start the league's 69th season, ended on a sun-drenched June Saturday afternoon. In between was a rescheduling nightmare due to the rainouts that pushed what was typically Championship Saturday into the Majors playing their championship game on a different day.

Typically, all three levels play their championship games on the same day culminating with Closing Ceremonies and a Homerun Hitting contest. Due to the rescheduled games and conflicts, the Majors played their championship game three days before the other two levels played theirs, which ended with the Closing Ceremonies. And, if you were fortunate enough to attend any of the championship games, you were in for a treat. All three games were decided in the last inning, and all were one-run games.

Braves Walk it off in Majors Thriller

In front of a large crowd, the Braves and Cardinals played an exciting game that was in doubt until the bottom of the sixth inning. That's when the Braves' Griffin Goshi, hit a ground ball through the infield, scoring Ethan Mooney from third base to give the Braves a 3-2 win for the championship.

The Braves finished behind the Mets for second place during the regular season, while the Cardinals were third. The Cardinals worked their way through the loser's bracket to reach the championship game. After falling to the Braves in the first round, they turned it around, defeating the Royals, White Sox and Mets. The Braves, who gave up the least runs during the regular season by a large margin, were undefeated on their way to the finals. After defeating the Cardinals, they held the Mets, one of the league's most explosive offenses, to one run in their 4-1 win to reach the final.

The Cardinals struck first for two first-inning runs. Logan Meyer singled to lead off the game, followed by a single by Colby Lee. Meyer would come around and score on a passed ball, and Lee scored on long fly ball by Johnny Amaral to give the Cardinals a 2-0 lead. The Braves countered with two runs in their half of the first inning. Declan McRoberts singled and would later score on a wild pitch. Crew O'Connor, who drew a base on balls, scored on an RBI single by Griffin Goshi to tie the game at 2-2.

The game became a strategic managerial game filled with great plays and pitching moves that involved six pitchers, including arguably two of the best, finishing the game. Each team had runners in scoring positions but couldn't push the base runner across. The Cardinal's Jude Hansen singled in the fifth inning but was left stranded at third base. In the fourth inning, Goshi singled and went to third base on a ball hit by Jack Richmond that was misplayed. But the Cardinals got out of the inning on a double play when Charlie Espinosa caught a line drive and forced Richmond when he was off second base.



Author Spotlight: Toshikazu Kawaguchi






<u>Film Review</u>

Sundance Darling, The Cow Who Sang a Song Into the Future, is Ripe Eco-Conscious Folklore

An eco-conscious folklore bathed in surrealism, The Cow Who Sang a Song Into the Future is an ambitious exploration of relationships with things beyond the material world. Director Francisca Alegría crafts a story rich in imagery and topical urgency in this bold feature debut.

The film takes place in southern Chile, in an area overrun by pollution and water contamination. Thousands of fish have turned up dead in the river, so it's shocking to see a woman emerge from the deadly waters. As she makes her way from the river and into the small town, she catches the eye of an older man. When he spots her, he immediately gets overcome with emotion. He believes this is Magdalena (Mia Maestro), his deceased wife who killed herself in a mysterious suicide decades ago.

This revelation frightens the man's middle aged daughter, Cecilia (Leonor Varela), who returns to her hometown to be by her dad's side while he recovers from his shock. Could this really be her resurrected mother, back from the dead? Cecilia doesn't believe this theory until she comes face to face with Magdalena herself in the woods. Magdalena is quiet-silent throughout the entirety of the film, in fact-but conveys her message through her expression. Cecilia can't deny her mother's presence but one big question remains: why is Magdalena here?


The Cow Who Sang A Song Into The Future is, at its core, a simple story about life and death, both literally and figuratively. The resurrection of Magdalena is like Mother Nature in human form who descends from the ethereal world to draw attention to the local factory that is killing fish and contaminating the water, putting all humans and animals at risk. In addition to the vivid imagery and heartfelt performances, one of the standout characteristics of the film is the use of music; specifically, the lyrics that accompany the haunting melody. The bass drum beats like a heartbeat as a choir of voices sings about returning to Earth after death. It's equal parts haunting and beautiful and expertly fills in the gaps between scenes.

Unlike some environmental films that aim to shock or scare viewers into action, The Cow Who Sang A Song Into The Future acts as a gentle reminder that if we continue to live selfishly, our planet, environment, and our lives will feel the repercussions. Most importantly, though, it's not too late to reverse some of the damage that's already been done. •



If there is a TV or music or others in the background, always ensure you are sitting close to the person you are speaking to. This helps create better focus and also alleviates the difficulties of speaking to someone that may be hard of hearing. Try to find a comfortable chair for yourself so that you may show yourself as relaxed in your body language and don't project tension. Be sure to speak slowly enough to let them process what you are saying and give them enough time to form their own thoughts and respond.

What if you sense tension during communication?

Never take this personally. There are many factors involved in cognitive decline and chances are that you may have limited control. This said, invite your loved one to lead the conversation if they are able. As you are mindful of their mood and nonverbal communication, ask if there is anything he or she wants to talk about and never shut out sad feelings or thoughts. This conversation may be simple but still beneficial and you should feel free to ask simple questions, one at a time. Avoid asking "Remember when...?" If you still feel limited by conversation, consider having a magazine in your hands with pictures that may motivate conversation, such as "look at this: I like the colors of this picture, do you?"

Humor and dementia

Humor, sarcasm, irony, and other forms of

communication that may fill our normal days may be difficult to follow for someone with cognitive decline. Worse yet, it may give them the feeling that you are laughing at them or frustrated by their challenges-make sure to minimize these. But no one should go a day without laughing... think of it as exercise for yourself and your loved one. Set aside 10-15 minutes a day and do something that will not only amuse your loved one, but you as well. You may motivate conversations about a funny event. As a tip, consider browsing through an album of funny family photos or playing some of their favorite music or videos of their favorite comedians from years ago. Studies have shown that the quickness and visual energy of slapstick comedy may often be more entertaining for people with dementia. It is fast-paced, and yet requires little context. Consider shows like I love Lucy, Three's Company, The Carol Burnett or Dick Van Dyke Shows. For homegrown comedy, you may sing a song, perform a dance, or put on a silly hat. If these things aren>t working, don't take it personally - just move on to something else.

Reconsidering Expectations

It is true that it can be difficult to communicate with someone in cognitive decline. But communication can also be limited to short or simple interactions. A few smiles can make for a great afternoon. •





"on the anticipation of one possibility being reducing the increase that's due to come up in January. I believe it's (the increase) 9.5 percent. And one thing we've possibly talked about was reducing that increase in order to offset that excess charge." Baldino and Marsocci called it a subsidy. Said Pimentel, "As long as we have a strategy and are accounting for it here. I mean, it wasn't our fault. They took it from us, and we took it from them."

At the end of the report, which lasted about 50 minutes, and after the public hearing was closed, Baldino said the report had been presented in a "very clear and cogent fashion. Any opportunity we have to educate the folks in town on where their tax dollars are going is time well spent." Pirsztuk said, "I'm just really excited that we do have the funds for the capital improvement... It's been a push for us to really put every additional revenue we get into the Capital improvement reserve, so I'm just really excited to see that we're moving forward. I just hope that my message to the city manager, as well as Elias Sassoon, has been, 'Let's push forward. We'll find the money.' And I just want to continue that message." She added, "Let's get some of these capital improvements that have been stacking up for quite a while done."

Pimentel noted that the budget and the ongoing work to upgrade the city's bond rating have been taking place during the possibility of an upcoming recession and that the recent unusual natural gas price increase gave the city an unexpected \$6 million to put into the CIP fund, which is "prudent" and enables the city to "build for the future." He also noted that the \$1 million budget increase for the city's police department for 2023-2024 is for "one-time costs," saying, "I also think this (the budget) does a reasonably good job of capturing some things we didn't foresee. The public safety sort of issue that we have with this sort of trenchant crime wave of property crime that we're trying to address with an increased police force and recruitment bonuses. Those are one-time costs that we could not have foreseen two years ago." He cautioned that the city is still negotiating with personnel "bargaining units" and "\$1.5 million in raises
