Recycle 2 Riches: How Ashleigh Dawson Gives Old Clothes New Life

What many people don't realize is that fashion trends take a huge toll on Mother Earth.

From scrap material during manufacturing to old clothes that get thrown in the trash, the amount of waste that comes from major brands around the world often exceeds the products they produce and sell. For instance, the fashion industry produces 92 million tons of textile waste every year. They're also responsible for 20% of global waste water through dyeing and finishing processes.

Combine this with the fact that the average US consumer dumps over 80 pounds of clothes annually and the world is suddenly flooded with fabrics. But waste doesn't have to be the final outcome.

Ashleigh Dawson, President and CEO of Recycle 2 Riches (R2R), a 501(c)(3) non-profit based in El Segundo, has dedicated her career to solving this industry crisis. By encouraging consumers to up-cycle their old fabrics and materials, Dawson aims to create a closed-loop lifestyle that goes beyond just old sweaters in the closet.

"I was doing fast fashion internships in Los Angeles, three of them before I got to really understand the truth of the fashion industry," says Dawson. "And it's not just the amount of waste with clothing—I realized that every aspect of consumption required assistance. So, to address this, I embarked on a personal journey to explore ways to live a closed-loop lifestyle."

By "closed-loop," Dawson means living in a way where nothing goes to waste. For instance, a worn-out pair of jeans that you buy in the store can transform into a handbag that you now use for carrying groceries. You can sprinkle

used coffee grounds from your morning brew onto a plant to help fertilization. Everything you purchase has a continuous lifecycle that doesn't end with it being thrown in the trash. So as Dawson pursued this endeavor, she realized that many people live unaware of how simple it can be.

"Basically, most people don't know that these solutions already exist. Thus, we established the R2R directory and eventually evolved into a non-profit organization."

Dawson is a member of WeWork, a global co-working franchise located in El Segundo at 222 Pacific Coast Highway. Currently, her team is working to organize sustainable events

that teach the community there how to take small actions that can have a big impact on their overall environmental footprint—both at work and at home!

A typical day for Dawson consists of answering any conscious consumer questions from R2R community members or any partnership emails she has to reply to. If it is not an event day, she takes collaboration meetings throughout the day, working from 9 AM to 5 PM unless she has an event or speaking engagement. Each day calls for a different set of tasks. Some days call for picking up dead-stock (clothing inventory that are no longer in production)

City Enlists College Students to Create Visions

El Camino College had a sizeable presence in the City of El Segundo last month as the El Segundo Unified School District (ESUSD) and the City of El Segundo Planning Division each solicited design ideas from El Camino's architecture students for two separate outdoor projects. The projects involved students from two different architecture classes, "Design Studio 1" and "Design Studio 2," and comprised of reimagining two different types of spaces within the City of El Segundo.

For both projects, students met with both District Management and City Staff to discuss the project criteria, which was followed by an analysis of the existing conditions, determination of the program, and the development of various design solutions. These student-designed projects helped the District and the City frame a conversation around the redesign of these outdoor spaces currently being contemplated. For the students, the exercises offered some insight into the professional processes and demonstrated the nexus between their academic efforts and the activities associated with an architecture practice.

The El Segundo presentations began with the proposals for outdoor learning spaces at the District's Center Street Elementary School on Friday, May 12. For this project, Design Studio 2 students





1912 Clubhouse Added to the **National Register of Historic Places**

The El Segundo Woman's Club Clubhouse, the 1912 grammar school for the newly founded City of El Segundo, has been added to the National Register of Historic Places following an application submitted by Club member Jane Burrell to the California State Office of Historic Preservation.

Built in 1912, the wood-framed El Segundo schoolhouse served elementary students until of Women's Clubs, has been an important civic catalyst for the City of El Segundo, holding community forums and cultural events, and participating in local and national initiatives and celebrations. Donating to local, national, and international charities has been a core mission of the Club since its inception, along with scholarships for higher education beginning in the 1930s. In 2023, the Club awarded



1933. The building was left unoccupied until it was purchased by the El Segundo Woman's Club in 1936 and moved to 541 Standard Street. Noted architect, John C. Austin, donated his services to advise on remodeling the building, and in 1940 designed a new entrance for the Clubhouse.

The El Segundo Woman's Club was founded in 1922 by seventeen women to "search for knowledge and help their neighbors." The Club, which is part of the General Federation



Angels Defeat Padres 1-0 in Pitcher's Duel




Anders Tipton came in relief of Forhuber and pitched the sixth and seventh innings. He struck out two in the sixth inning and

<u>Film Review</u>

Spider-Man: Across the Spider-Verse **Is A Dazzlingly Spectacular Sequel**

Spider-Man: Across the Spider-Verse is an incredible, mind-blowing work of art that is also one of the best films of the year. The film dives even deeper into the concept of the multi-verse(s), and its spectacularly animated

sequences reach dizzying new heights in this sequel to 2018's Into the Spider-Verse, which won the Oscar for Best Animated Feature Film.

The story continues with Miles Morales (Shameik Moore) as he continues to figure out his life as New York's newest Spidey. Zipping through cityscapes with the greatest of ease, his biggest struggle is balancing his teenage life: honoring his commitments to his mother (Luna Lauren Vélez) and soon-tobe-police chief father (Brian Tyree Henry), looking ahead to college and oh yeah, trying to save the world-all while keeping his identity a secret from those he loves. The only ones who know Miles' true identity are the league of Spider-Men who helped teach him the ropes (webs?) after crash-landing into his universe in the previous film. All of the Spider-Men, including punky introvert Gwen Stacy (Hailee Steinfeld), are spread across different worlds.

The film opens with Gwen's origin story shown over an incredible drum-solo montage that also illustrates each world's specific visual style (Gwen's is a watercolor one, while Miles' ink-blotted world more readily resembles comics). After Gwen is attacked in her world by the universe-hopping villain Vulture (Jorma Taccone), she also unexpectedly meets a few more Spider-Men and women (Oscar Isaac as Spider-Man 2099 and Issa Rae). These heroes are part of a "Spider-Society" that protects the multi-verses from "canon disruptions." Wishing to leave her world behind, she pleads to join theirs. Against better judgment, she decides to pop over to Miles' world for a quick visit.

While Miles has matured since the first film, although still wise-cracking and perhaps a bit too cocky in his Spidey role, he underestimates the arrival of a clumsy new villain, Spot (Jason Schwartzman). Spot warns Miles that he is his new nemesis and holds him responsible for his genetic mutation; being covered in spots that he can use to travel through space (a result of the first film's universe collider).

A surprise visit from Gwen excites Miles, and the two web-sling around the city in friendly flirtatious fun. But when he sneakily follows her and her Spidey task force into a new universe (we travel to many in the film; buckle up) and disrupts a key moment in that world, he learns of an unintended truth that the Spider-Men share: some events, while tragic, are fated to happen and keep all of the universes connected and in order. Miles learns that he can't save everyone, a truth he struggles to accept and ultimately, doesn't.

And yet, while it's the most wow-worthy and spectacular thing I've seen this year so far, it fails to capture the same heart as its predecessor Into the Spider-Verse did. Likely, there is too much going on. The first film was more self-contained, in that all of the action crash-landed into Miles's world. By the time we've jumped into our sixth universe, you do feel a sense of endless abandon that makes it difficult to remain emotionally connected to the looming threat lurking back in Miles's world.

Spider-Man: Across the Spider-Verse is an incredible work of art that bursts with fun and visual wonder that proves the sequel game can remain strong (Beyond the Spider-Verse will return in March 2024).



On a larger scale, from January to the end of April, Dawson is focusing all of her energy on planning the Earth Day Summit, the largest annual fundraiser R2R puts on. With the notion, "Everything is sacred, nothing is wasted," she focuses her day's energy on reducing waste by finding a use for the things that people already have in this world because as R2R says, "everything can be something."

Most of the nonprofit work for Dawson is on the computer, and a little bit of it is actually in the community. However, her goal is always to bring initiatives and conversations out of the office and into the community as much as possible.

"Our goal within the next five years is to establish our closed-loop physical community and expand our chapters in California and across America," says Dawson. "Additionally, we aim

out our mission across America. Personally, I hope to secure a TED Talk within the next 5-10 years."

were directed to develop a design for one of six spaces that exist in between and adjacent to the half dozen classroom buildings. Currently defined by blacktop surface, the spaces lack formal programming and design measures to support student learning. Each of the spaces were designed to be multi-functional and flexible as well as support the developmental stage associated with a specific grade. Further, the proposals addressed various environmental constraints and ecological opportunities to provide Upon receiving draft findings that highlighted the community's priorities, the students analyzed and designed solutions that represented the City's history and context.

Assistant Professor of Architecture at El Camino College, Marc Yeber stated, "the students' work was remarkable in their use of the City's iconography as the seed to cultivate their respective design processes. Further, their project outcomes helped to embed a visual narrative about El Segundo while addressing

the functional needs of the space." In fact, the designs employed notions of the El Segundo Blue Butterfly, the aerospace industry or even the Chevron Refinery as design cues to help define their space. "As a result, the solutions were specific to the plaza in El Segundo which is a hallmark for creating a sense of place," he added.

Combined, these two design opportunities elevated the student work and offered El Camino College students an unexpected enrichment to their academic endeavors. Such collaboration with outside institutions and professional partners has become a key component in immersing students in their educational experience. The Architecture Department at El Camino College offers an in-depth and comprehensive curriculum designed to launch students into a university architecture program or a career path within the architecture field.



more greener and comfortable environments.

The students presented their findings and design proposals to a group of District staff, teachers and parents. One of the reviewers, Frank Glynn, a local architect and resident of El Segundo commented, "The students demonstrated a wide array of innovative strategies for creating outdoor learning in the interstitial spaces of the Center Street Campus," he continued, "They are to be commended for the depth of research that went into envisioning age-appropriate solutions for each of the various grades."

This was followed by presentations of a different type of outdoor space for the City's Planning Commission on Thursday, May 25 associated with the El Segundo Civic Center Plaza. Originally built in 1956 and remodeled in 1975, the plaza is an anchor to many community events including festivals, celebrations and a weekly farmers market. This civic space currently poses several challenges including not enough soft surfaces for child interaction, a significant deficiency in shading, minimal landscaping, and a lack of *place*. As part of the El Segundo Downtown Specific Plan, Design Studio 1 students were asked to reimagine the space to accommodate more impromptu activity, to encourage a variety of activities for different ages and to become an economic catalyst for revitalizing the downtown district.
